The ornamental design for a cane handle, as shown and described.

### DESCRIPTION

FIG. 1 is a top right front perspective view of a cane handle showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view thereof; the right side elevational view being a mirror image;

FIG. 4 is a rear elevational view thereof;

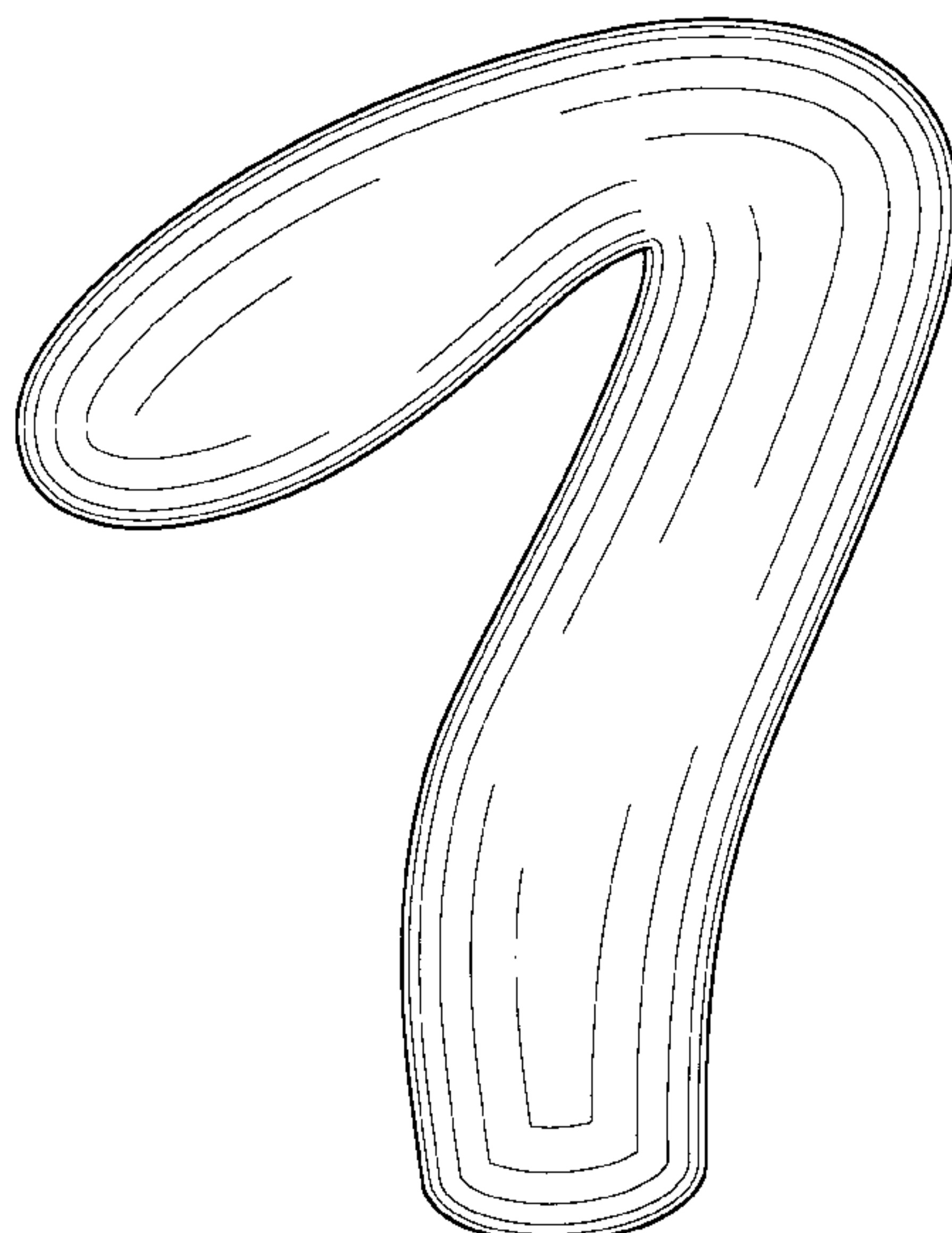
FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a top right front perspective view, shown in reduced scale, and showing, in phantom, how the cane handle would appear on a cane.

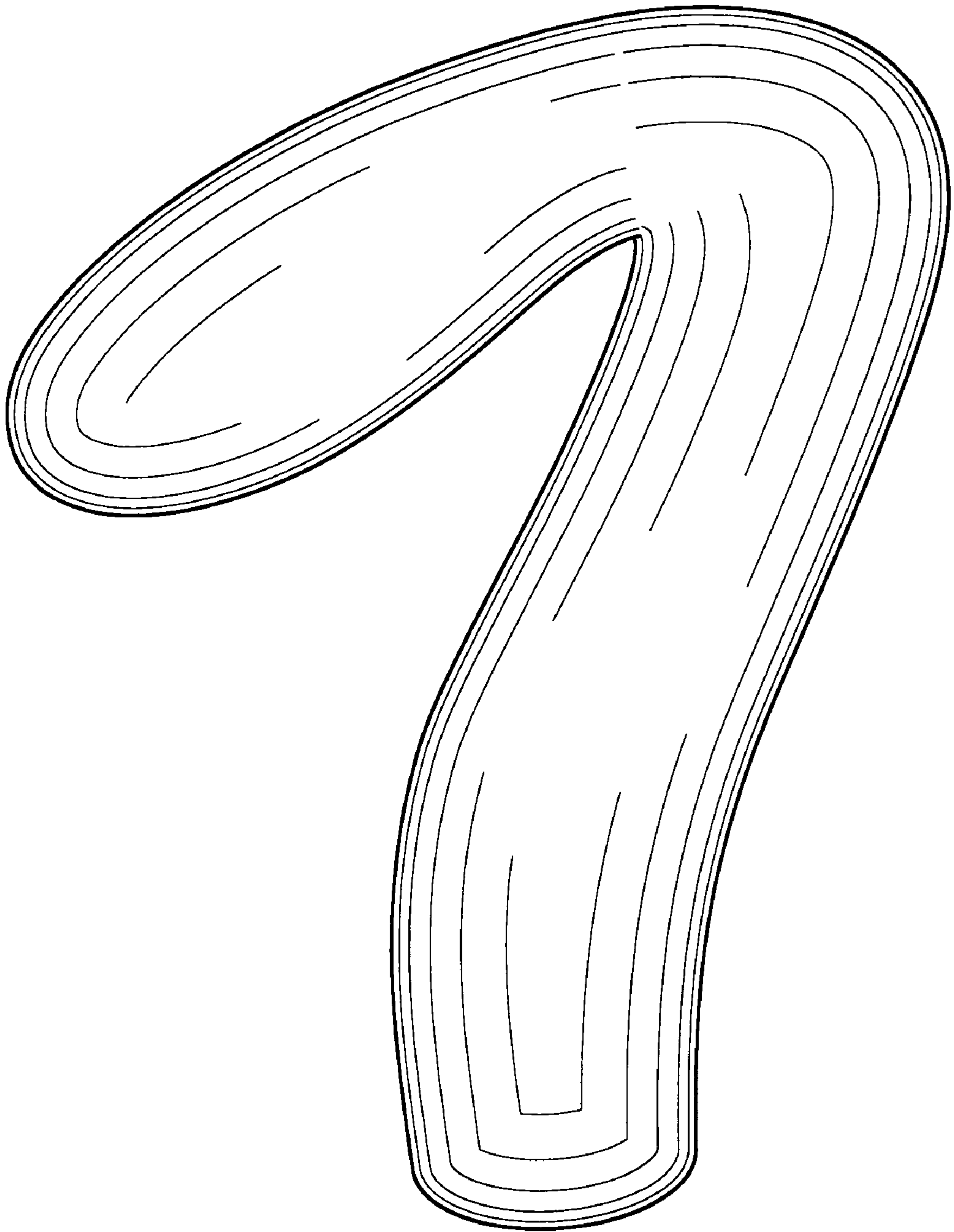

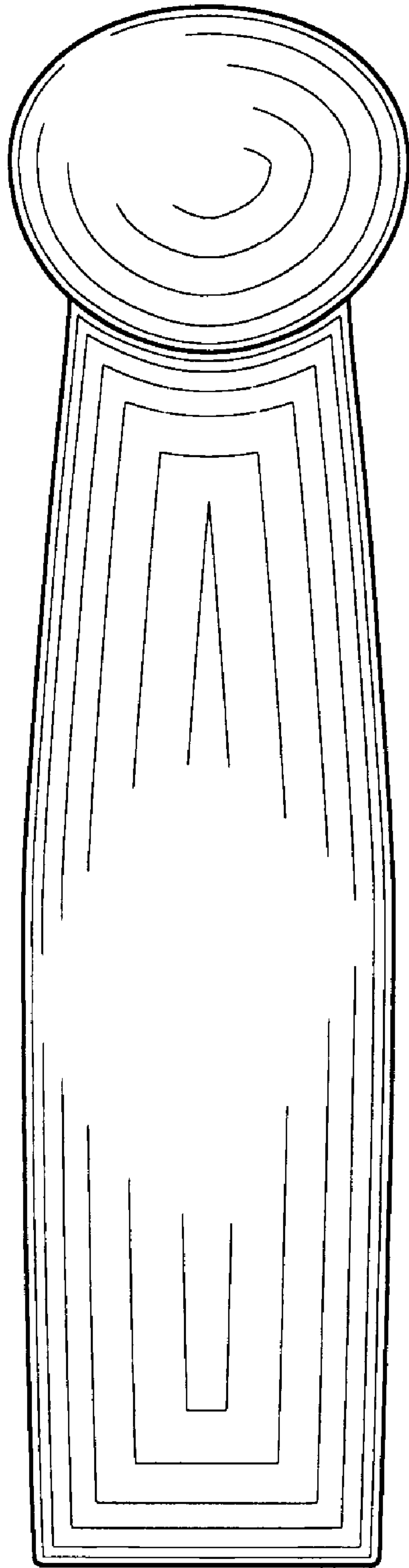

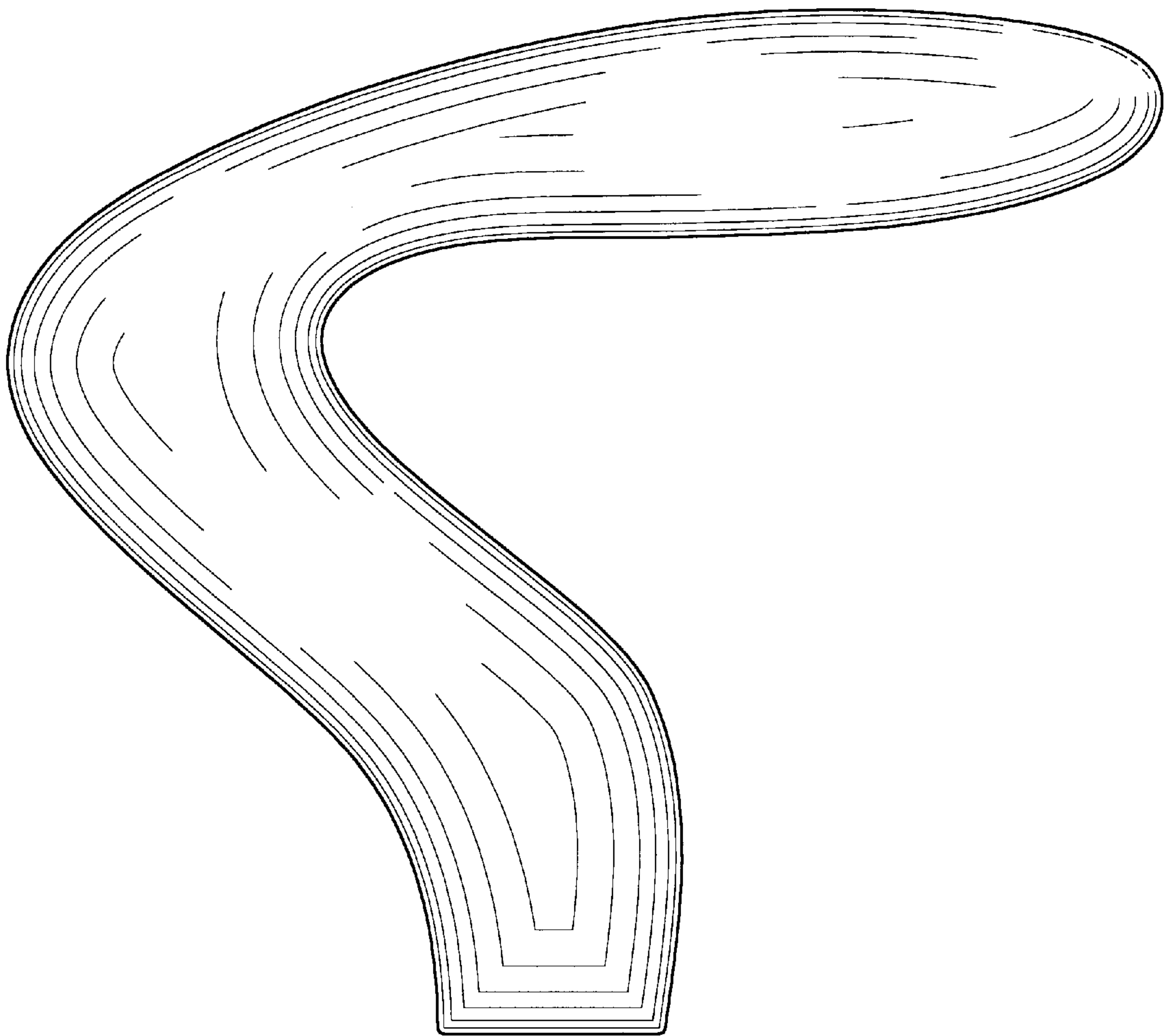

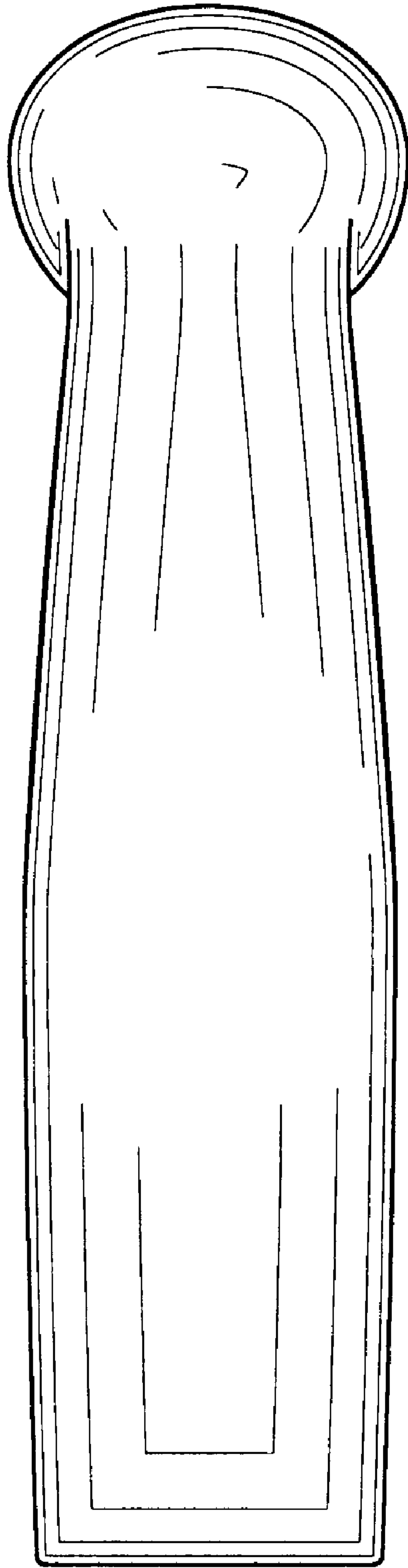

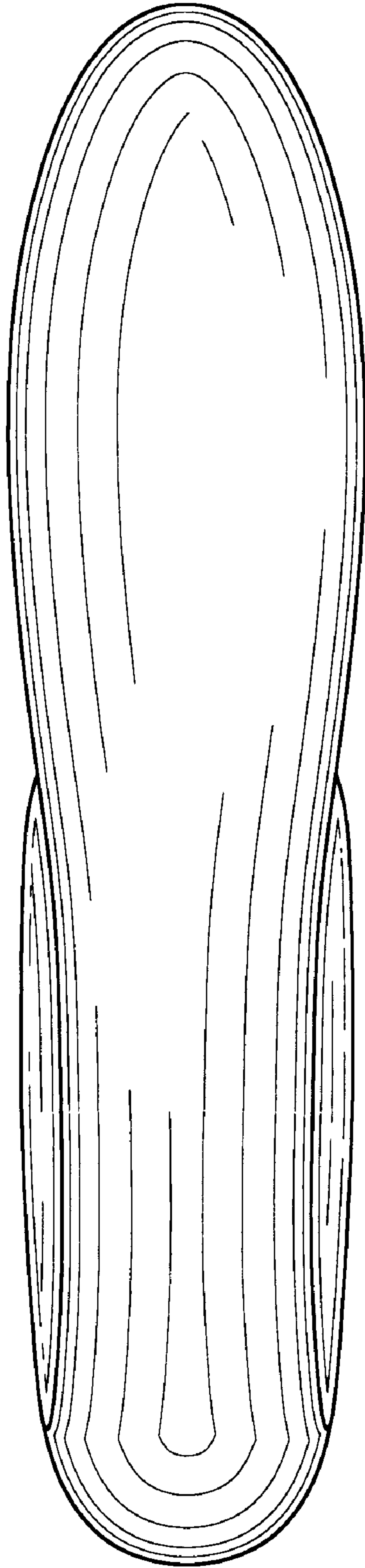

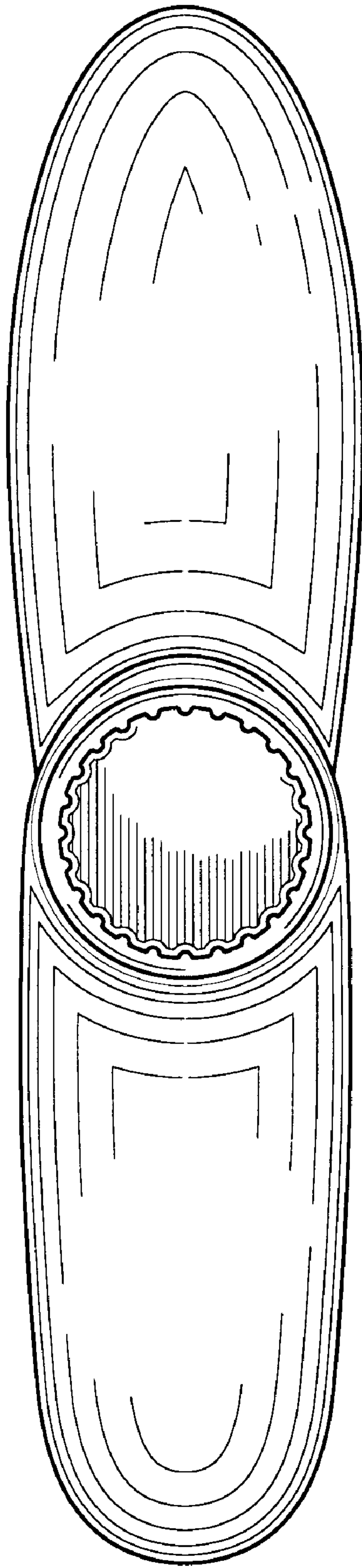

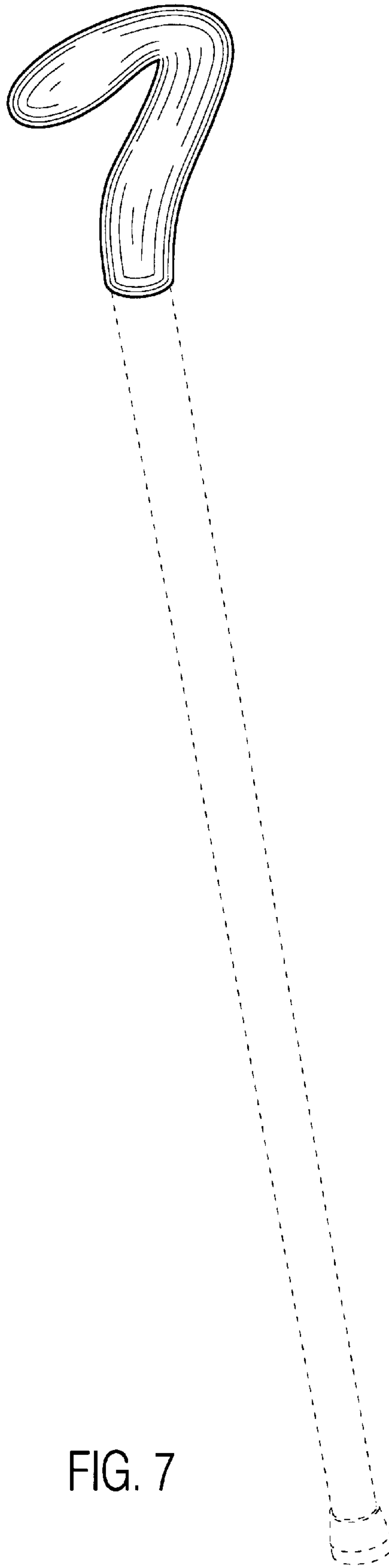
