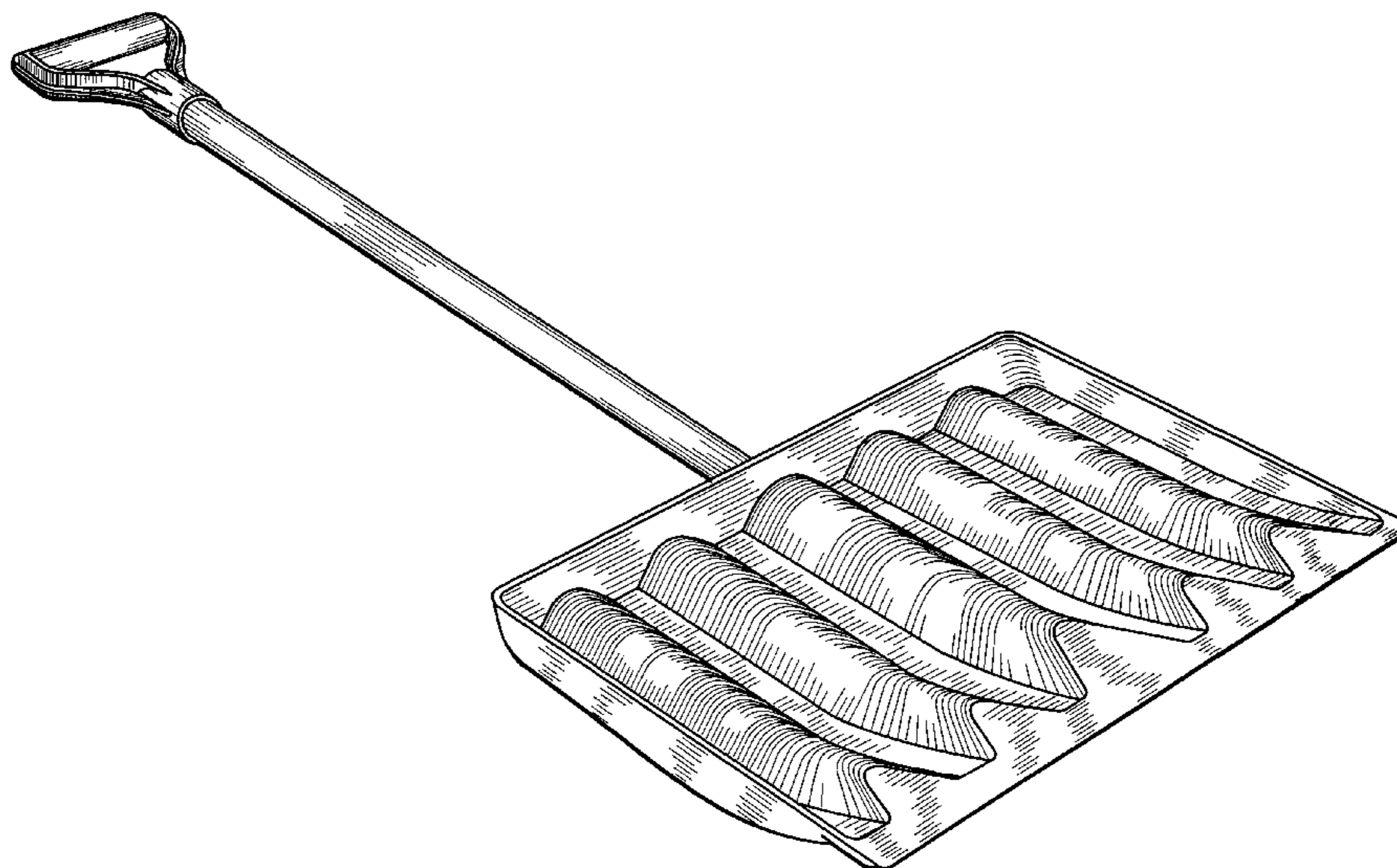

DESCRIPTION

FIG. 1 is a front perspective view of the snow shovel showing my new design;
FIG. 2 is back perspective view of a first embodiment of the snow shovel showing my new design;
FIG. 3 is a bottom end view of the snow shovel showing my new design;
FIG. 4 is a top end view of the snow shovel showing my new design;
FIG. 5 is a left side view of the snow shovel showing my new design.
FIG. 6 is a right side view of the snow shovel showing my new design.
FIG. 7 is a top plan view of the snow shovel showing my new design.
FIG. 8 is a back plan view of a first embodiment of the snow shovel showing my new design; and,
FIG. 9 is a back perspective view of a second embodiment of the snow shovel showing my new design.
The undisclosed front view of the second embodiment is identical in appearance to that shown in the first embodiment.

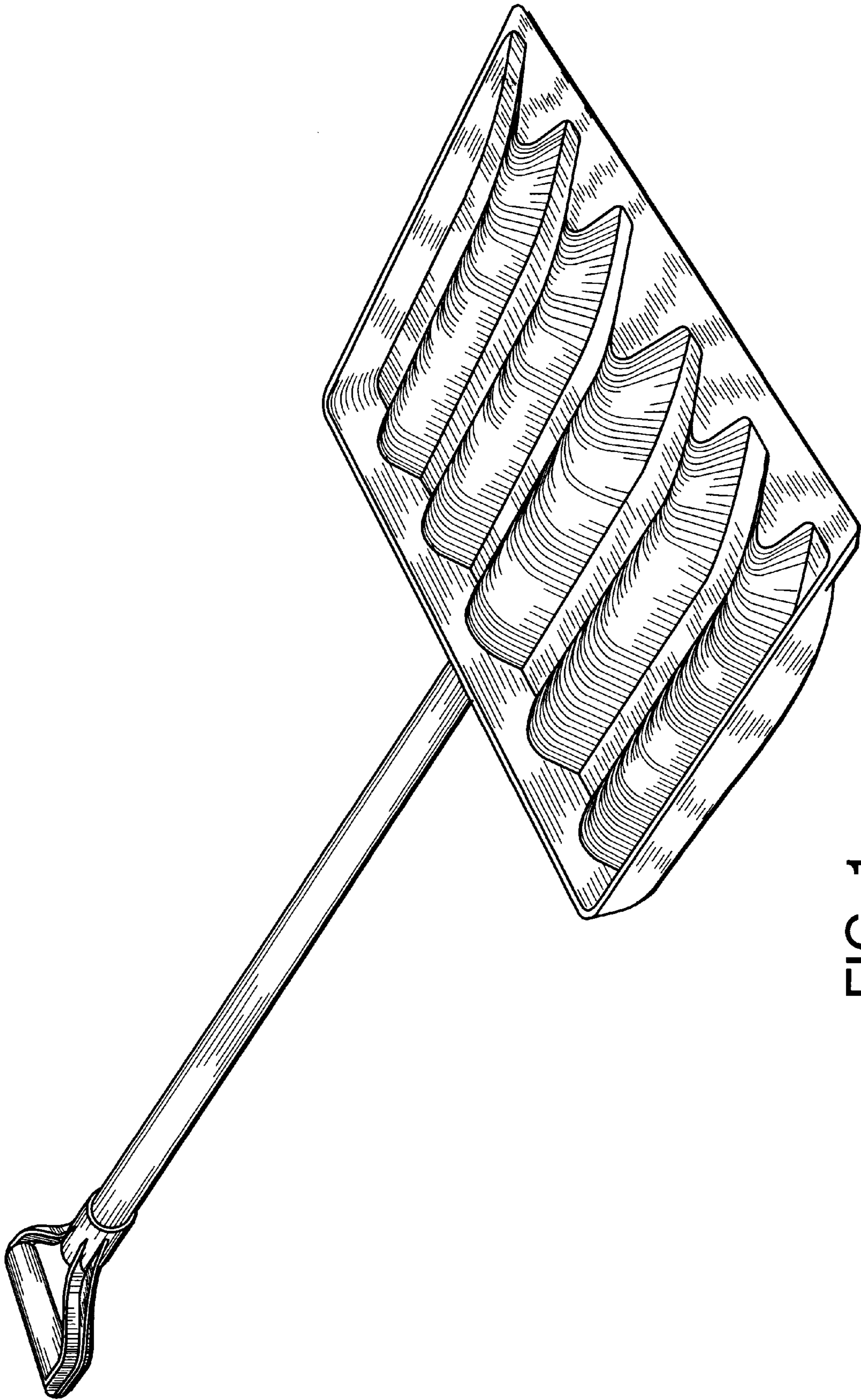

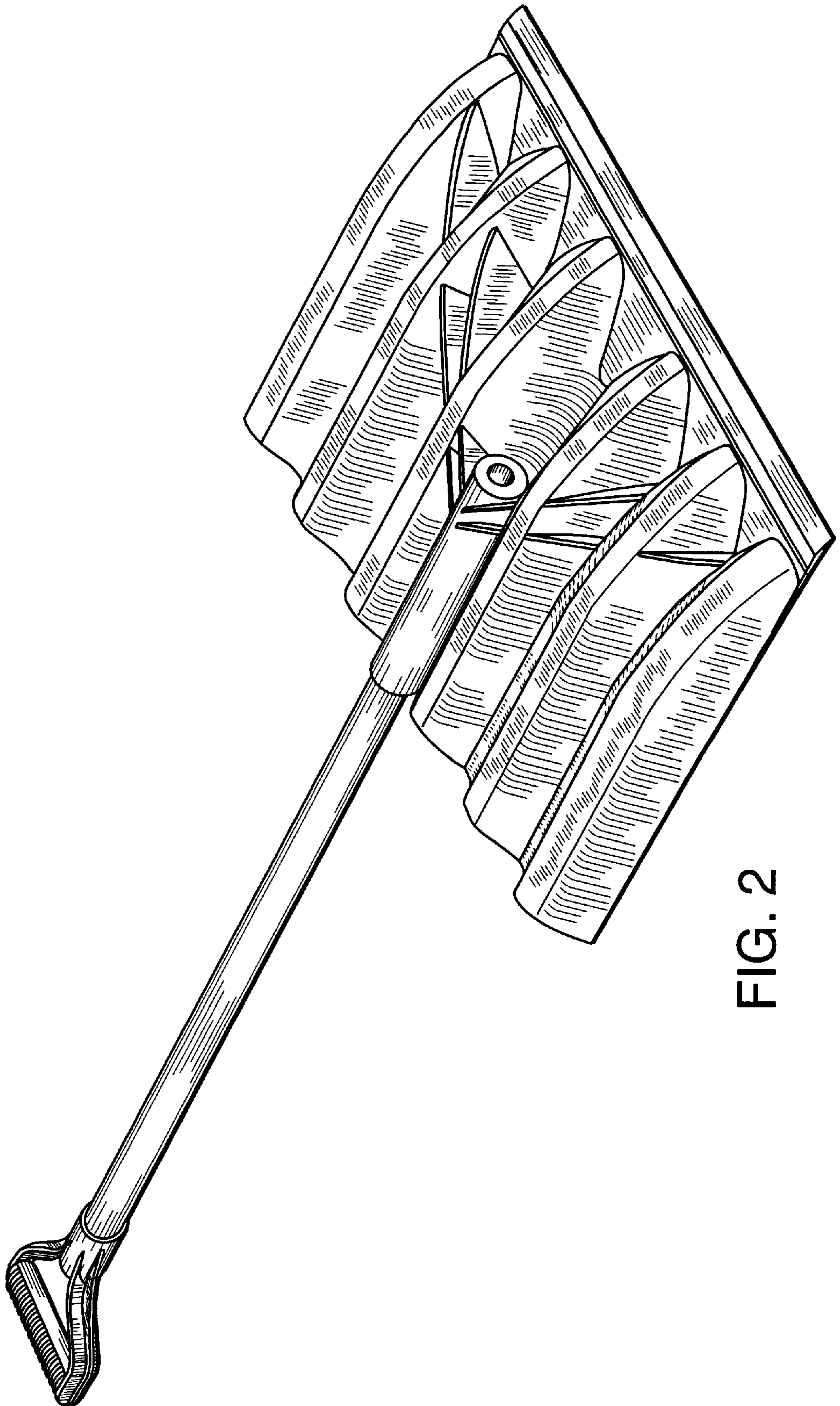

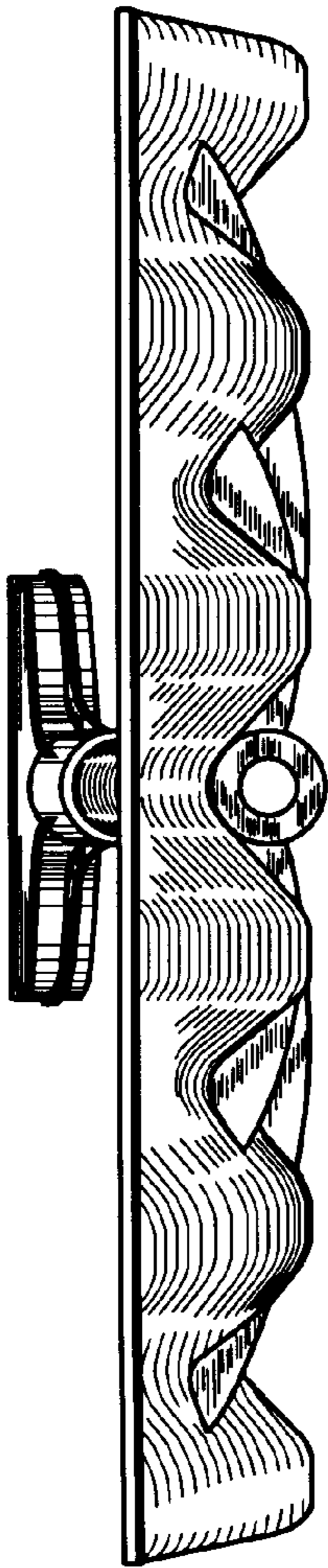

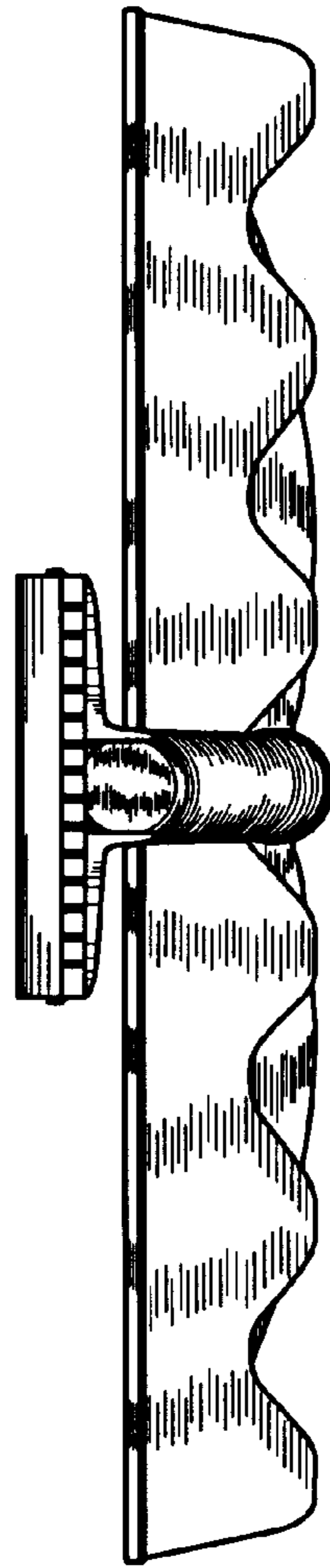

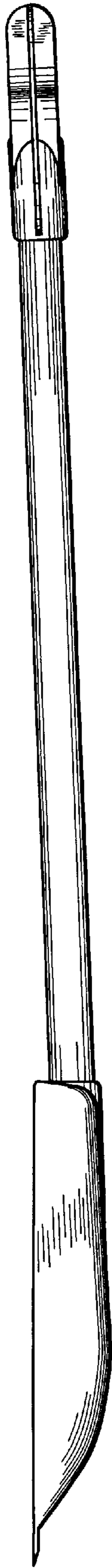

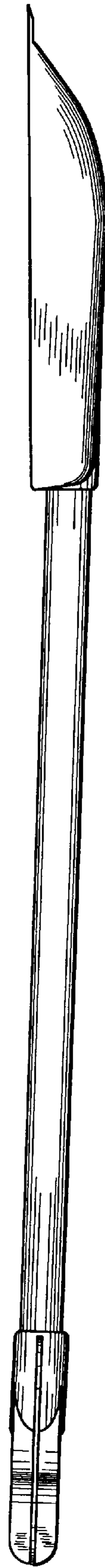

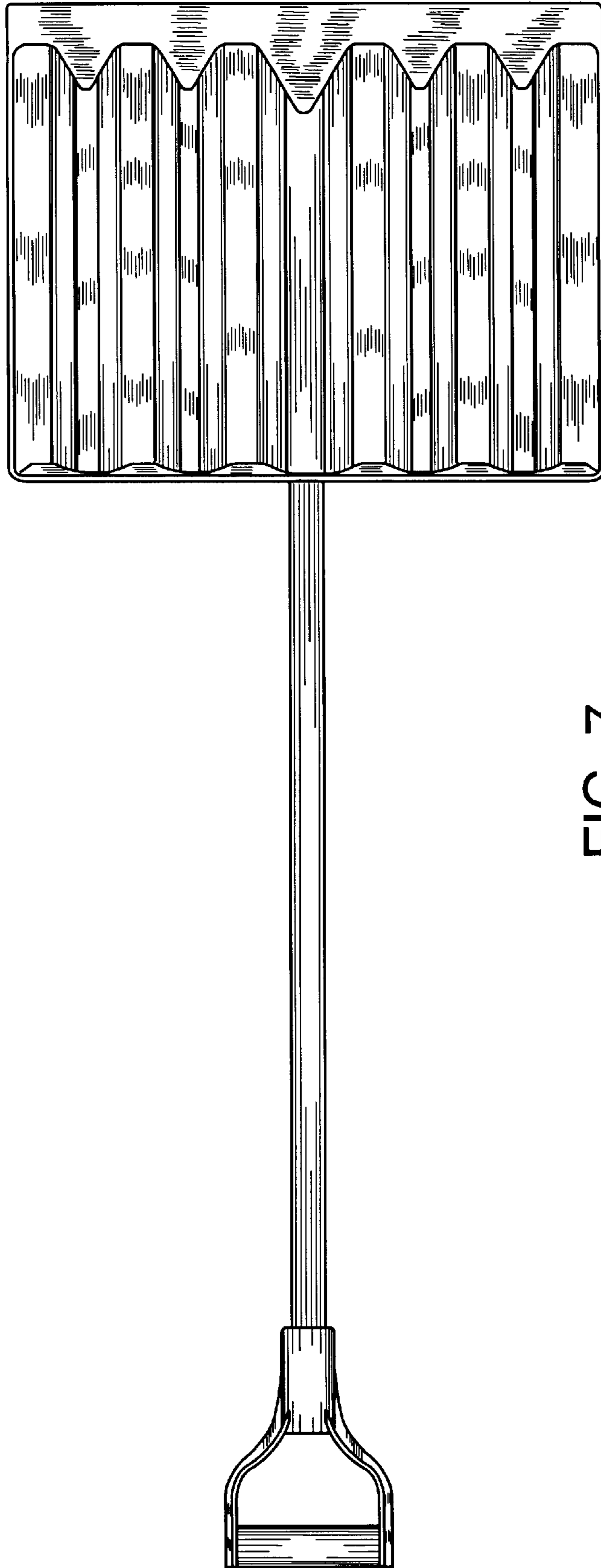

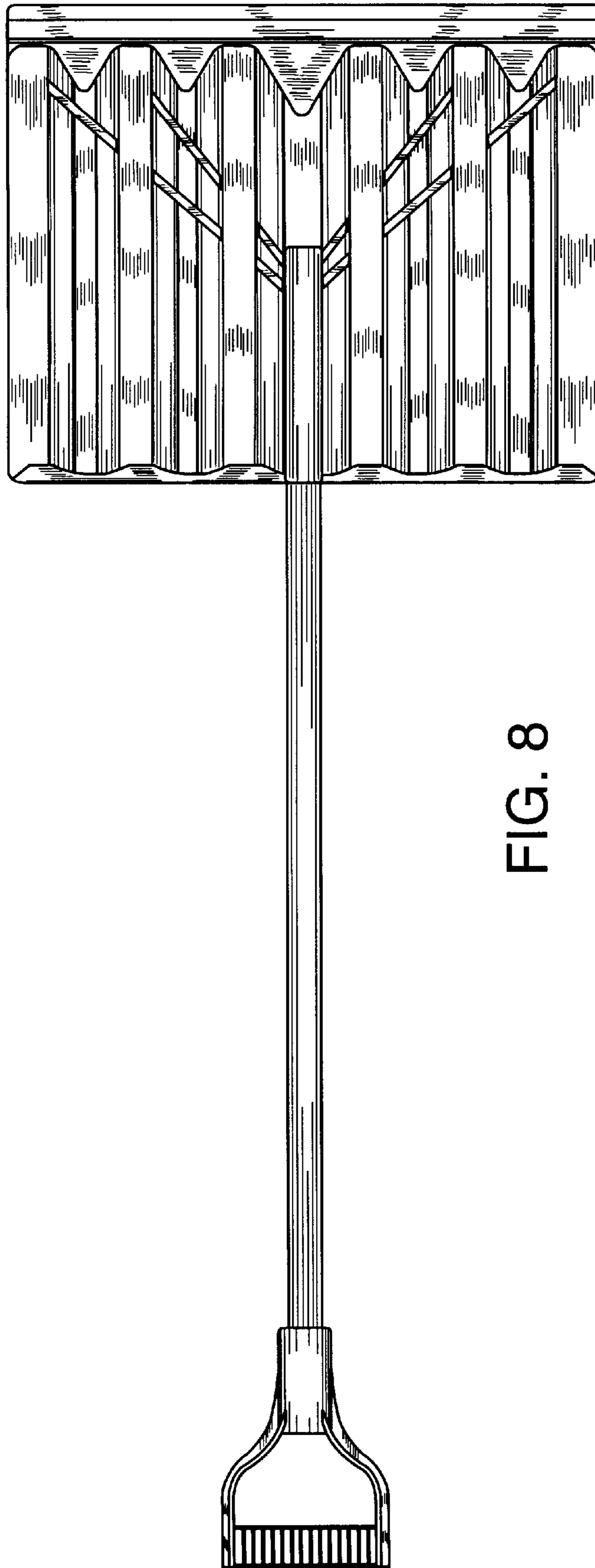

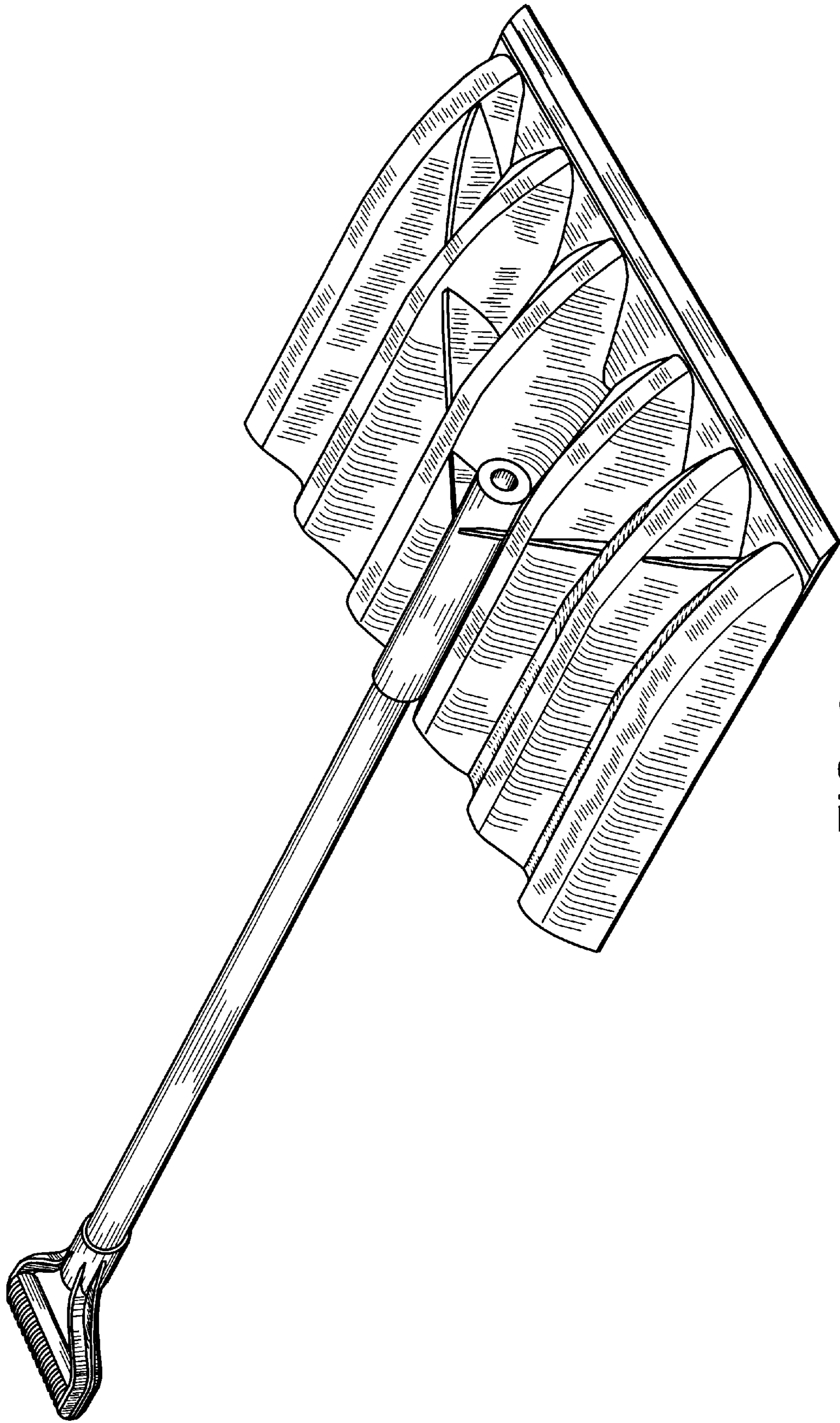
