FIG. 5 shows a bottom end view of the enclosure handle shown in FIG. 1; and,

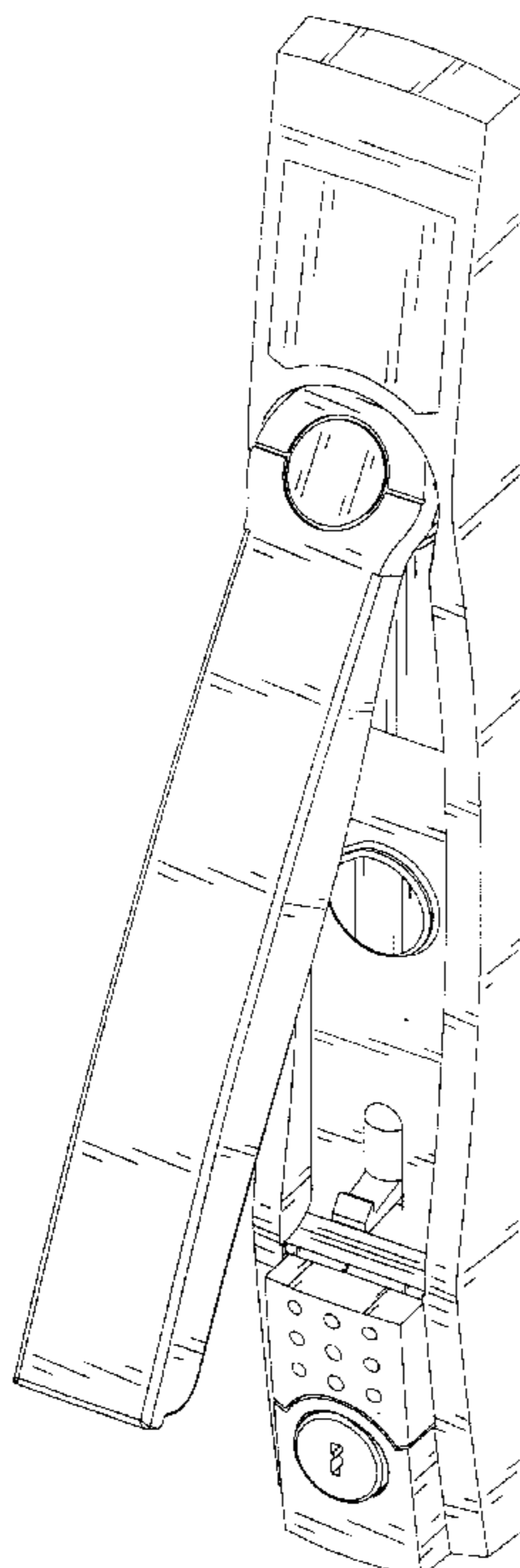
FIG. 6 shows a top end view of the enclosure handle shown in FIG. 1.

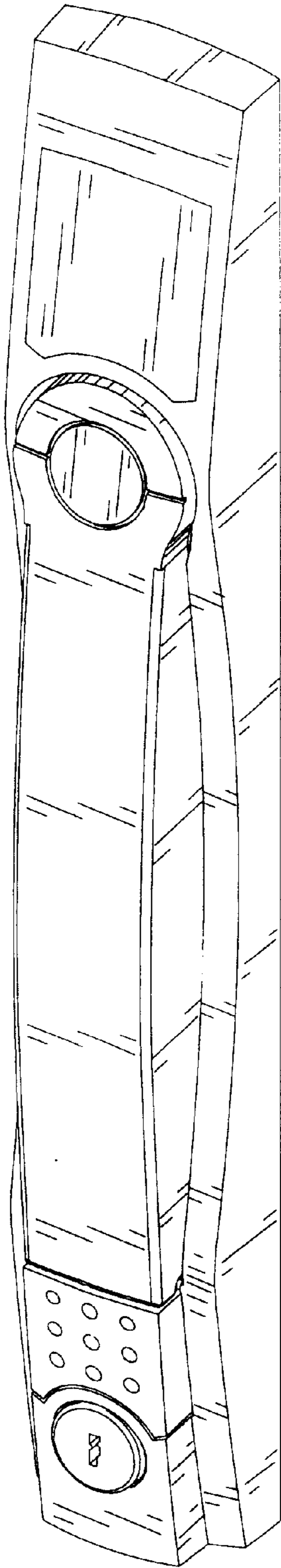

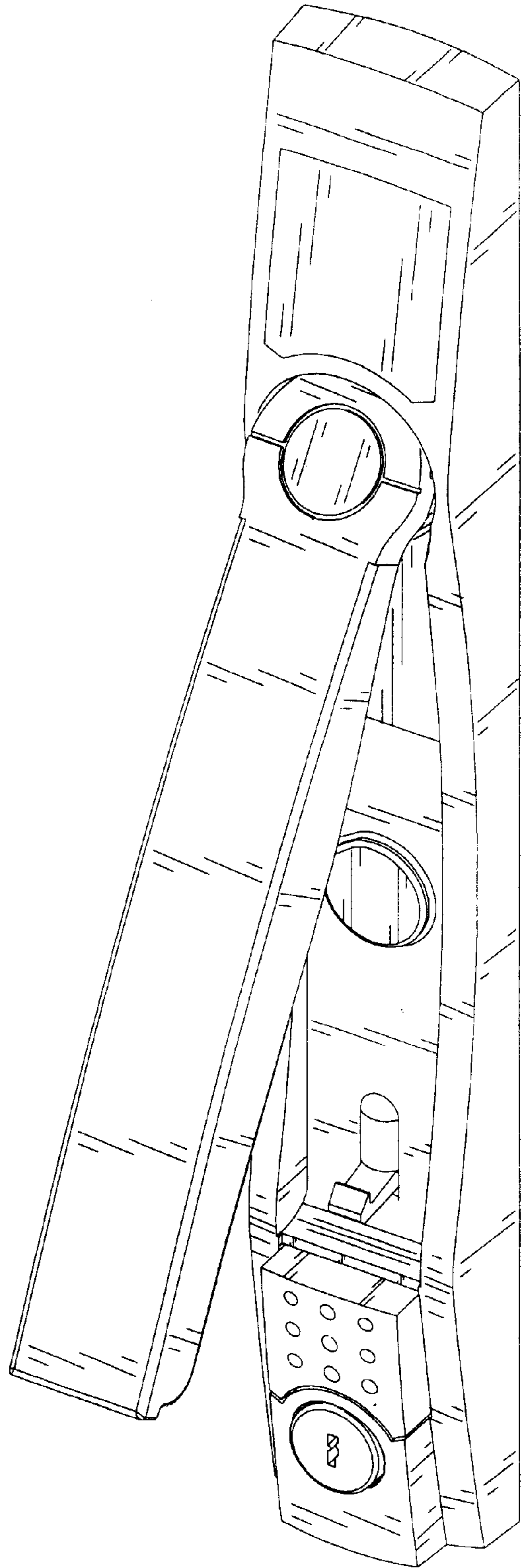

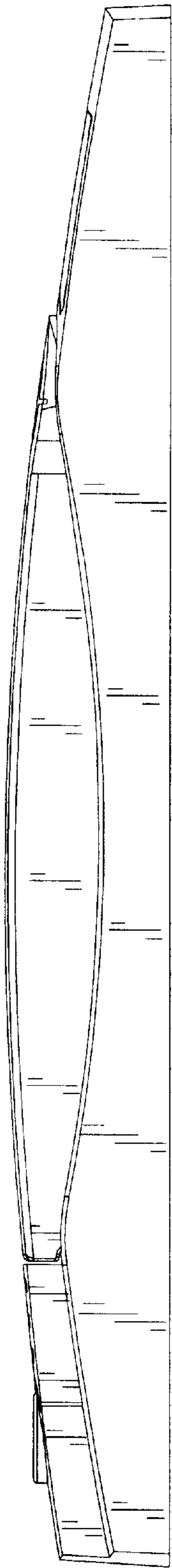

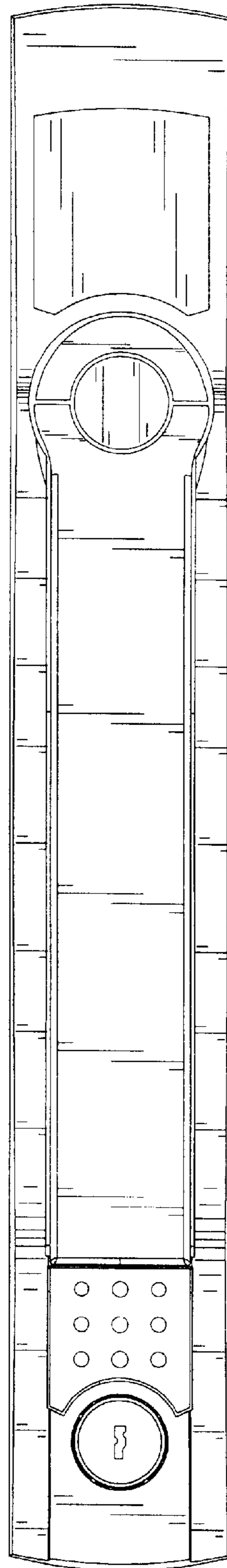

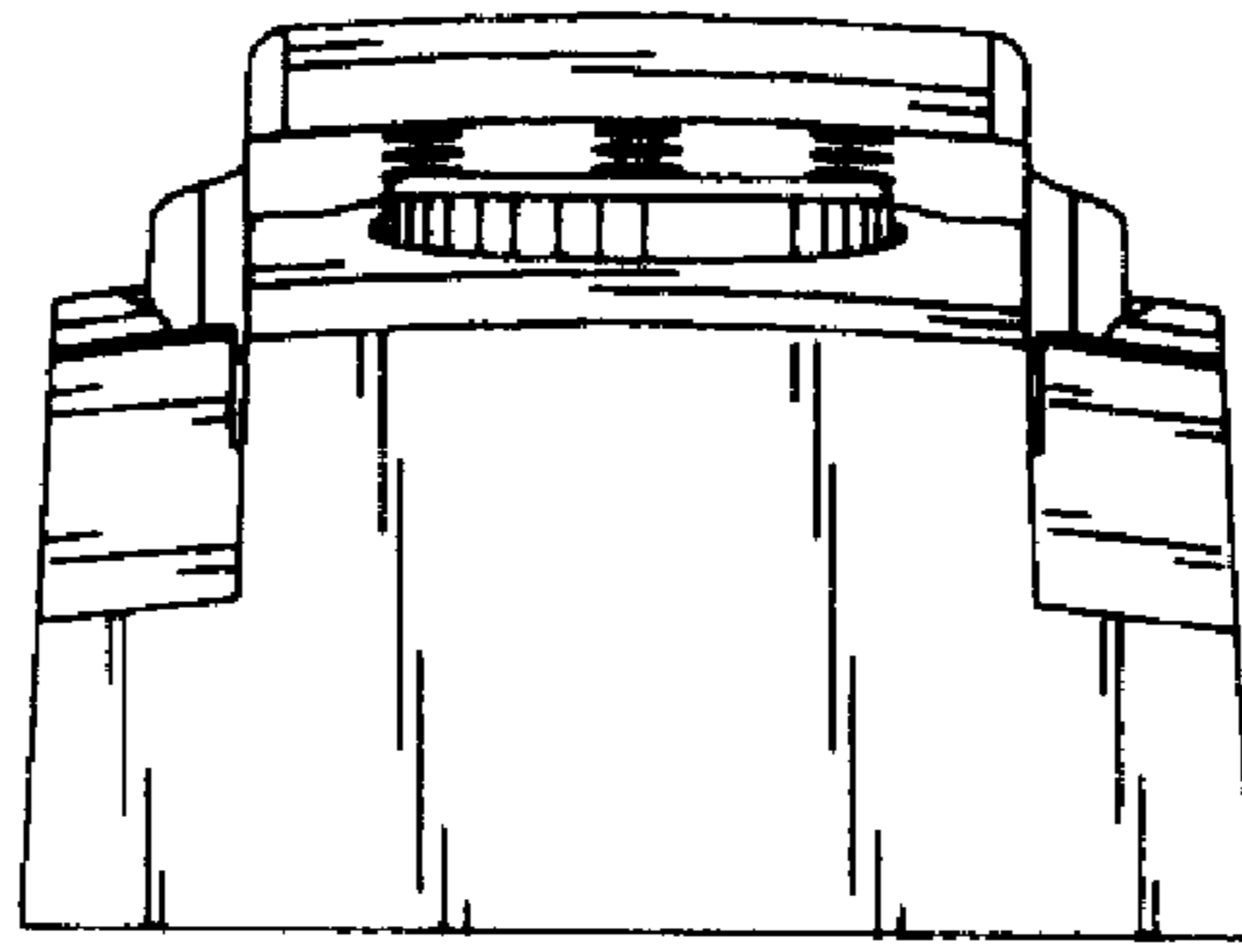

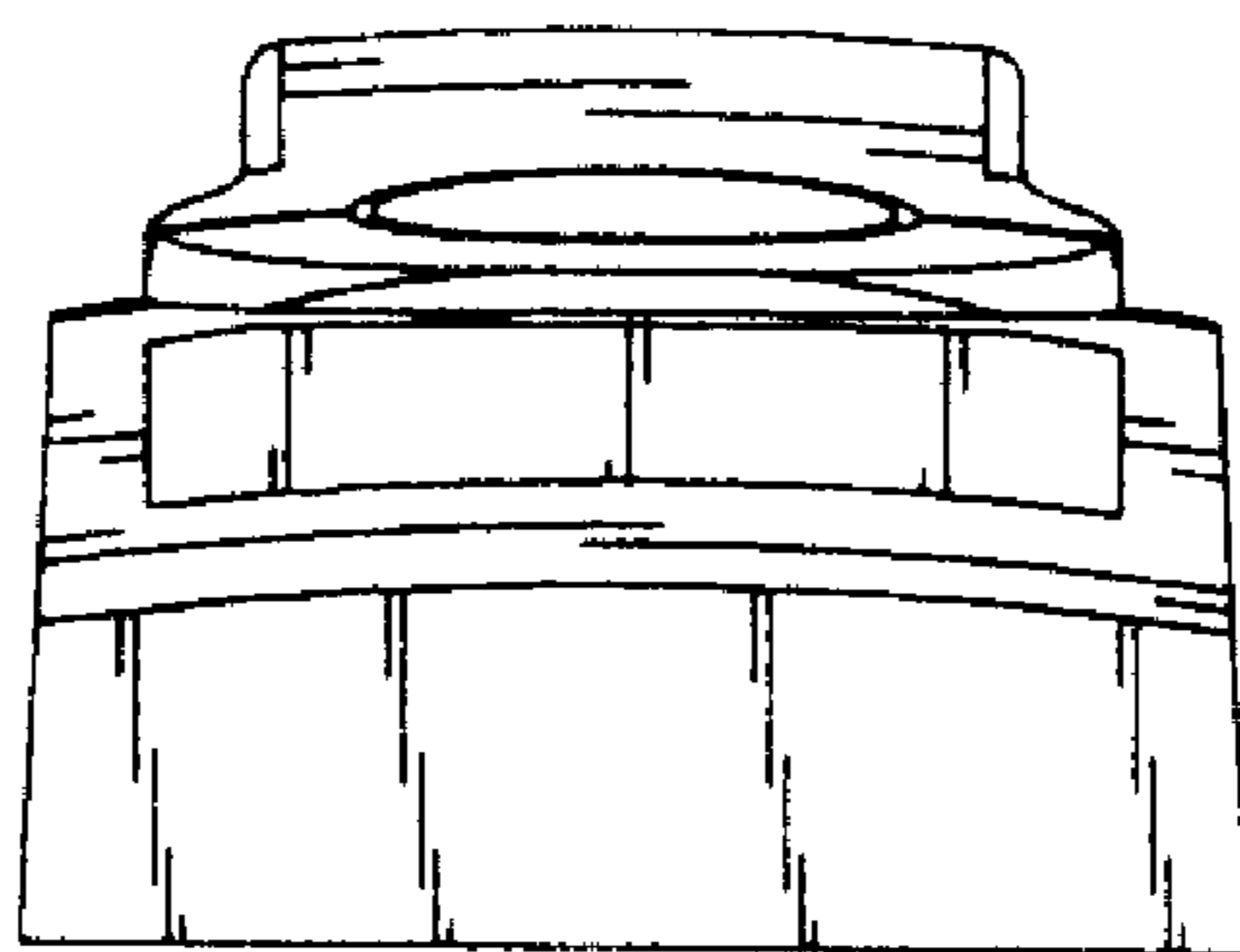
