[57] **CLAIM**

I claim a new ornamental design for animal grave marker, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an animal grave marker showing my new design;

FIG. 2 is a left side elevational view, and the right side elevational view is a mirror image of the left side elevational view;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front elevational view of a second embodiment of an animal grave marker showing my new design;

FIG. 7 is a left side elevational view of the second embodiment for my new design and the right side is a mirror image thereof;

FIG. 8 is a rear elevational view of the second embodiment for ornamental design for animal grave marker;

FIG. 9 is a top plan view thereof;

FIG. 10 is a bottom plan view thereof;

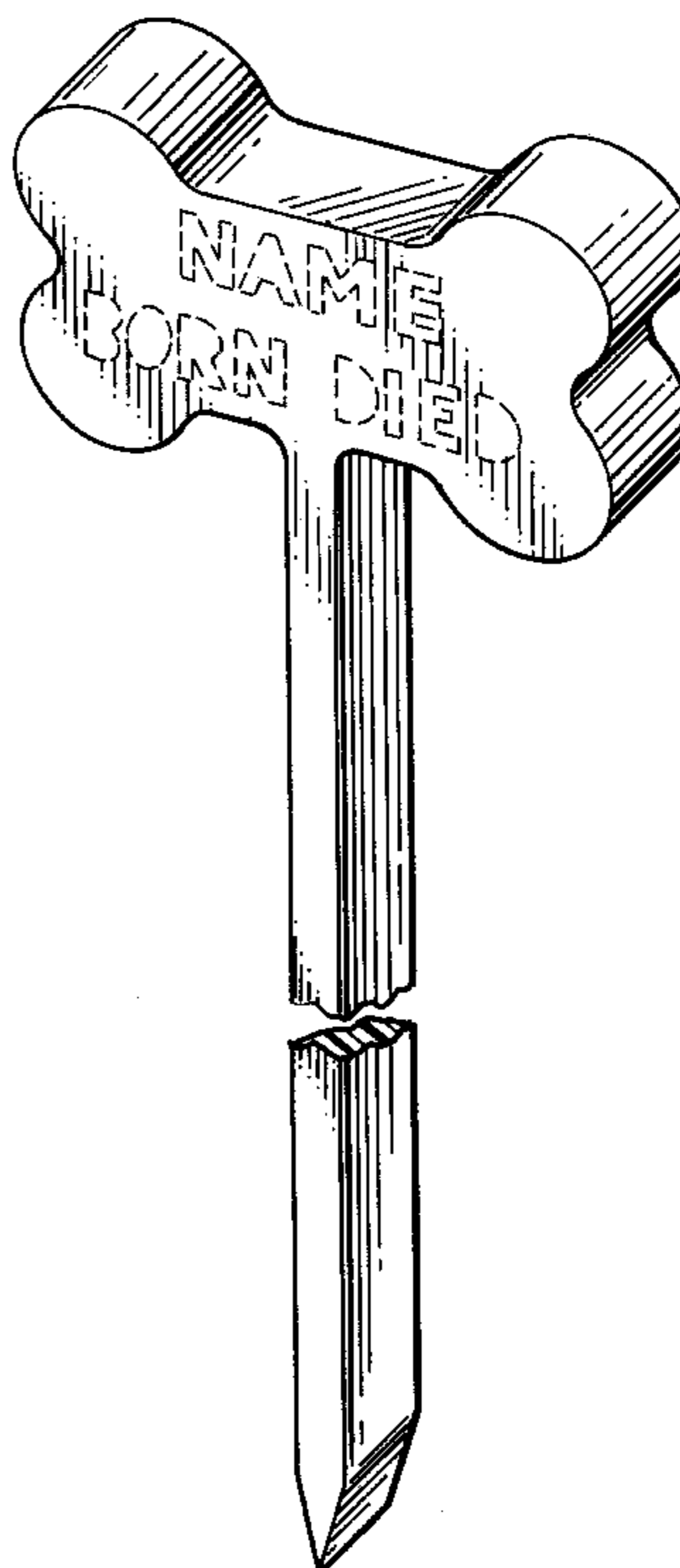
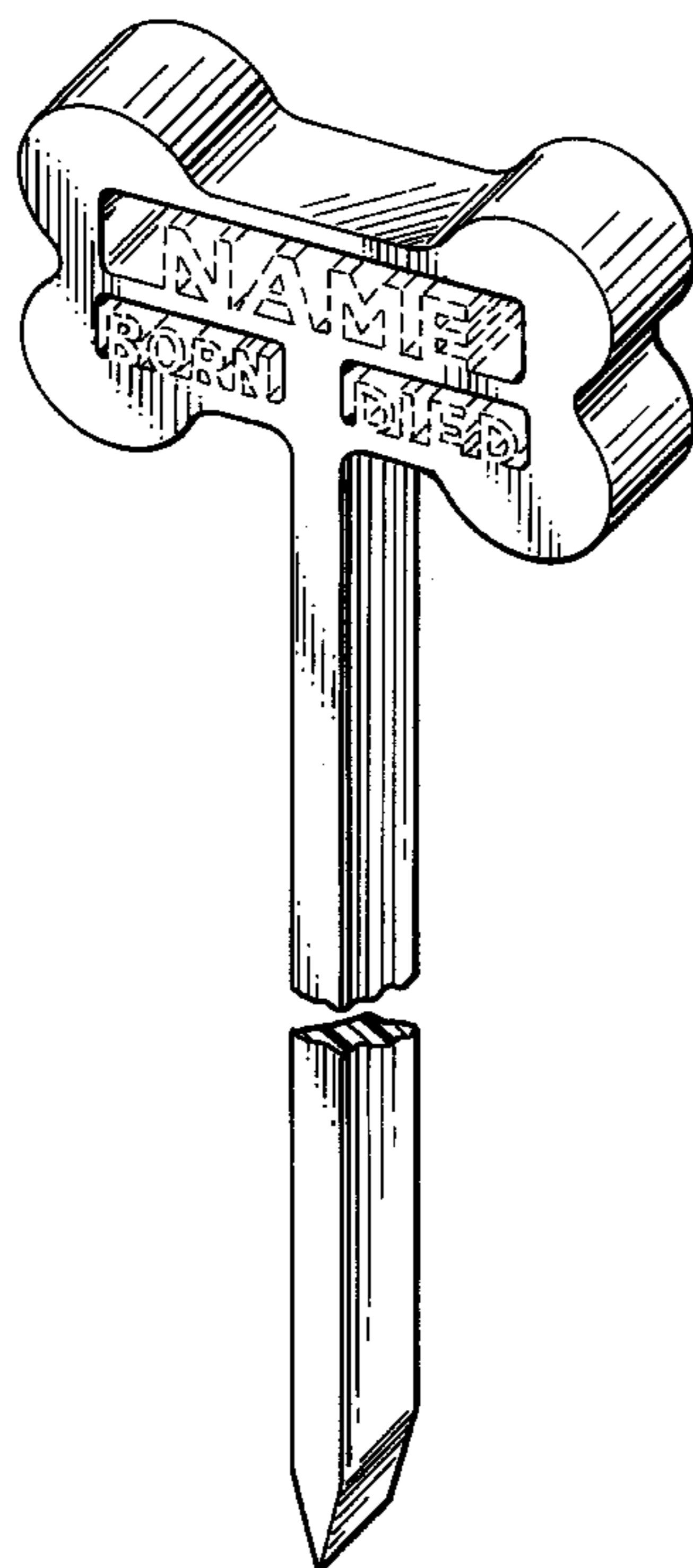
FIG. 11 is a front perspective view of the embodiment of FIG. 1; and,

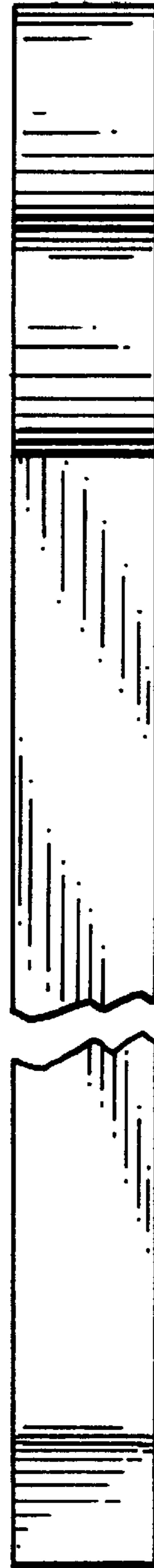
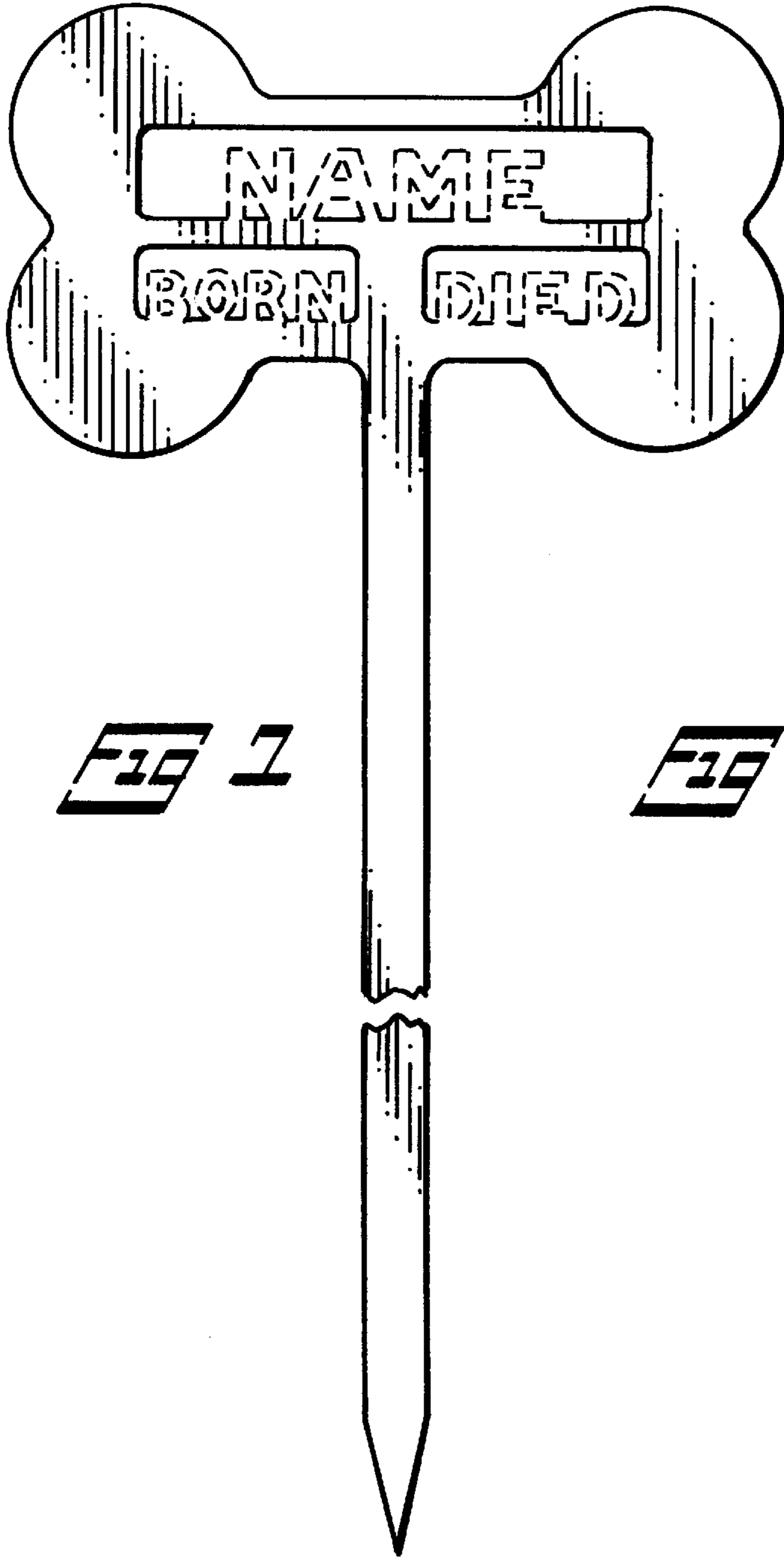
FIG. 12 is a front perspective view of the embodiment of FIG. 6.

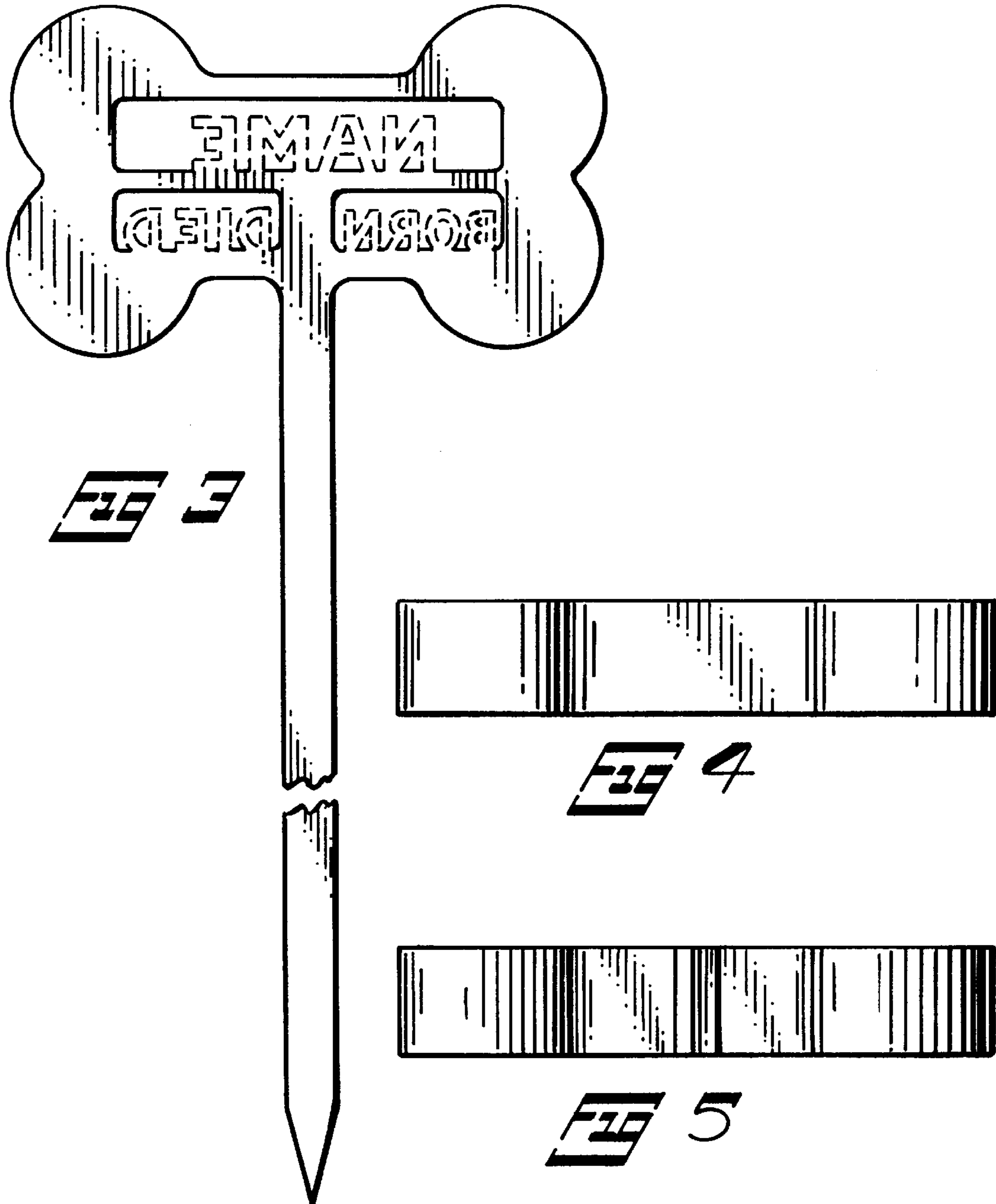
The stem is shown broken away in the FIGS. 1, 2, 3, 6, 7, 8, 11 and 12 to indicate indeterminate length.

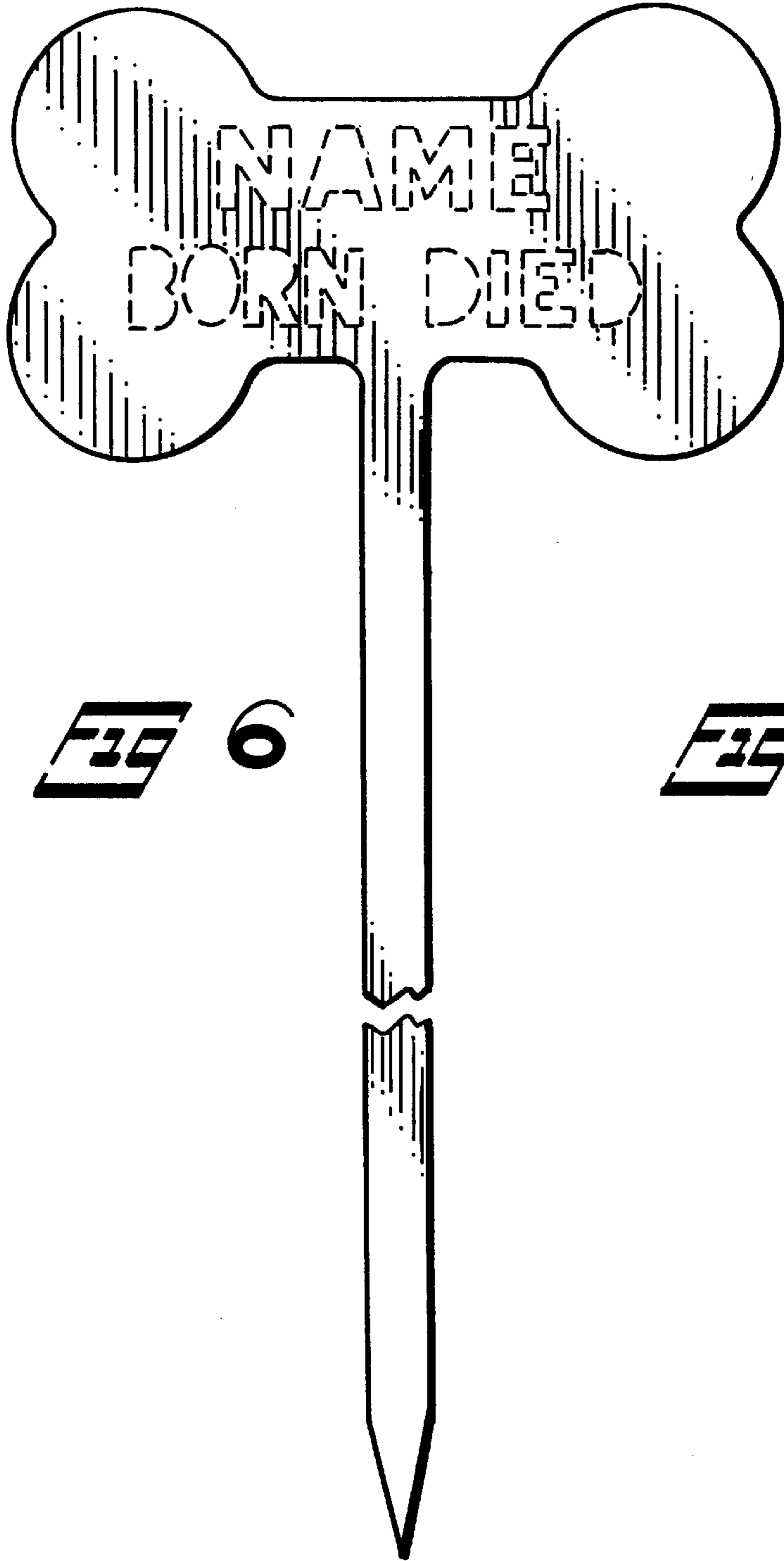

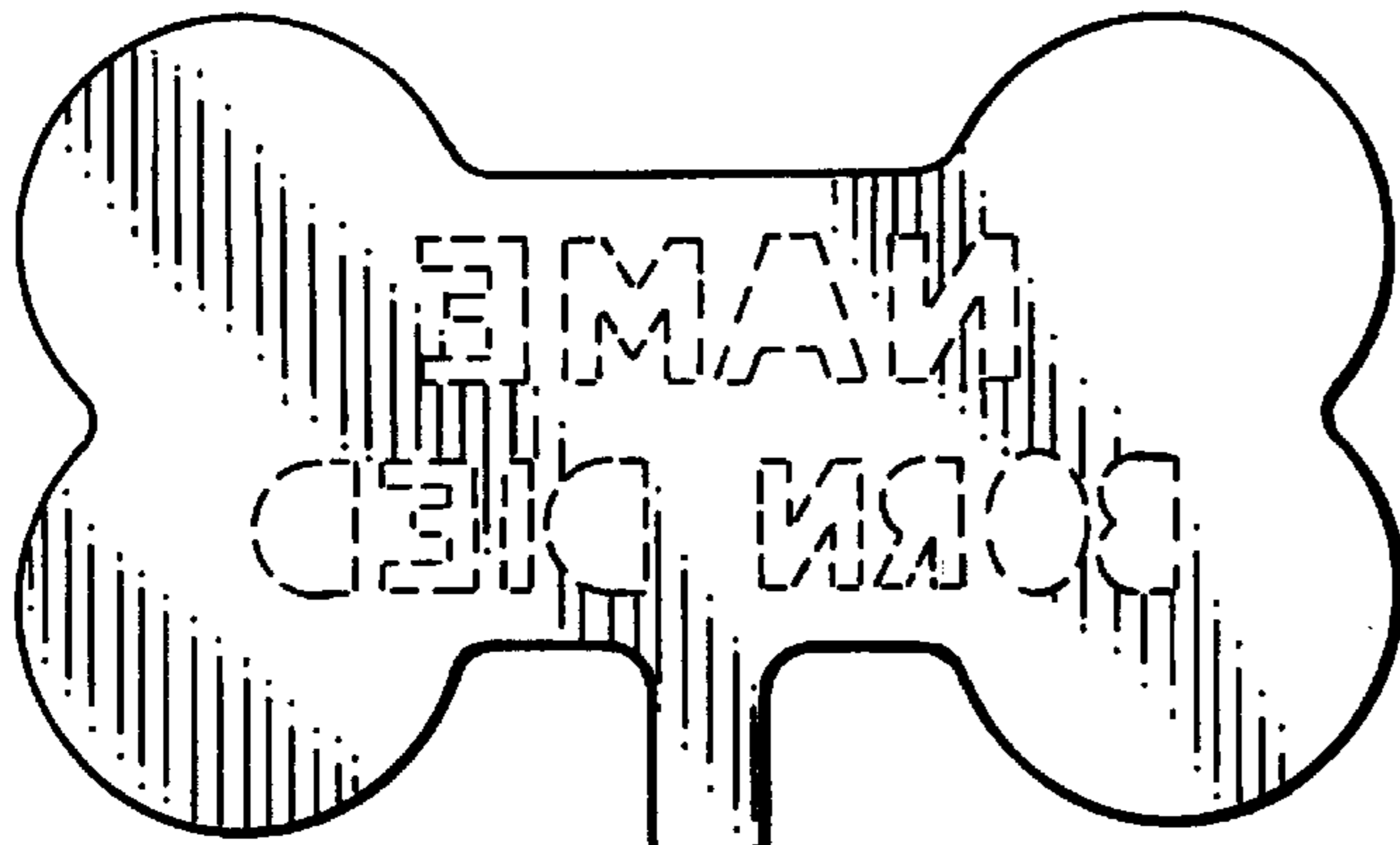

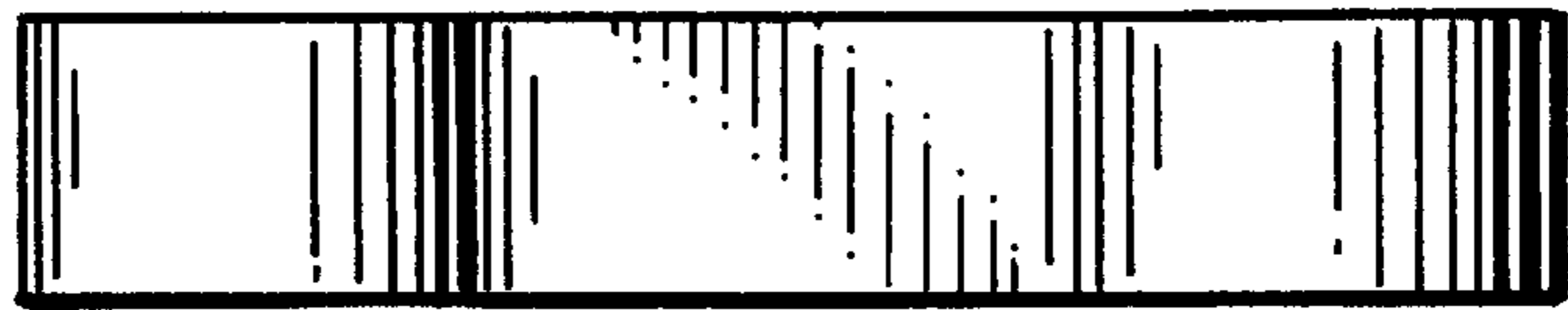
