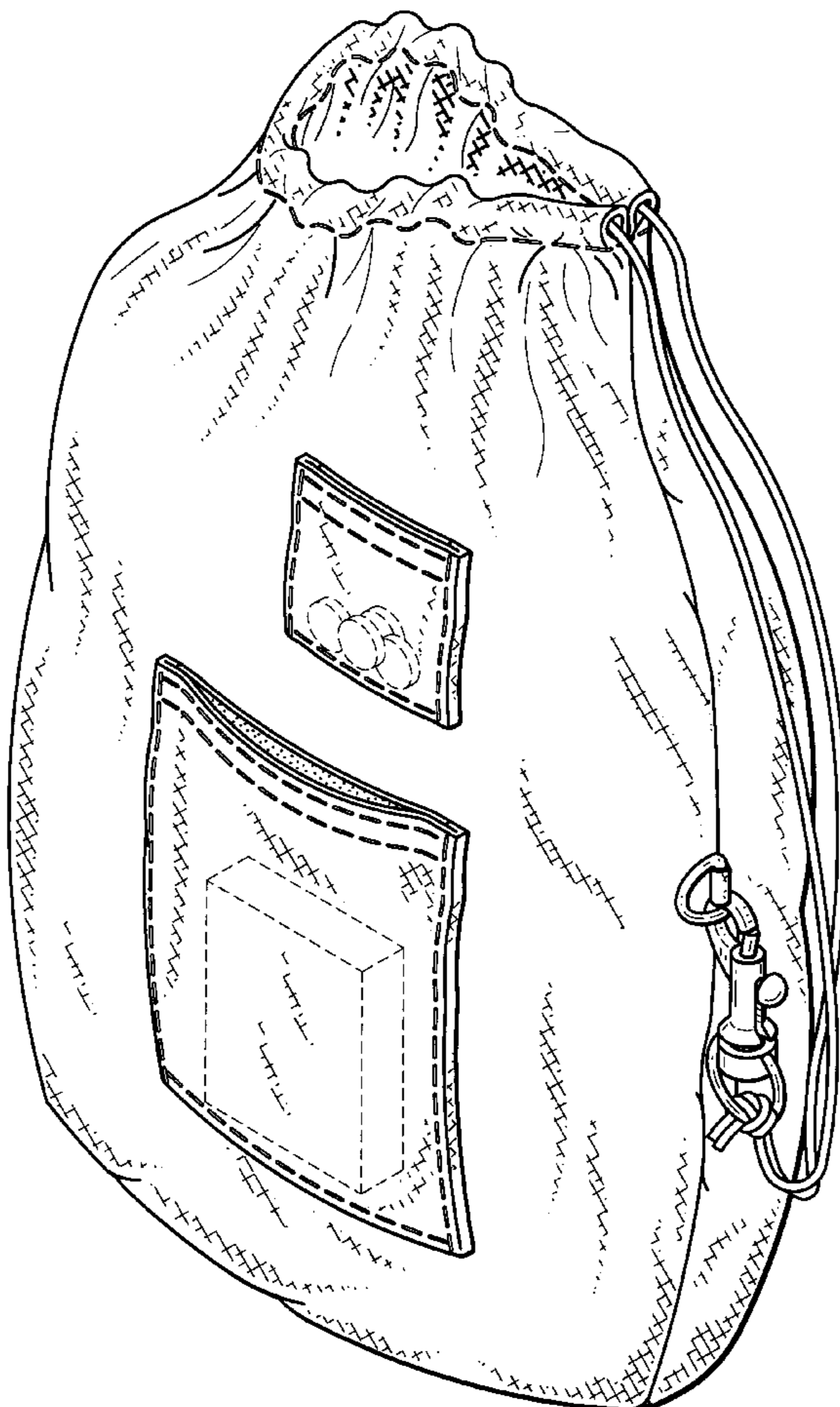
[57] **CLAIM**

The ornamental design for a laundry bag with external pockets, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of my new design for a laundry bag with external pockets showing the bag empty; FIG. 2 is a front elevation view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a left side elevation view thereof; and, FIG. 8 is a perspective view of my laundry bag showing the bag full and the pockets loaded with soap and coins. The dashed lines showing the coins and soap are for illustrative purposes only and form no part of the claimed design. The cross-hatching shading in all the figures is fragmentarily shown for convenience of illustration, it being understood that the cross-hatching is uniformly continuous over the surface on which it appears.

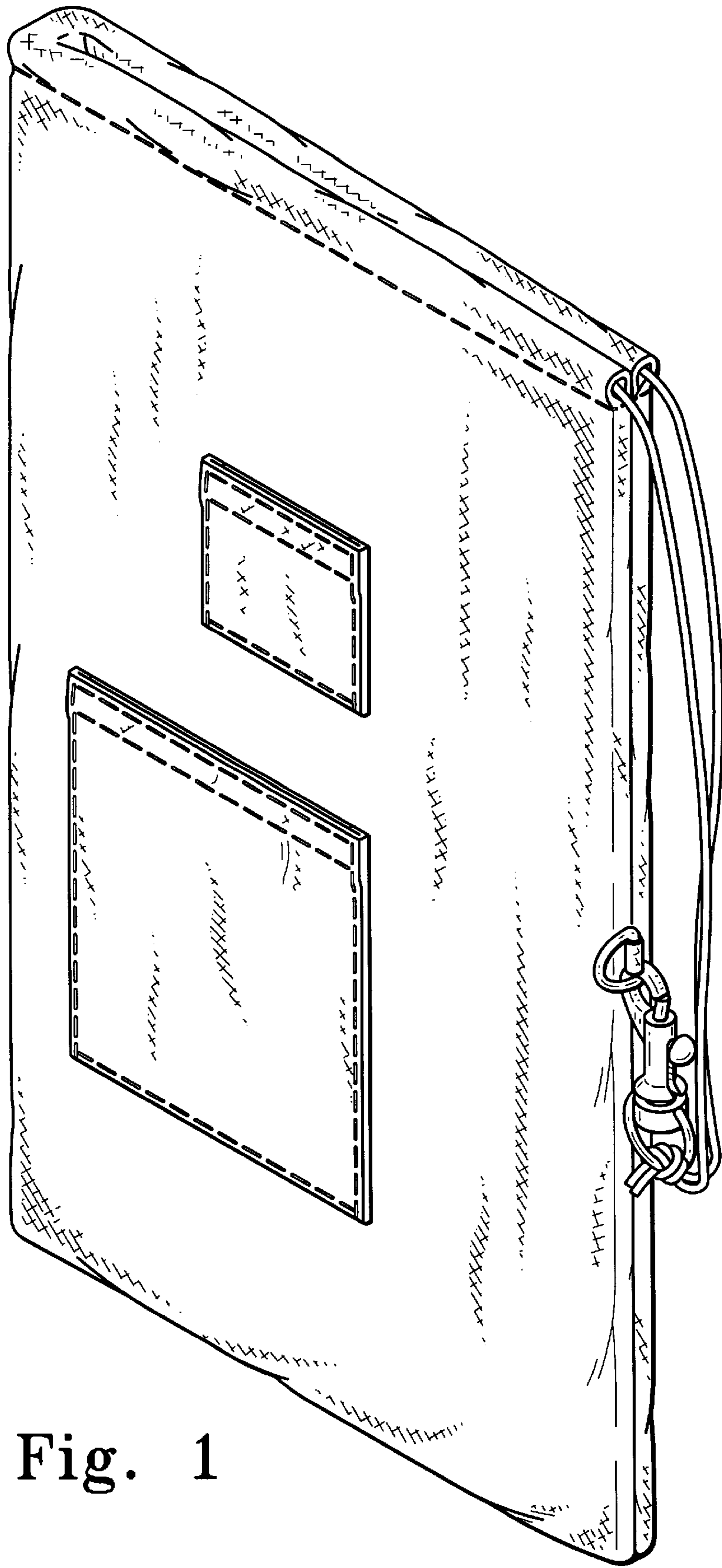

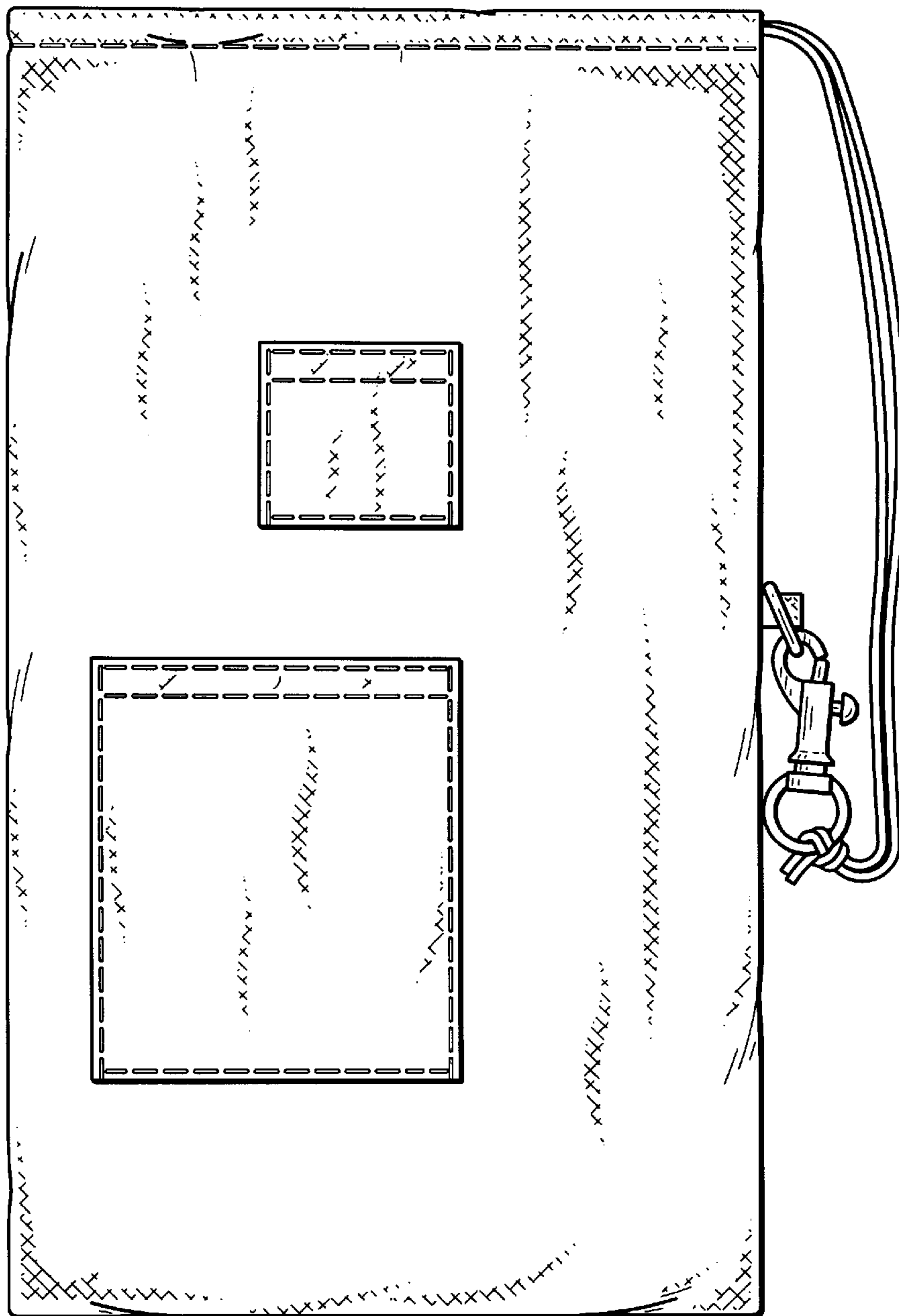

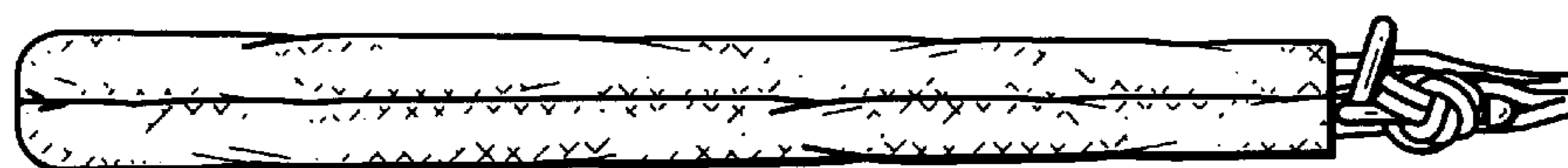

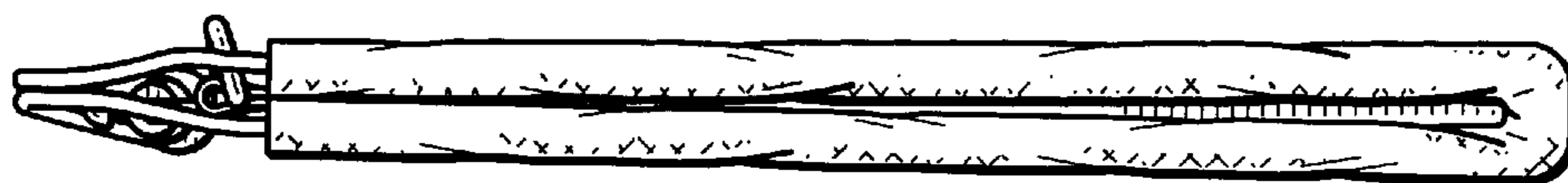

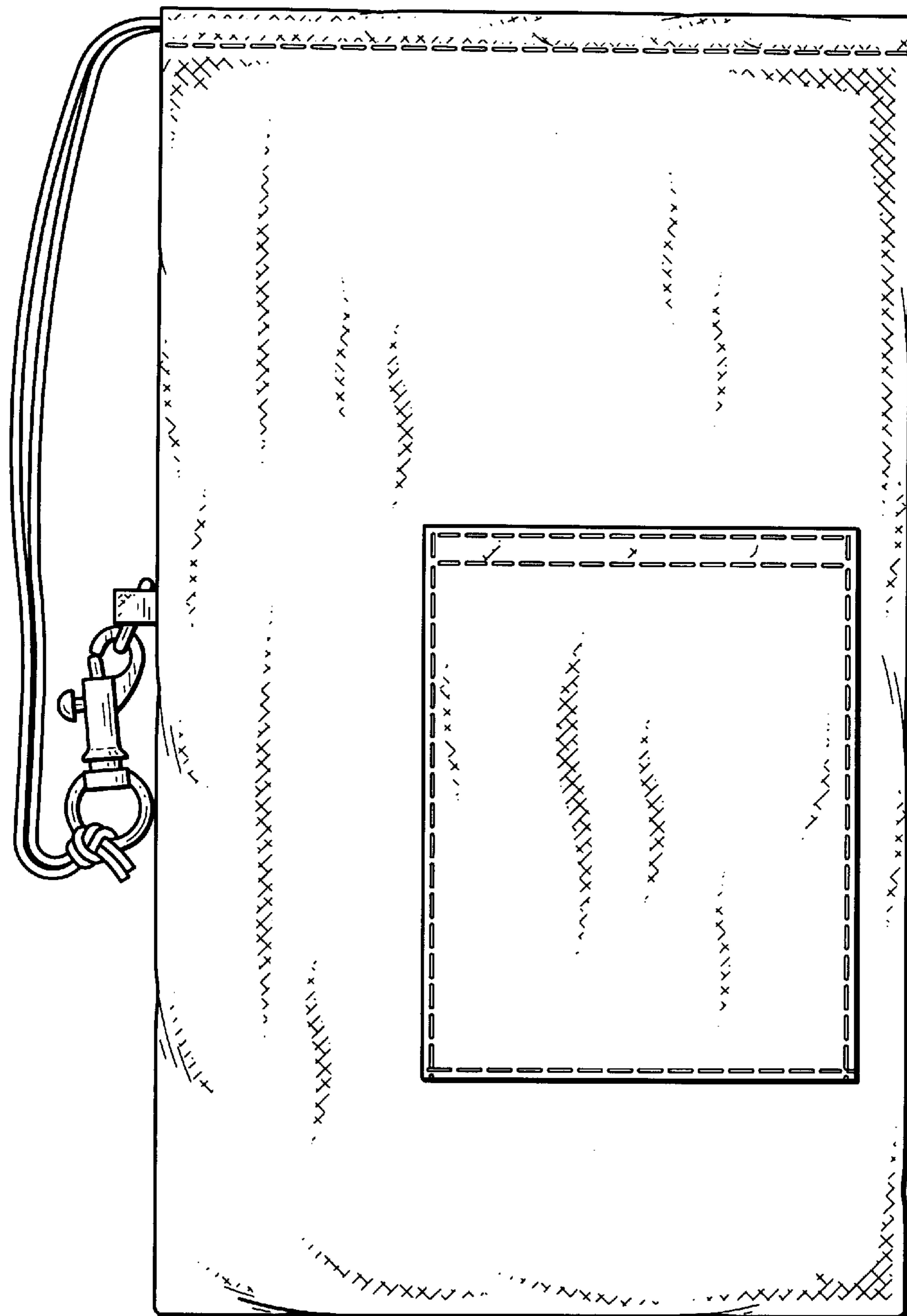

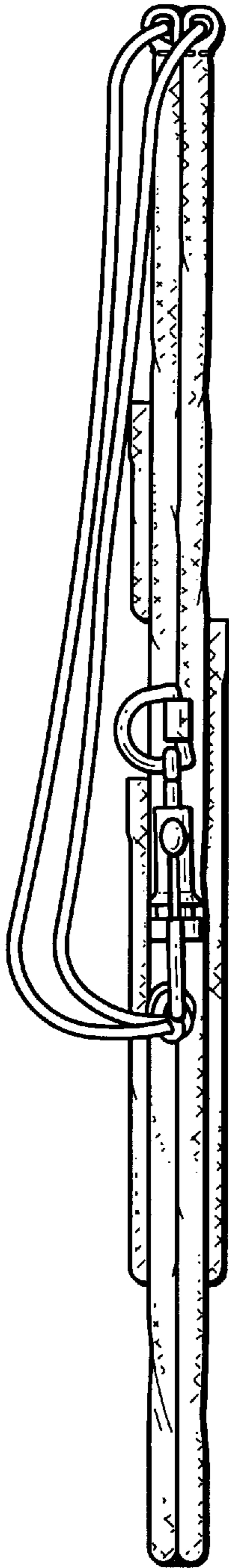

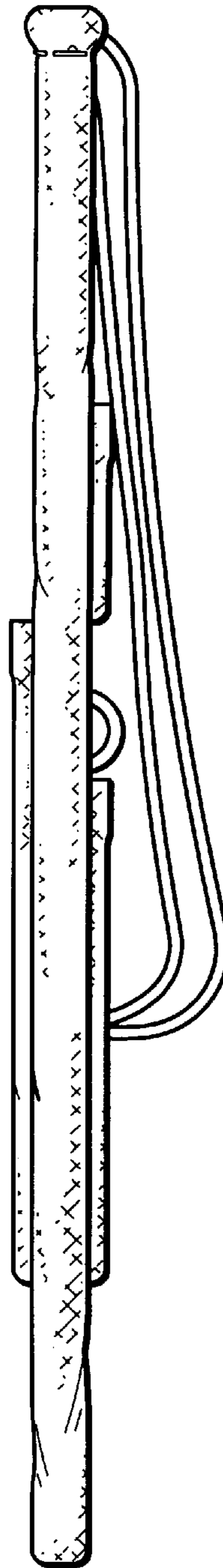

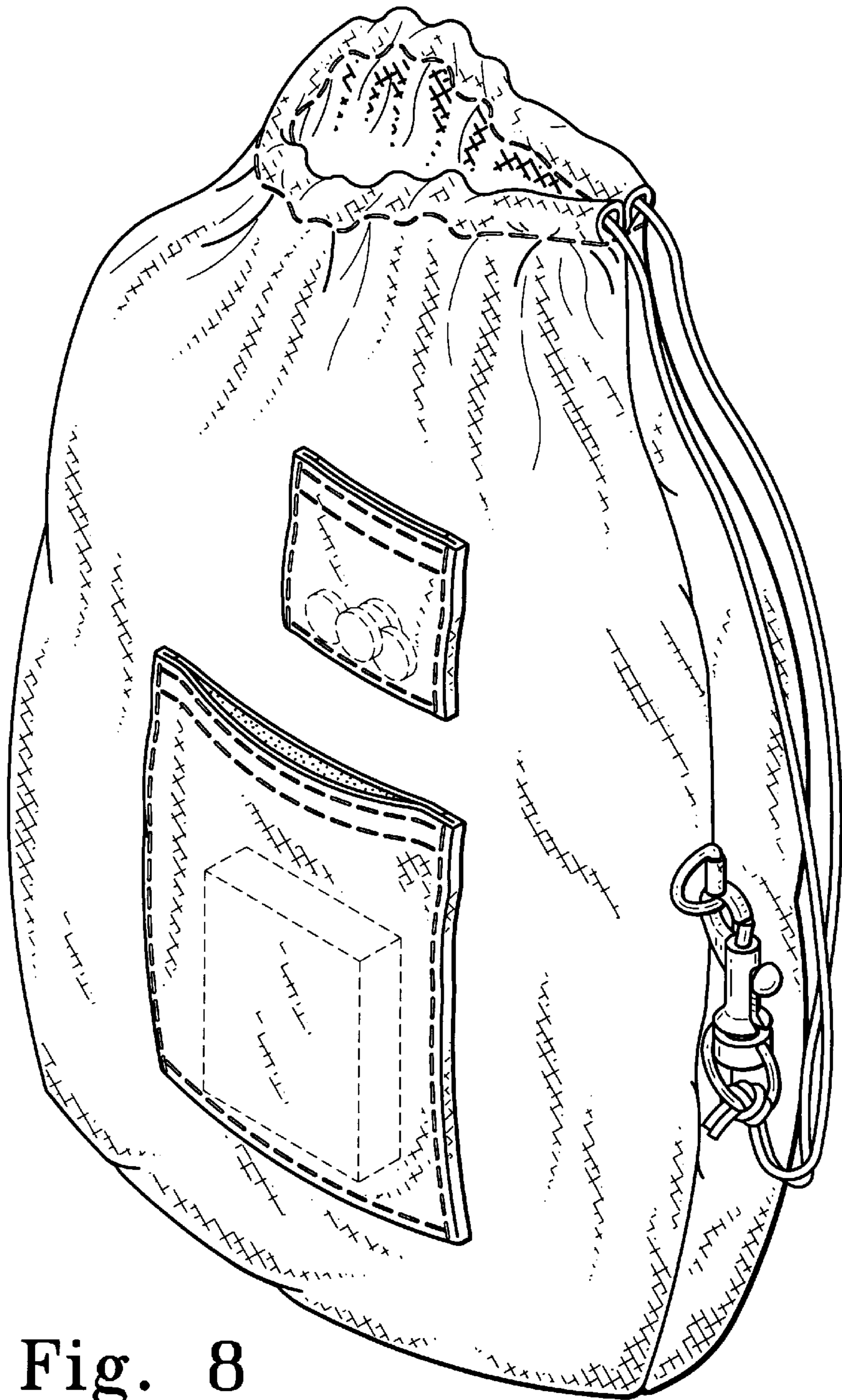
