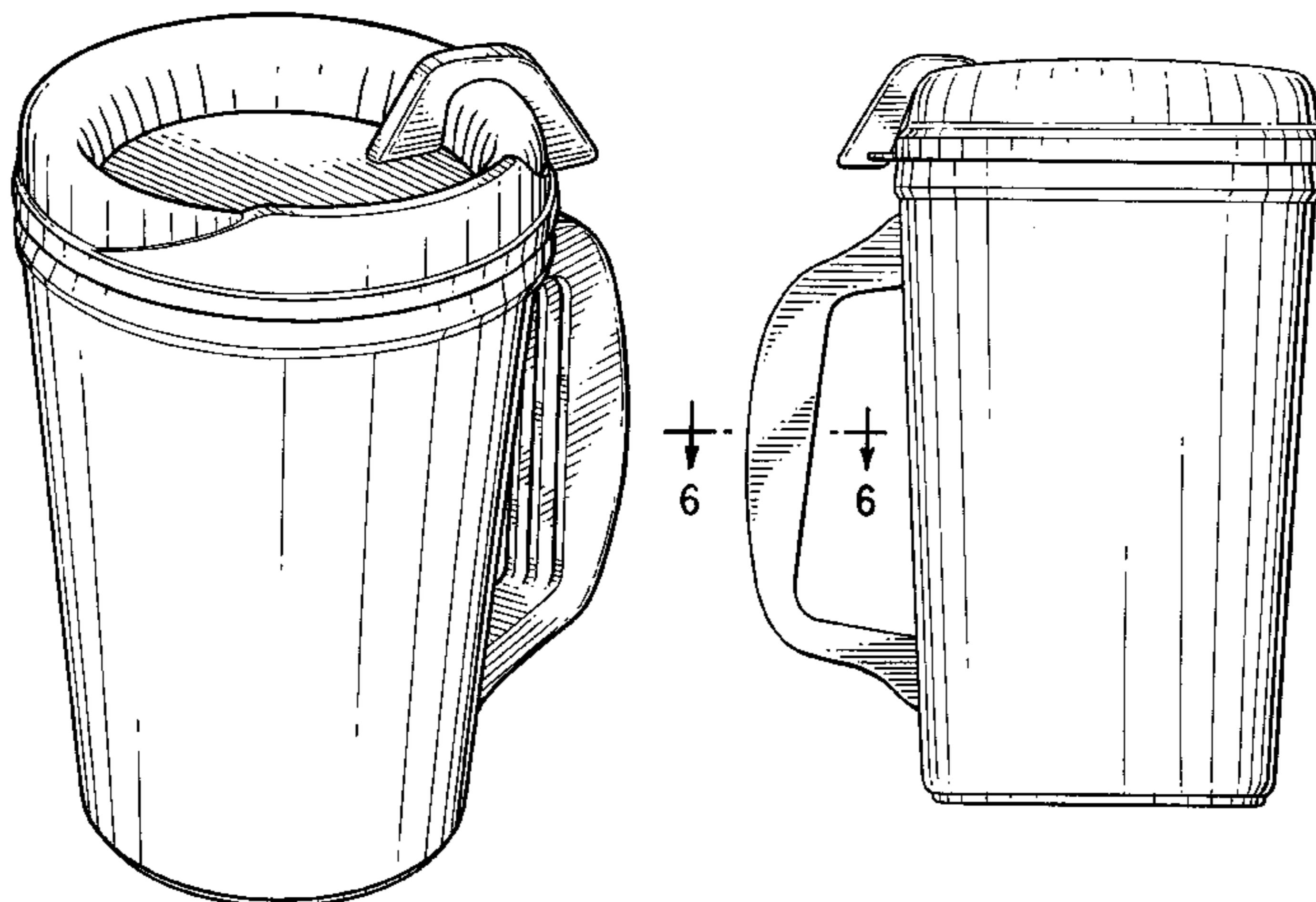
[57] CLAIM

The ornamental design for a beverage mug with lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a beverage mug with lid showing my new design;
 FIG. 2 is an exploded perspective view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a cross-sectional view thereof taken along line 6—6 of FIG. 5 showing the handle porting with the rest of the mug and lid portion removed for ease illustration;
 FIG. 7 is a right side elevational view of a Beverage Mug with Lid;
 FIG. 8 is a cross-sectional view thereof taken along line 8—8 of FIG. 4 showing the lid portion with the rest of the mug removed for ease of illustration.
 FIG. 9 is a bottom plan view of a beverage mug with lid;
 FIG. 10 is a perspective view thereof, taken from the side opposite that of FIG. 1; and,
 FIG. 11 is a perspective view thereof with the closure disk removed for ease of illustration.

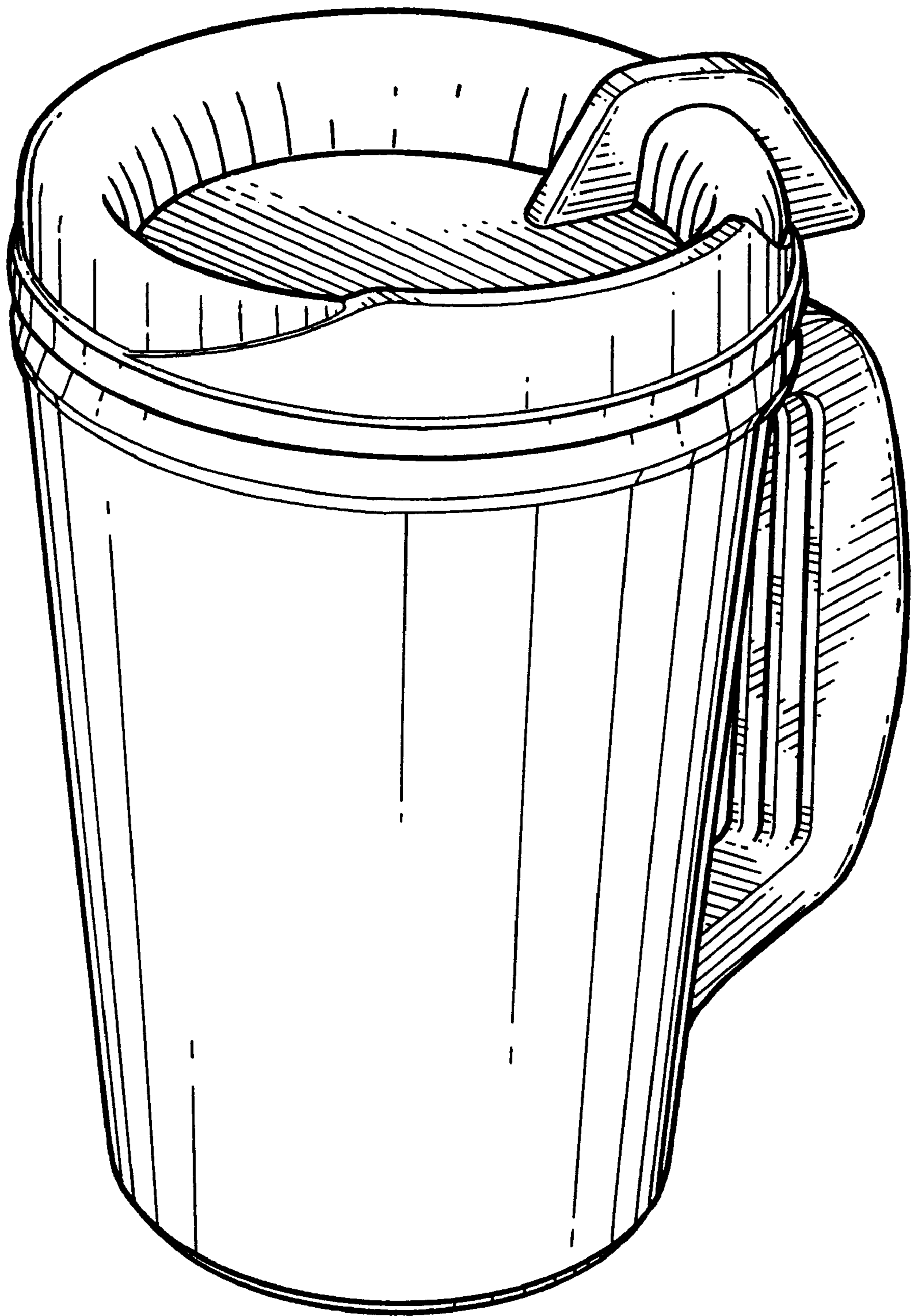

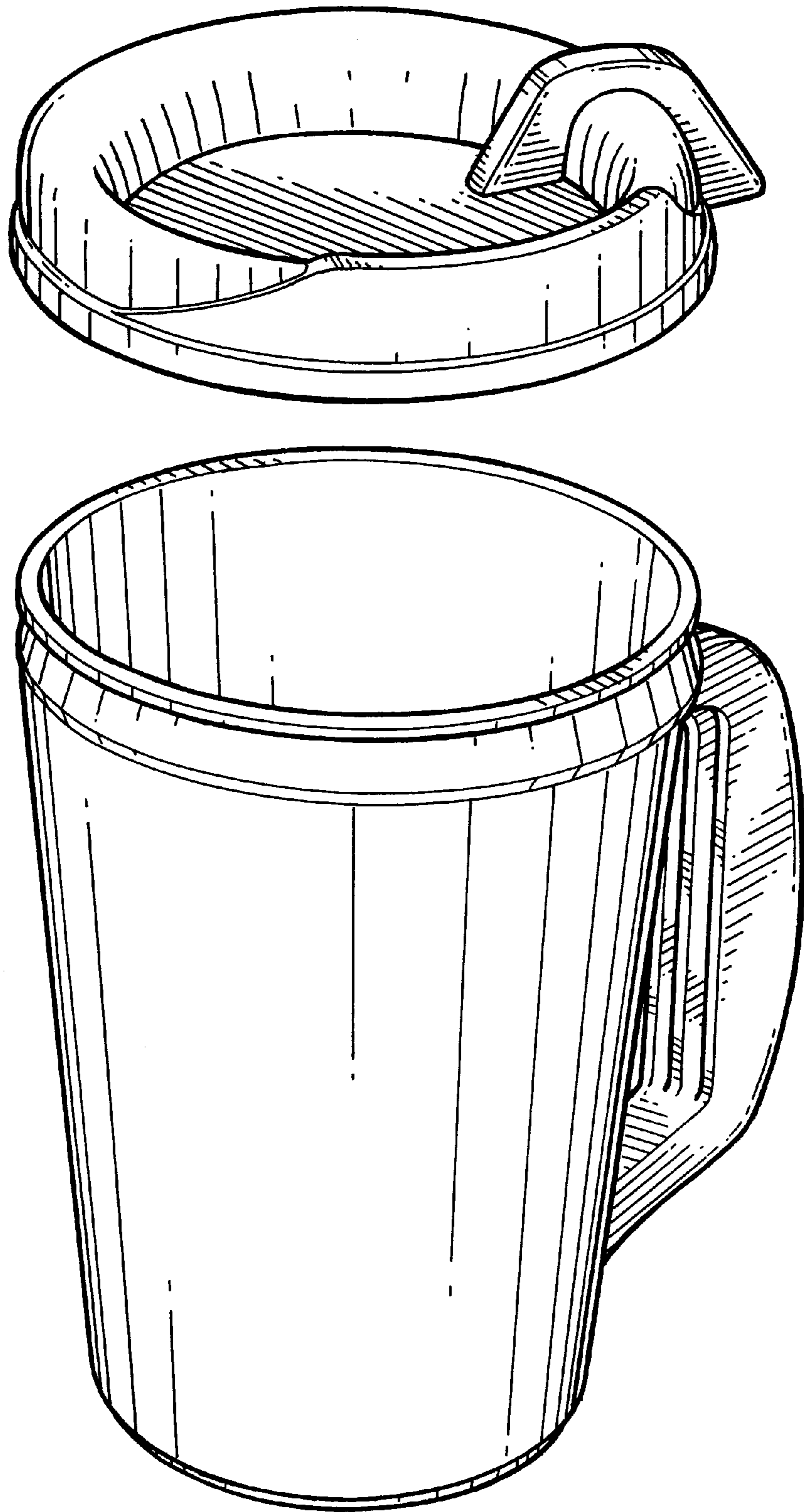

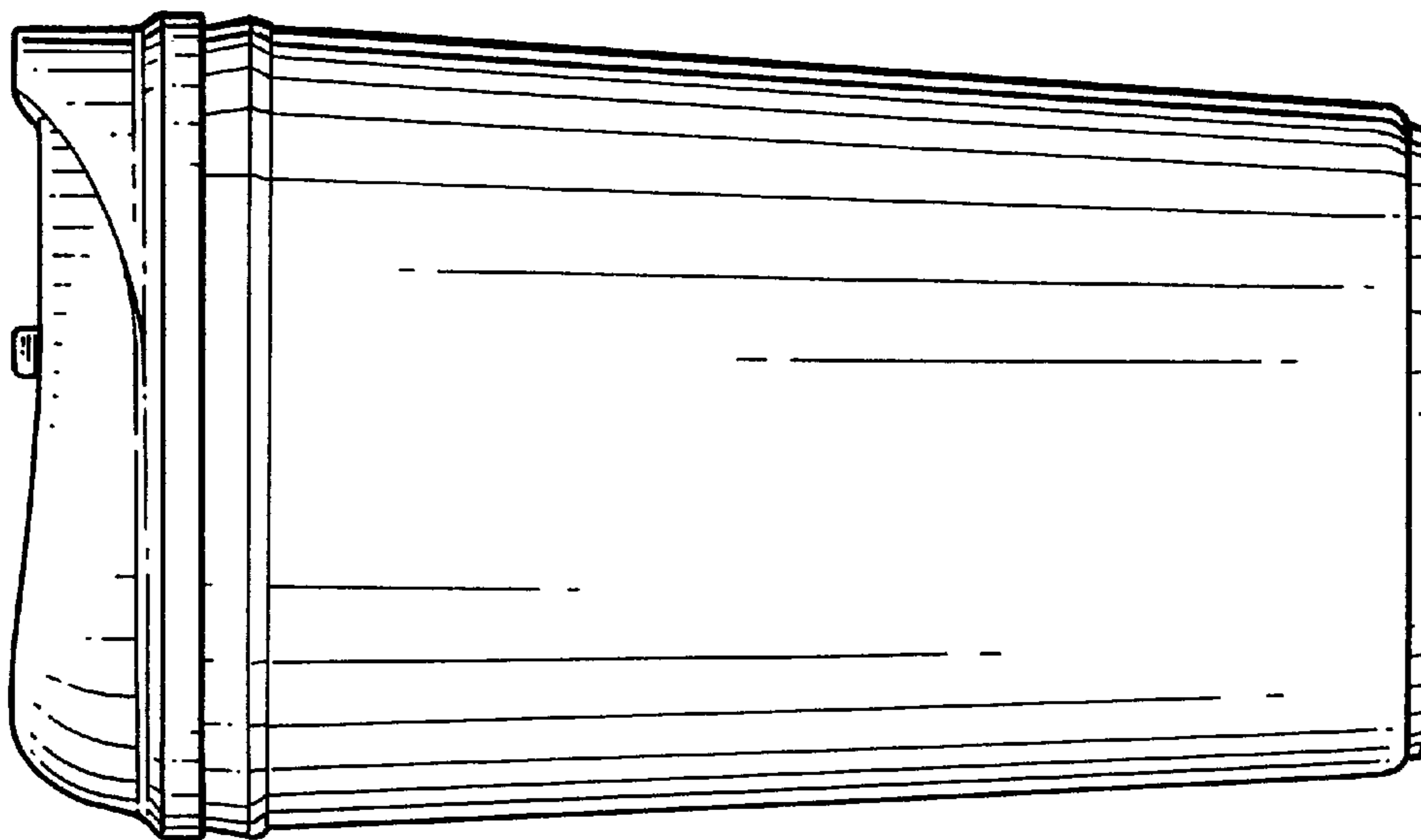

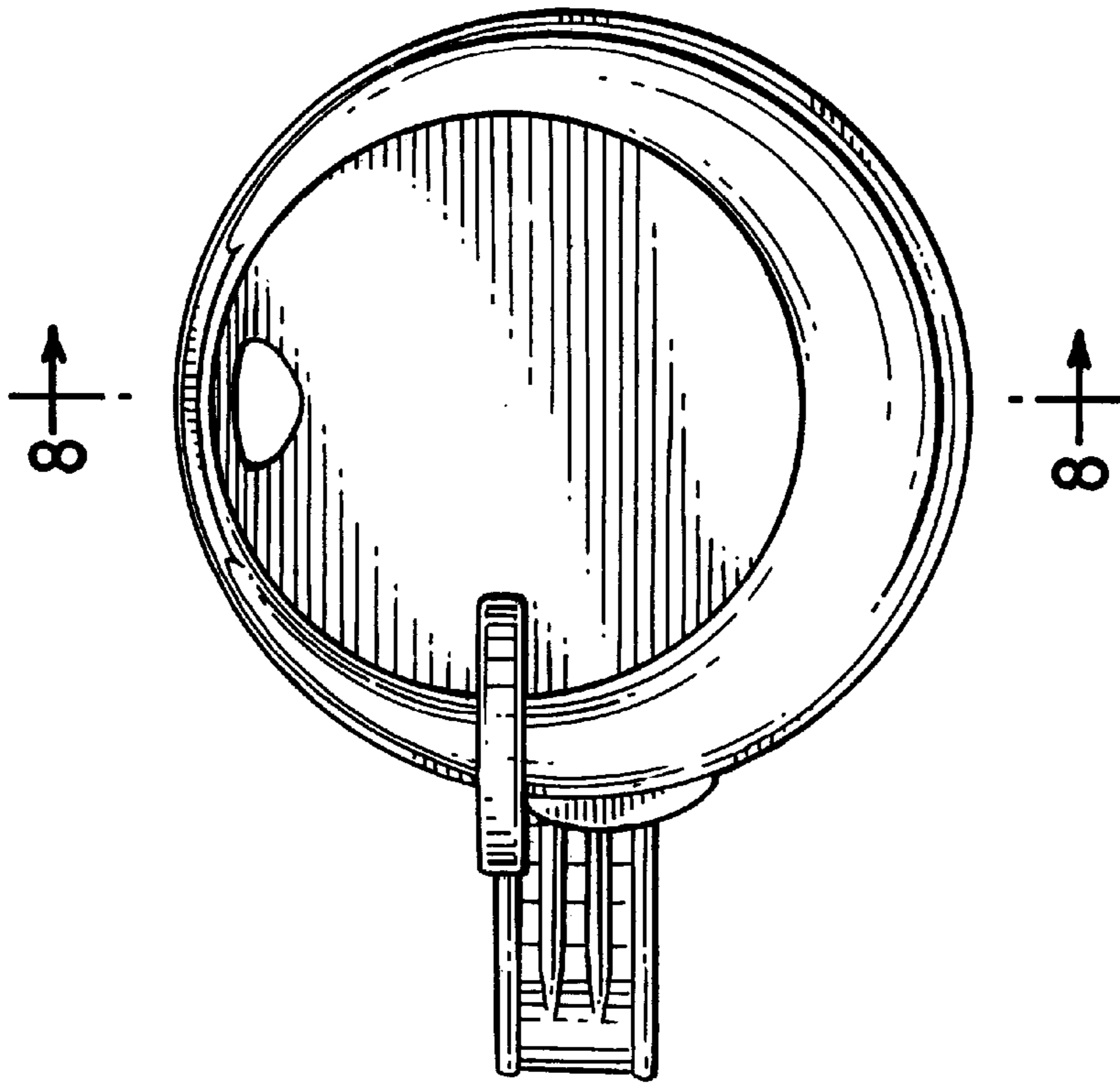

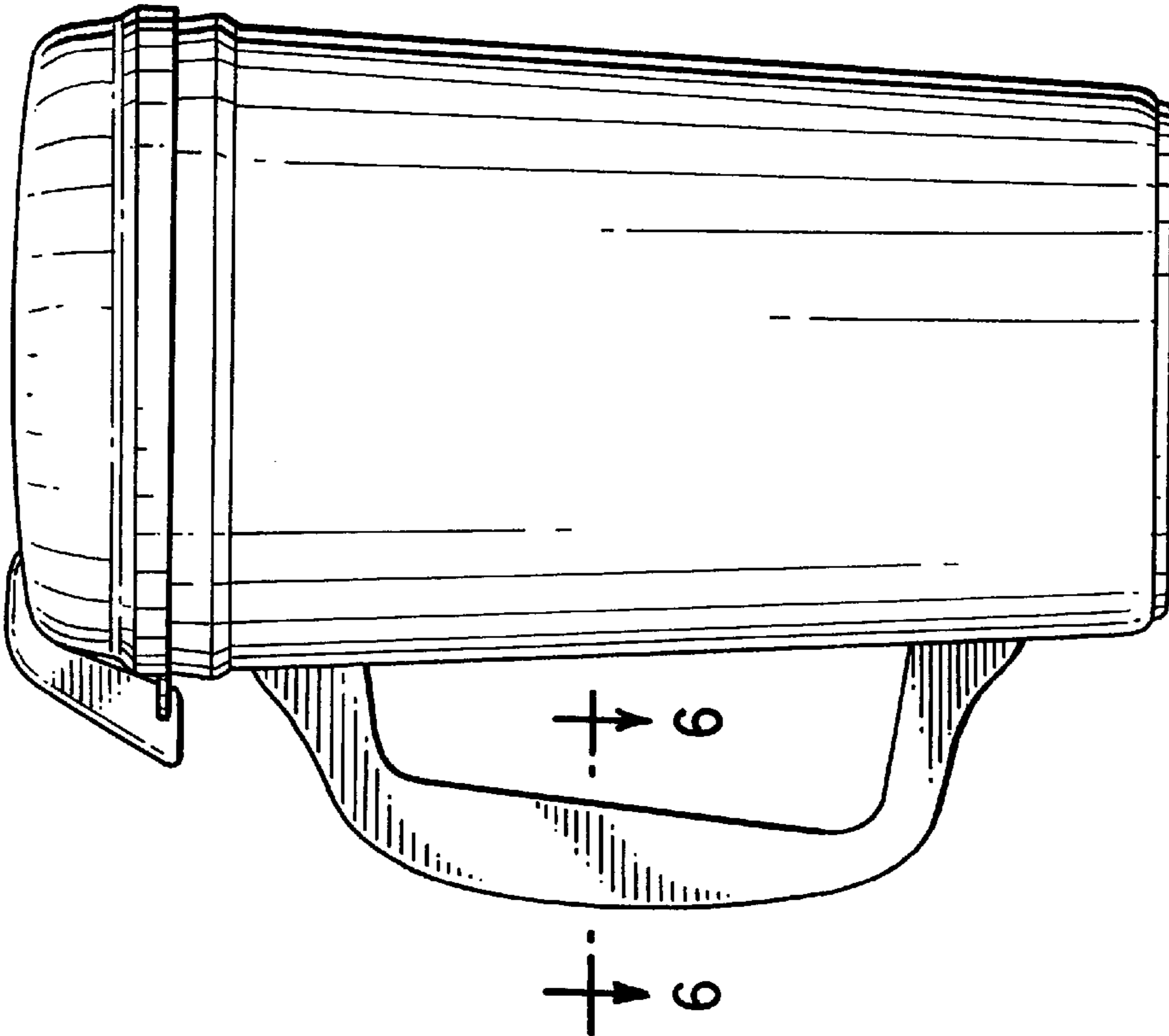

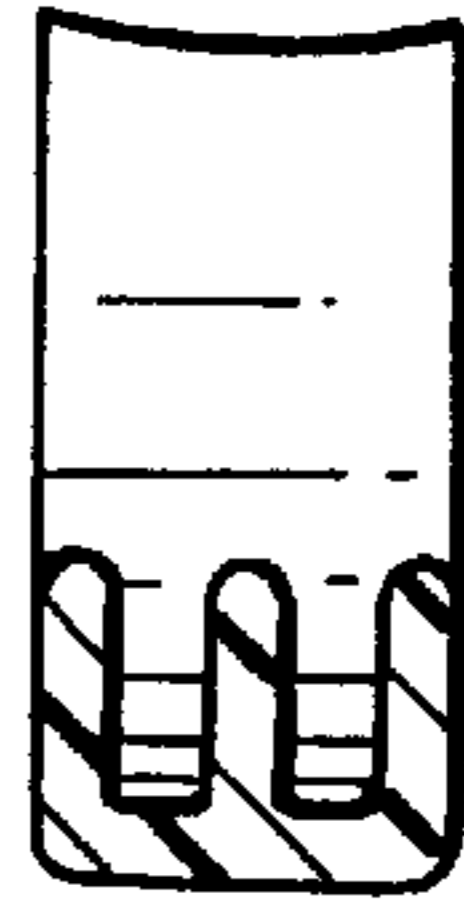

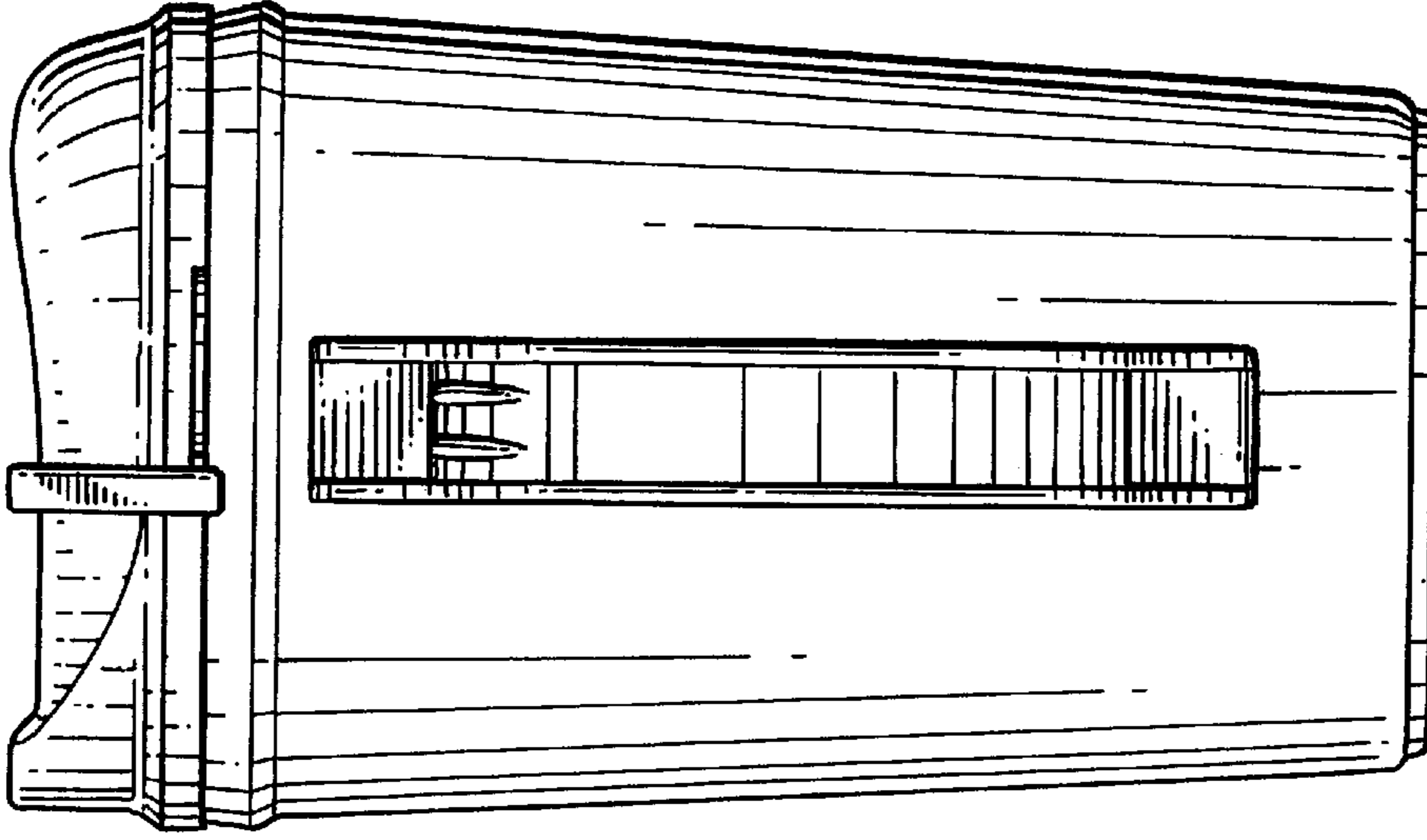

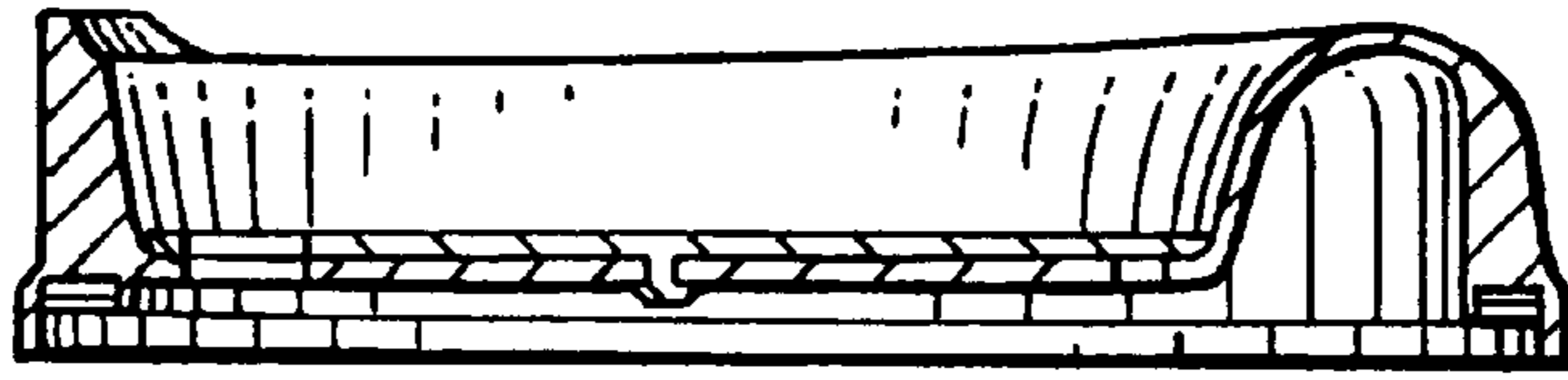

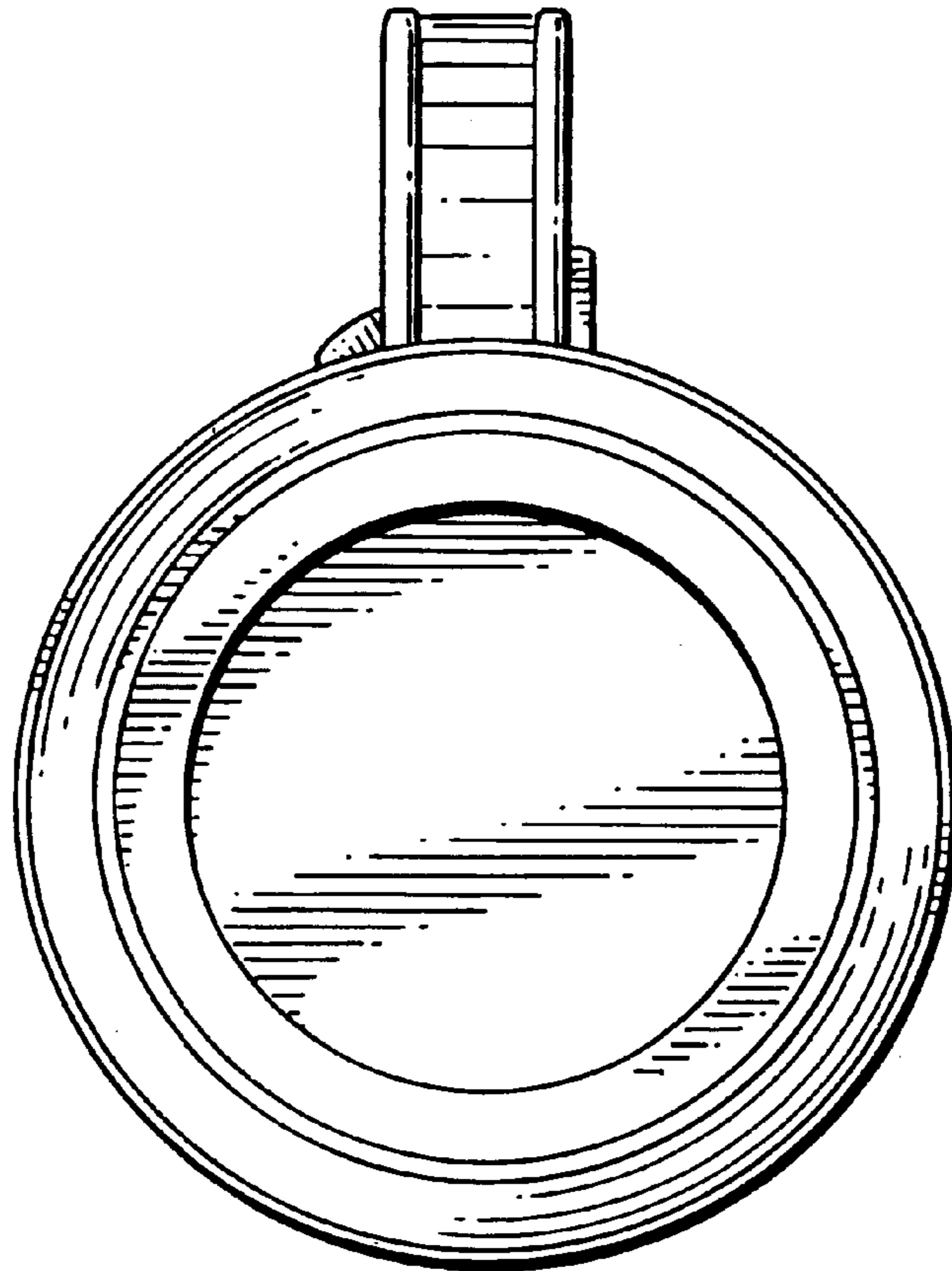

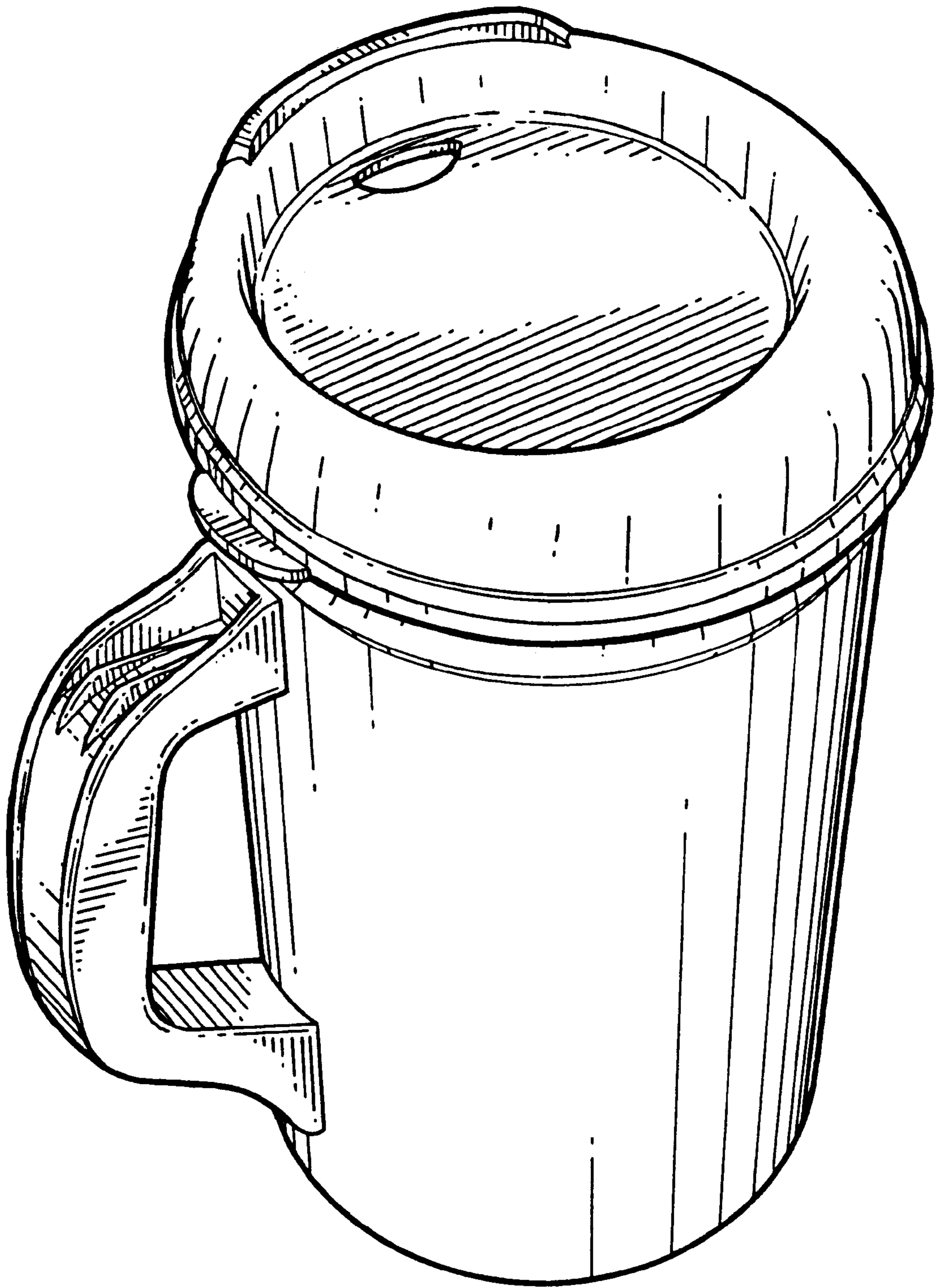
