[57] **CLAIM**

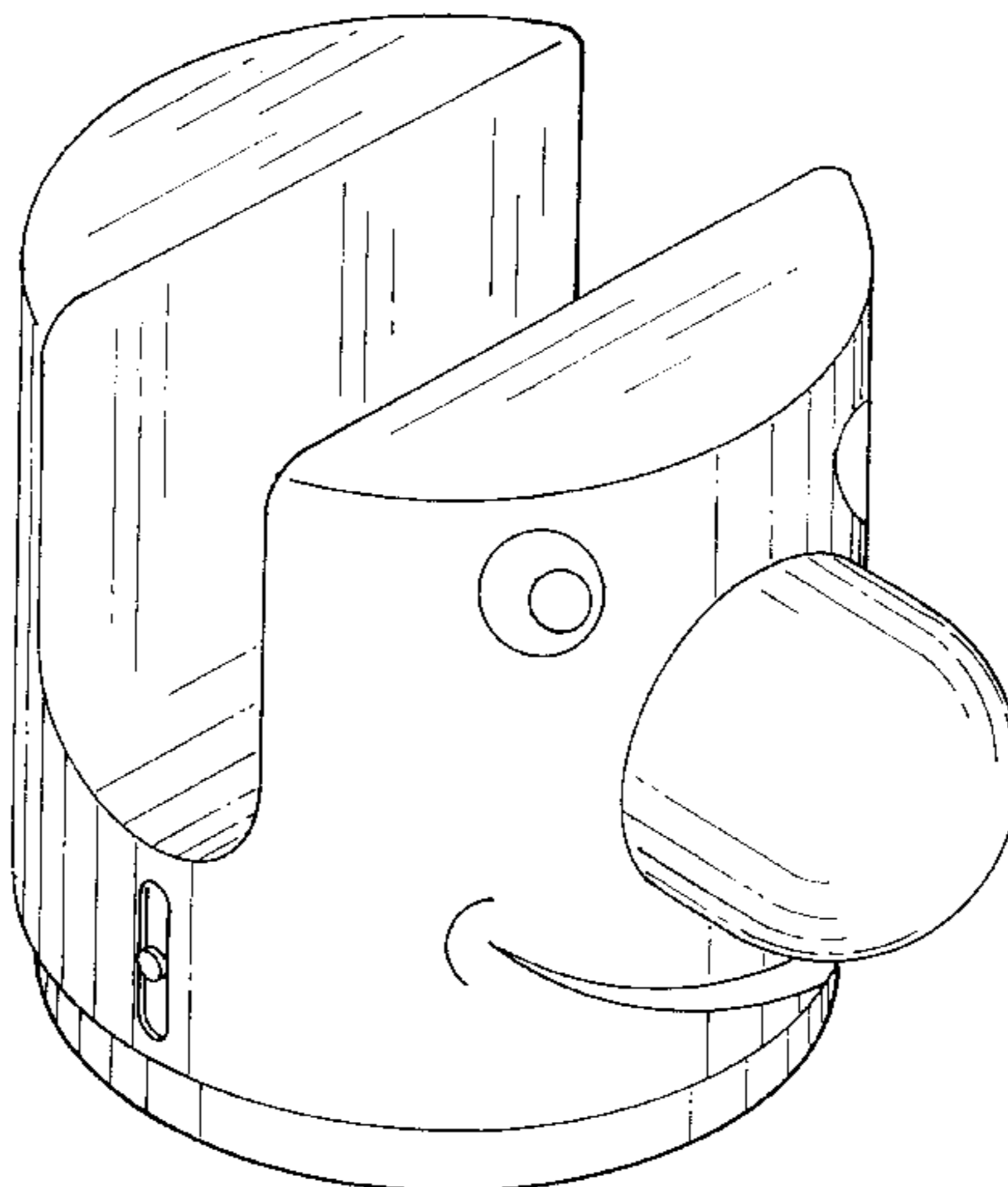
The ornamental design for a rocker drive for child recliners, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of rocker drive for child recliners in accordance with our design; FIG. 2 being a right side elevational view thereof; FIG. 3 being a front elevational view thereof; FIG. 4 being a top plan view thereof; FIG. 5 is a reduced scale, environmental perspective view thereof; FIG. 6 is an environmental perspective view thereof; FIG. 7 is a right side elevational view of a second embodiment of a rocker drive for child recliners in accordance with our design; FIG. 8 being a front elevational view thereof; FIG. 9 being a top plan thereof; FIG. 10 is a right side elevational view of a third embodiment of a rocker drive for child recliners in accordance with our design; FIG. 11 being a front elevational view thereof; FIG. 12 being a top plan view thereof; FIG. 13 is a right side elevational view of a fourth embodiment of a rocker drive for child recliners in accordance with our design; FIG. 14 being a front elevational view thereof; FIG. 15 being a top plan view thereof; FIG. 16 is a right side elevational view of a fifth embodiment of a rocker drive for child recliners in accordance with our design; FIG. 17 being a front elevational view thereof; FIG. 18 being a top plan view thereof; FIG. 19 is a right side elevational view of a sixth embodiment of a rocker drive for child recliners in accordance with our design; FIG. 20 being a front elevational view thereof; and, FIG. 21 being a top plan view thereof.

The broken line showing of baby carrier and a rocker handle is for illustrative purposes only and forms no part of the claimed design.

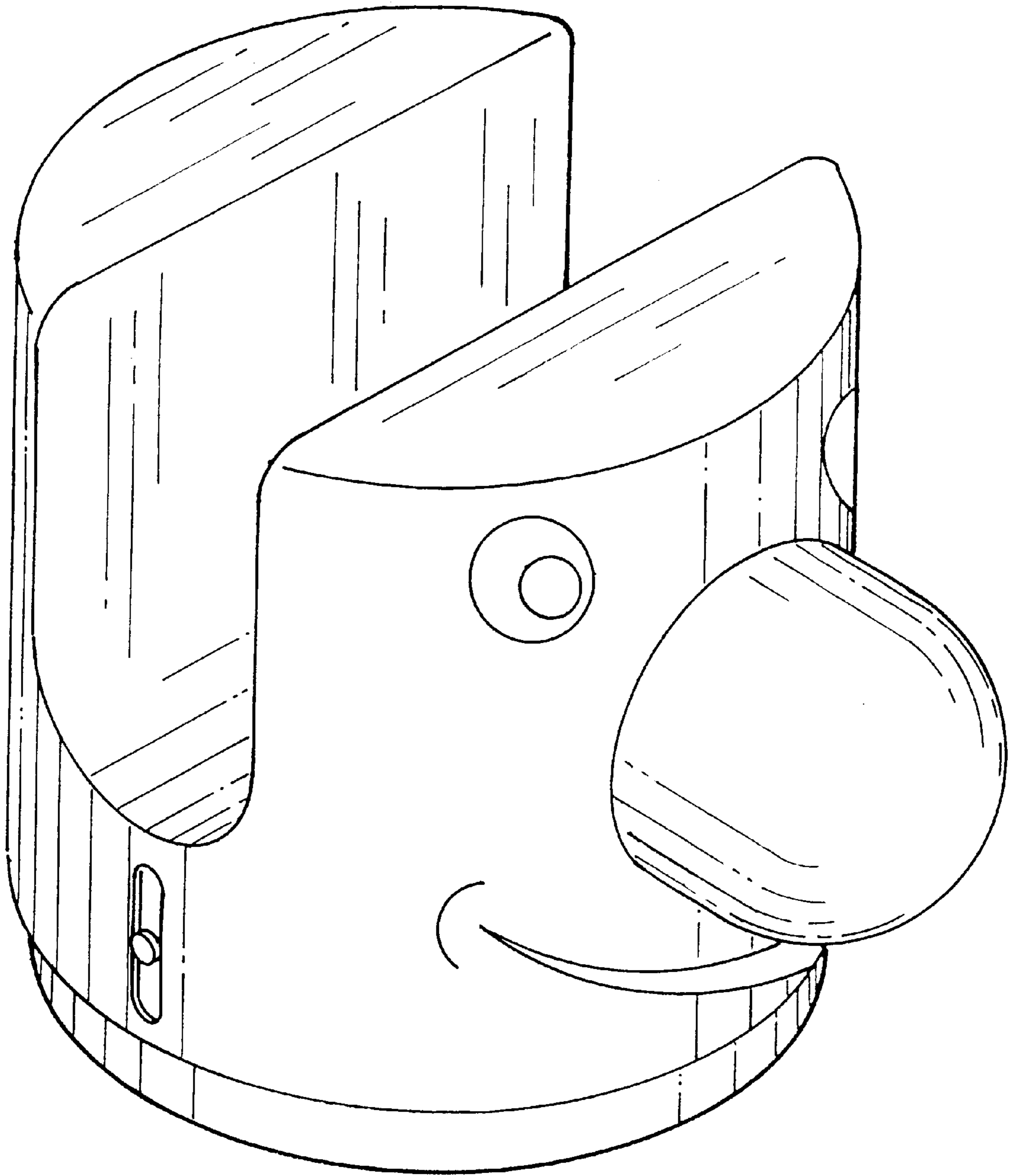

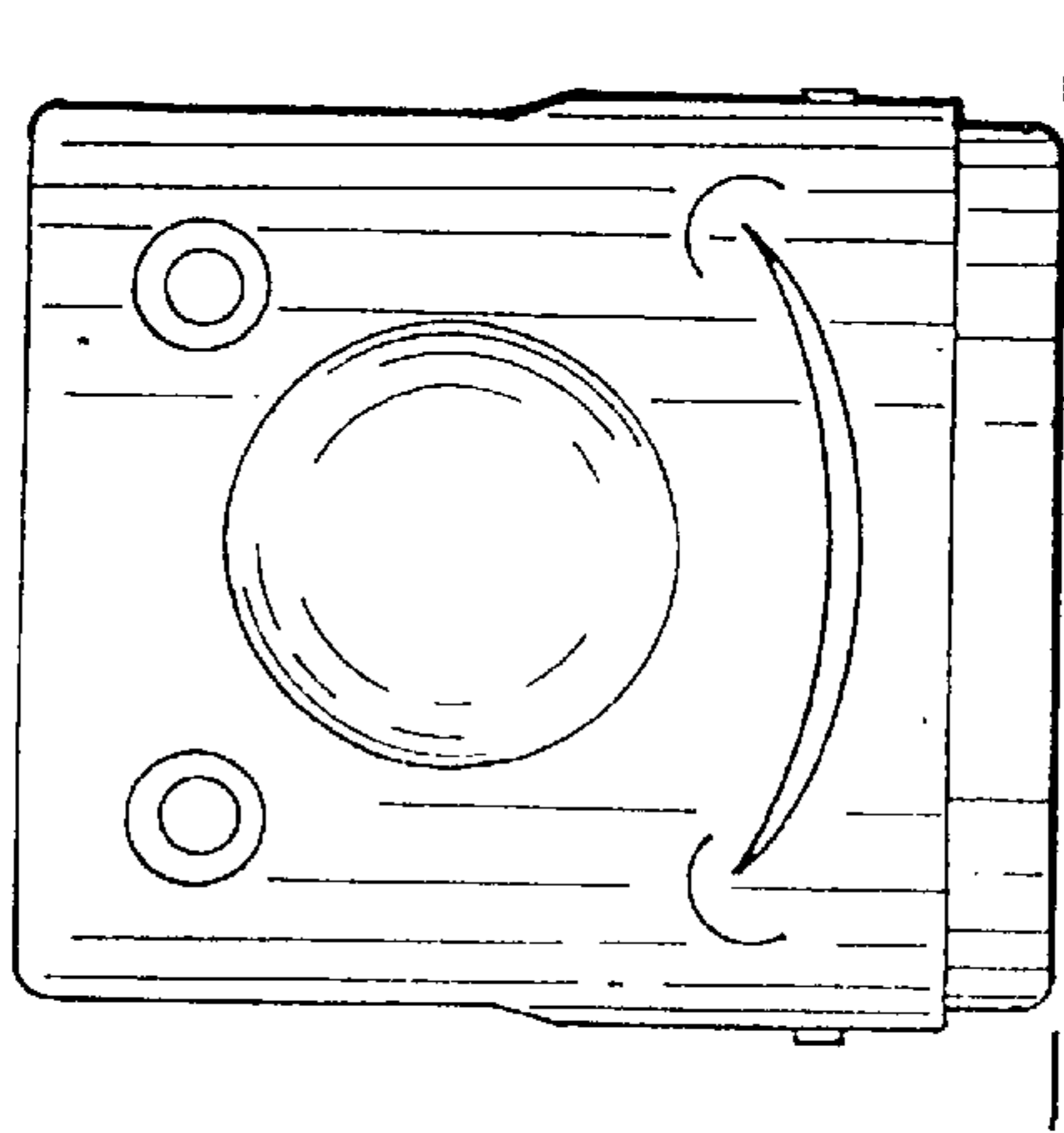

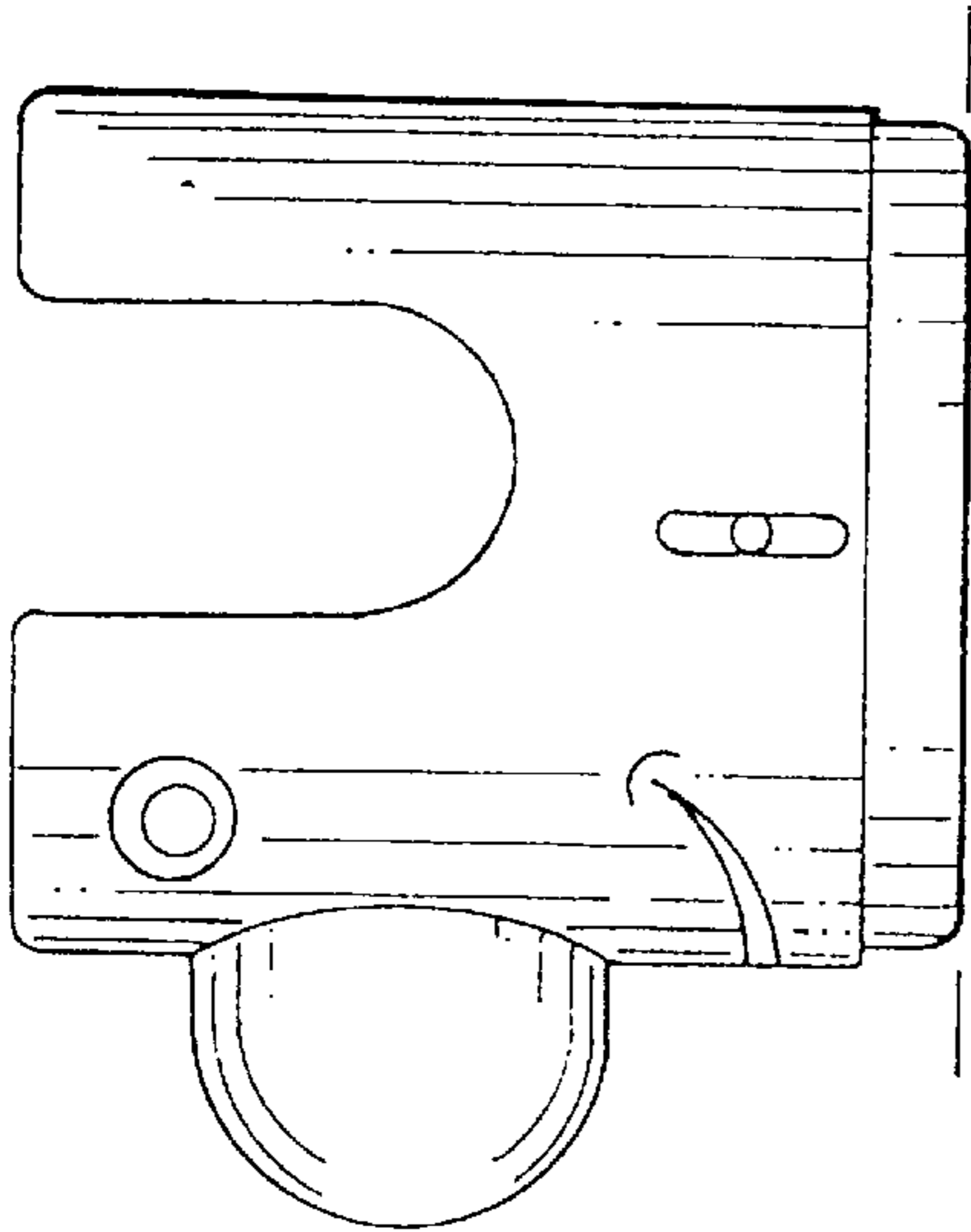

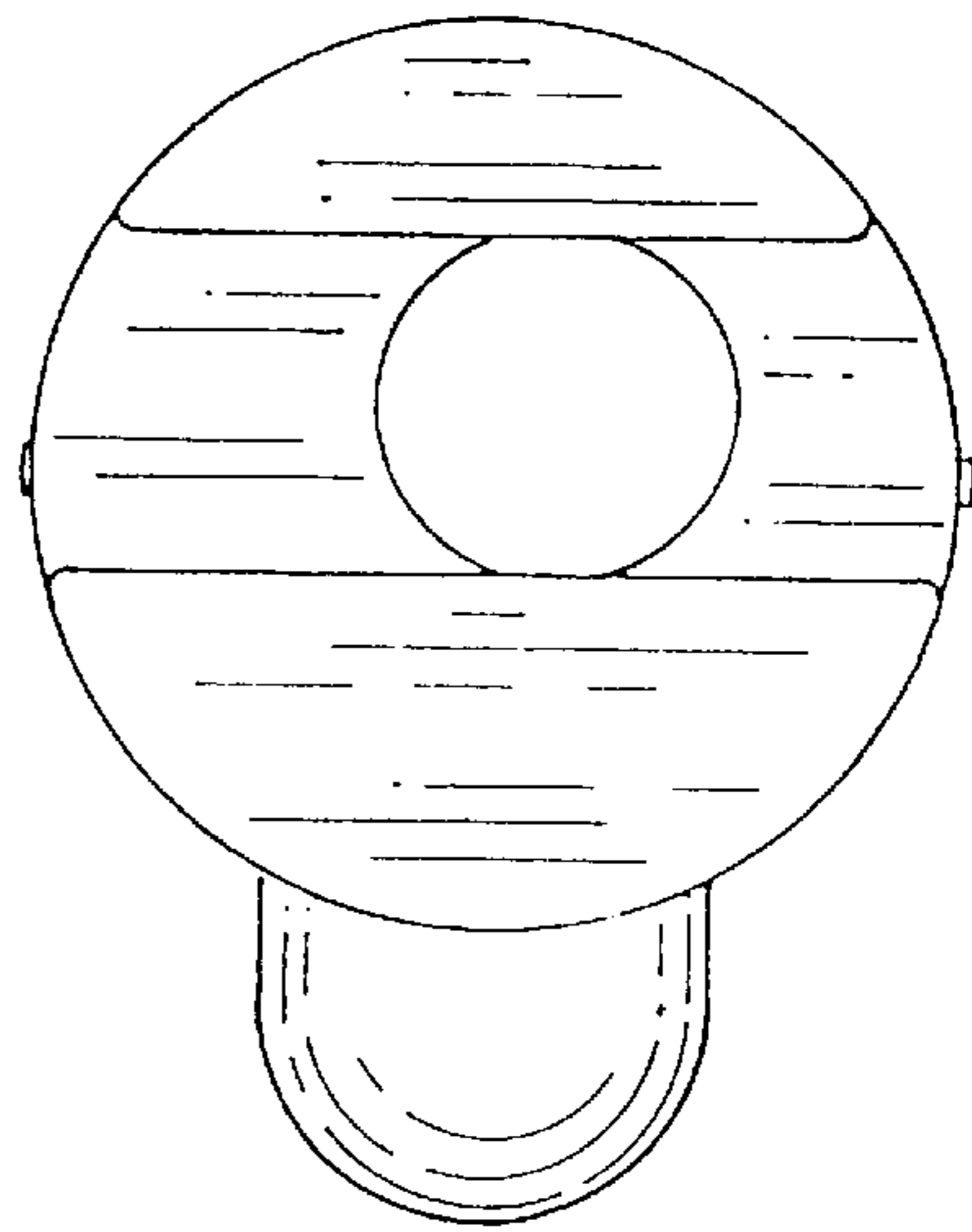

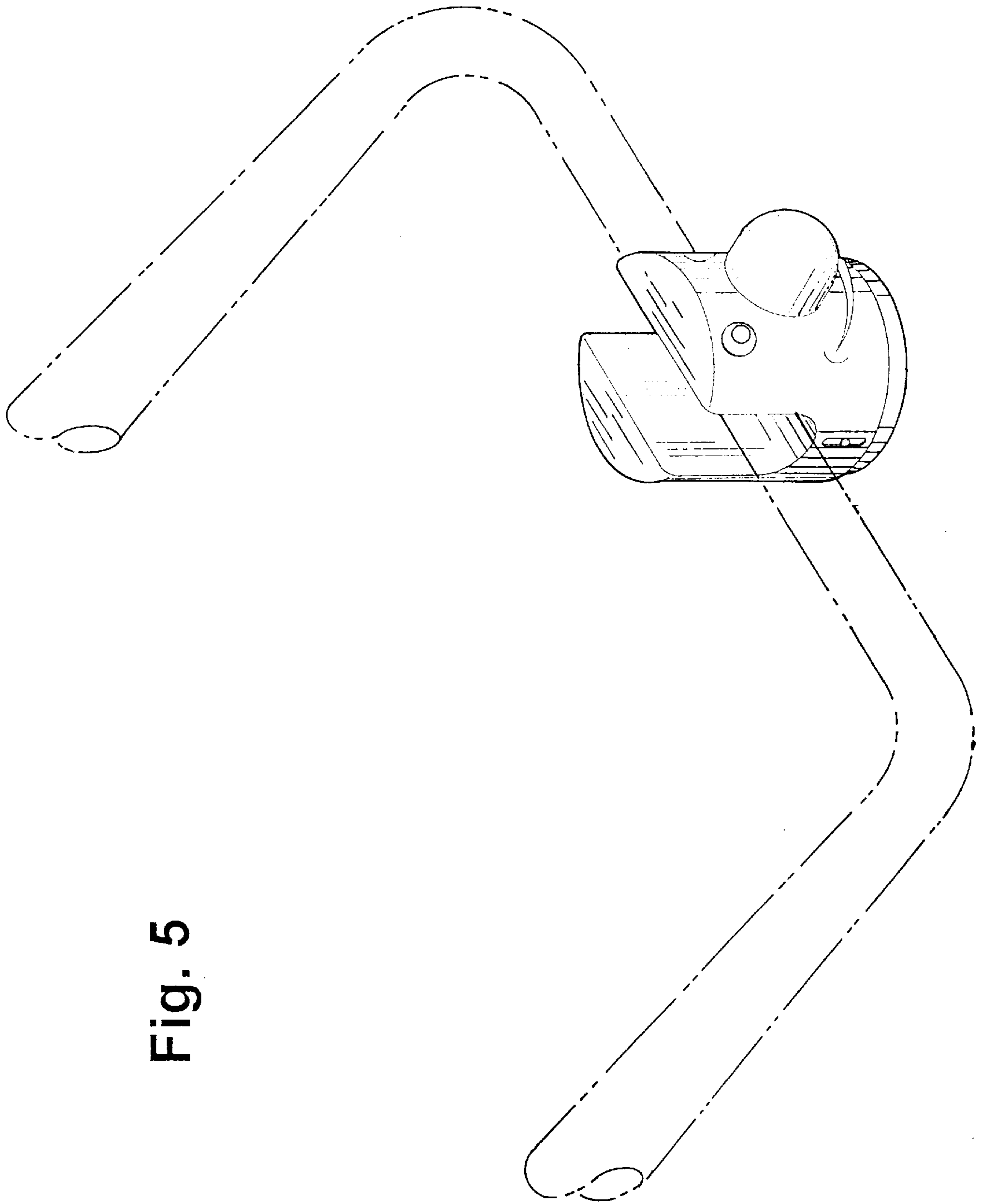
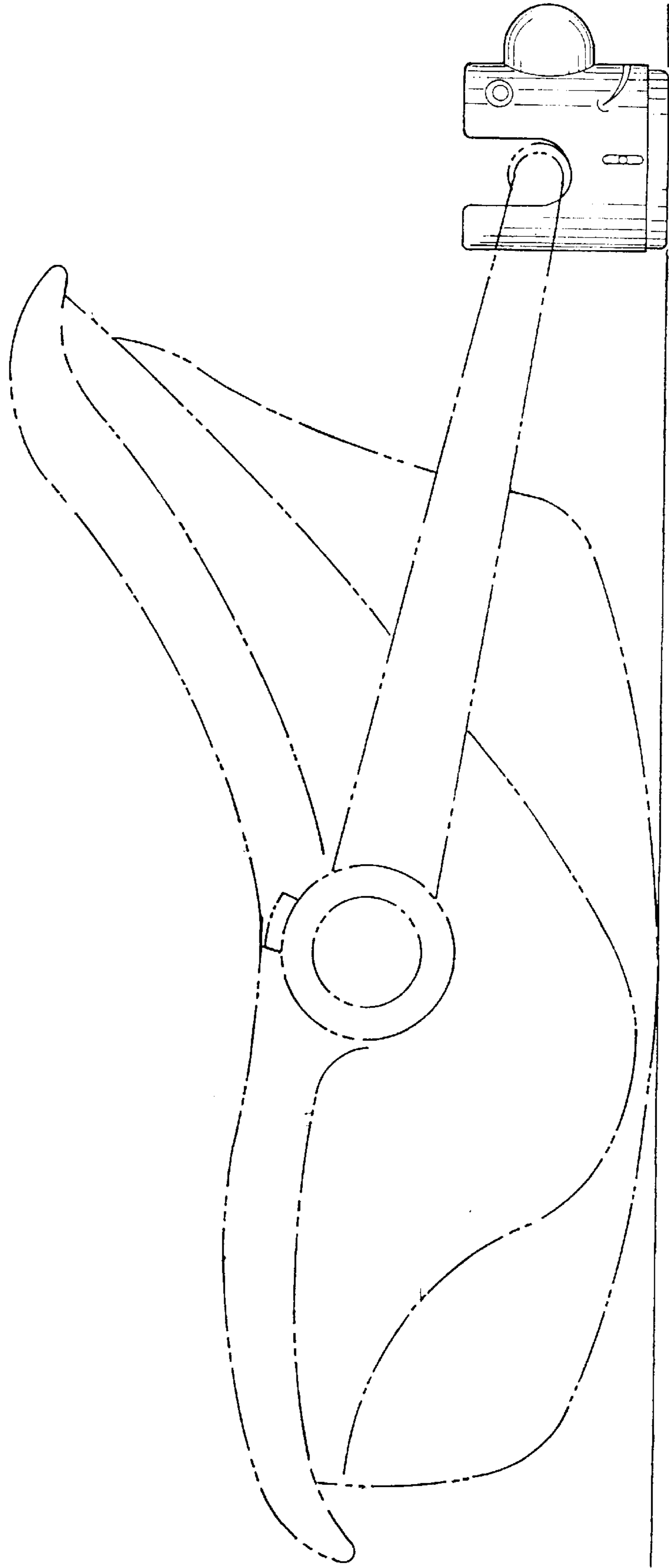

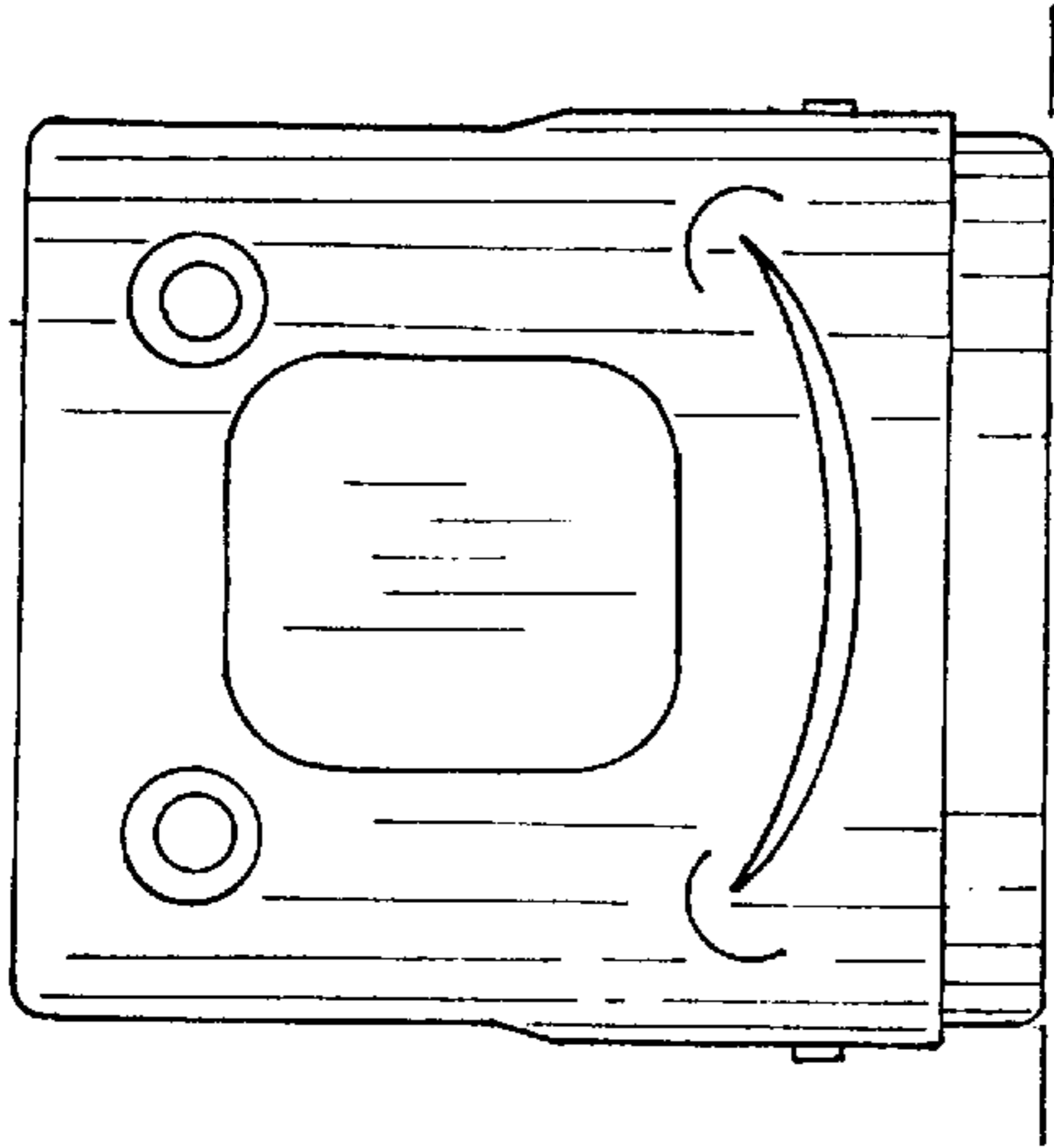

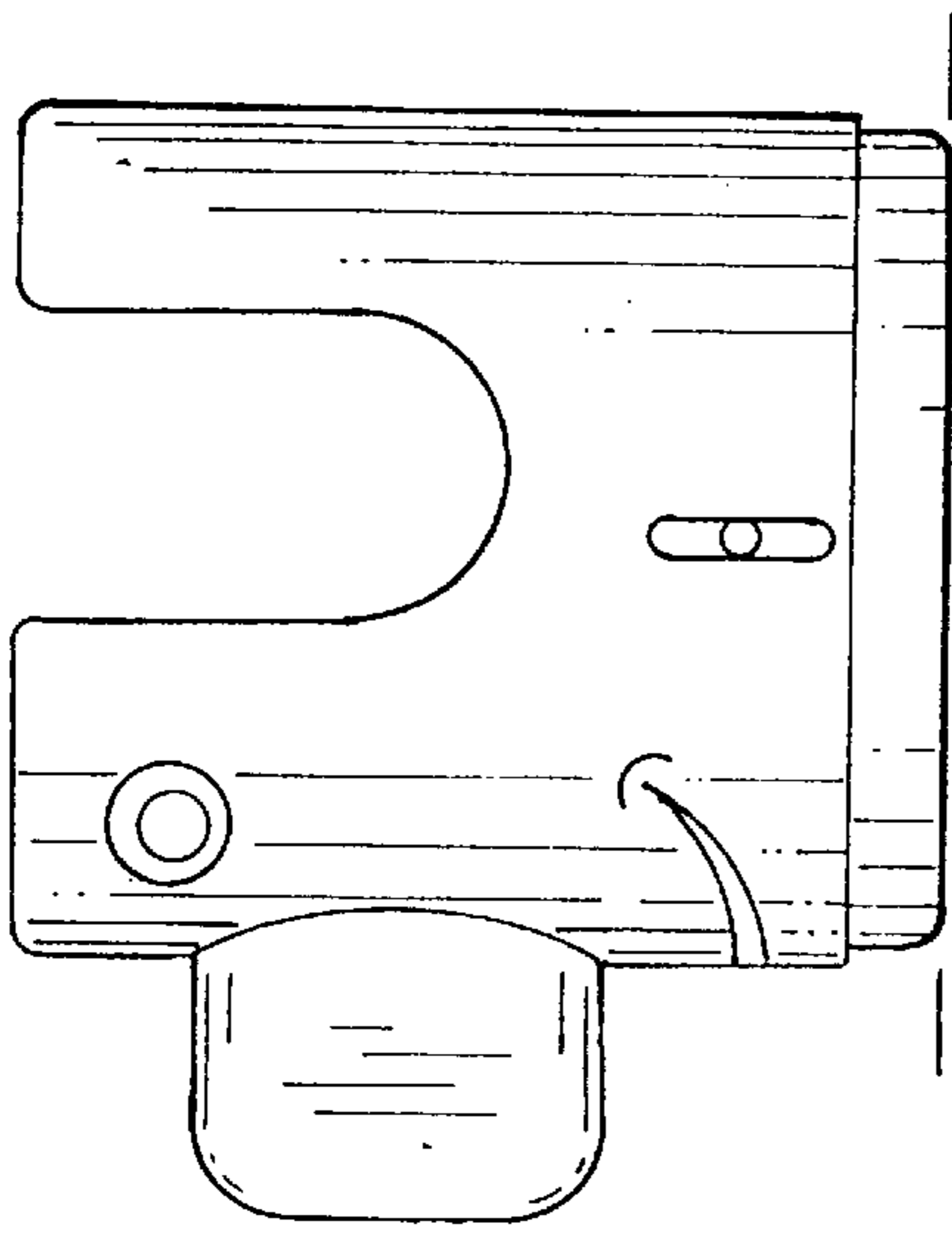

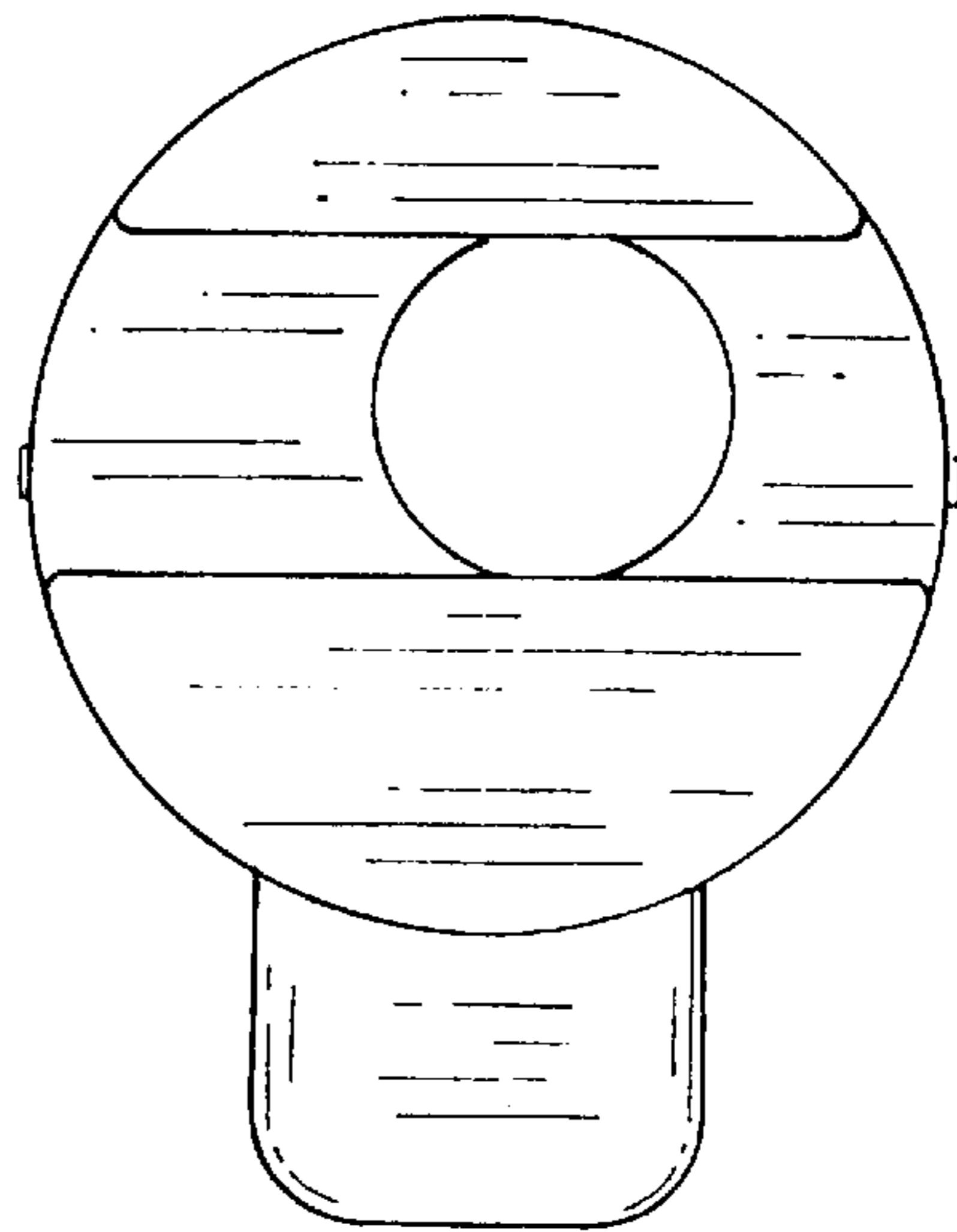

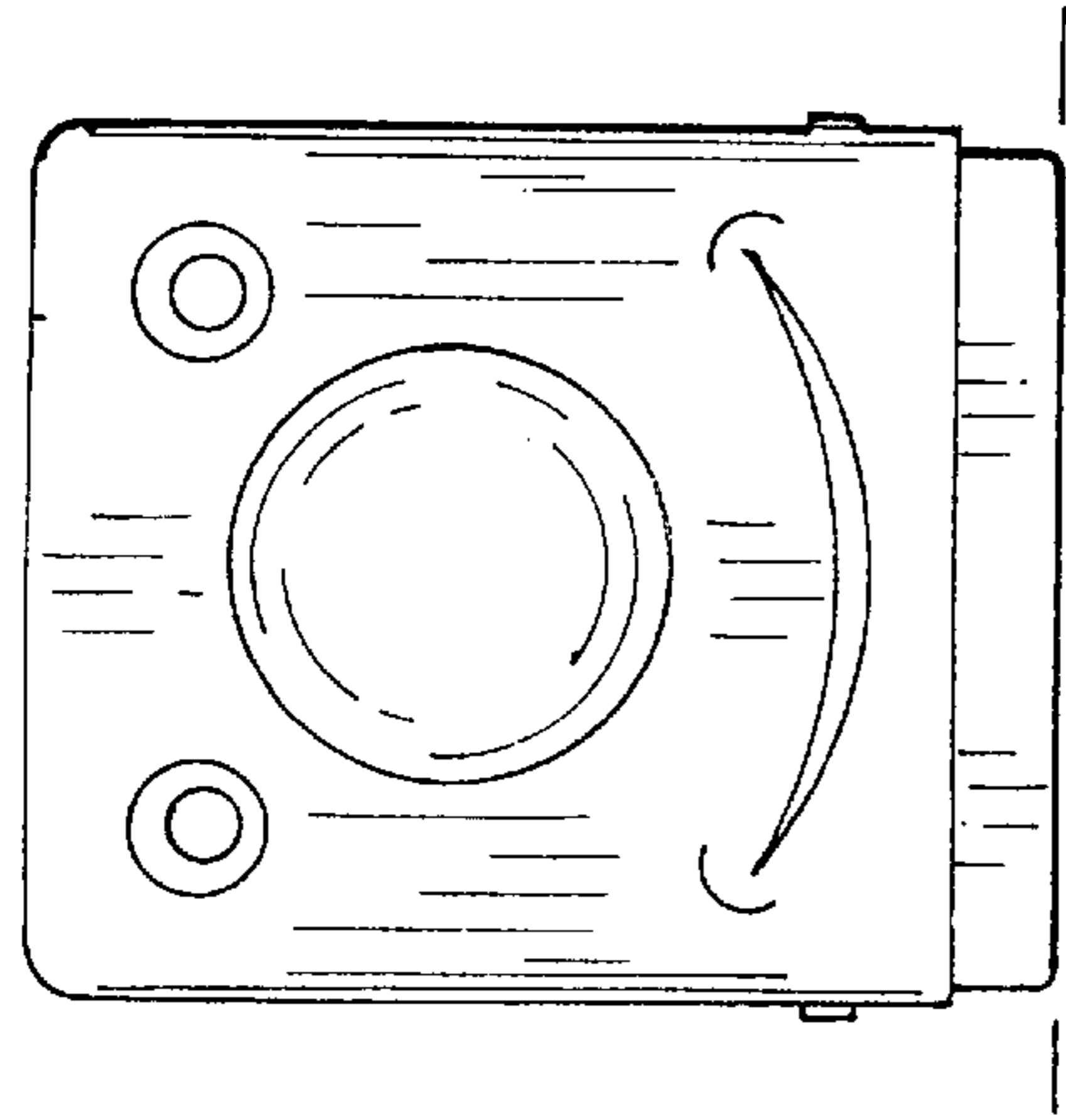

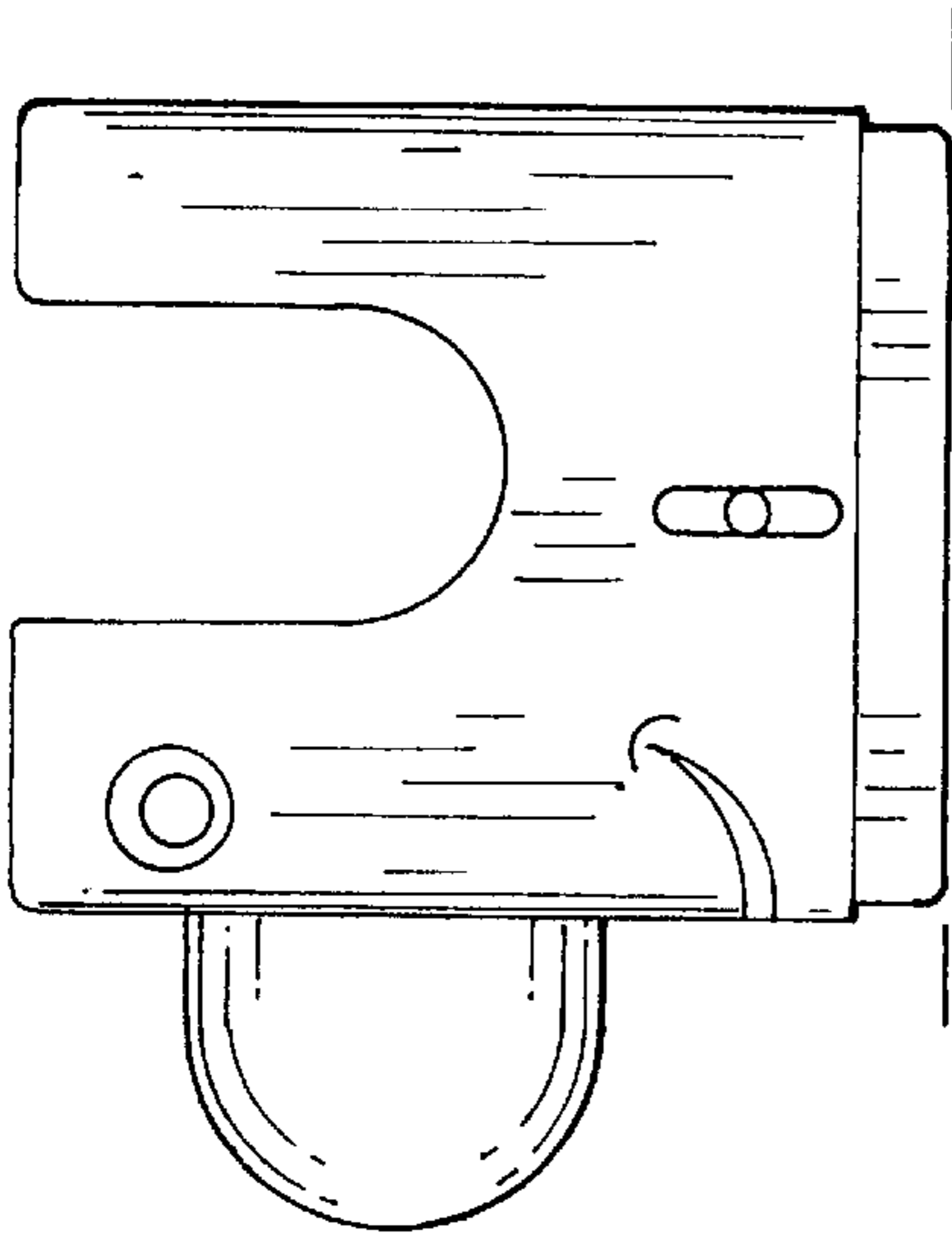

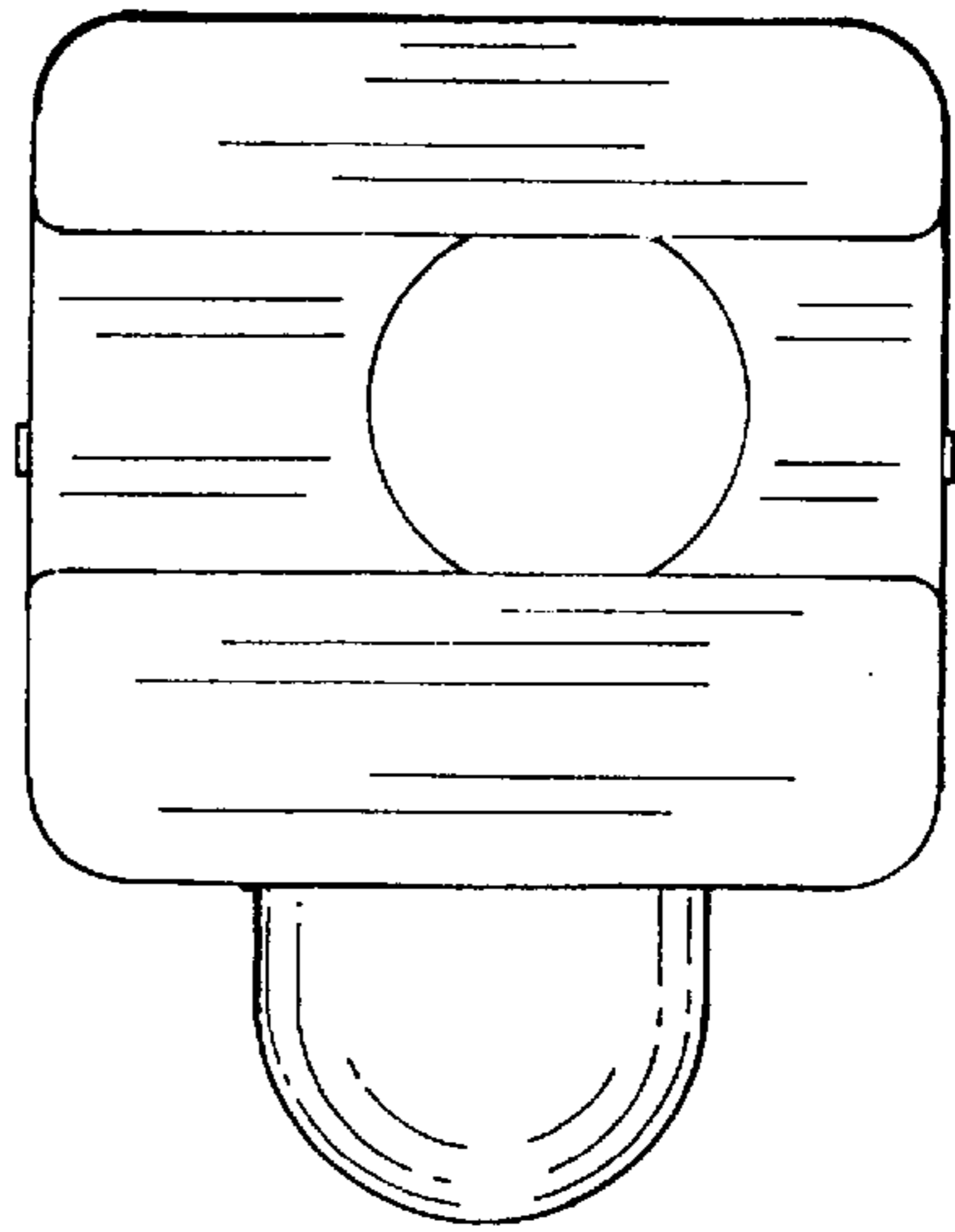

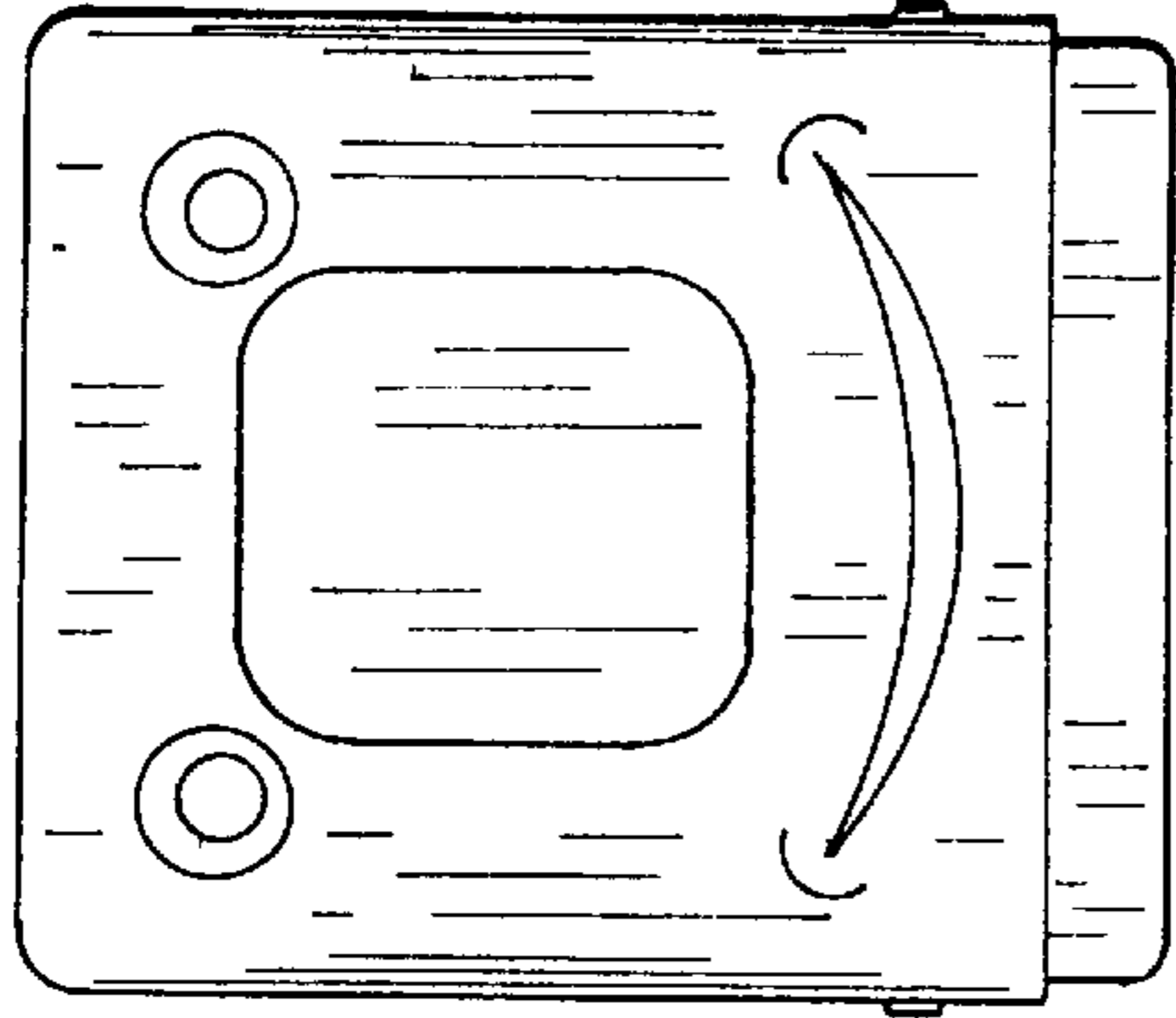

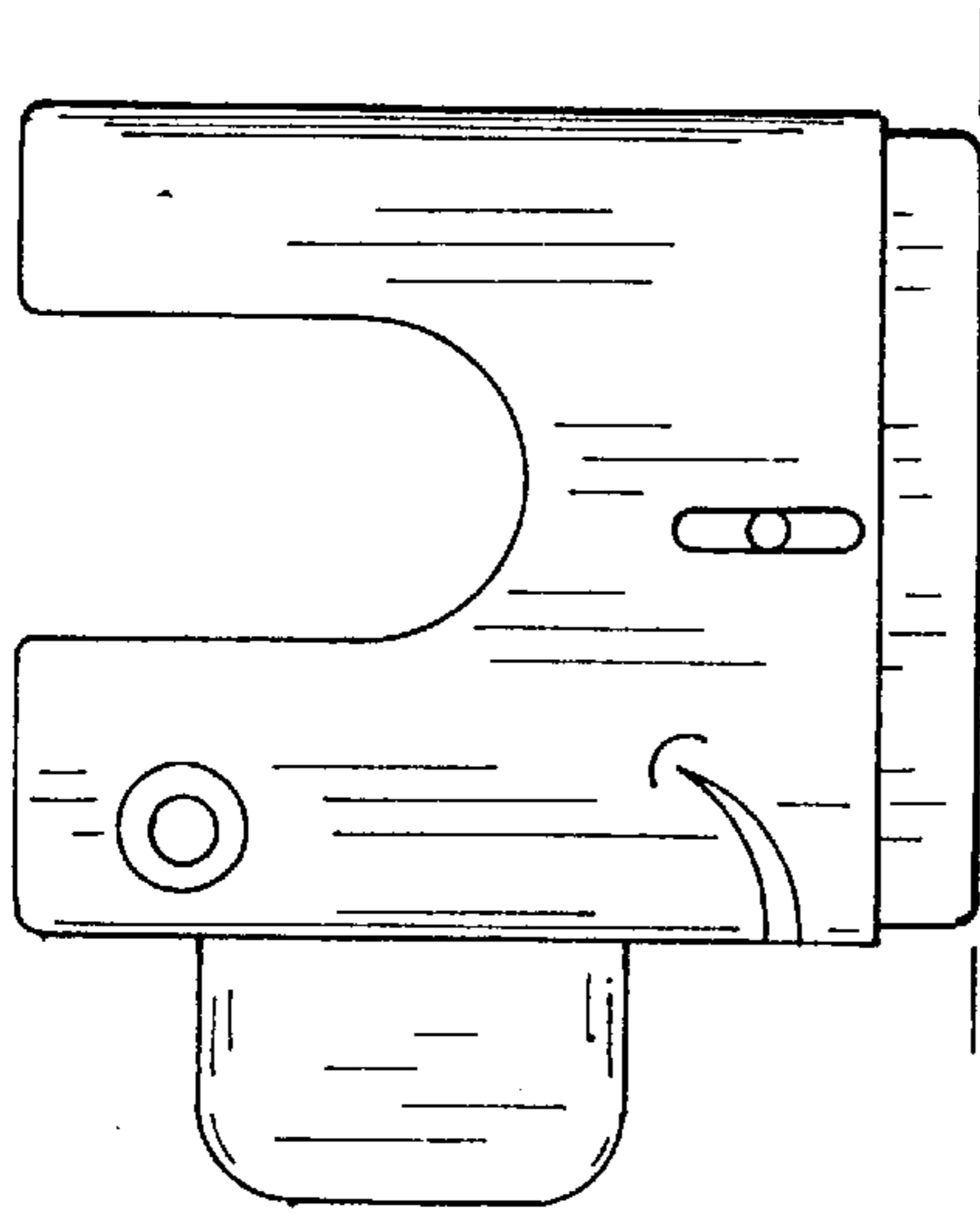

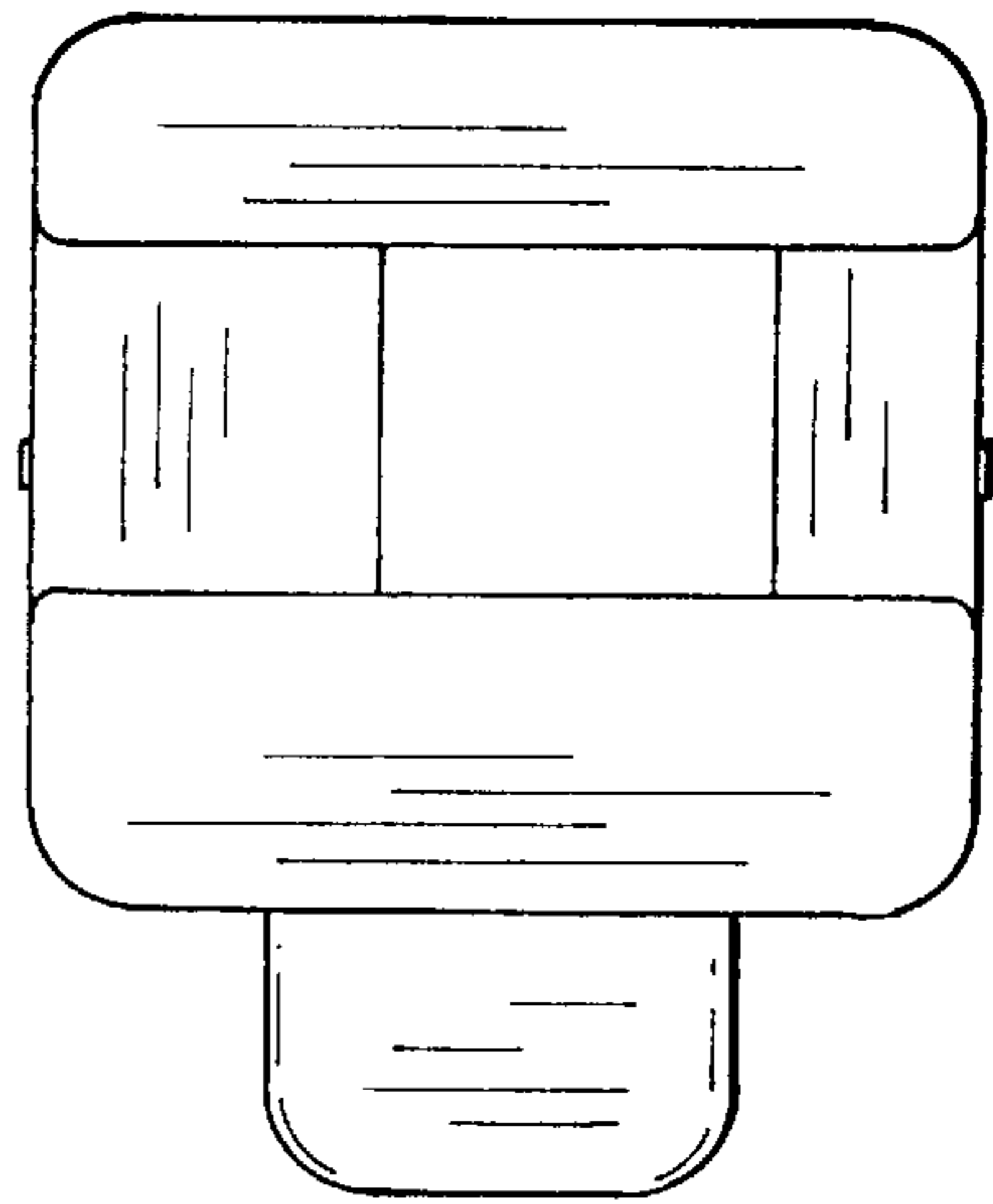

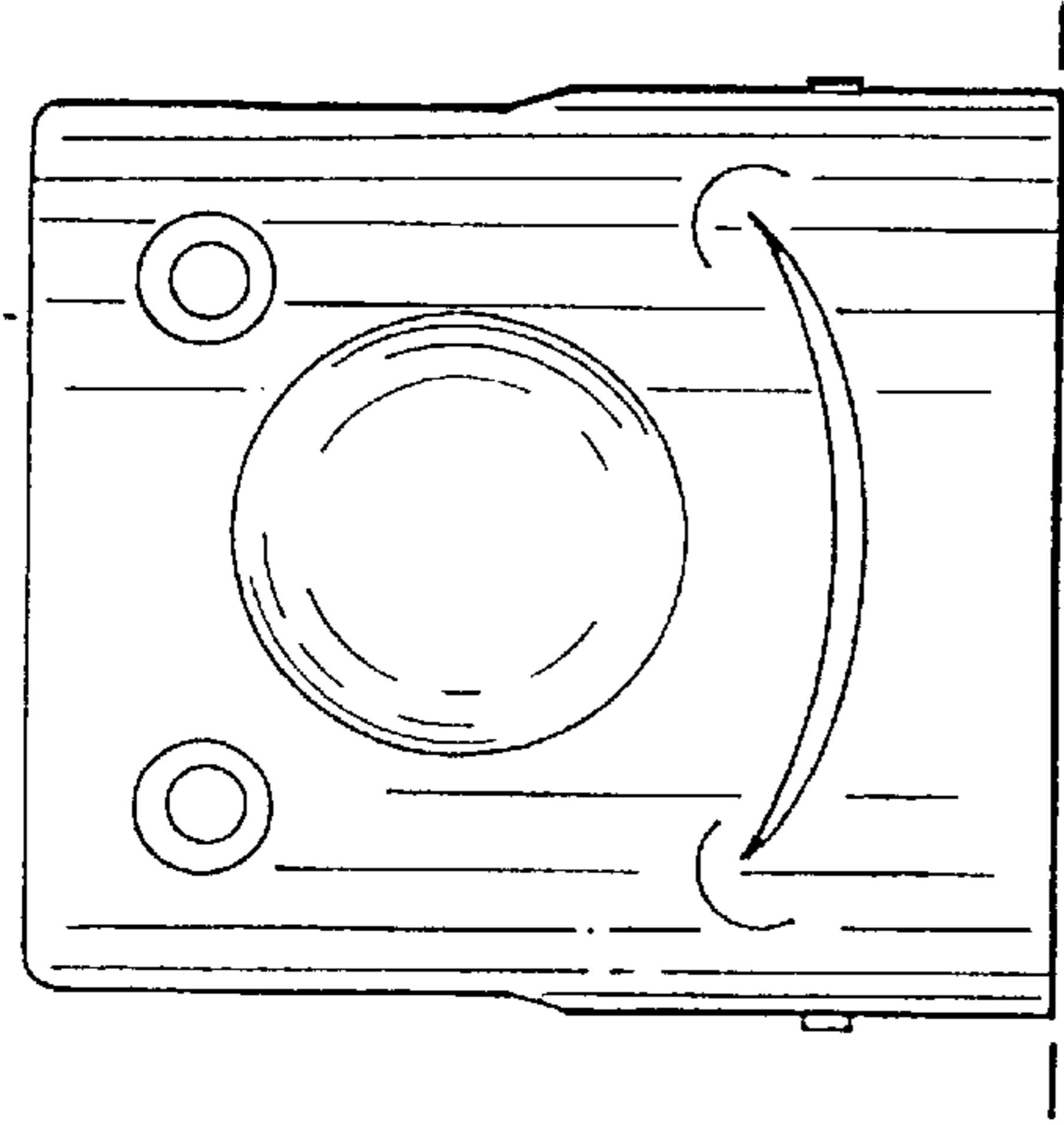

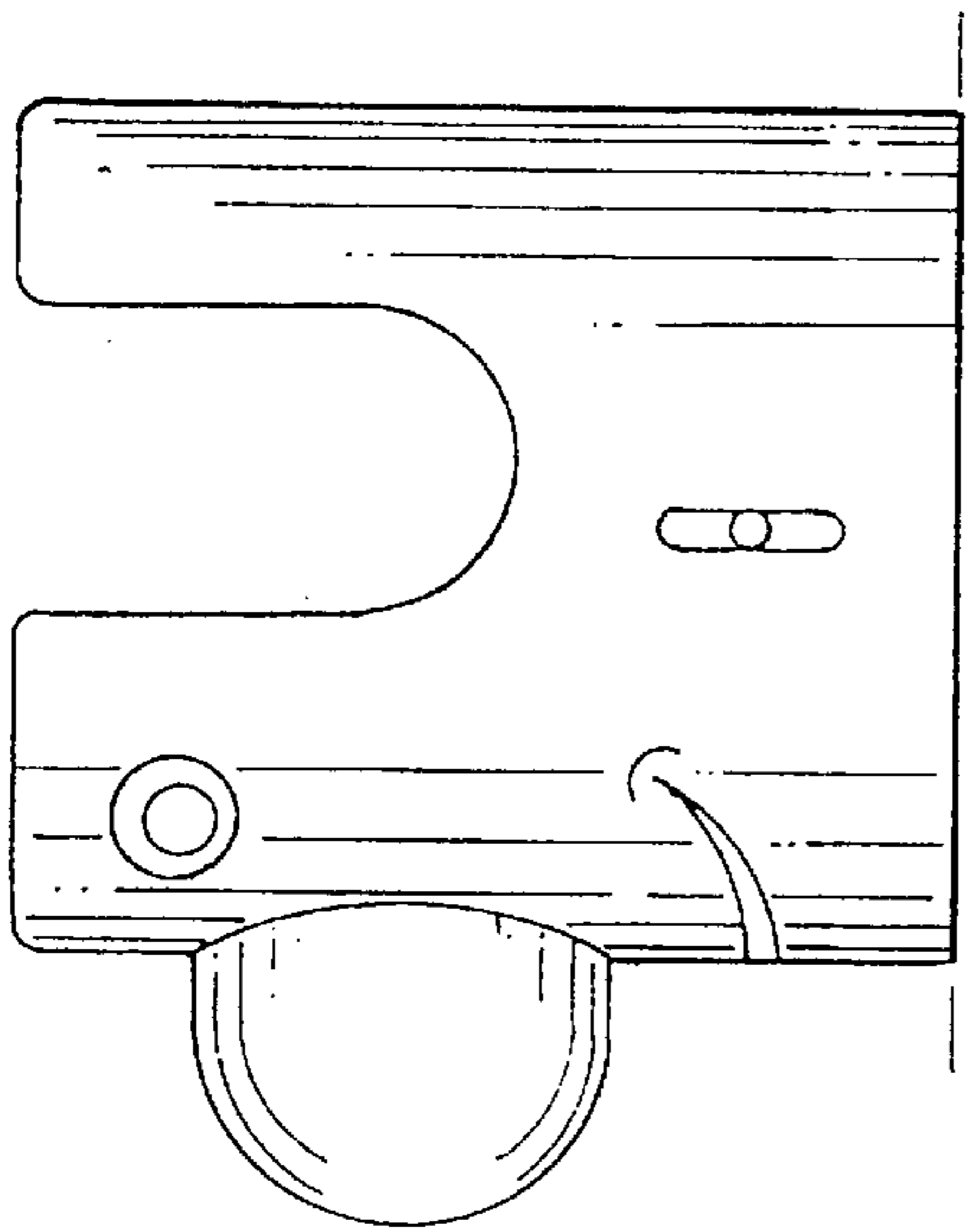

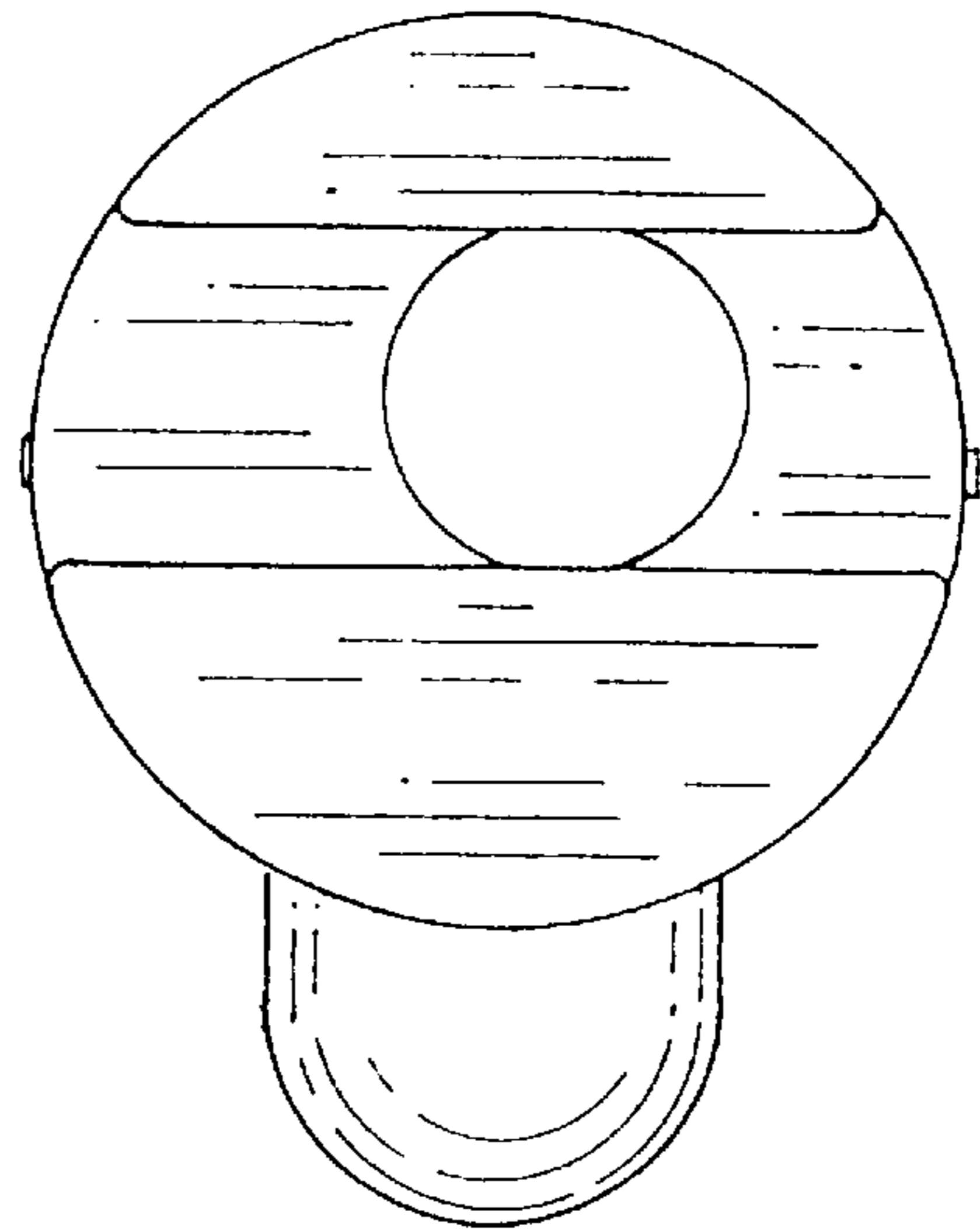

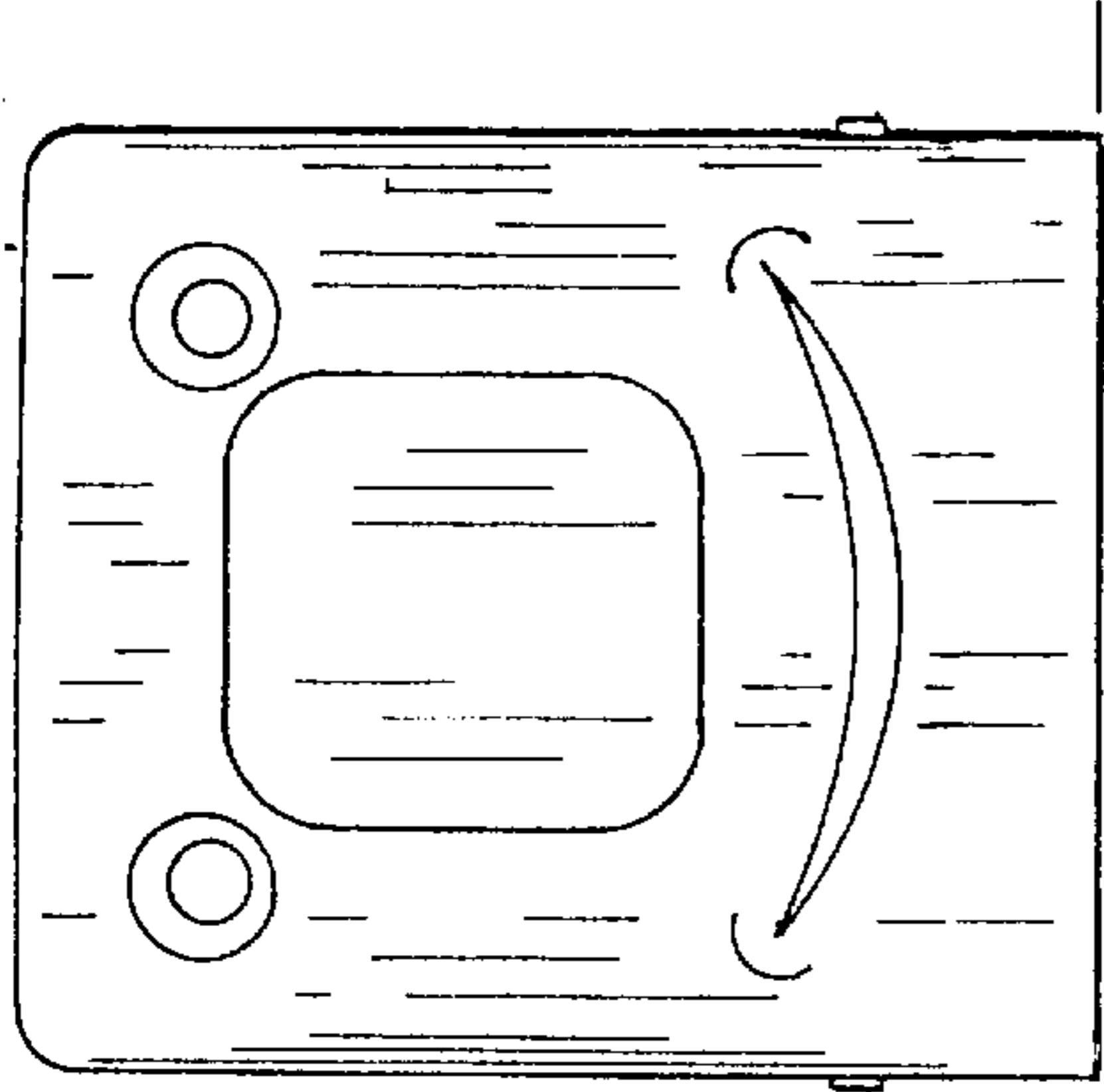

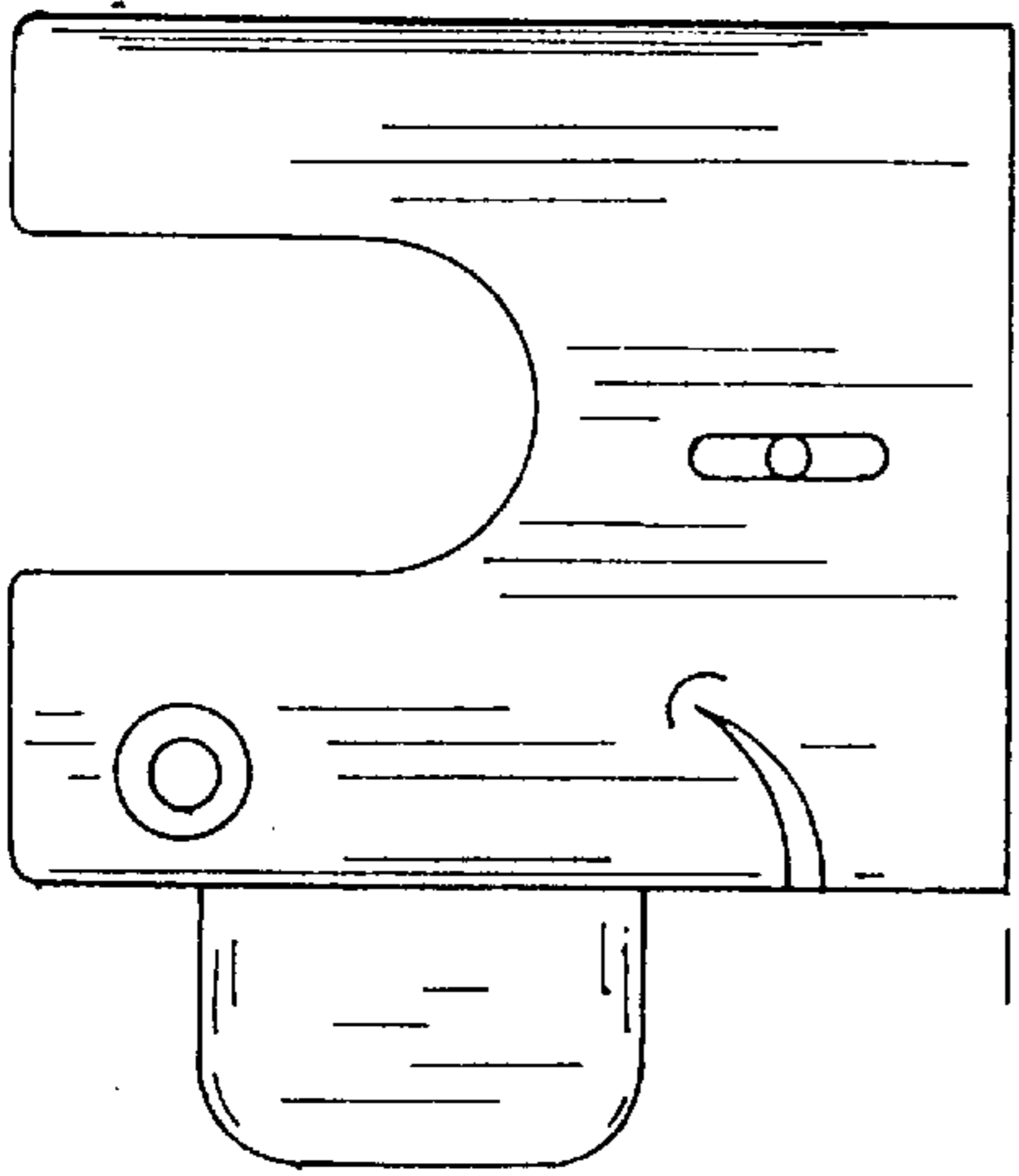

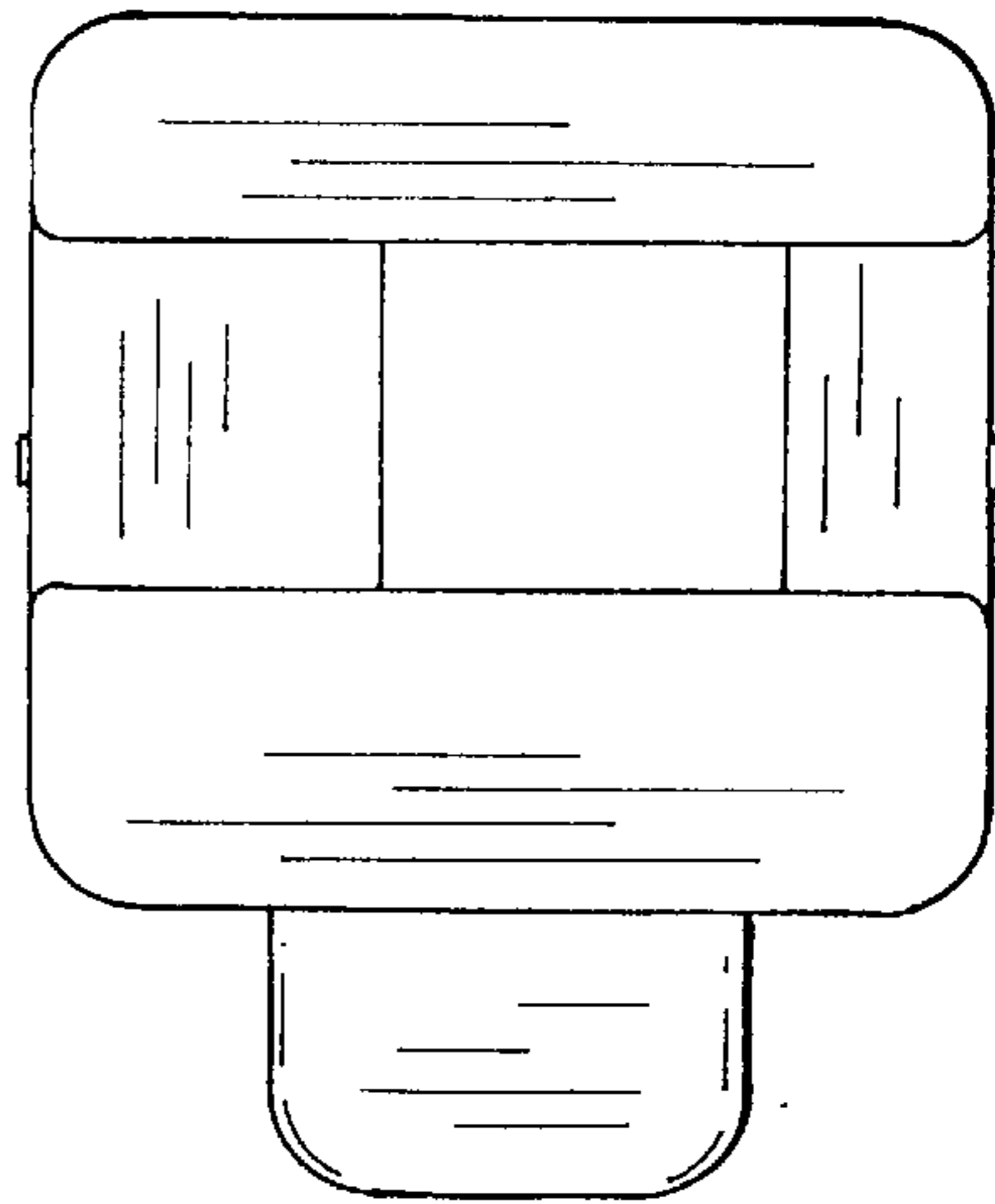
