[57] **CLAIM**

The ornamental design for a carrier for a pre-paid telephone calling card, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a carrier for a pre-paid telephone calling card;

FIG. 2 is a front side elevational view of the carrier for pre-paid telephone calling card depicted in FIG. 1;

FIG. 3 is a back side elevational view of the carrier for a pre-paid telephone calling card depicted in FIG. 1;

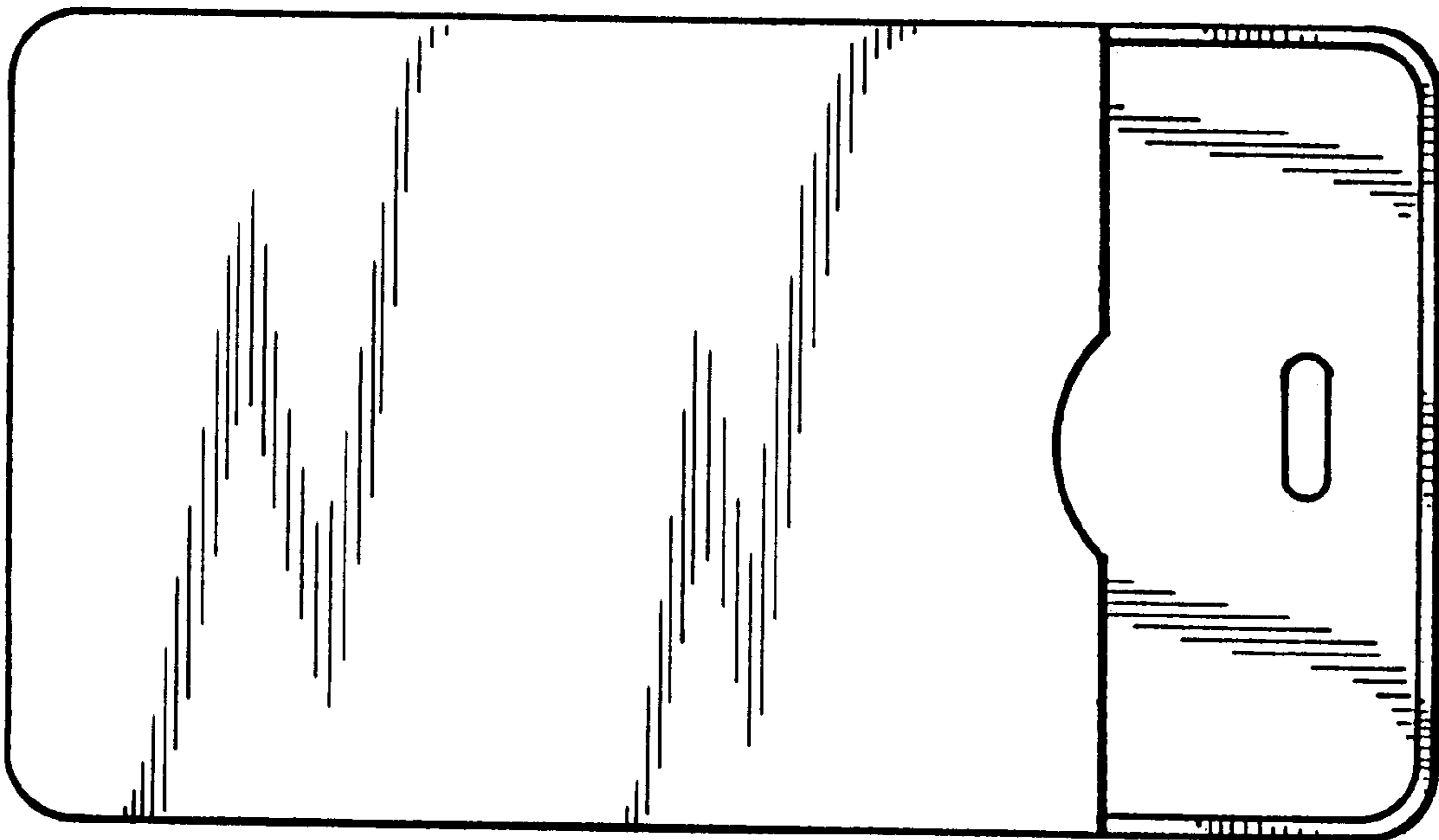
FIG. 4 is a longitudinal elevational view of the carrier for a pre-paid telephone calling card depicted in FIG. 1;

FIG. 5 is a lateral elevational view of the carrier for a pre-paid telephone calling card depicted in FIG. 1; and,

FIG. 6 is a cross section view of the carrier for a pre-paid telephone calling card depicted in FIG. 1 which is taken along the line 6—6 thereof.

The broken line showing of a card and ring in FIG. 1 and flowers in FIG. 3 is for illustrative purposes only and forms no part of the claimed design.

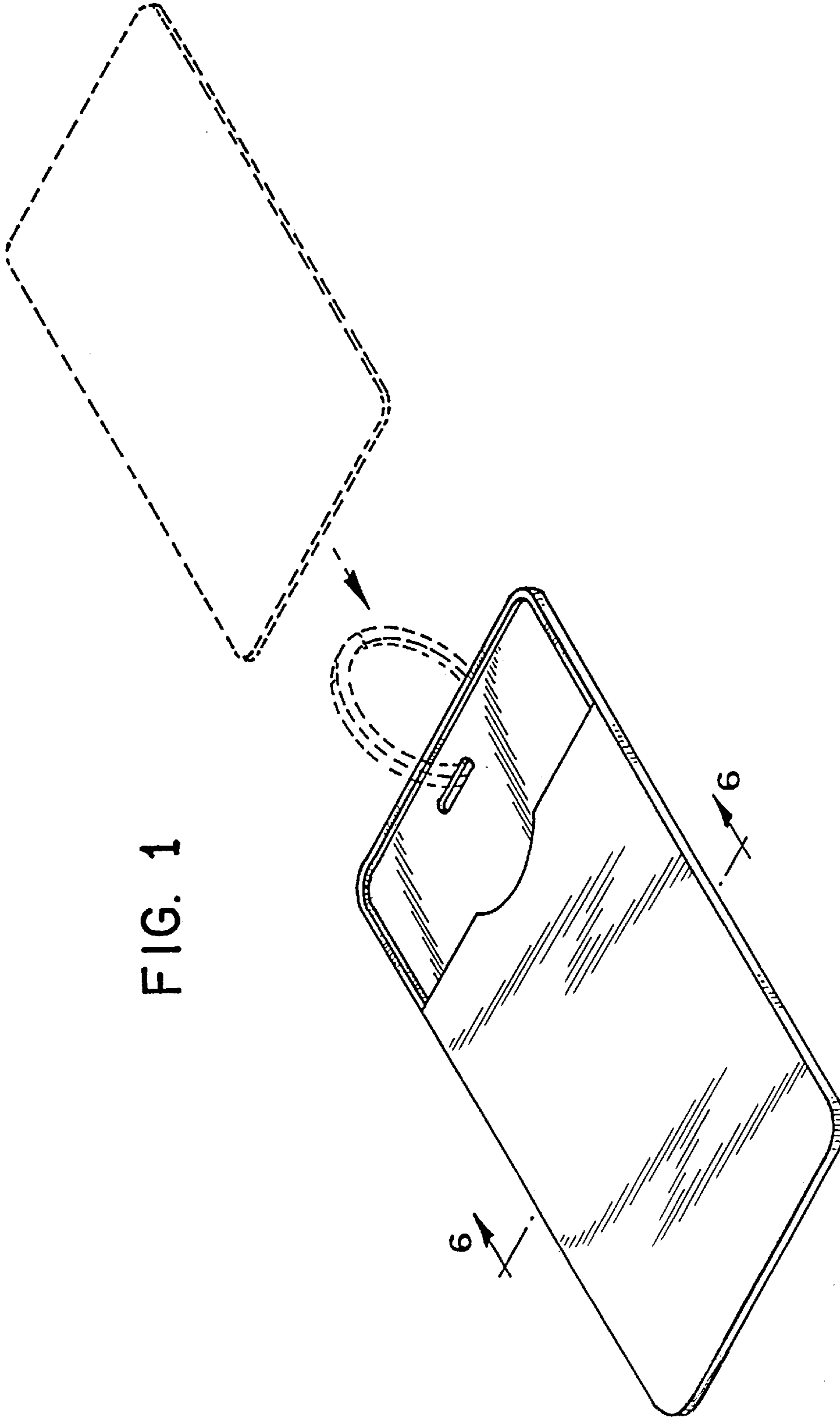

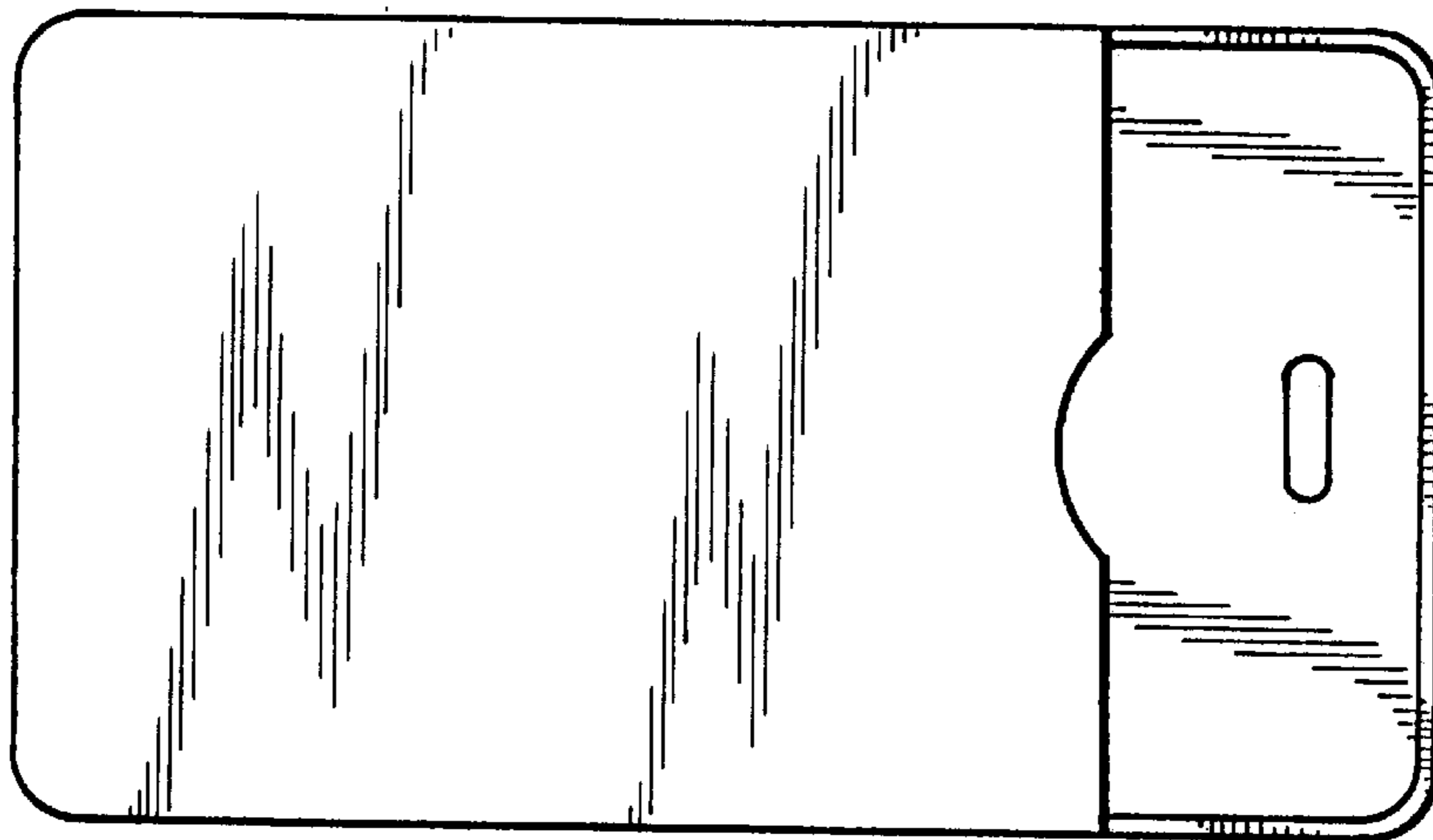

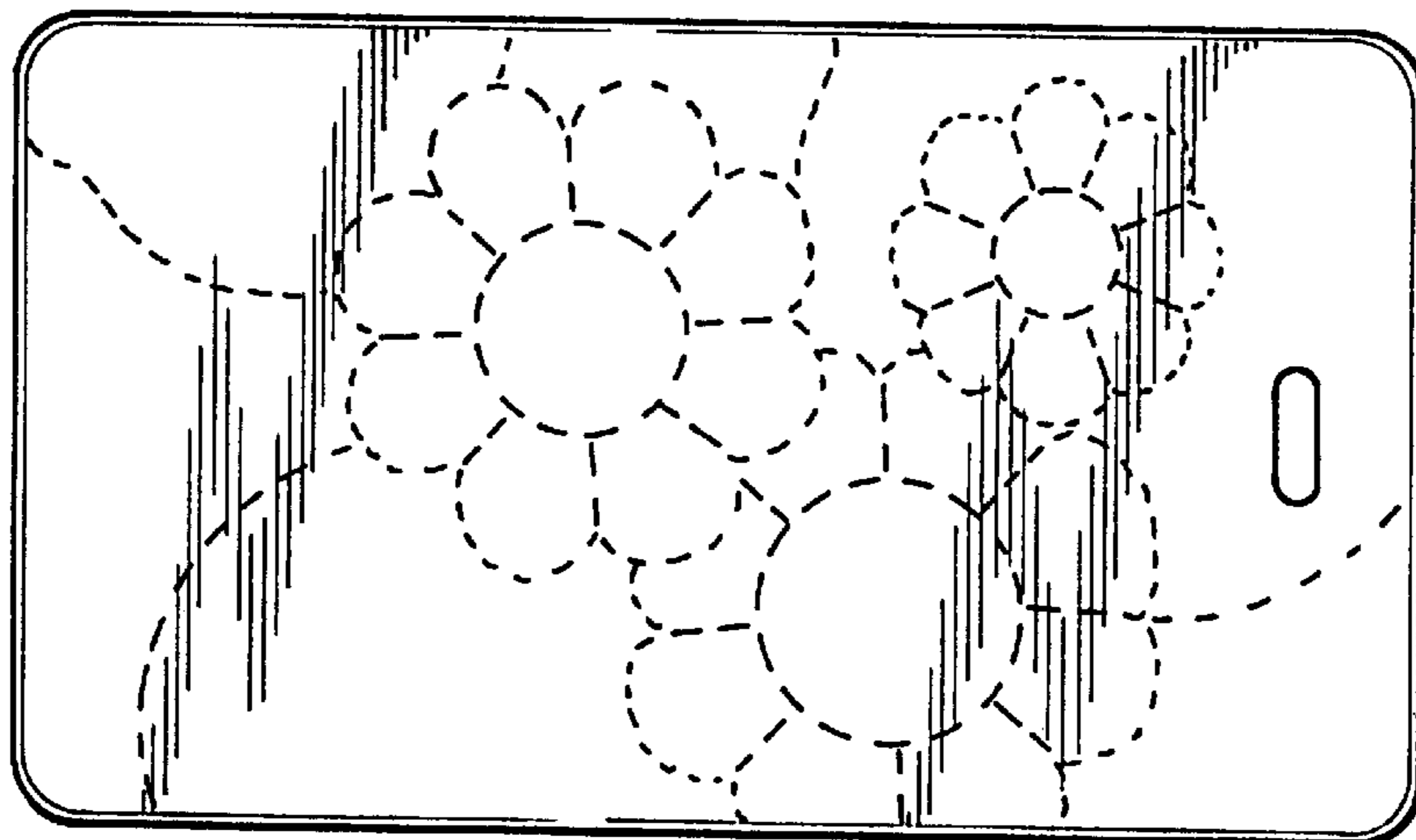
