The ornamental design for a coin display clock, as shown and described.

DESCRIPTION

FIG. 1 is a diagrammatic perspective view of the coin display clock in full lines with coins shown in broken lines representing environmental association matter being for illustrative purposes only and forming no part of the claimed invention.

FIG. 2 is a front elevational view of the coin display clock.

FIG. 3 is a rear elevational view thereof.

FIG. 4 is a top plan view thereof.

FIG. 5 is a bottom plan view thereof.

FIG. 6 is a left side elevational view of the coin display clock; and,

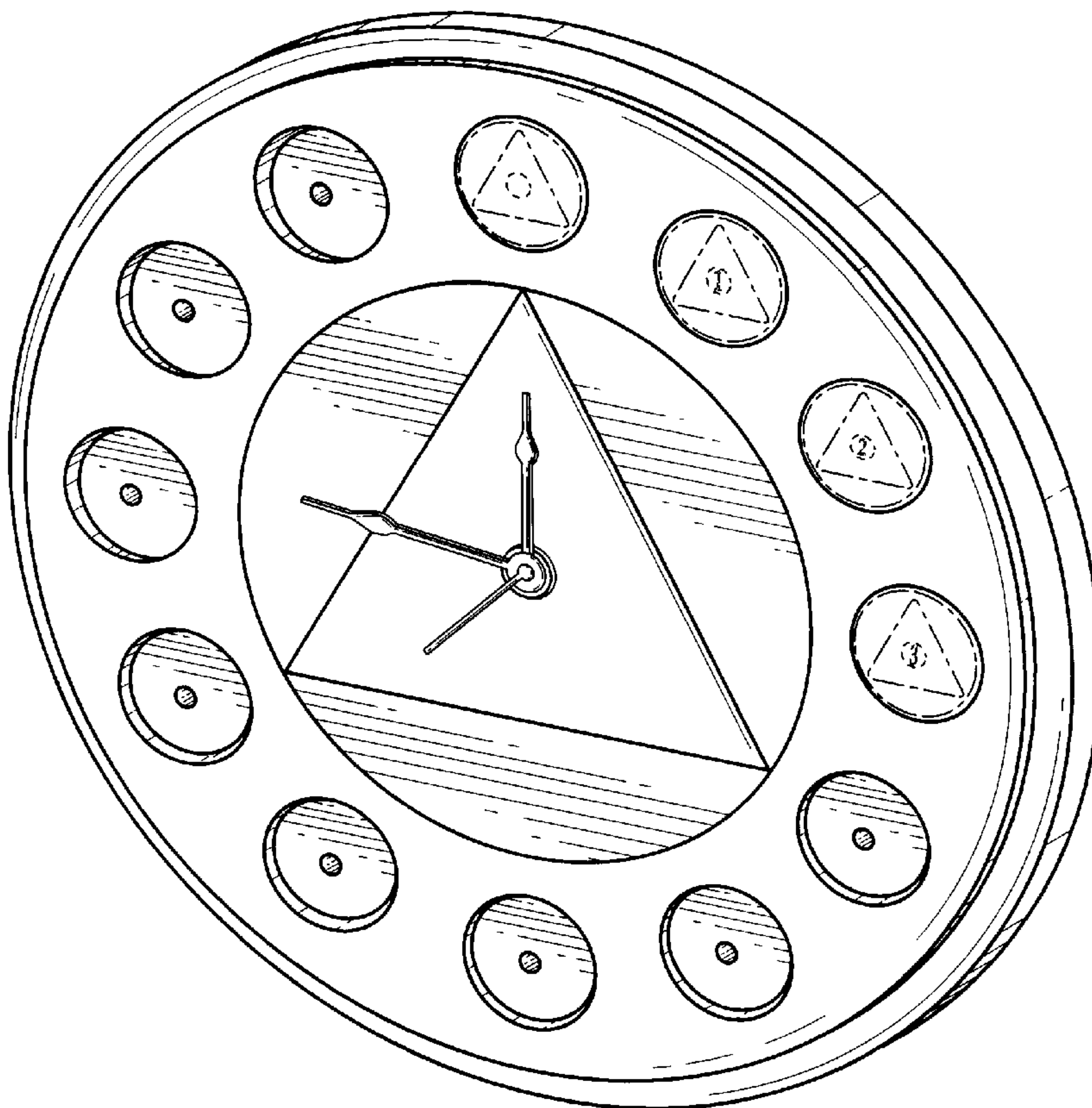
FIG. 7 is a right side elevational view thereof.

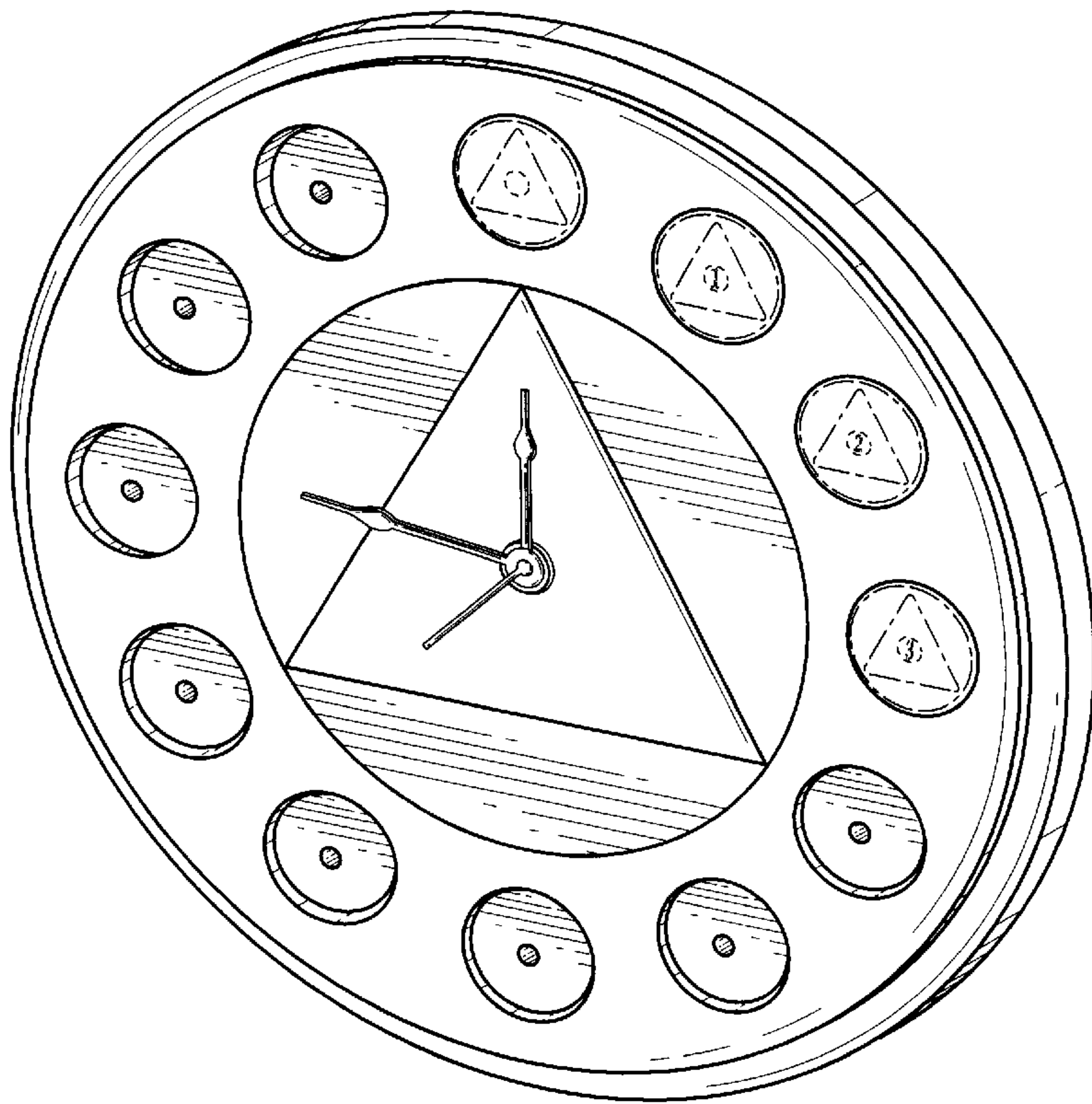

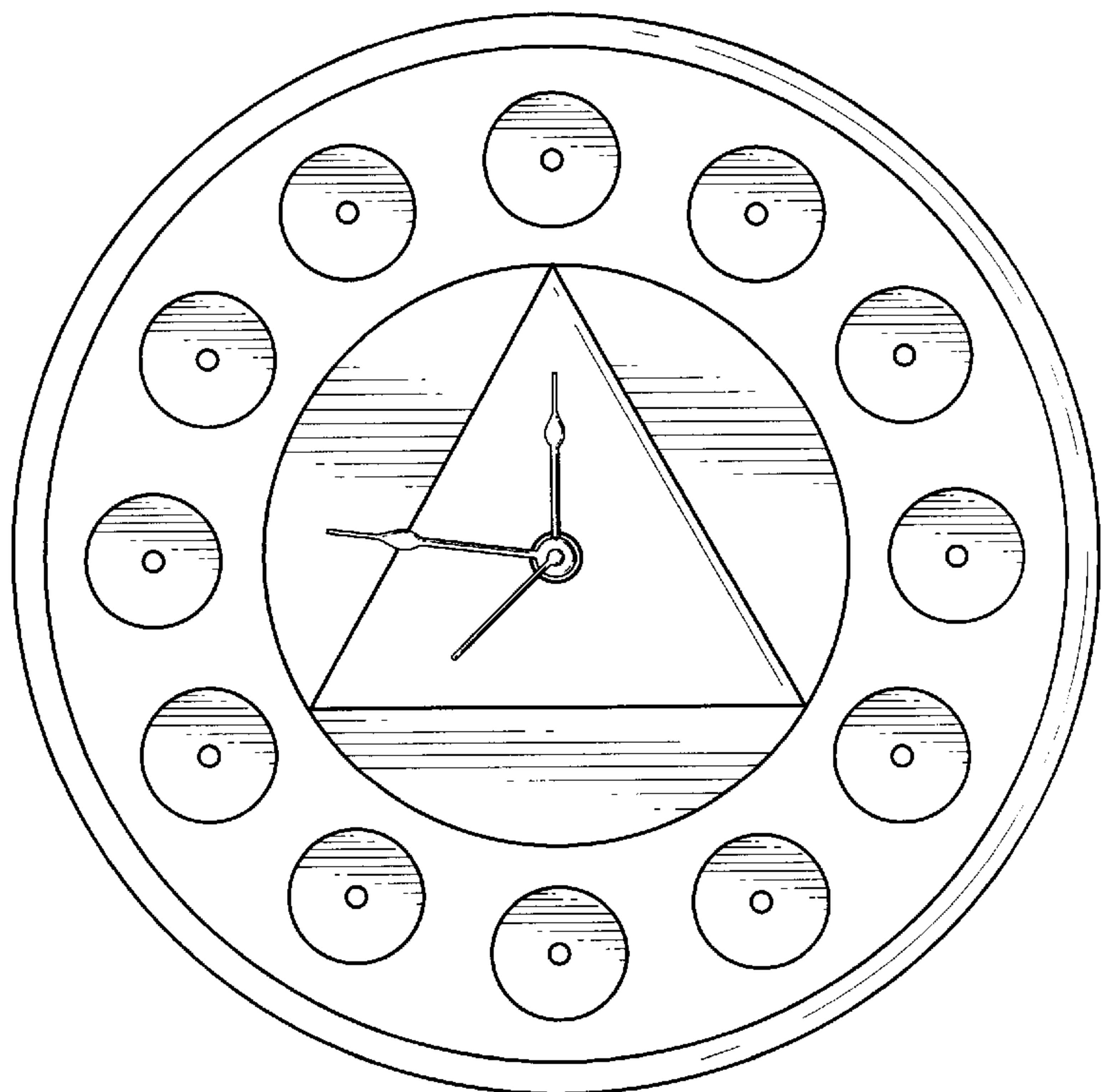

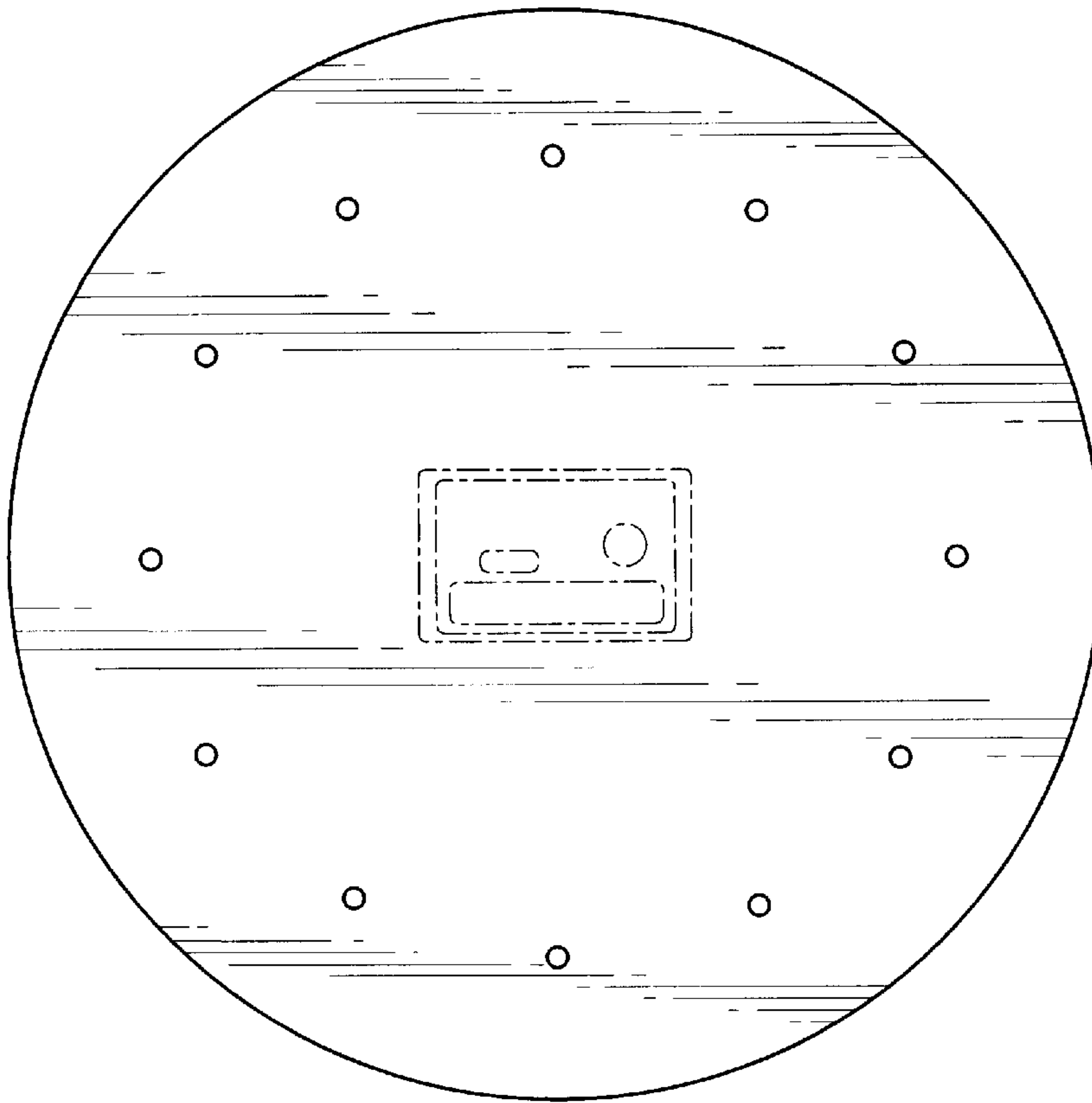

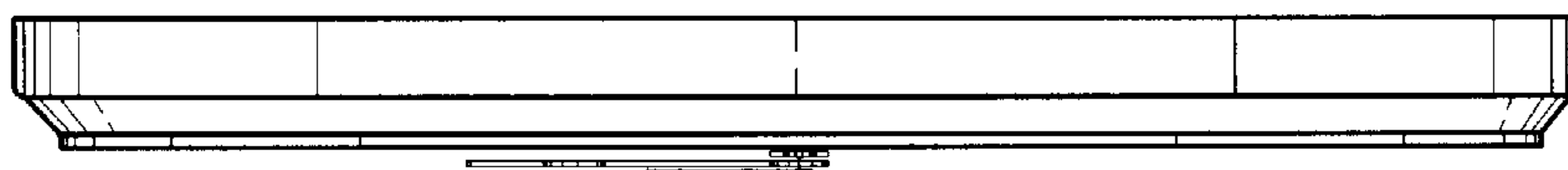

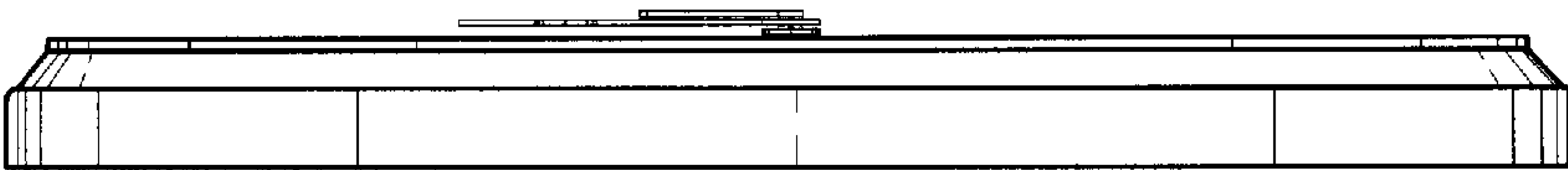

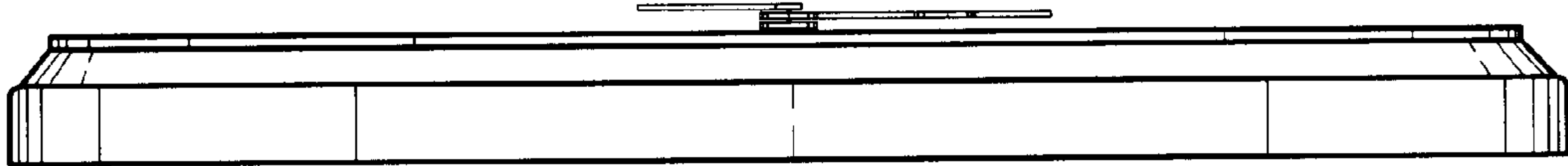

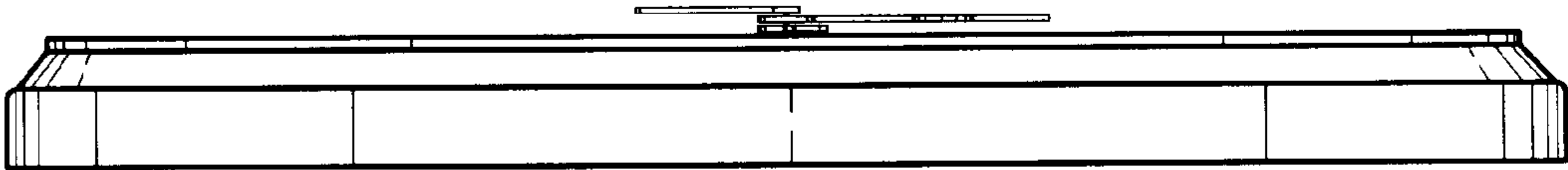
