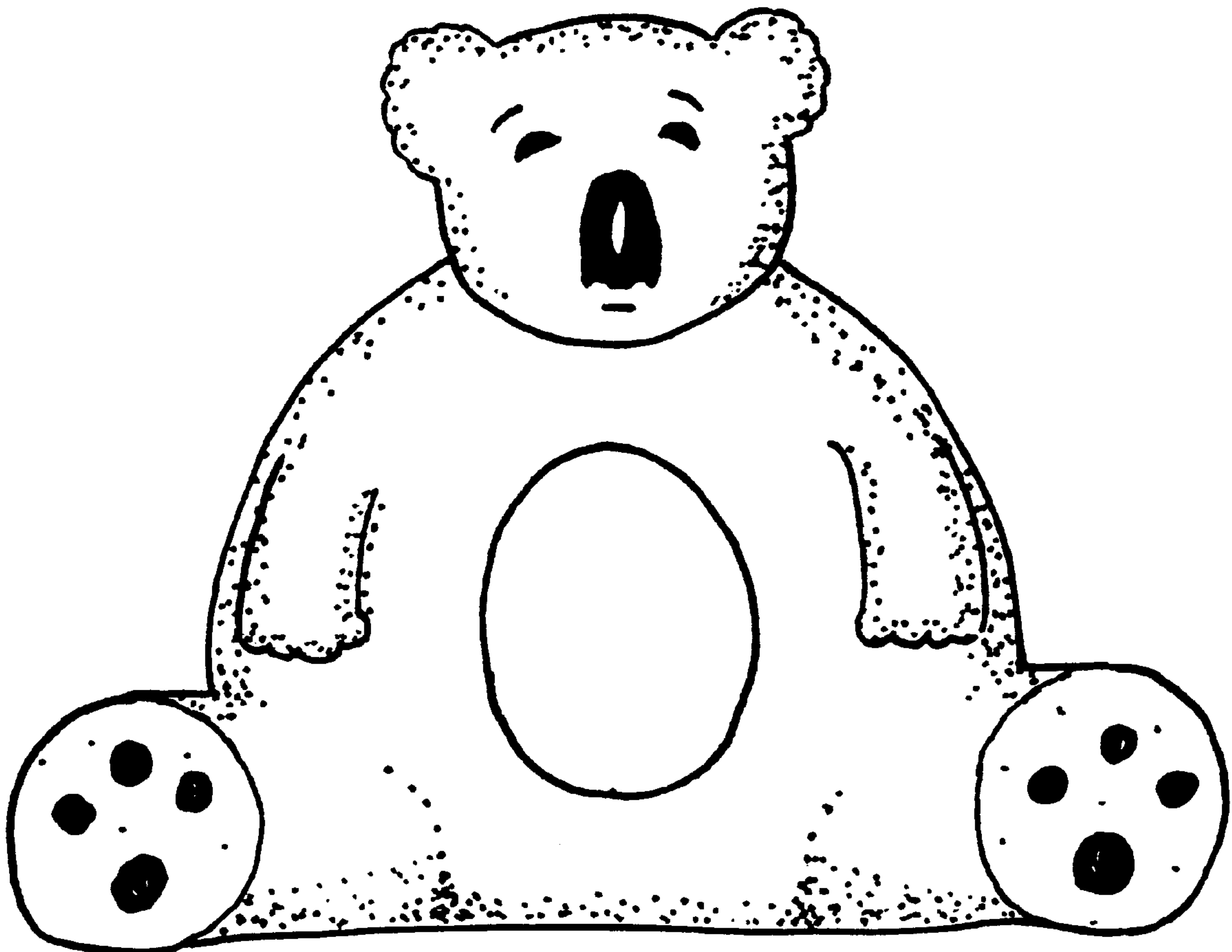
### [57] **CLAIM**

The ornamental design for a cushion in an animal configuration, as shown and described.

### DESCRIPTION

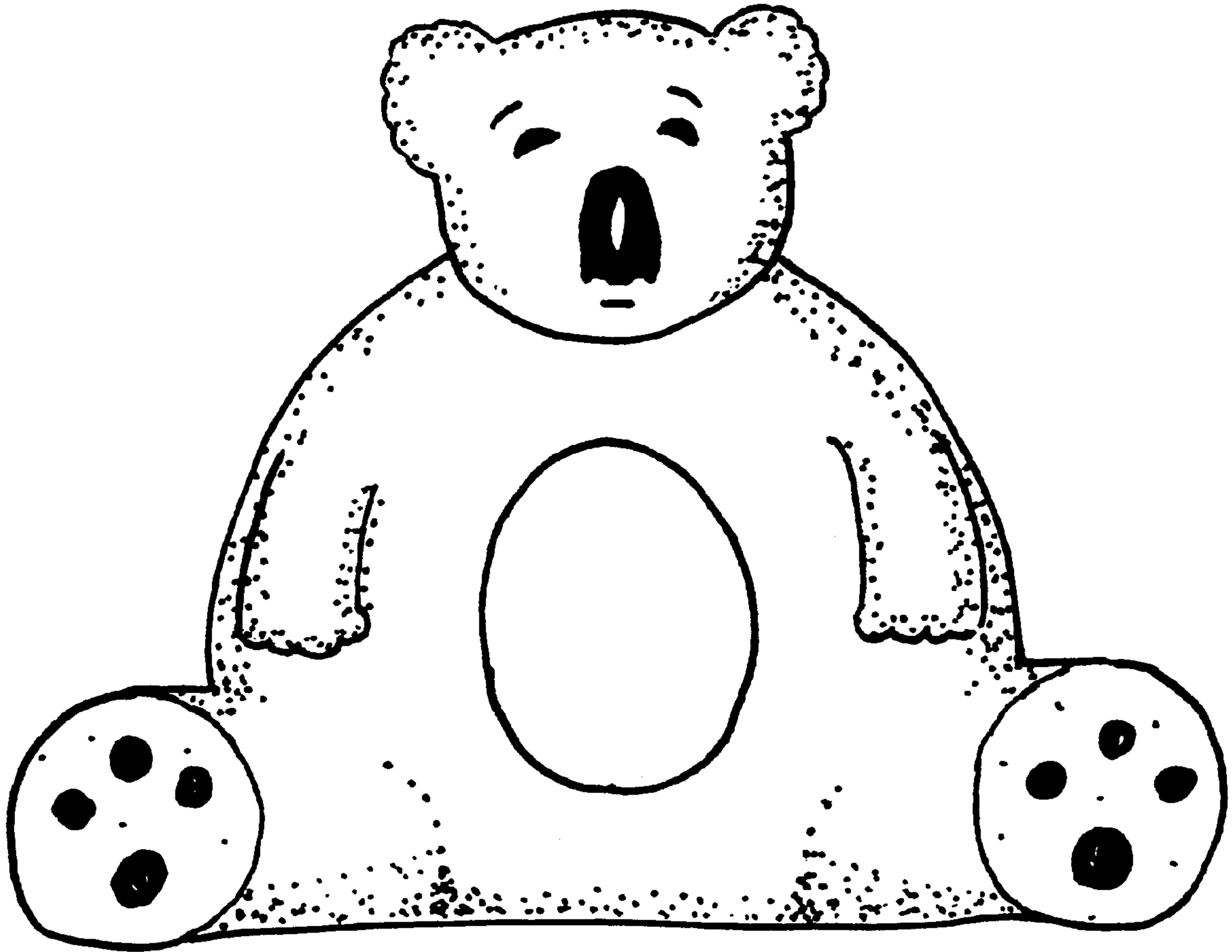

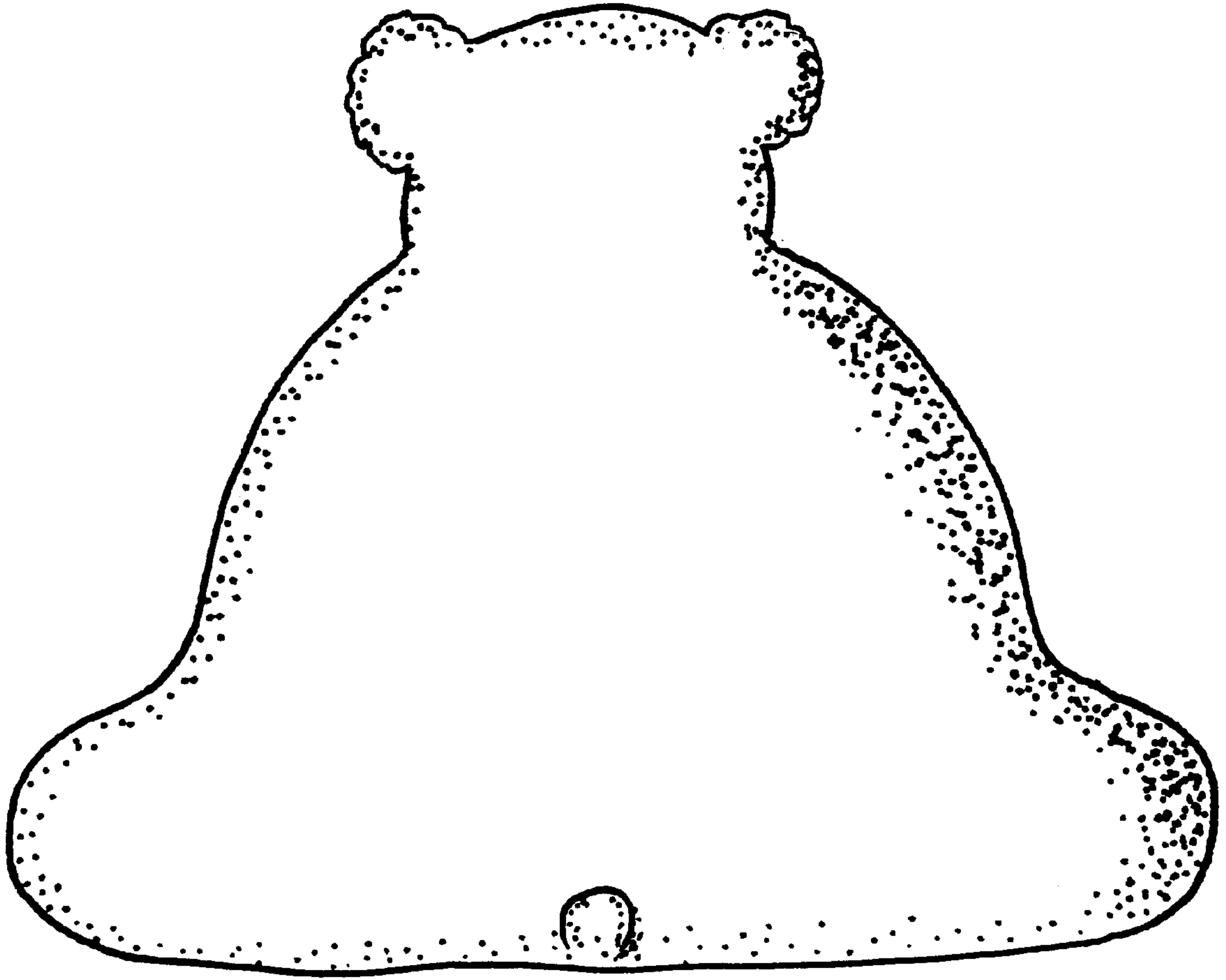
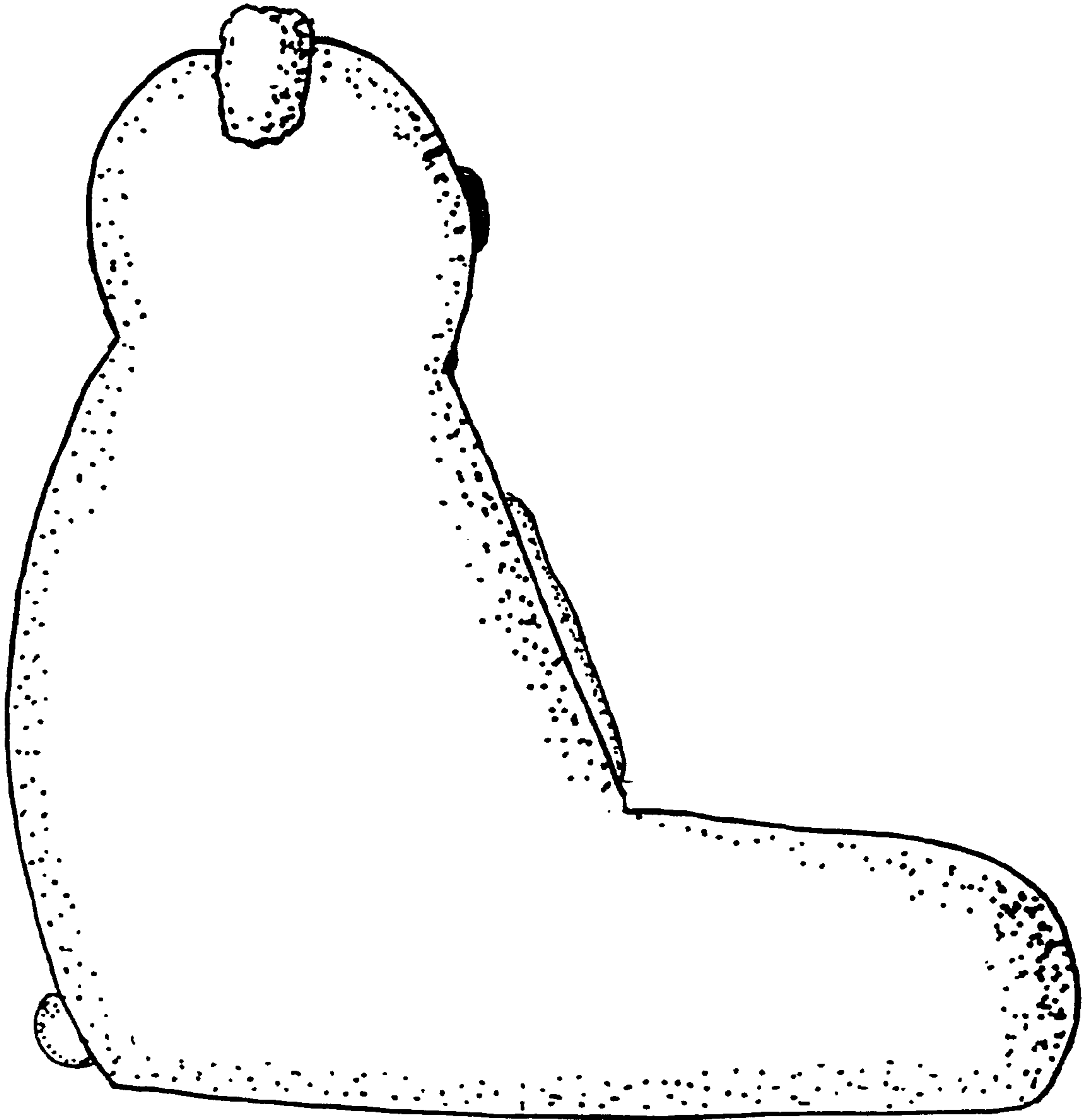

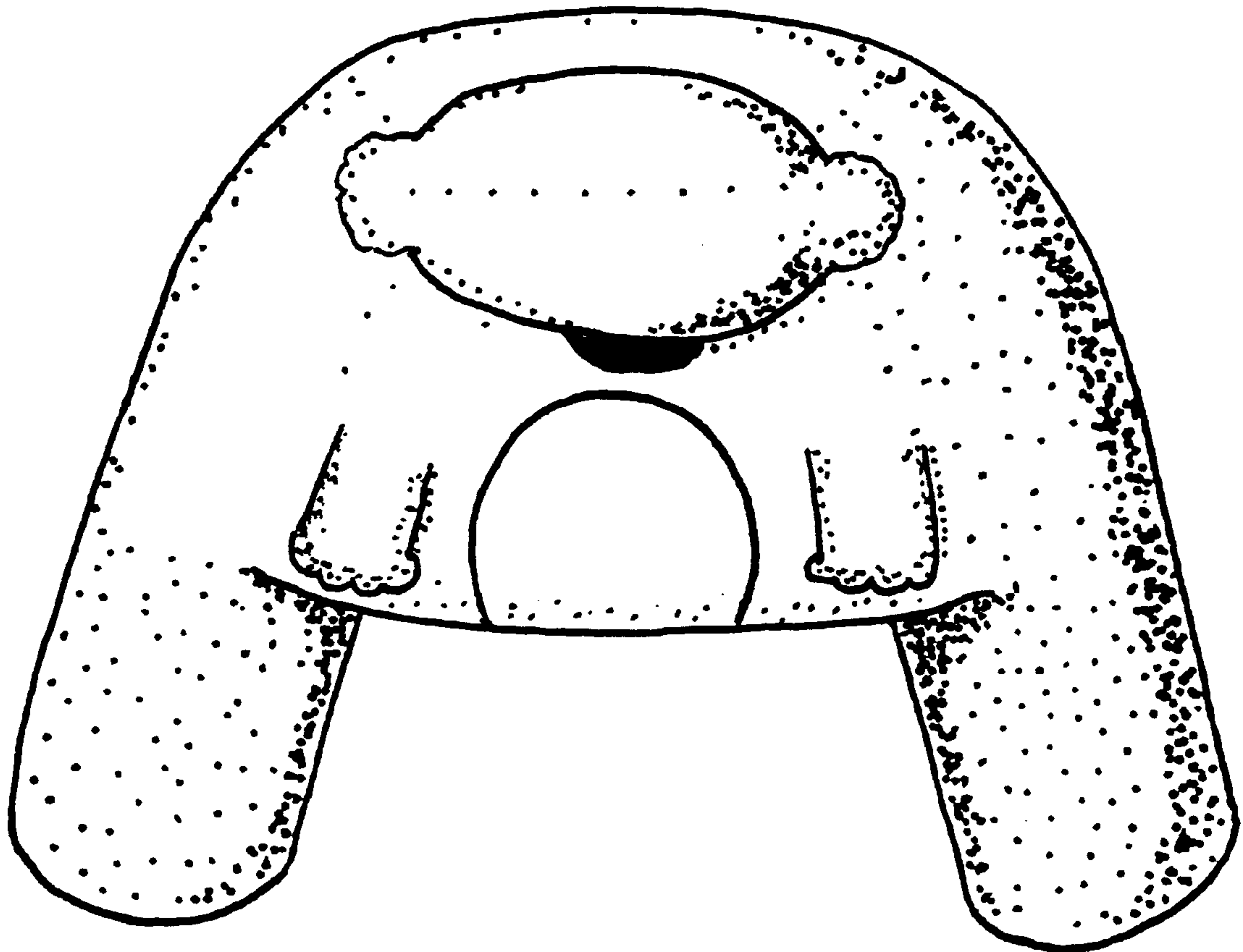

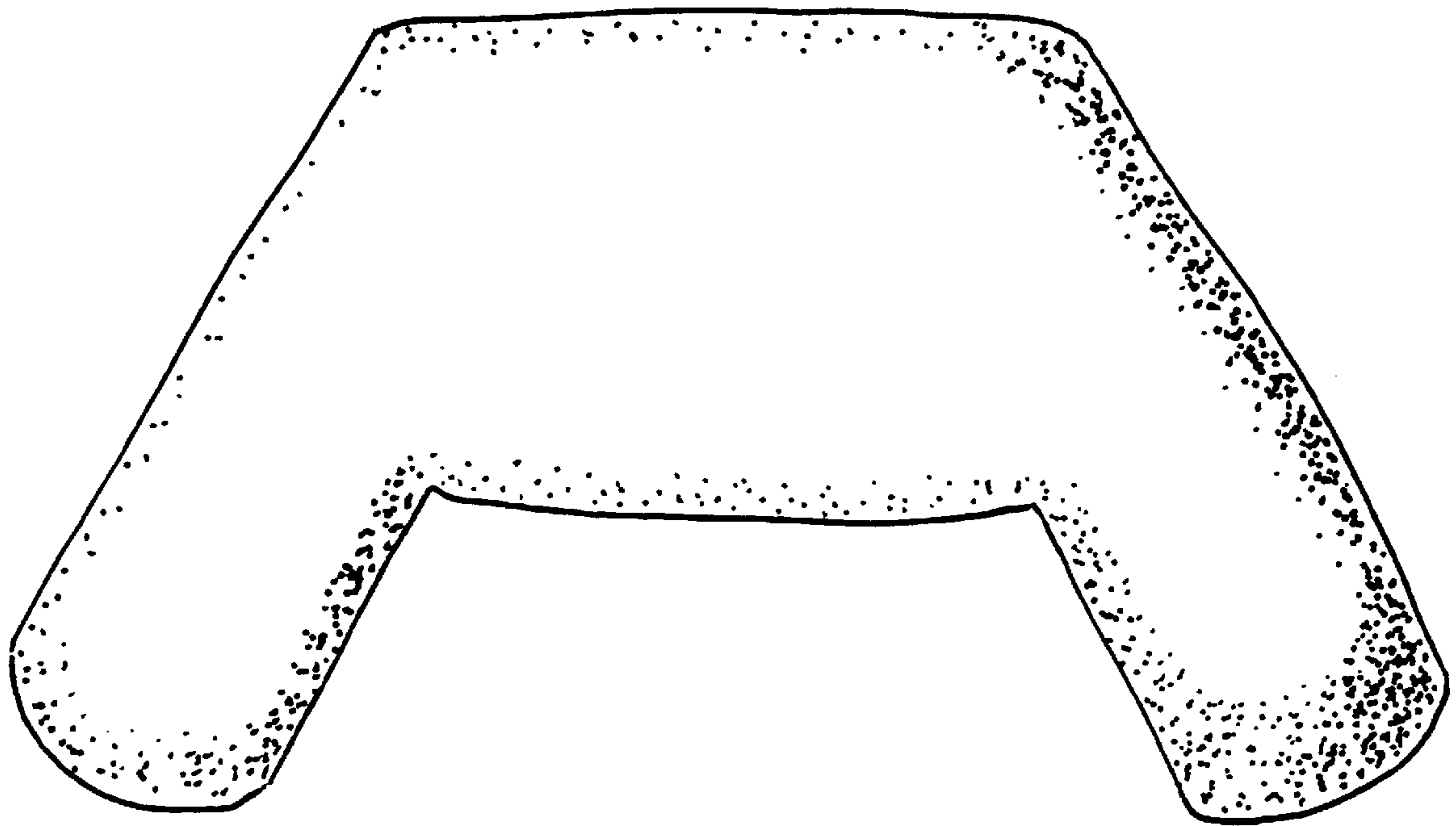
