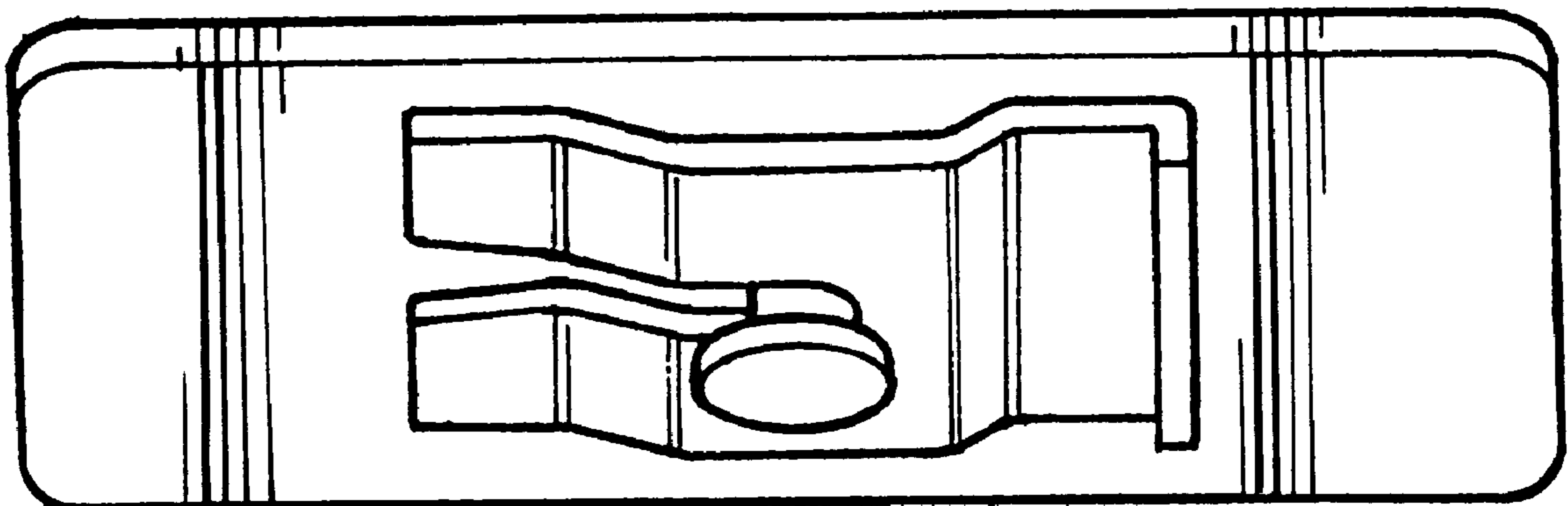

### DESCRIPTION

FIG. 1 is an exploded view showing my hood deflector retainer clip;  
FIG. 2 is a cross-sectional view showing the hood deflector retainer clip;  
FIG. 3 is an enlarged, exploded perspective view thereof which is shown detached for clarity of illustration;  
FIG. 4 is a side view fully assembled with the opposite side being a mirror image thereof; and,  
FIG. 5 is a plan view thereof.  
The broken line showing of partial vehicle hood and hood deflector is for illustrative purposes only and forms no part of the claimed design.  
FIG.6 is a perspective view of the claimed article fully assembled.

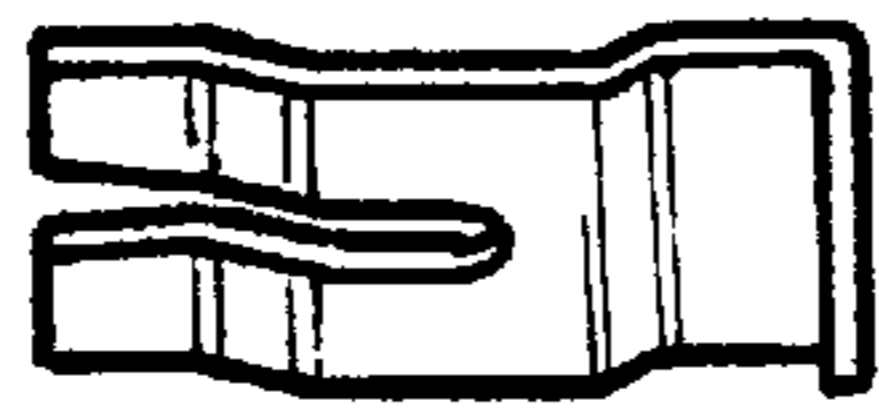
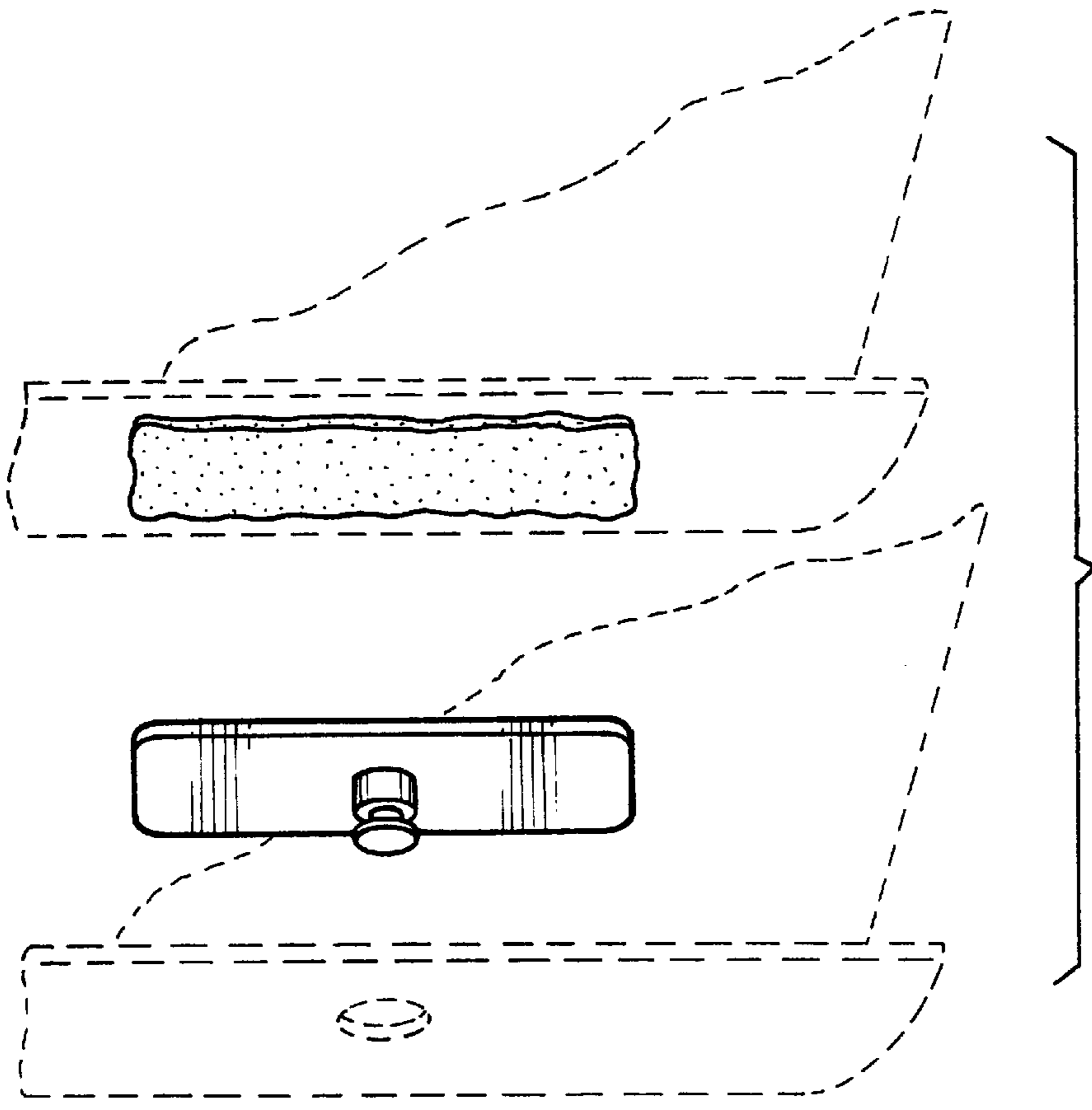
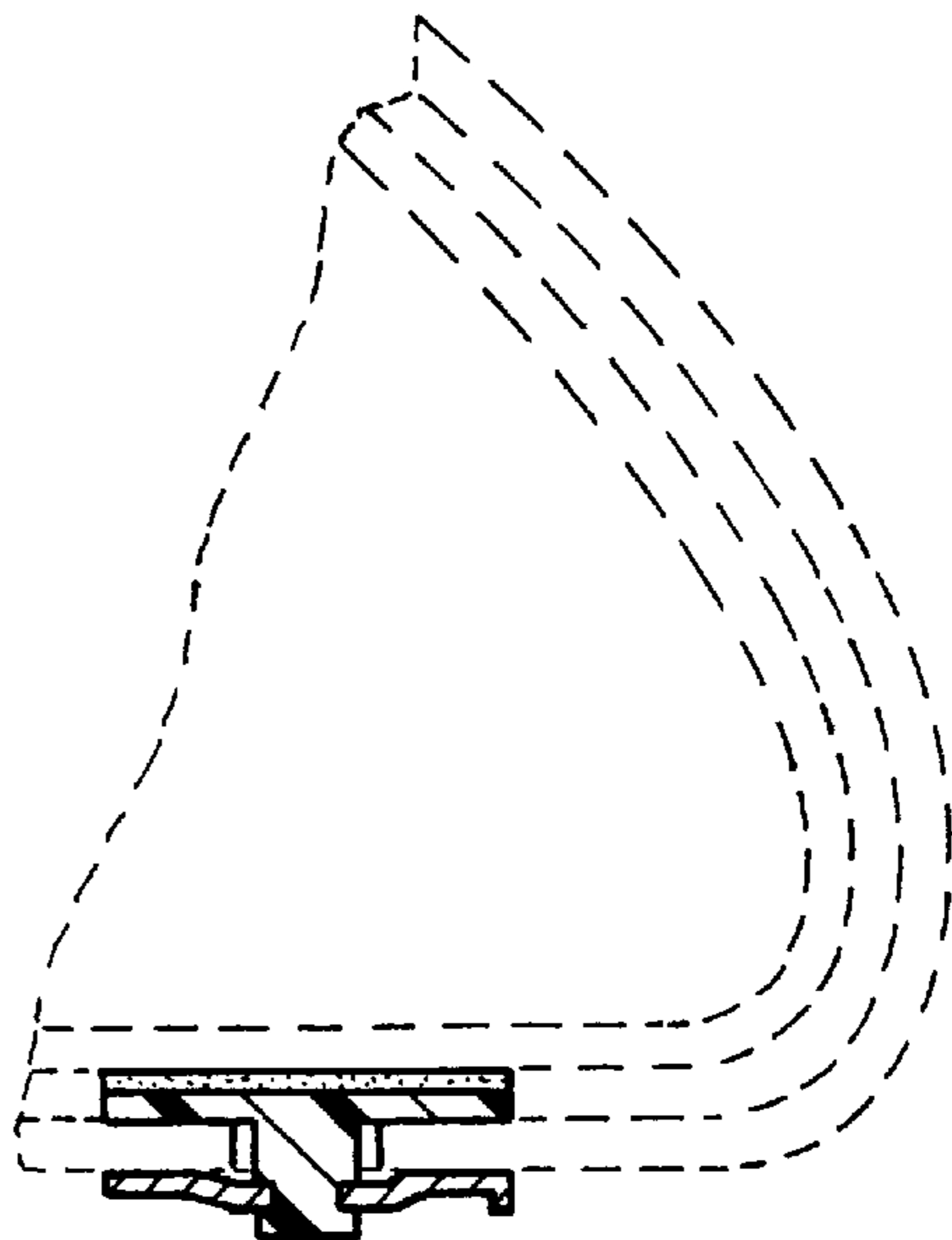

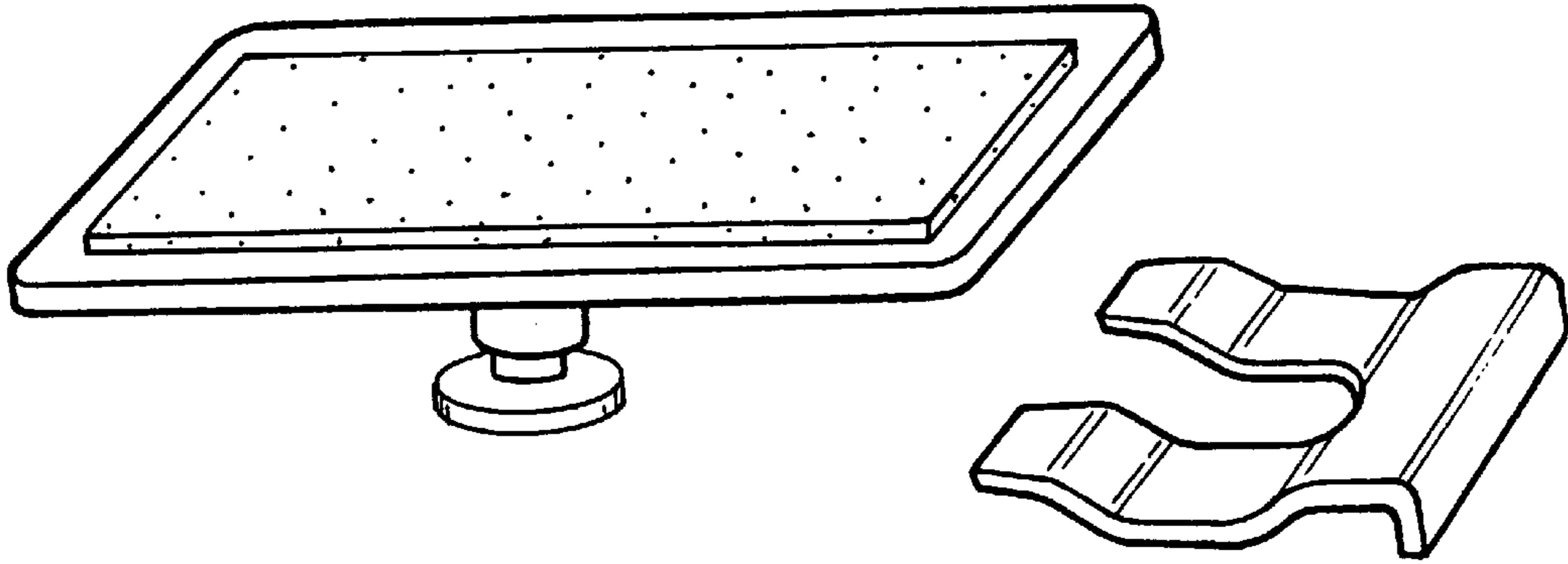

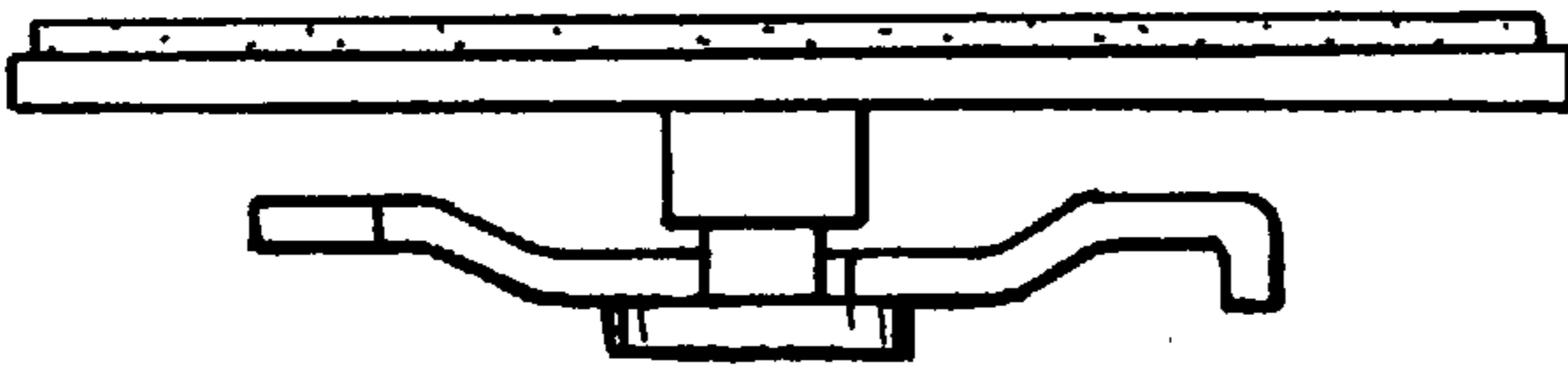

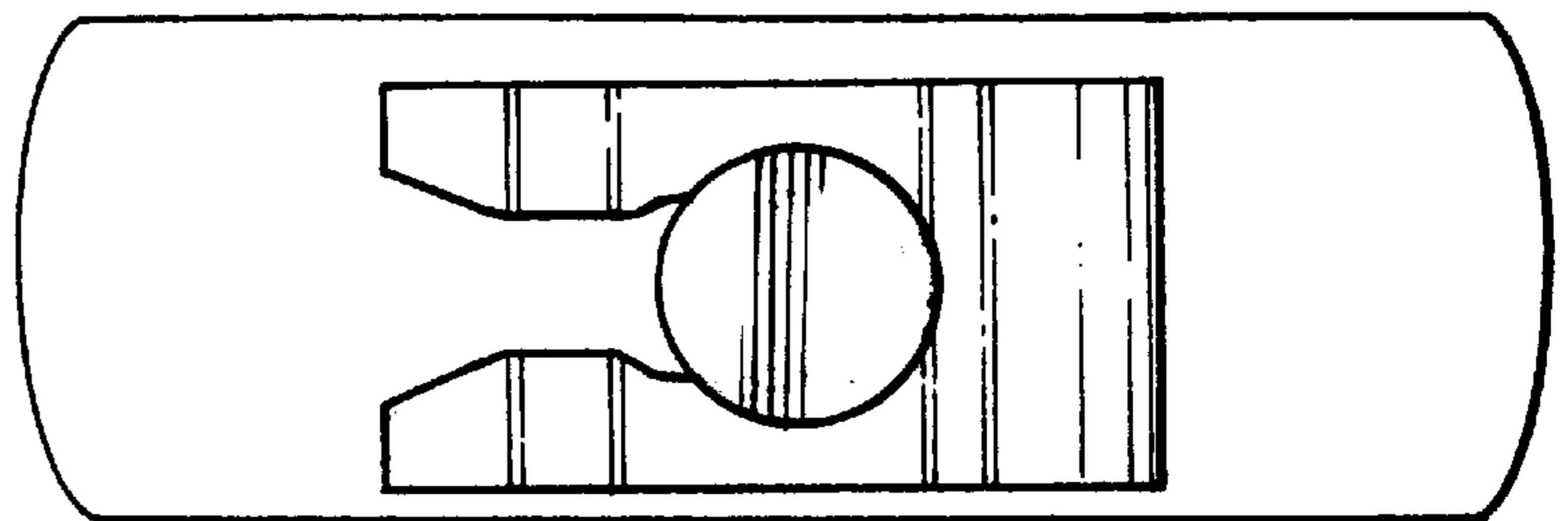

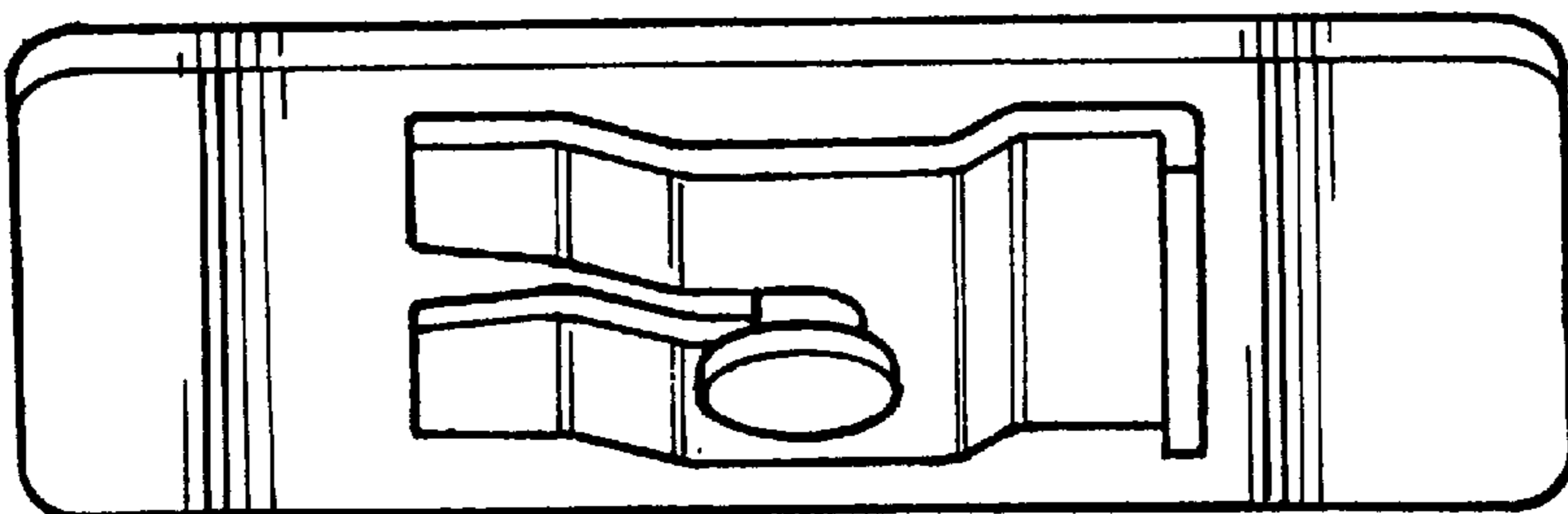
