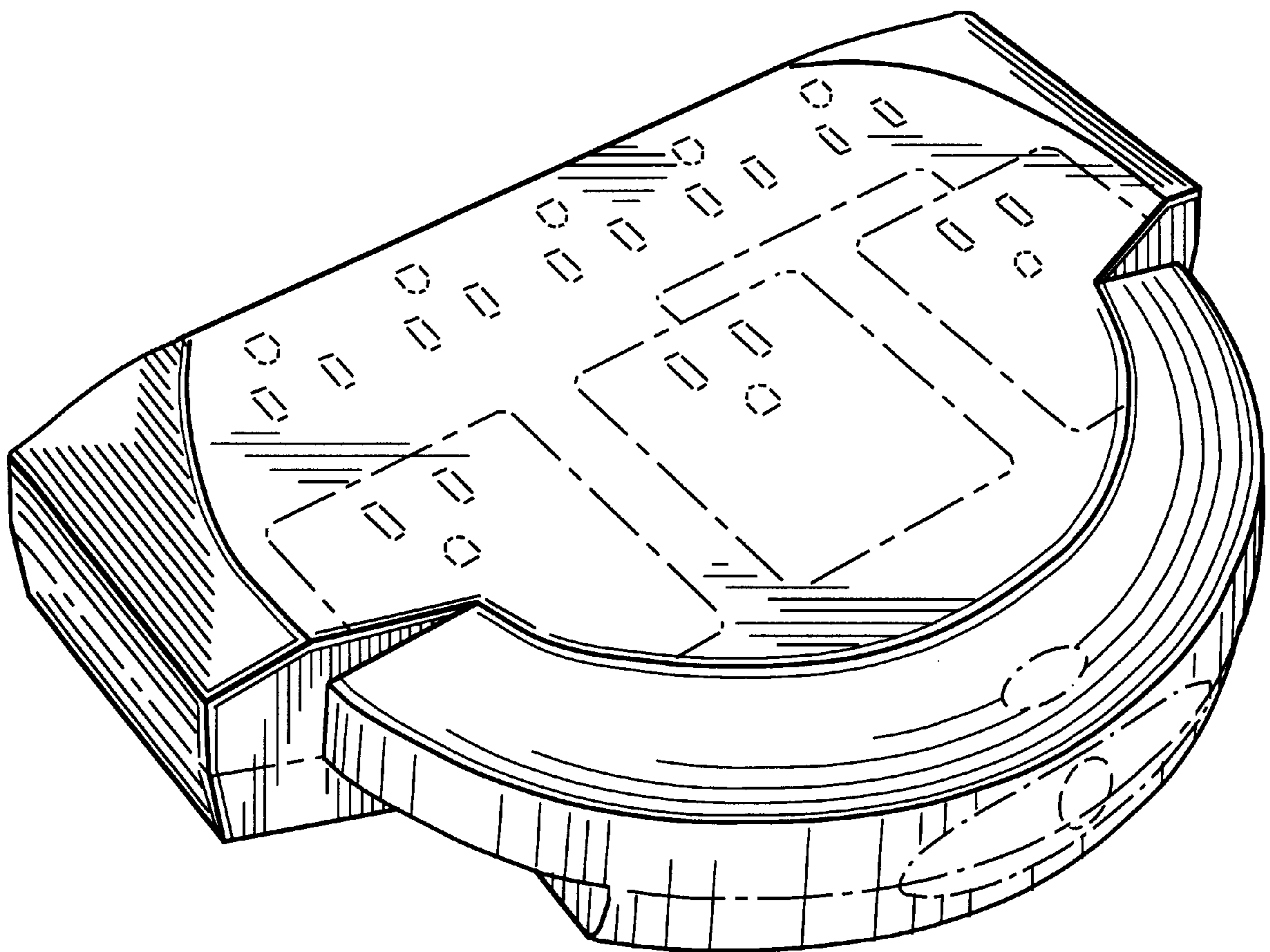
The broken line showing in FIGS. 1-7 of various elements and features of the electrical surge protector unit is for environmental purposes only and forms no part of the claimed design.

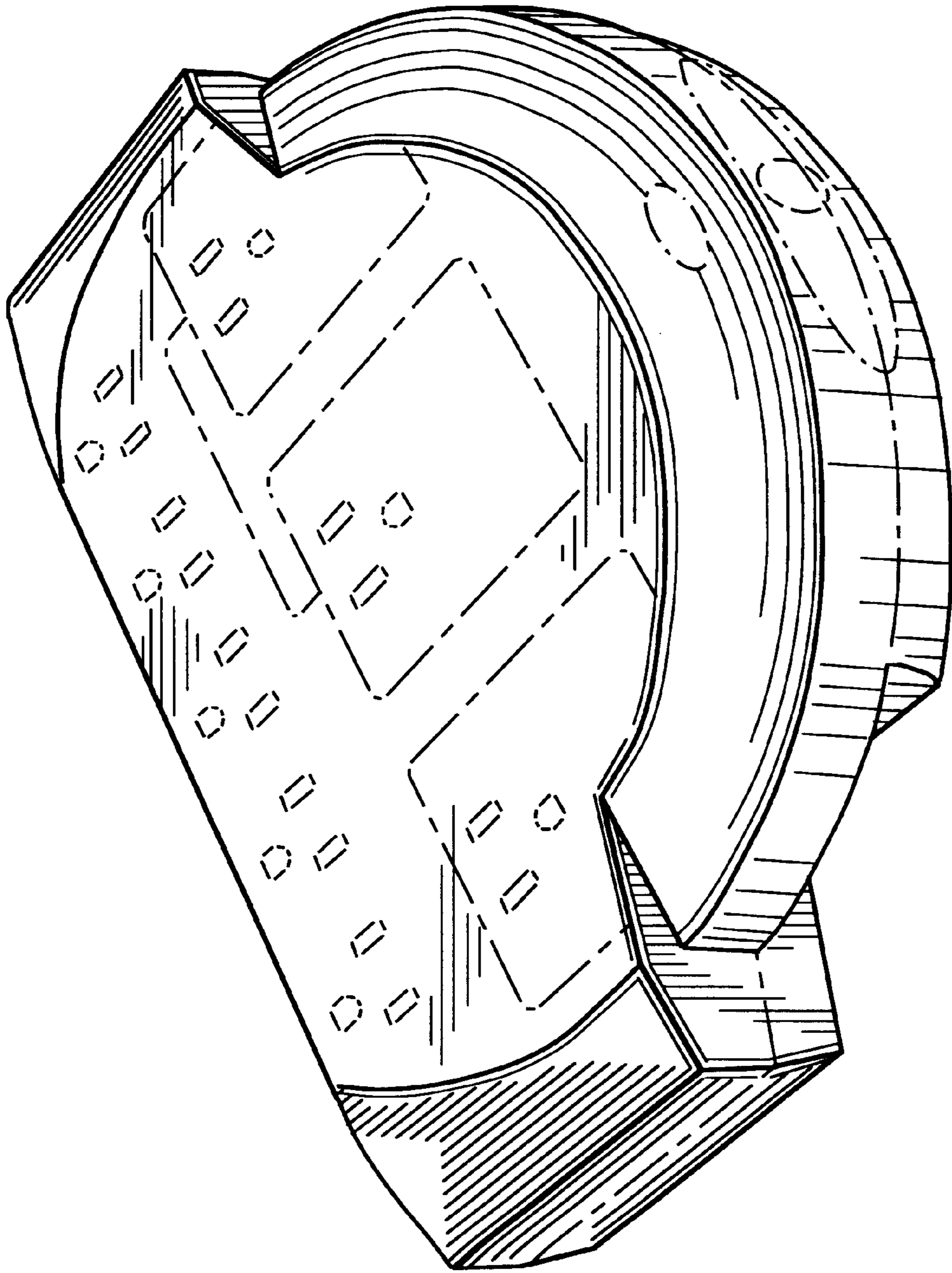

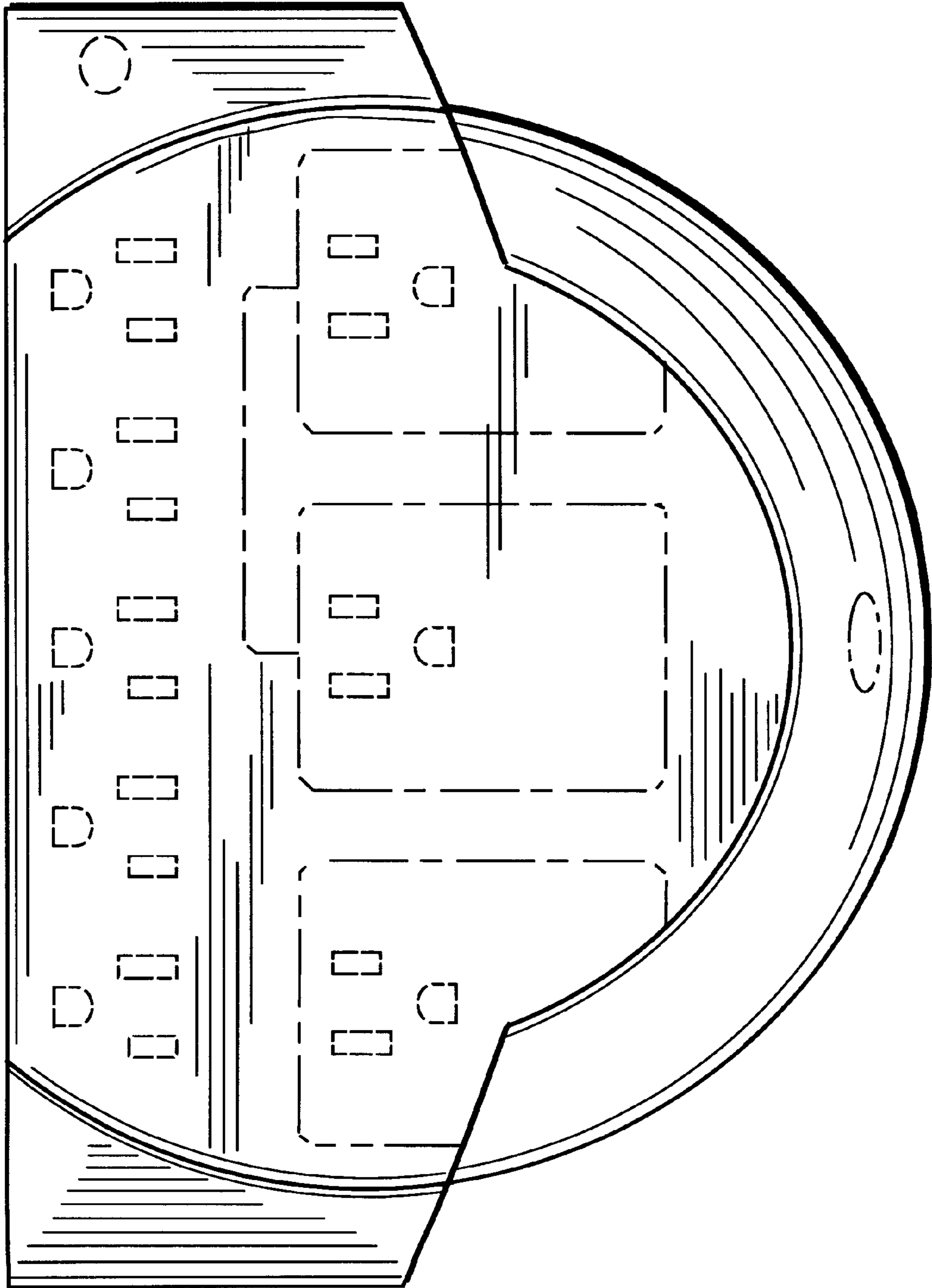

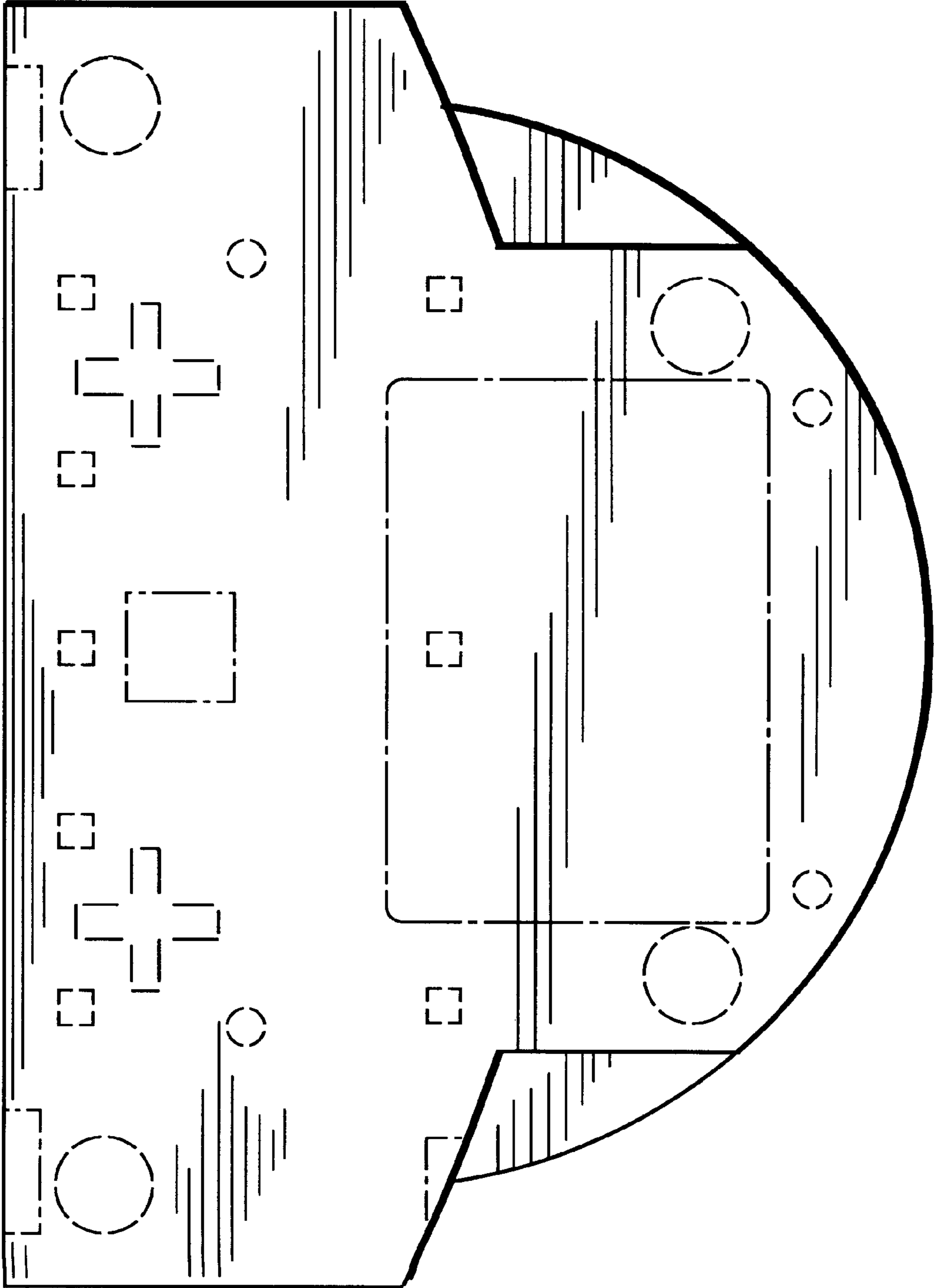

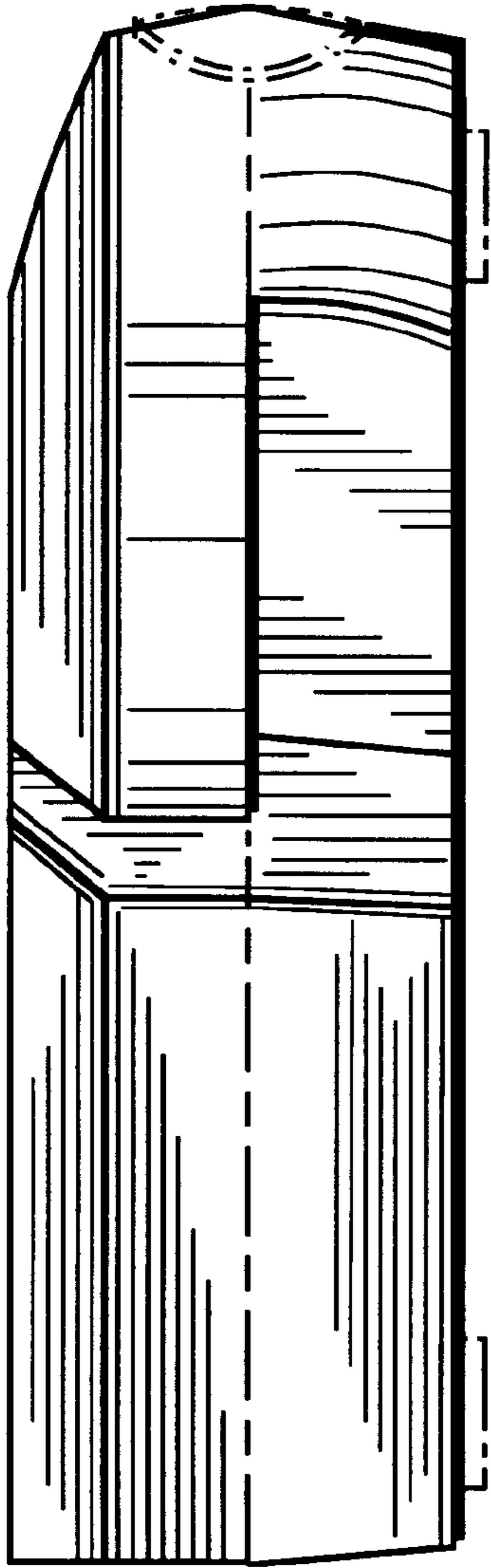

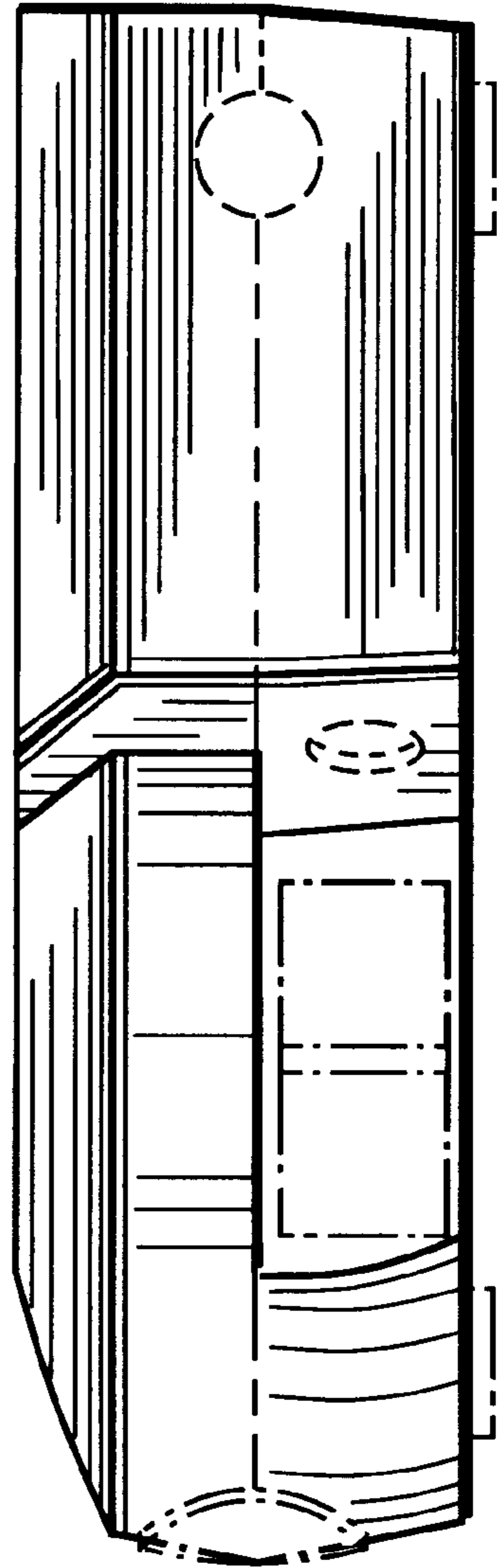

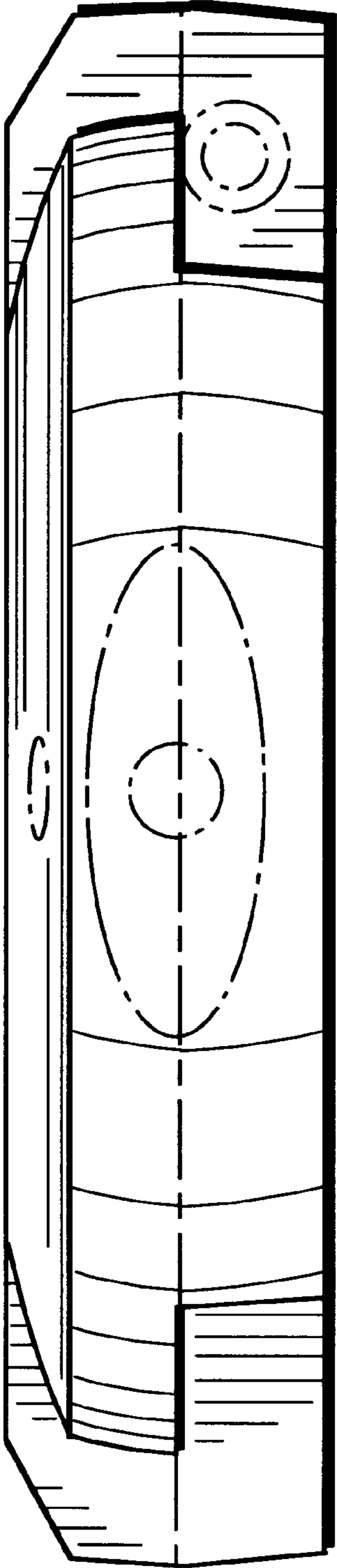

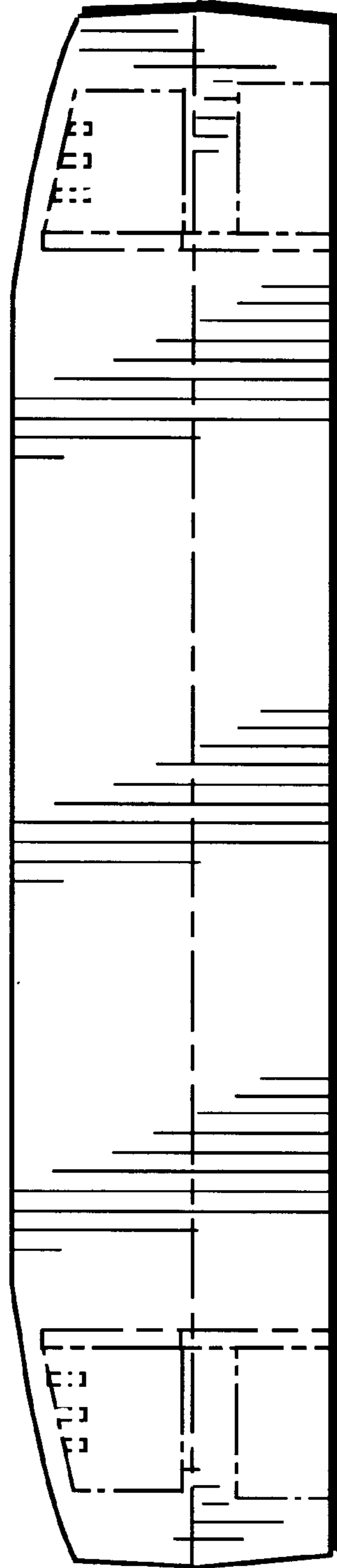
