[57] **CLAIM**

The ornamental design for an internally illuminated yard address sign, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational of the first embodiment of an internally illuminated yard address sign embodying the inventive design;

FIG. 2 is a right side elevational view of the design of FIG. 1, the left side being a mirror image; FIG. 3 is a rear elevational view of the design of FIG. 1; FIG. 4 is a top plan view of the design of FIG. 1; FIG. 5 is a bottom plan view of the design of FIG. 1; FIG. 6 is a front perspective view of the design of FIG. 1; FIG. 7 is a right side perspective view of the design of FIG. 1;

FIG. 8 is a front elevational view of the second embodiment of an internally illuminated yard address sign; FIG. 9 is a right side elevational view of the design of FIG. 8, the left side being a mirror image; FIG. 10 is a rear elevational view of the design of FIG. 8; FIG. 11 is a top plan view of the design of FIG. 8; FIG. 12 is a bottom plan view of the design of FIG. 8; FIG. 13 is a front perspective view of the design of FIG. 8; FIG. 14 is a right side perspective view of the design of FIG. 8;

FIG. 15 is a front elevational view of the third embodiment of an internally illuminated yard address sign; FIG. 16 is a right side elevational view of the design of FIG. 15, the left side being a mirror image; FIG. 17 is a rear elevational view of the design of FIG. 15; FIG. 18 is a top plan view of the design of FIG. 15; FIG. 19 is a bottom plan view of the design of FIG. 15; FIG. 20 is a front perspective view of the design of FIG. 15; FIG. 21 is a right side perspective view of the design of FIG. 15;

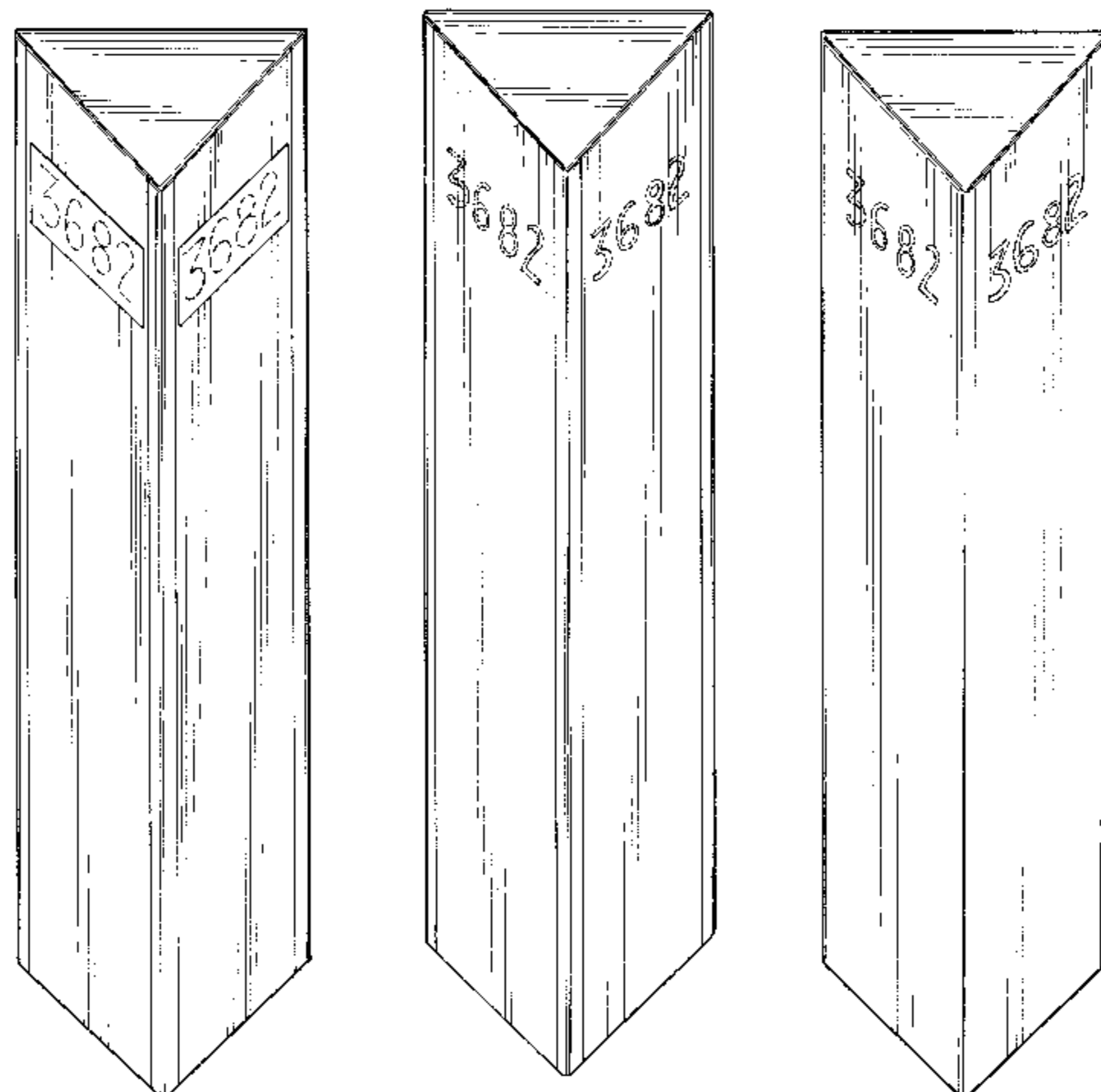
FIG. 22 is a right rear perspective view of the first embodiment design of FIG. 1, the opposite perspective view being a mirror image and the bottom view being disclosed in FIG. 5;

FIG. 23 is a right rear perspective view of the second embodiment design of FIG. 8, the opposite perspective view being a mirror image and the bottom view being disclosed in FIG. 12; and,

FIG. 24 is a right rear perspective view of the third embodiment design of FIG. 15, the opposite perspective view being a mirror image and the bottom view being disclosed in FIG. 19.

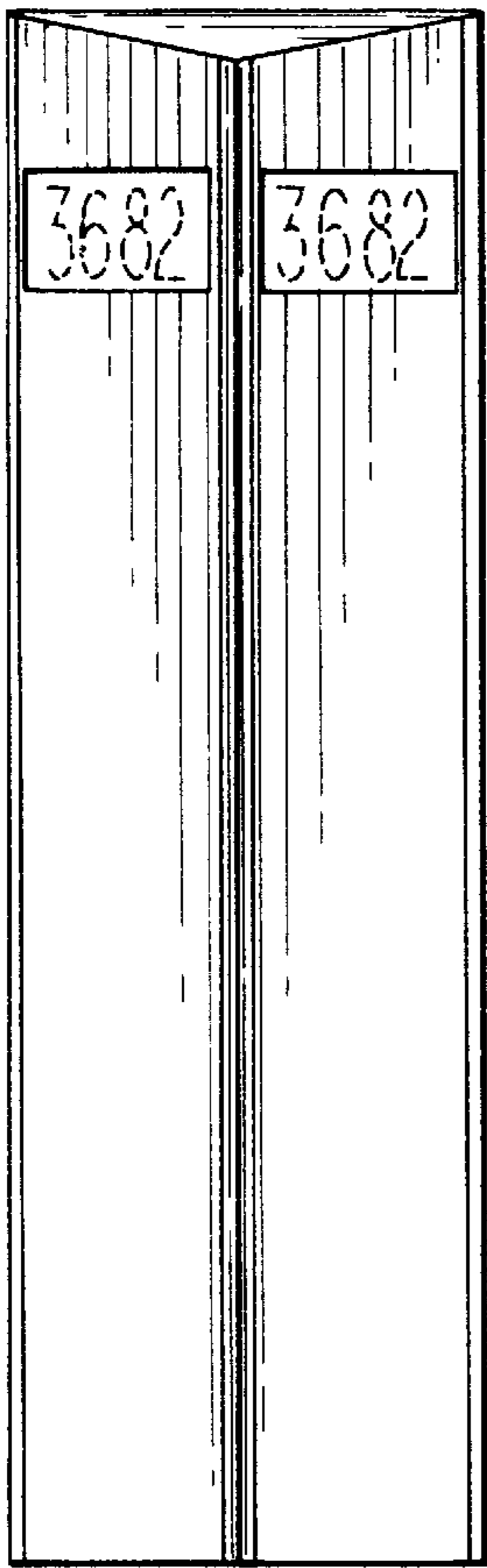

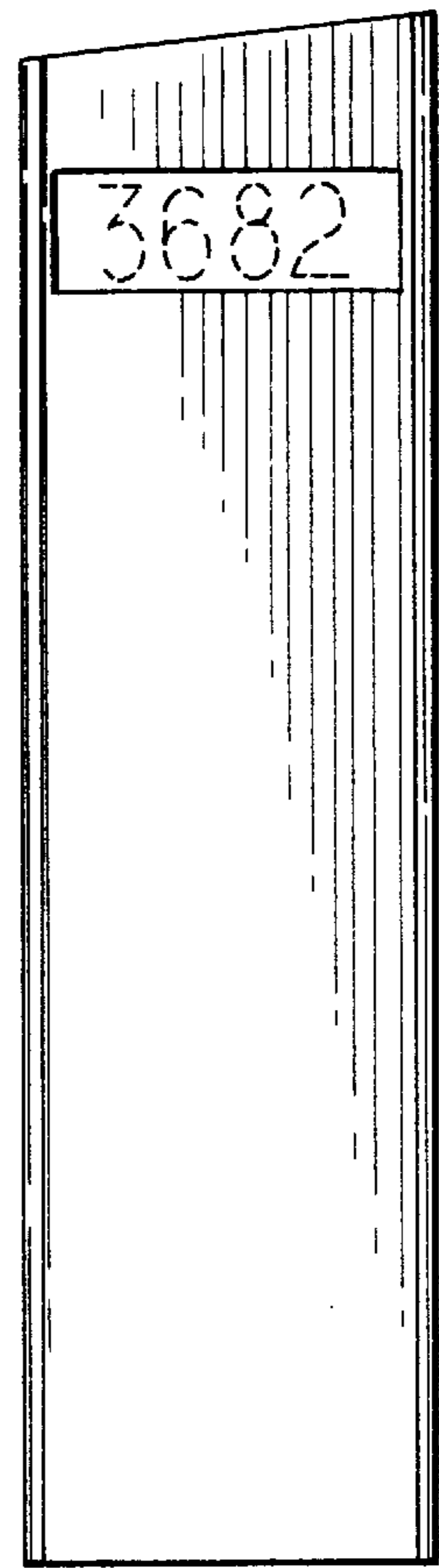

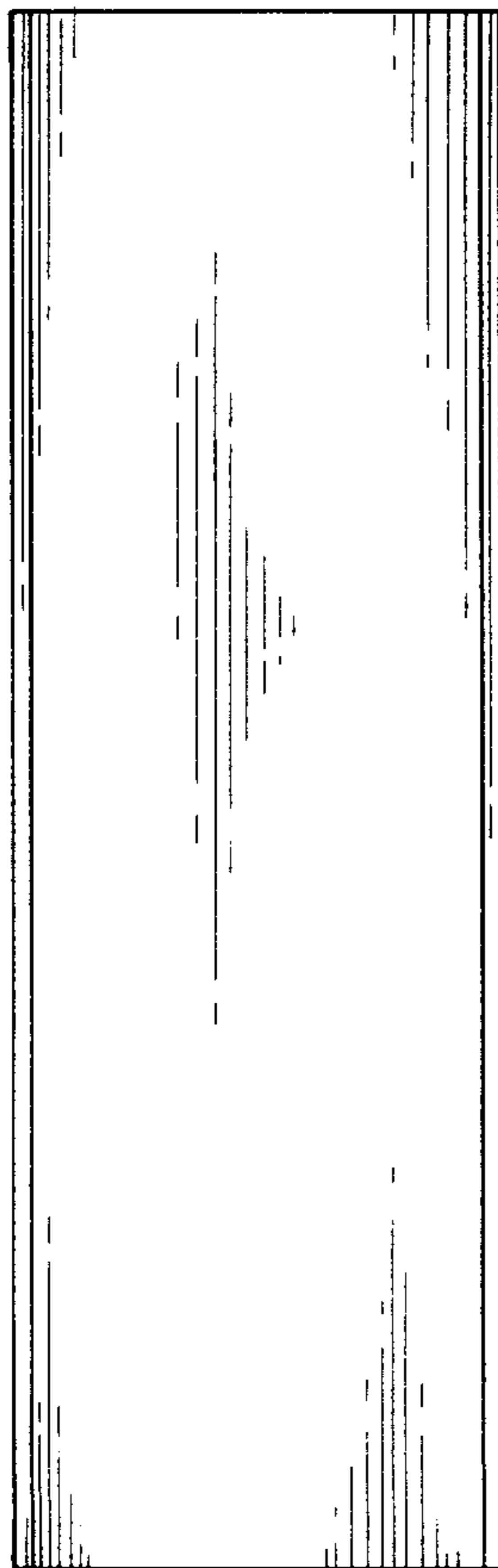

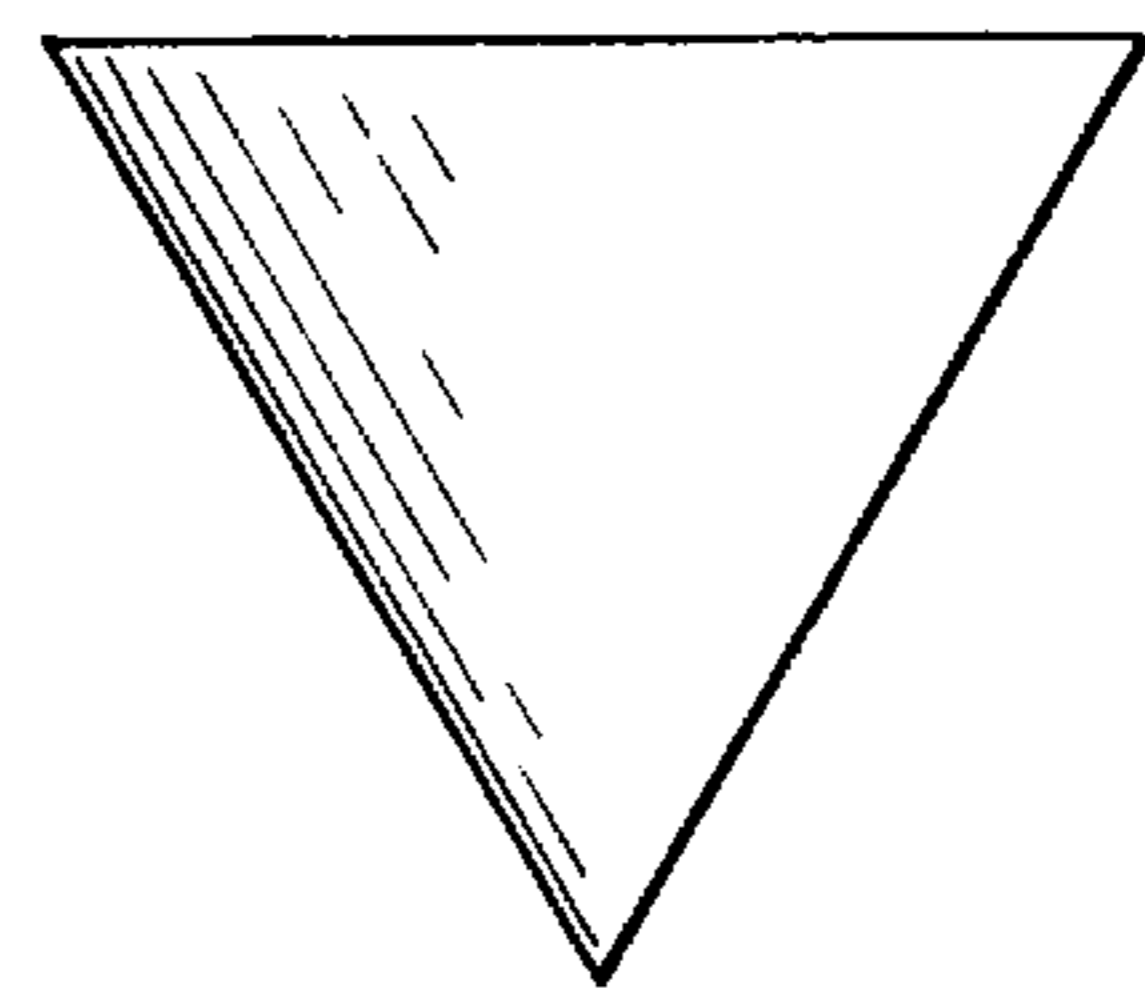

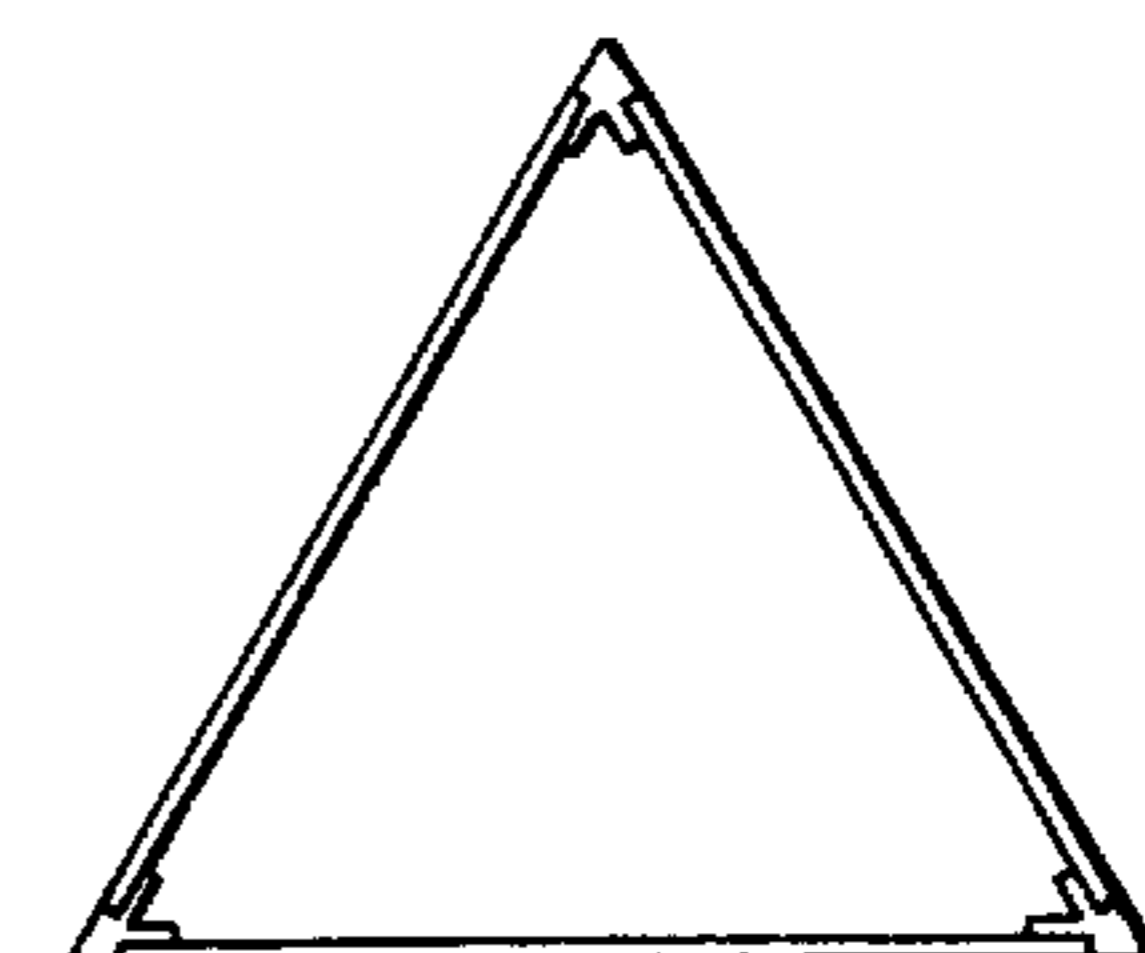

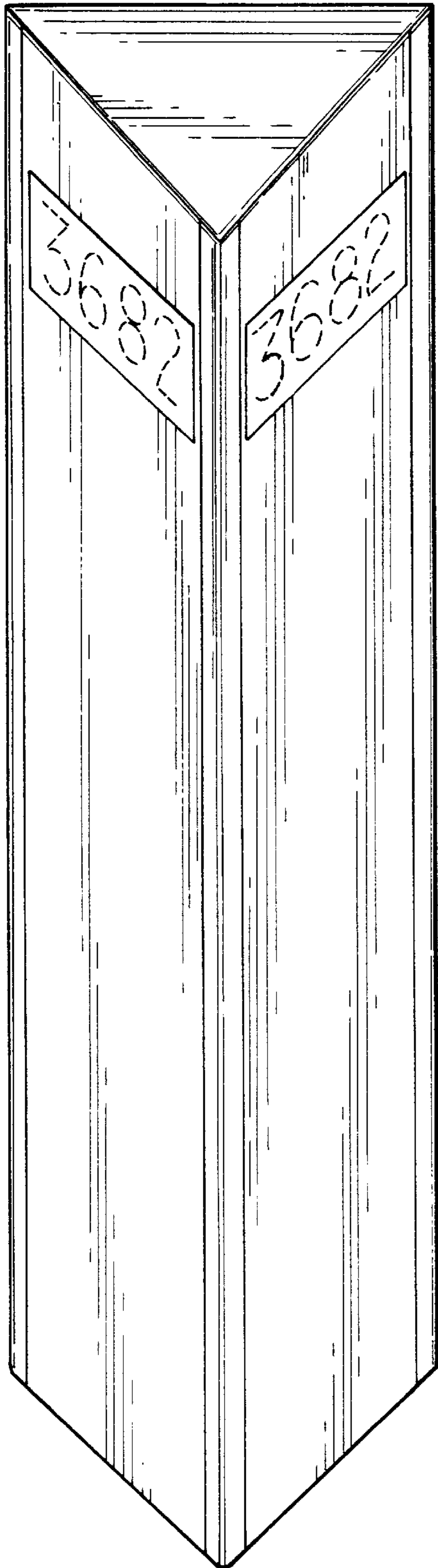

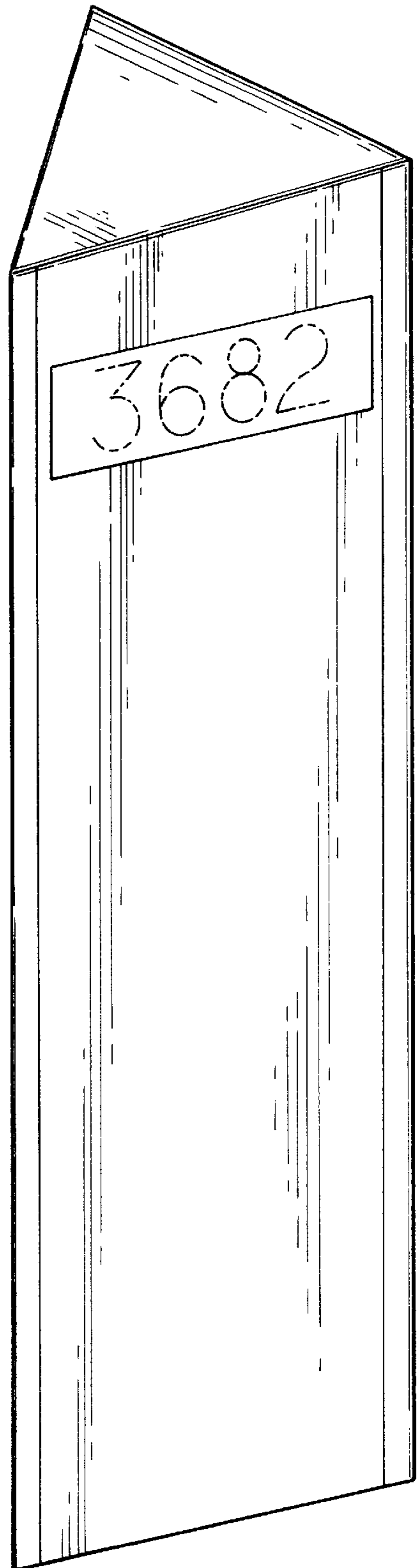

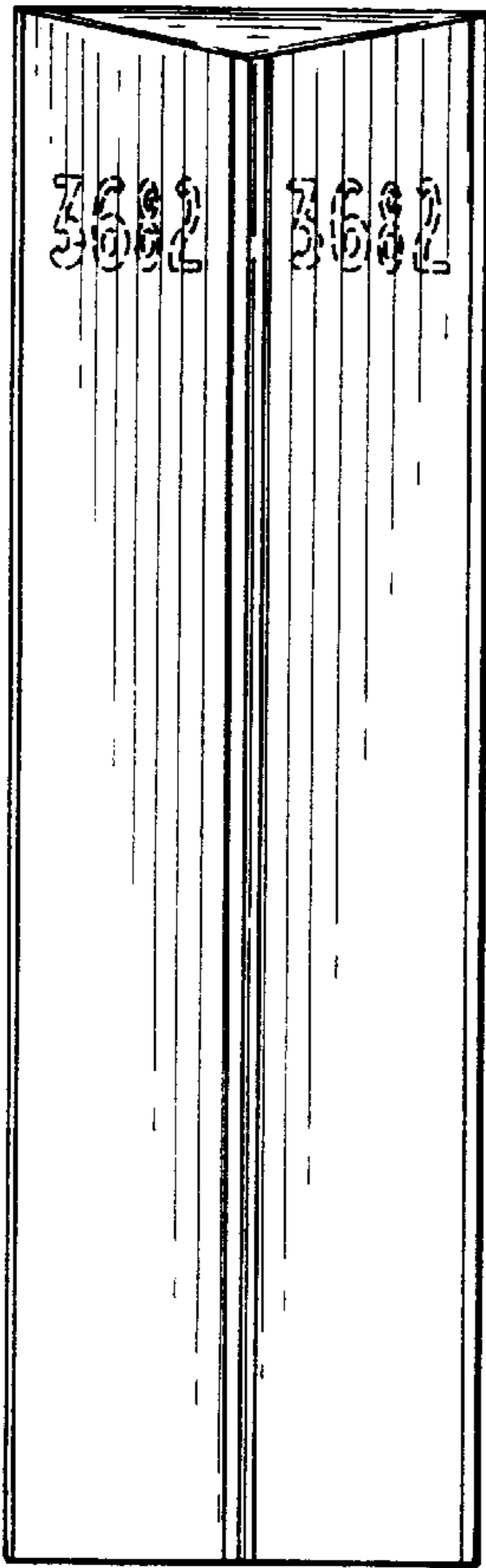

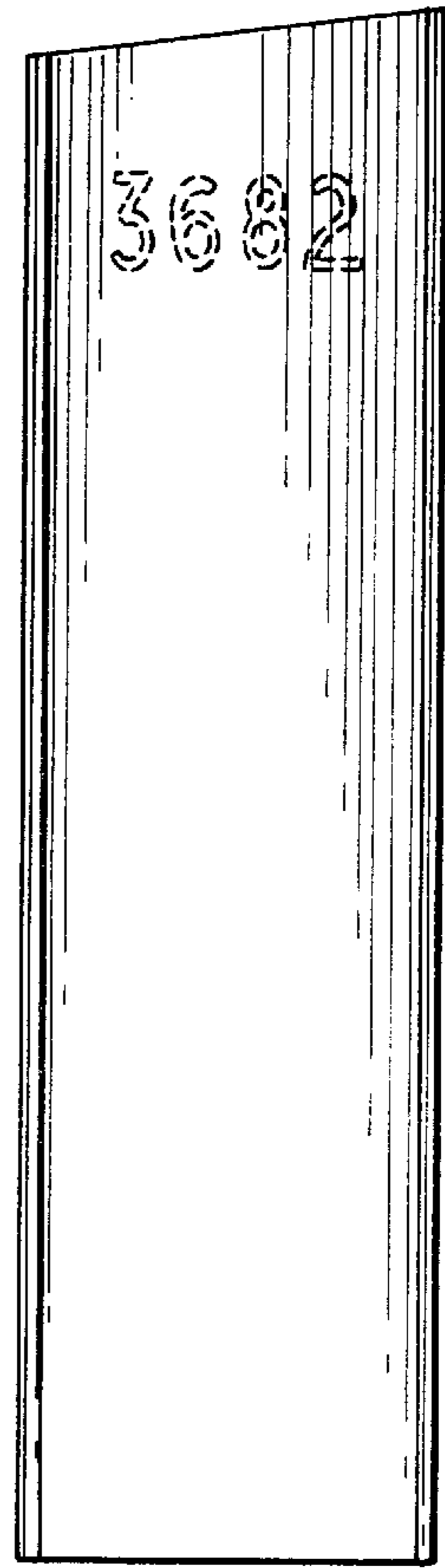

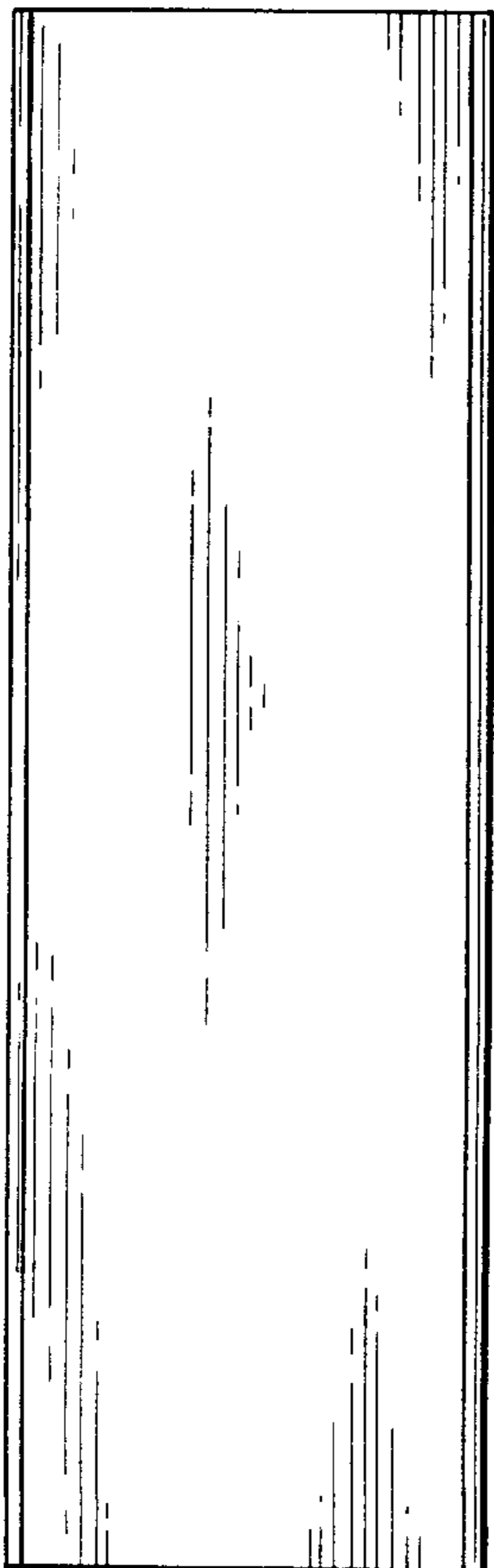

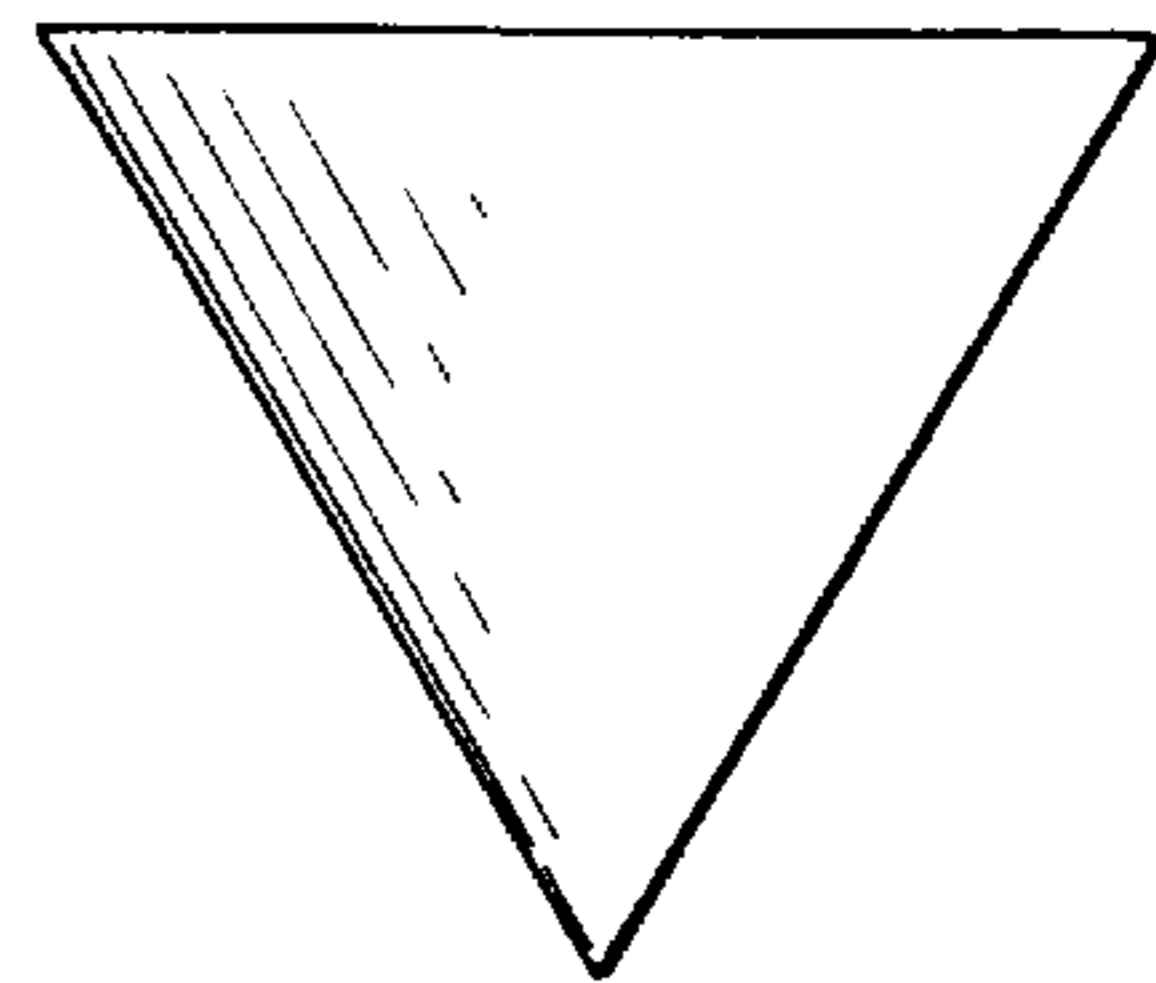

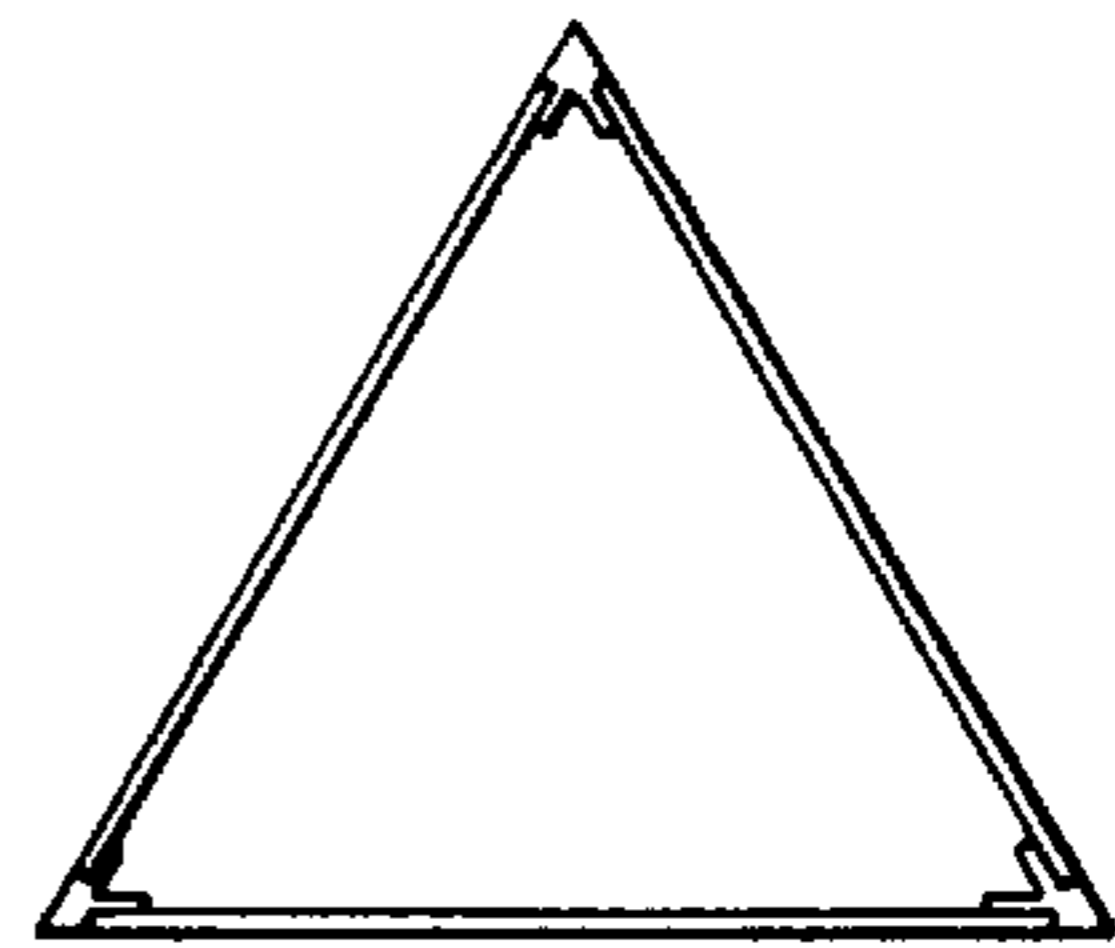

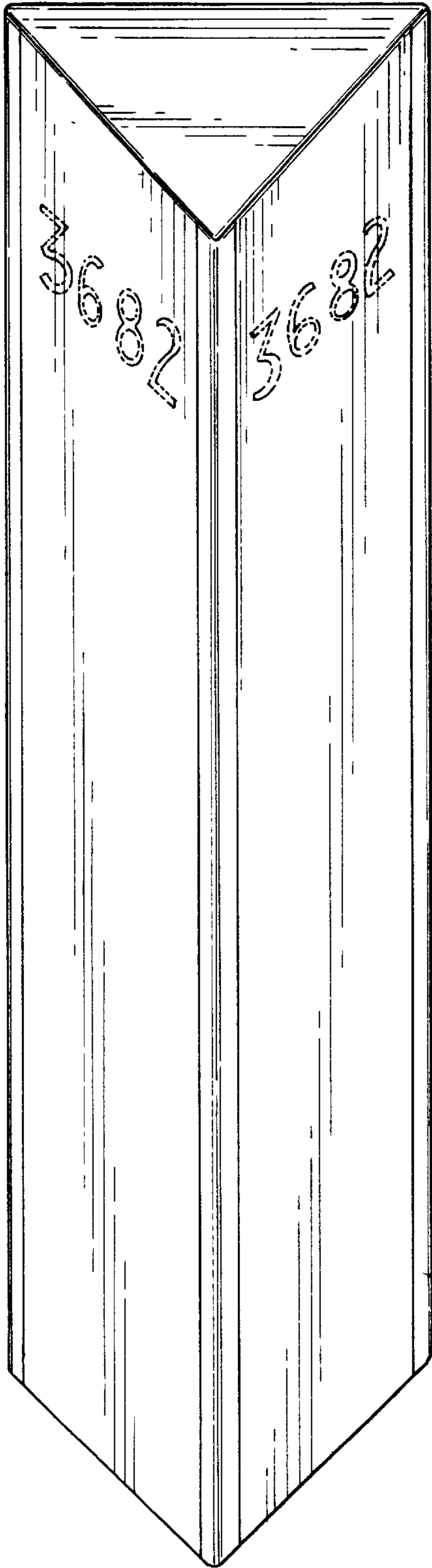

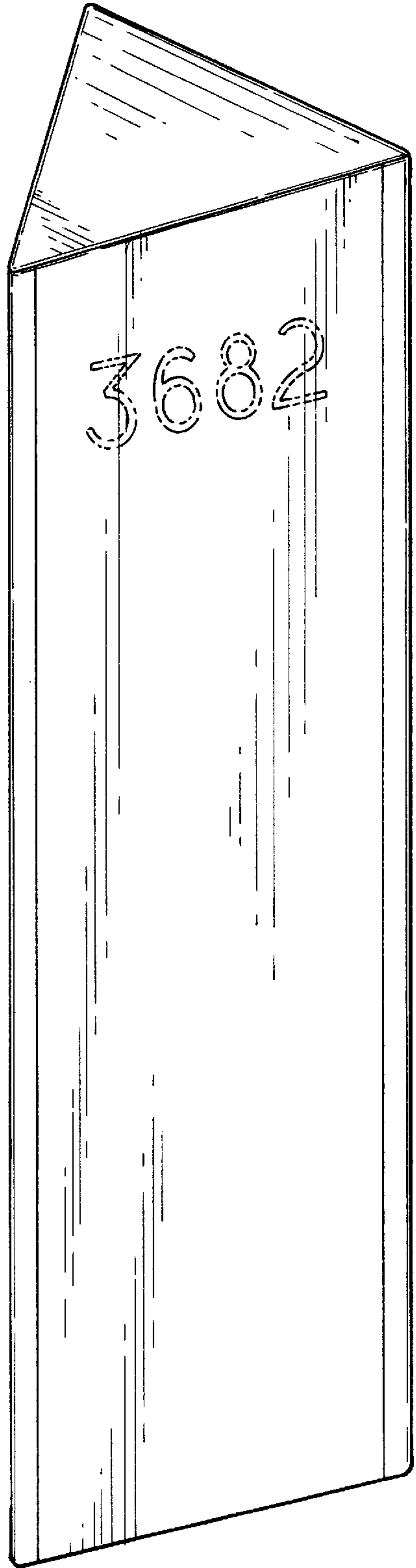

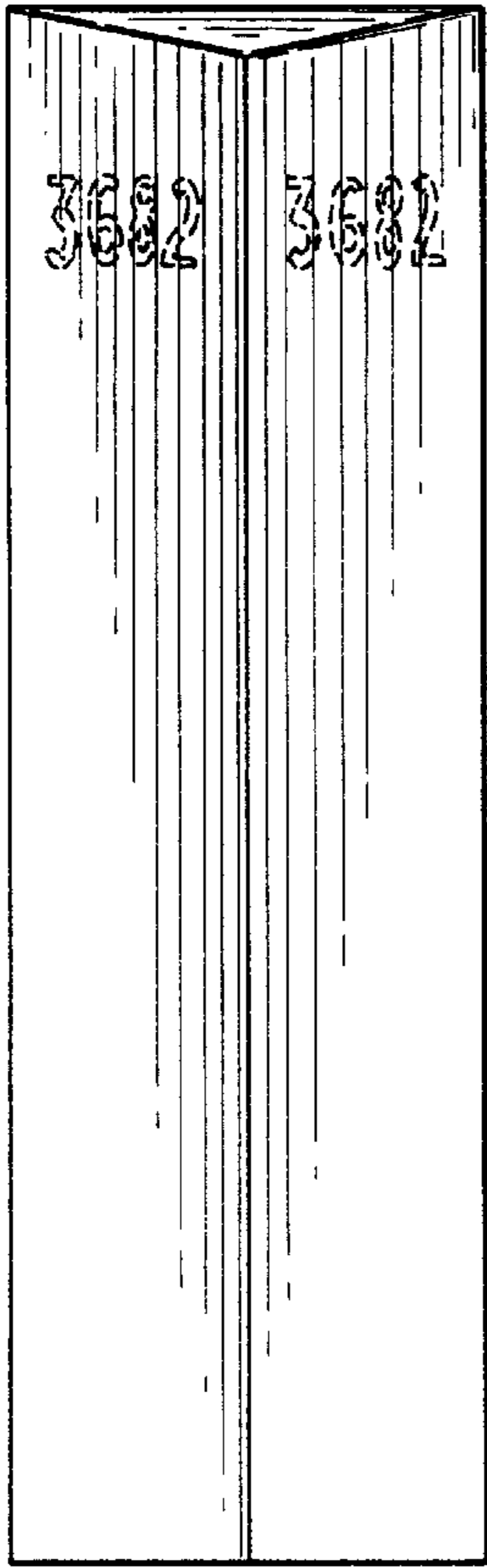

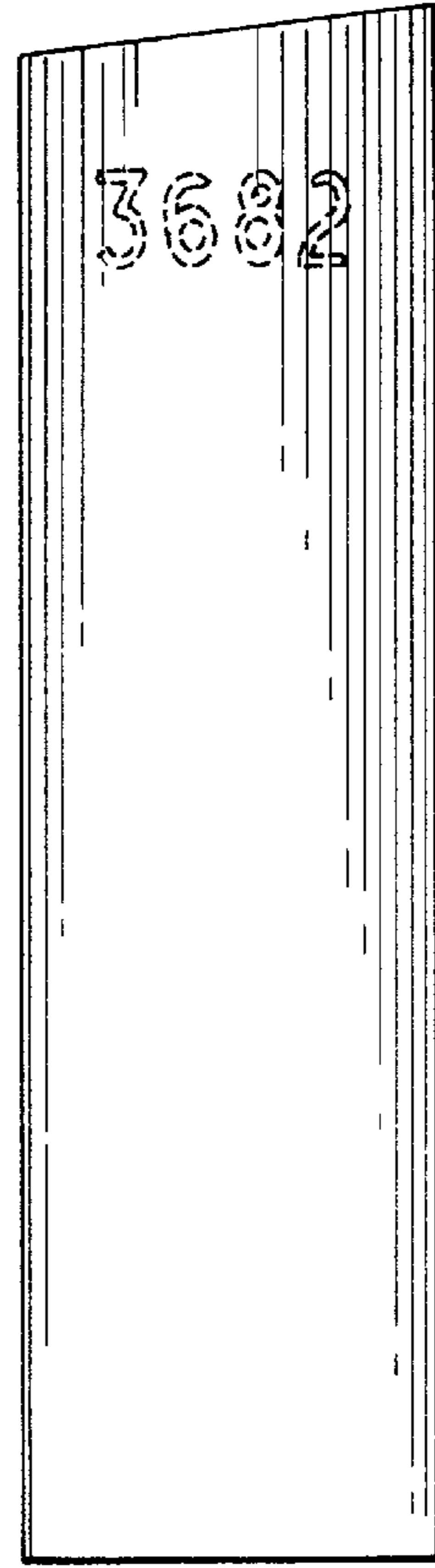

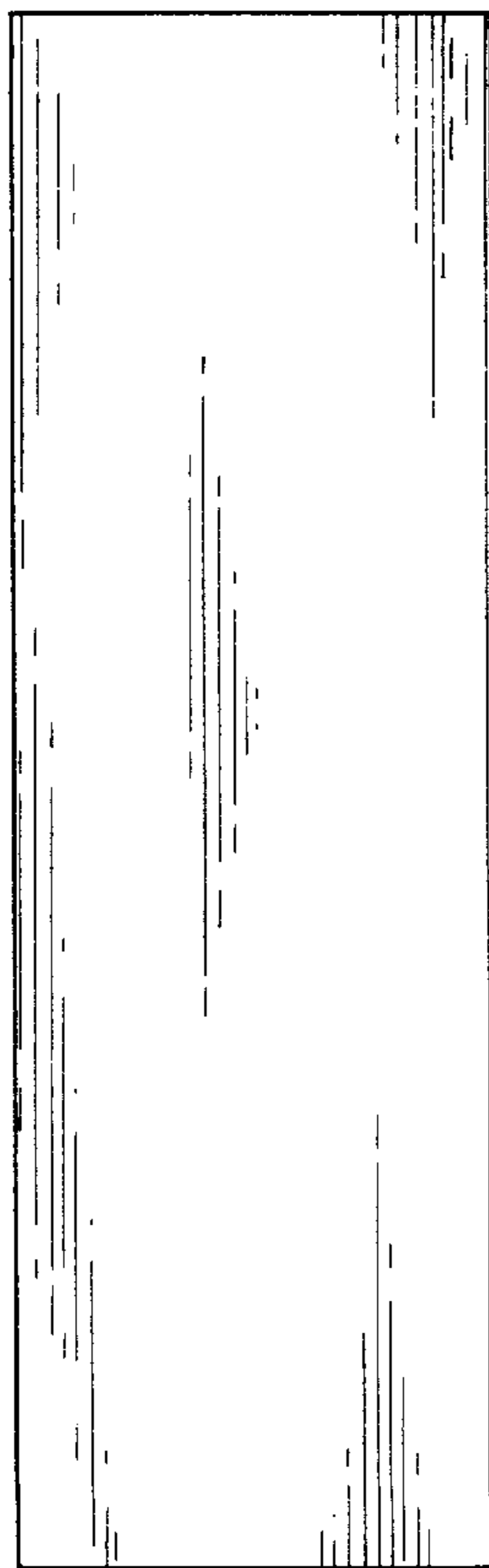

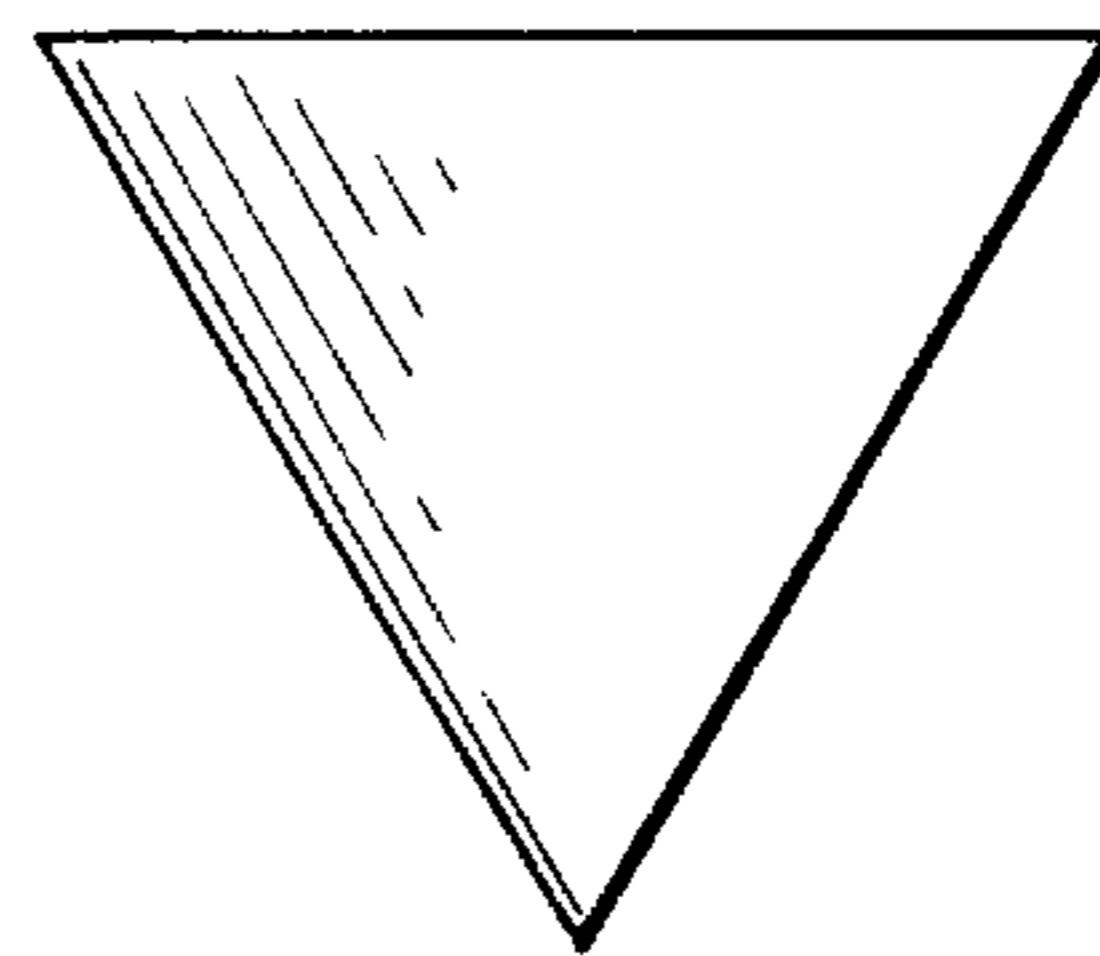

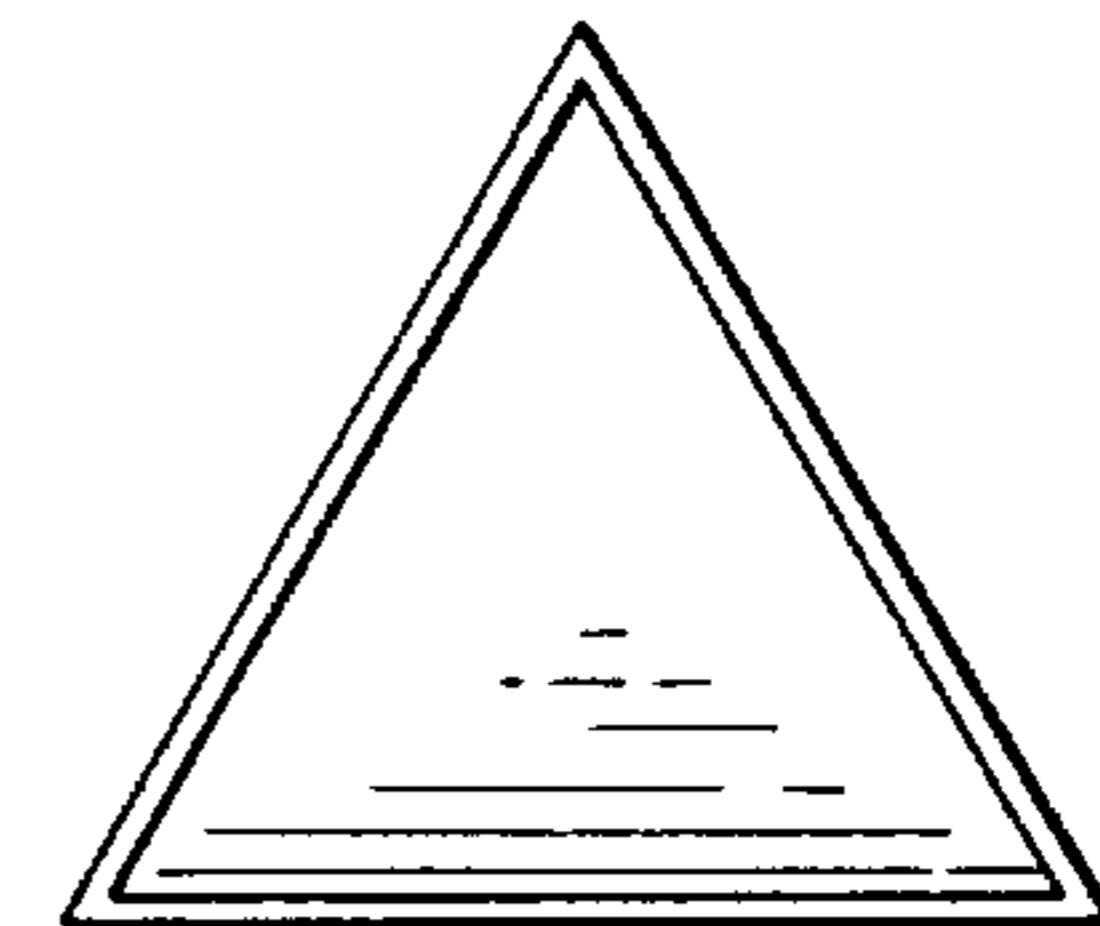

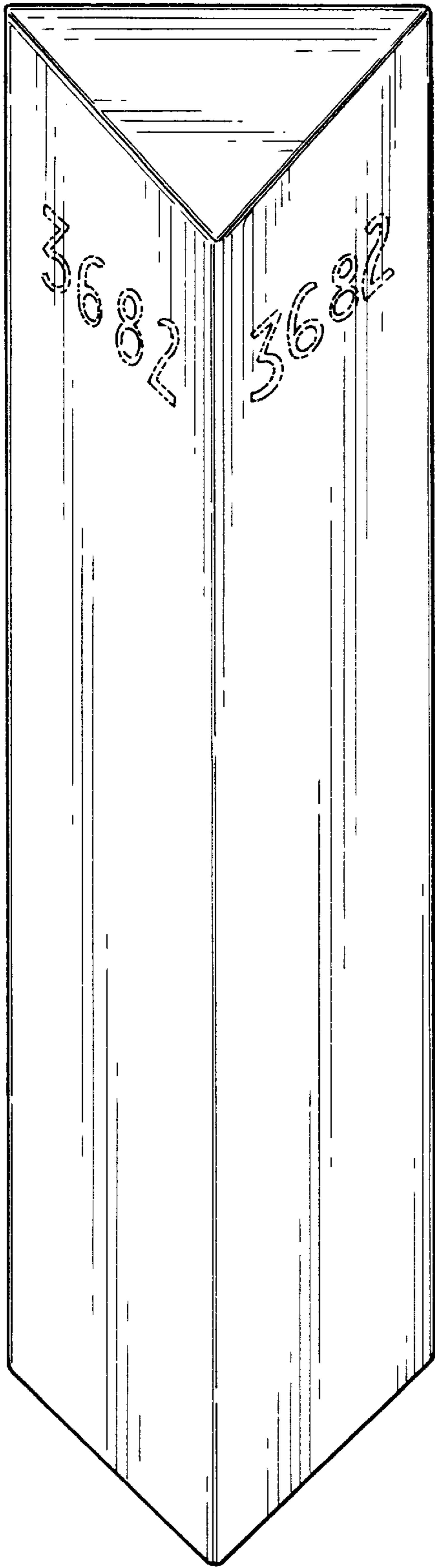

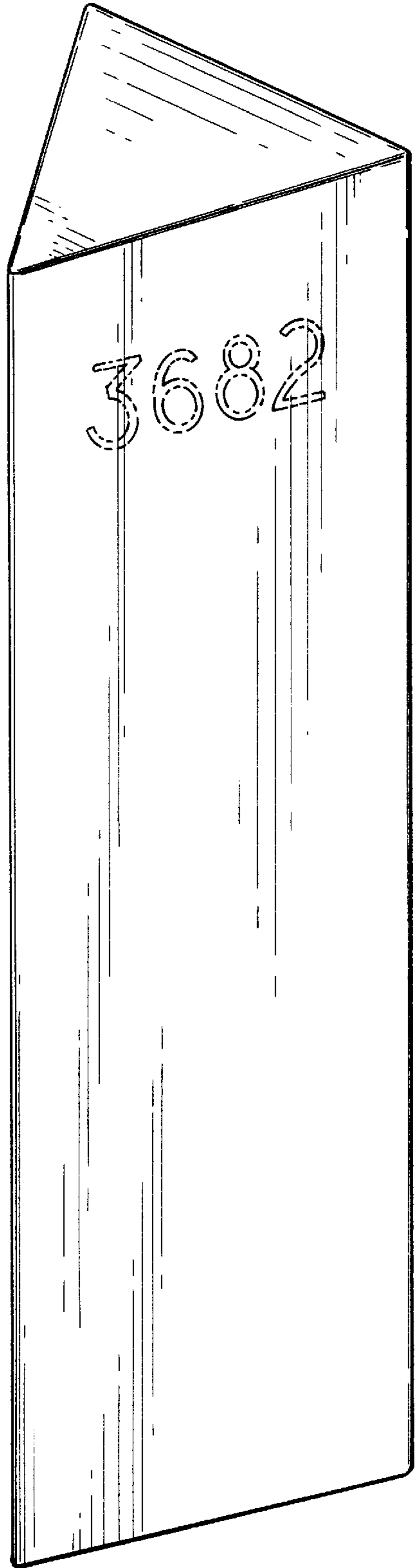

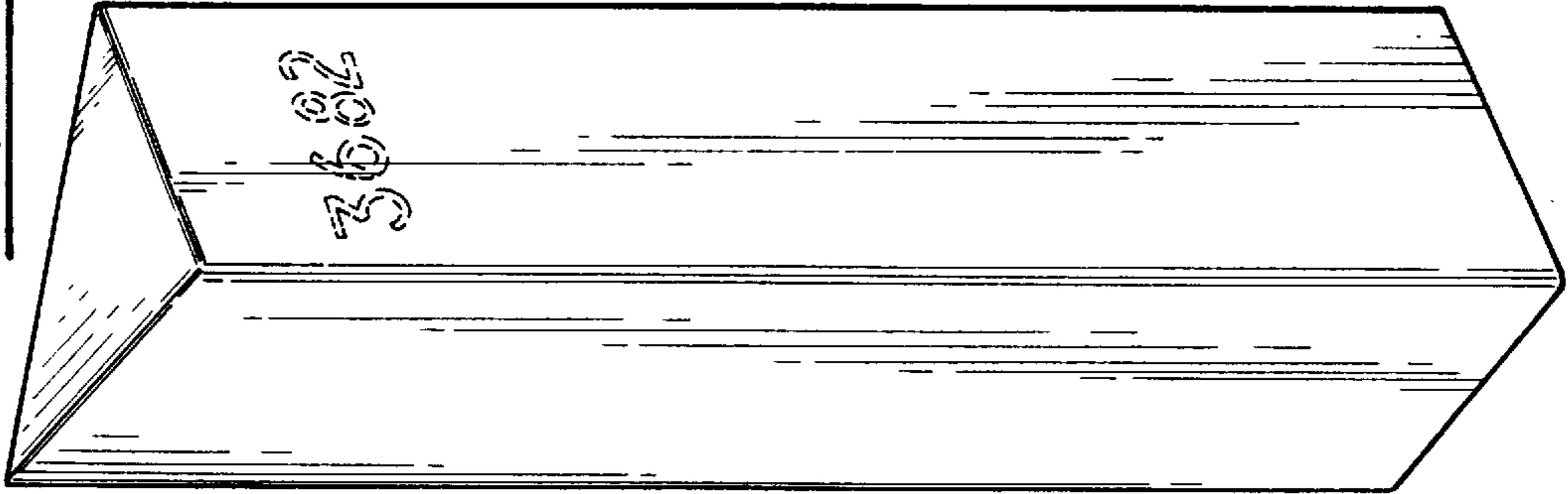

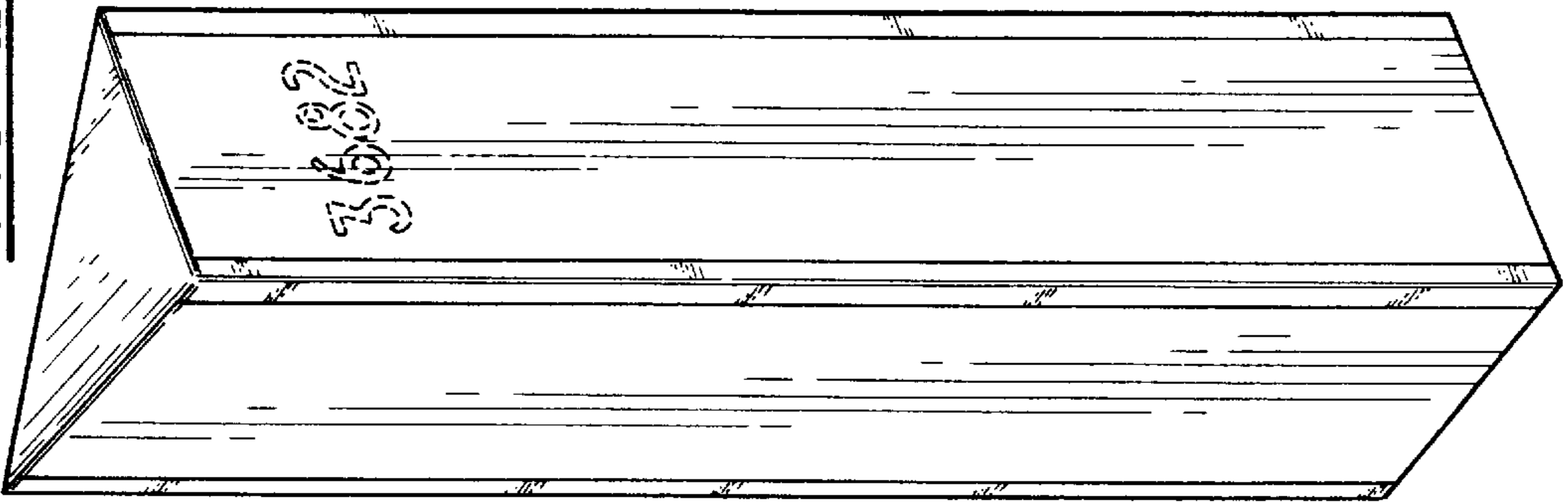
