The ornamental design for a wall-mounted lighting fixture, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the invention taken from a position in front of and below the fixture;

FIG. 2 is a front elevational view of the fixture;

FIG. 3 is a side elevational view of the fixture;

FIG. 4 is a rear view of the fixture;

FIG. 5 is a perspective view of a second embodiment of the lighting fixture of the invention seen from in front of and below the fixture;

FIG. 6 is a front elevational view of the fixture;

FIG. 7 is a side elevational view of the fixture;

FIG. 8 is an elevational view of the fixture taken from the top thereof;

FIG. 9 is an elevational view taken from the rear of the fixture;

FIG. 11 is a front elevational view of the fixture;

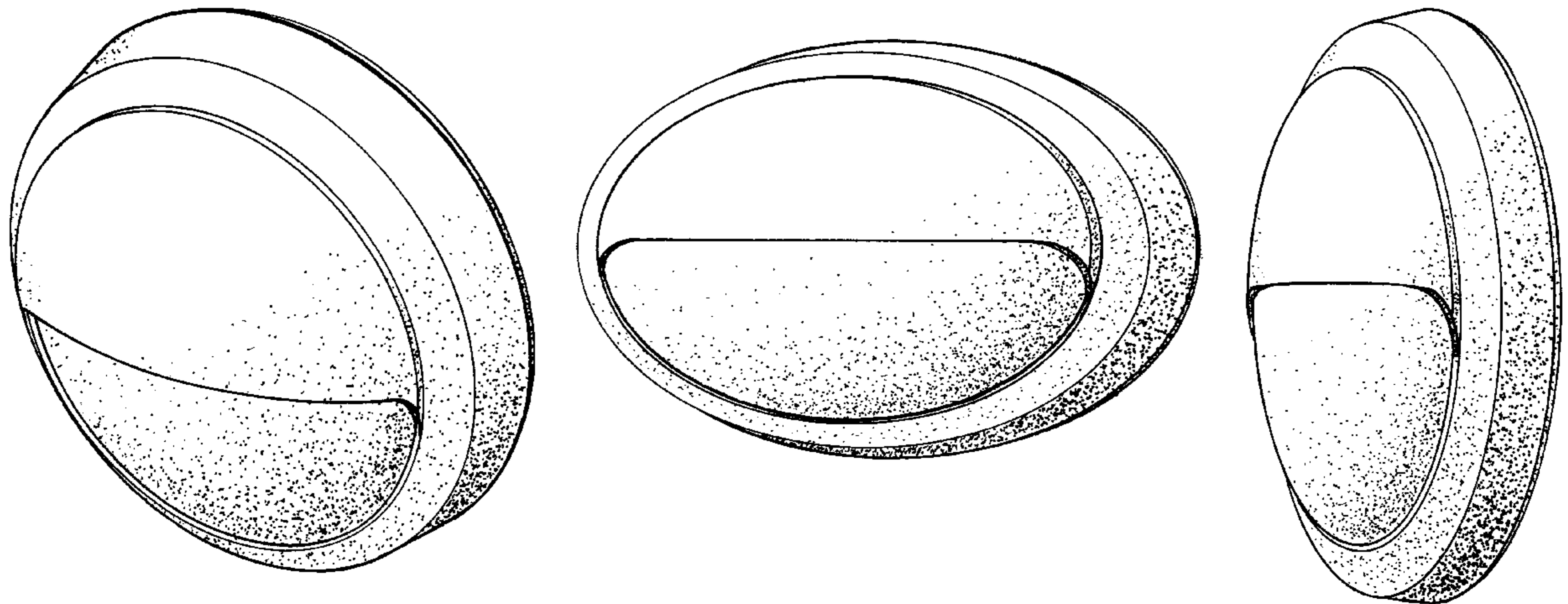
FIG. 12 is a side elevational view of the fixture;

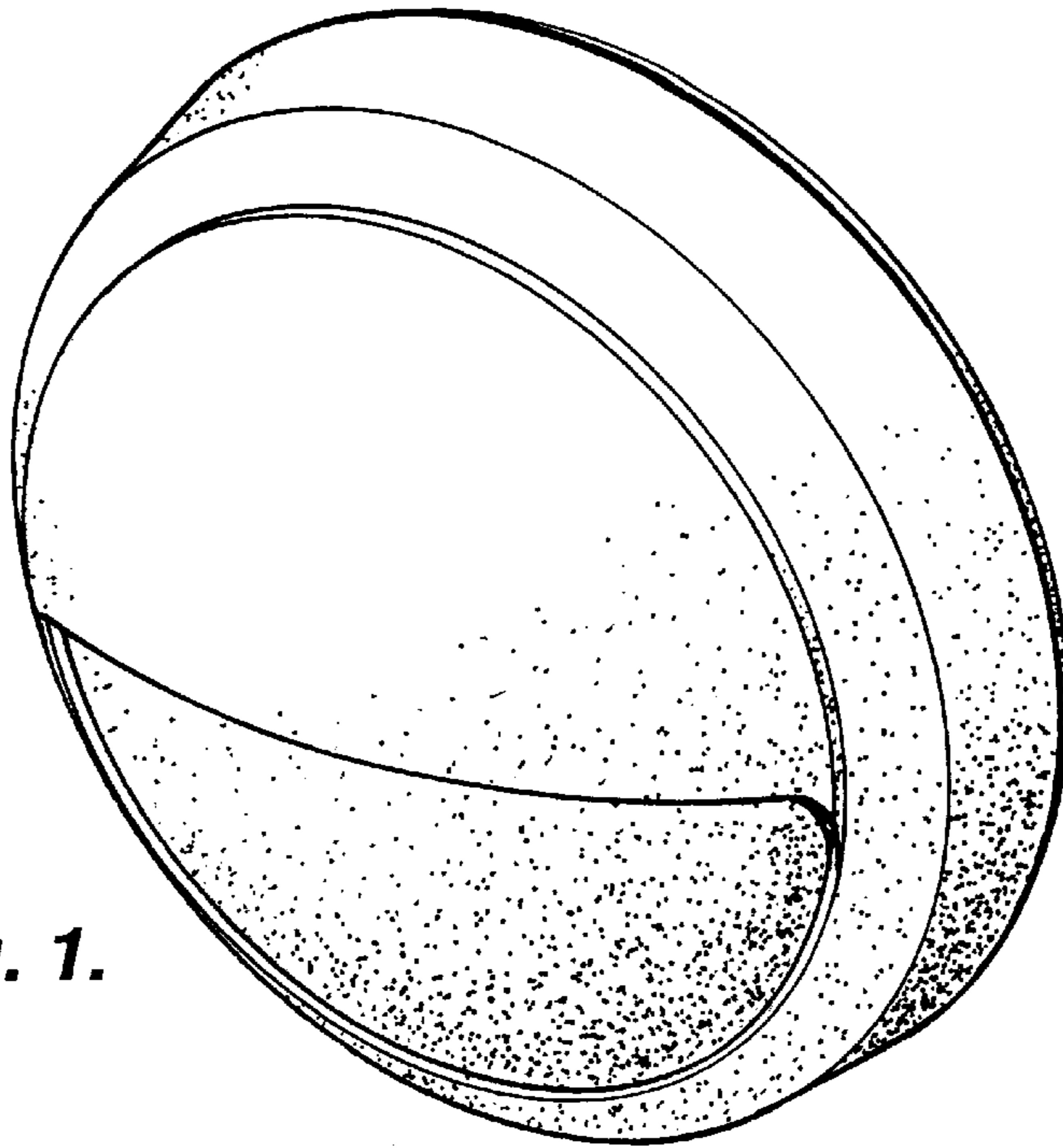
FIG. 13 is an elevational view of the fixture taken from the top thereof; and,

FIG. 14 is an elevational view taken from the rear of the fixture.

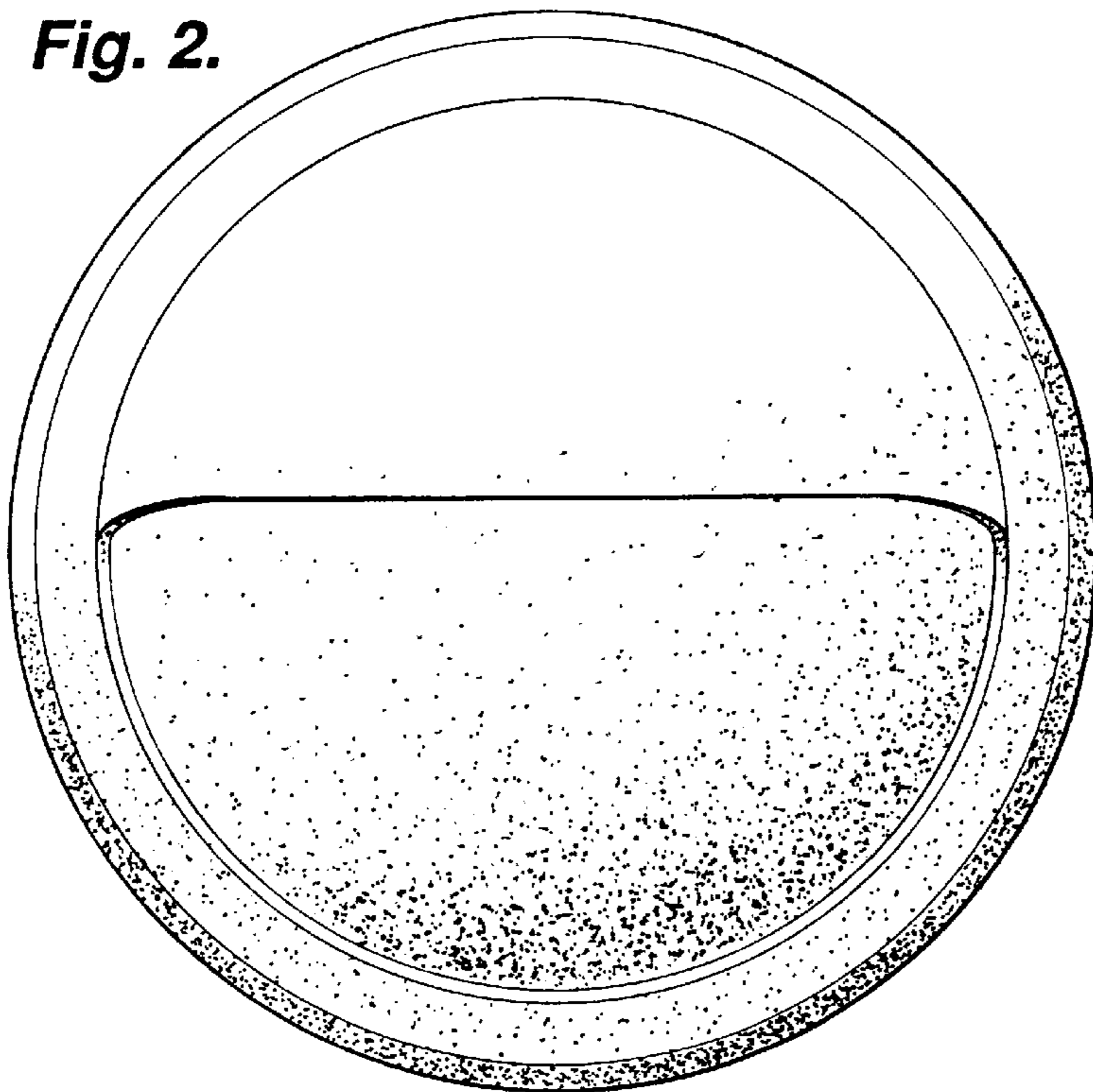

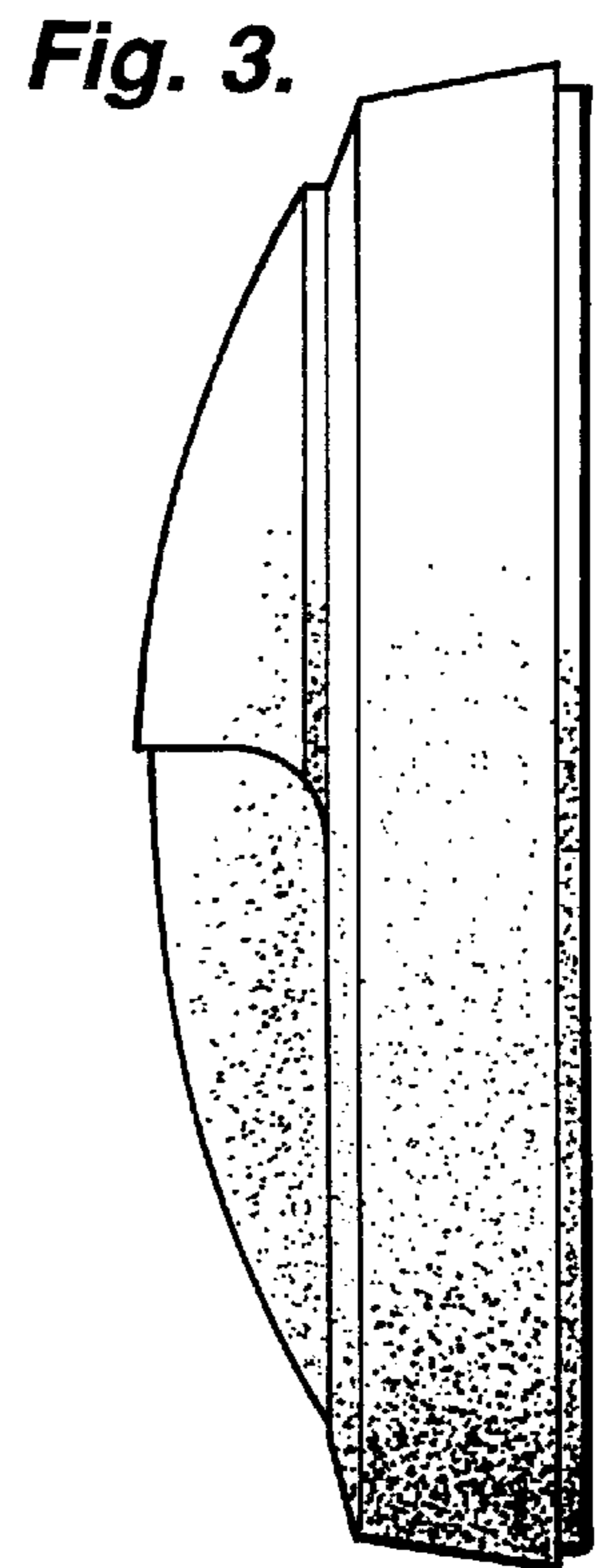




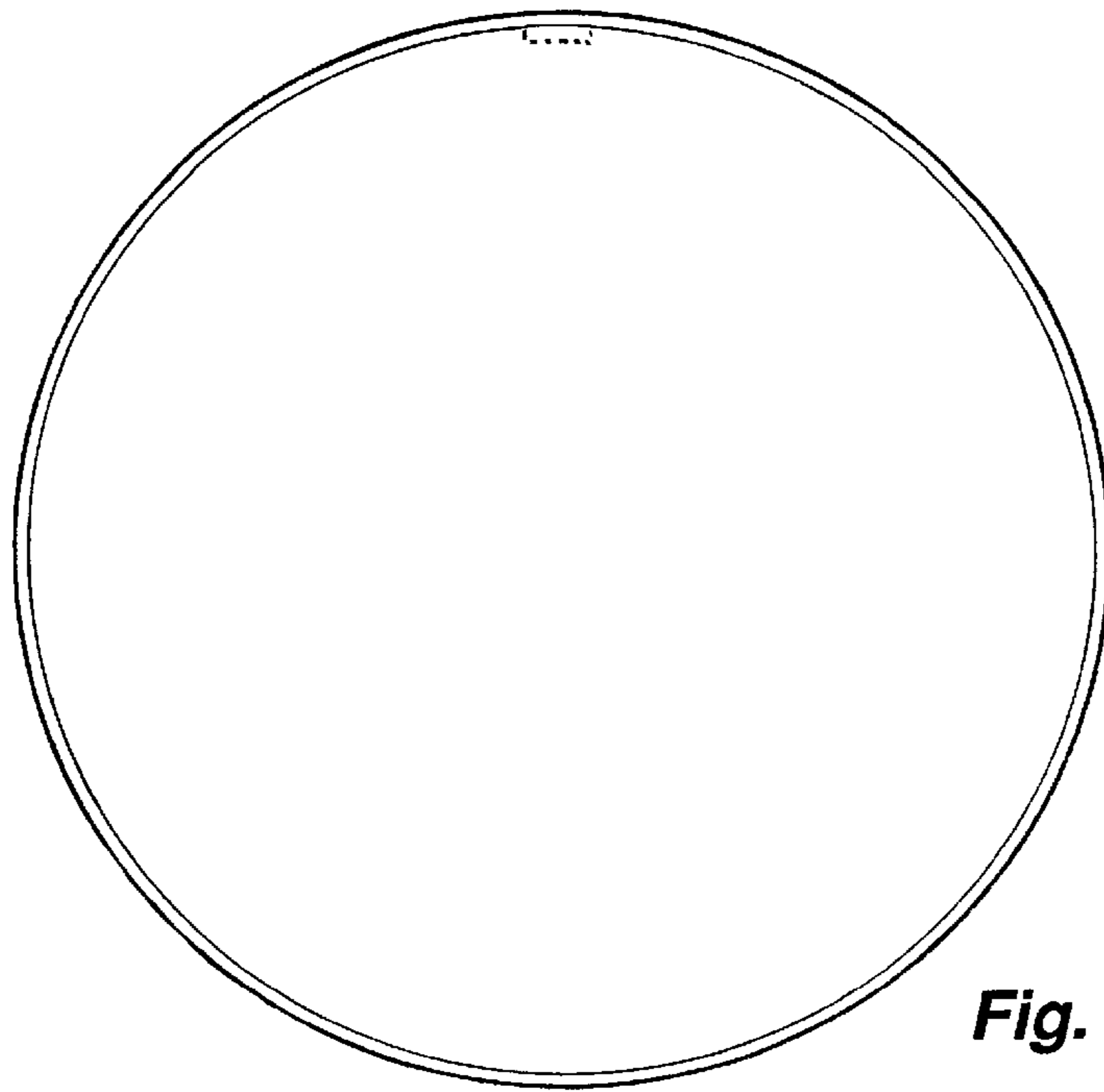

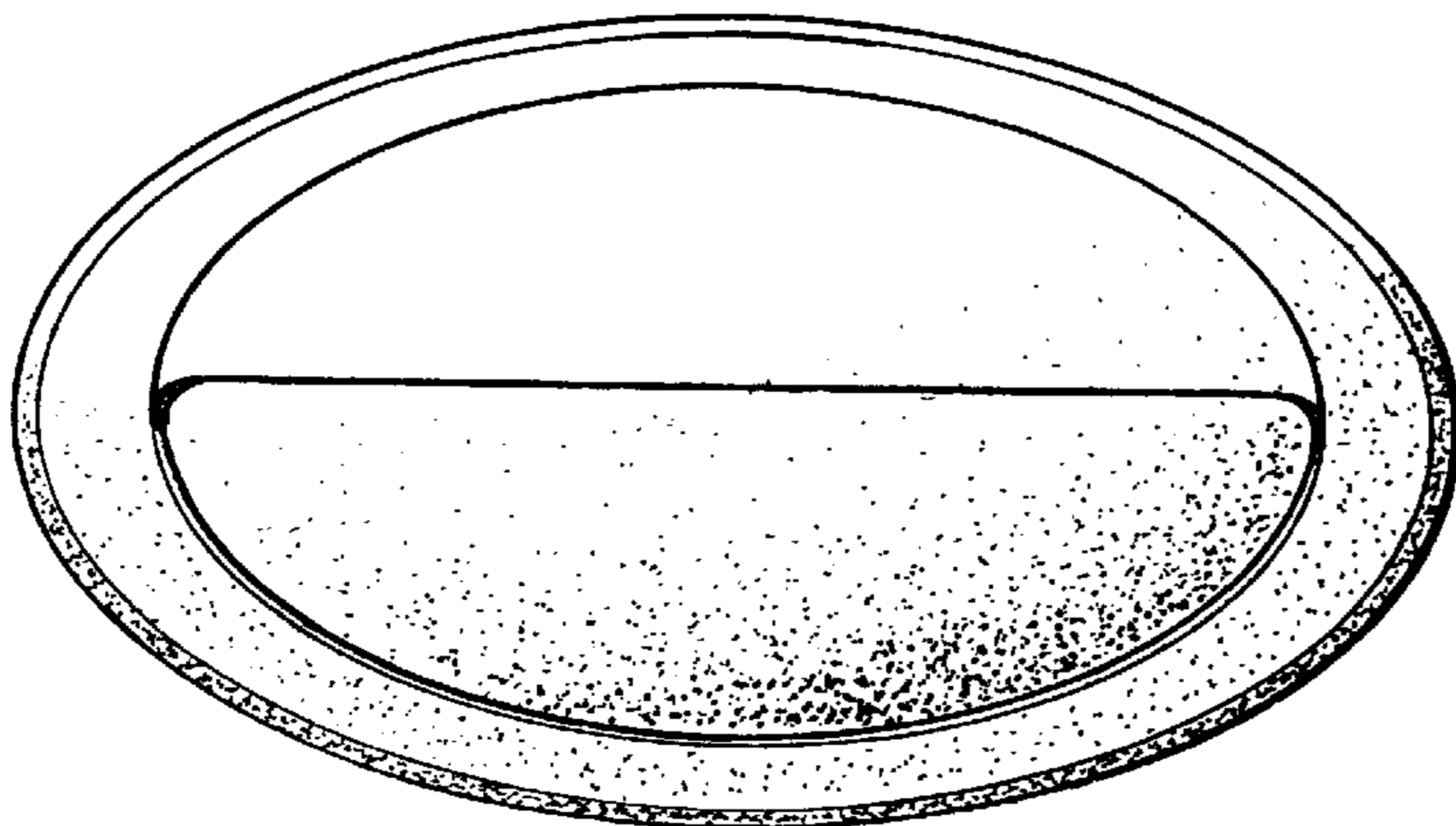

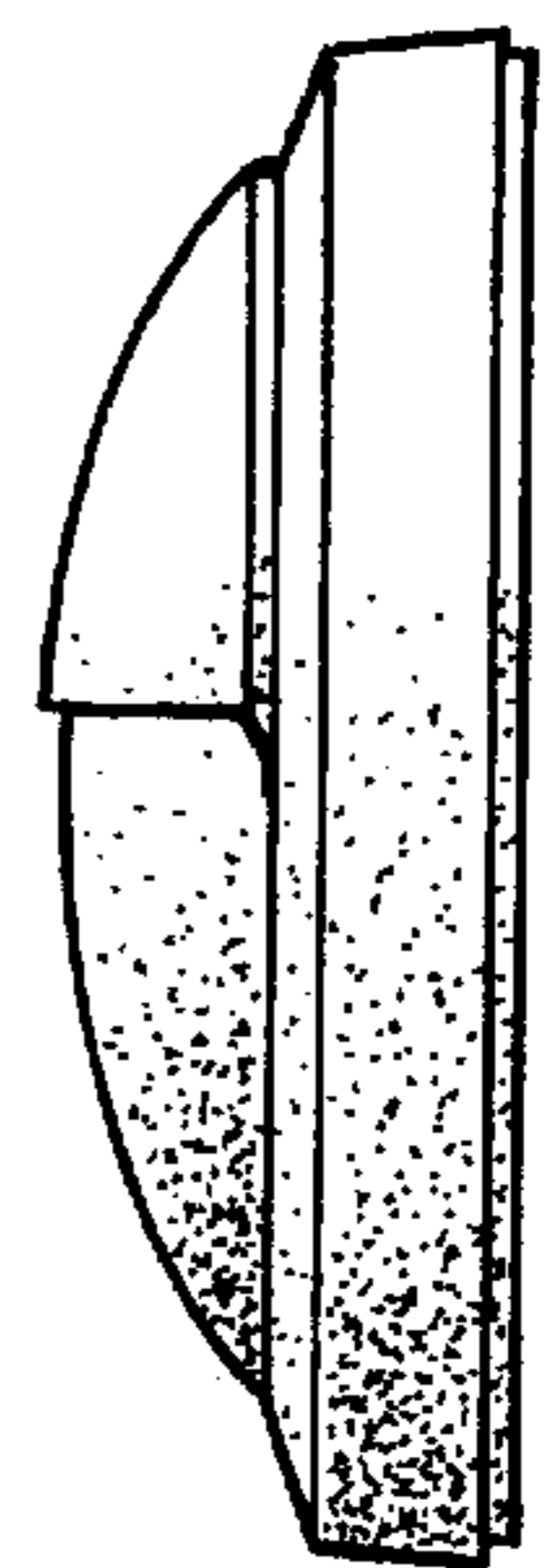

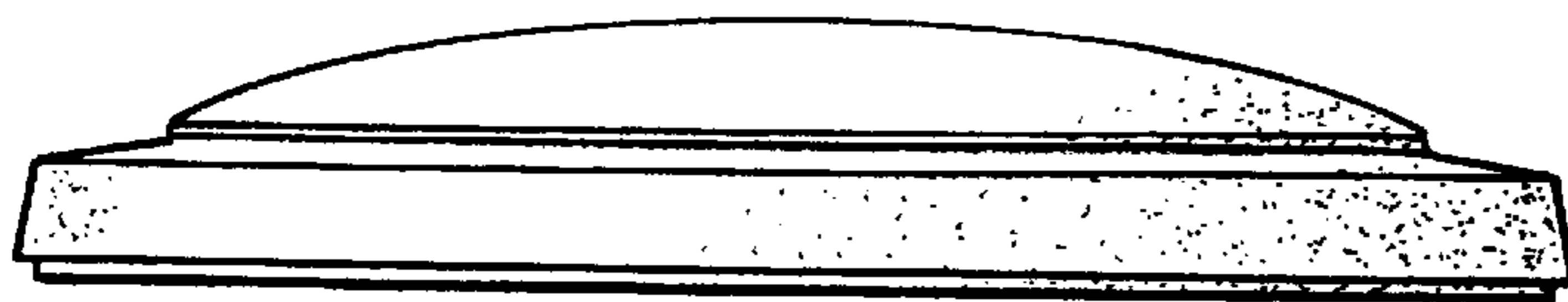

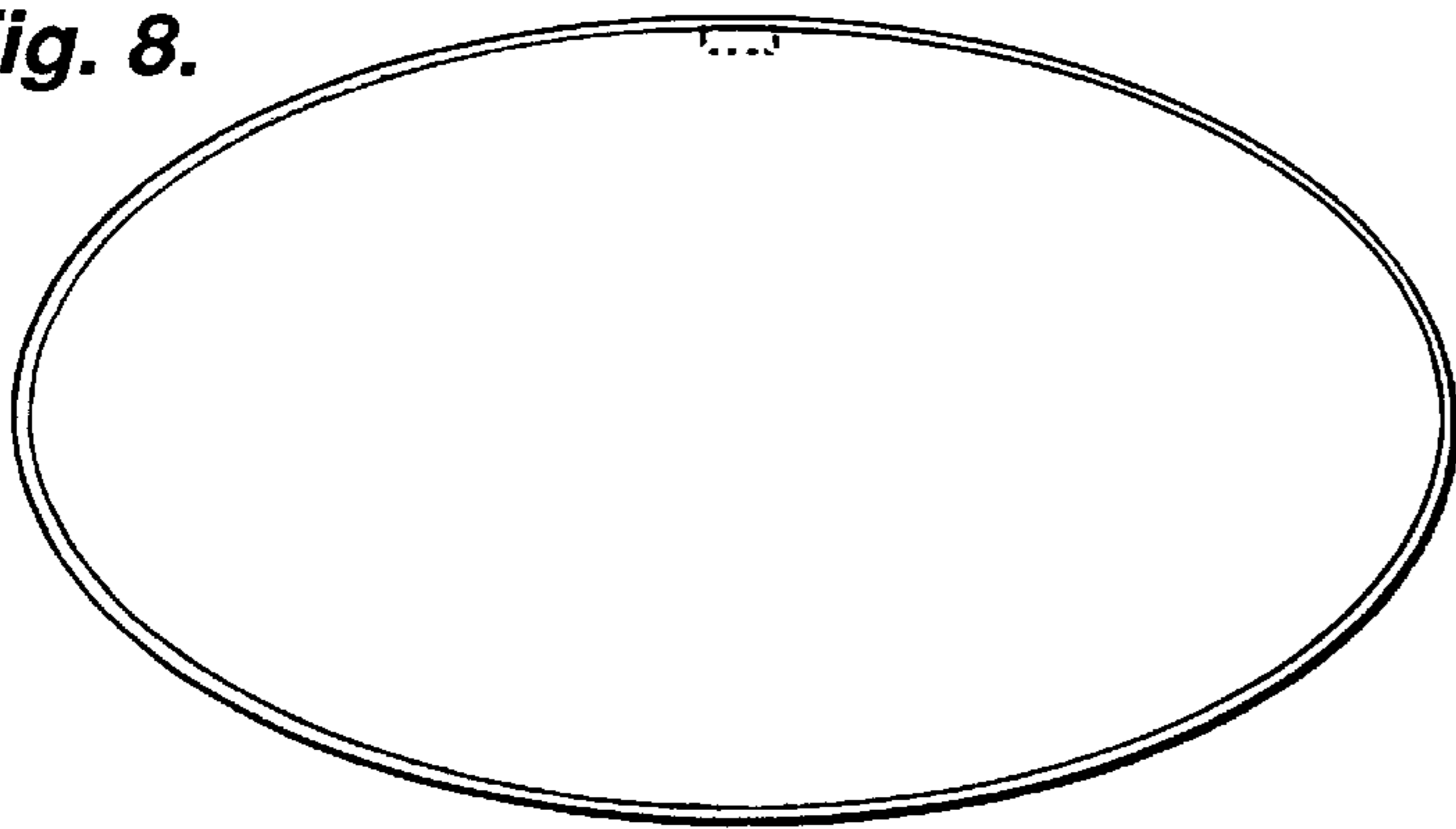

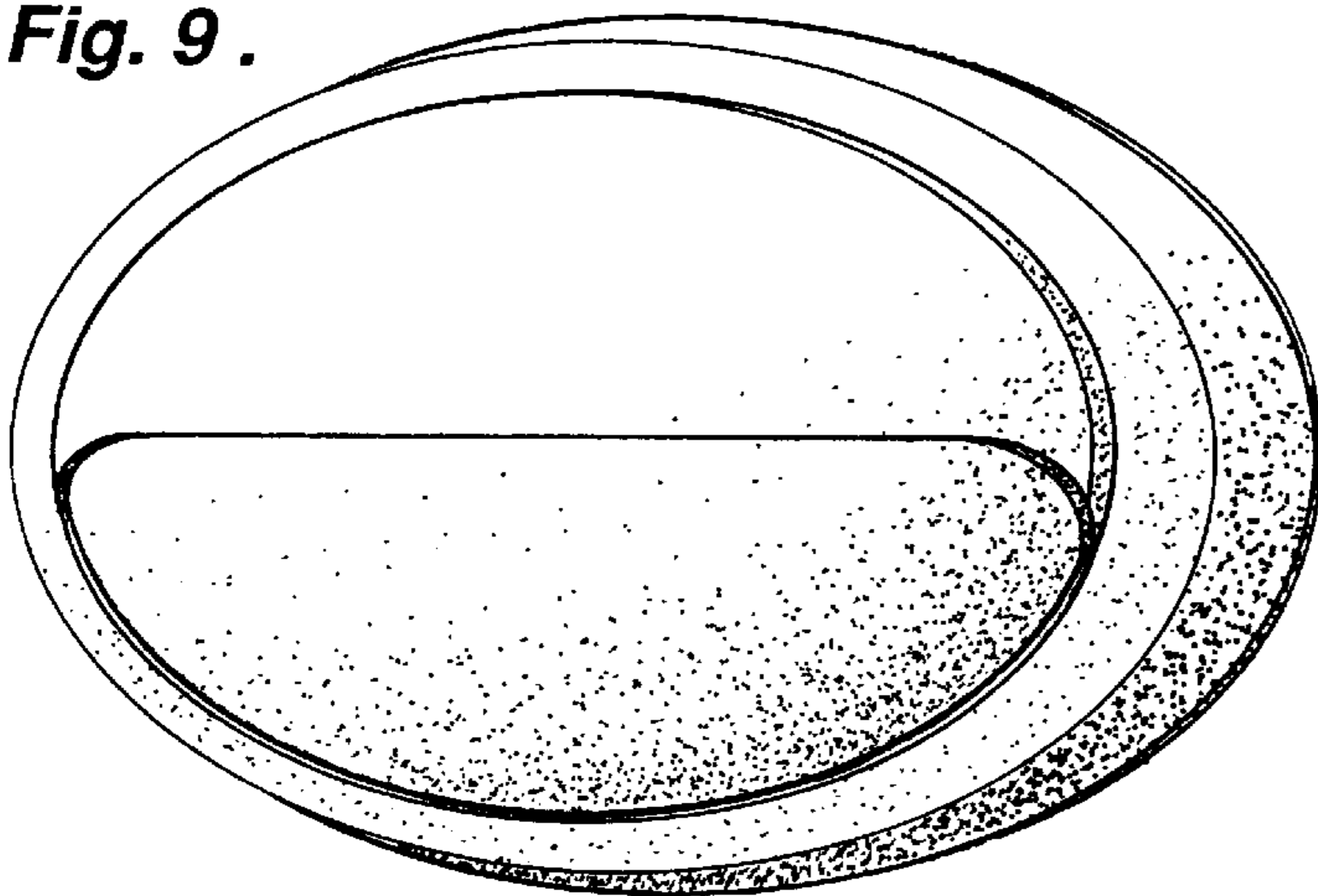

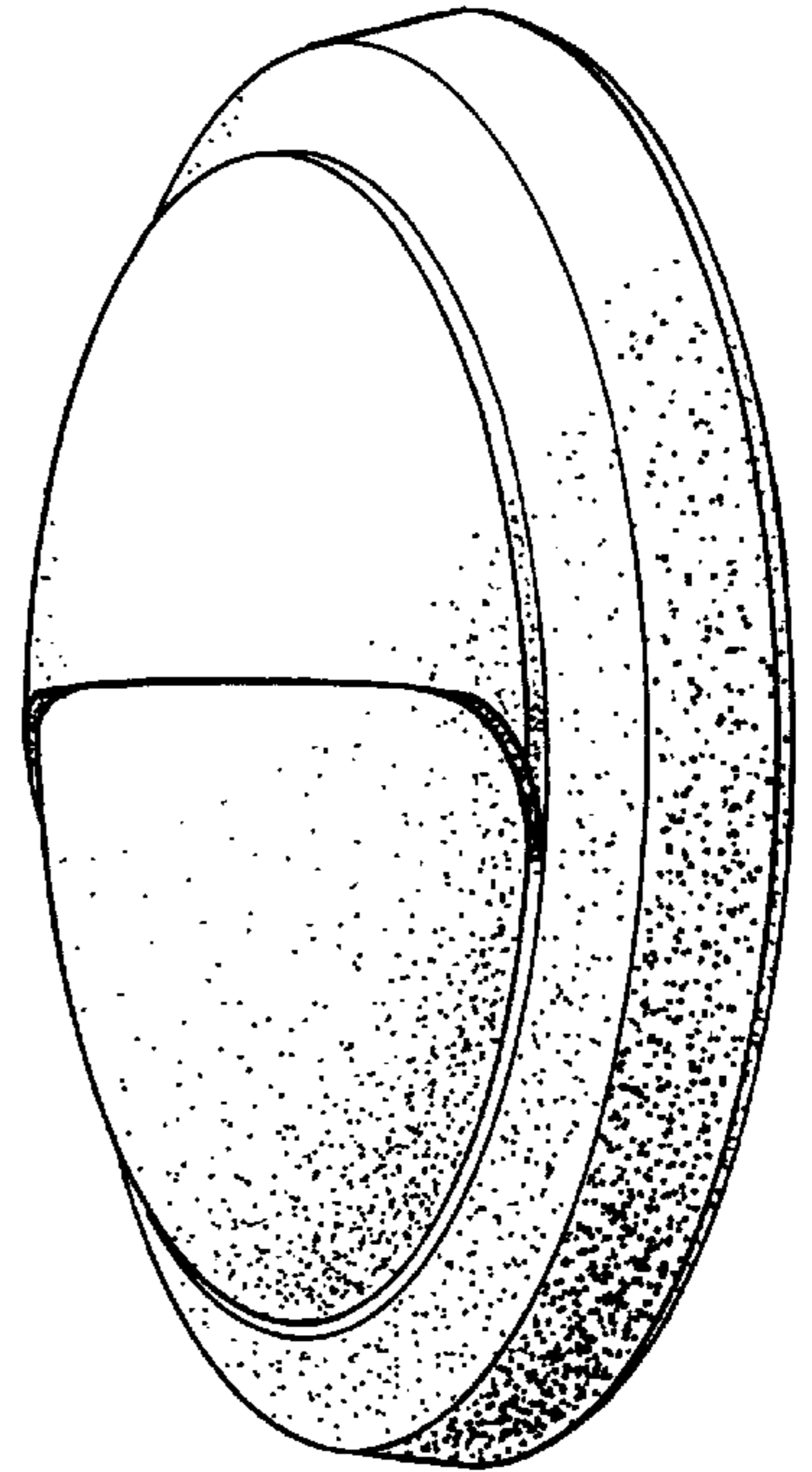

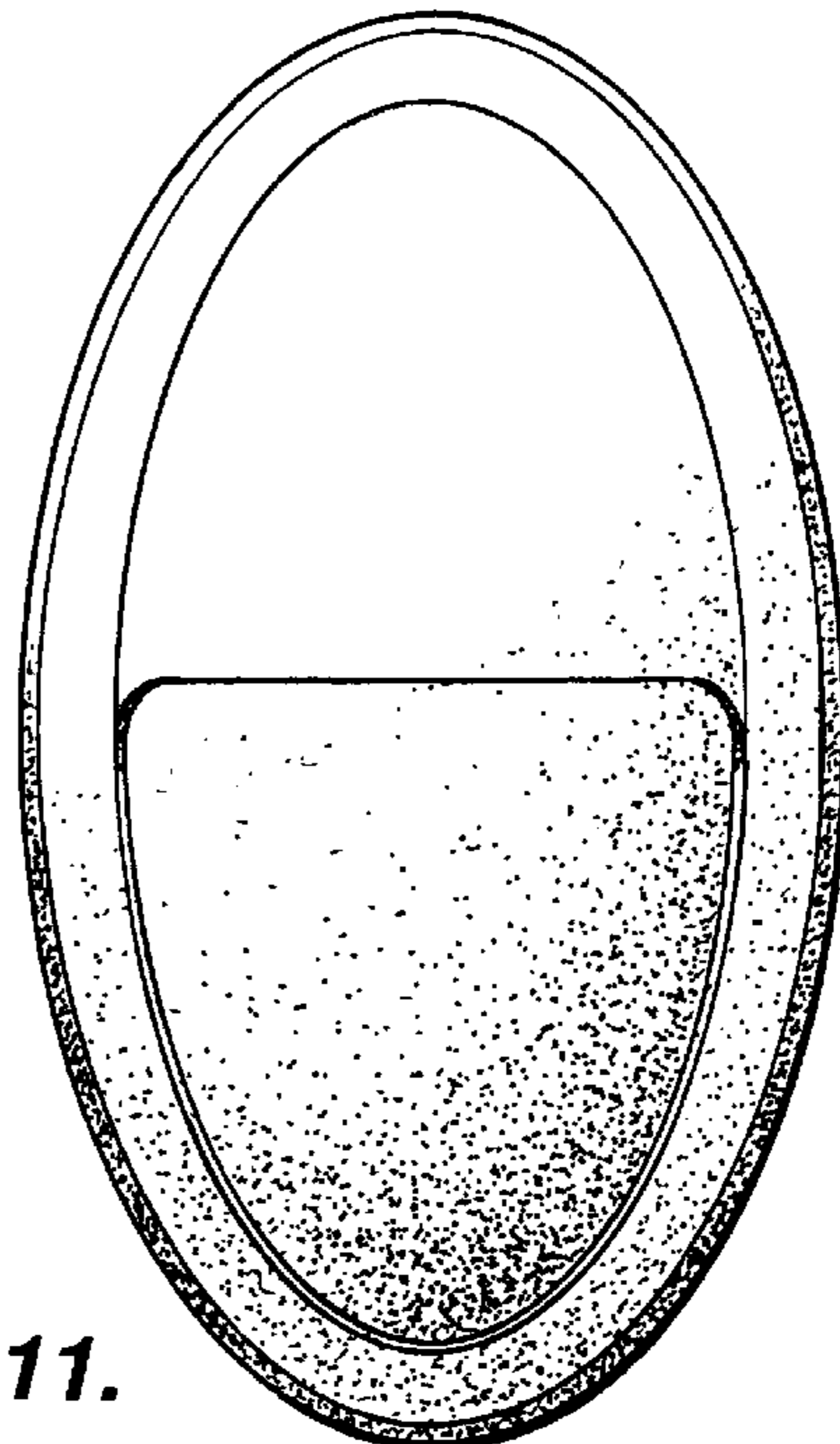

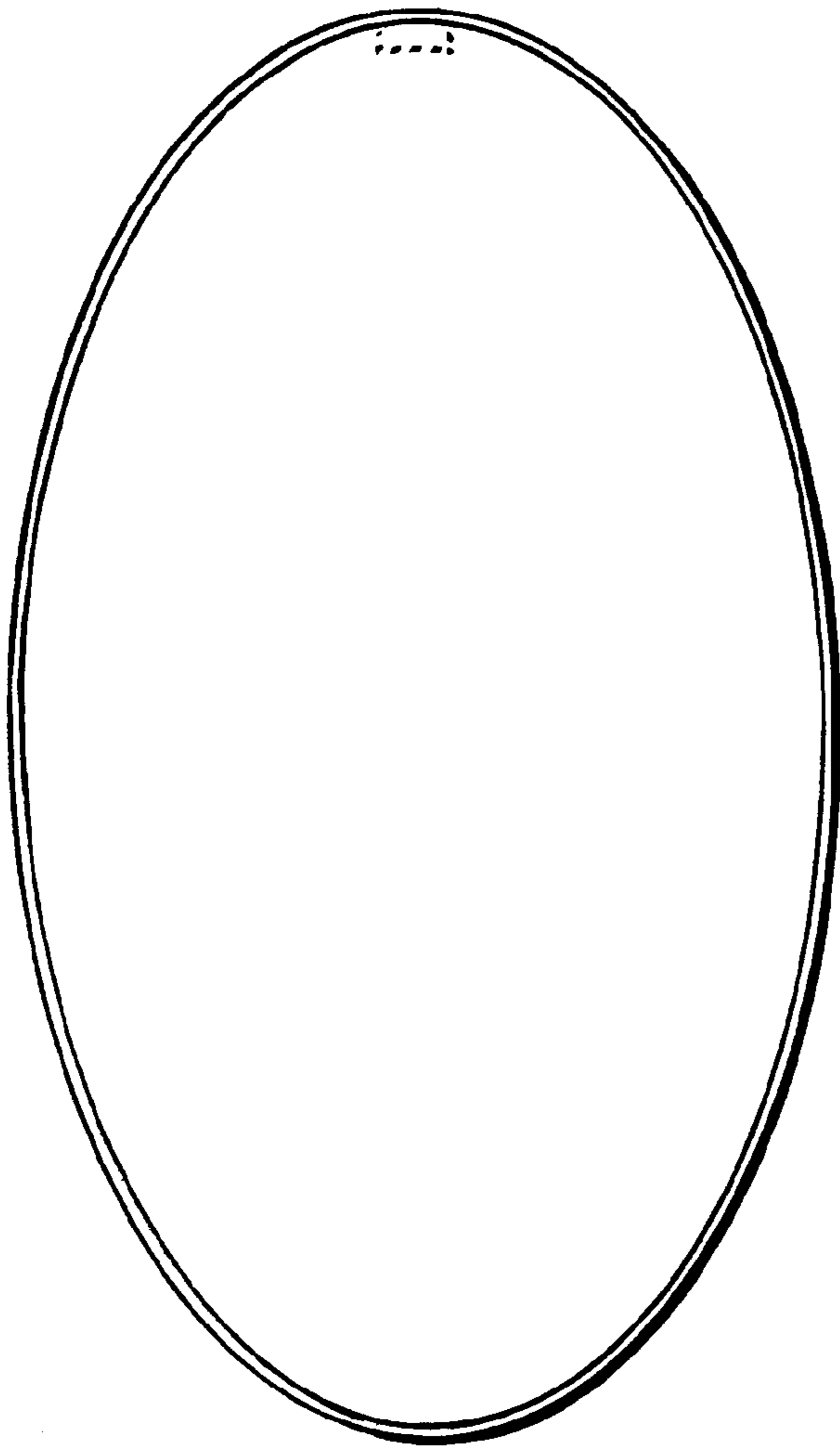

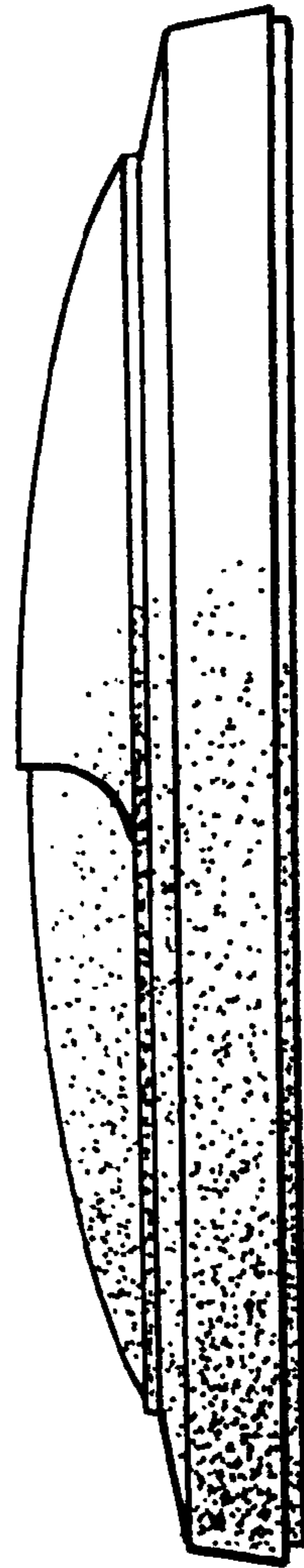
