[57] **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of the left component of a shoe outsole showing my new design, the right component being the mirror image thereof;
FIG. 2 is a left side elevational view thereof, the broken lines showing the upper being for illustrative purposes only and forming no part of the claimed design;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a rear elevational view thereof; and,
FIG. 7 a perspective view of the left side thereof, the broken lines showing the upper being for illustrative purposes only and forming no part of the claimed design.

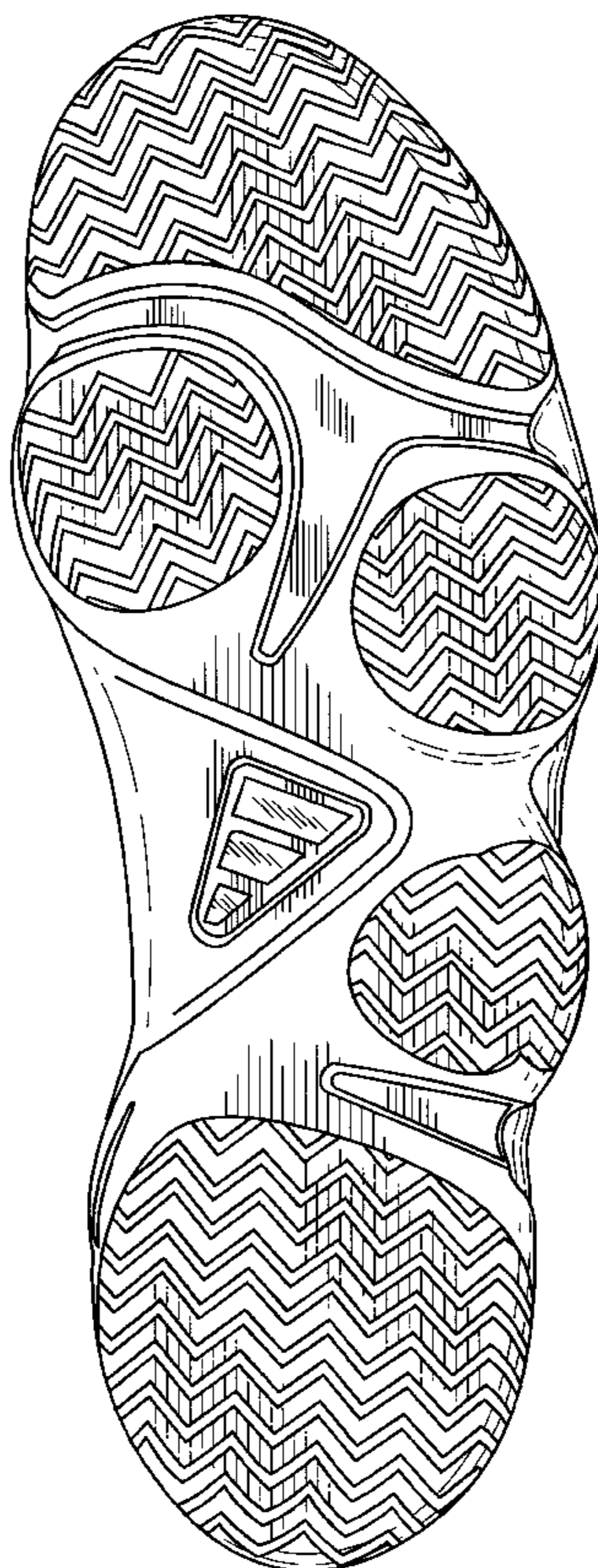
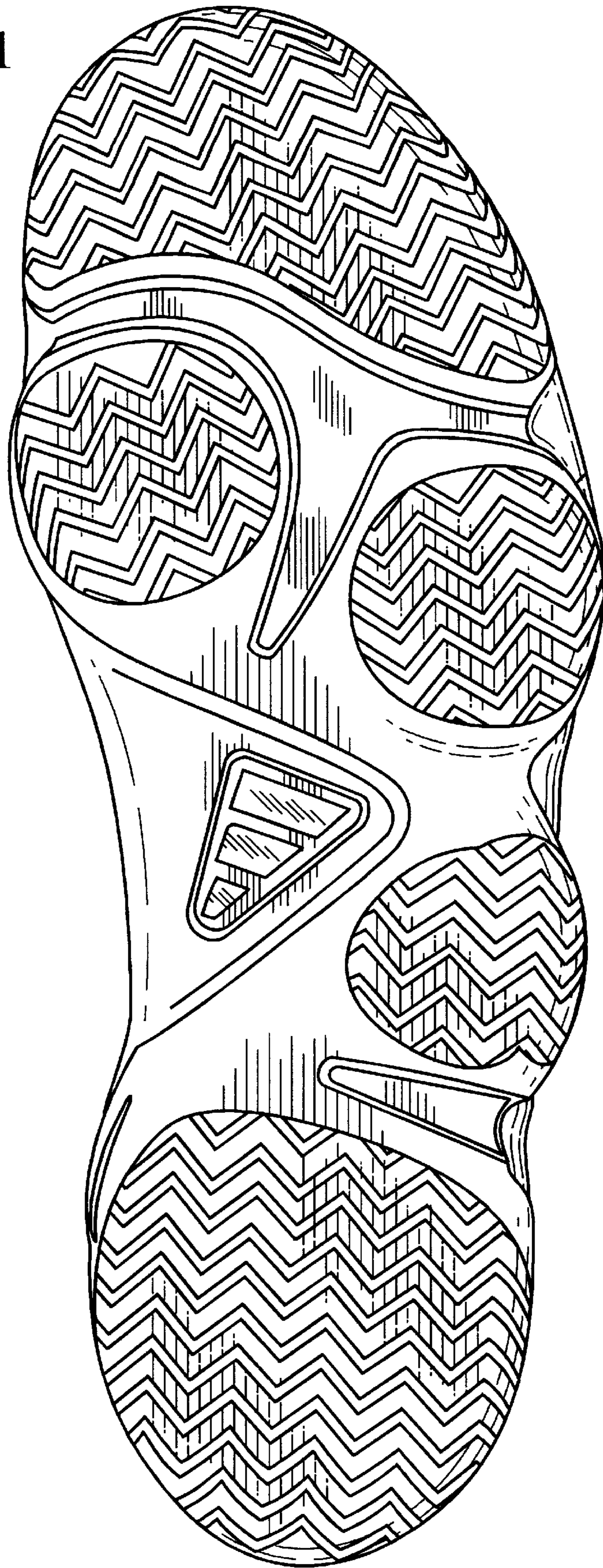

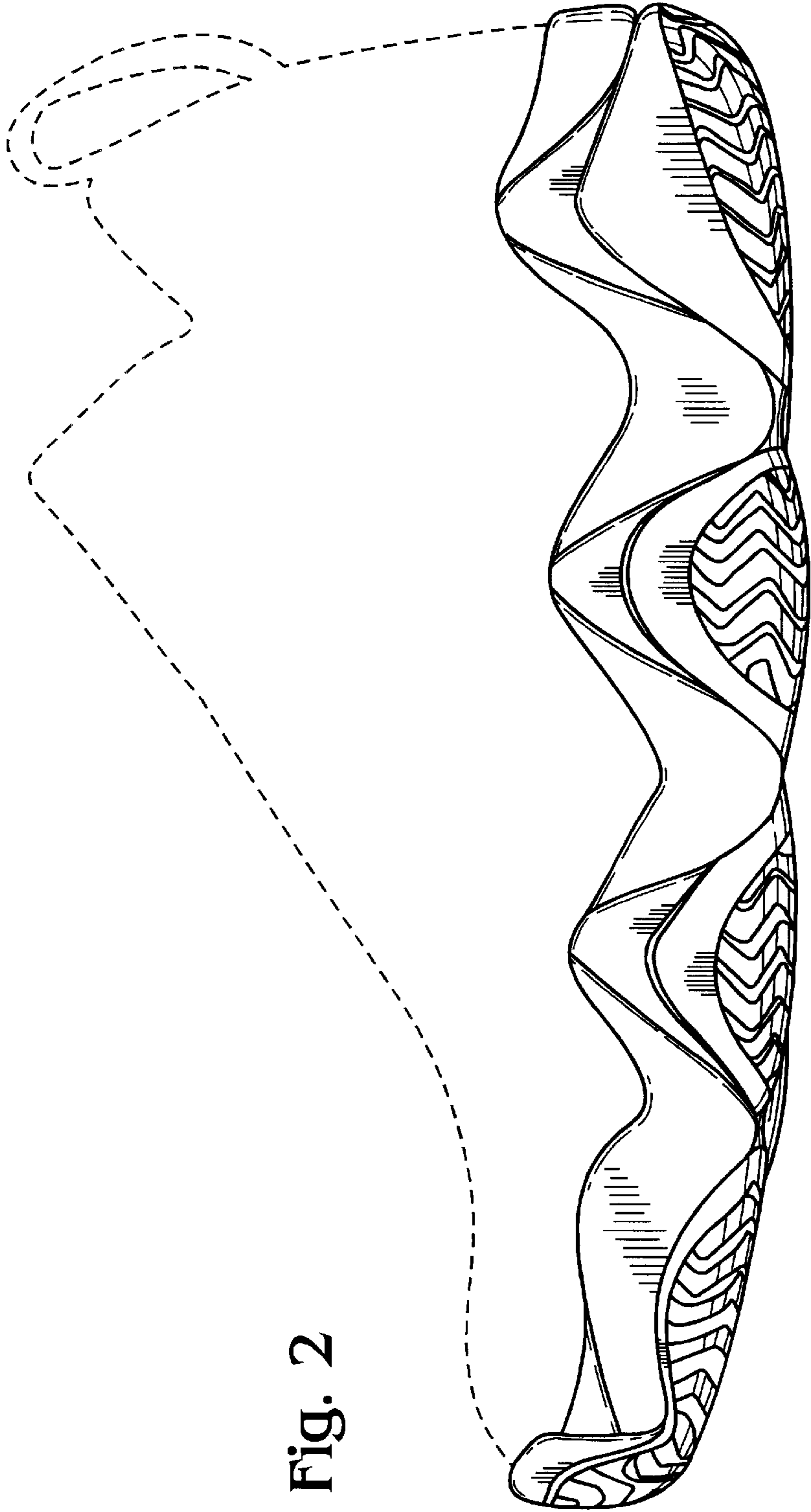

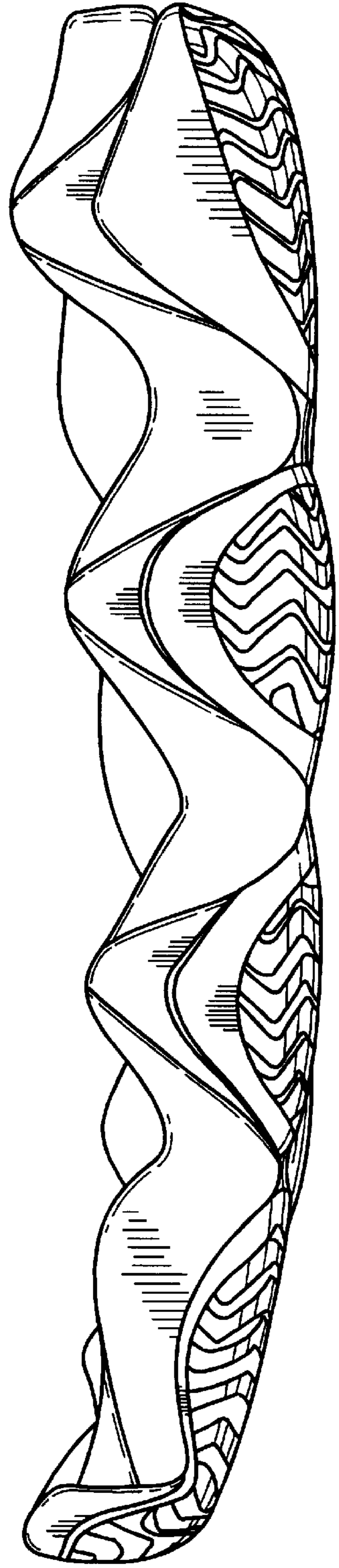

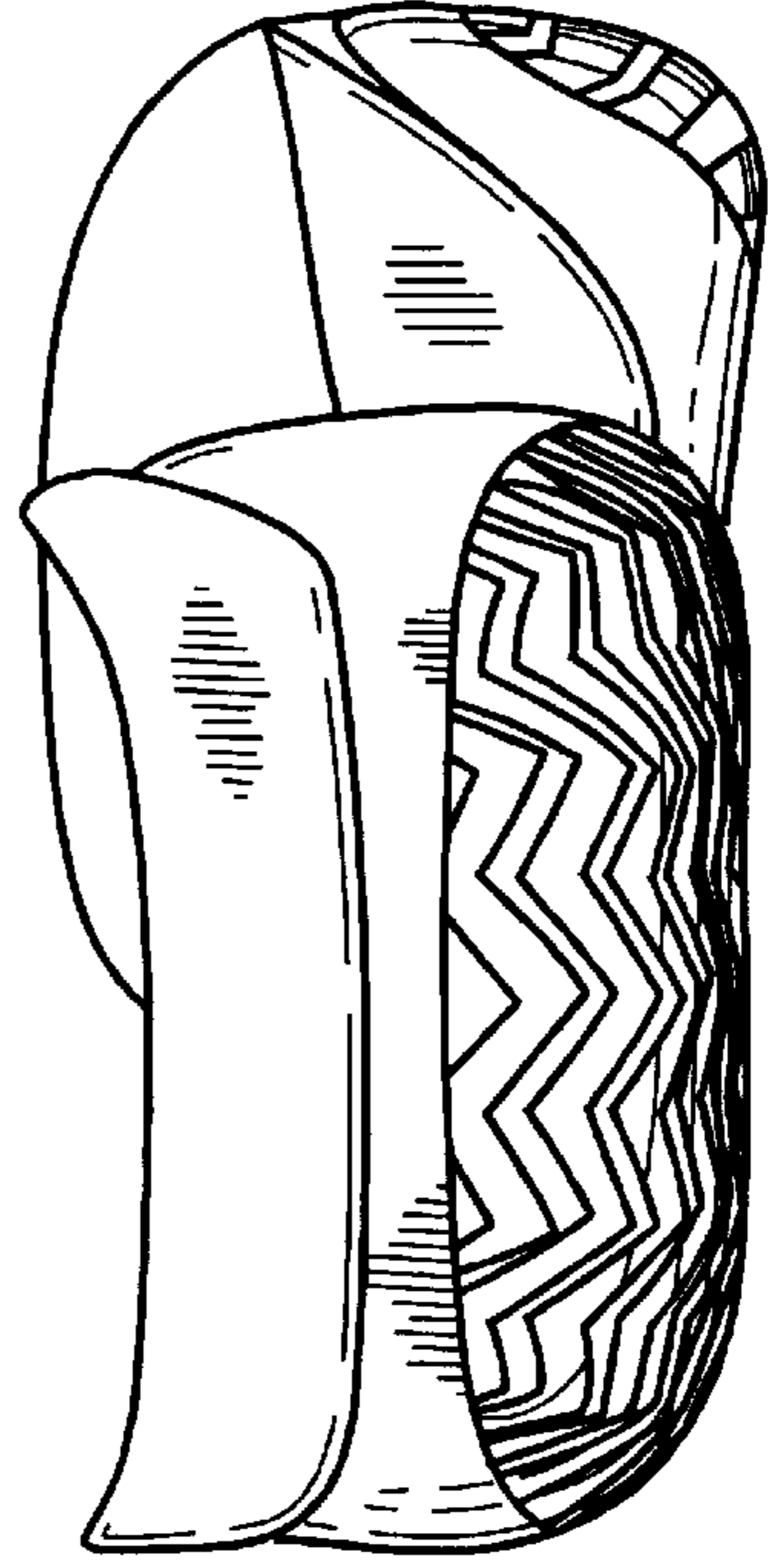
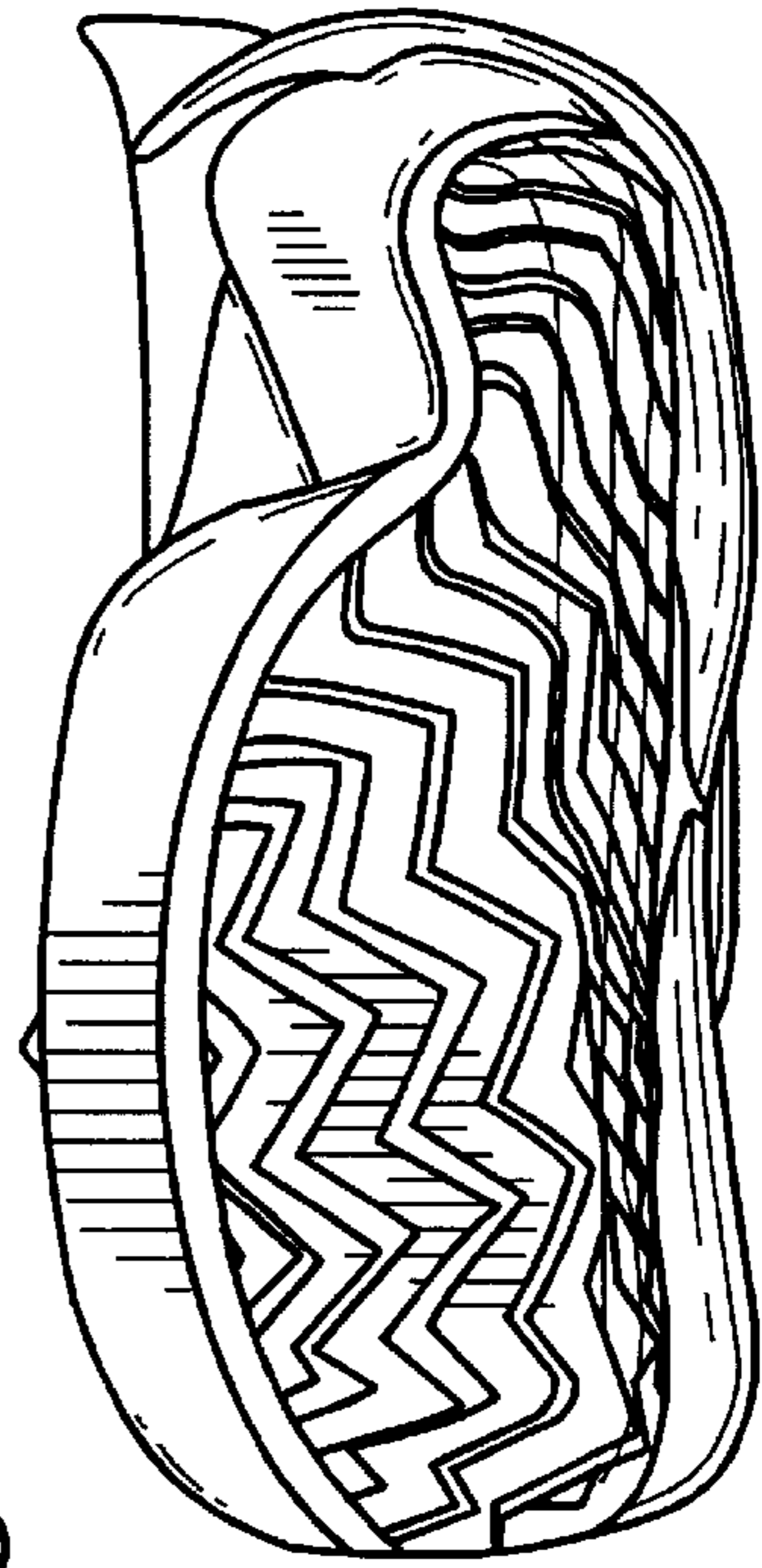

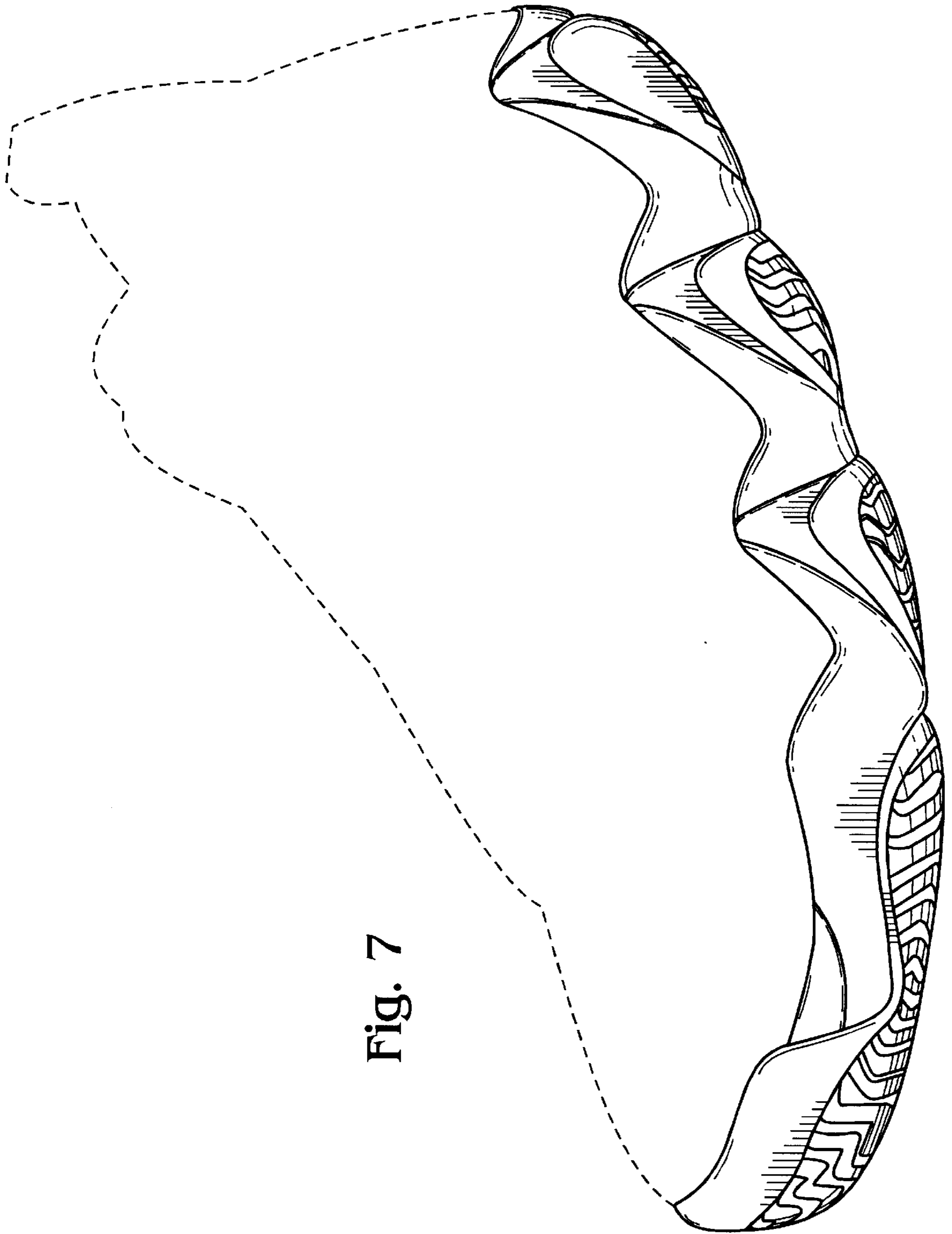
