[57] **CLAIM**

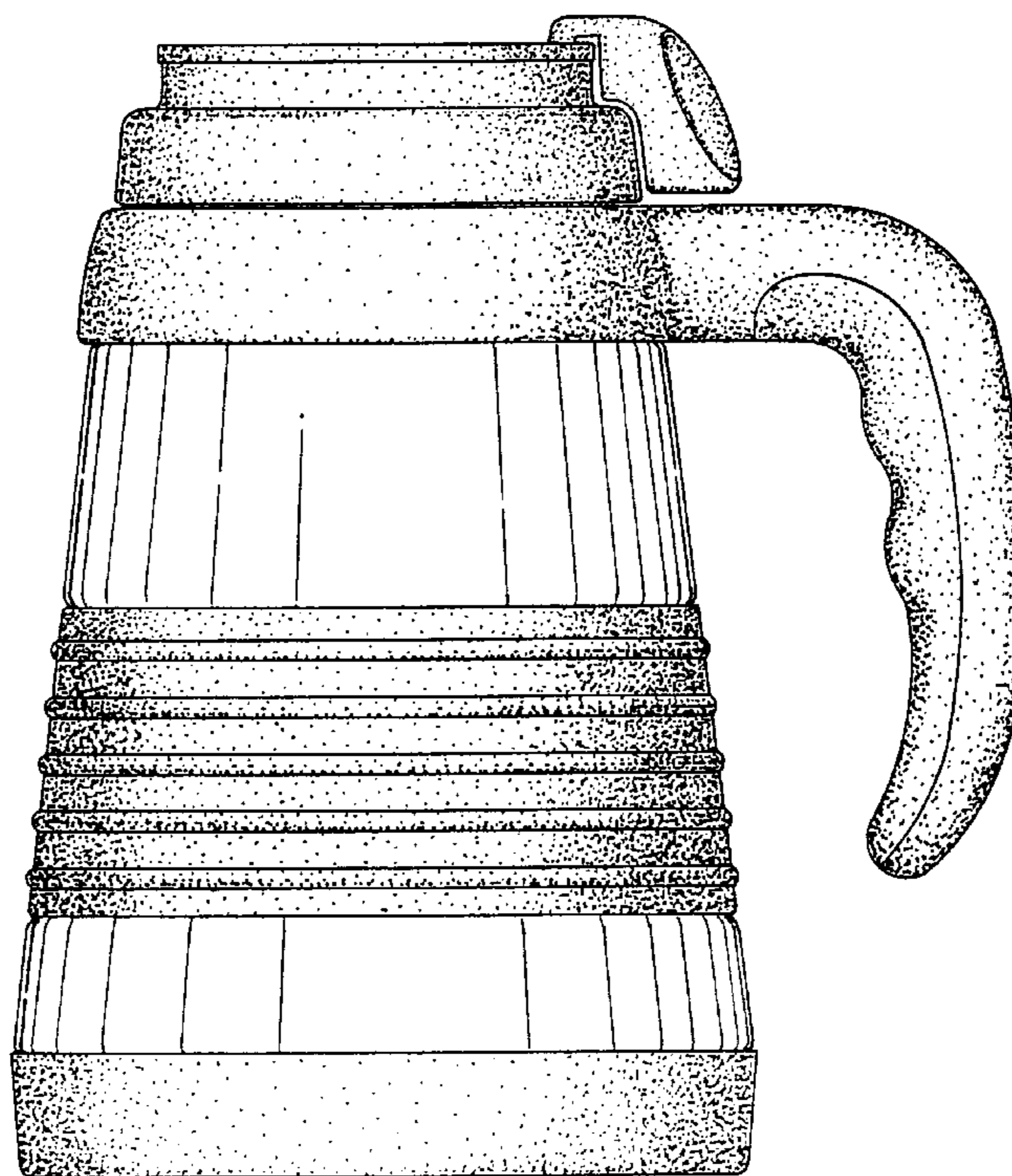
I claim the ornamental design for the cup with lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cup with lid showing my new design;
 FIG. 2 is a front elevational view thereof, the opposite side being a mirror image;
 FIG. 3 is a right side elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a cross-sectional view thereof, taken along line 7—7 of FIG. 5;
 FIG. 8 is a cross-sectional view thereof, taken along line 8—8 of FIG. 2;
 FIG. 9 is a top plan view thereof showing an example in use;
 FIG. 10 is a front elevational view thereof showing an example in use; and,
 FIG. 11 is a cross-sectional view thereof, taken along line 11—11 of FIG. 10.

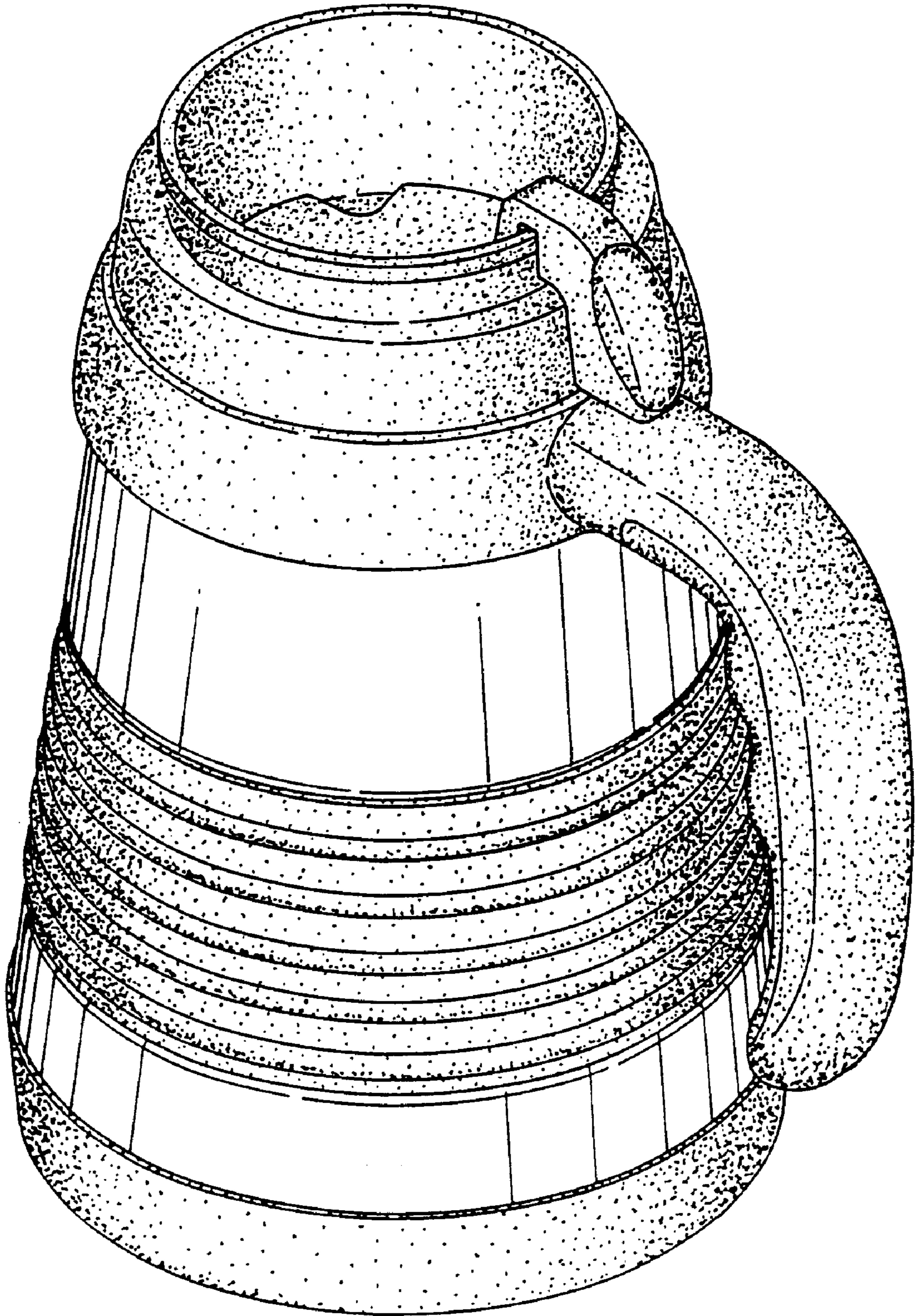
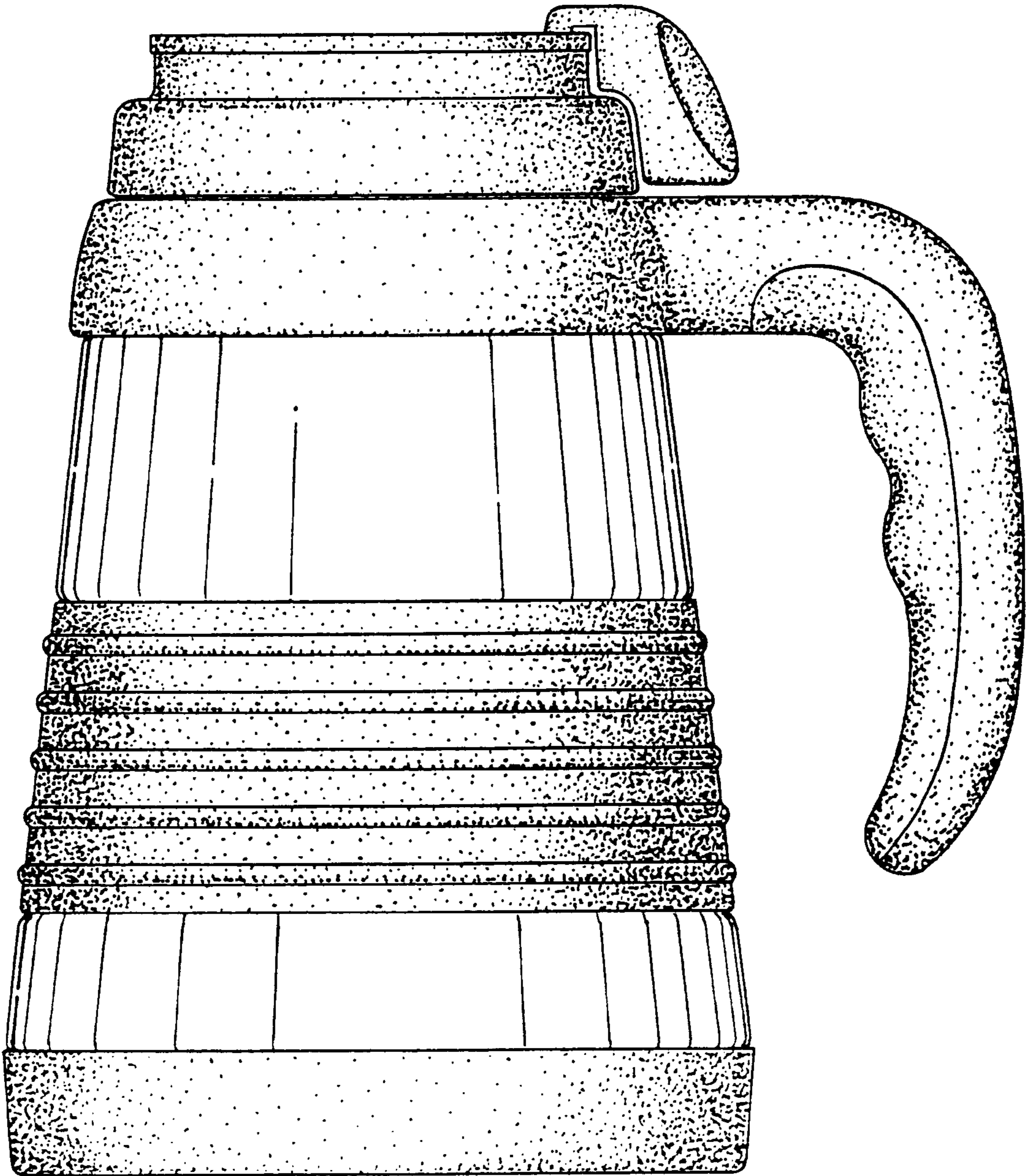

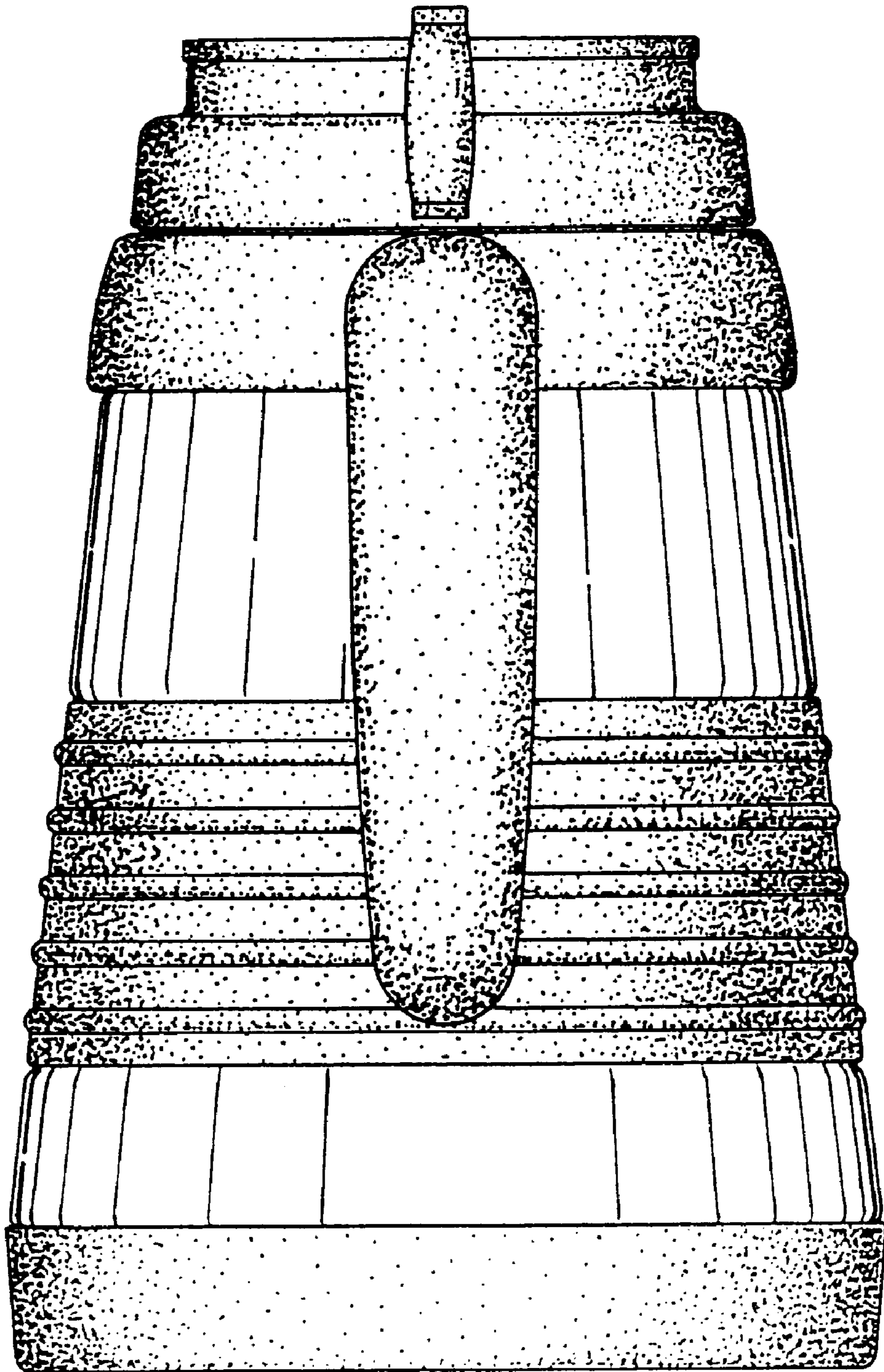

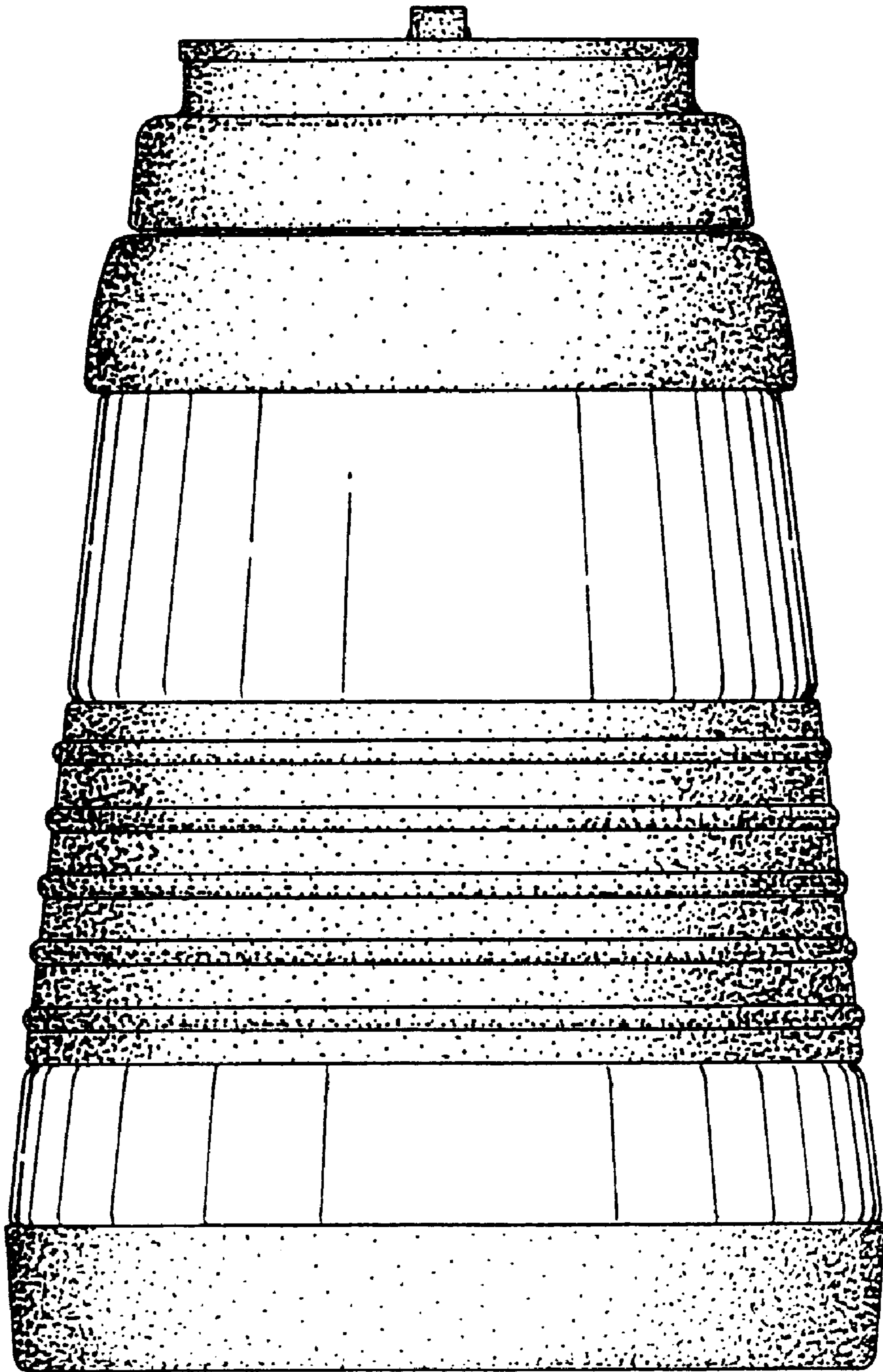

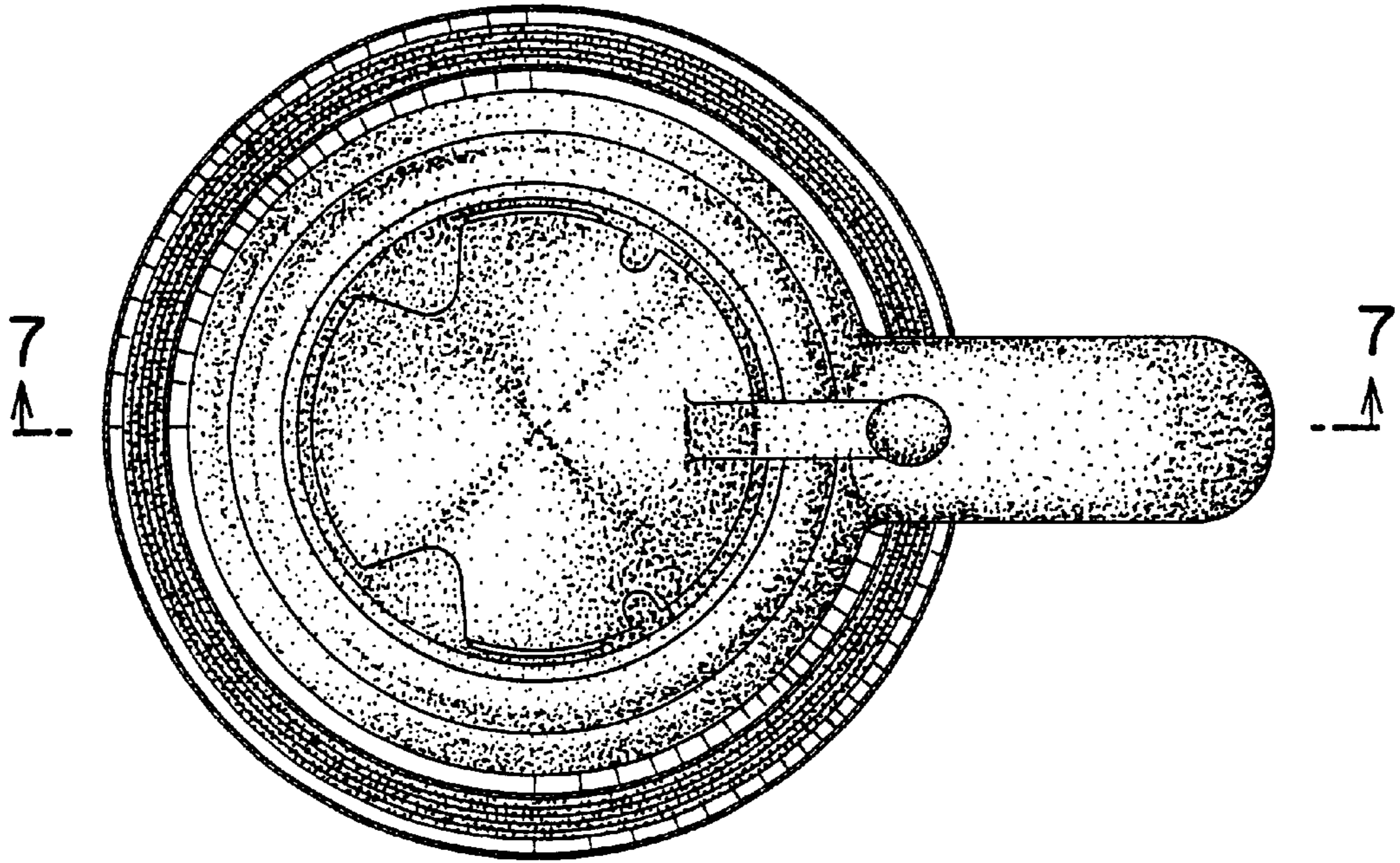

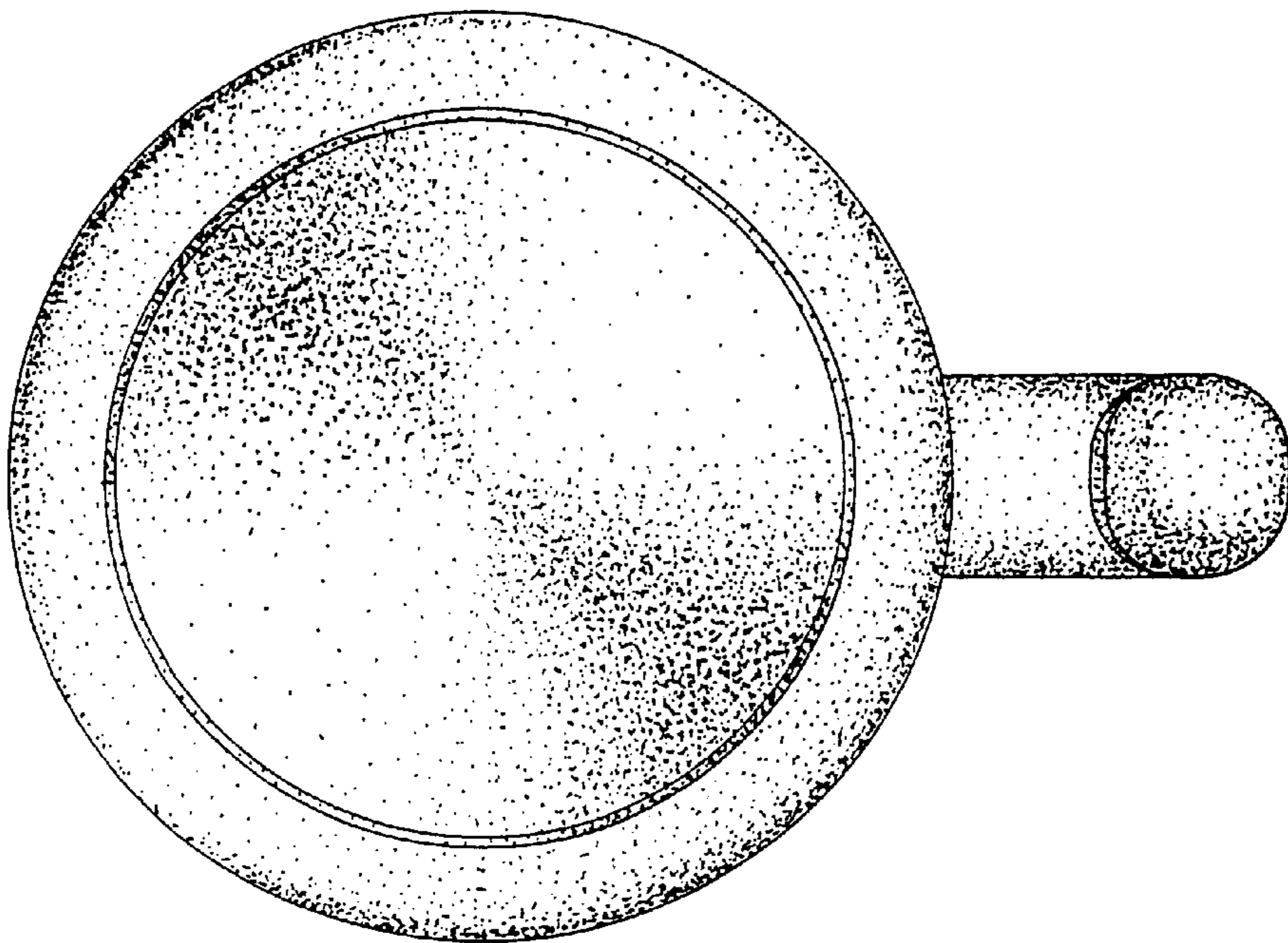

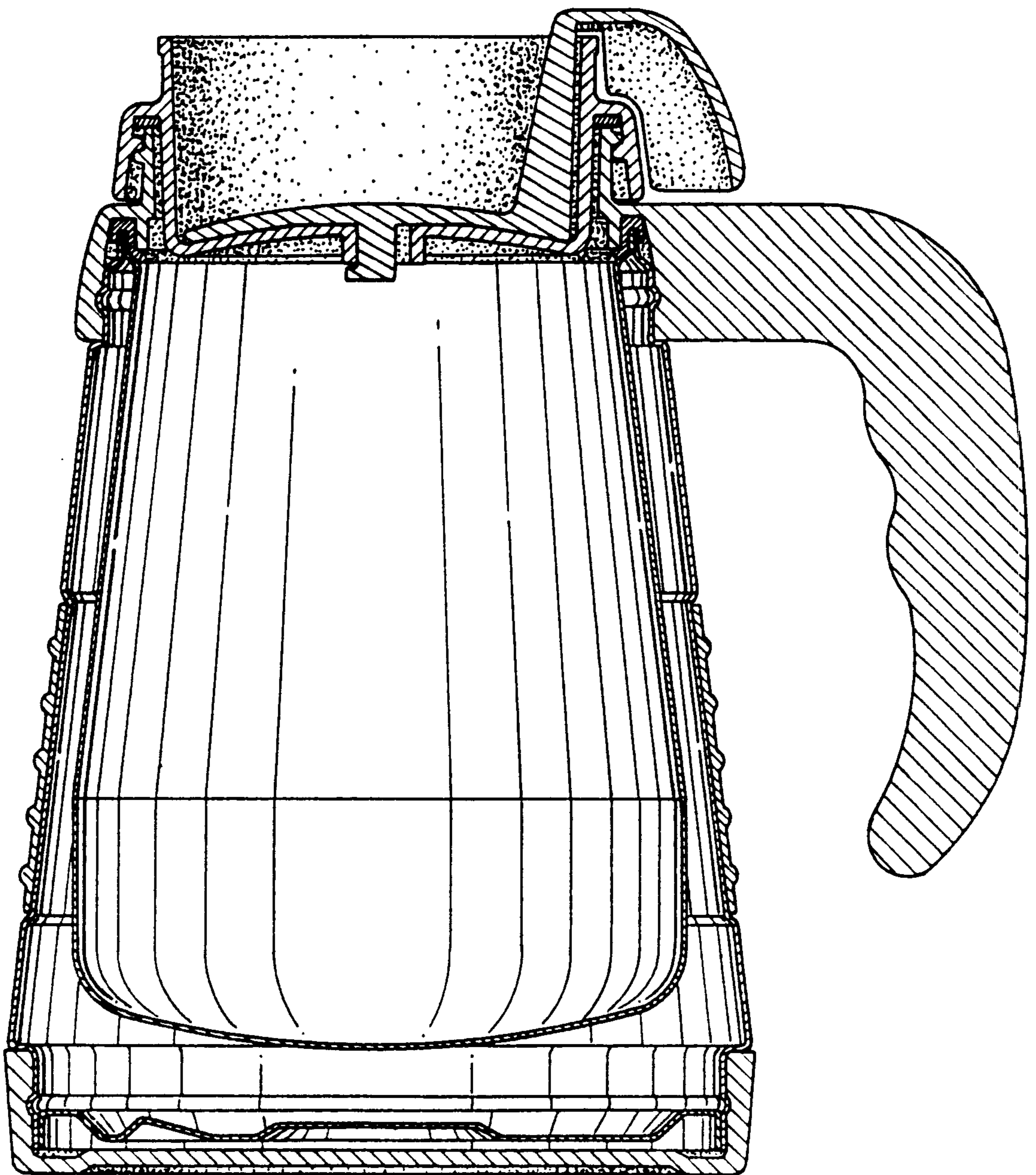

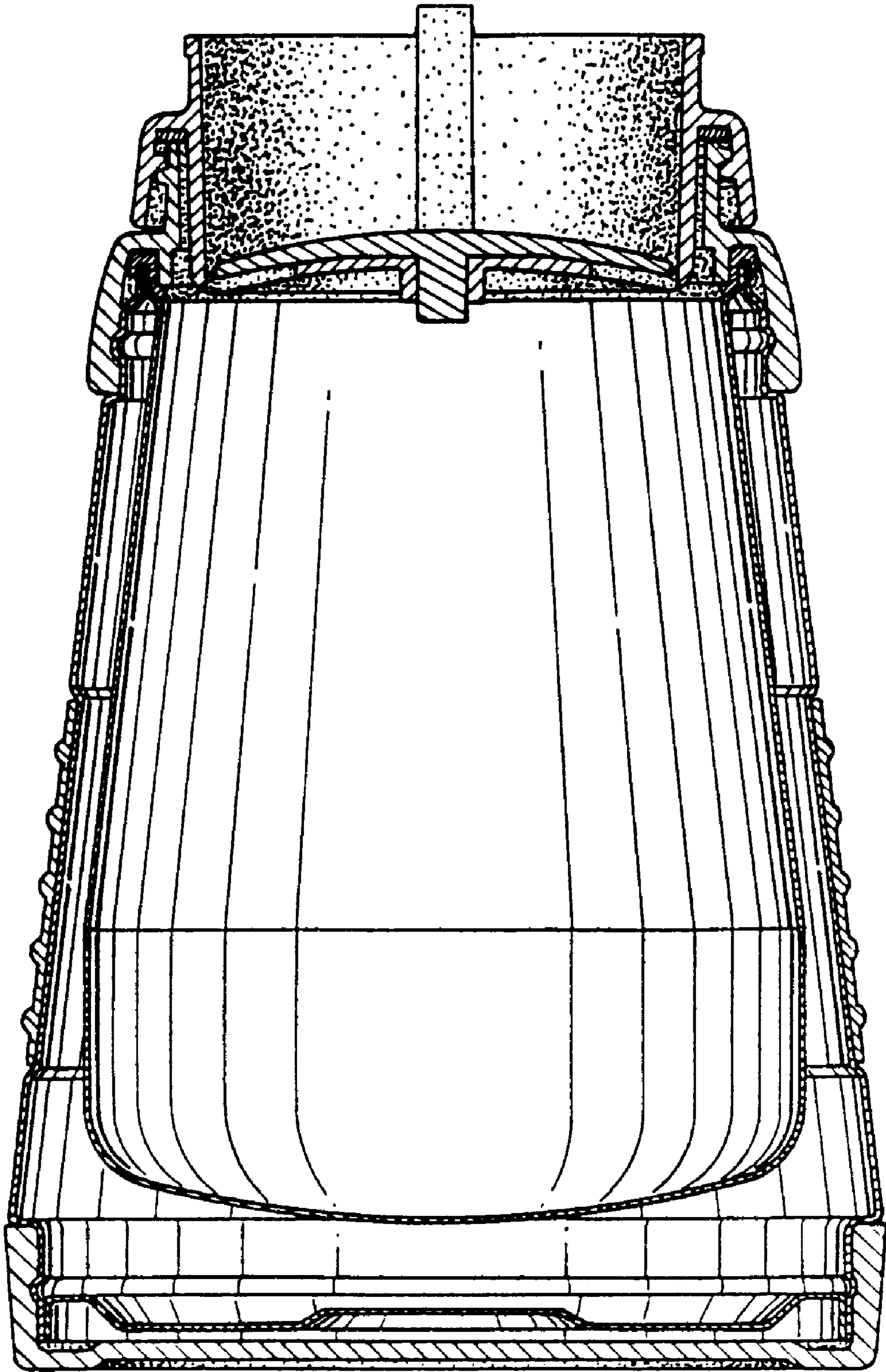

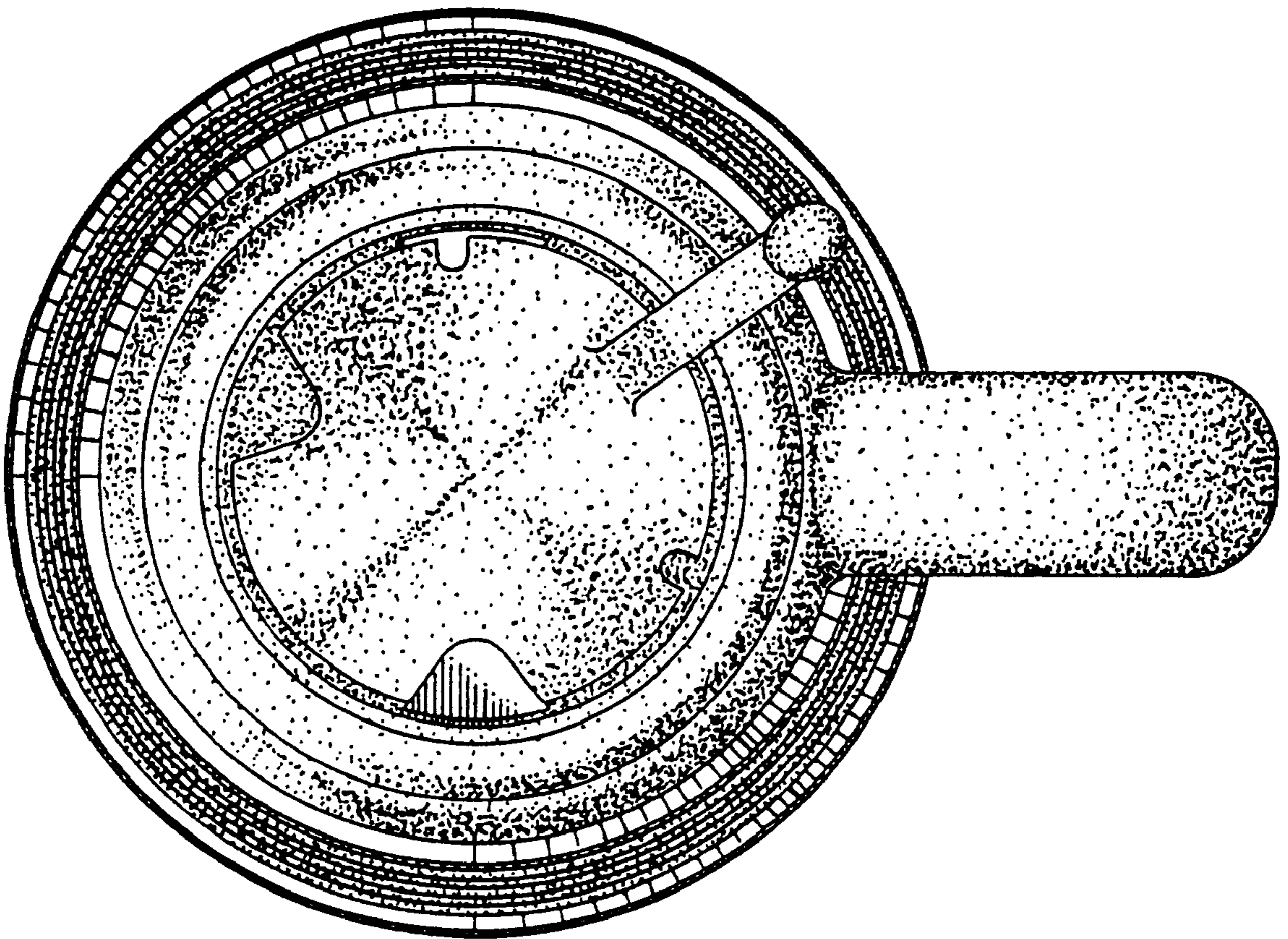

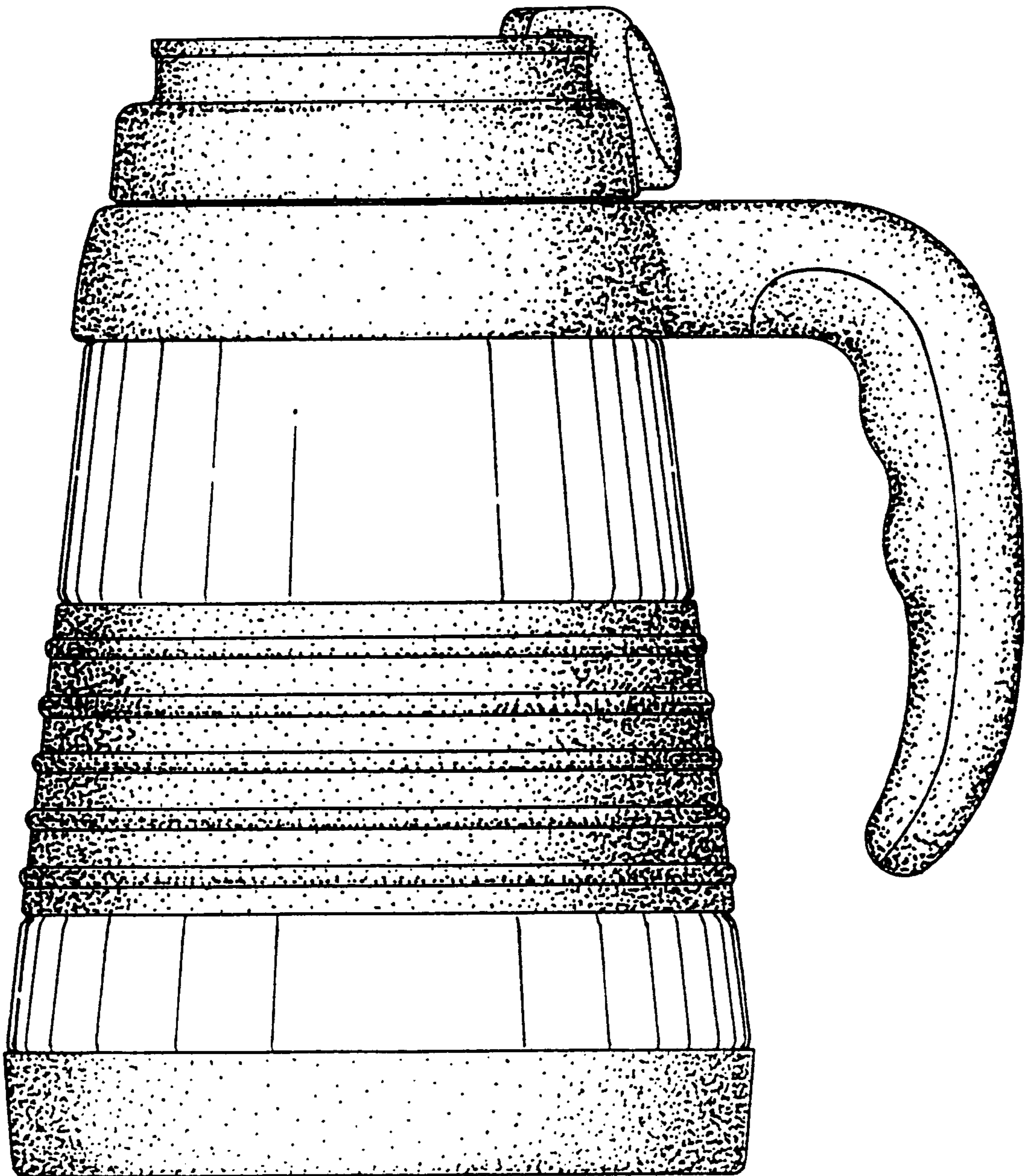
