FIG. 10 is a left side view of FIG. 7, the right side view being a mirror image of the side shown;

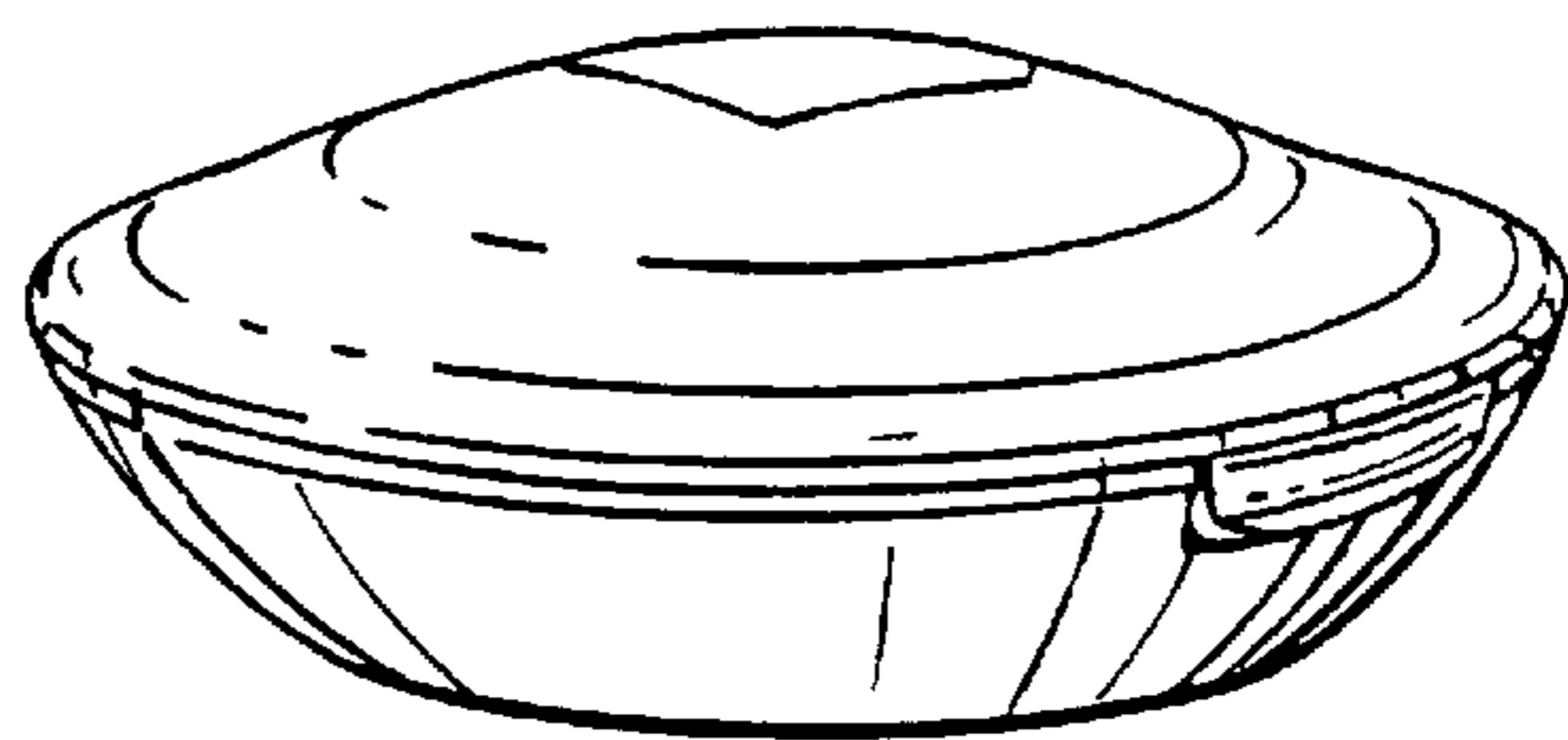
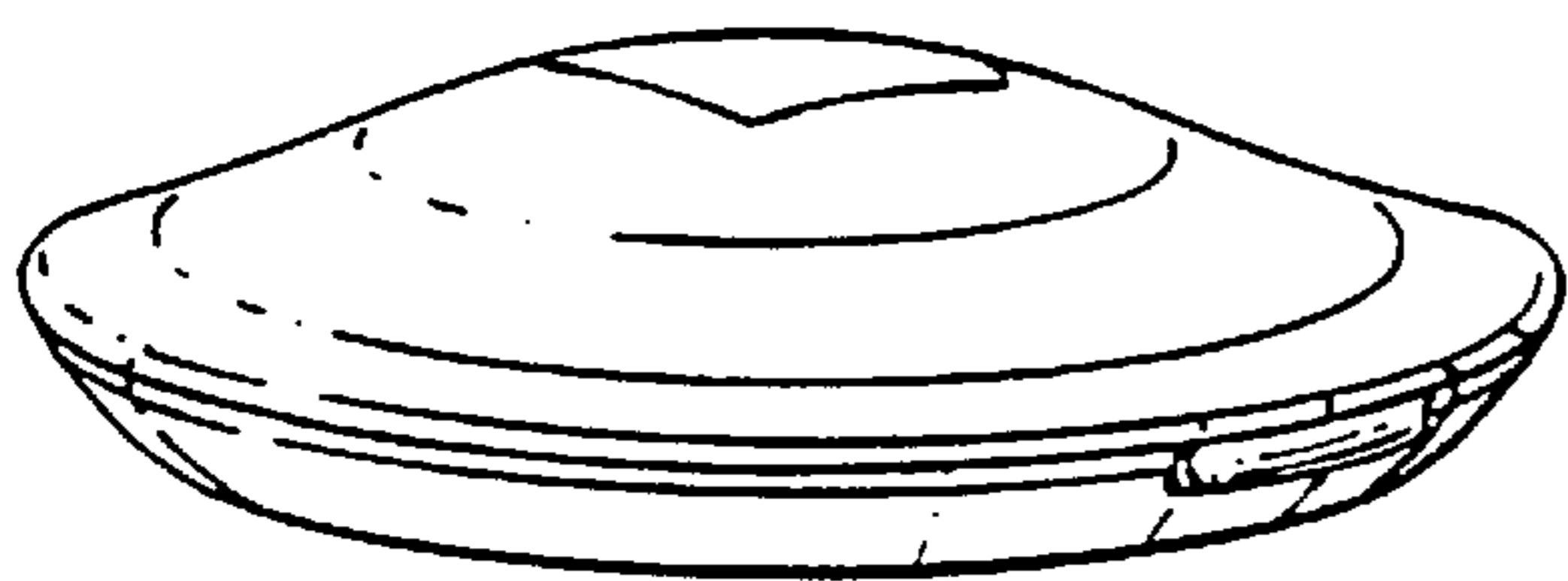
FIG. 11 is a top plan view of FIG. 7; and,

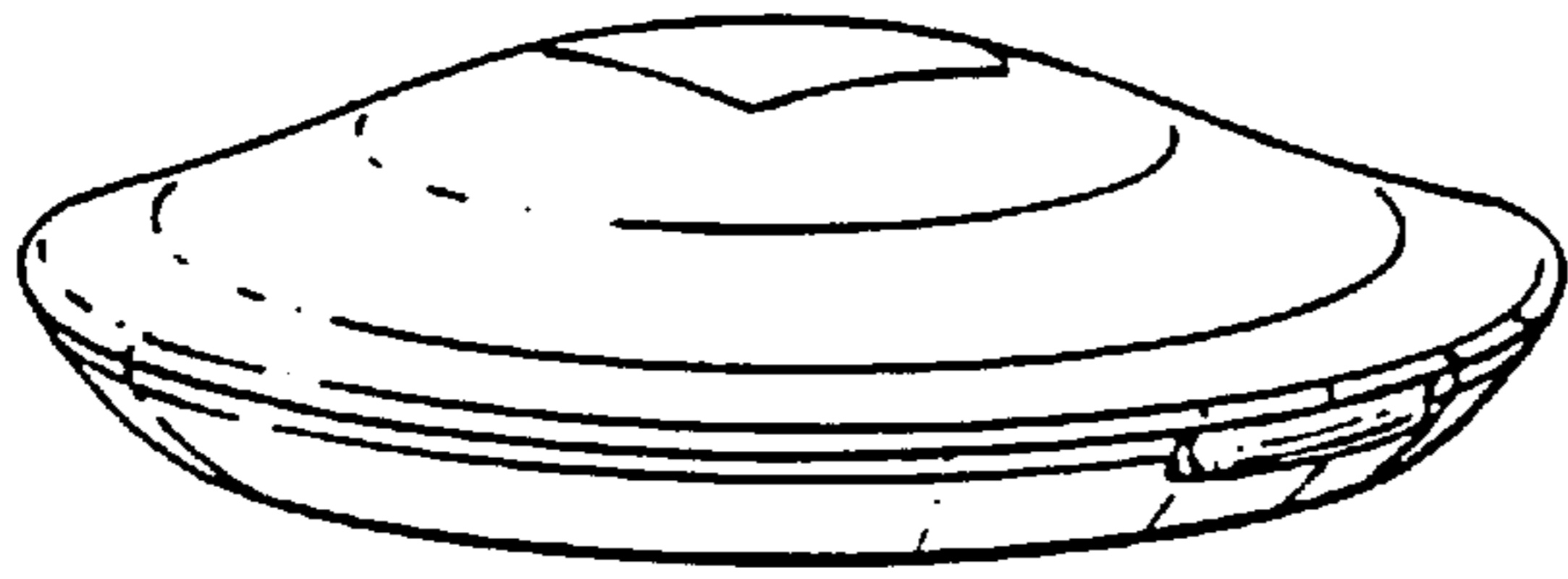

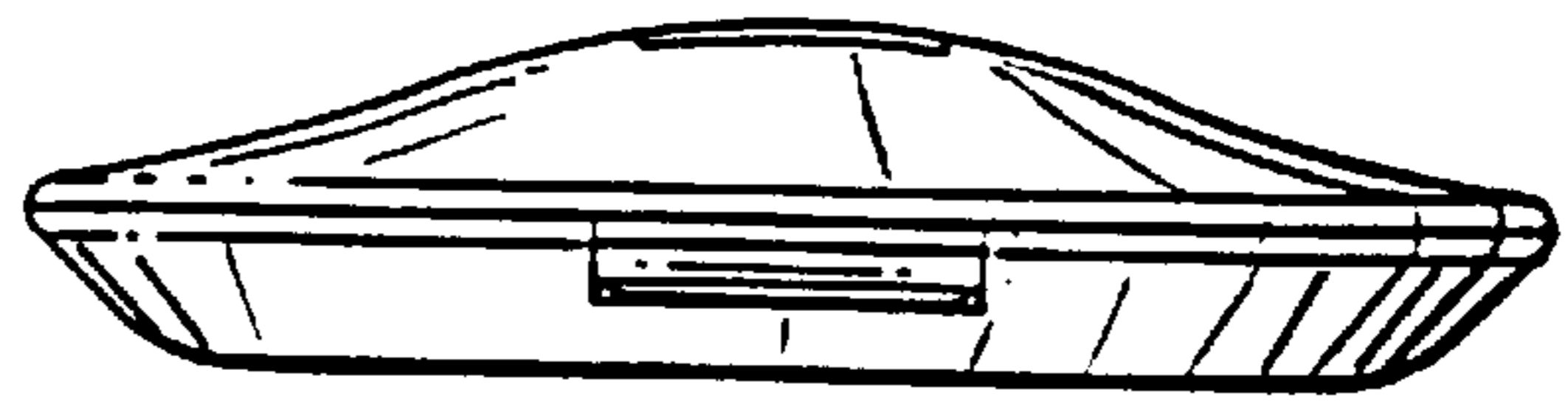

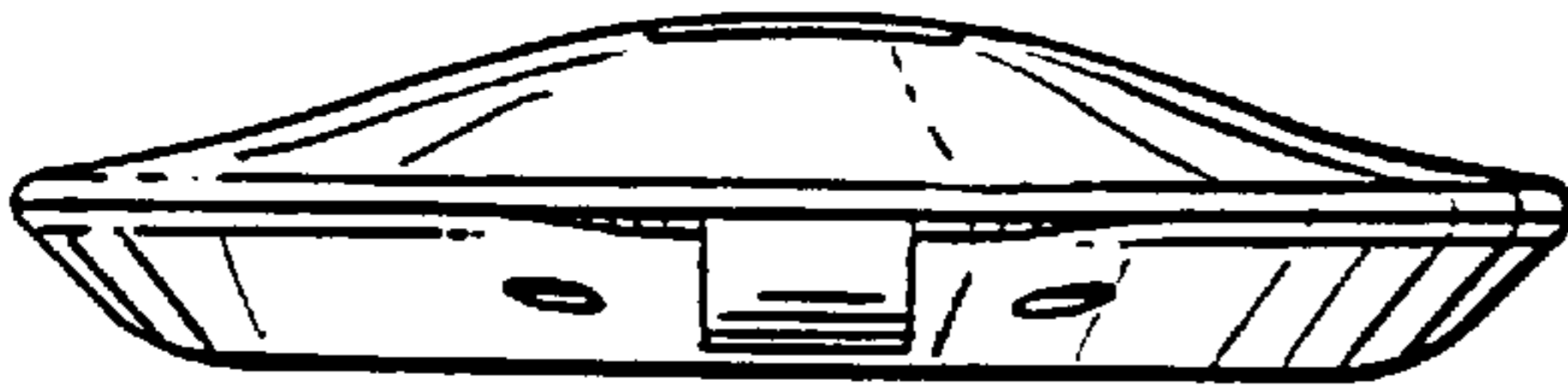

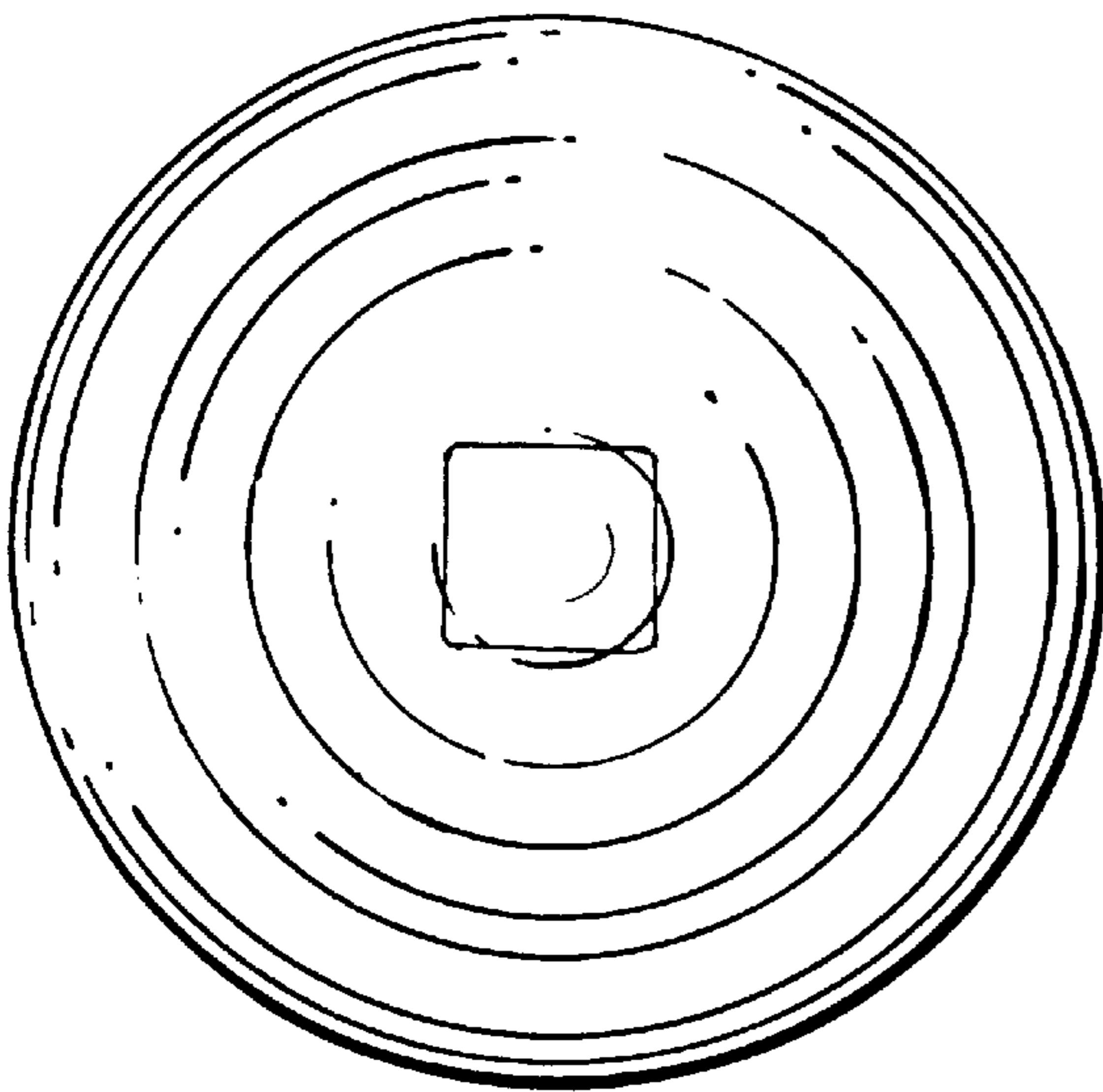

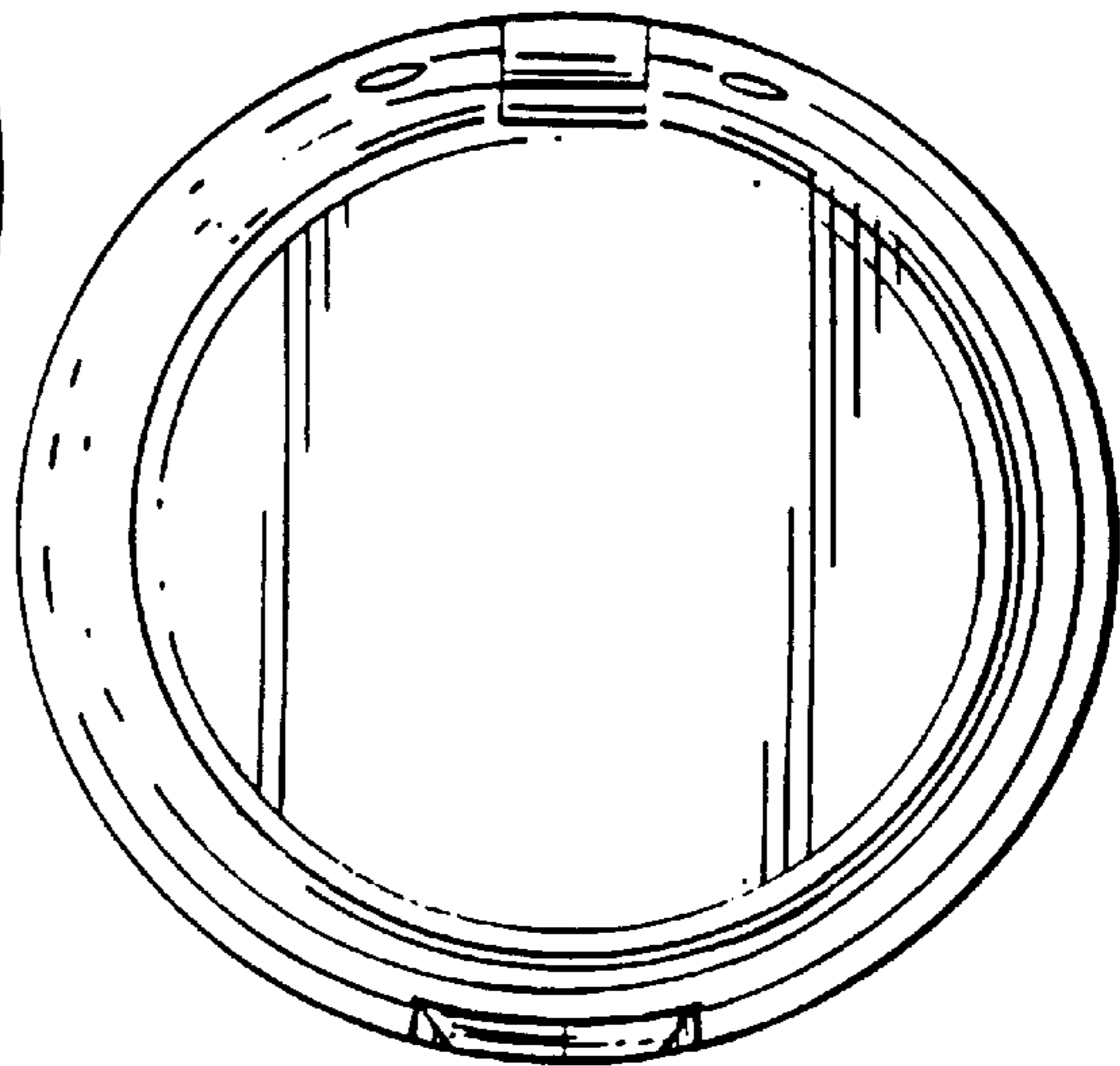

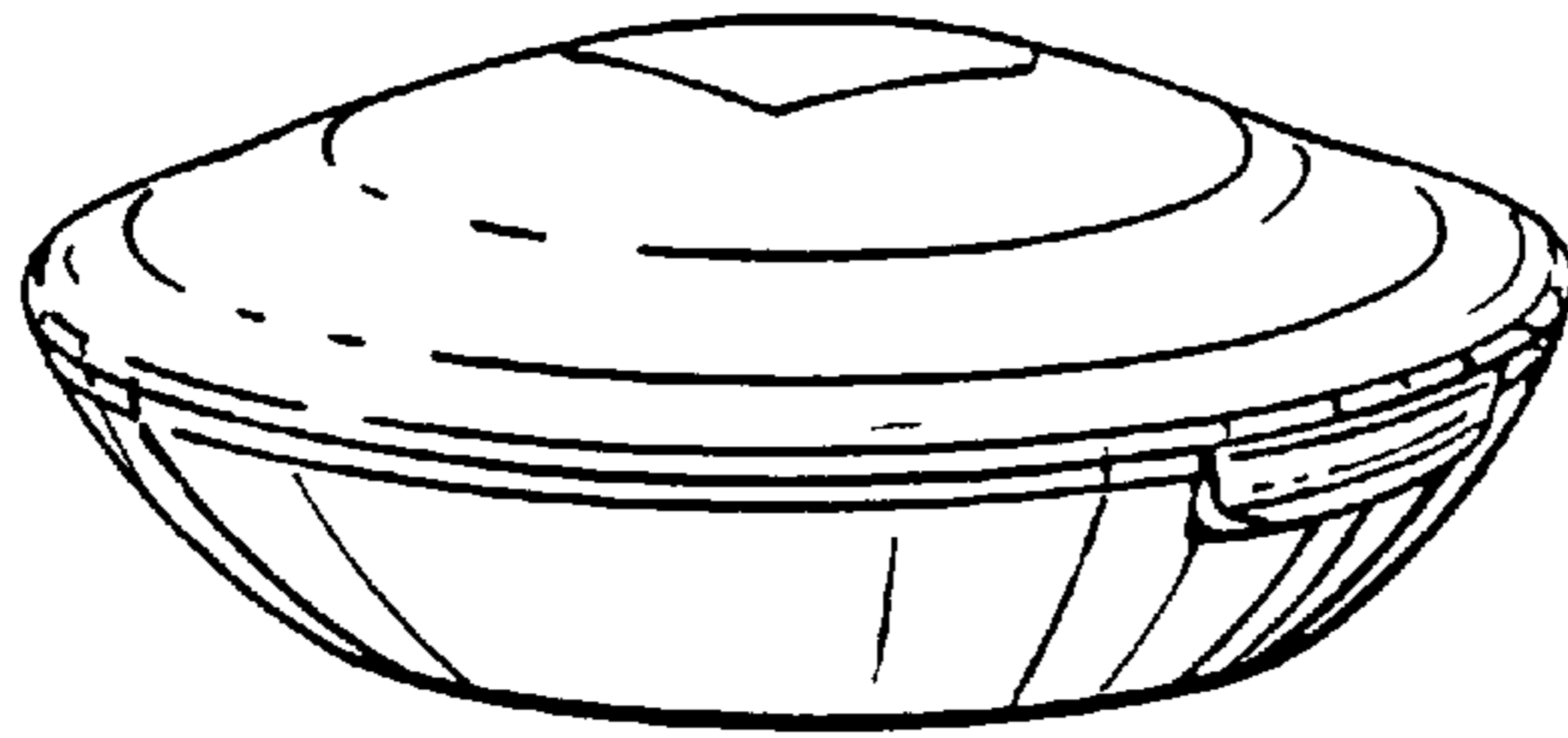

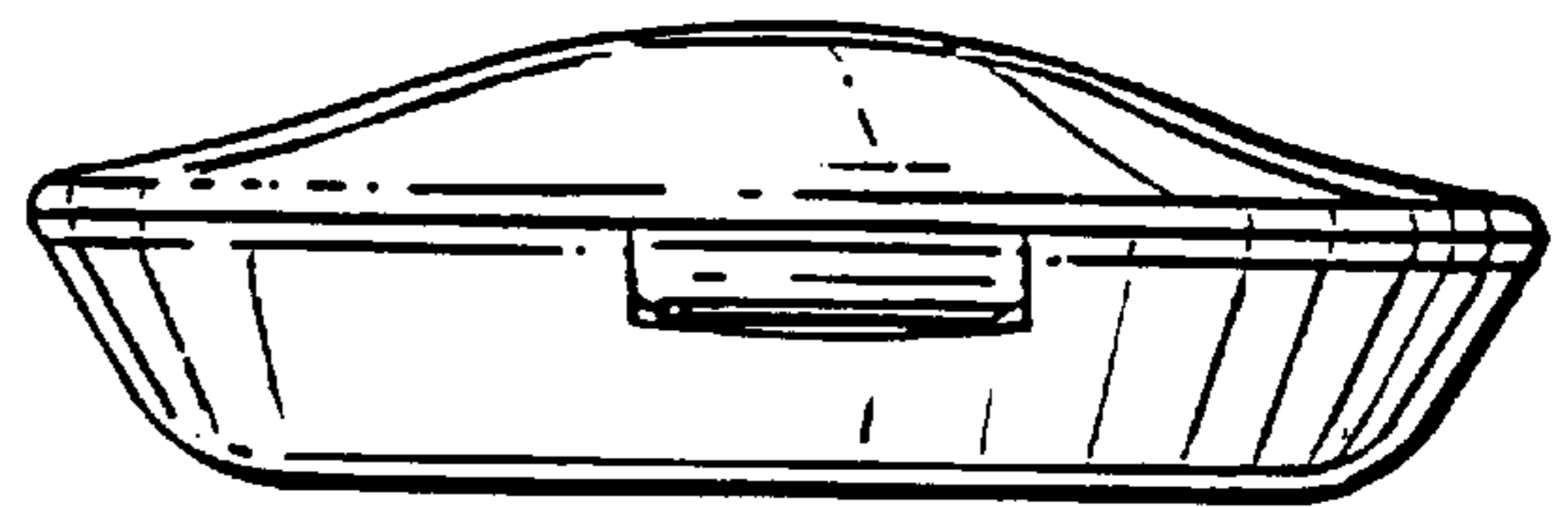

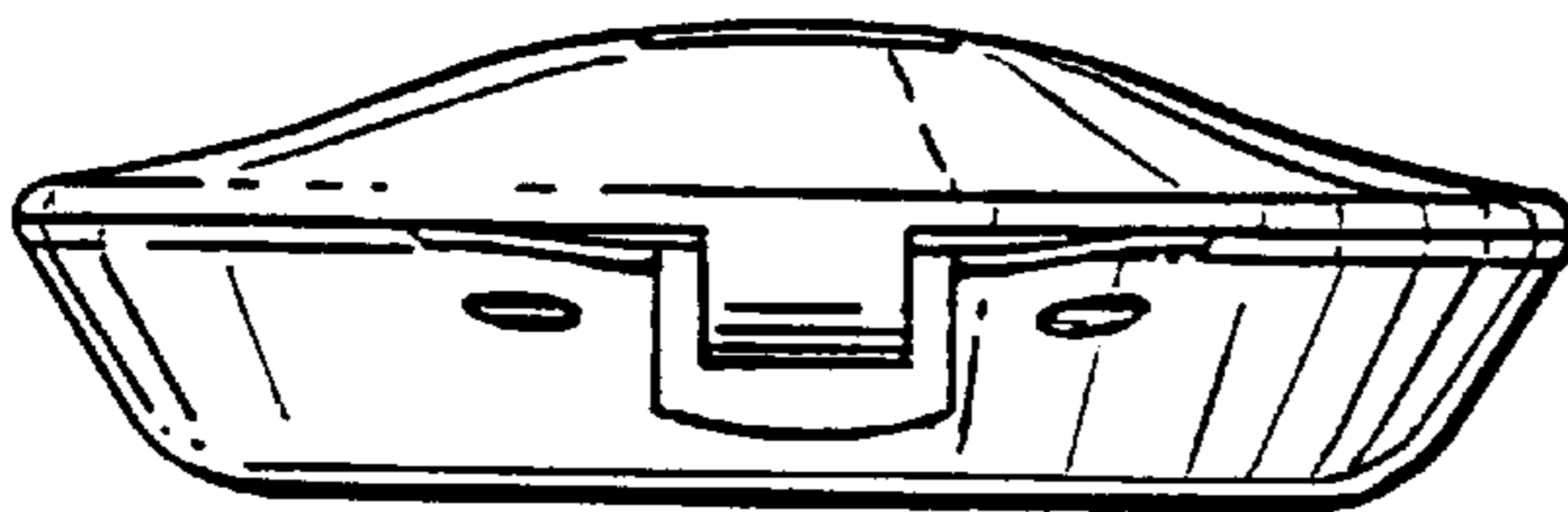

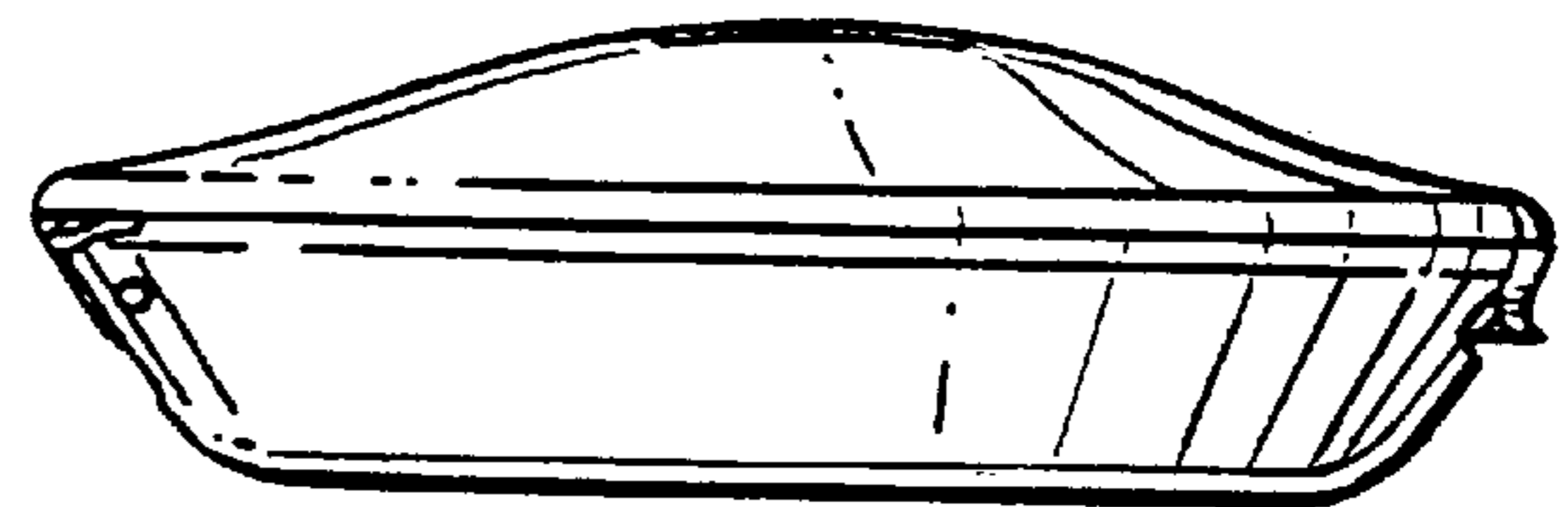

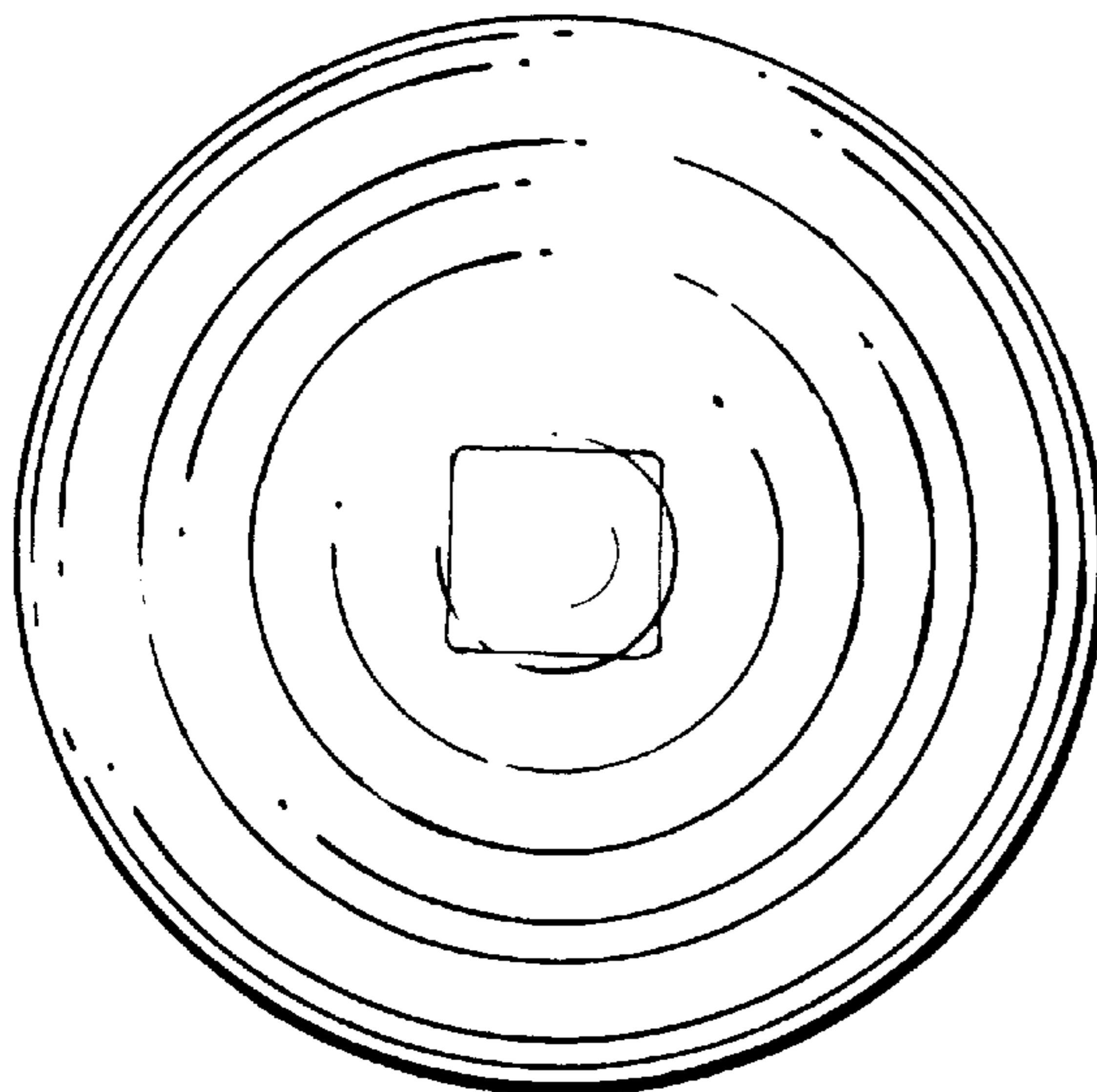

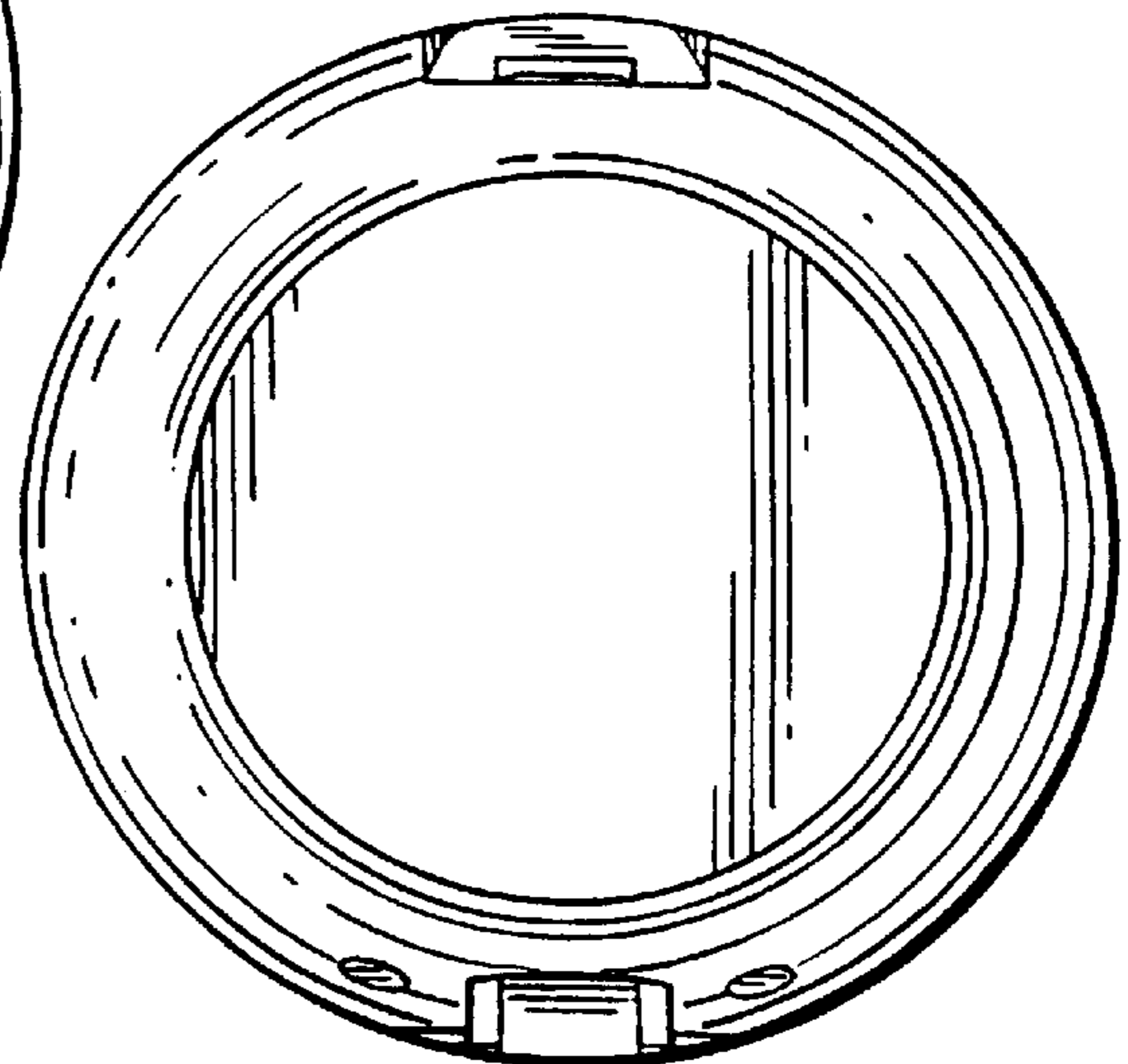
