[57] **CLAIM**

The ornamental design for a hand mixer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view as seen from the top, front and right side of a hand mixer showing my new design;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a perspective view as seen from the top, front and right side of a hand mixer showing a second embodiment of my new design;

FIG. 8 is a right side elevational view thereof;

FIG. 9 is a front elevational view thereof;

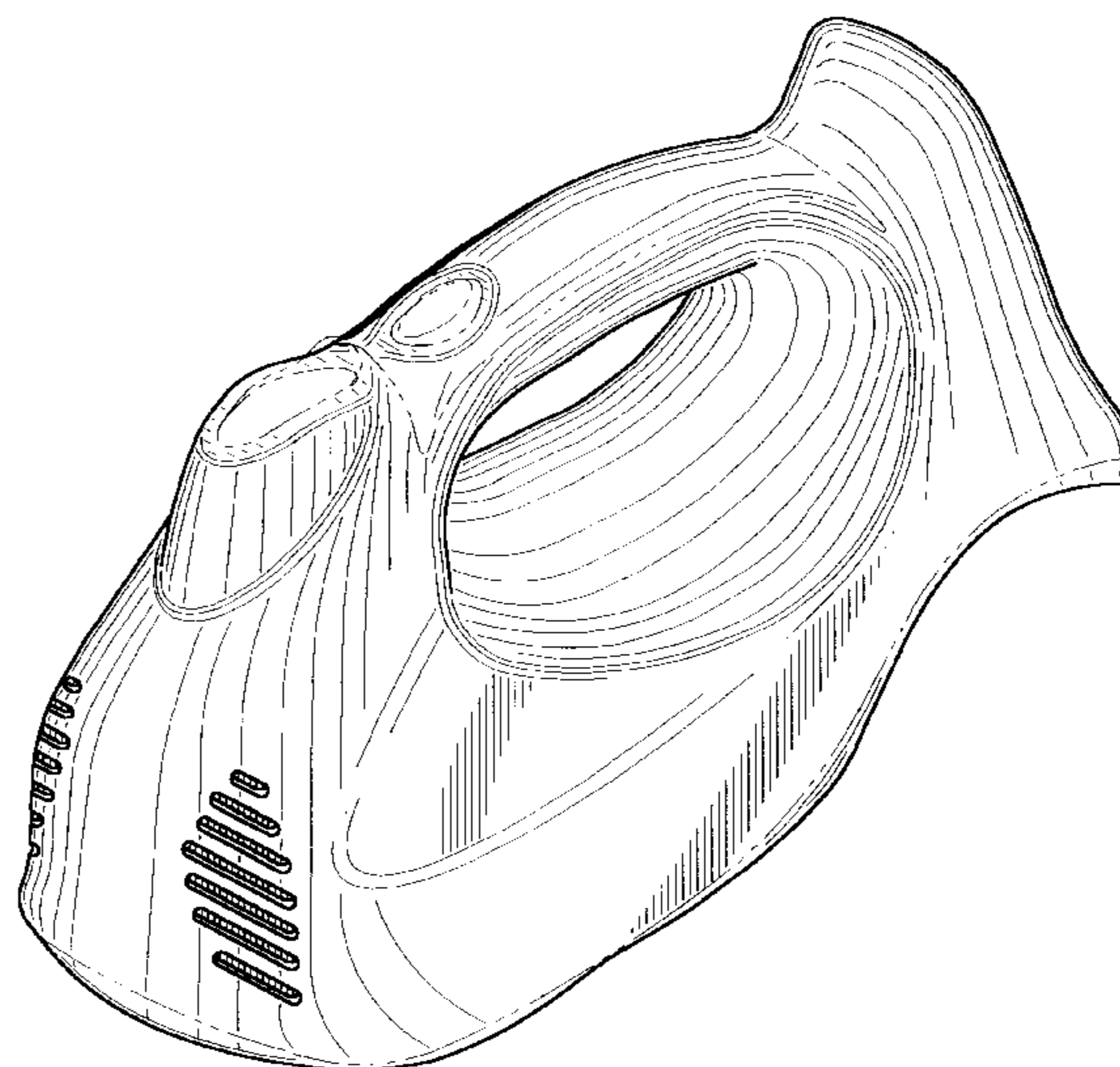
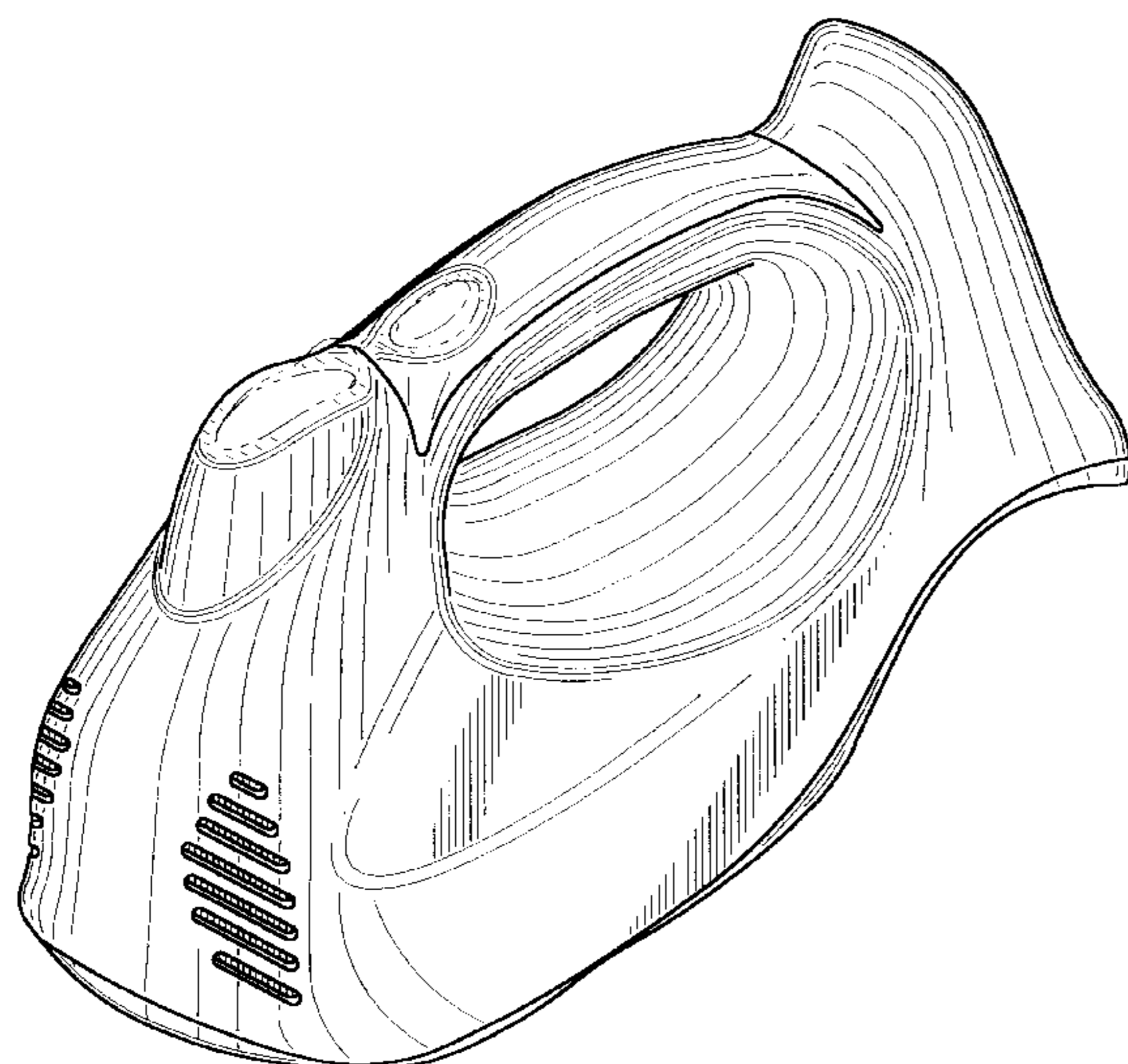
FIG. 10 is a rear elevational view thereof;

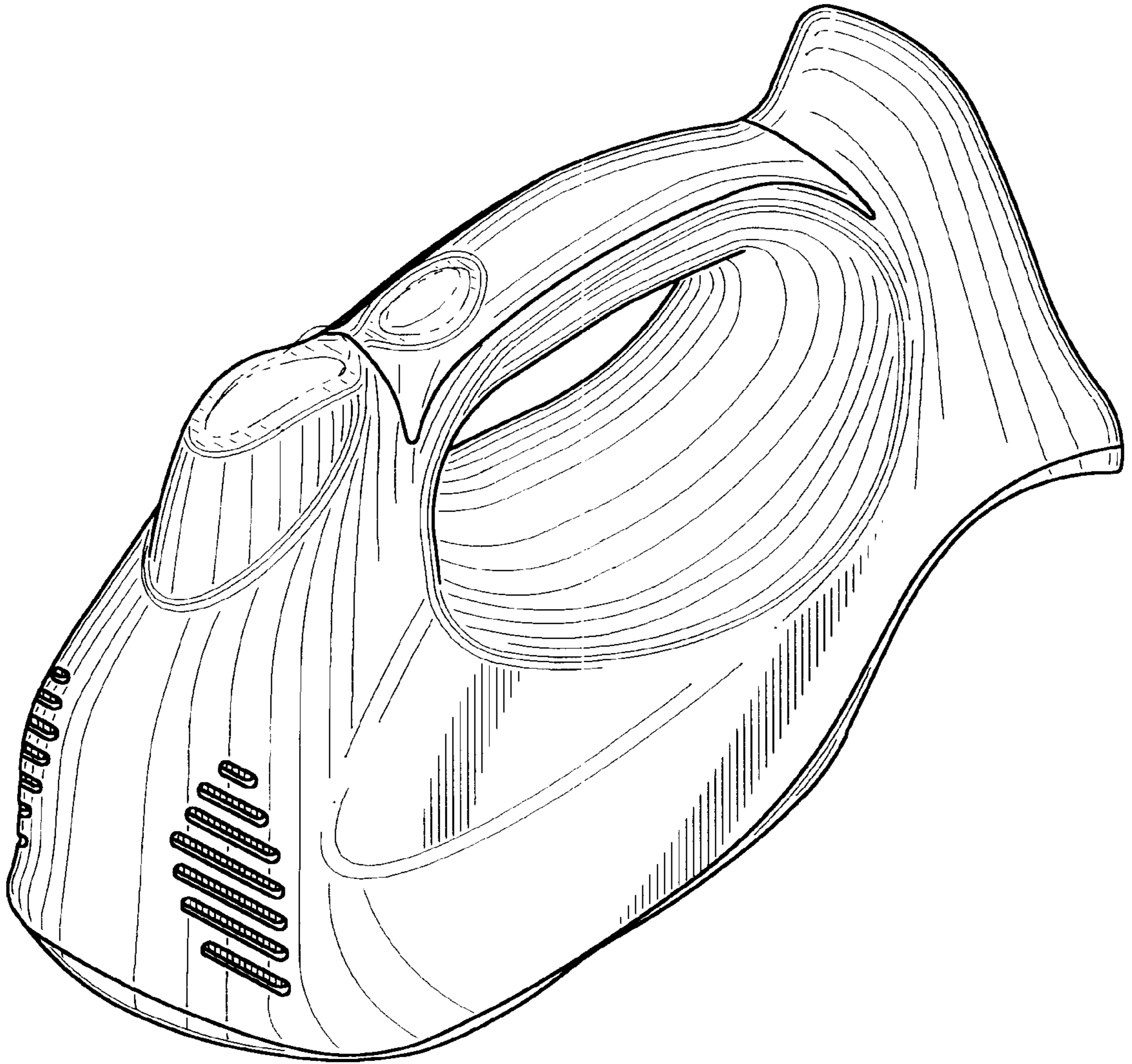

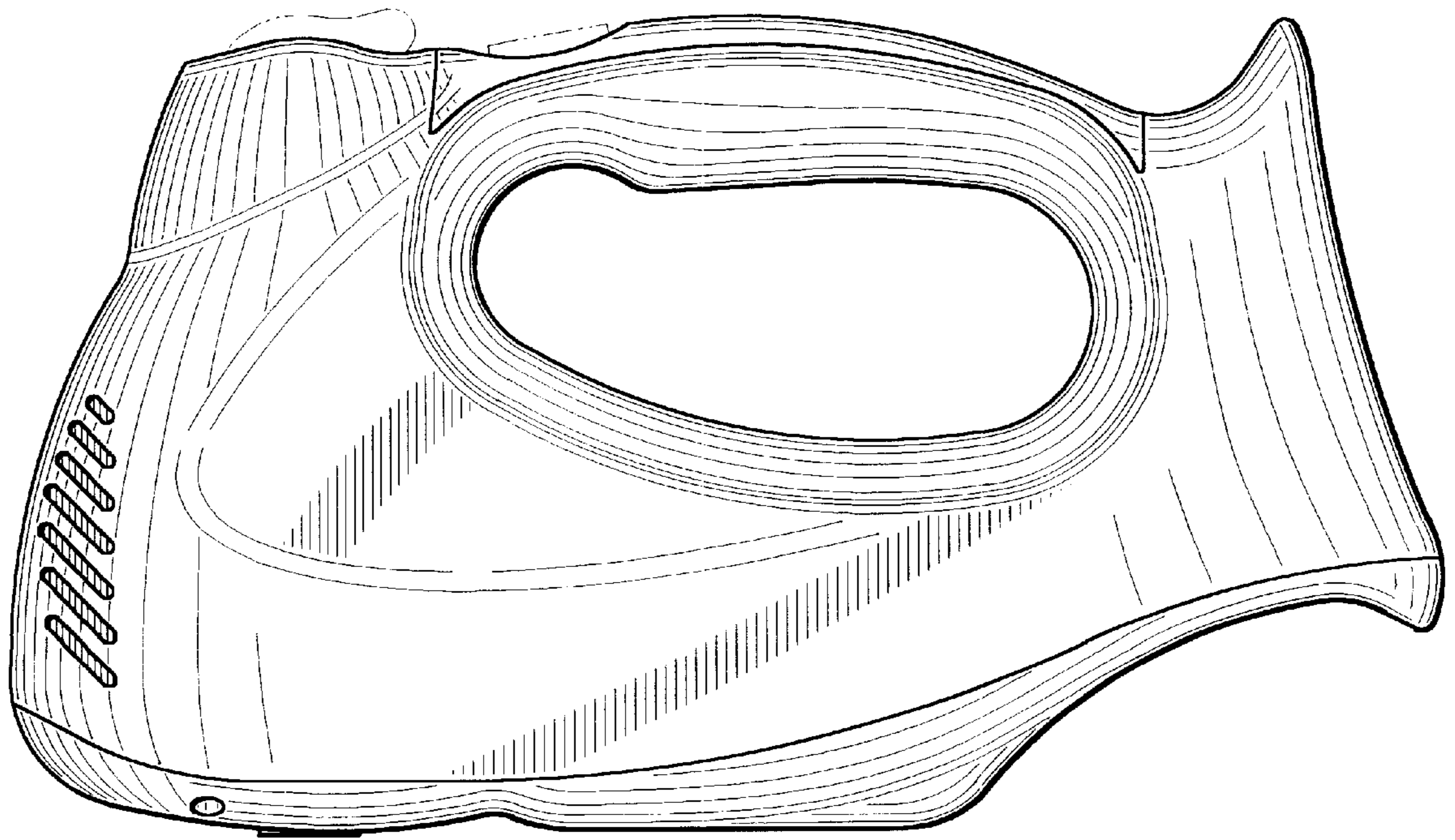

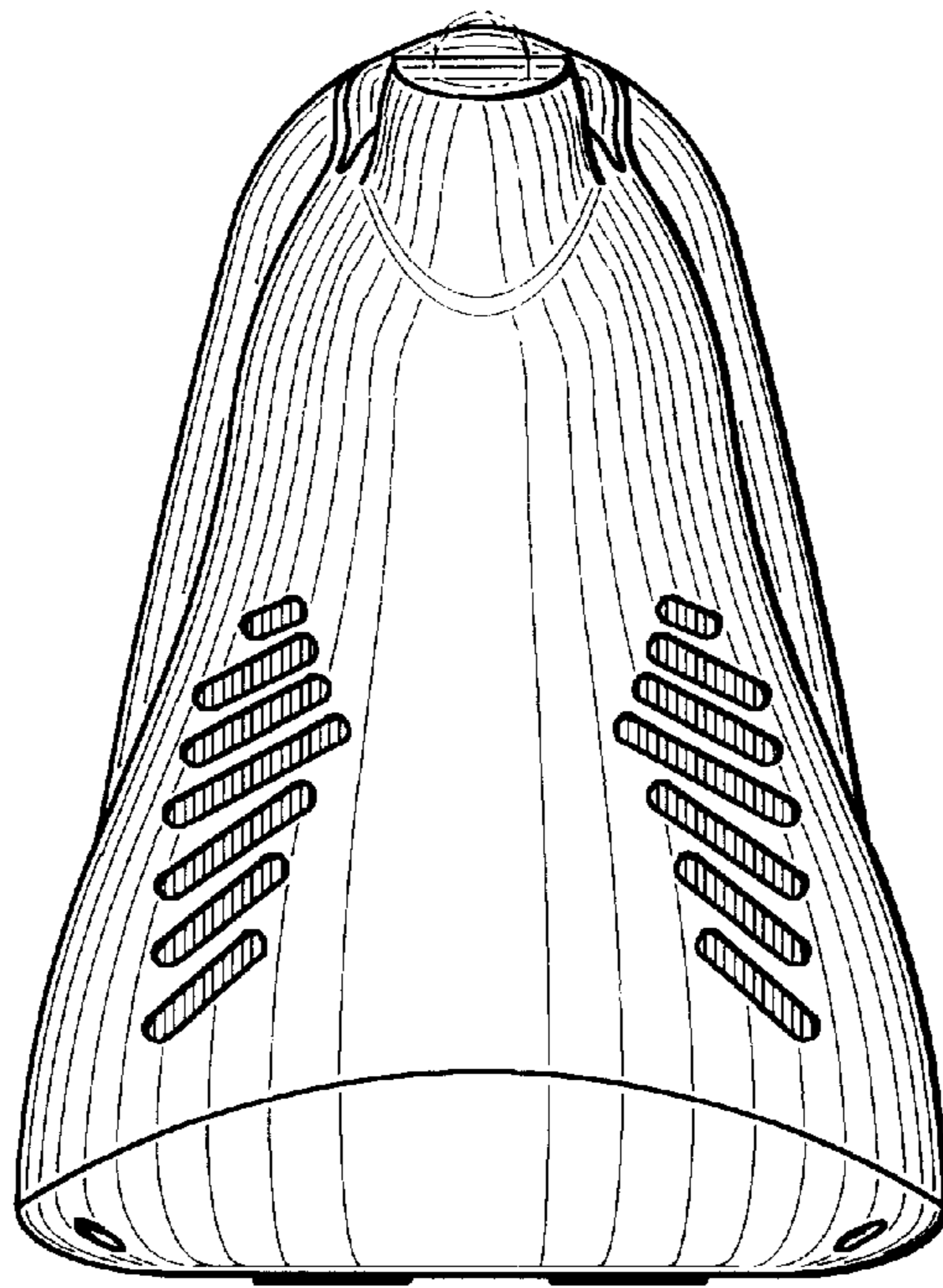

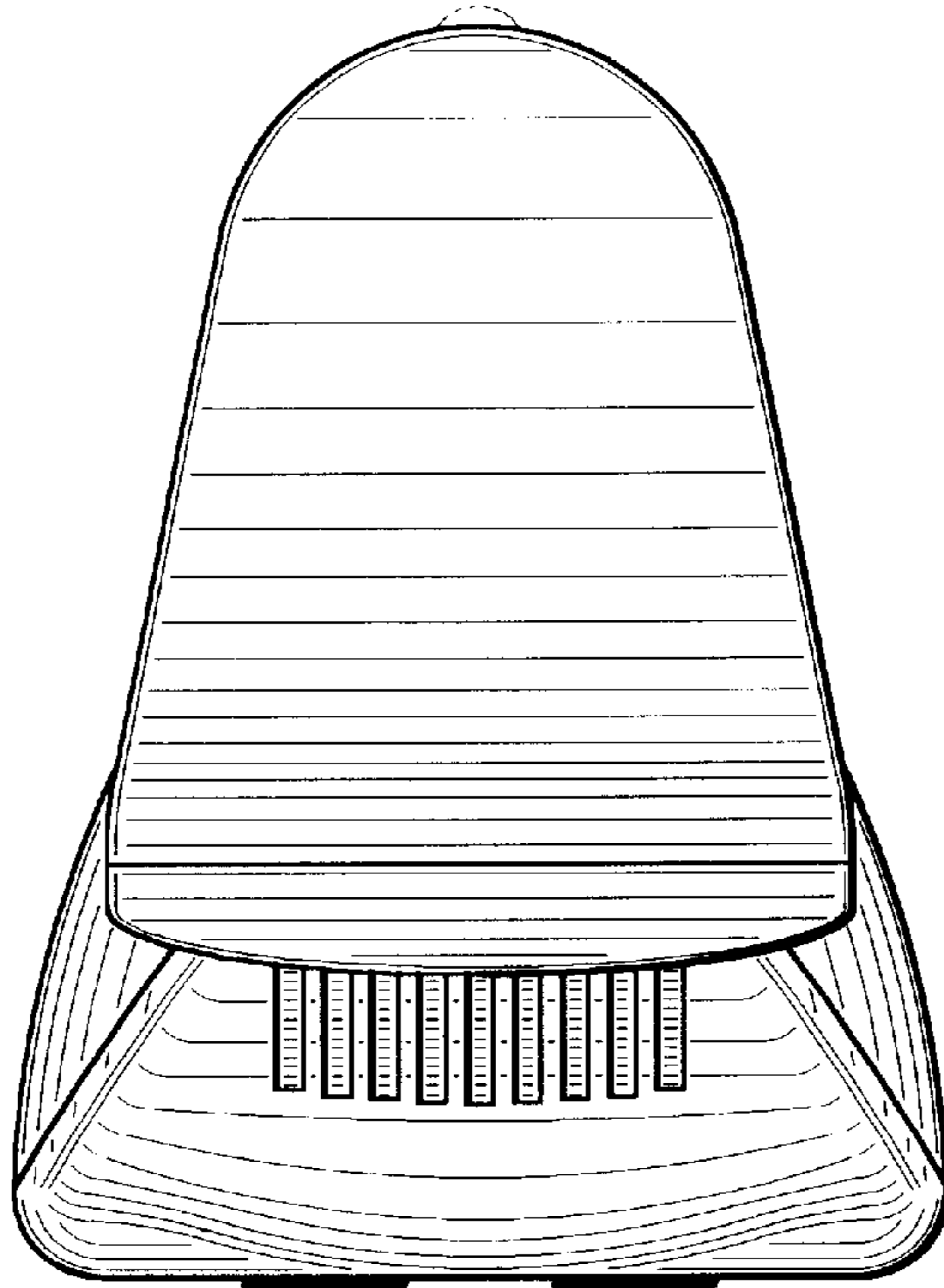

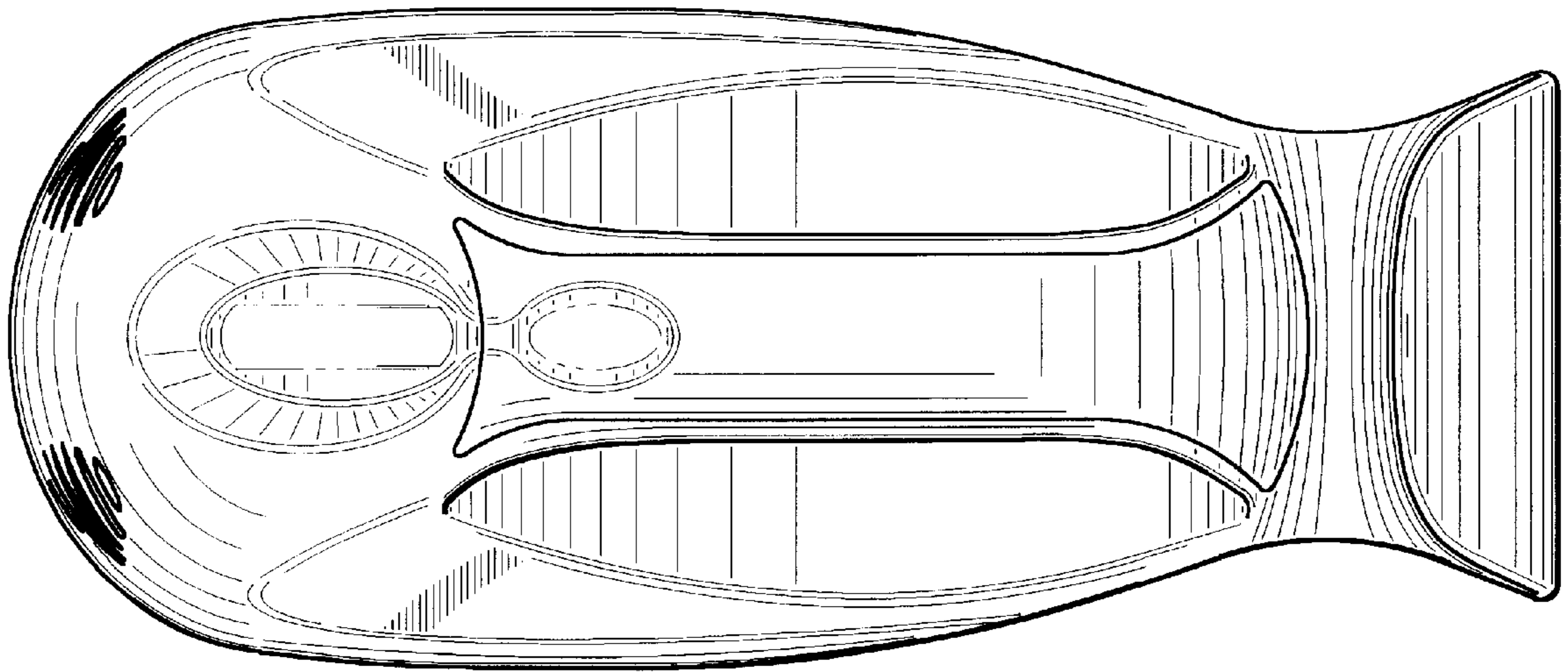

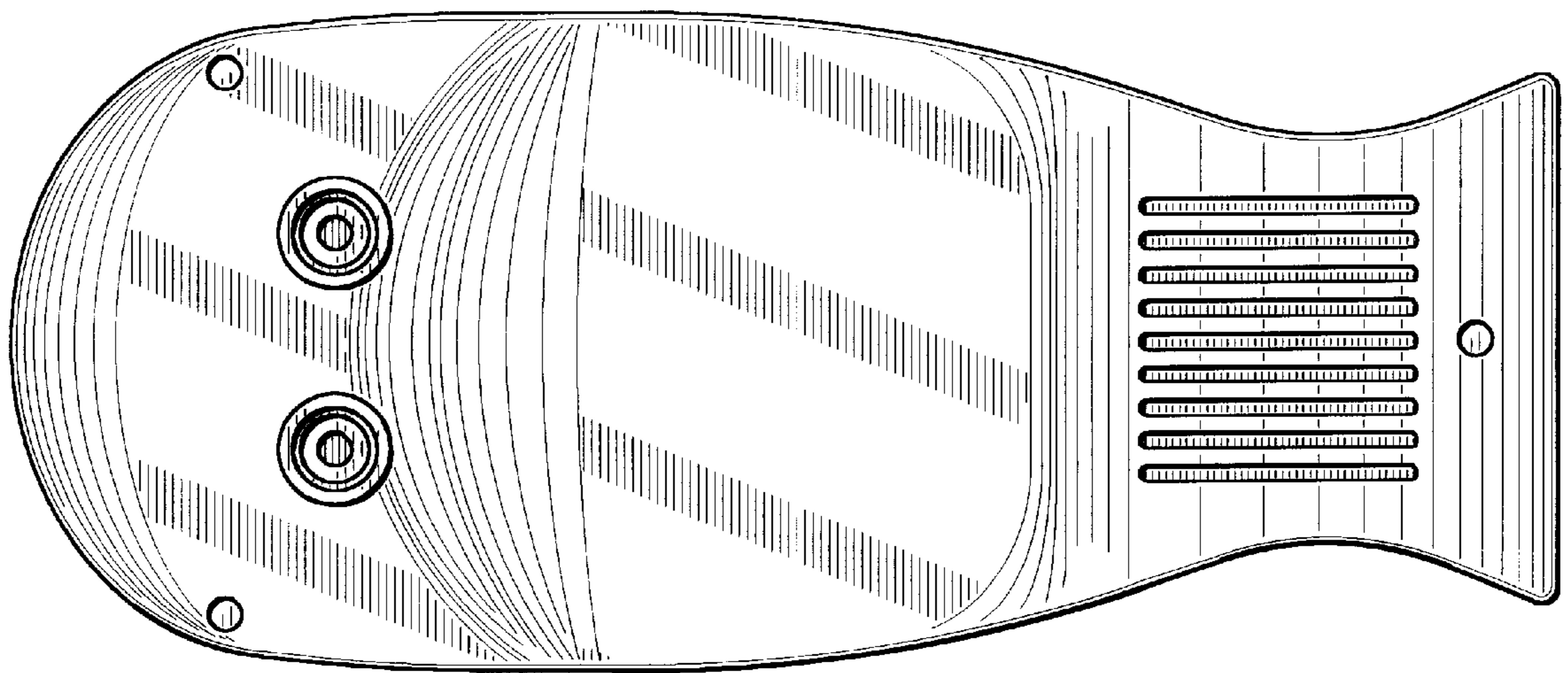

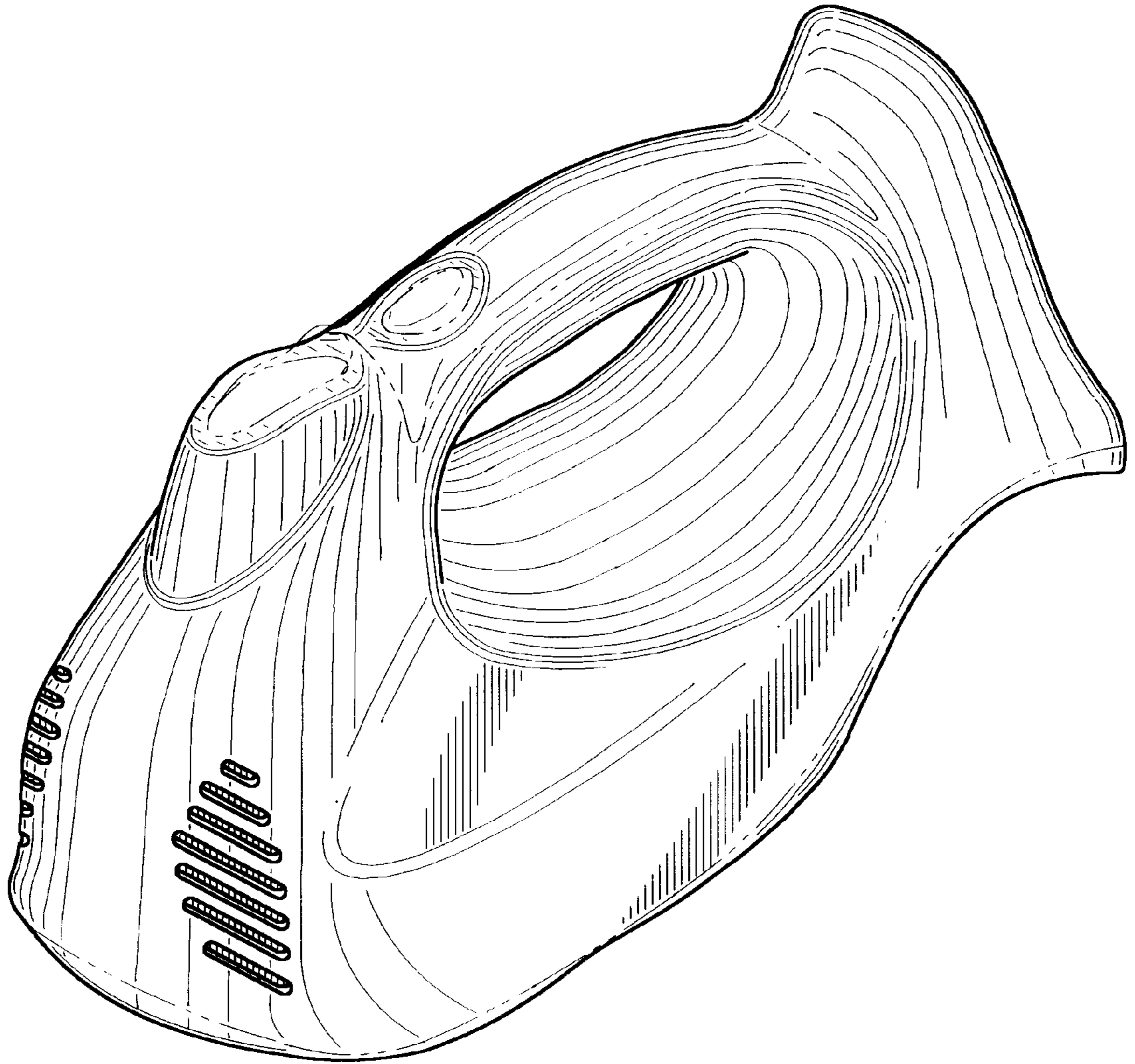

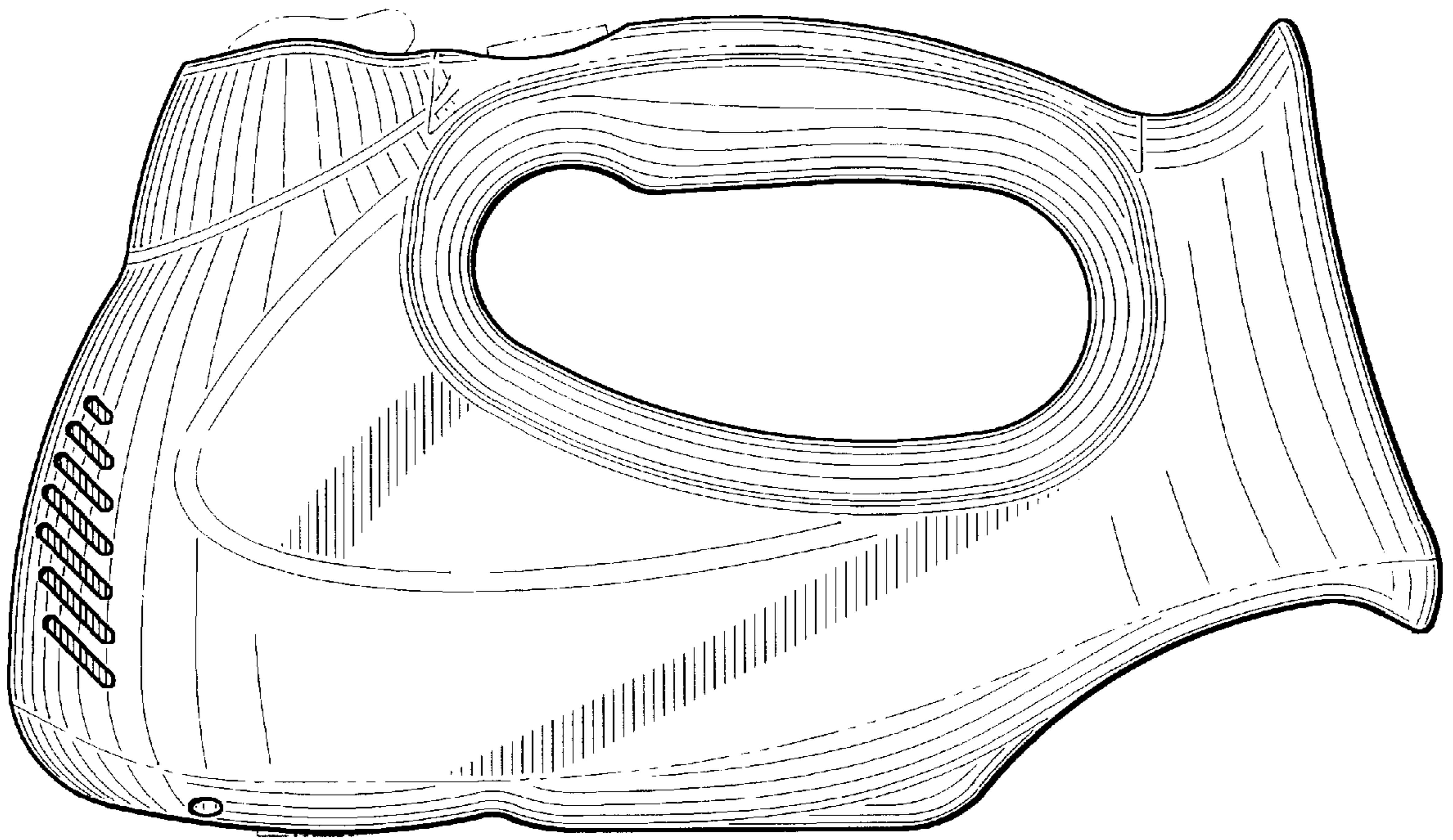

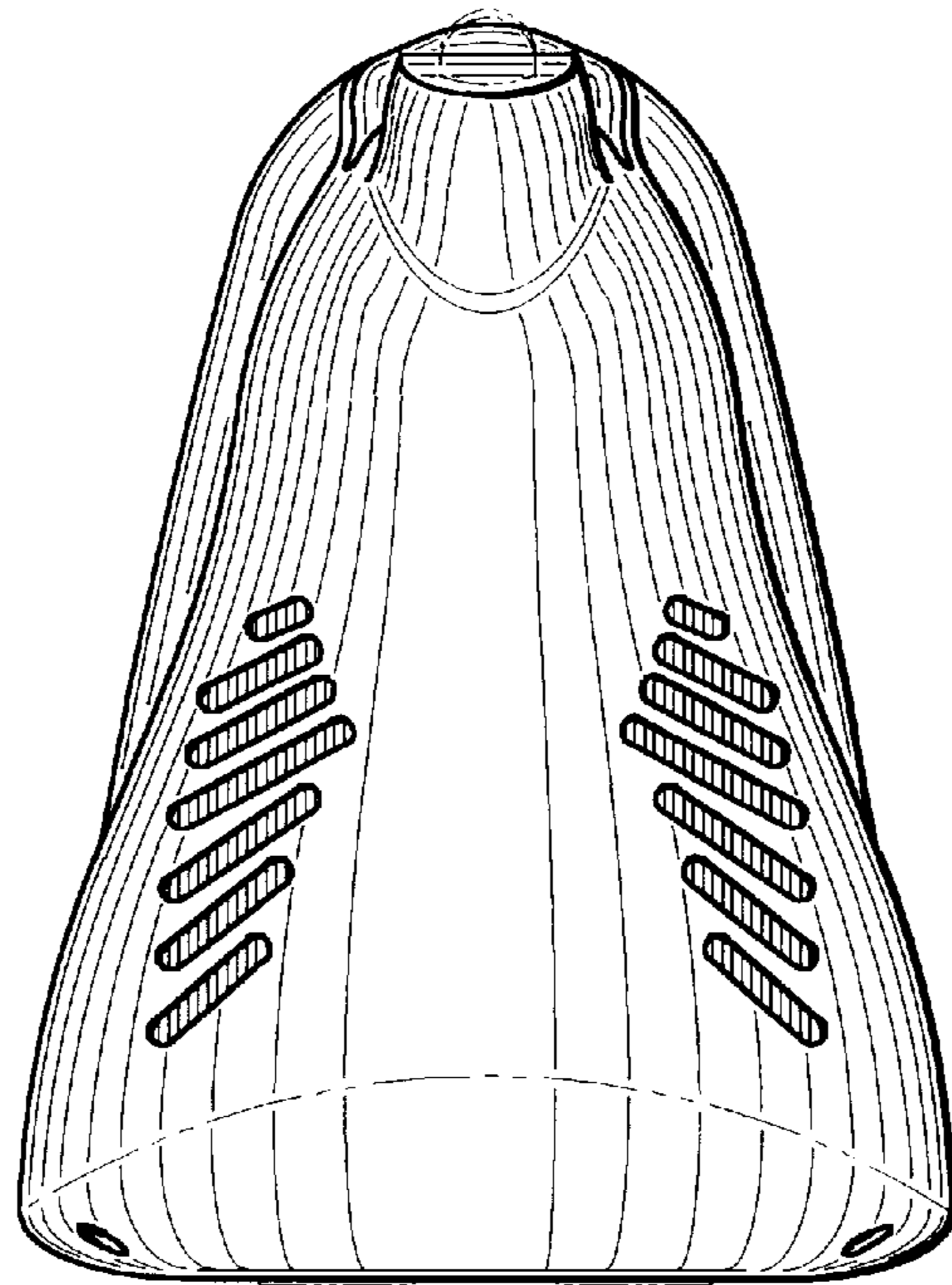

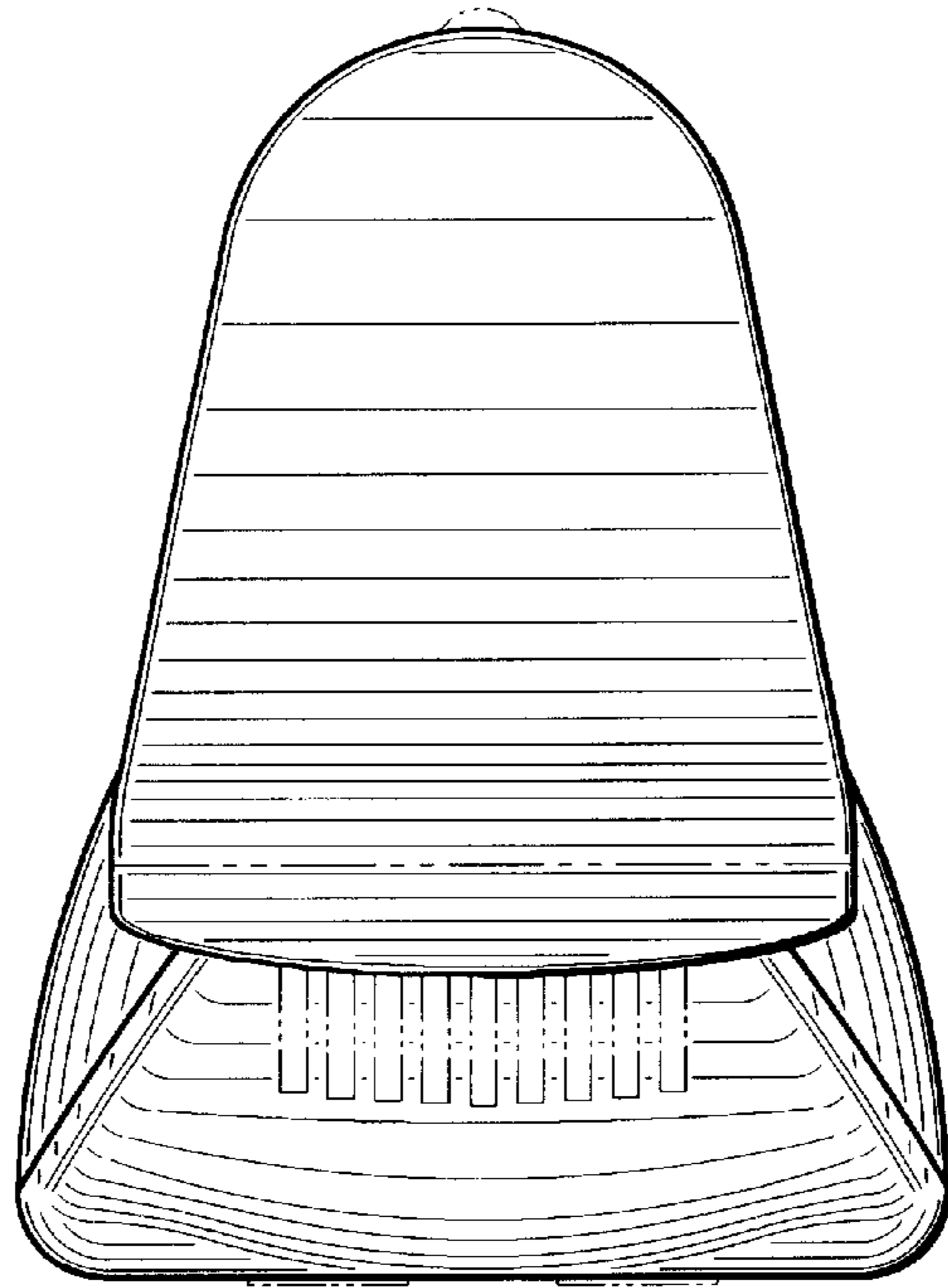

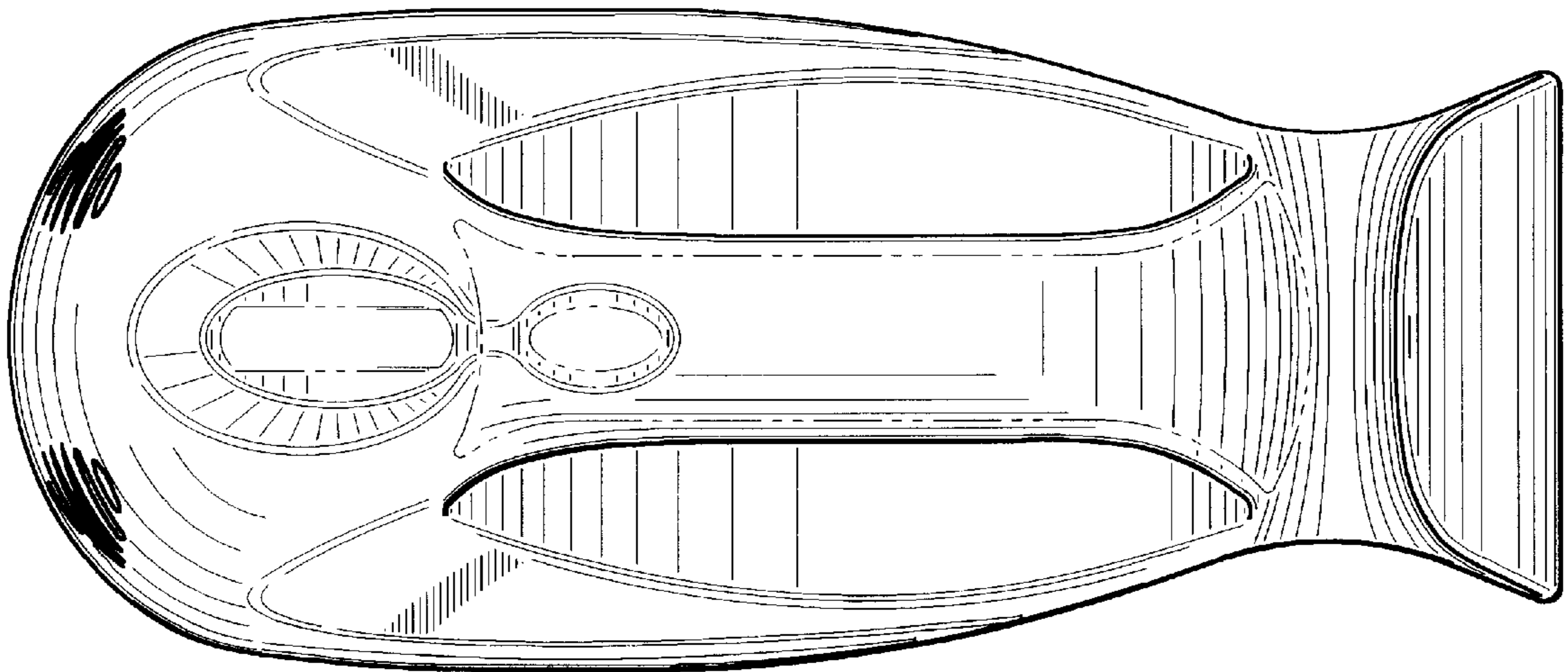

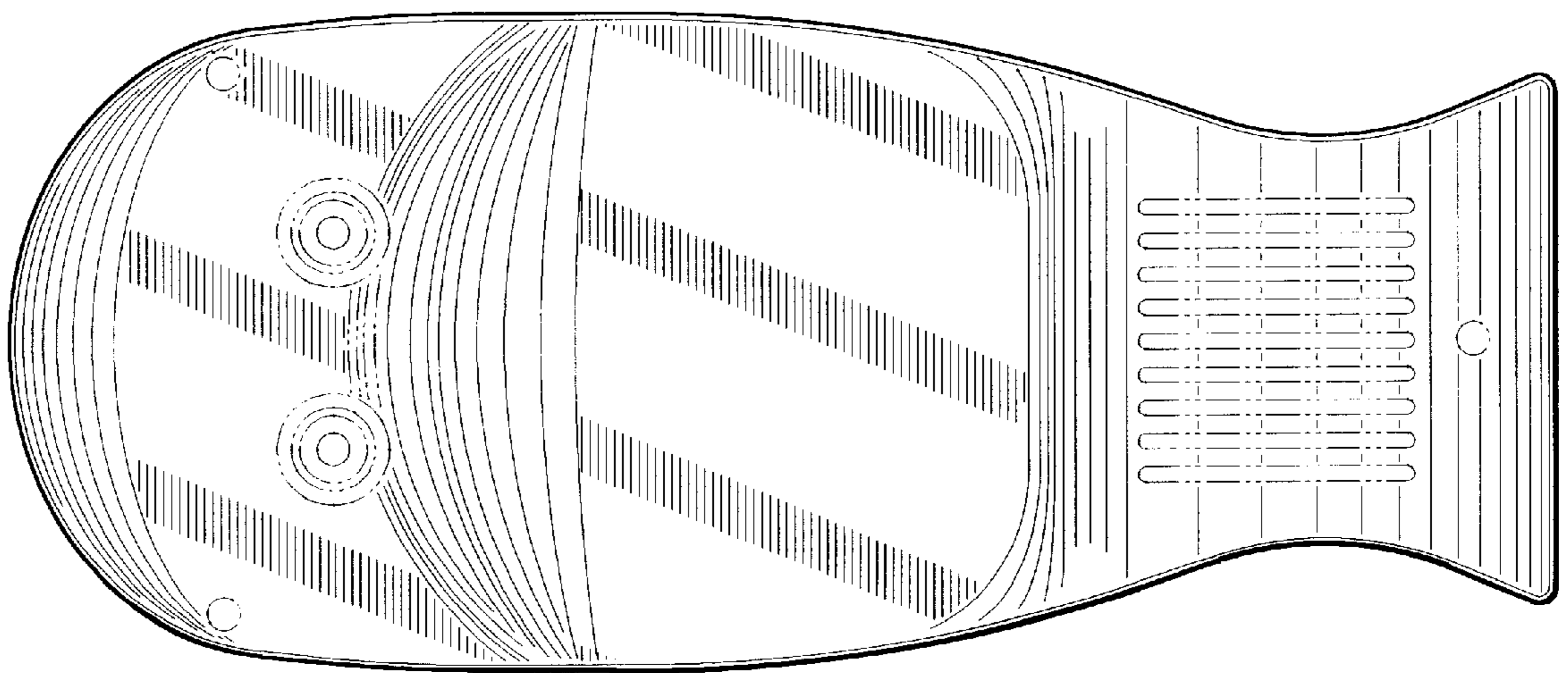
