[57] CLAIM

The ornamental design for a navigation interface for the display screen of an electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a navigation interface for the display screen of an electronic device;

FIG. 2 is a front view thereof;

FIG. 3 is a front view of a second embodiment thereof, on an enlarged scale, the input keys are shown separately for clarity of illustration;

FIG. 9 is a front view of an eighth embodiment thereof;

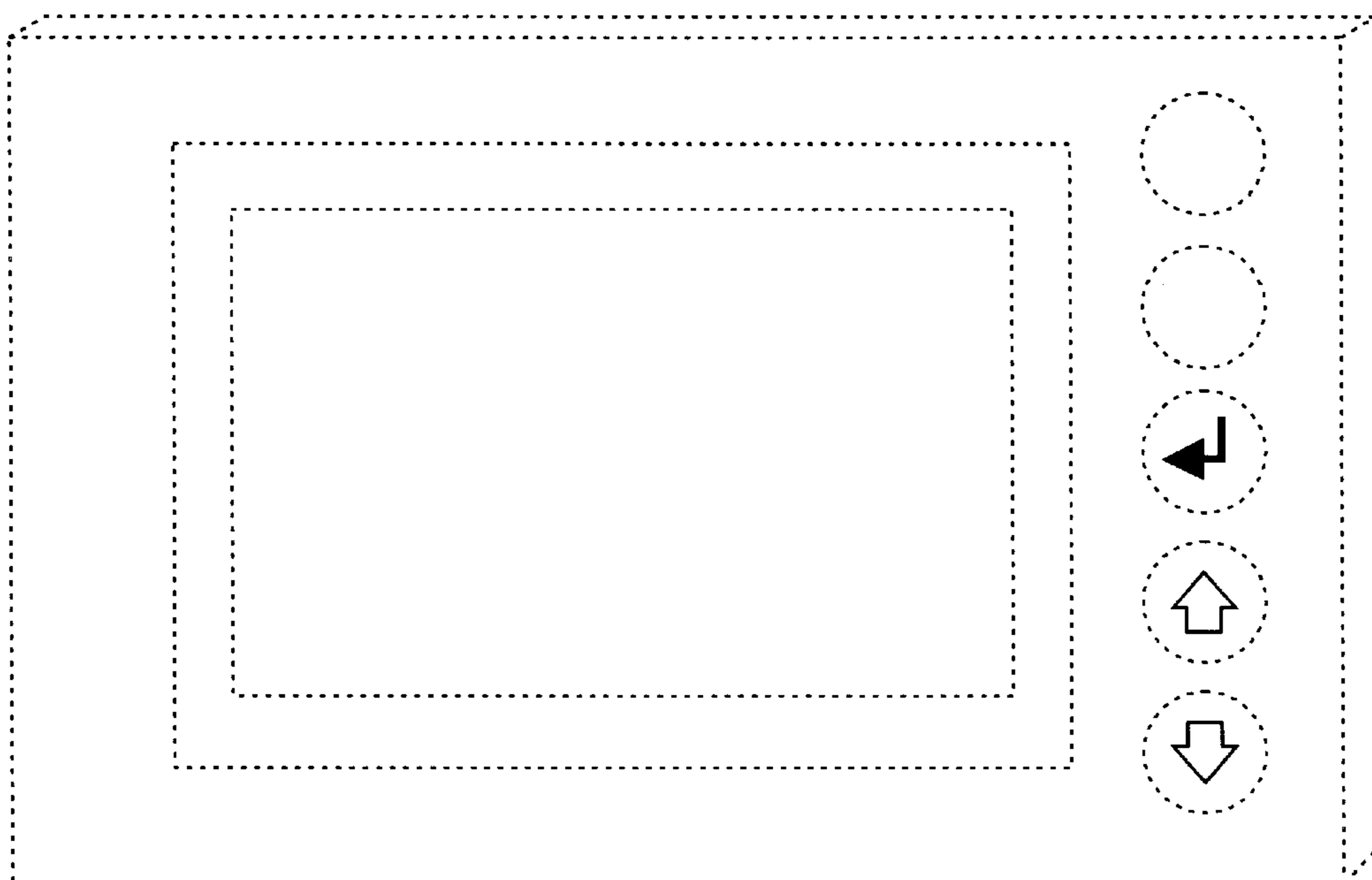
FIG. 10 is a front view of a ninth embodiment thereof;

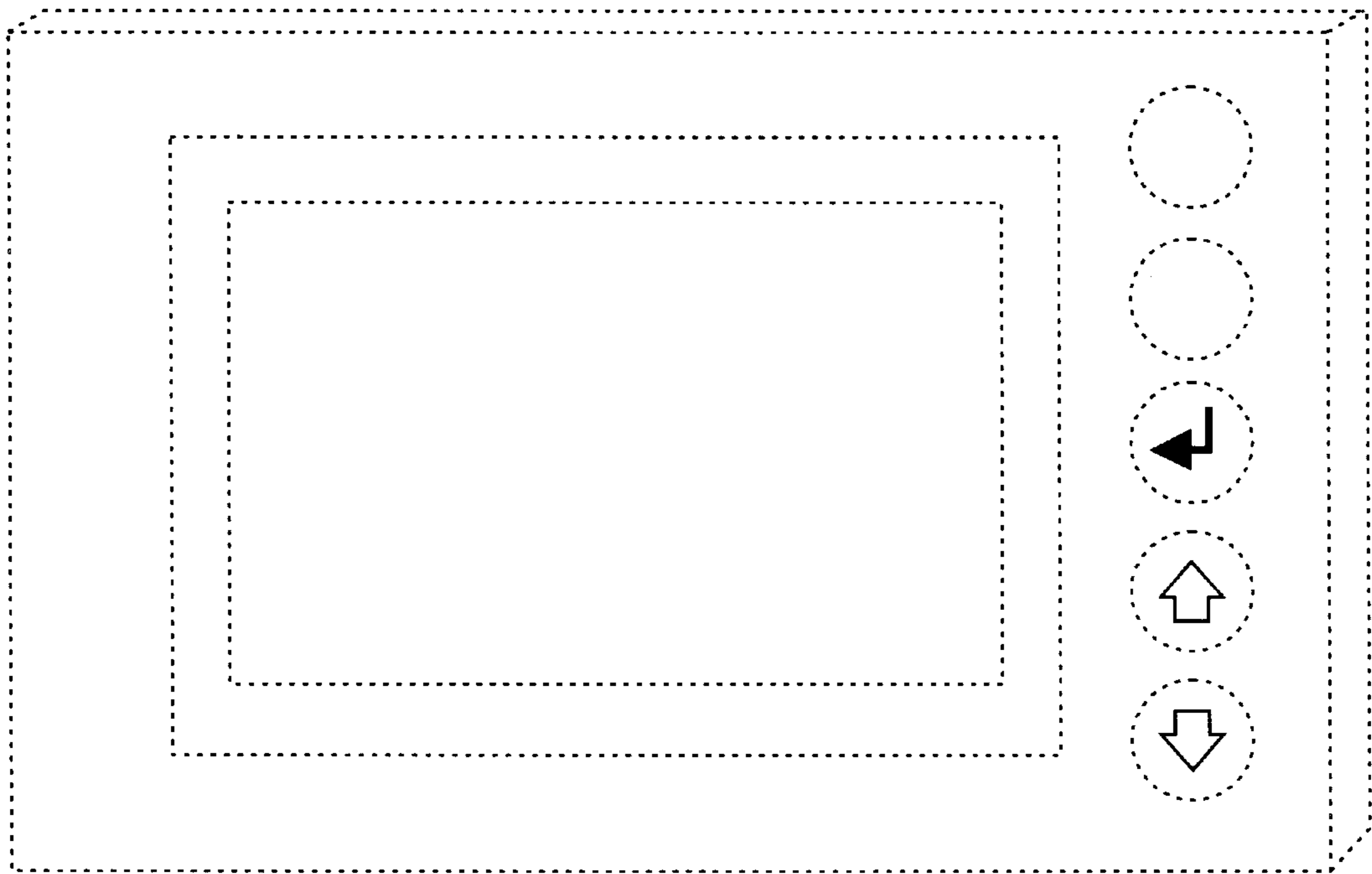

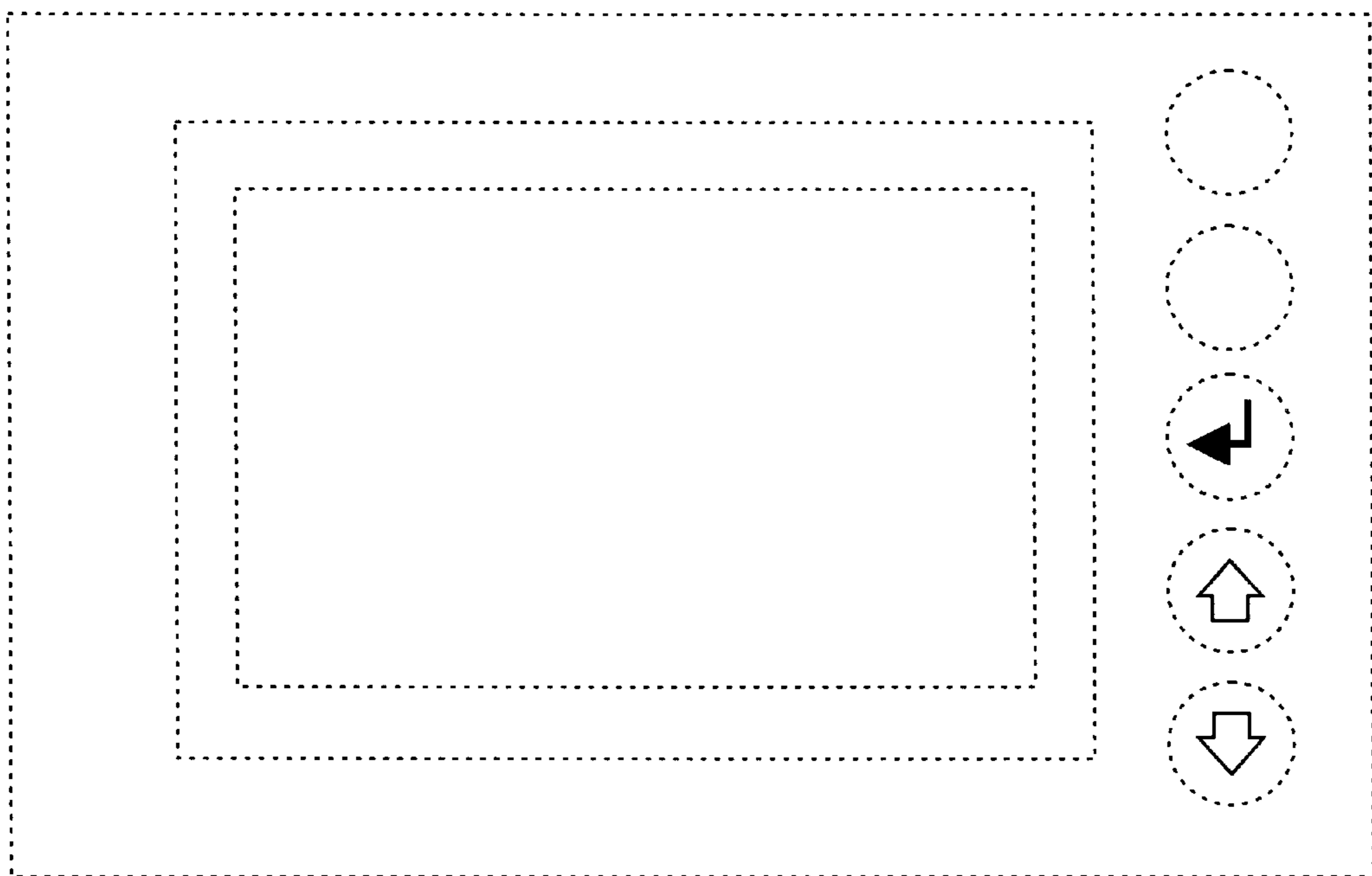

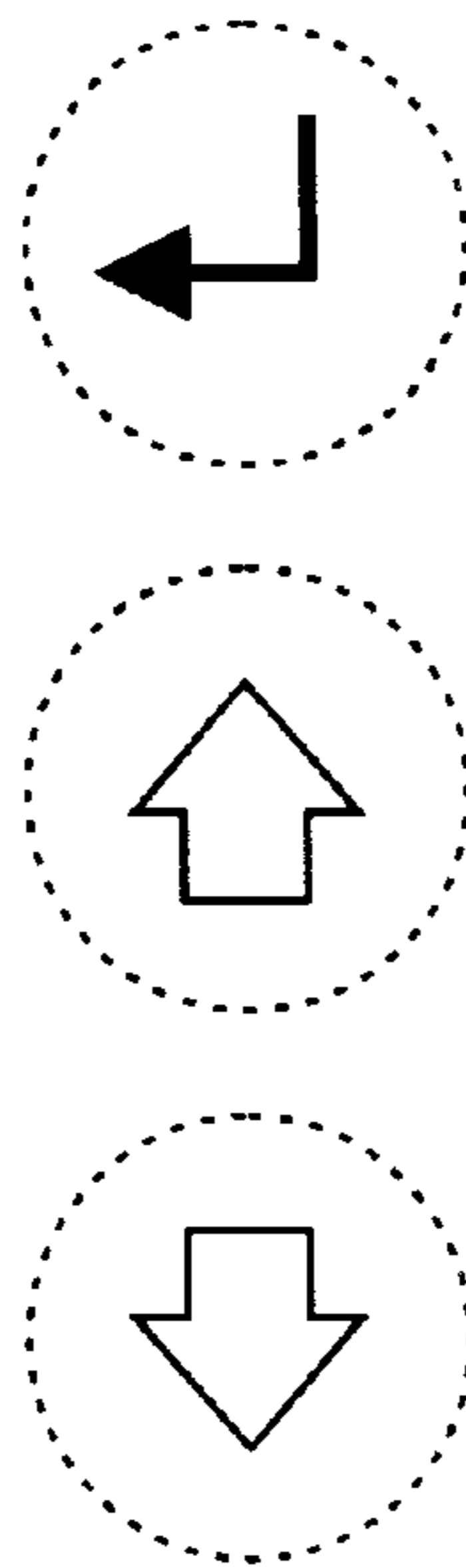

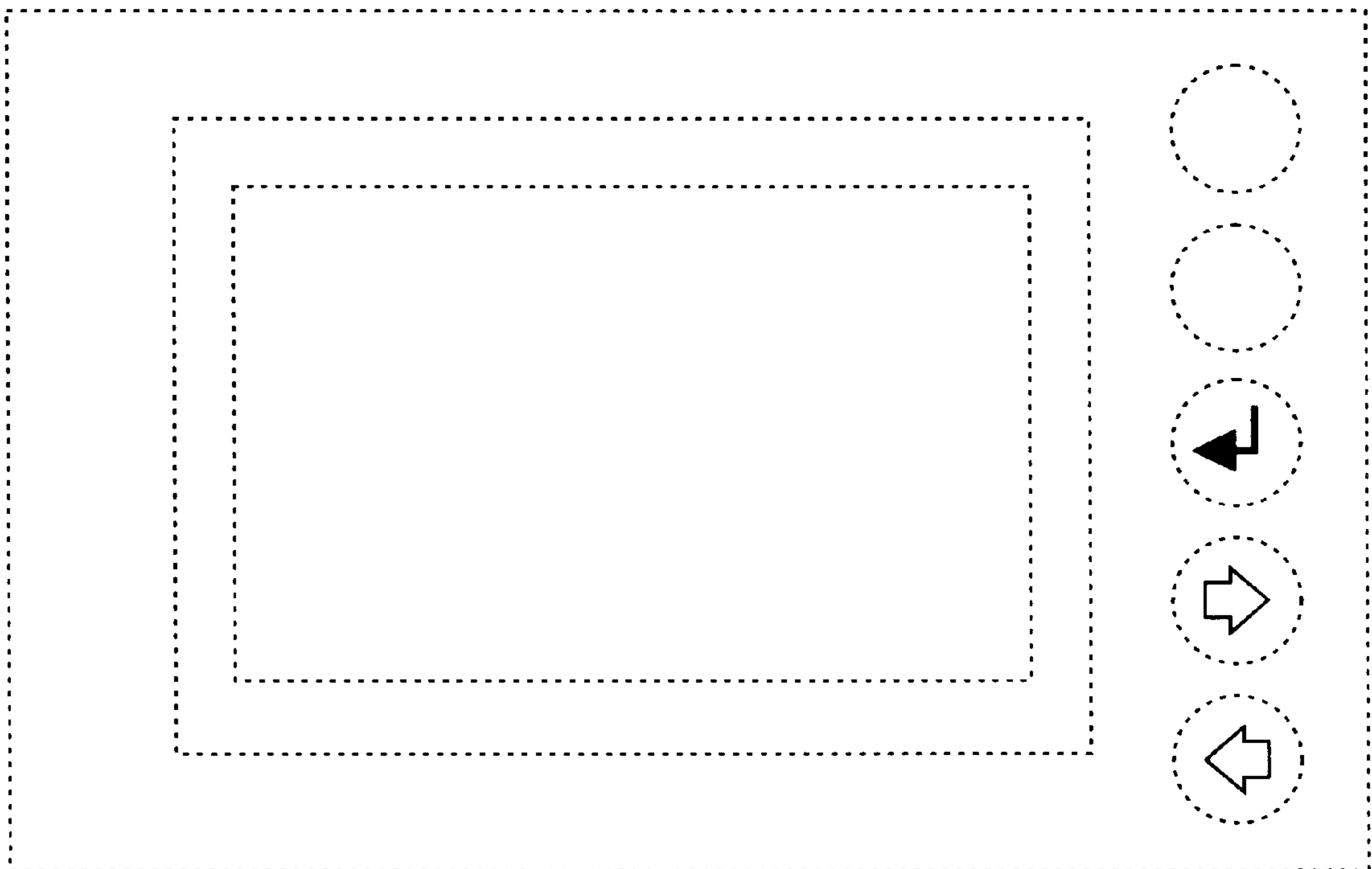

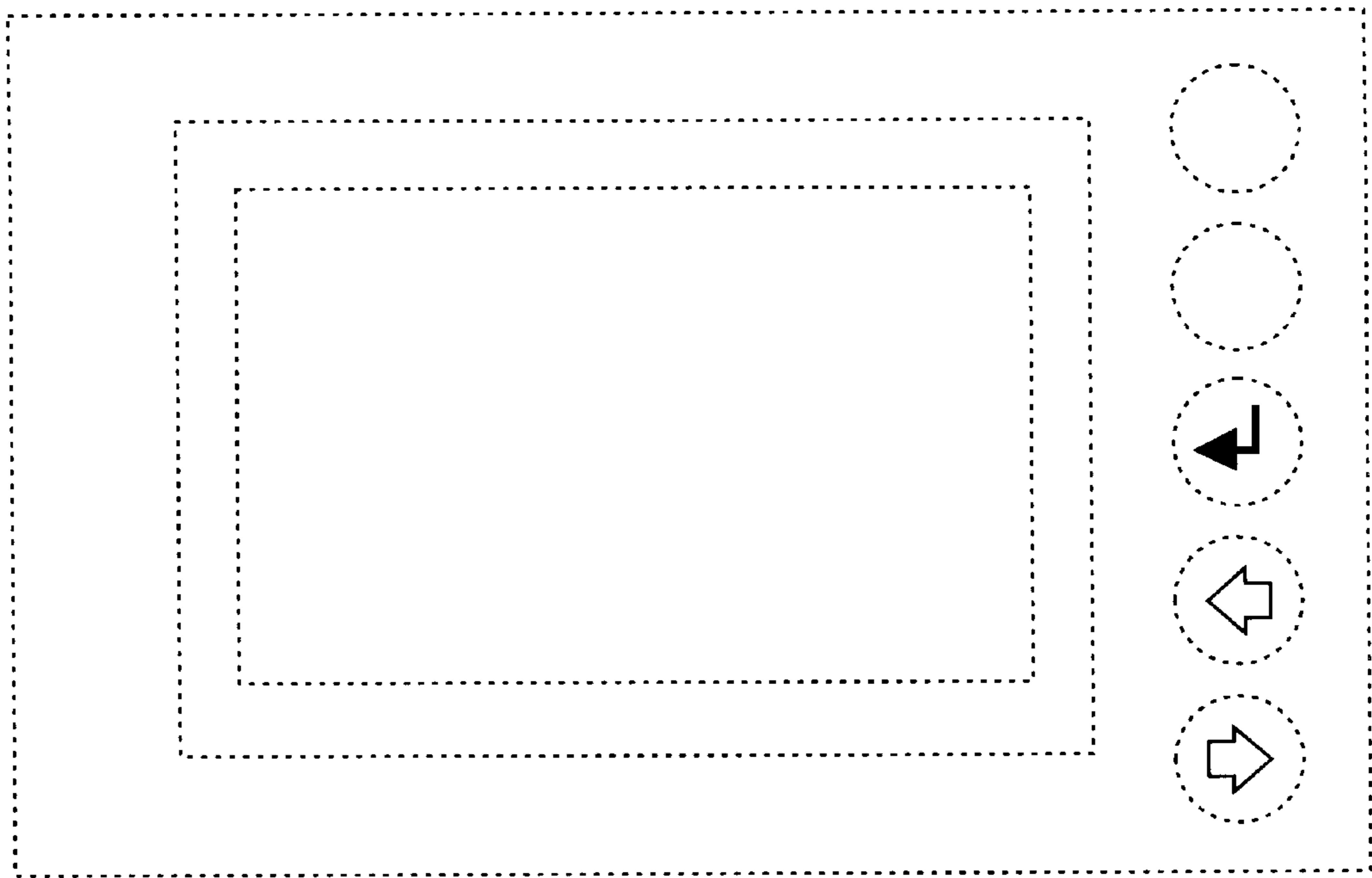

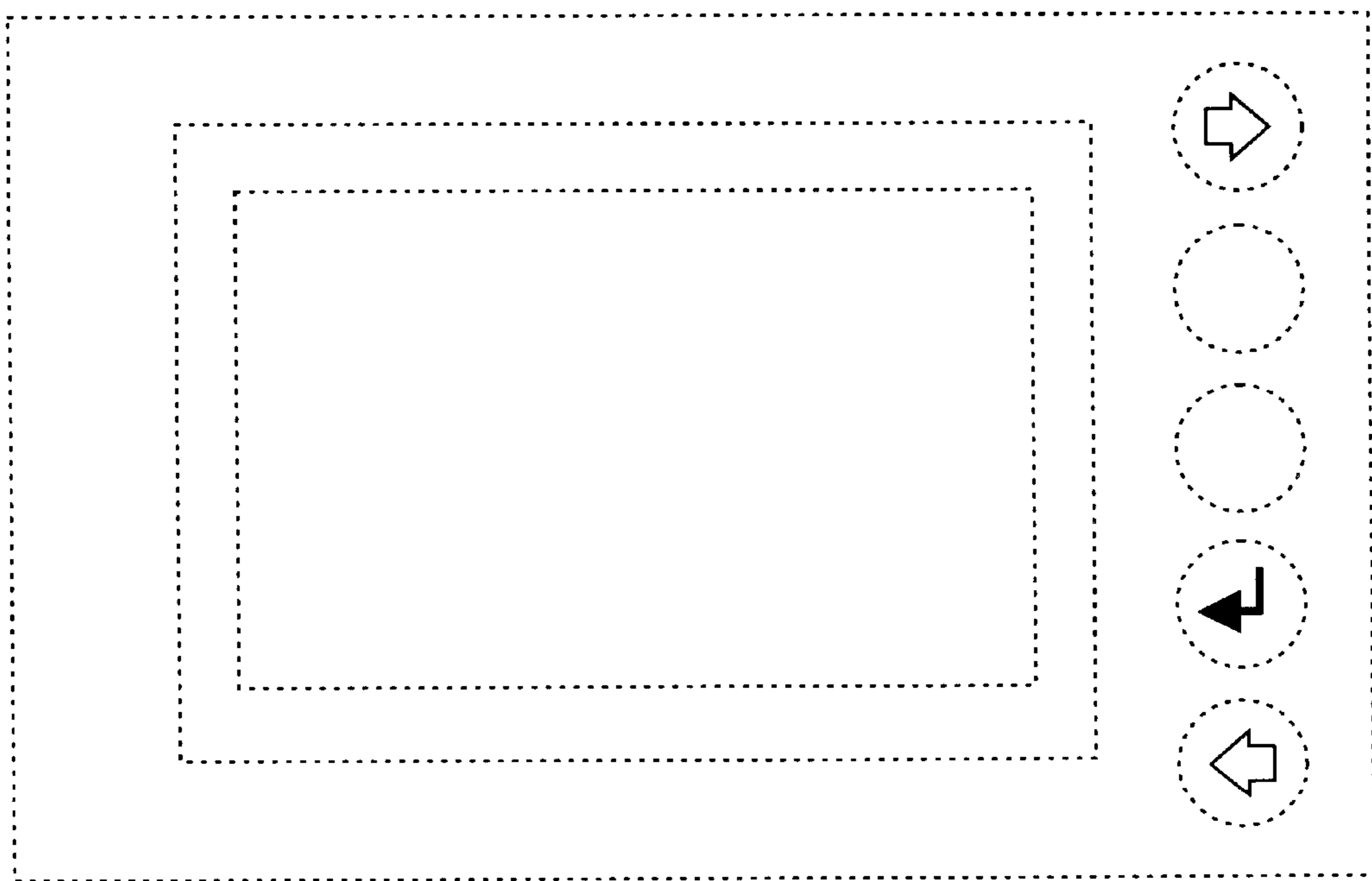

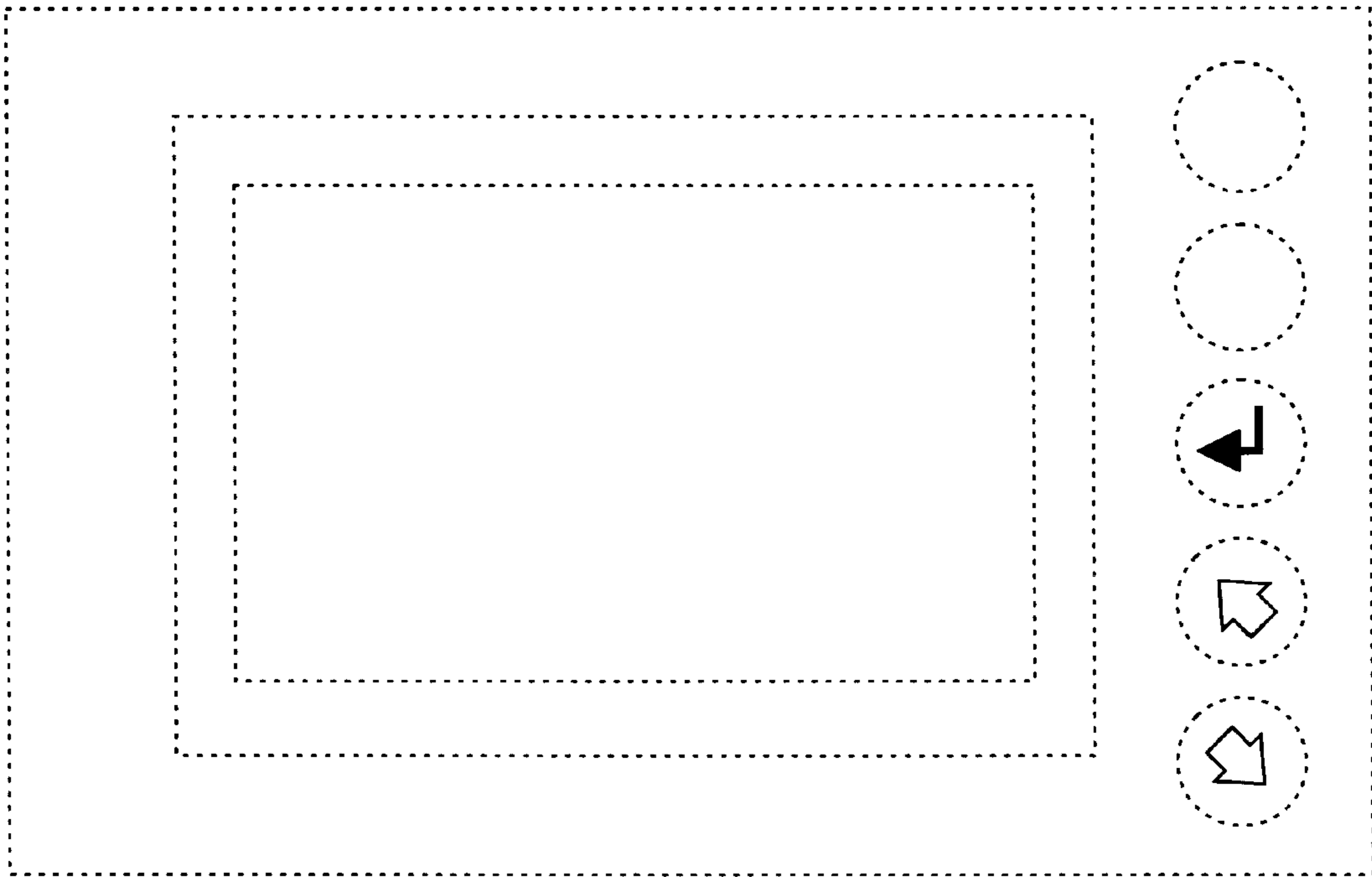

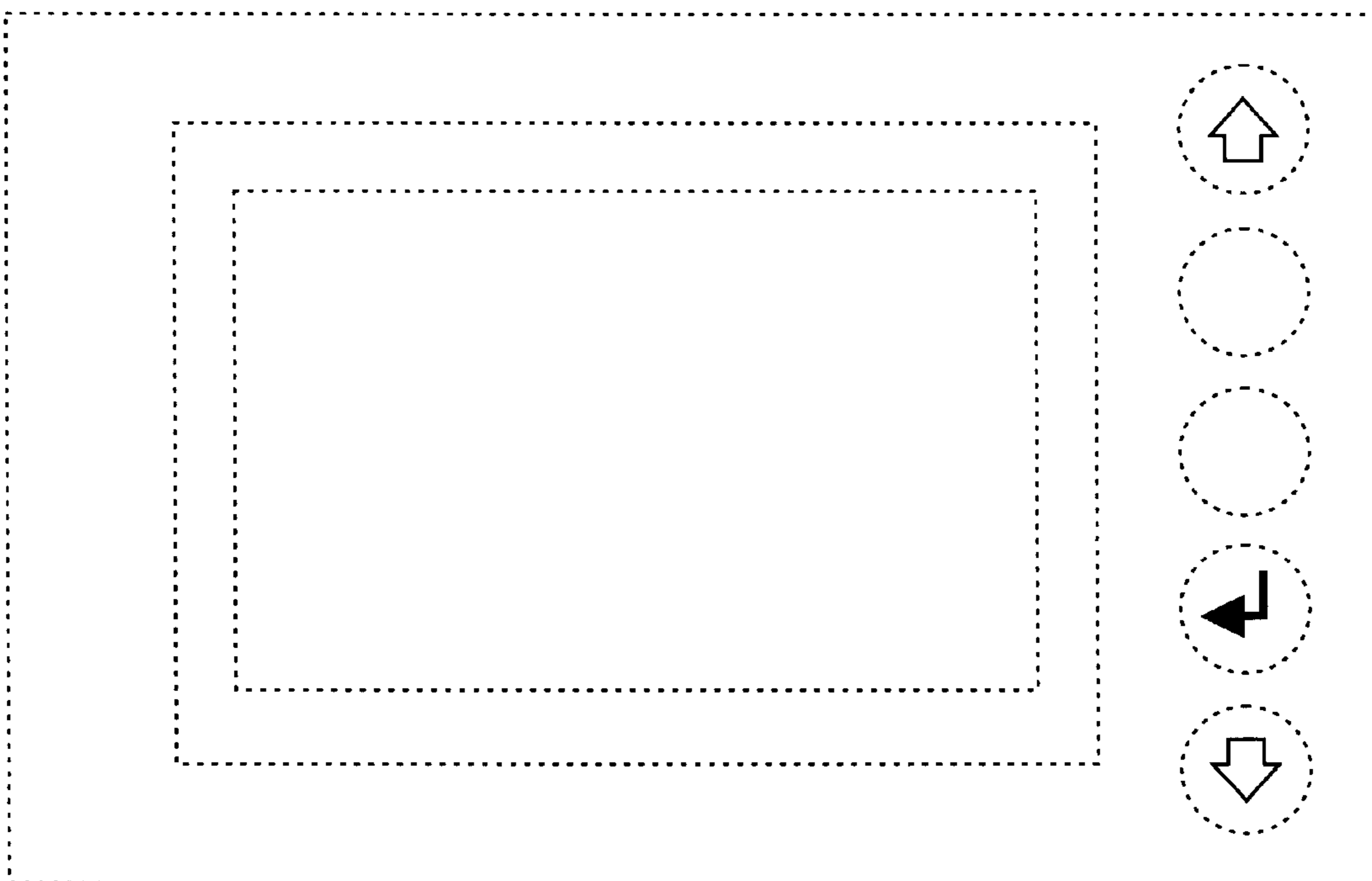

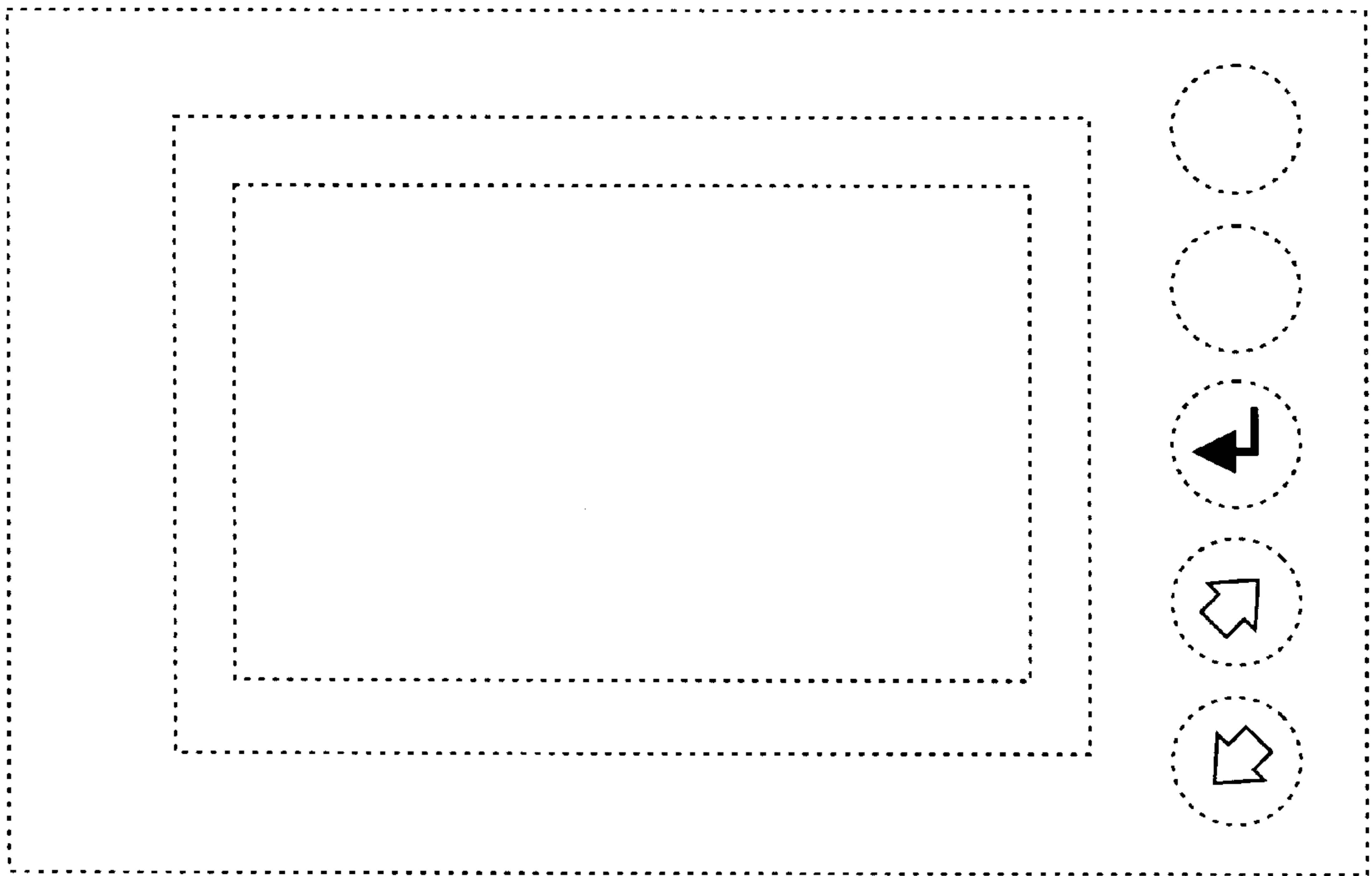

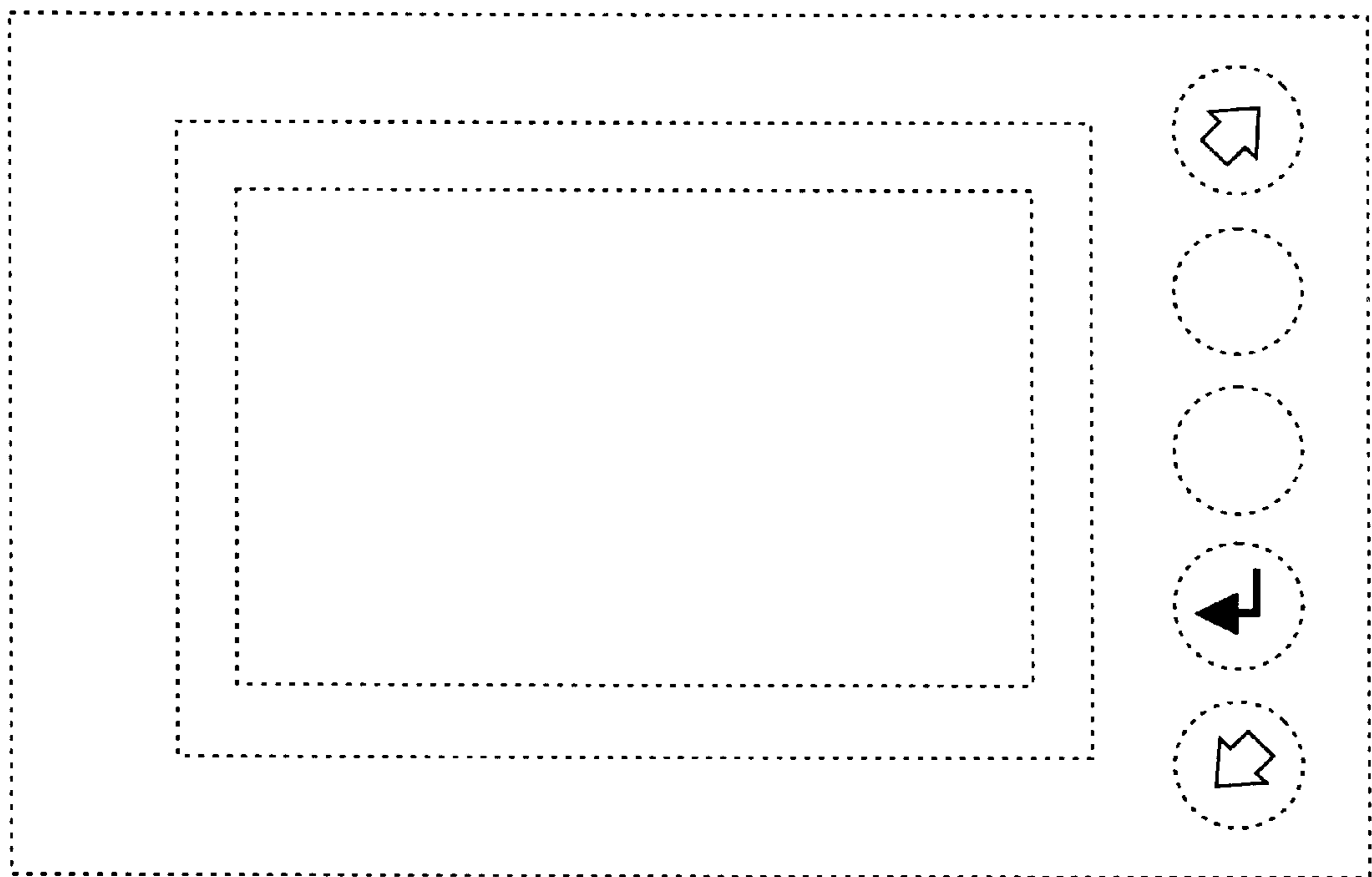

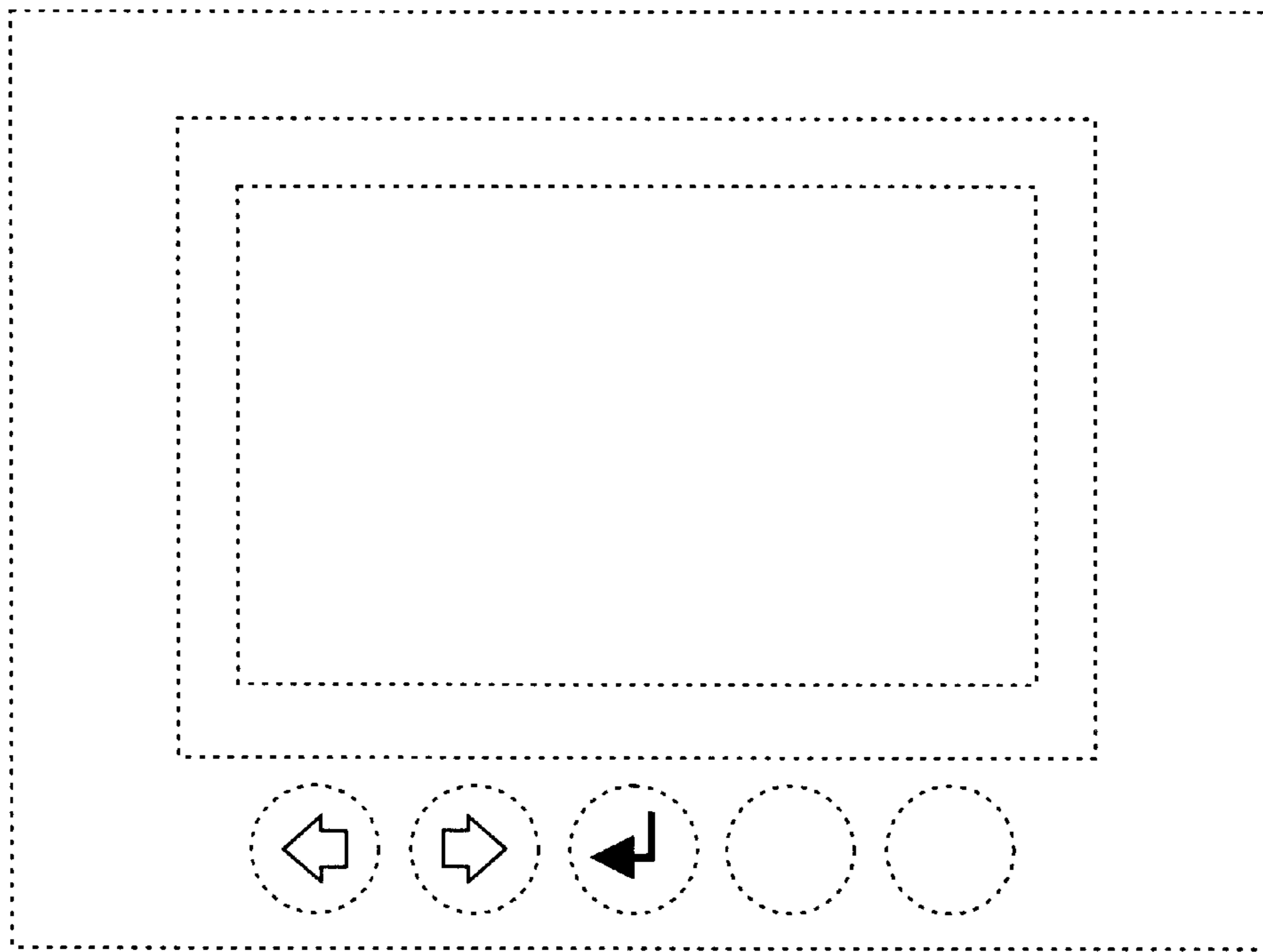

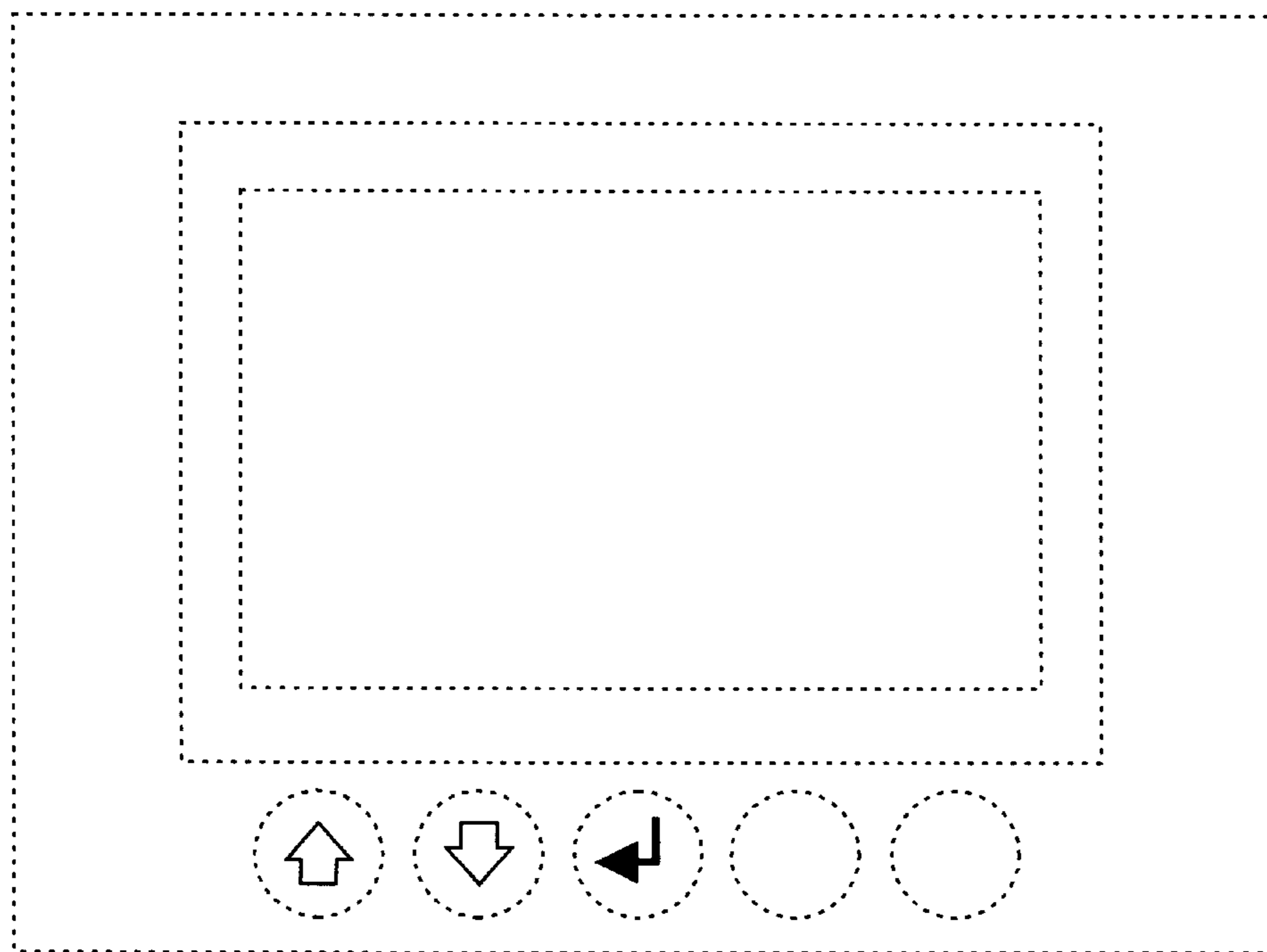
