[57] **CLAIM**

The ornamental design for a combined knife and flashlight, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front and side perspective view of a combined knife with flashlight, showing my new design; FIG. 2 is a left side view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front view thereof; and, FIG. 7 is a back end view thereof.

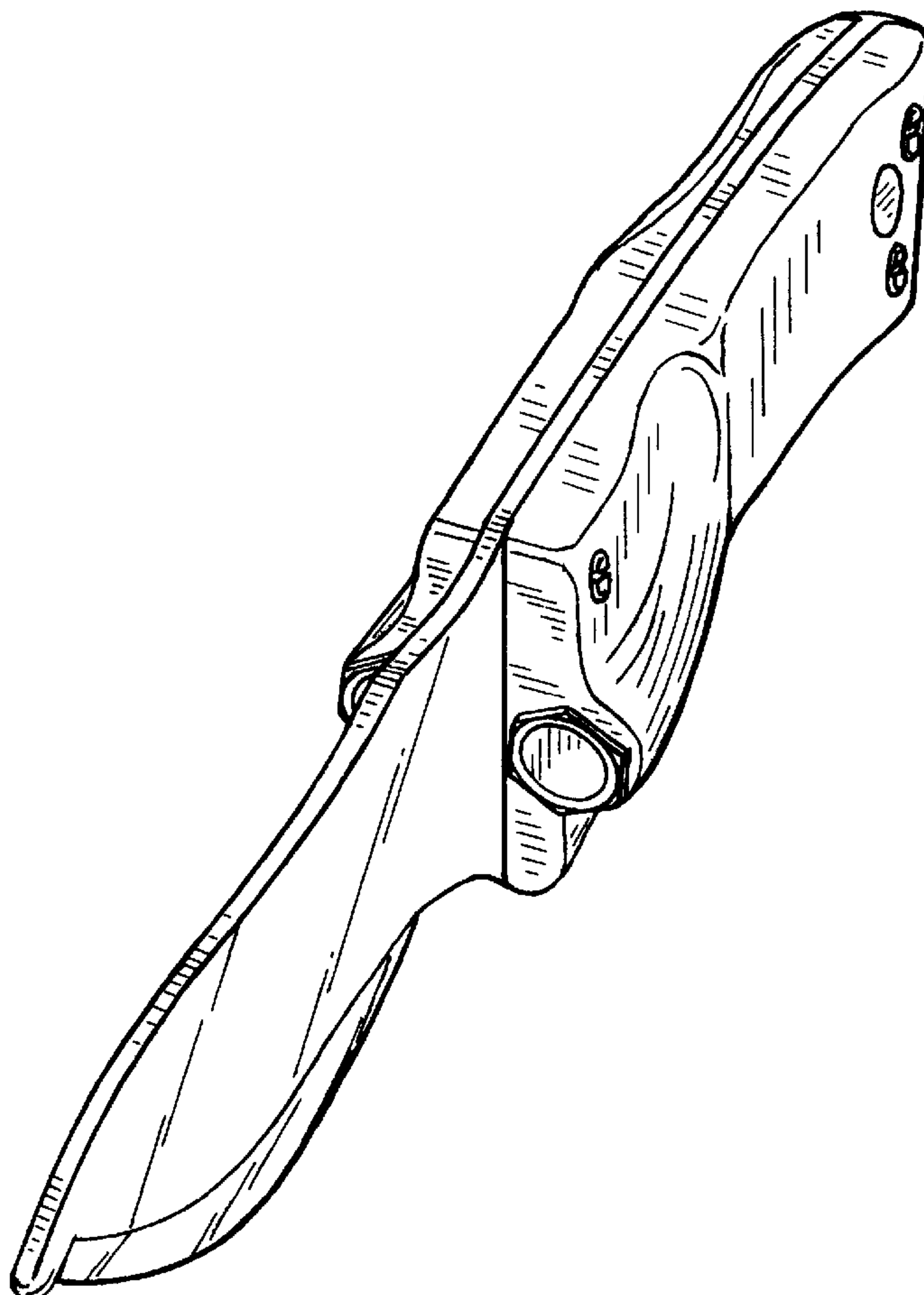

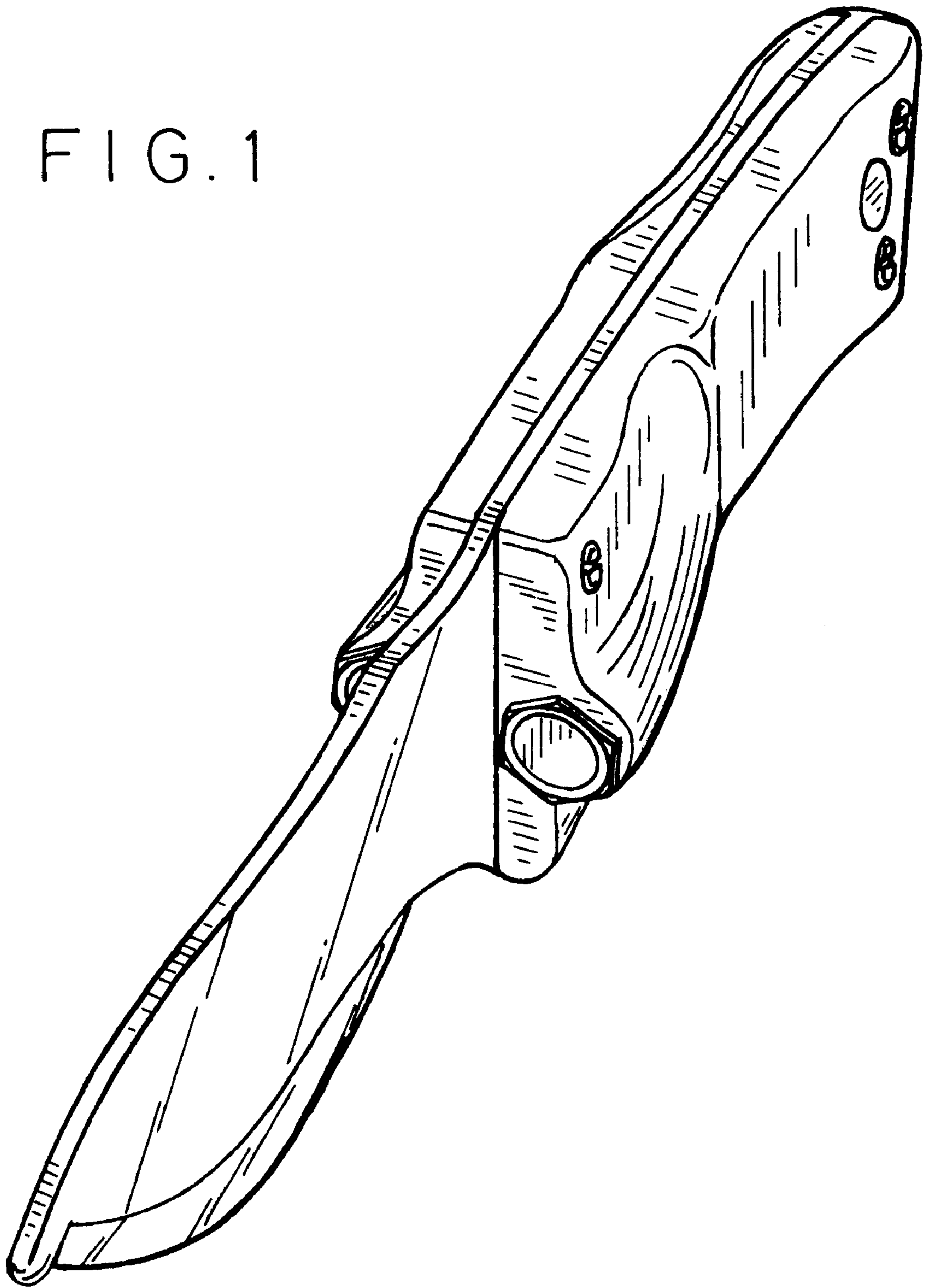

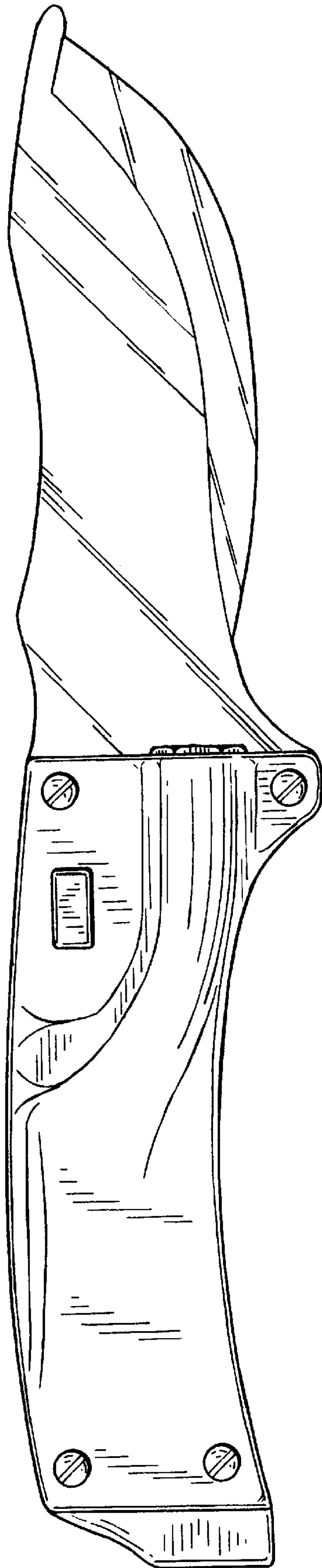

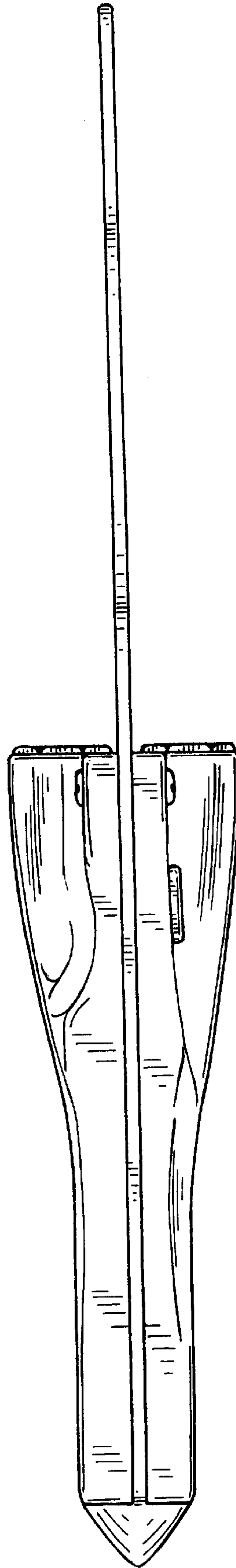

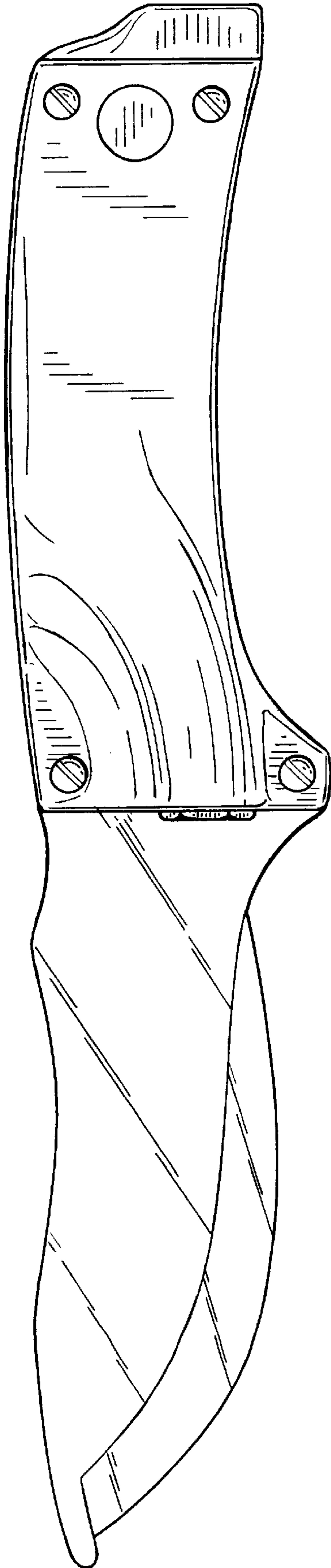
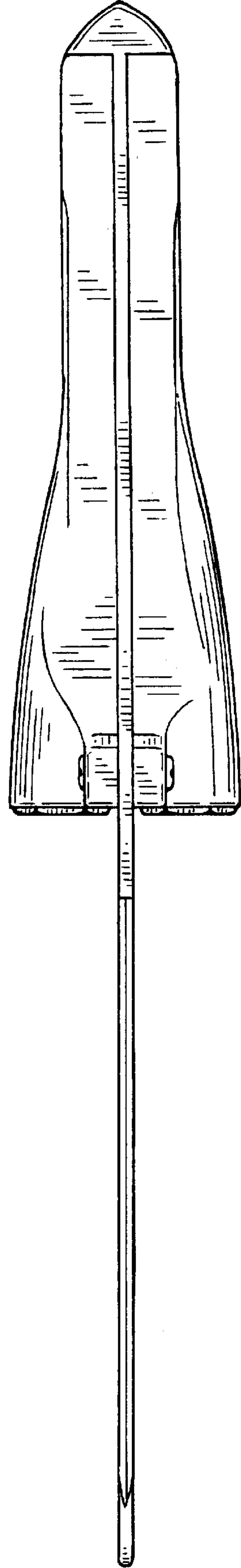

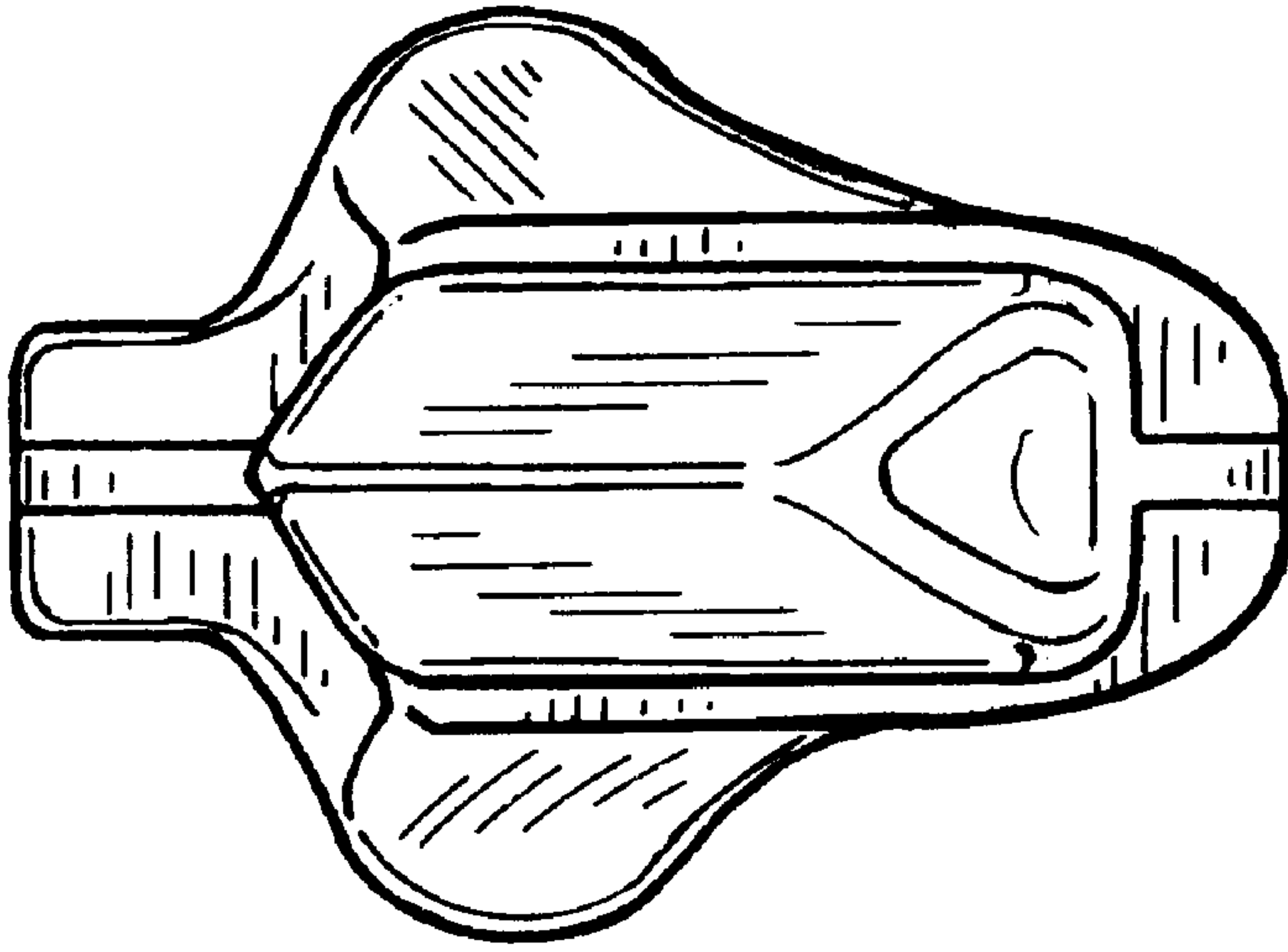

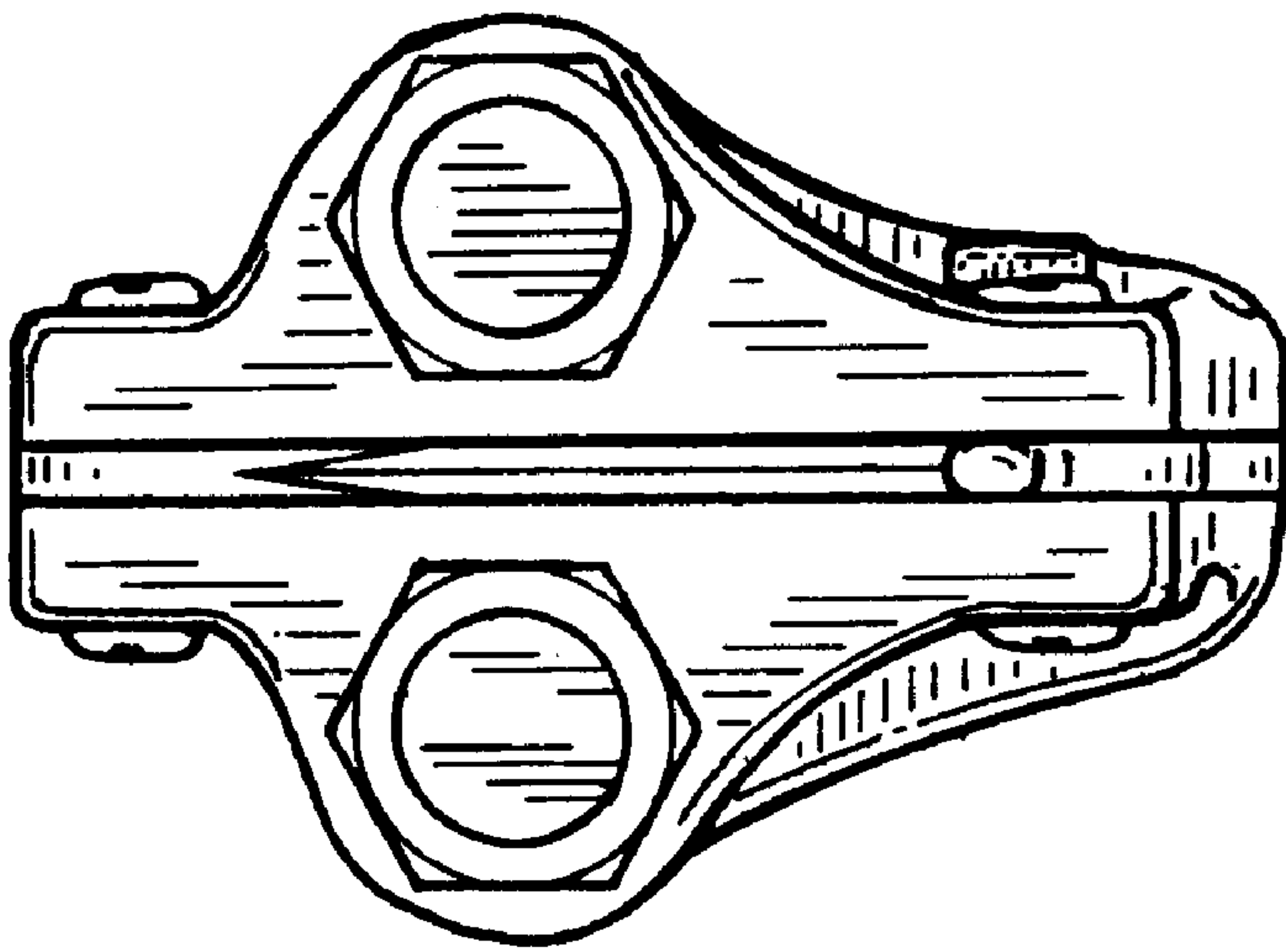
