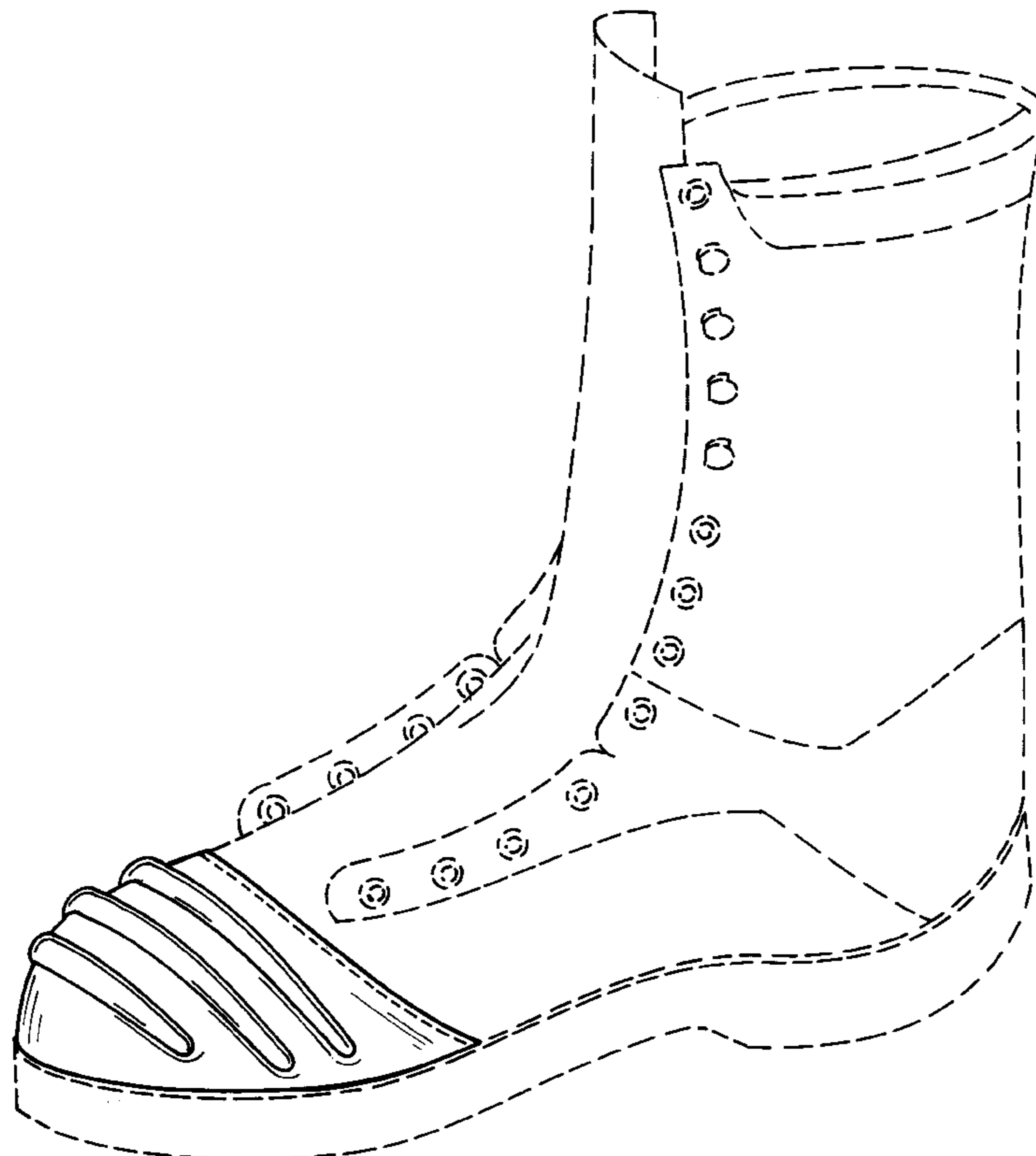
[57] **CLAIM**

The ornamental design for a shoe toe protector, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe toe protector, showing my new design;  
FIG. 2 is a right side elevational view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a front elevational view thereof; and,  
FIG. 5 is a top plan view thereof.  
The broken line shows the environment of the invention and is for illustrative purposes only and forms no part of the claimed design.  
The bottom of the shoe toe protector forms no part of the claimed design.

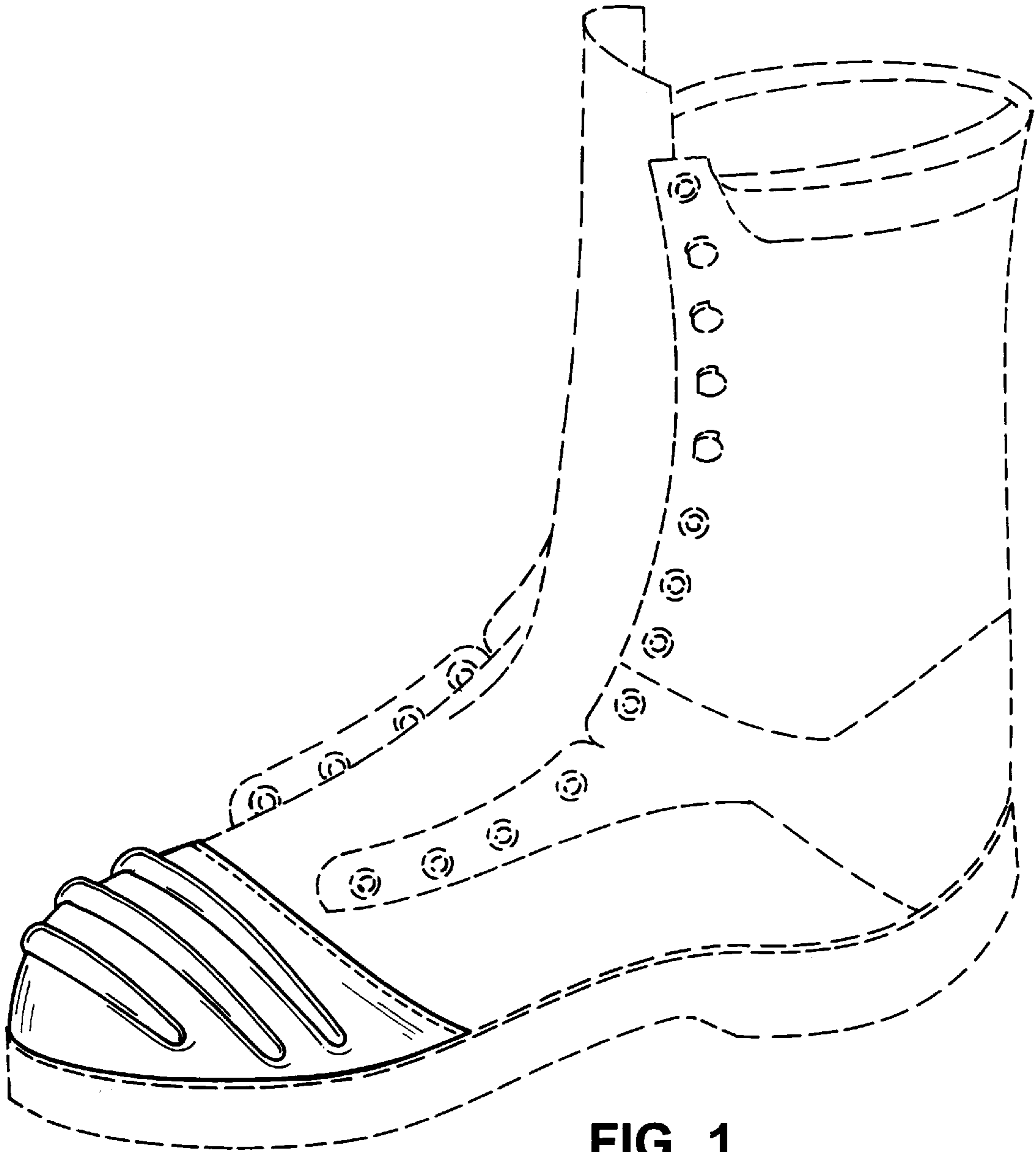

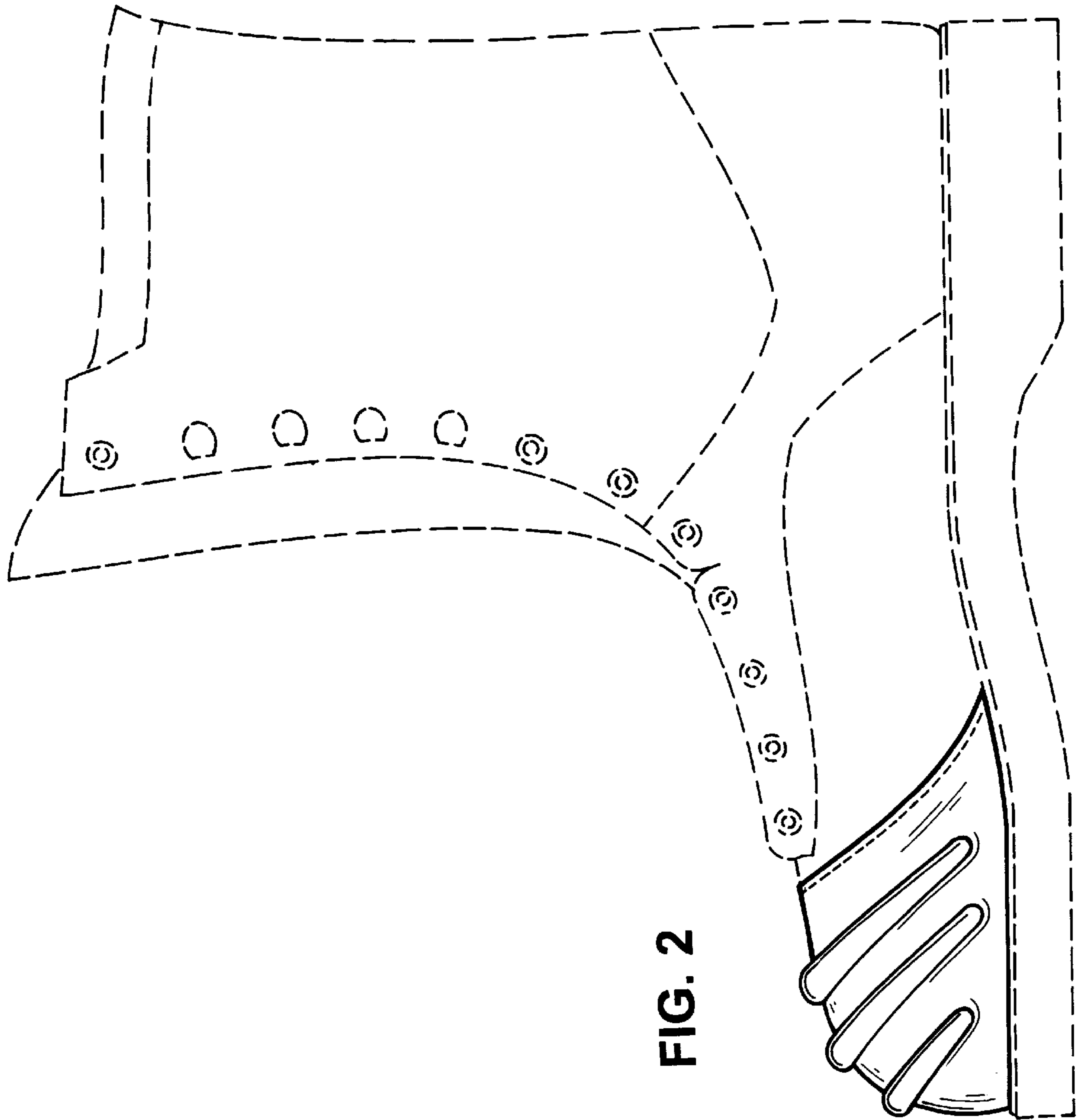

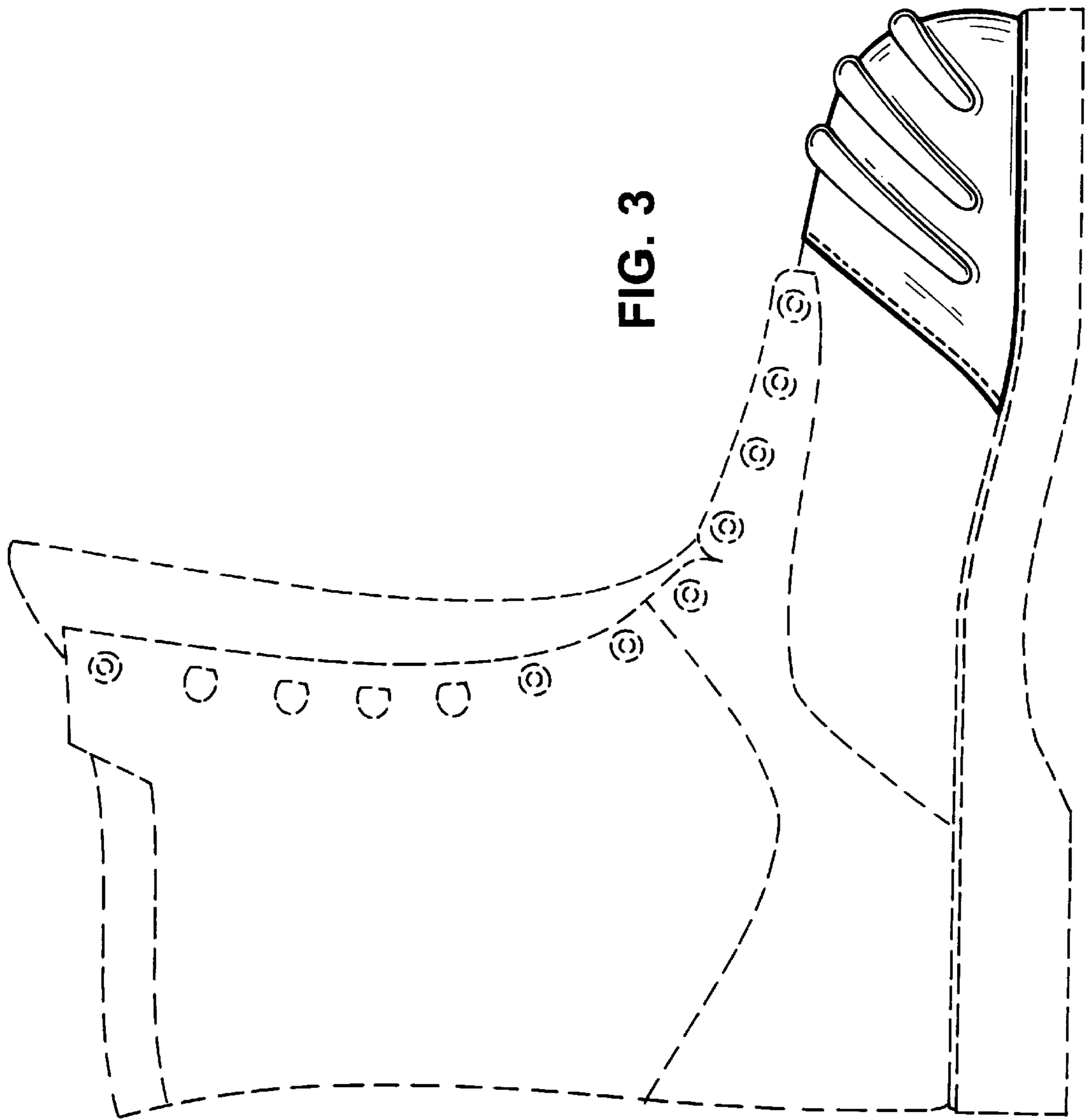

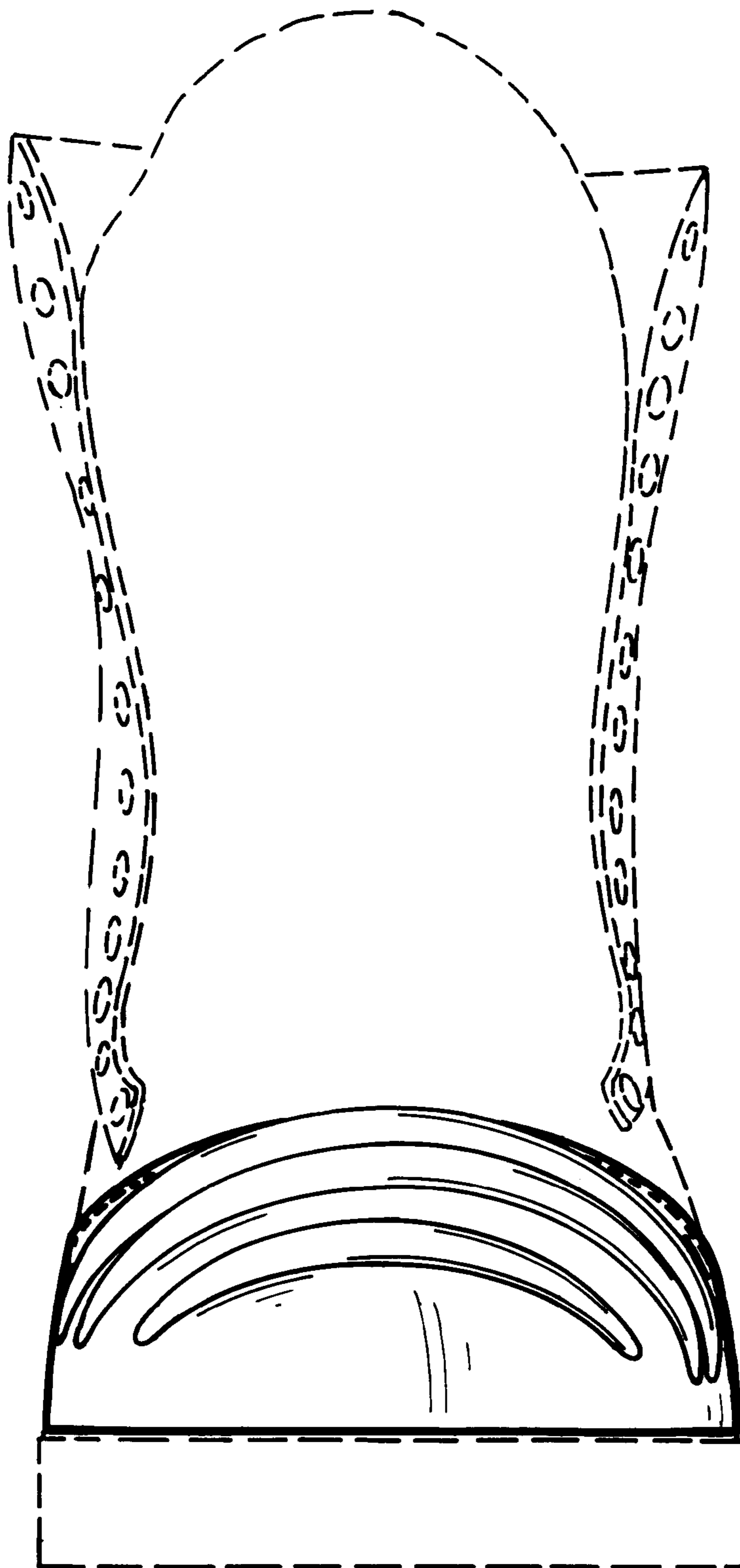

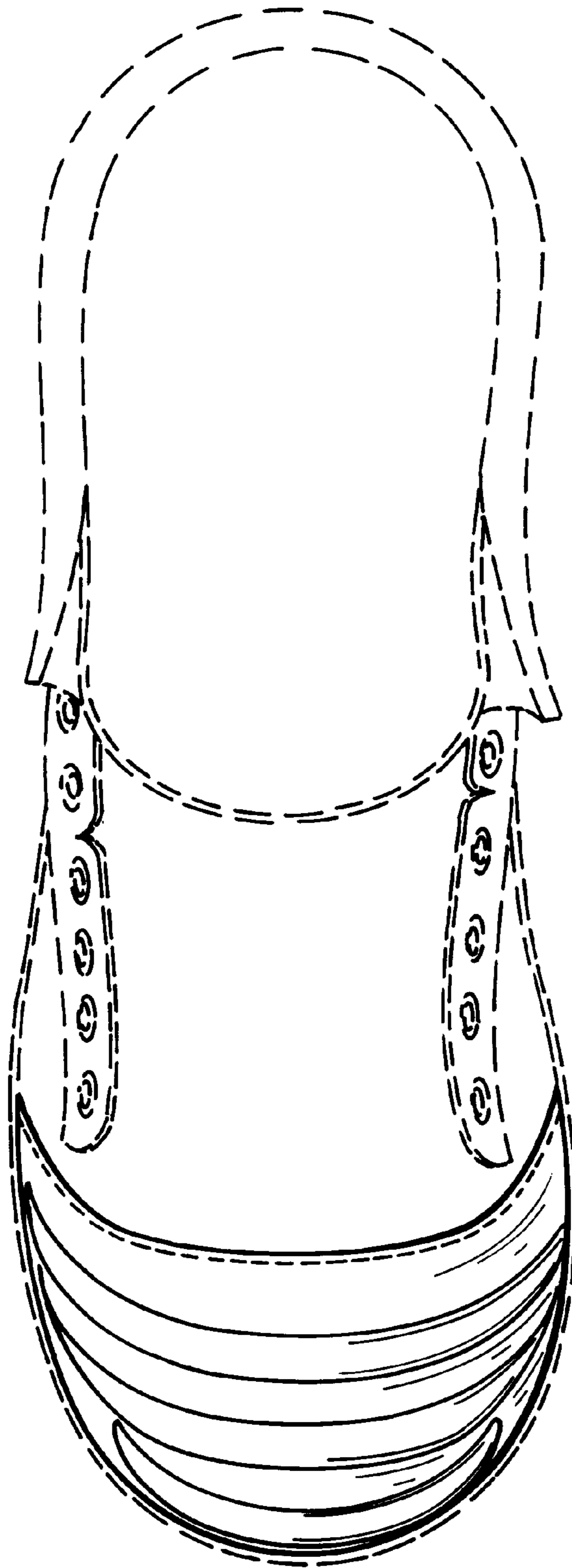
