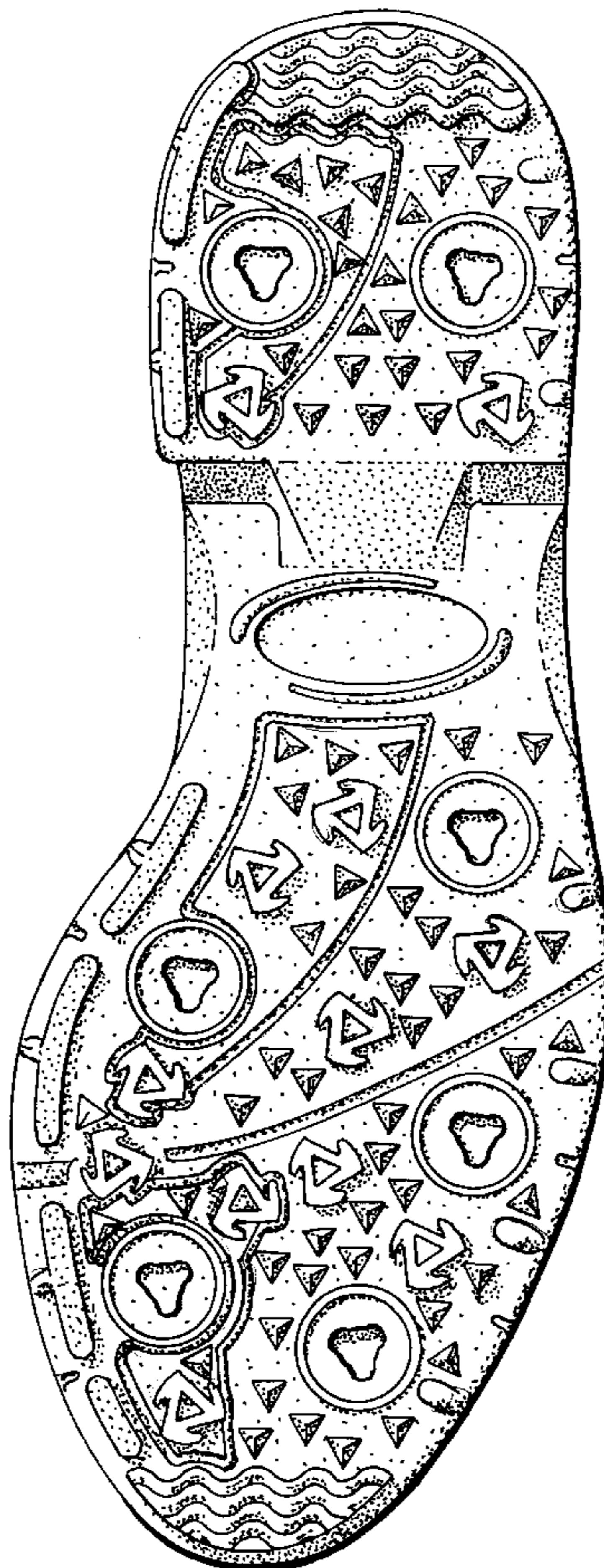
[57] **CLAIM**

The ornamental design for a outsole for a golf shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of an outsole for a golf shoe showing my new design;

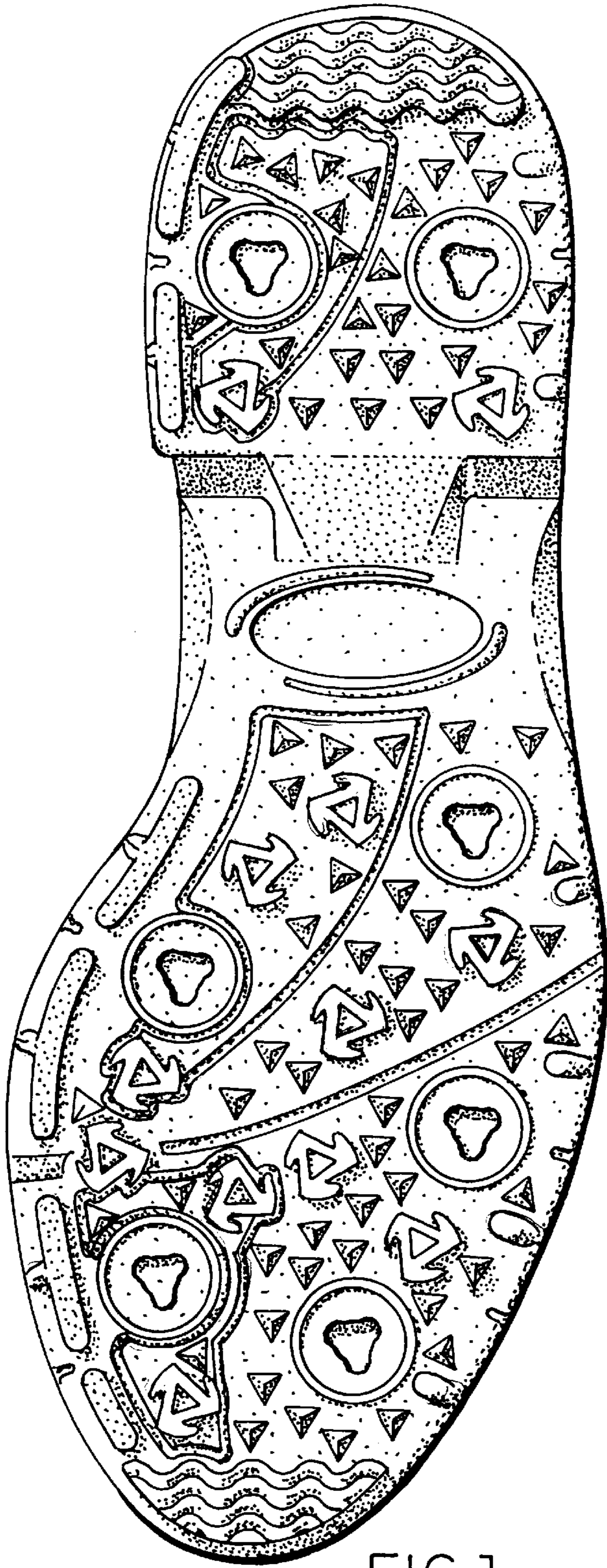

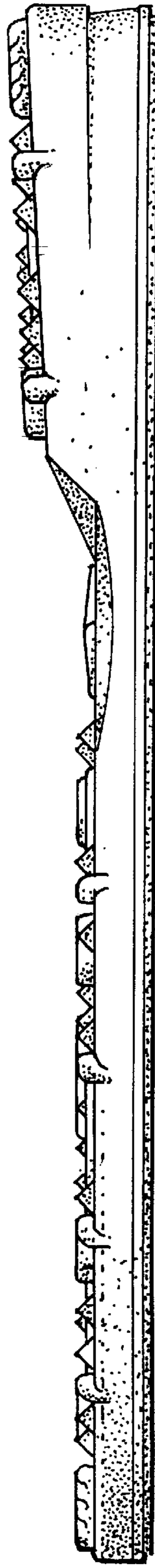

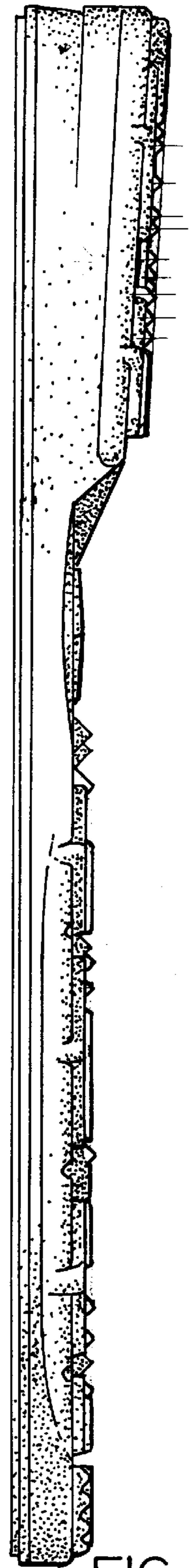

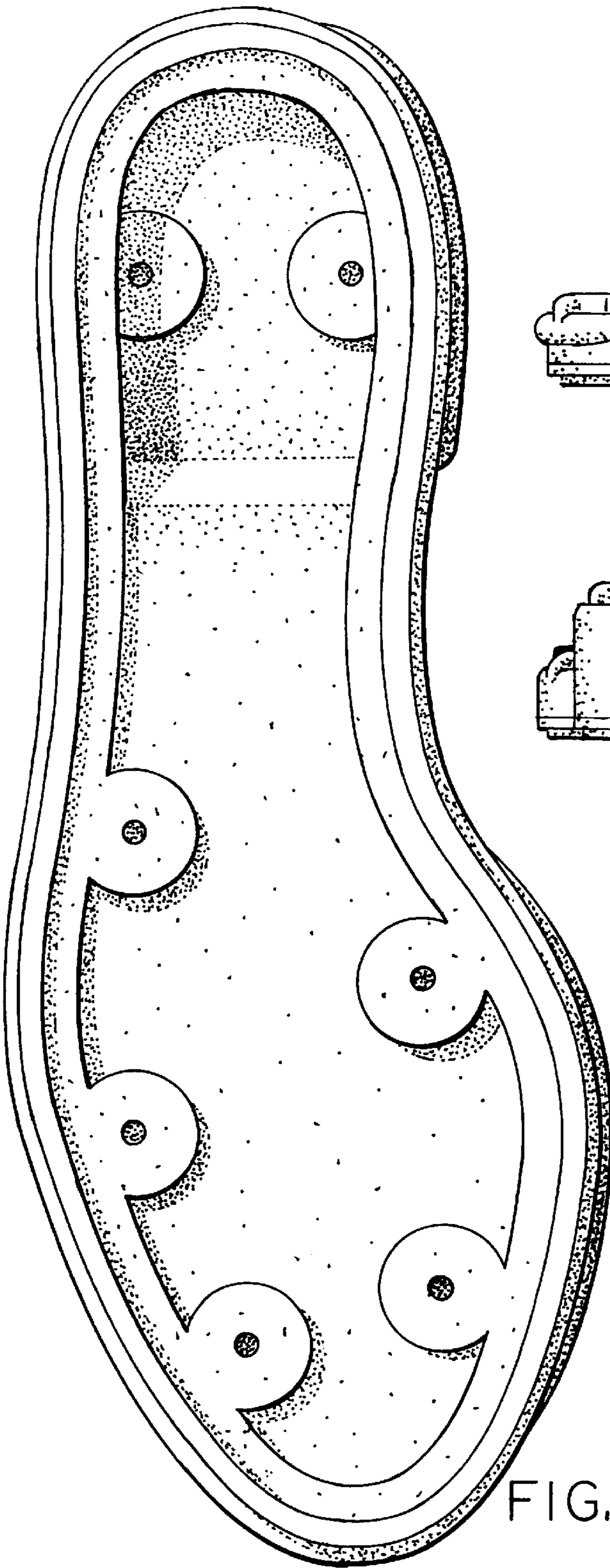

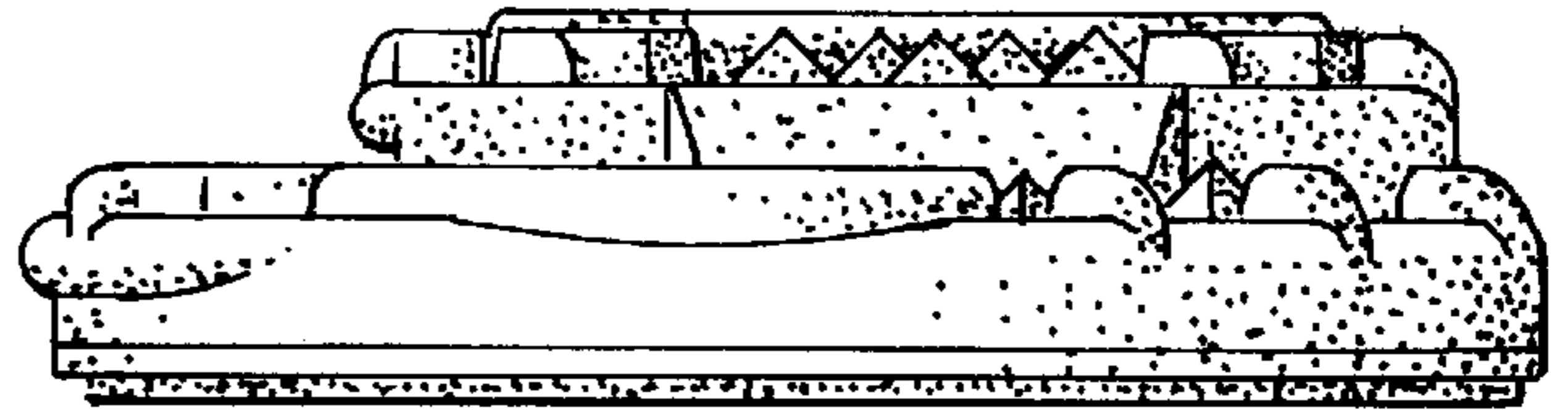
