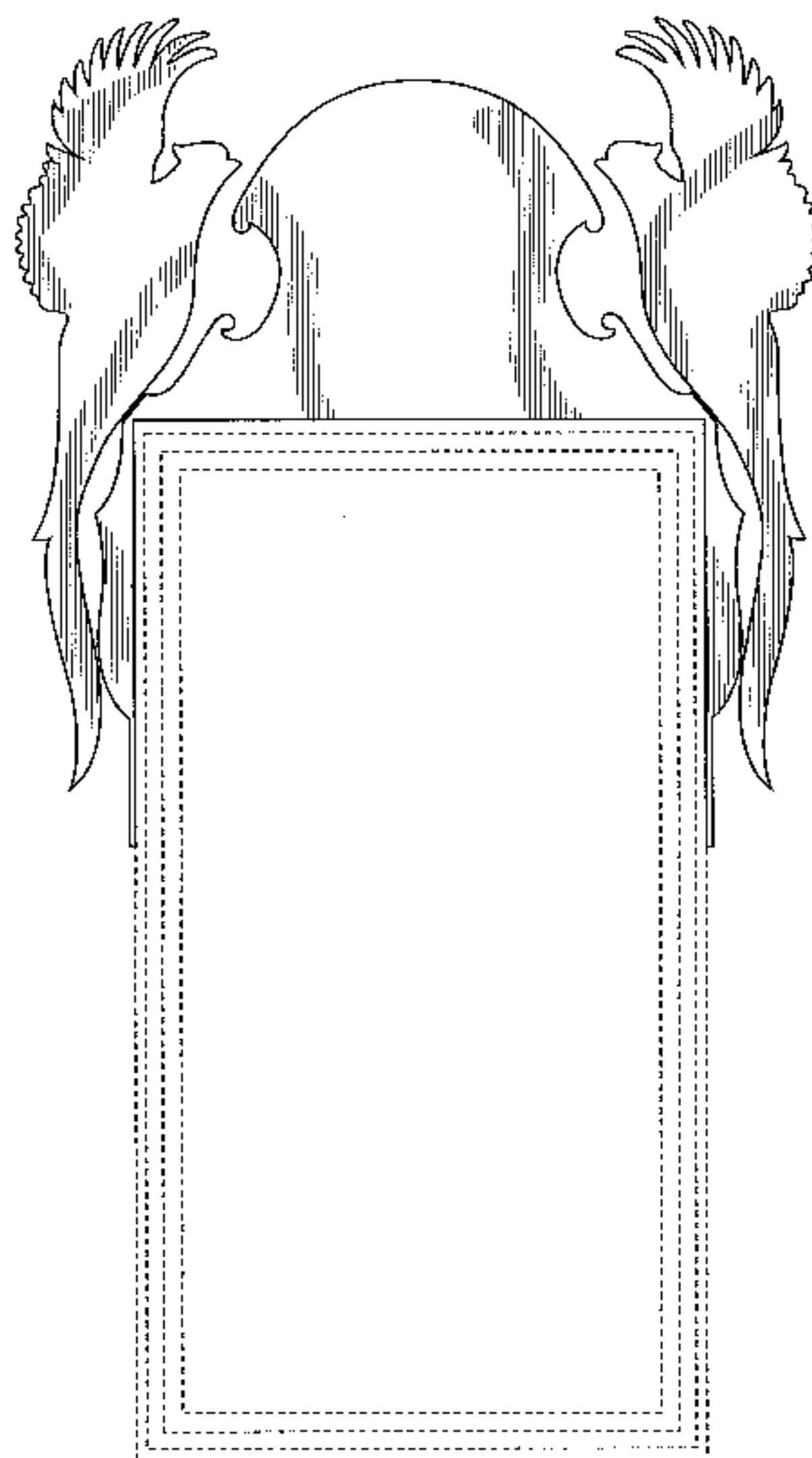
The ornamental design for a decorative frame, as shown and described.

**DESCRIPTION**

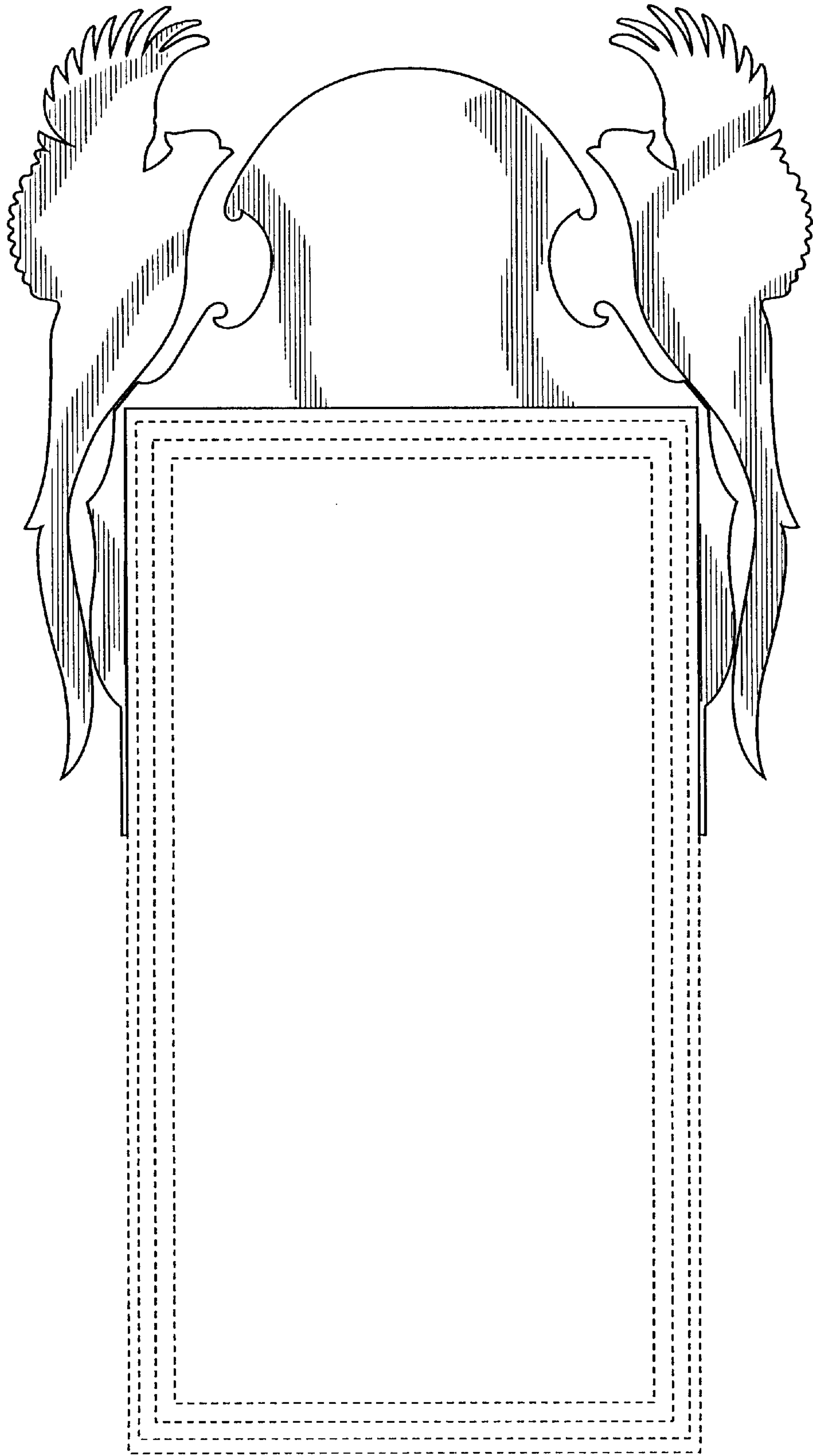
FIG. 1 is a front view of the invention;

Unclaimed subject matter is shown in dotted line format.

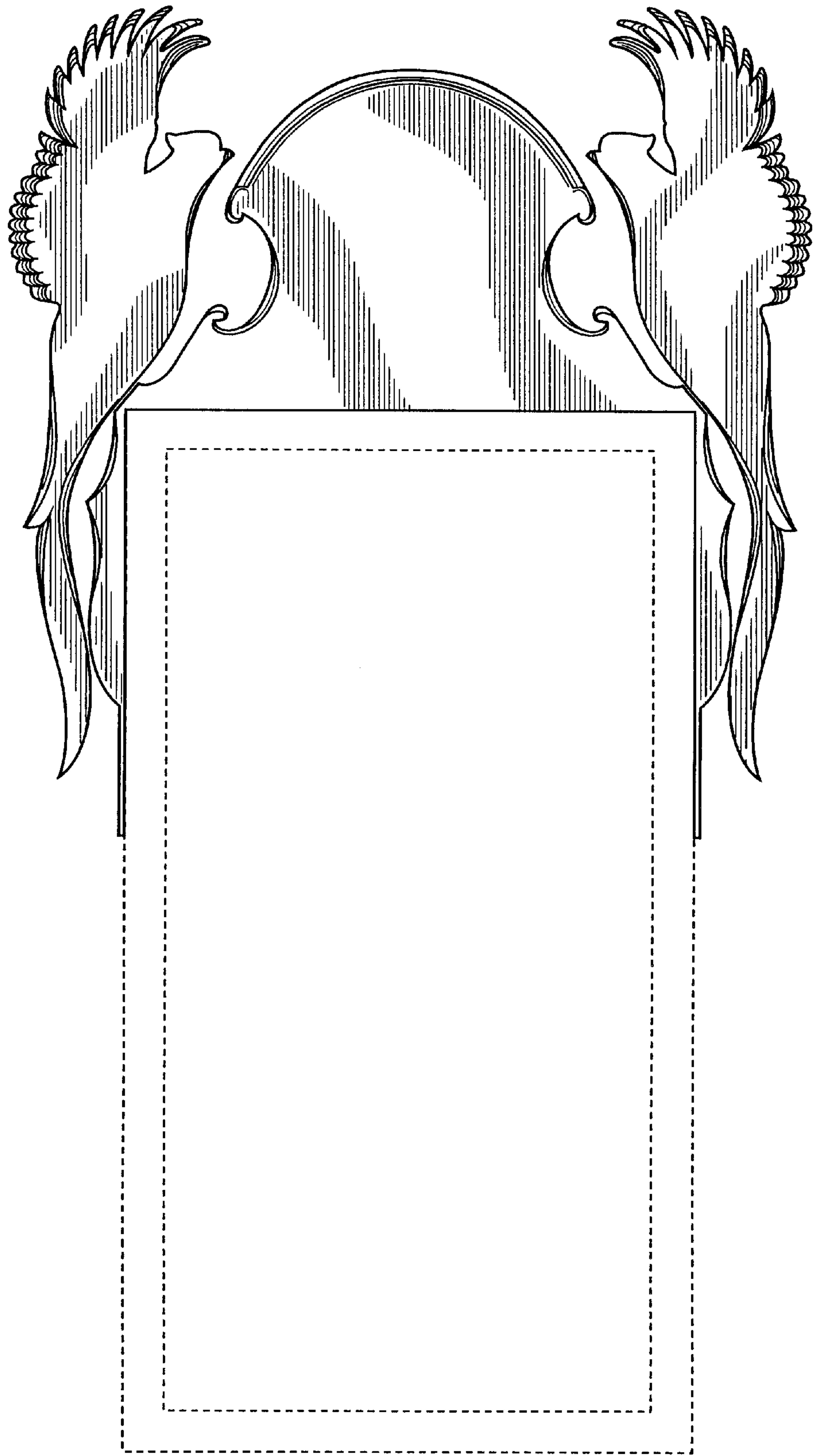

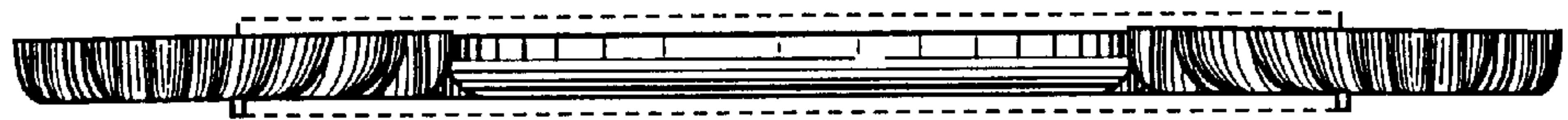
