[57] **CLAIM**

The ornamental design for a dresser, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a dresser showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a left side elevational view, the right side being a mirror image thereof;

FIG. 5 is an enlarged detail view of the upper left corner of the dressers shown herein;

FIG. 6 is an enlarged detail view of the bottom left corner of the dressers shown herein;

FIG. 7 is an enlarged detail view of the top decorative trim and drawer of the dressers shown herein;

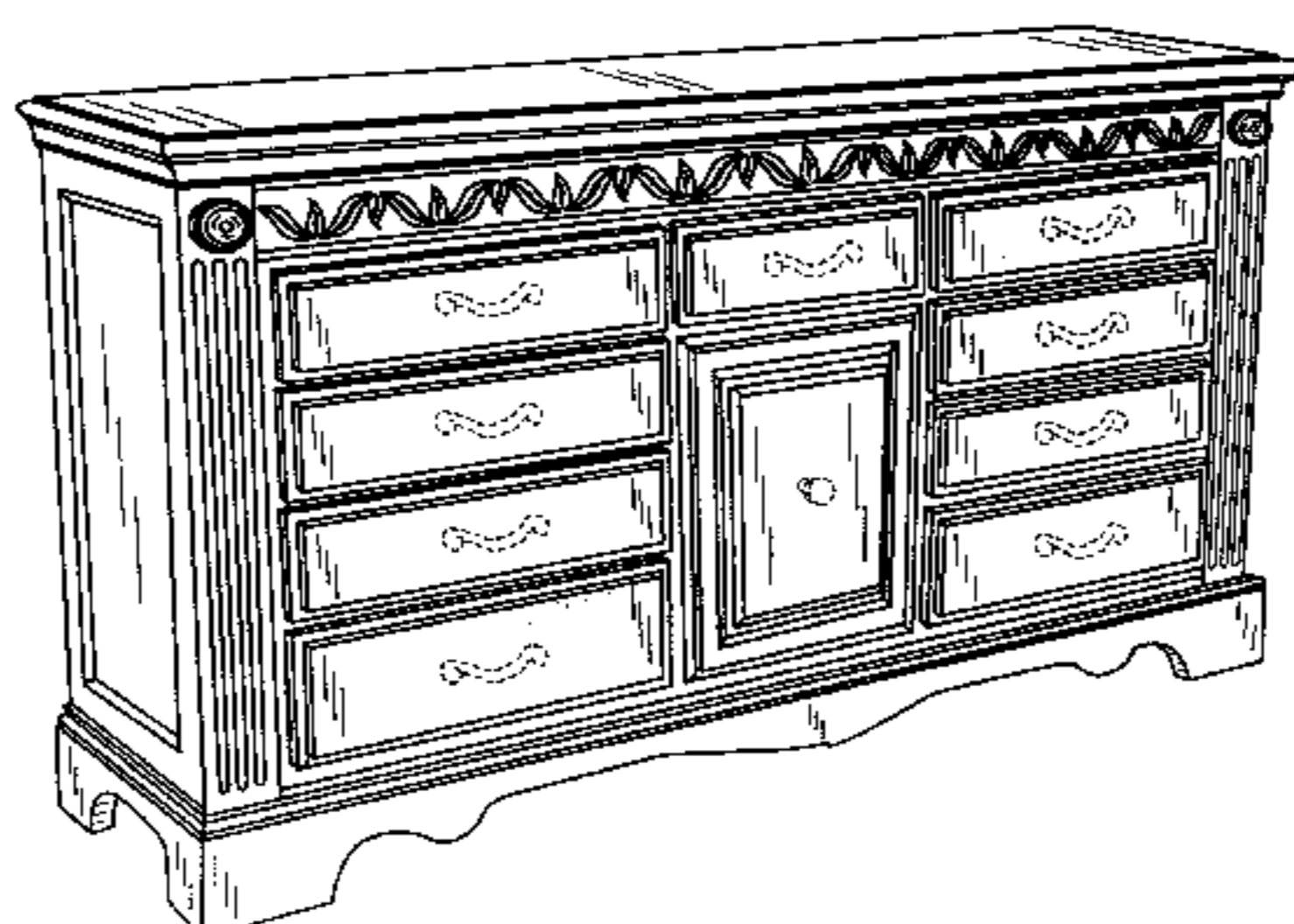
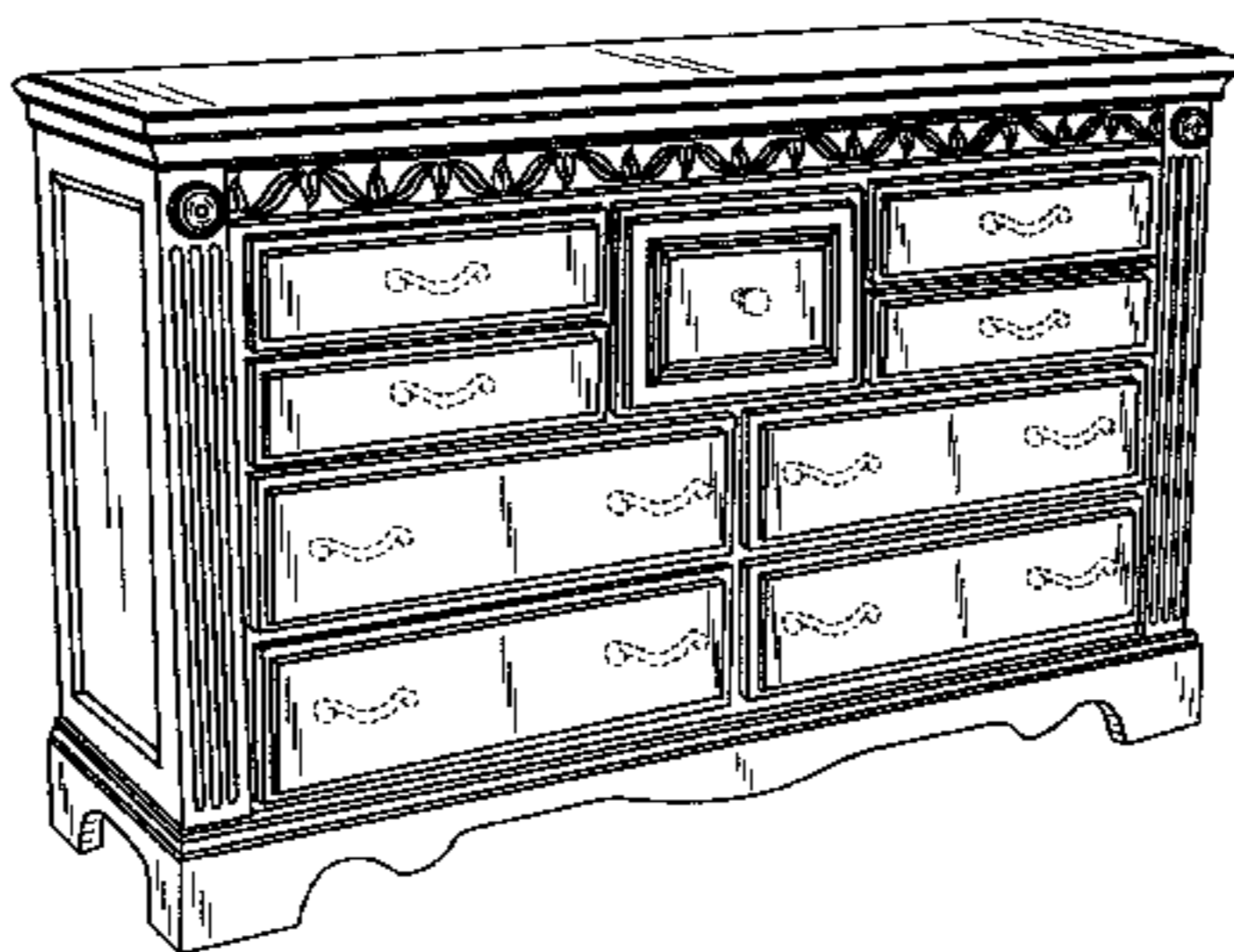
FIG. 8 is a front left perspective view of a second embodiment of the dresser shown in FIG. 1;

FIG. 9 is a front elevational view thereof; and,

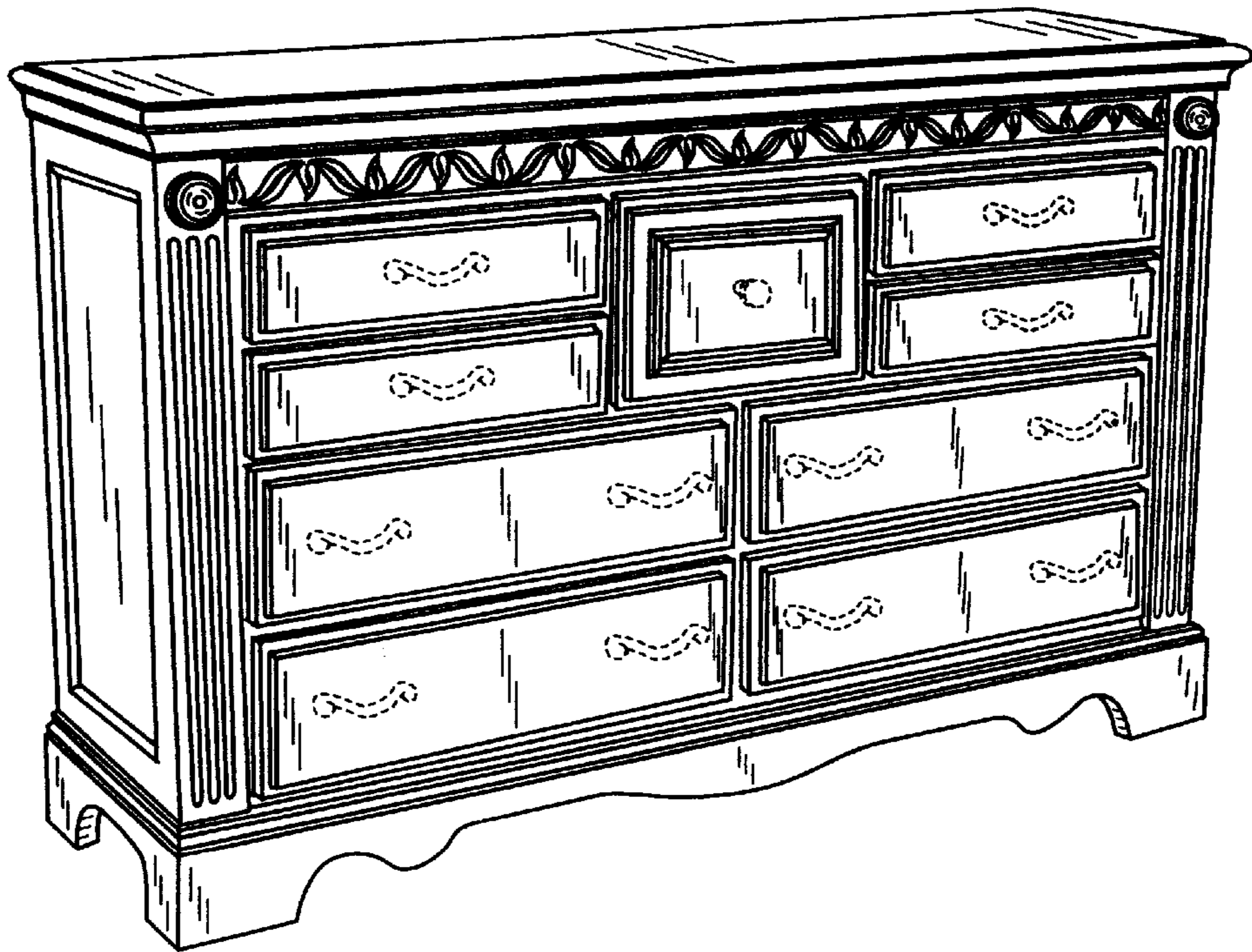

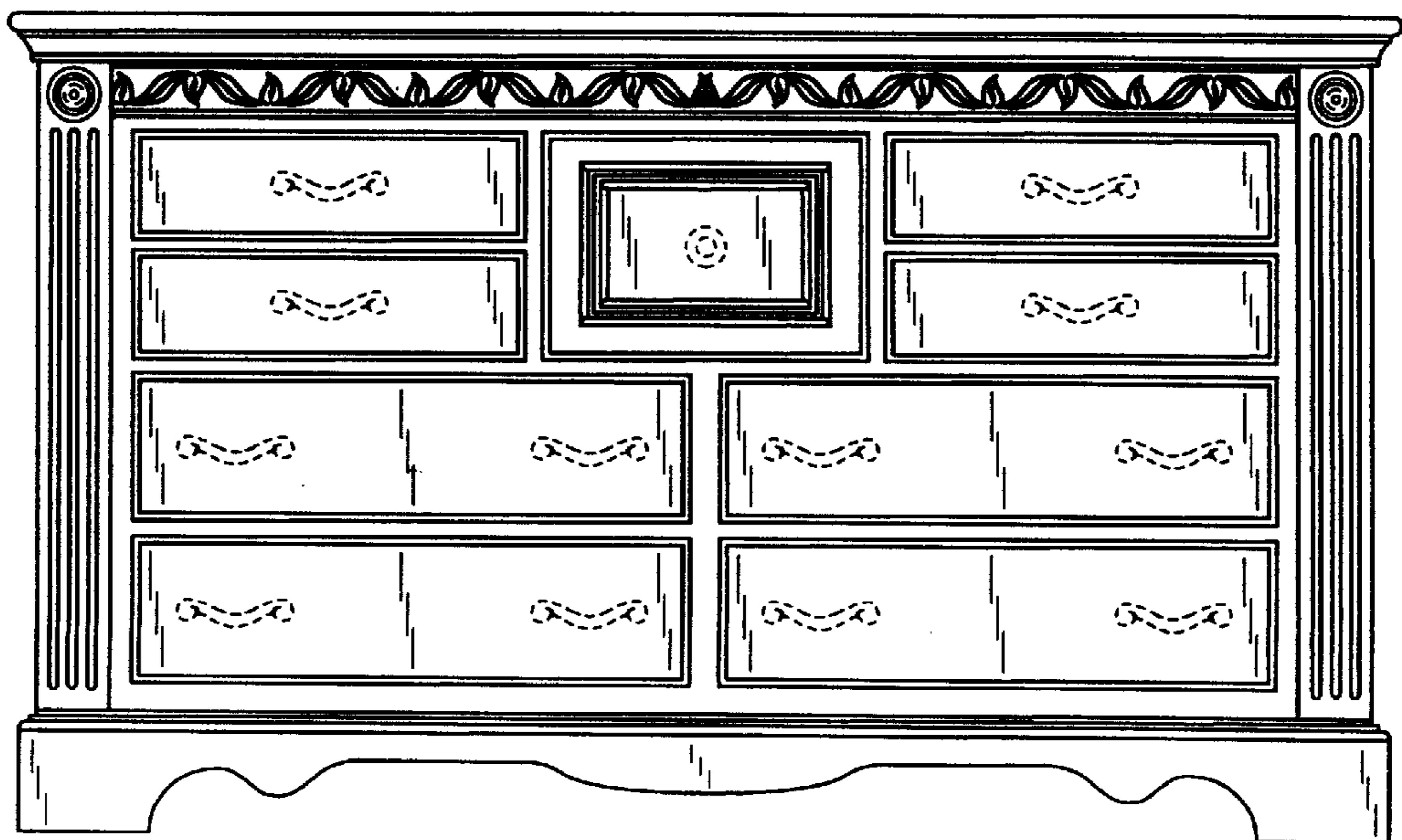

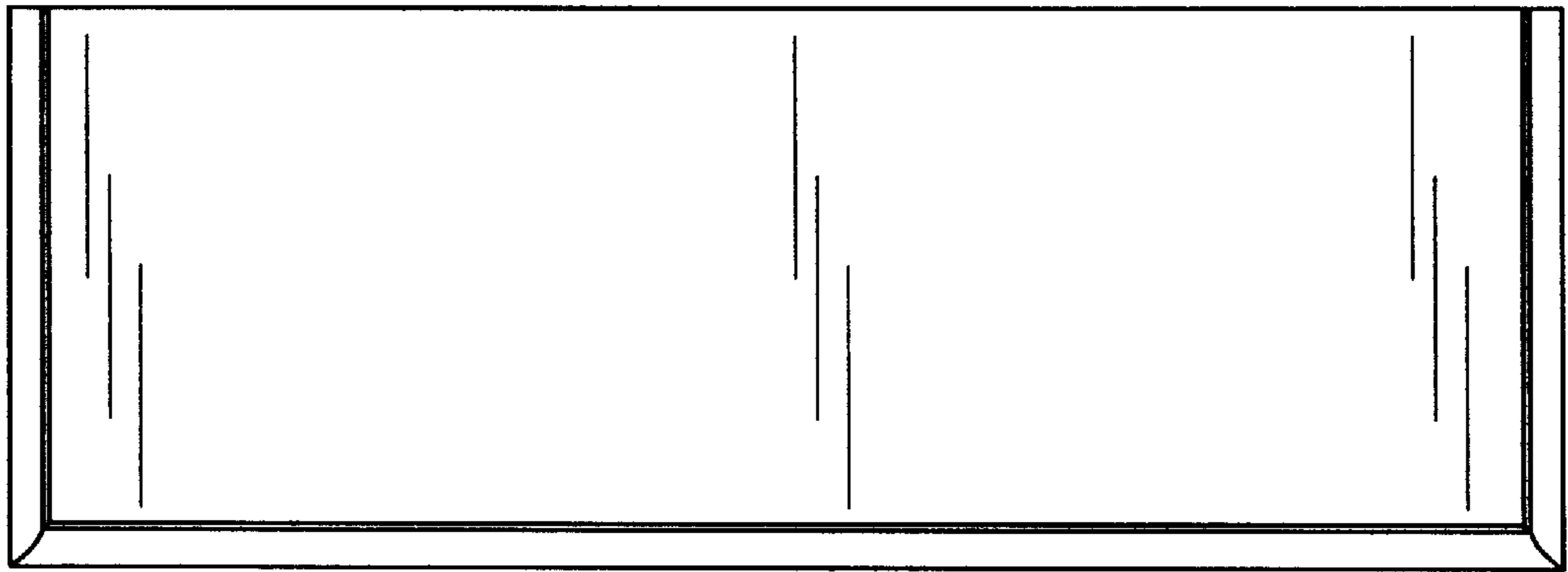

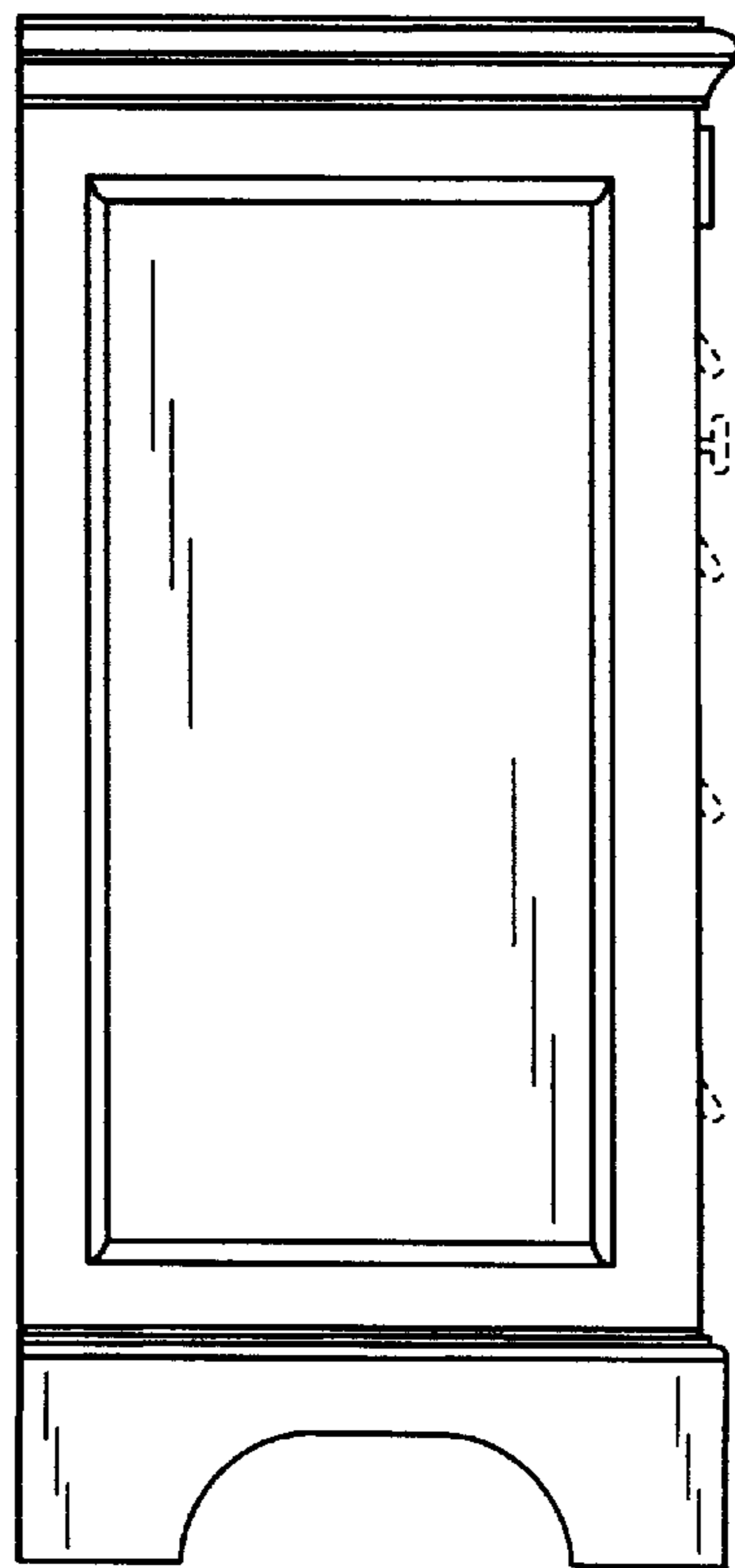

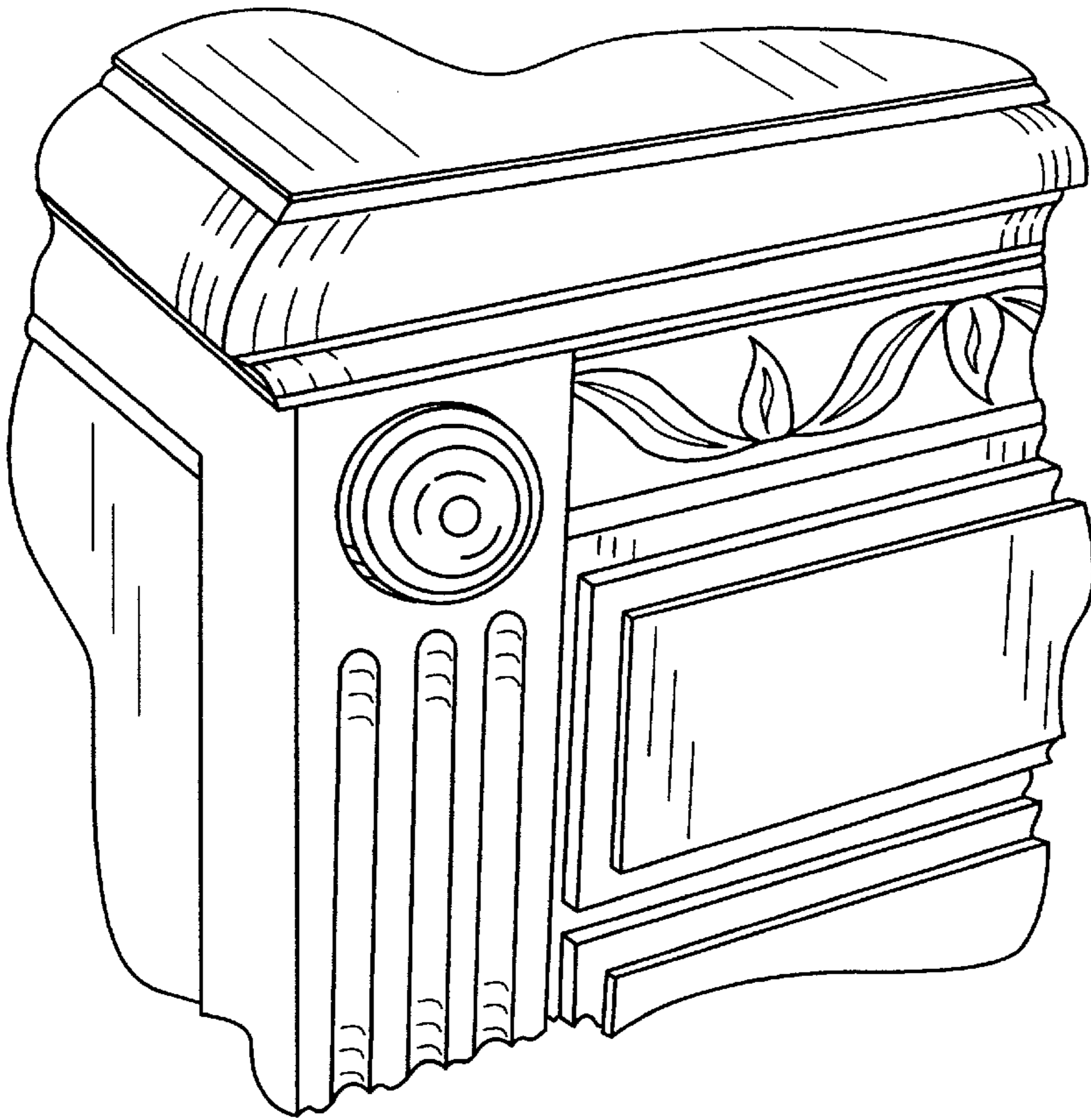

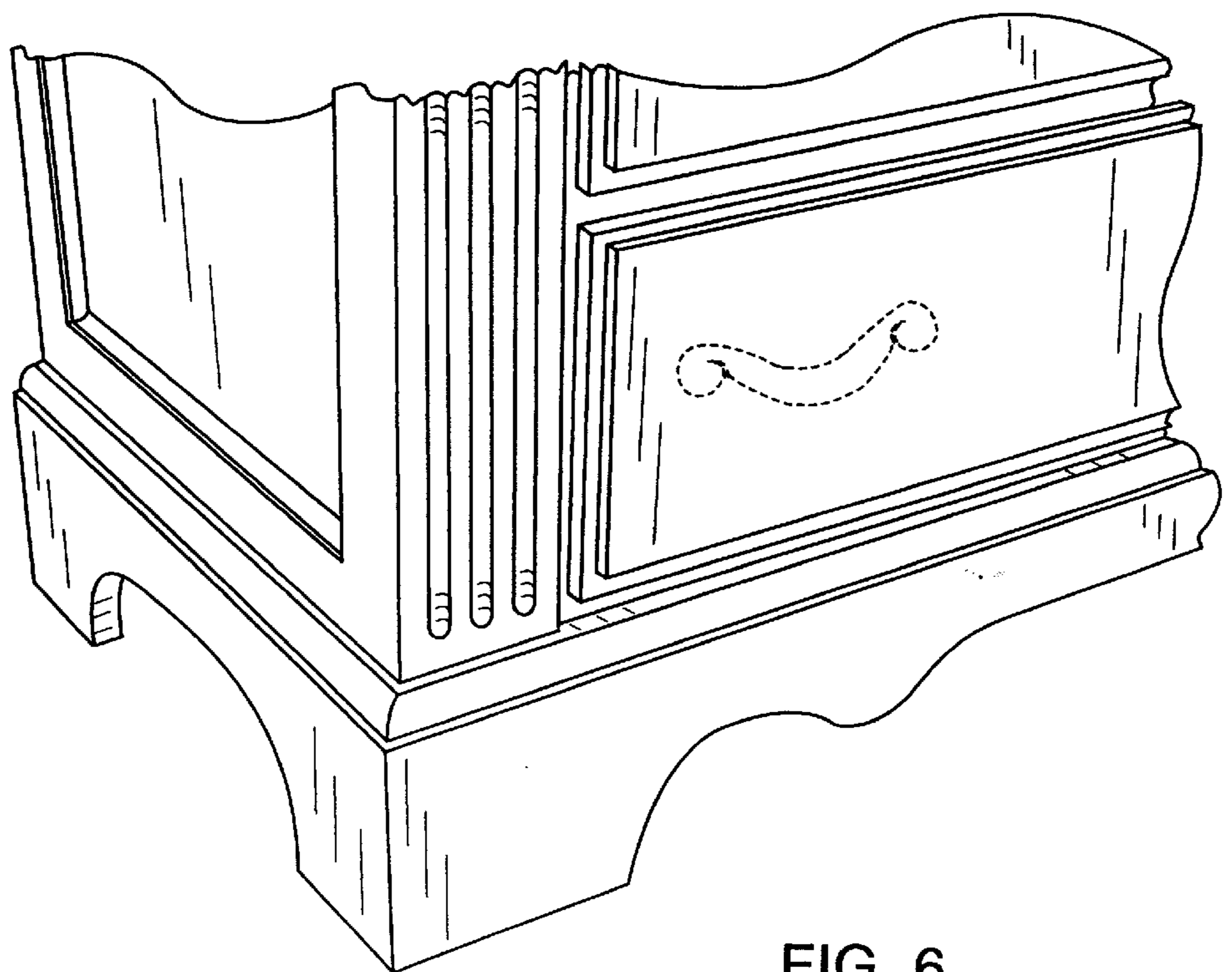

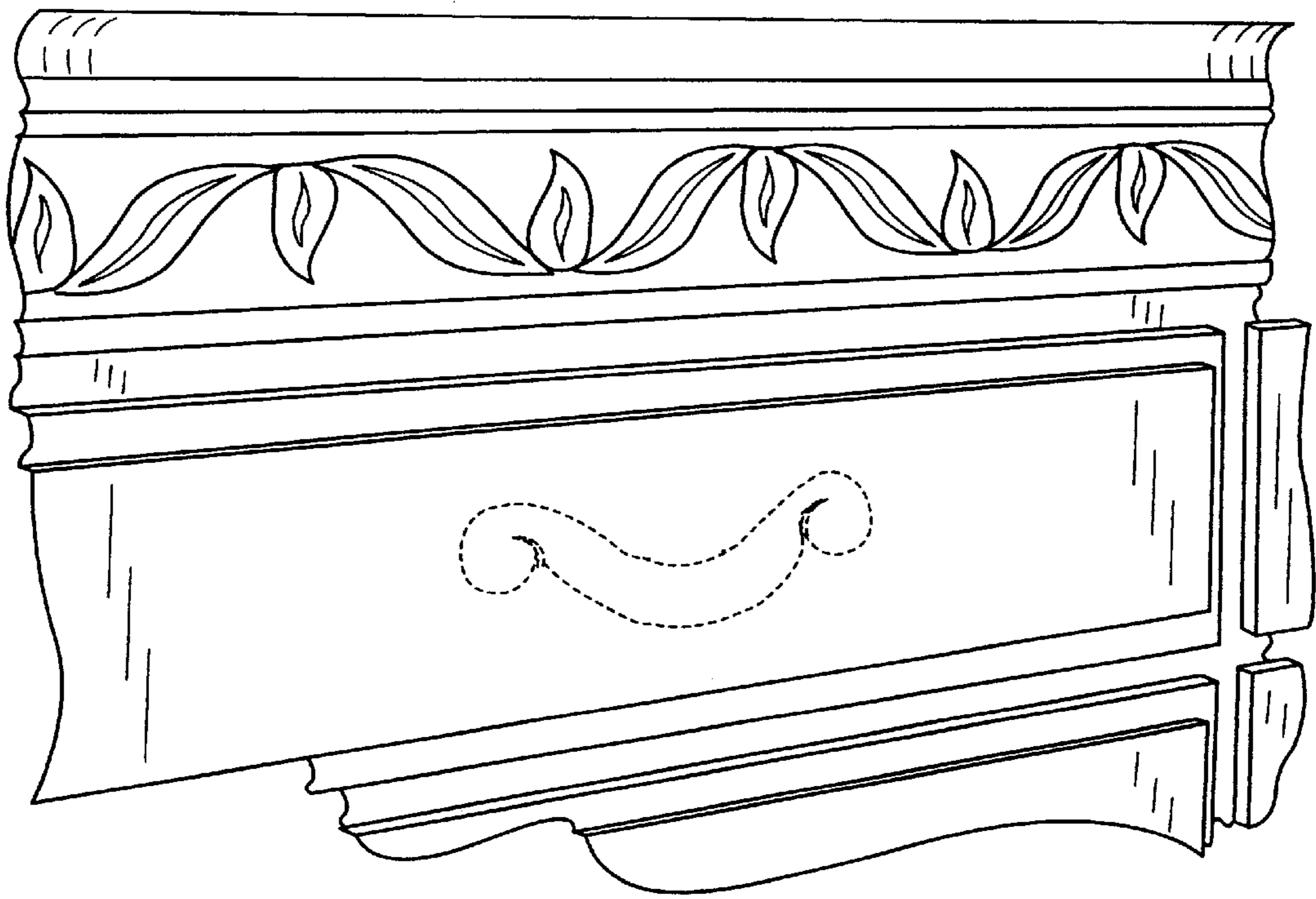

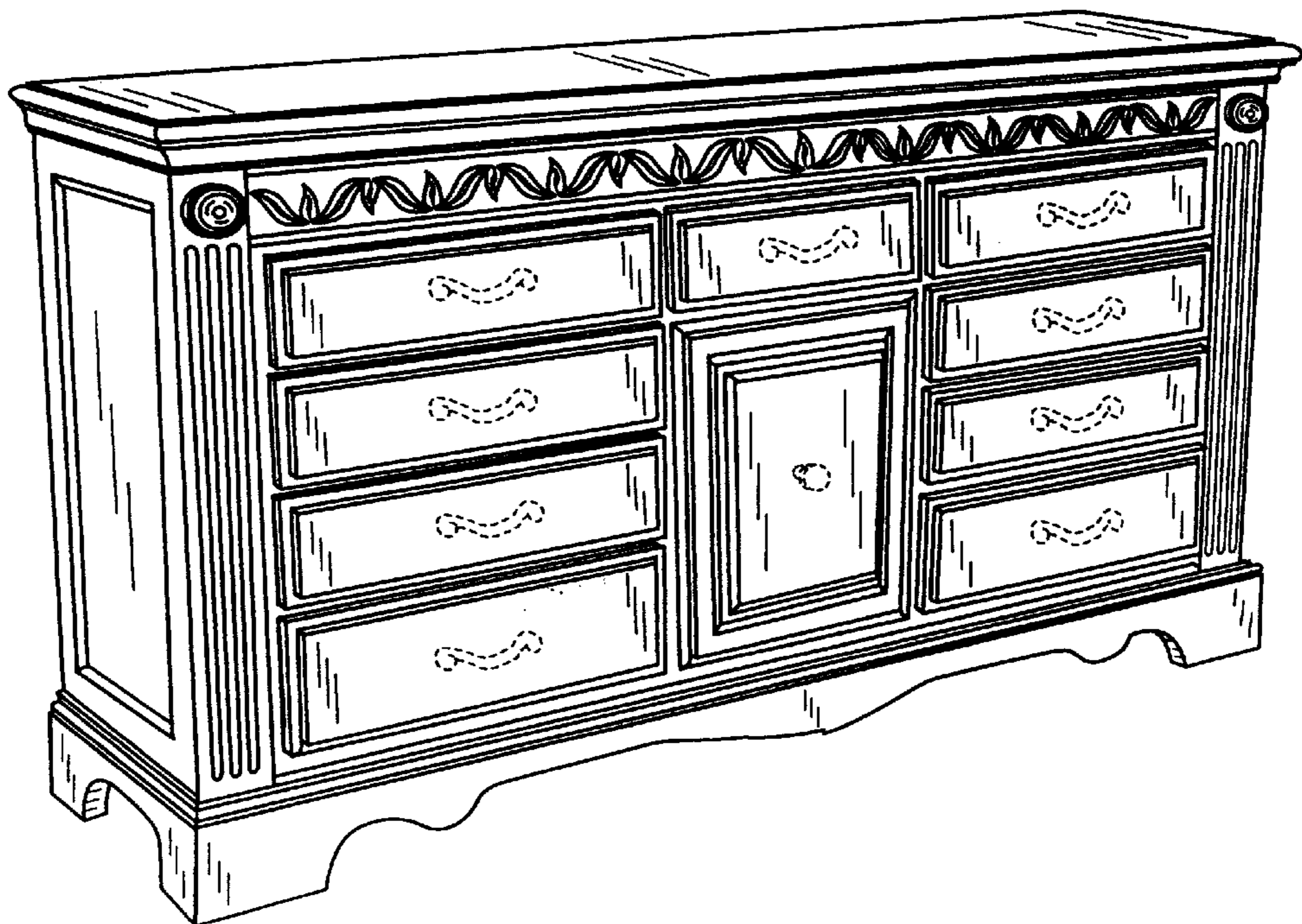

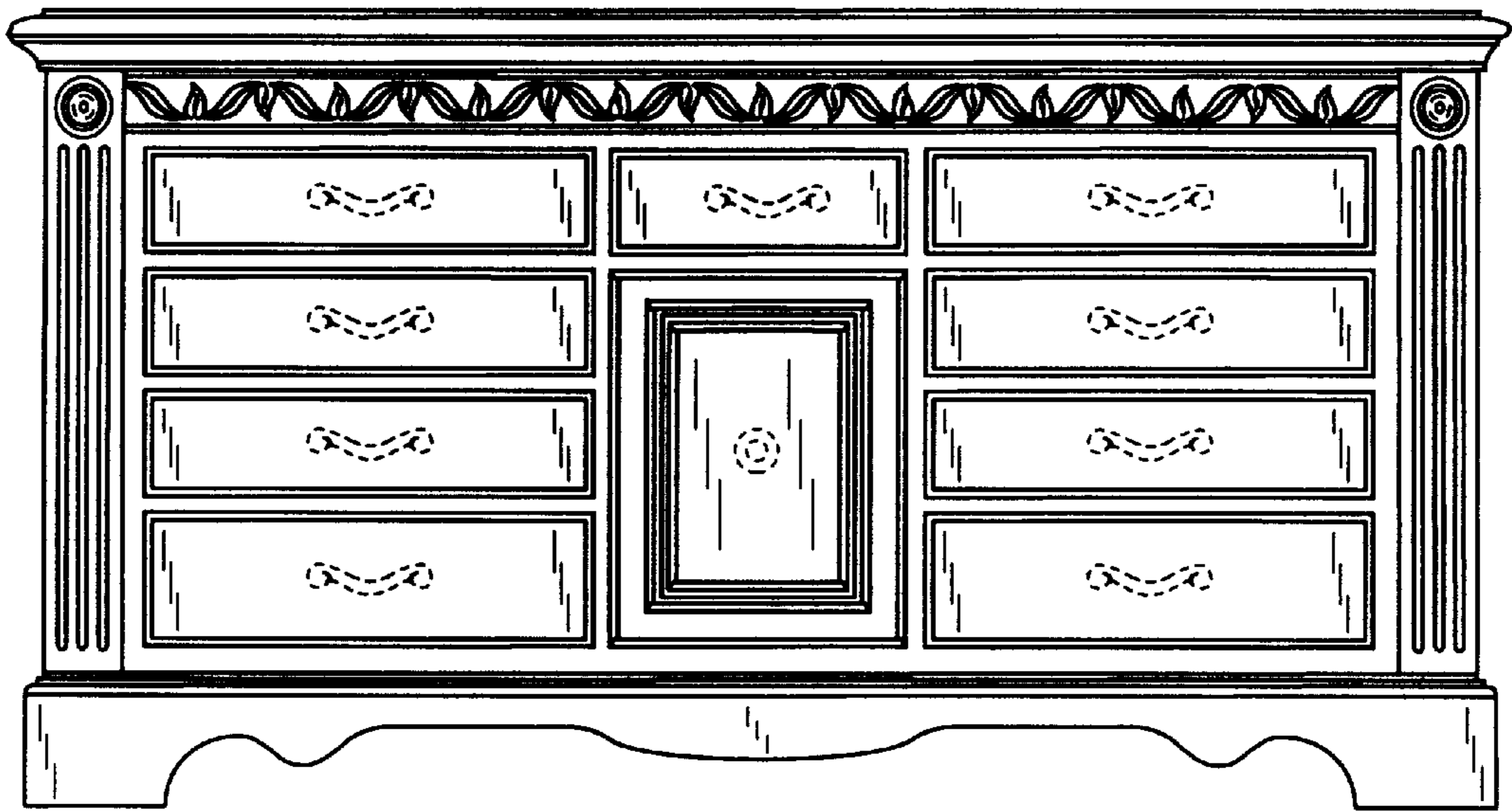

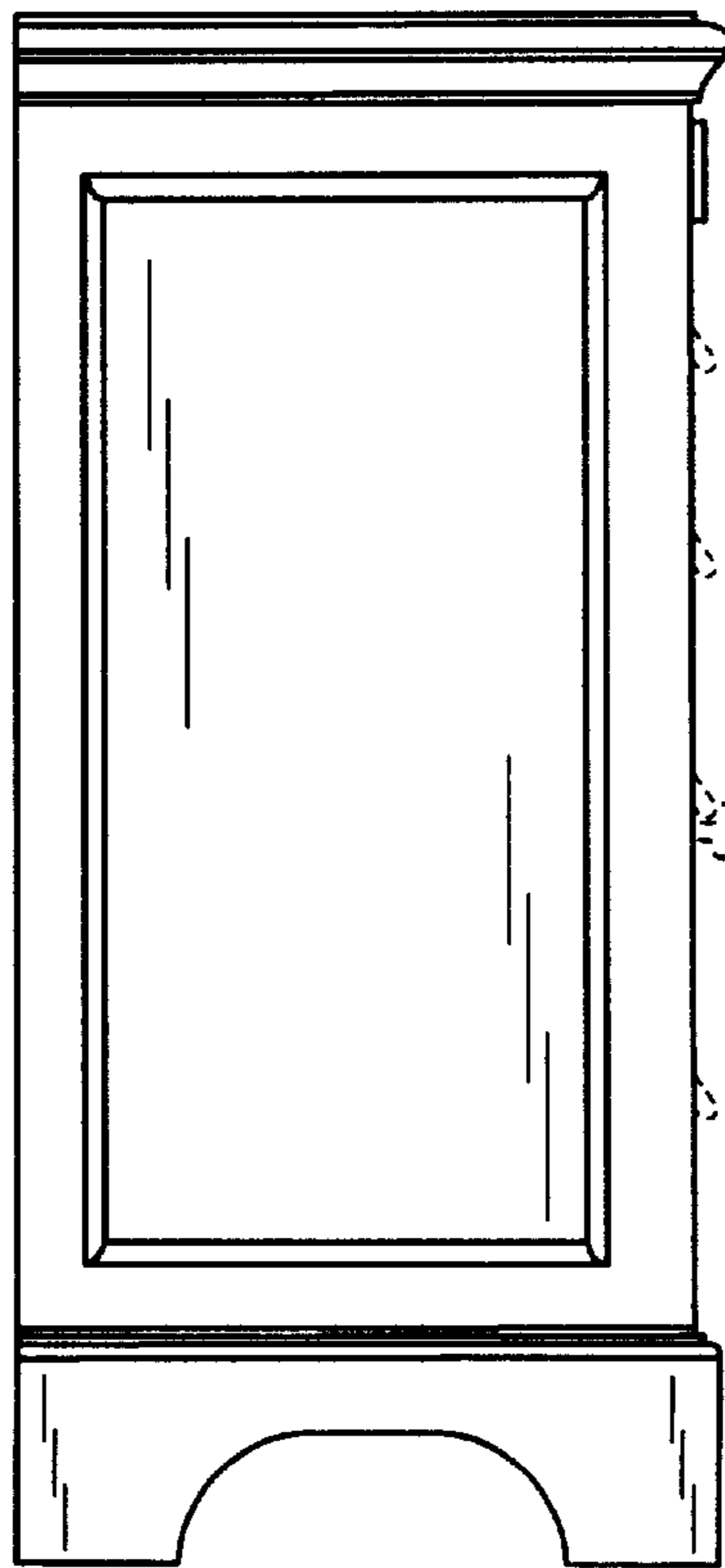
