The ornamental design for a speaker box, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a speaker box showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a front elevational view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a right side elevational view thereof; and  
 FIG. 7 is a rear elevational view thereof.  
 FIG. 8 is a perspective view of a second embodiment of a speaker box showing my new design;

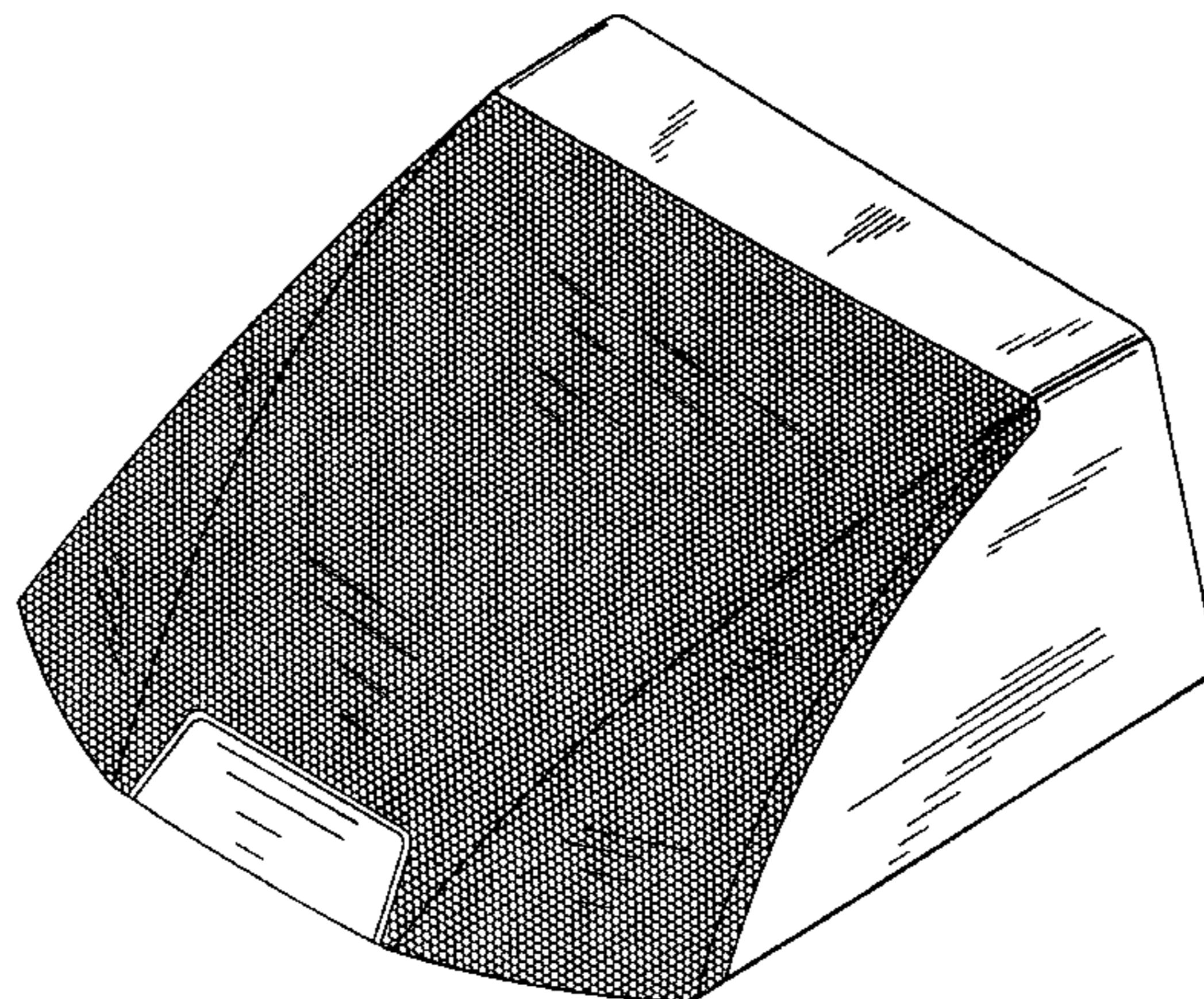
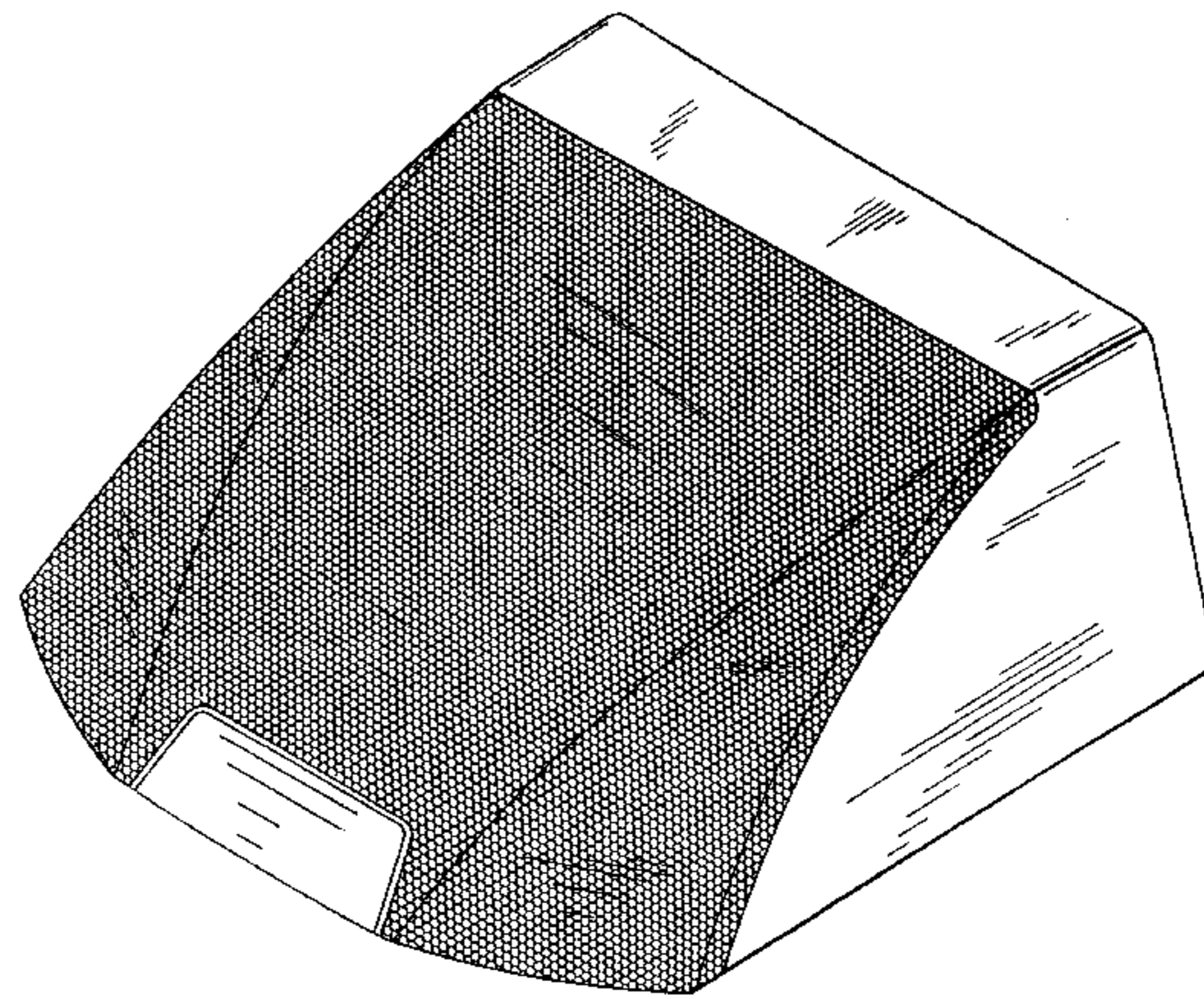

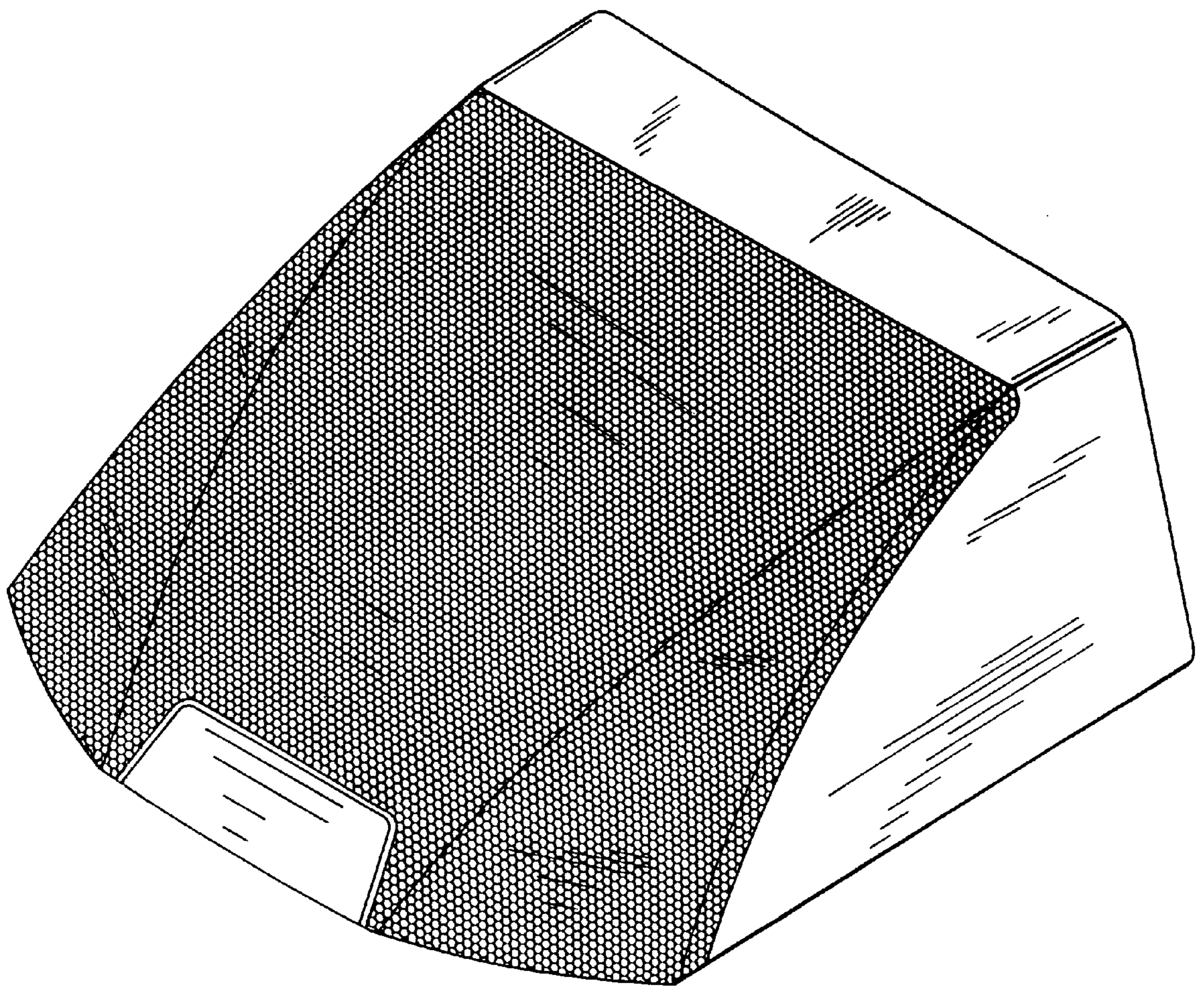

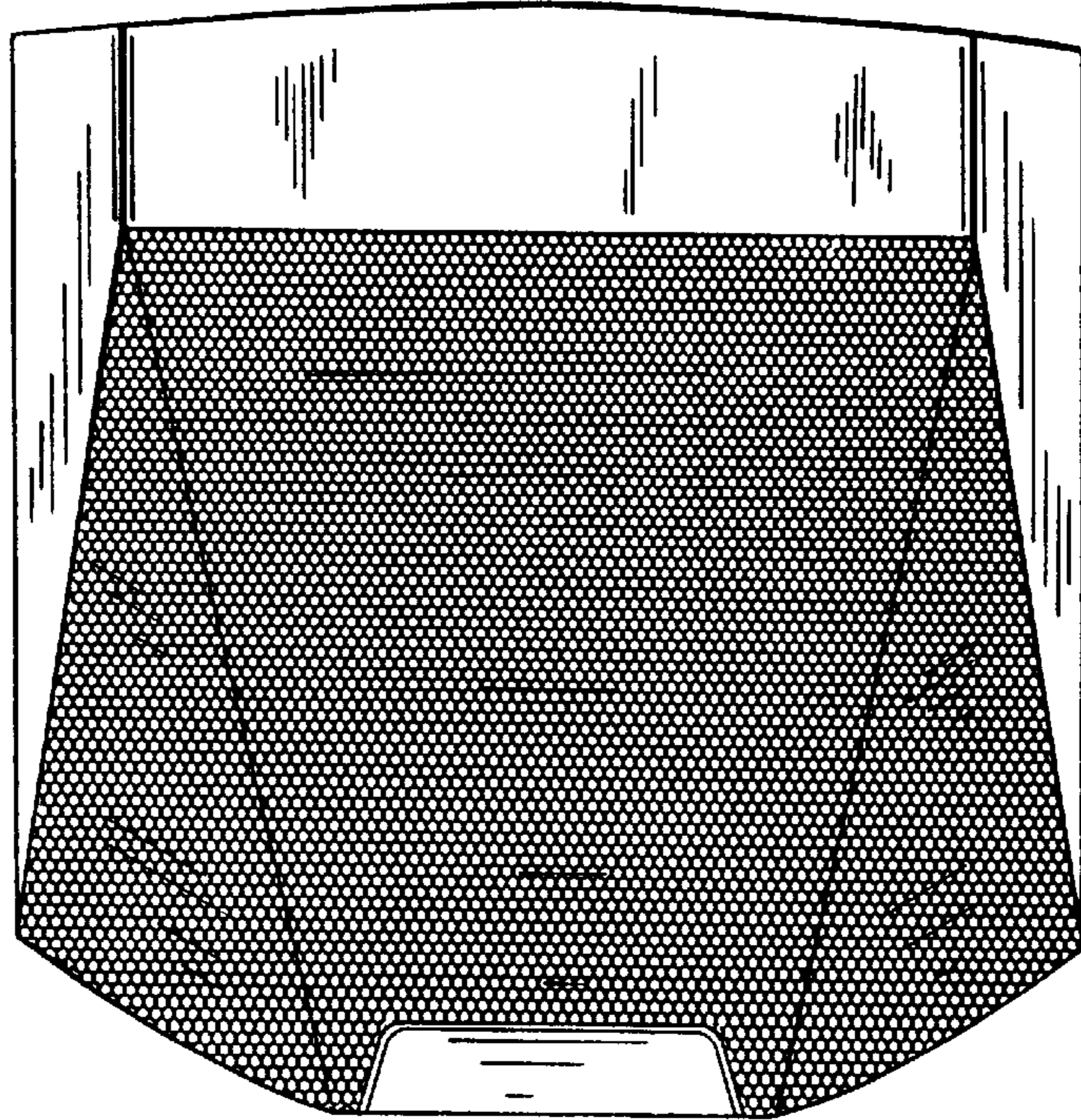

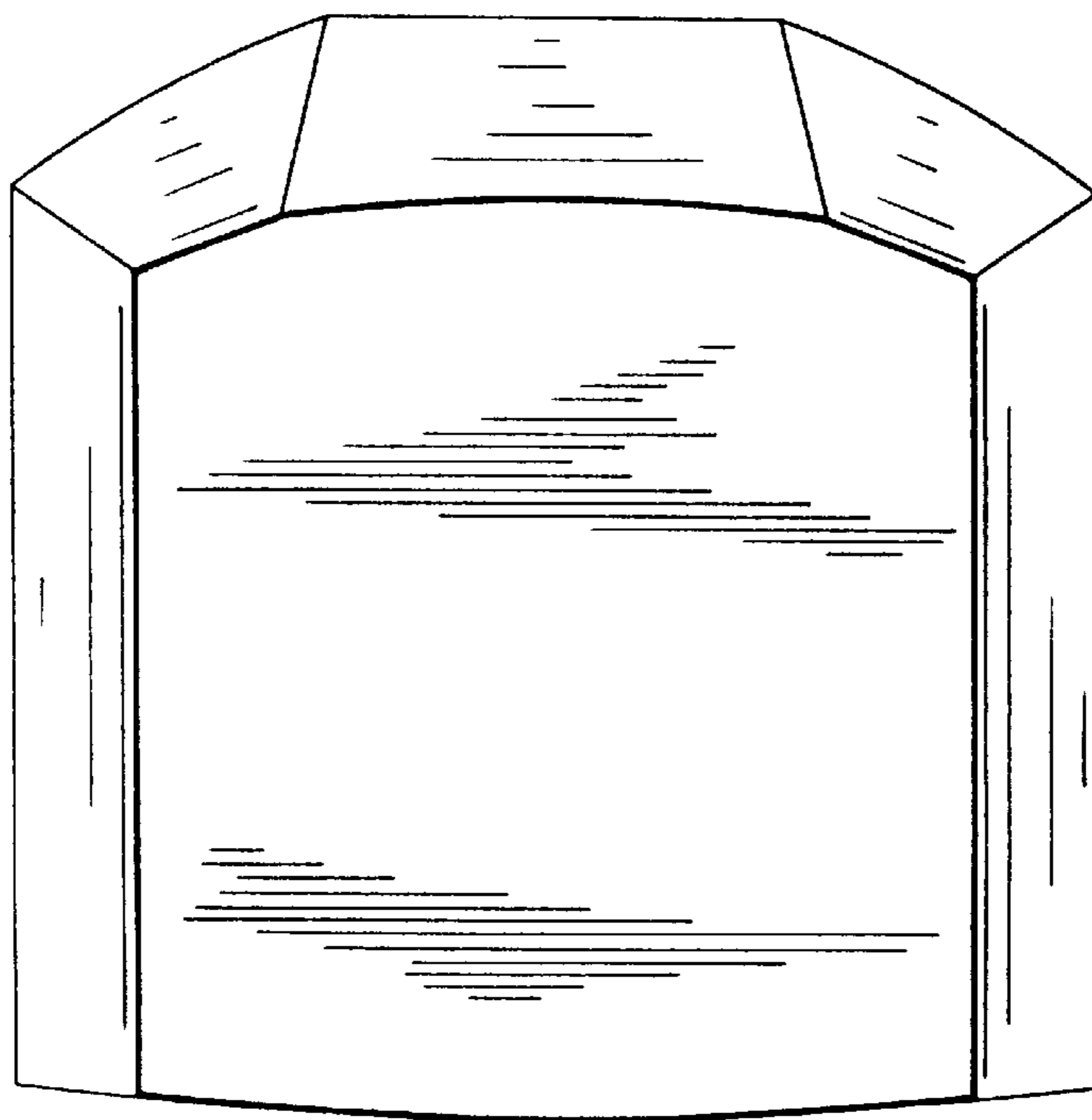

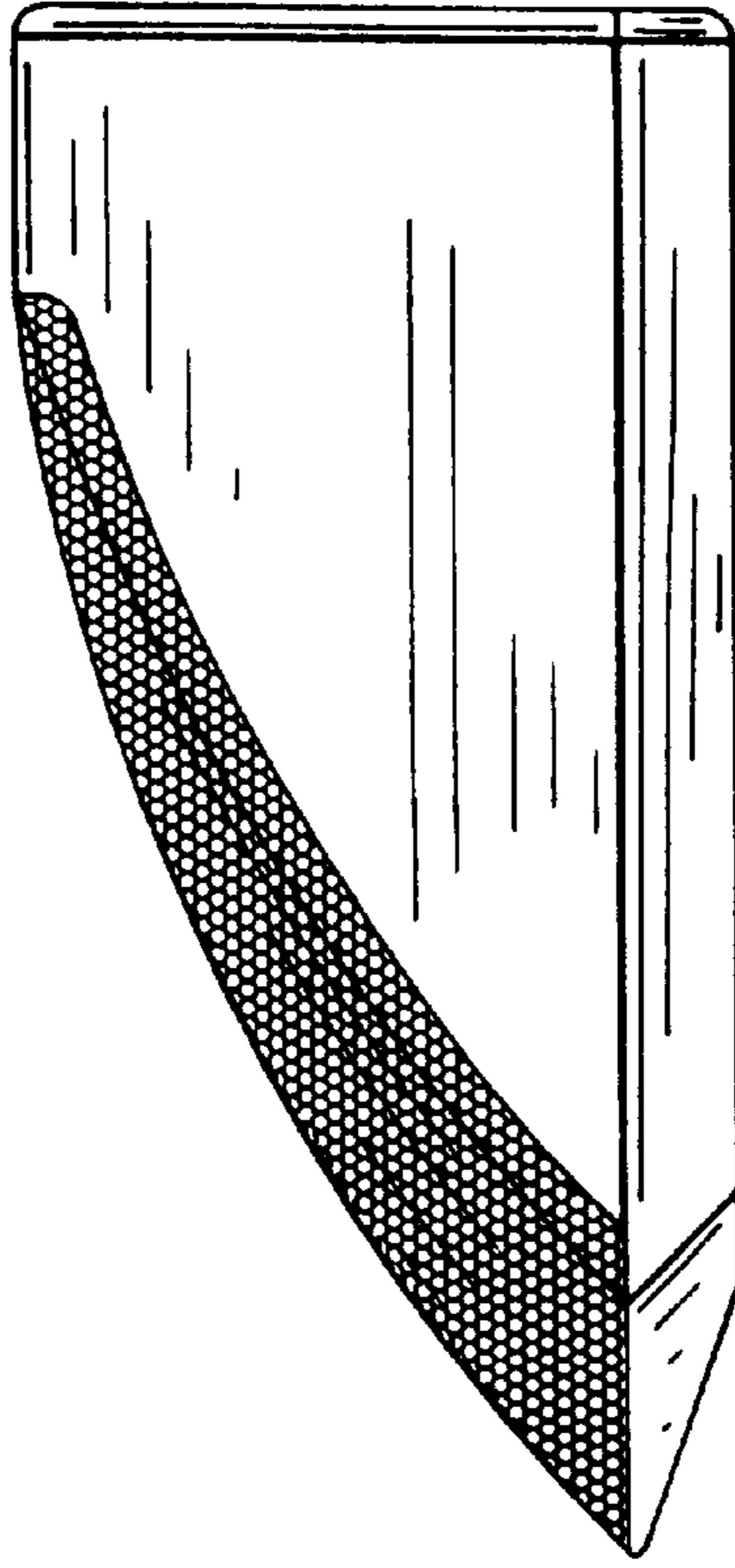

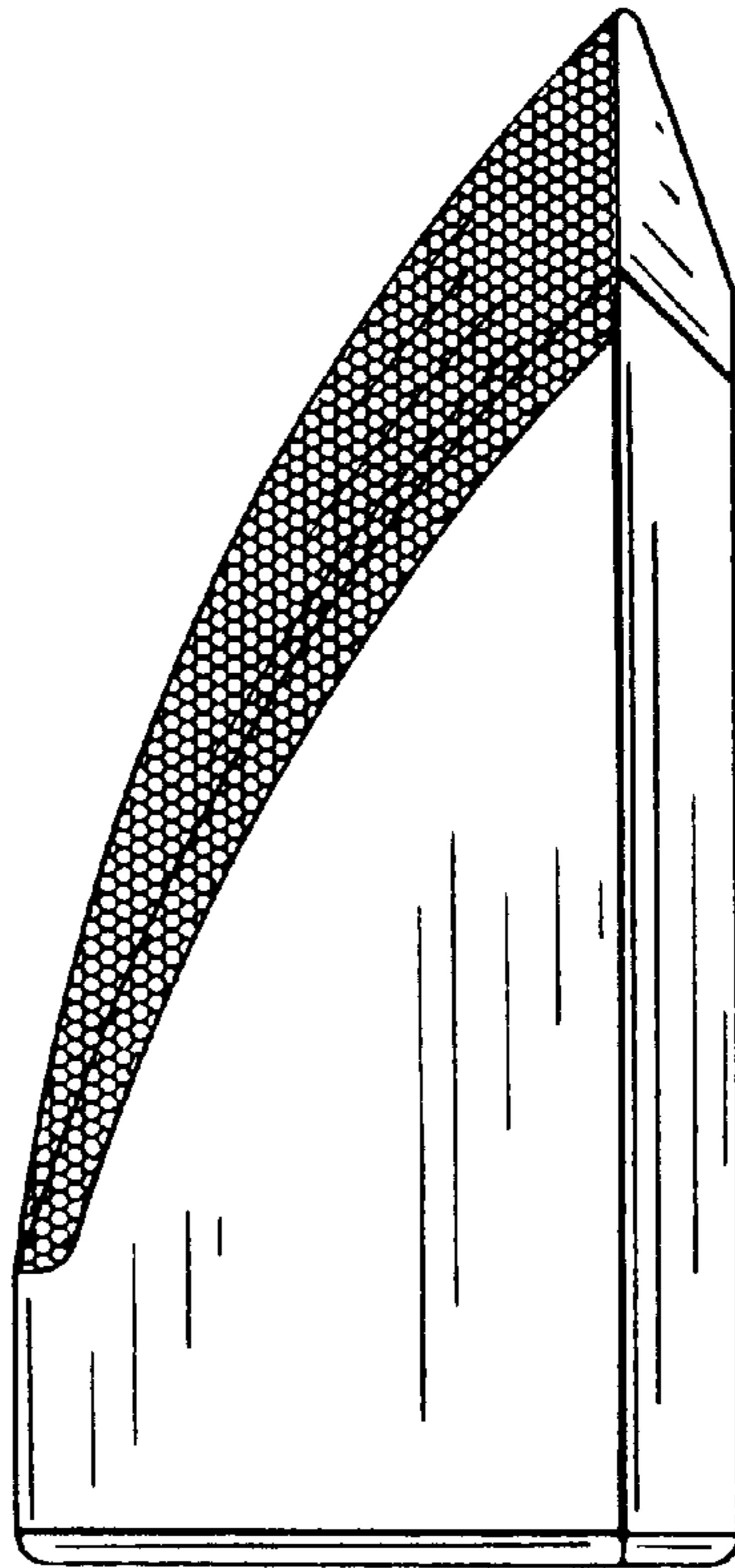

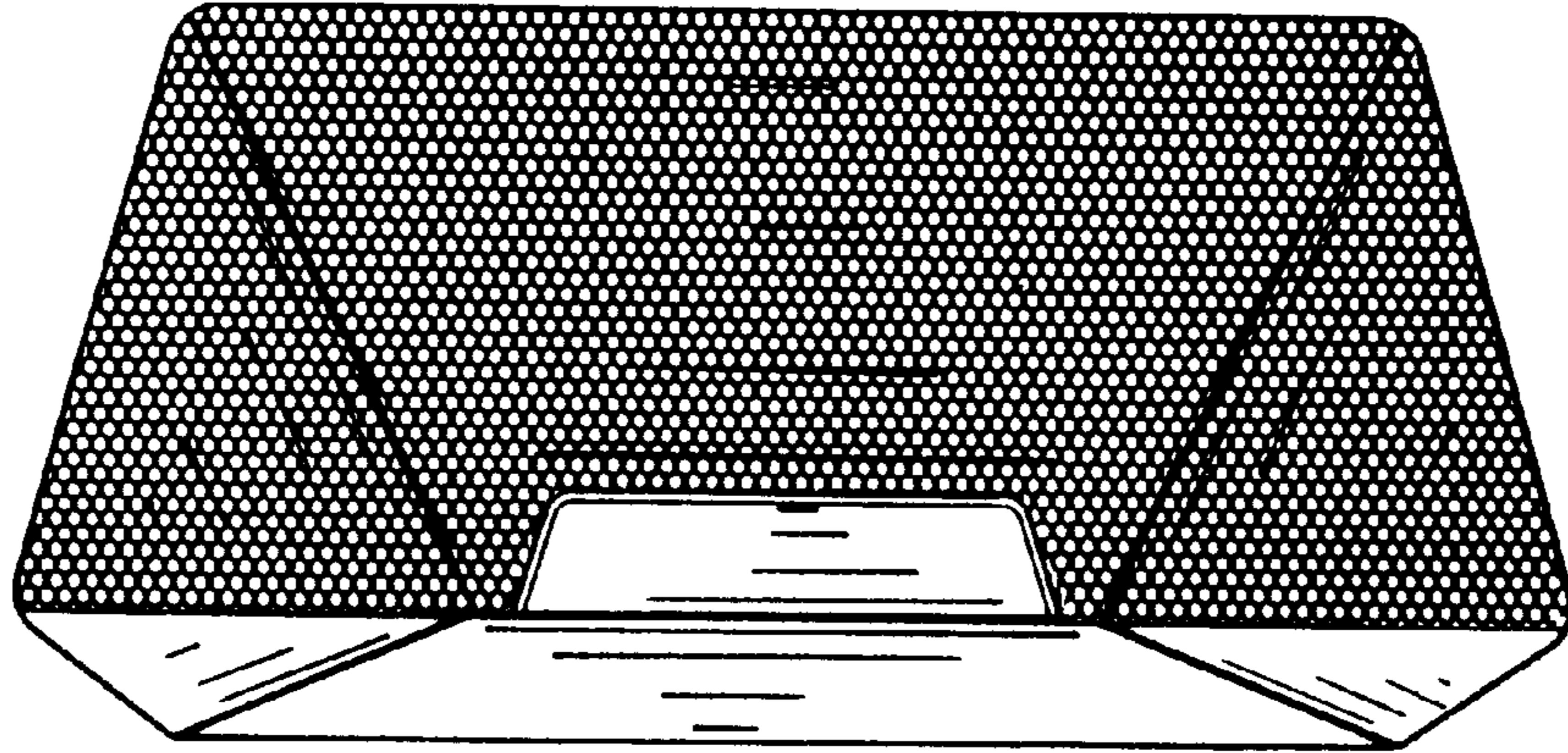

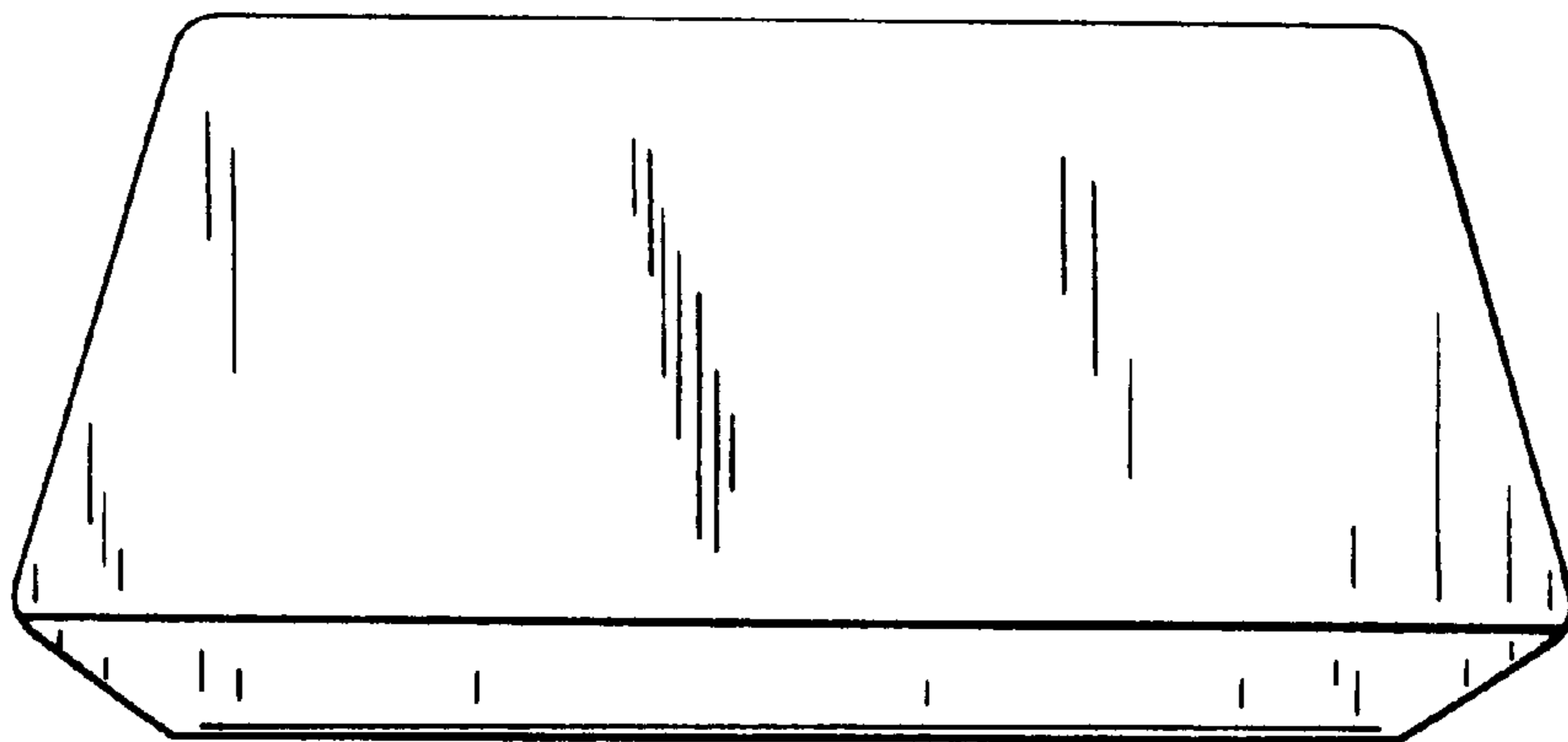

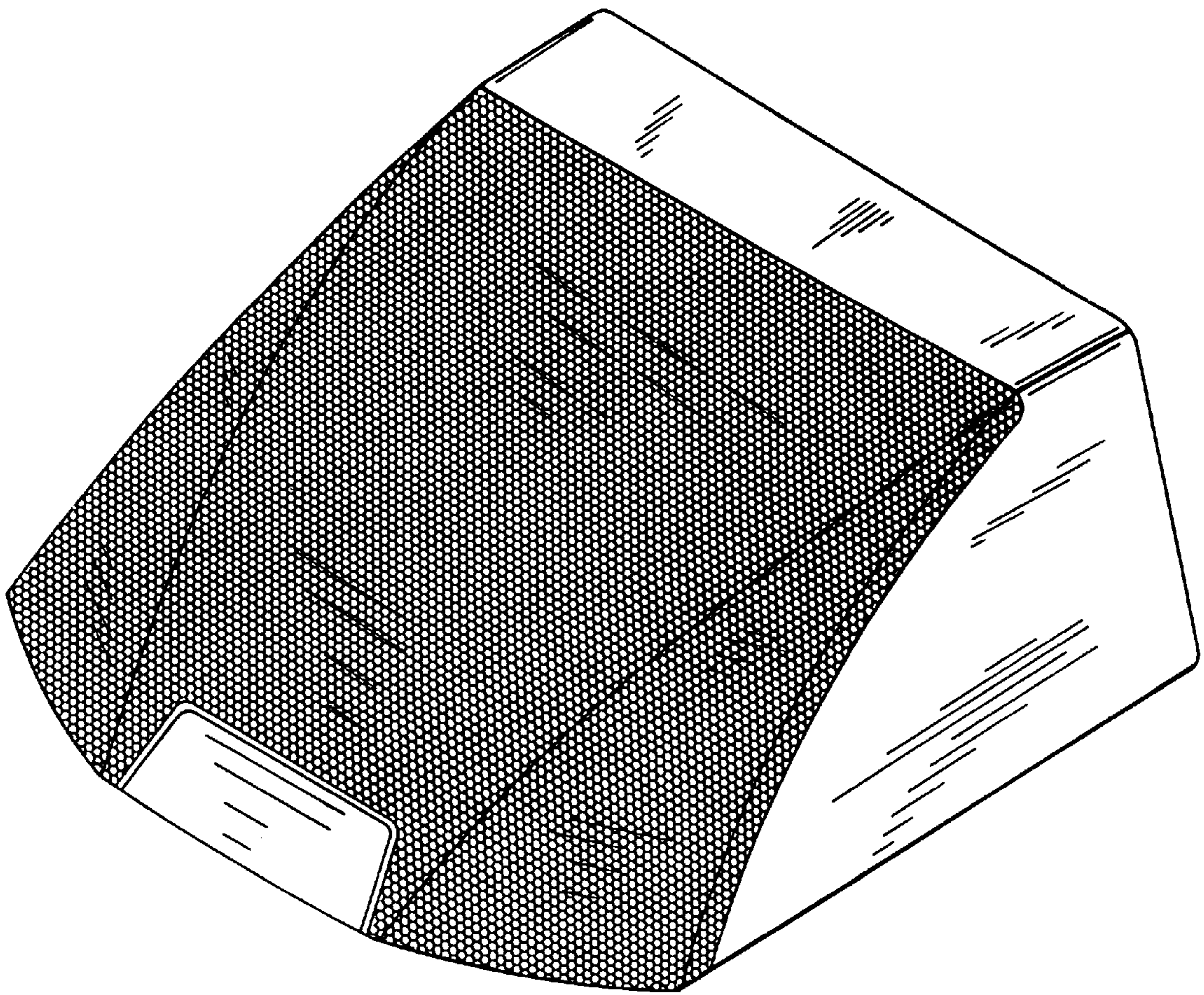

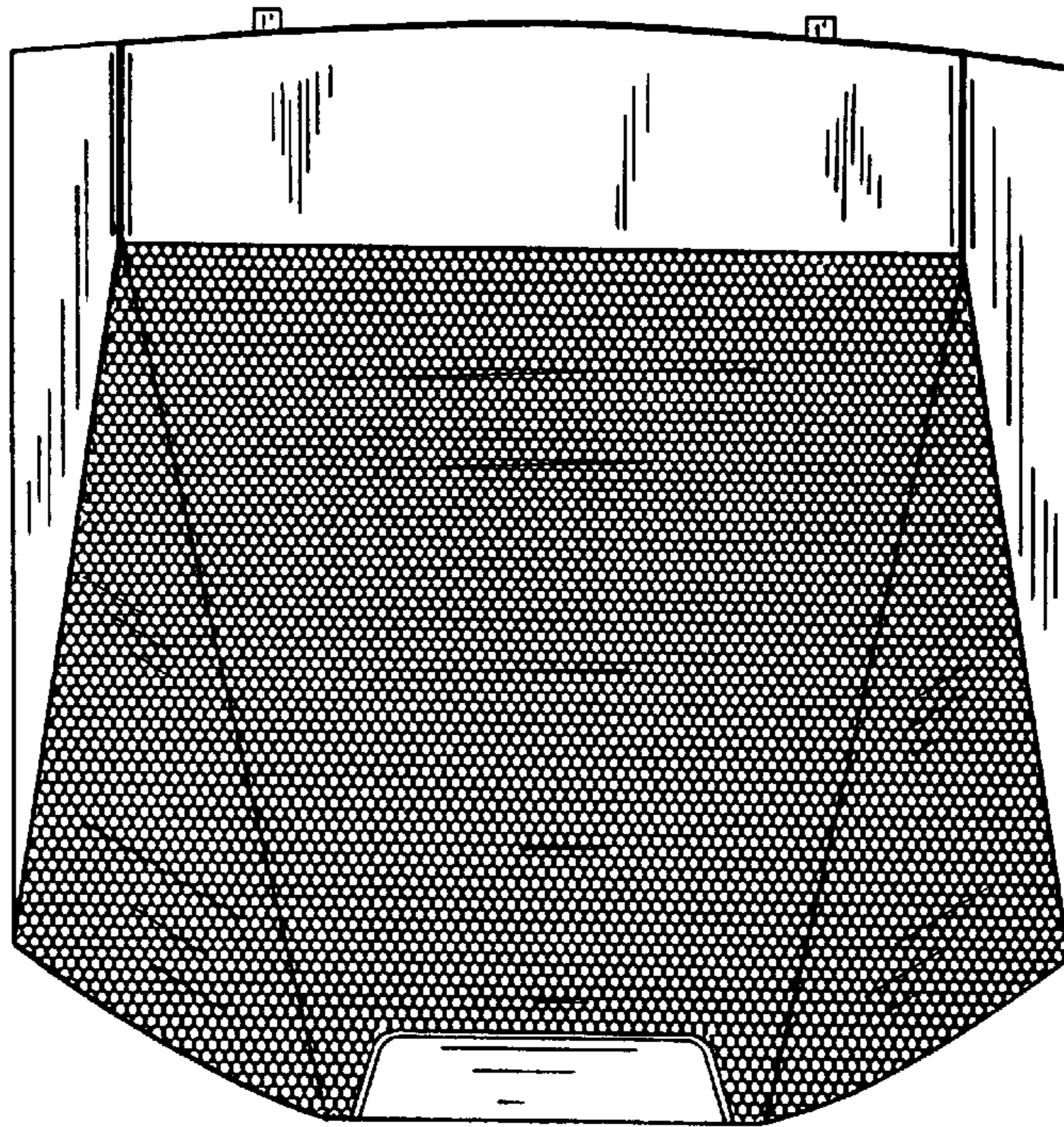

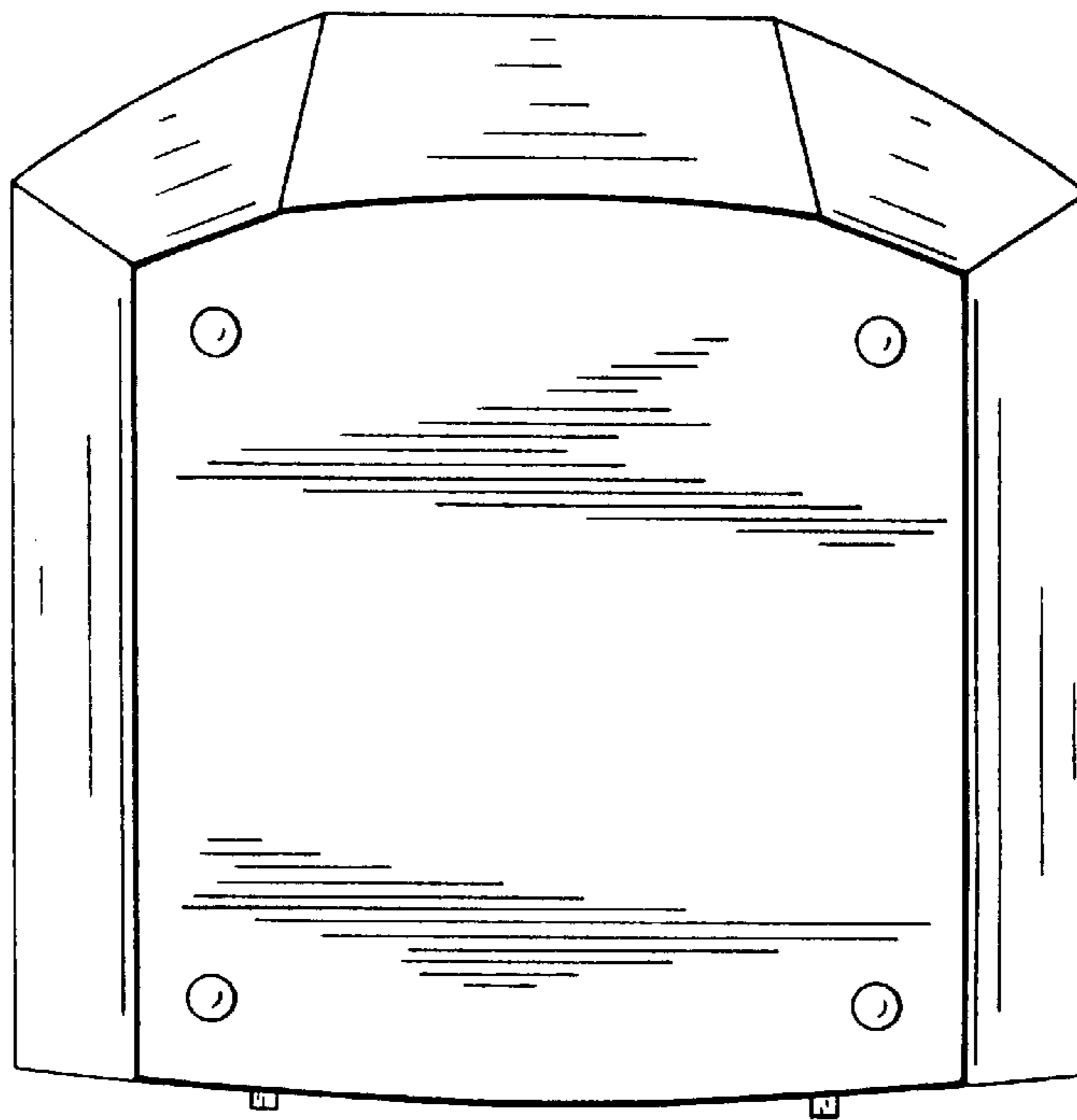

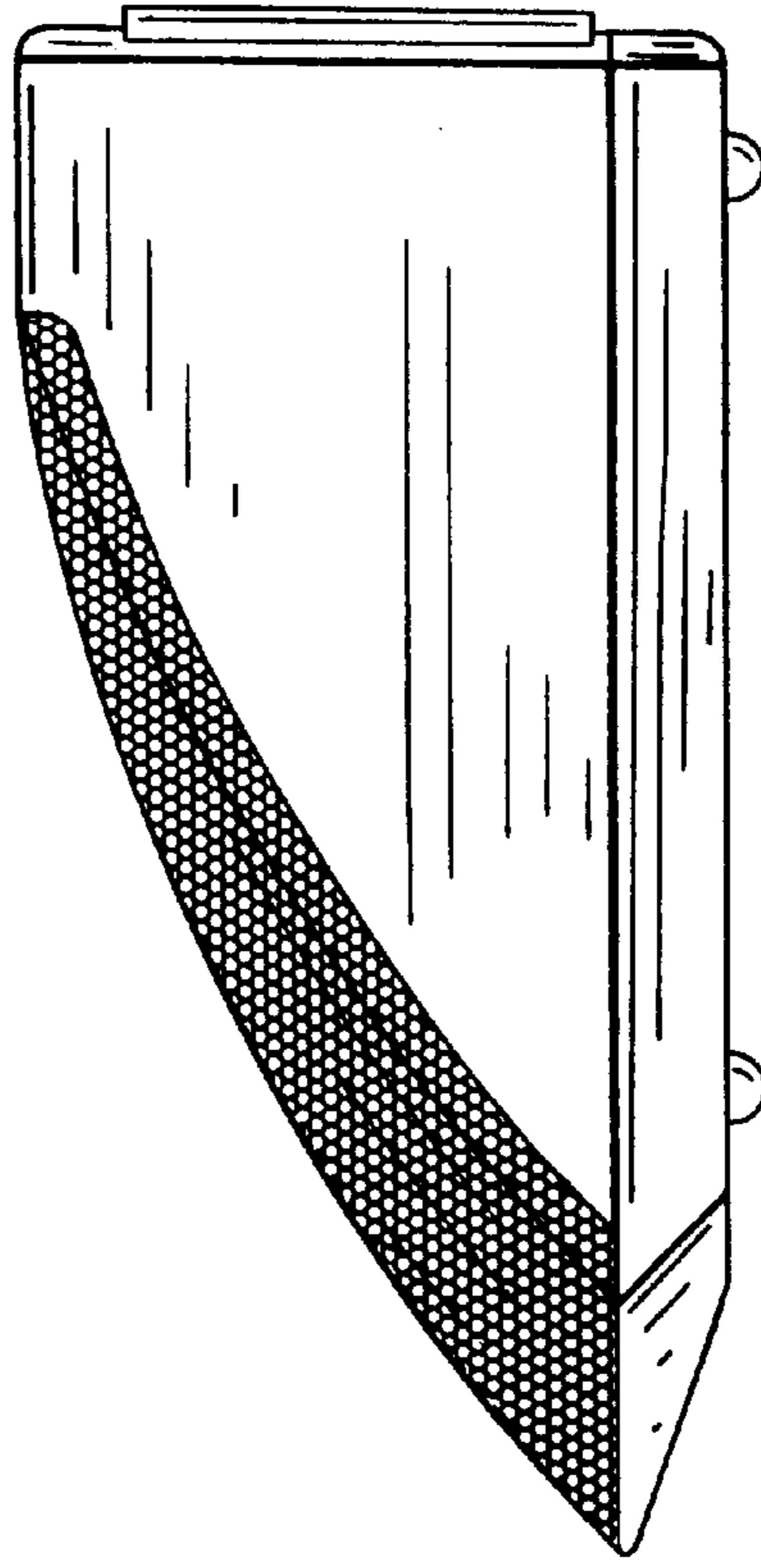

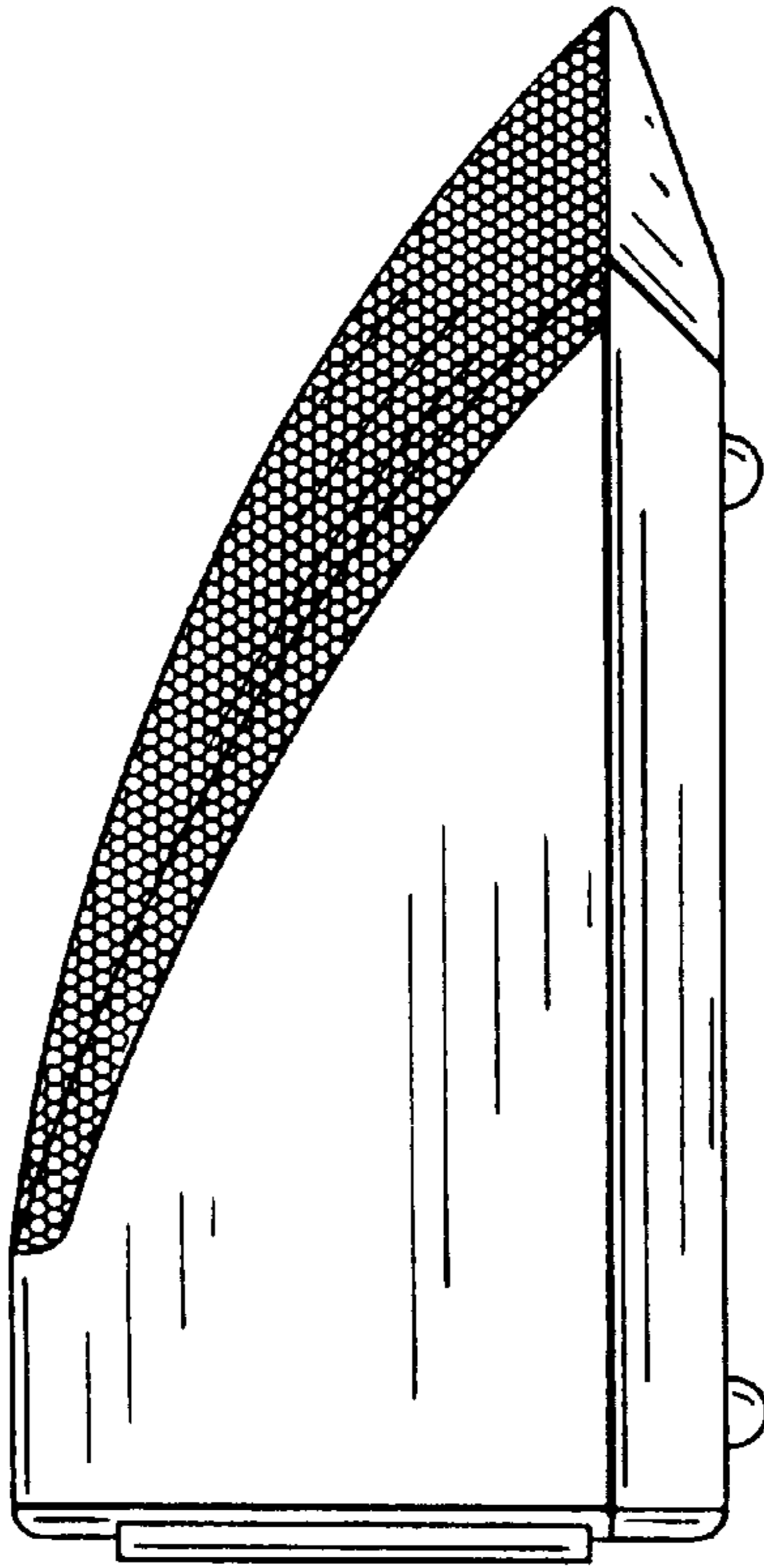

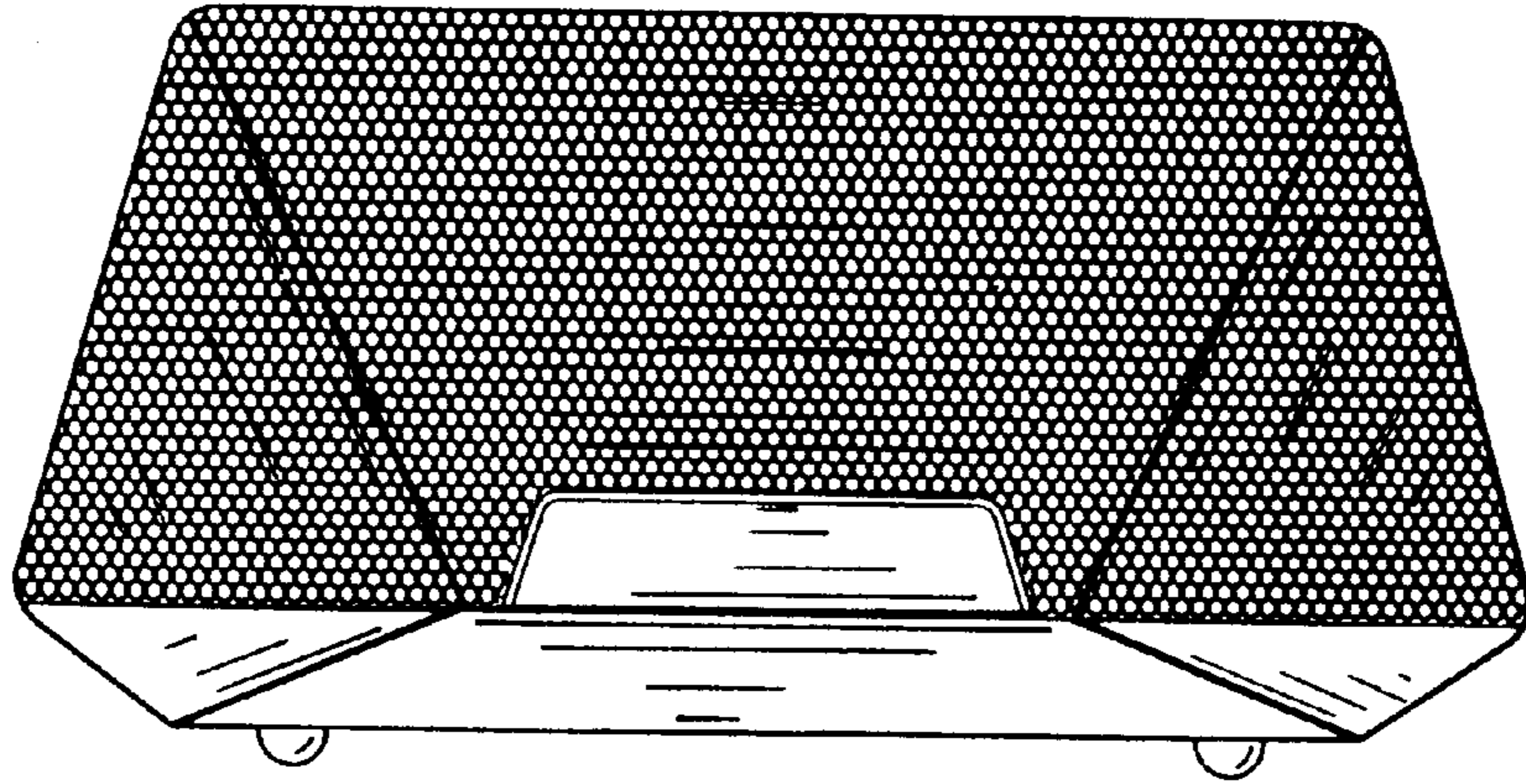
