[57] CLAIM

The ornamental design for a spiral ring memo clip, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of a first variant of a spiral ring memo clip showing a first embodiment of my new design, and a memo card attached thereto; FIG. 2 is another front, top and left side perspective view thereof;

FIG. 3 is a front view thereof, the rear view being a mirror image;

FIG. 4 is a right side view thereof, the left side view being a mirror image;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a front, top and right side perspective view of a second variant of a spiral ring memo clip showing a second embodiment of my new design;

FIG. 8 is a front view thereof, the rear view being a mirror image;

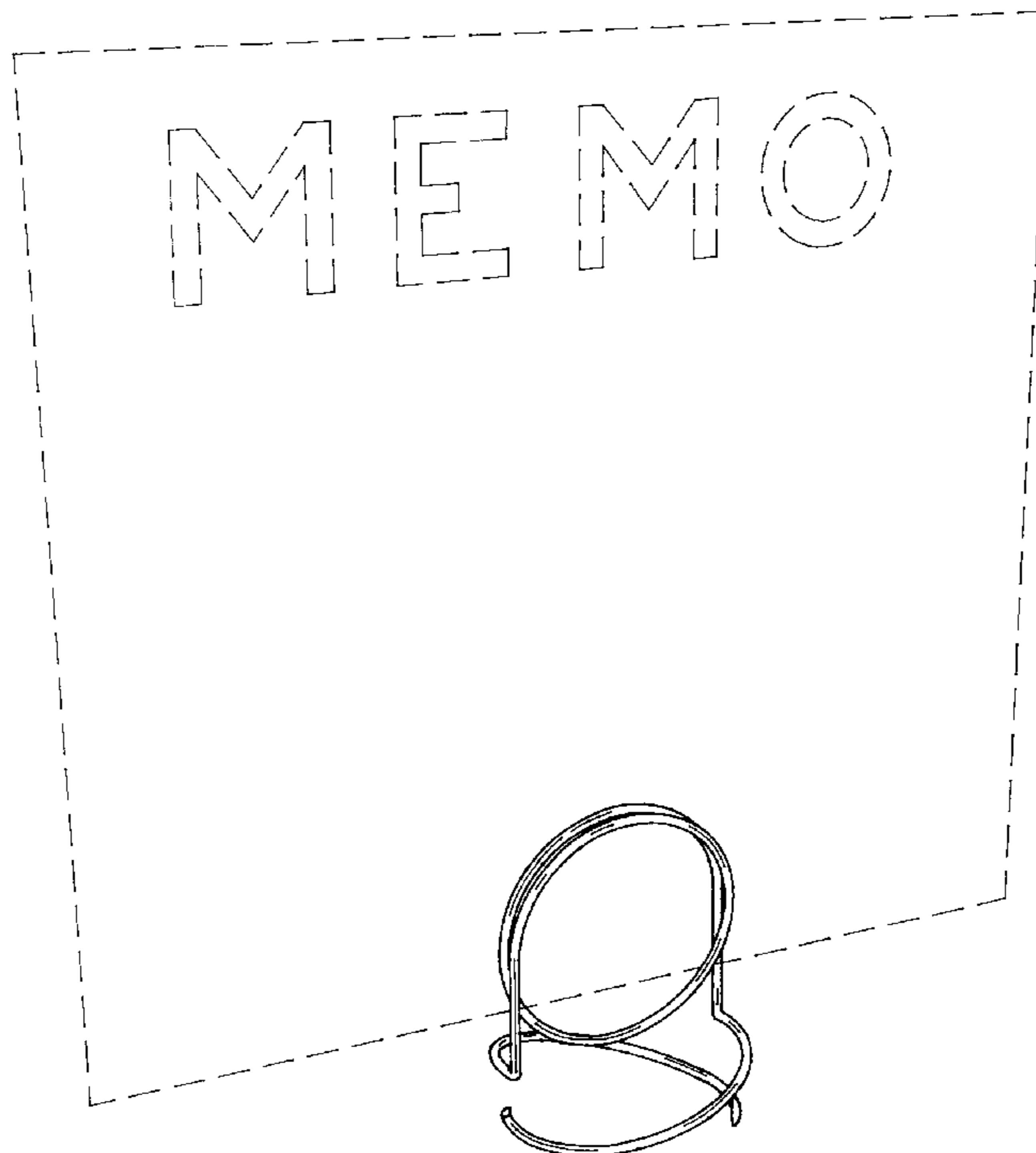
FIG. 9 is a right side view thereof, the left side view being a mirror image;

FIG. 10 is a top view thereof; and,

FIG. 11 is a bottom view thereof.

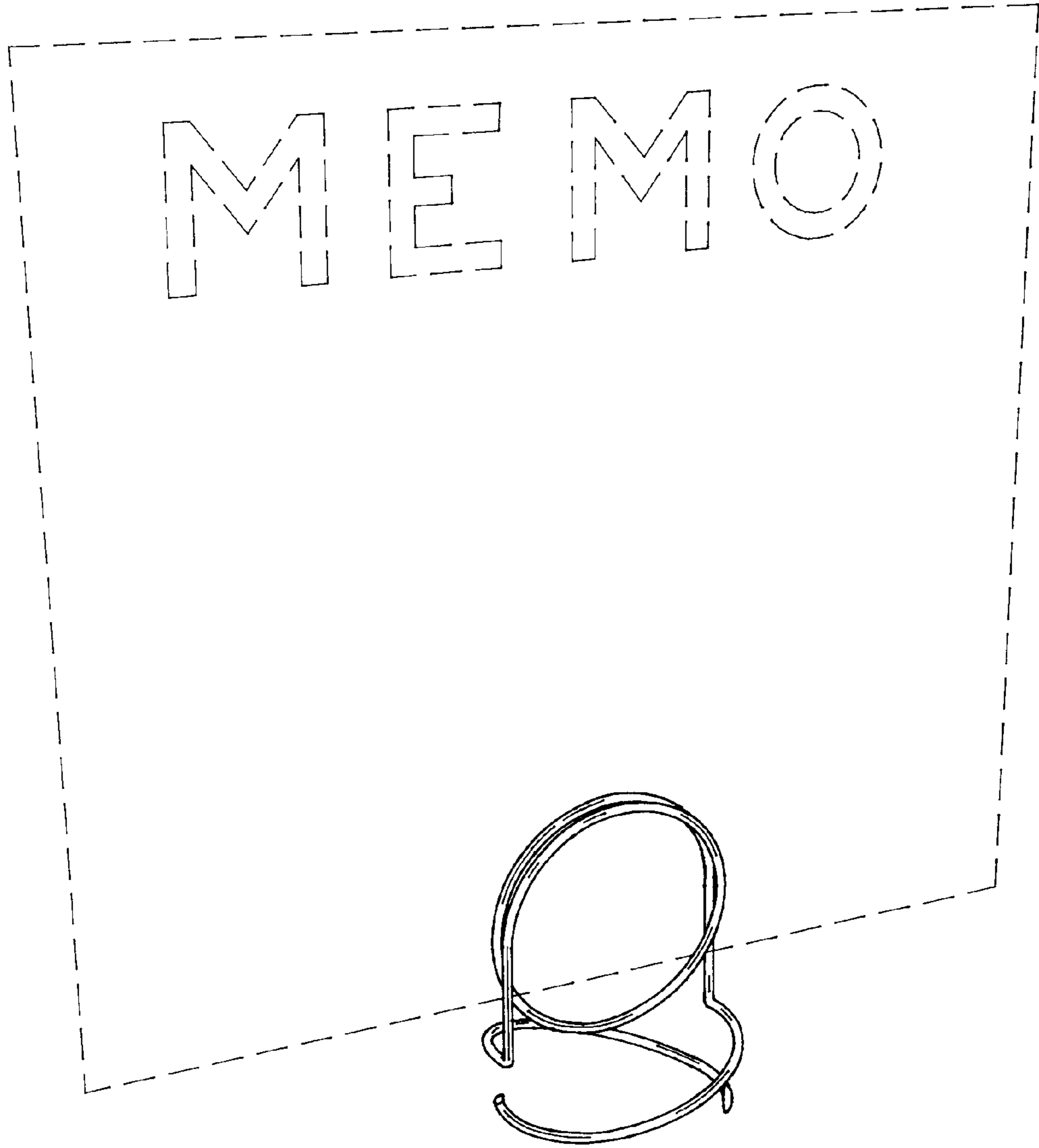

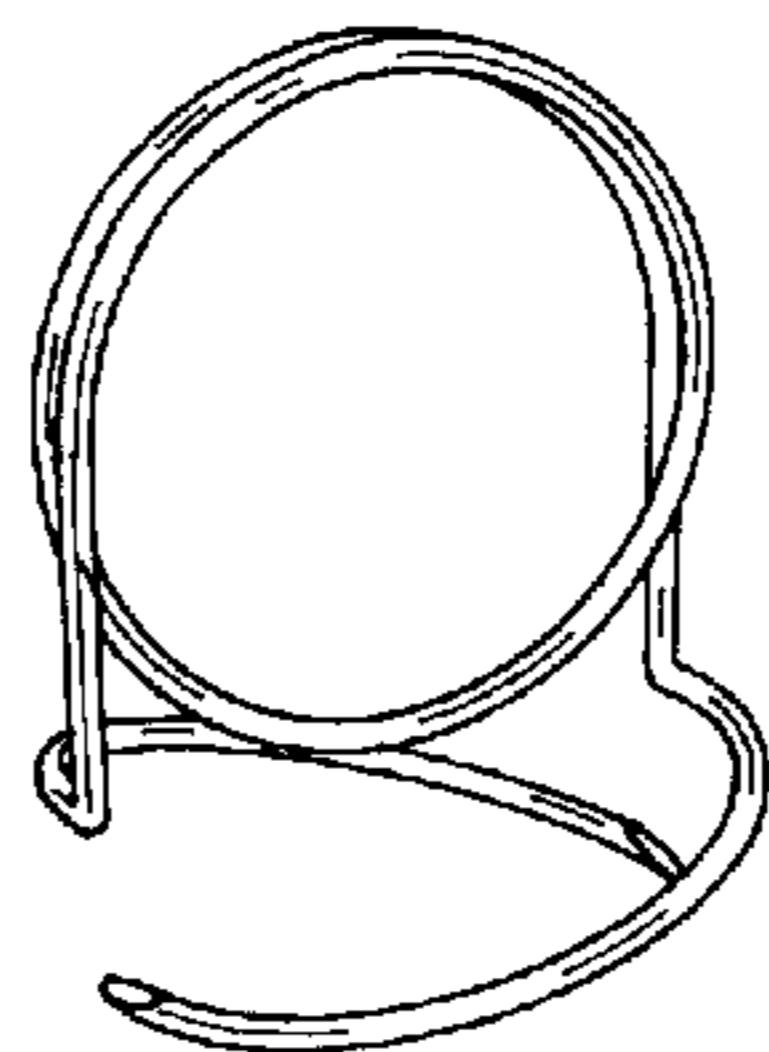

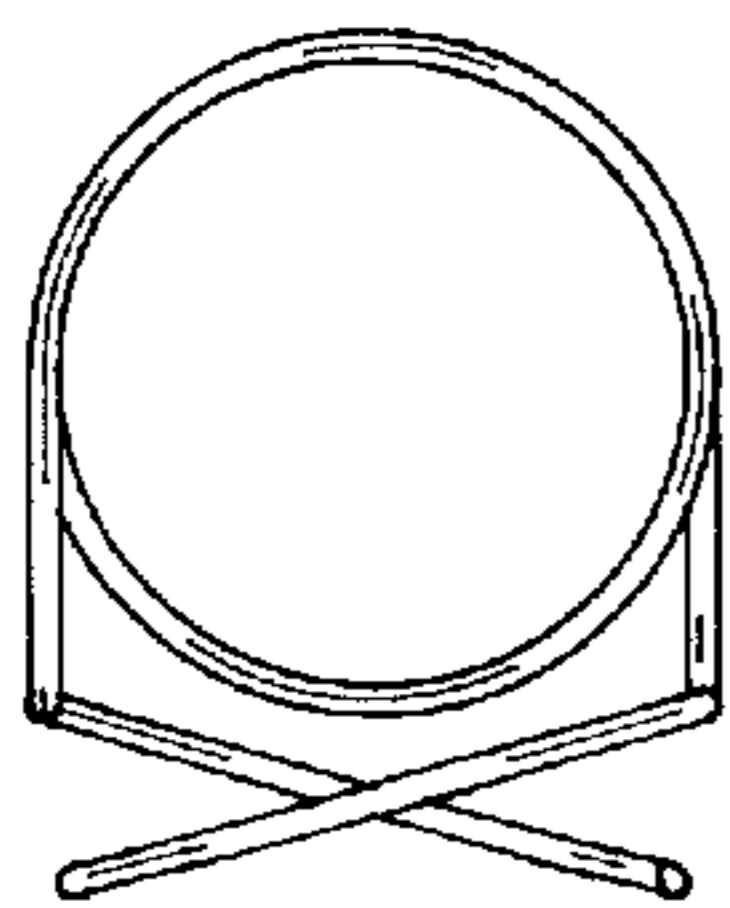

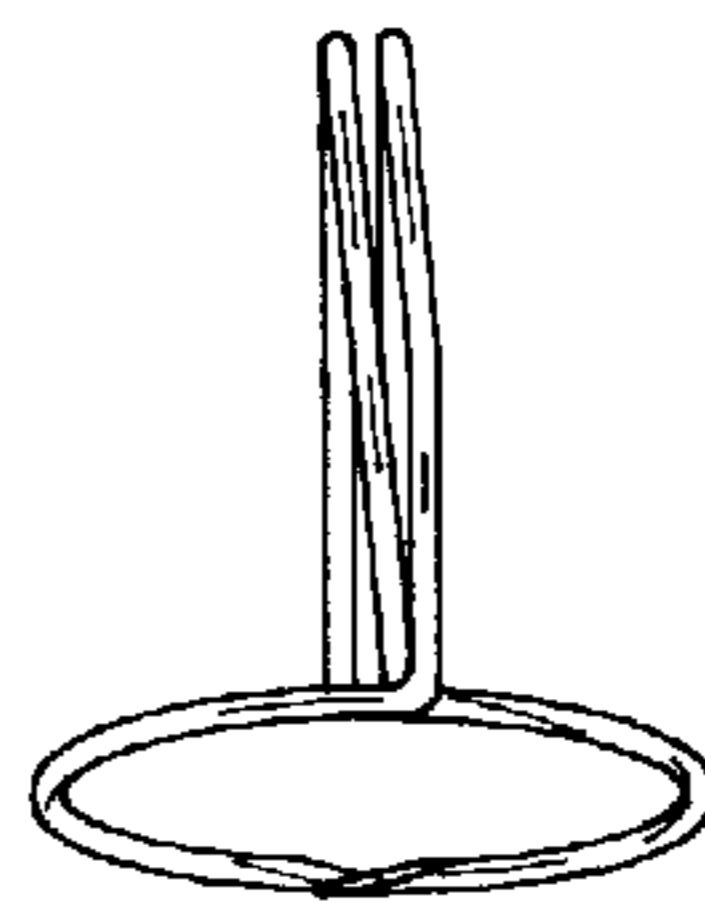

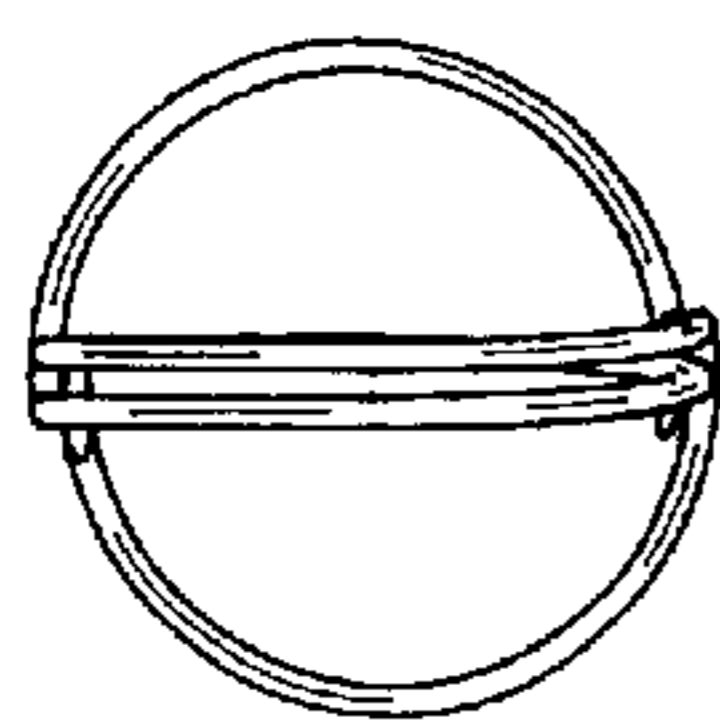

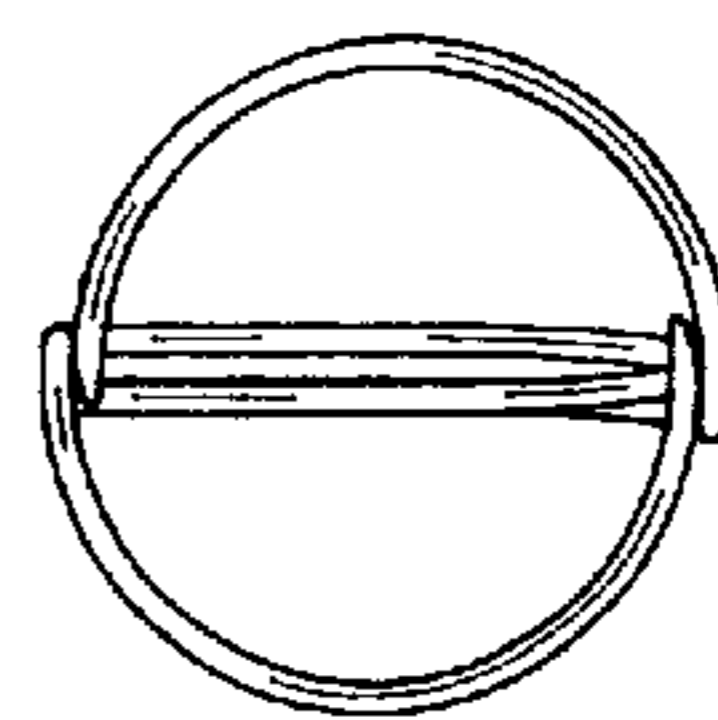

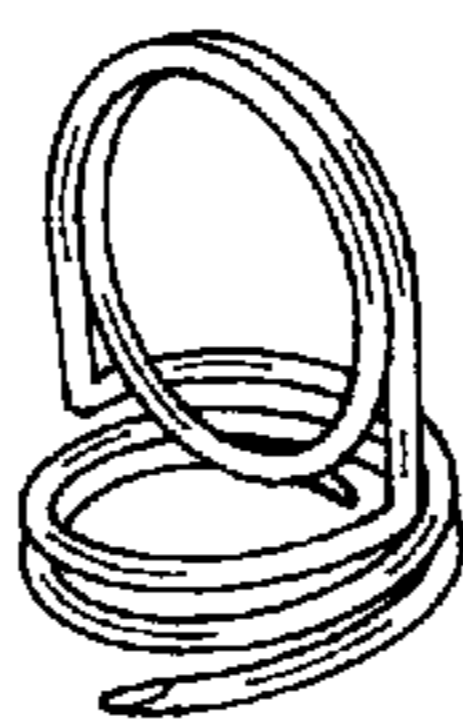

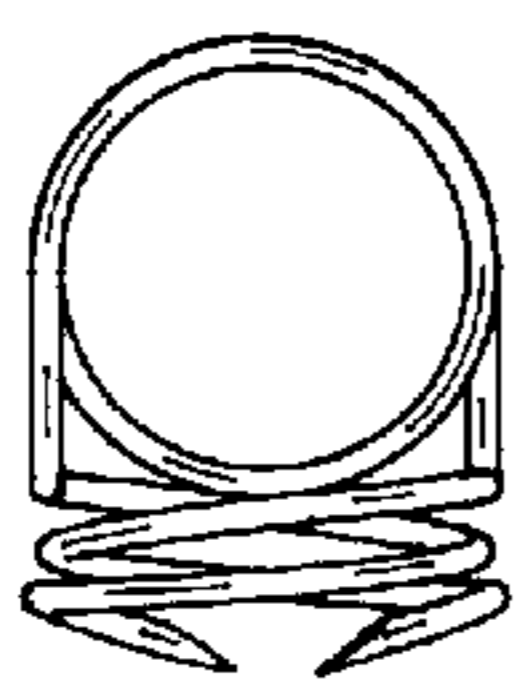

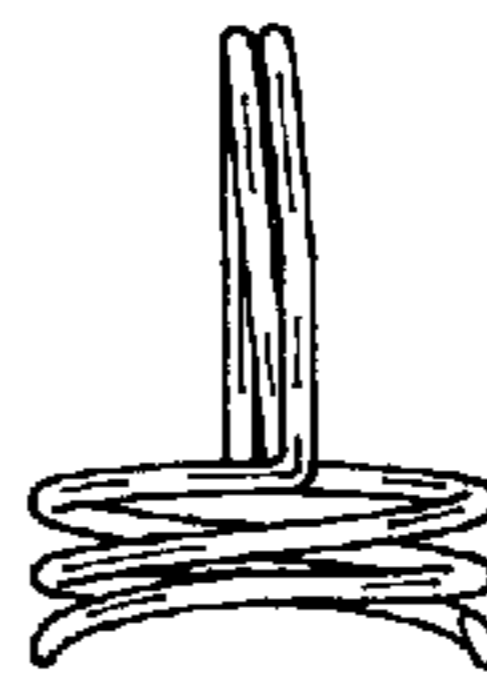

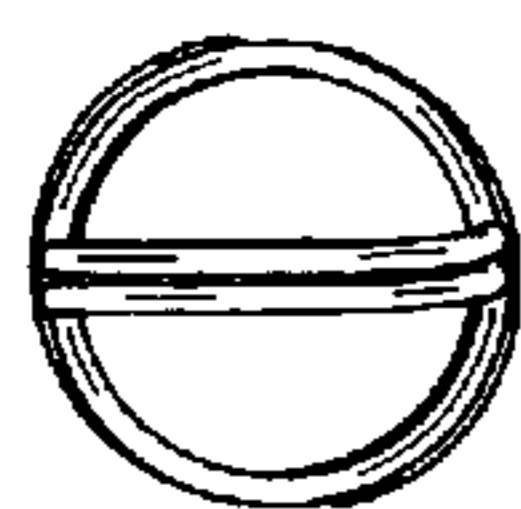

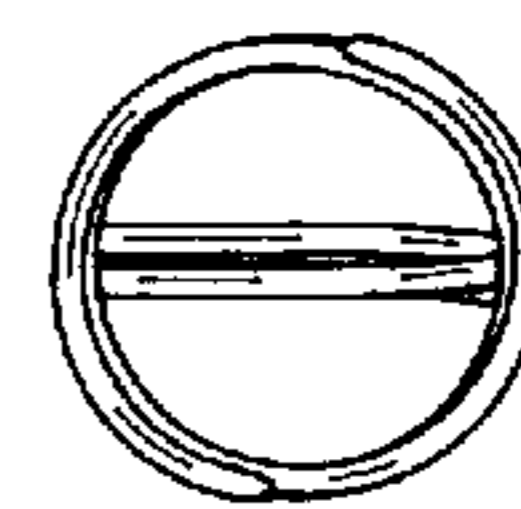
