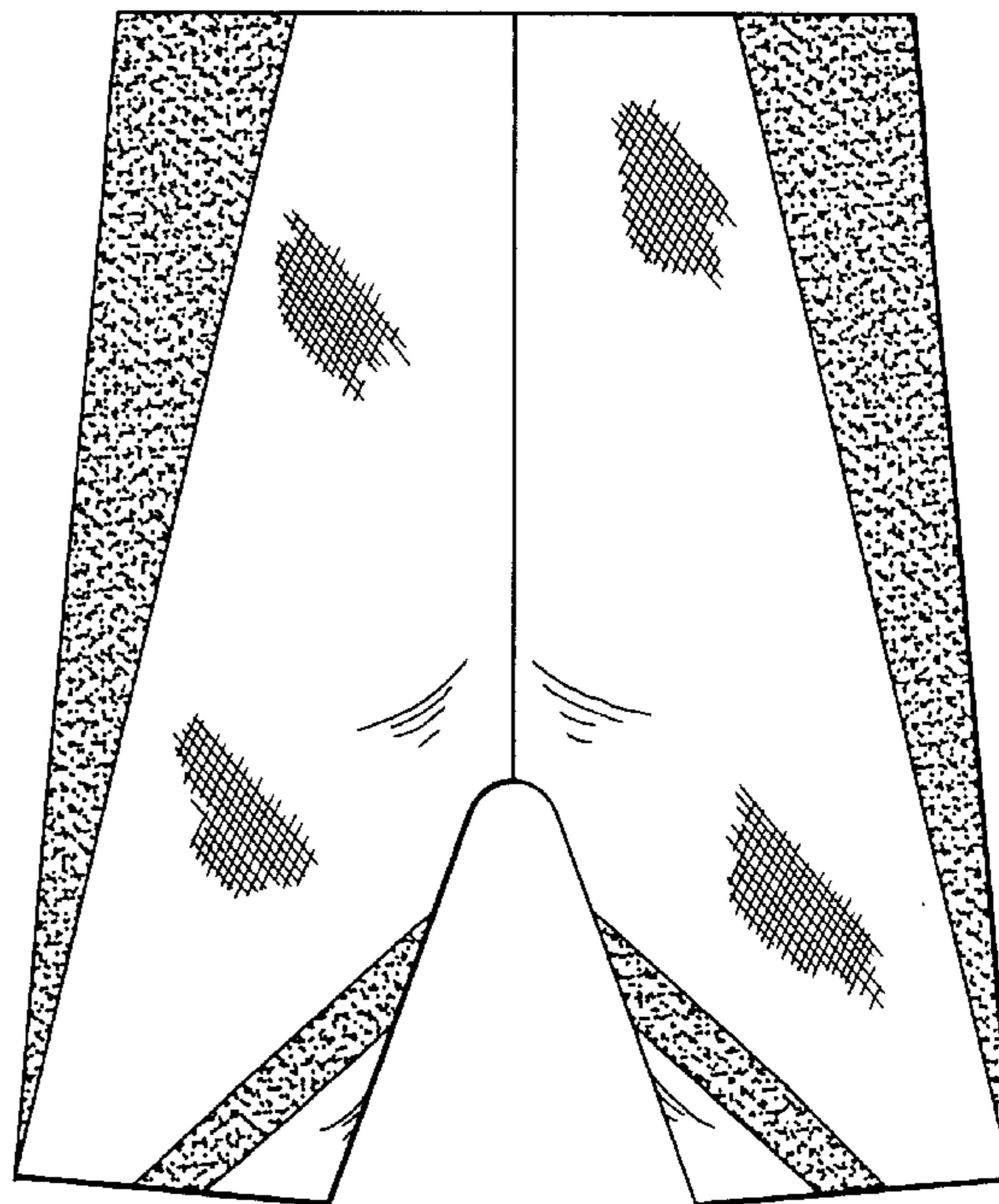
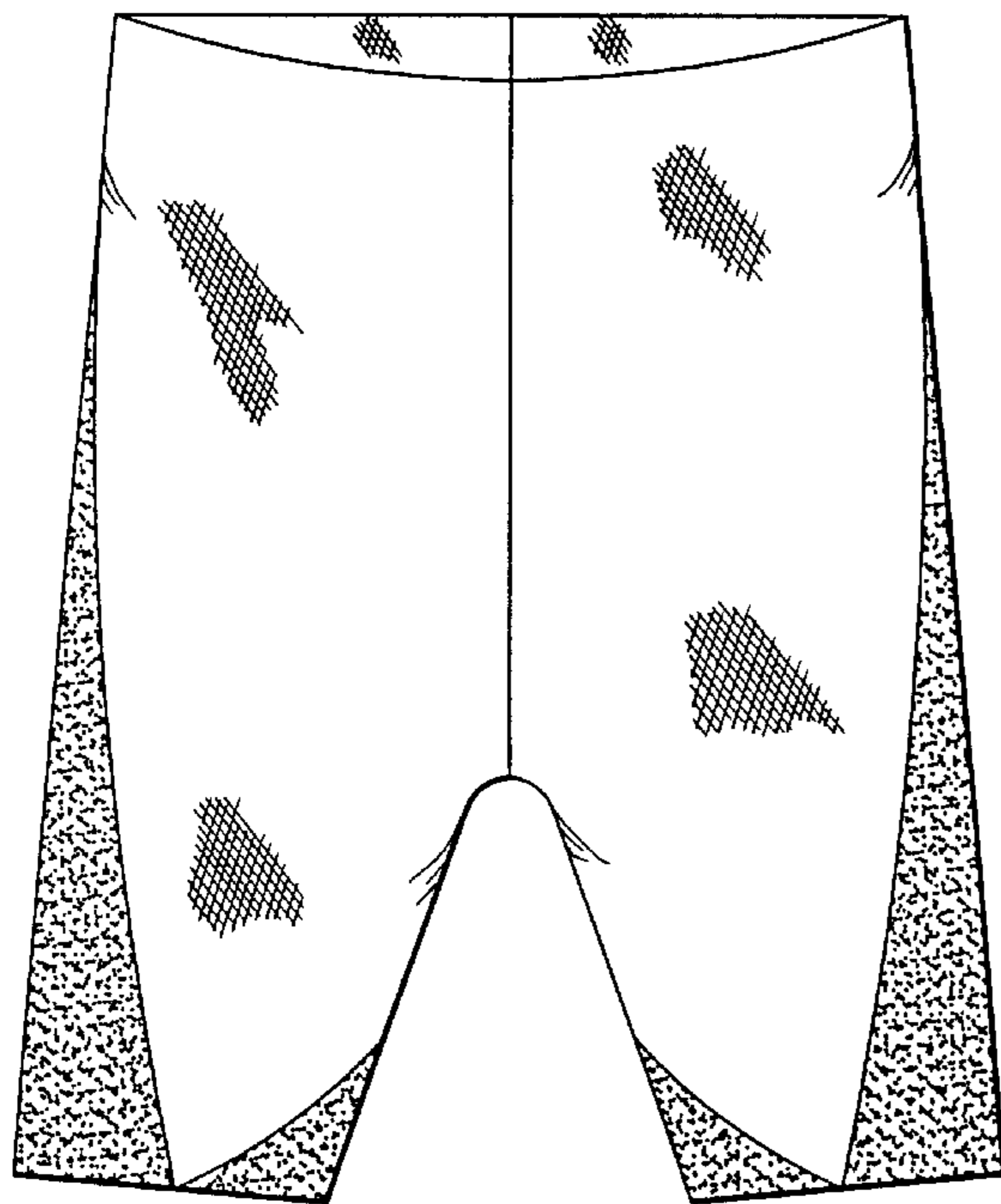
[57] CLAIM

The ornamental design for sports shorts, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of sports shorts showing our new design; the broken lines partially showing a human form in FIGS. 1 and 2 being for illustrative purposes only and forming no part of the claimed design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a side elevational view thereof; and, FIG. 5 is a rear elevational view thereof.

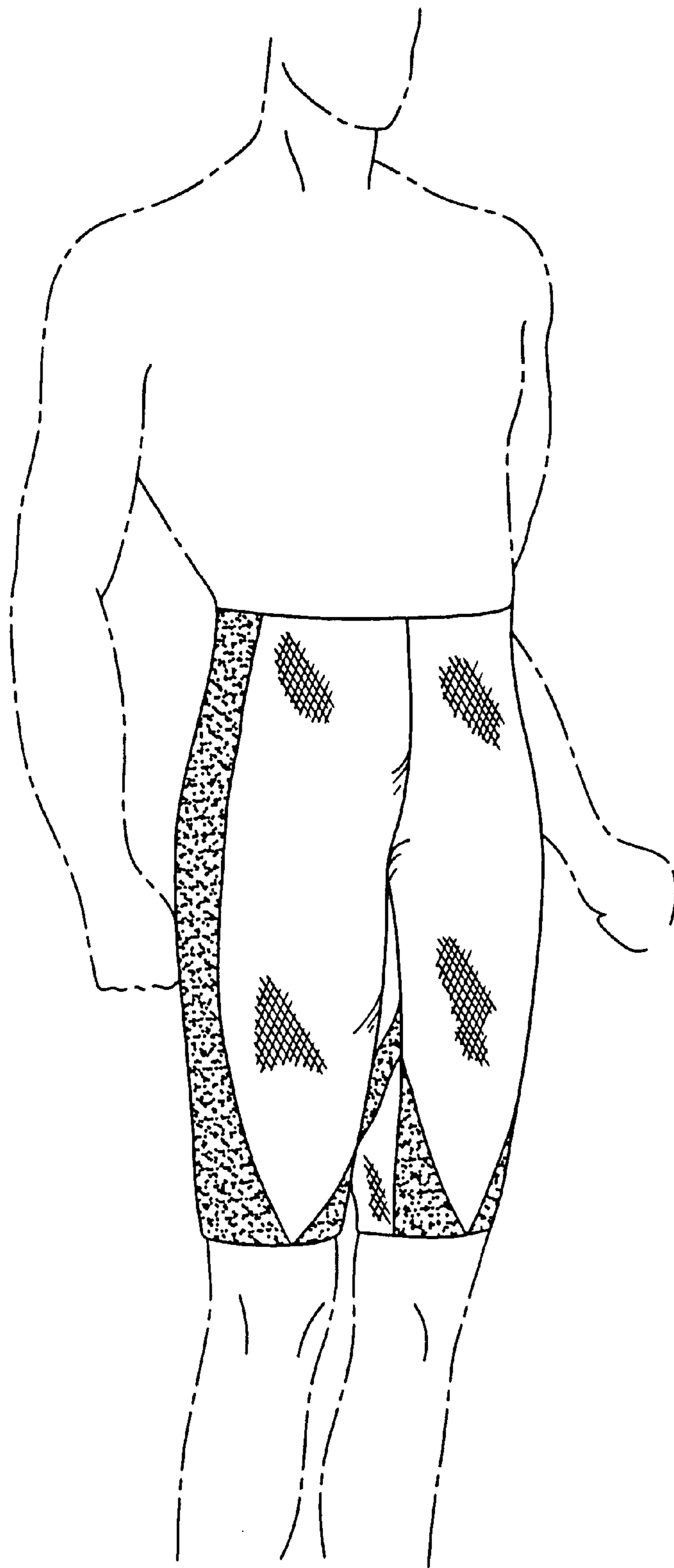

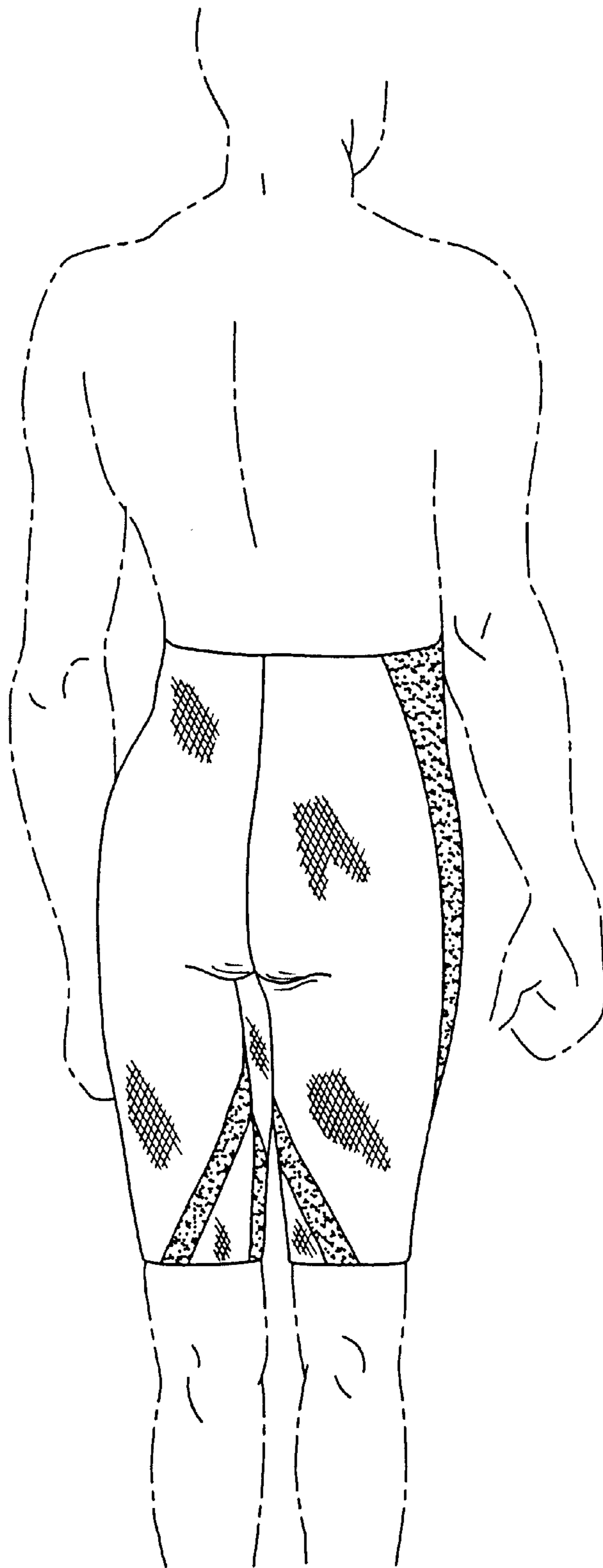

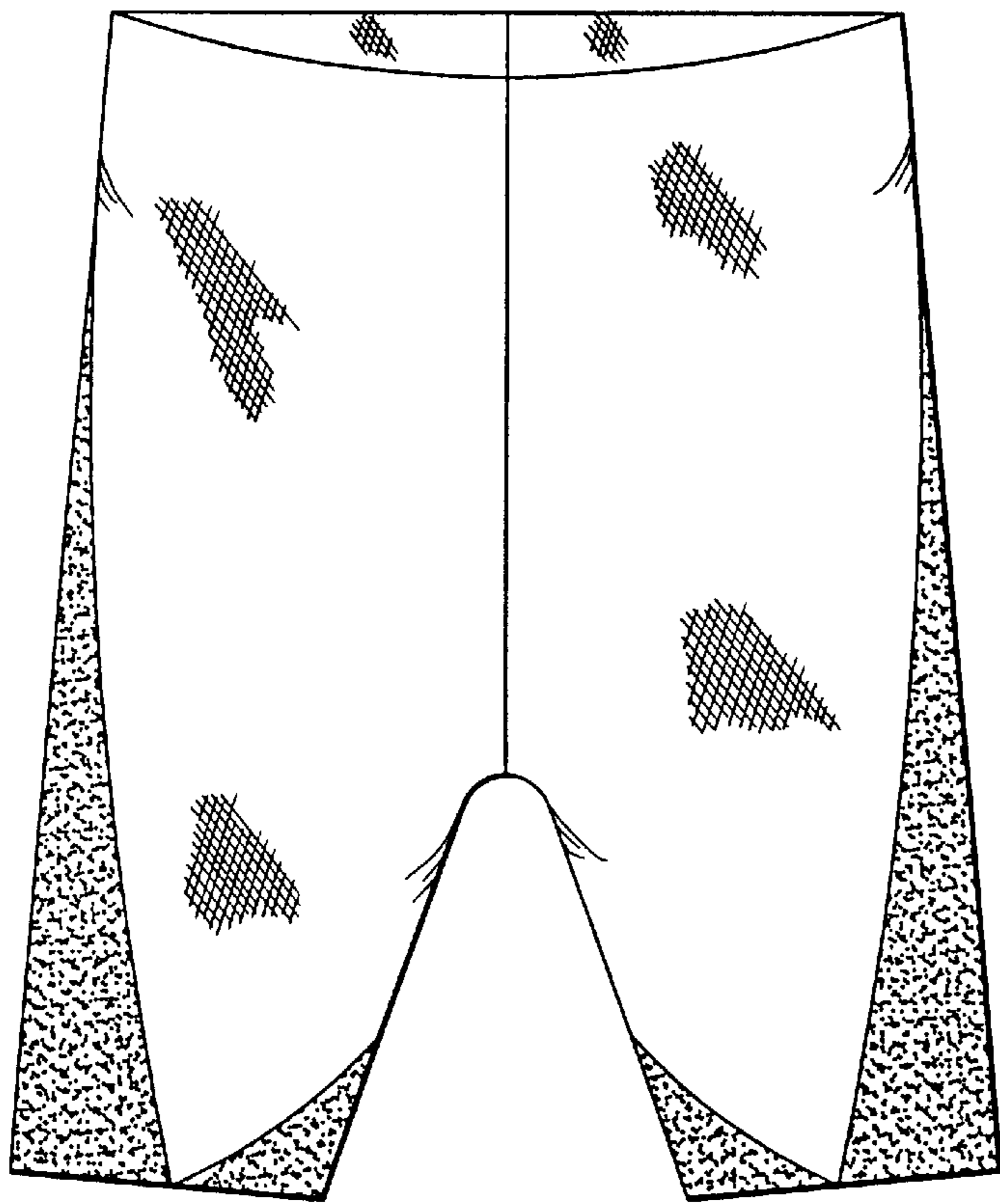

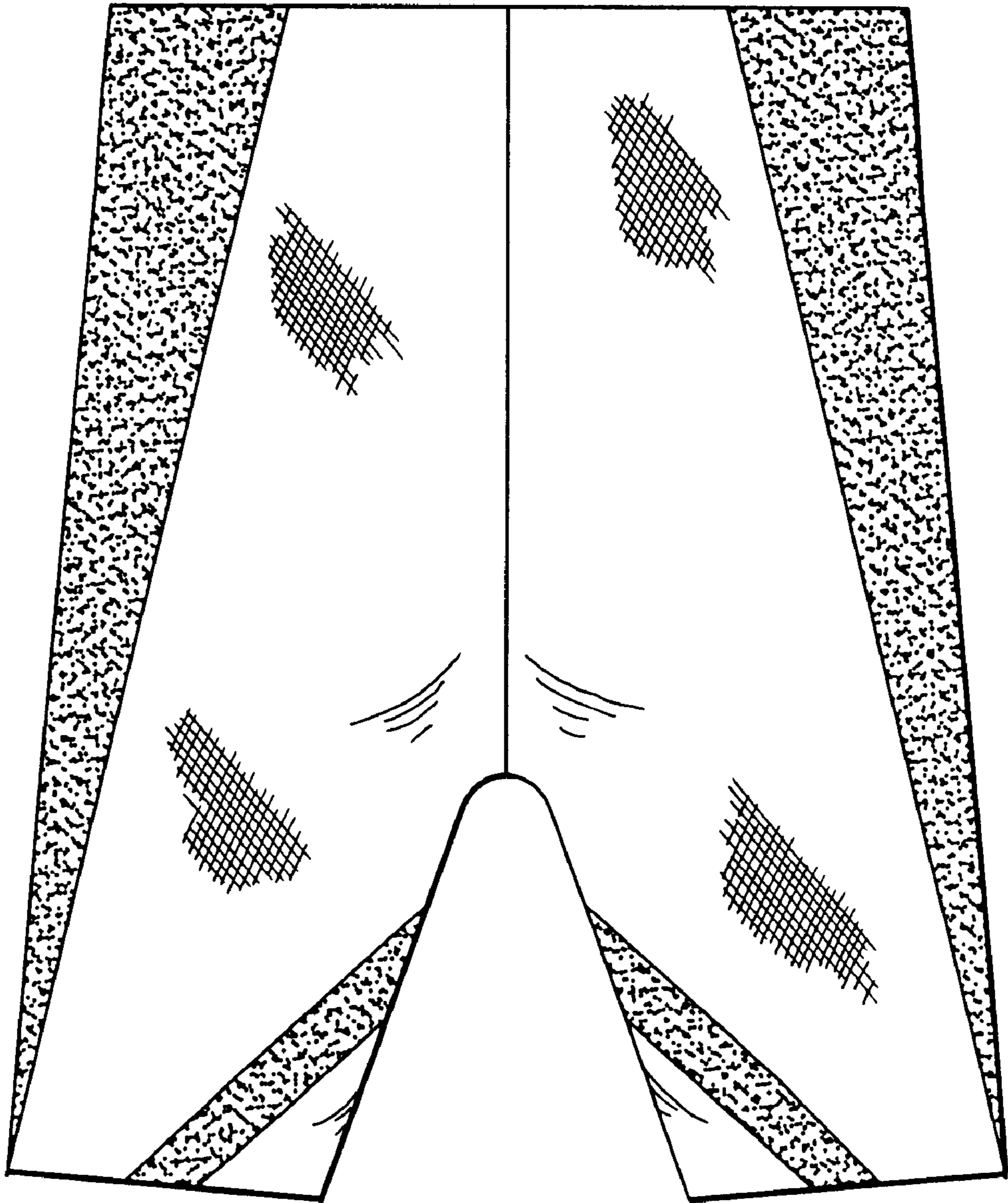
