[57] **CLAIM**

The ornamental design for a stamp with removable covers, as shown and described.

FIG. 1 is a top plan view showing my new design for a stamp with removable covers,

 FIG. 5 is a left side view thereof,

 FIG. 7 is a top plan view showing the upper cover of my new design for a stamp with removable covers,
 FIG. 8 is a bottom plan view thereof,
 FIG. 9 is a front view thereof,
 FIG. 10 is a back view thereof,
 FIG. 11 is a left side view thereof,
 FIG. 12 is a right side view thereof,
 FIG. 13 is a top plan view showing my new design for a stamp with removable covers with the covers removed,
 FIG. 14 is a bottom plan view thereof,
 FIG. 15 is a front view thereof, the back view being a mirror image thereof,
 FIG. 16 is a left side view thereof, the right side view being a mirror image thereof,
 FIG. 17 is a top plan view showing the lower cover of my new design for a stamp with removable covers,
 FIG. 18 is a bottom plan view thereof,
 FIG. 19 is a front view thereof, the back view being a mirror image thereof,
 FIG. 20 is a left side view thereof, the back side view being a mirror image thereof; and,
 FIG. 21 is a front view of a modified form of the stamp with removable covers of FIGS. 1-6 showing four stamps of FIGS. 13-16.

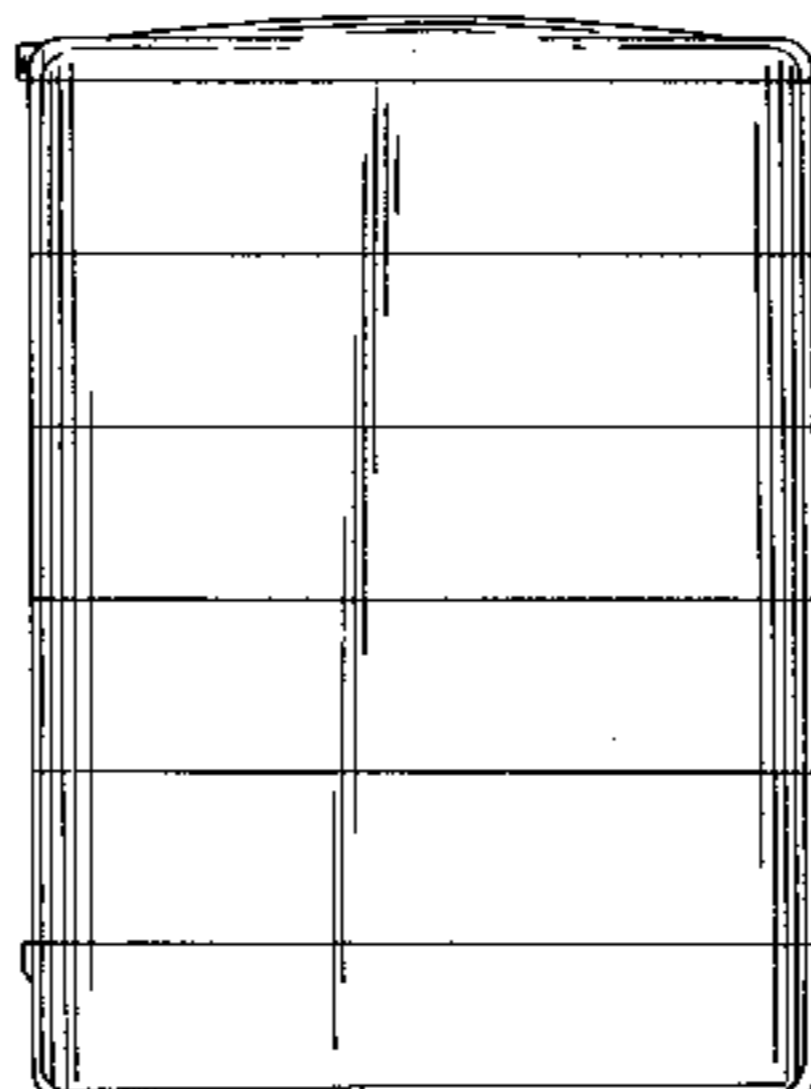
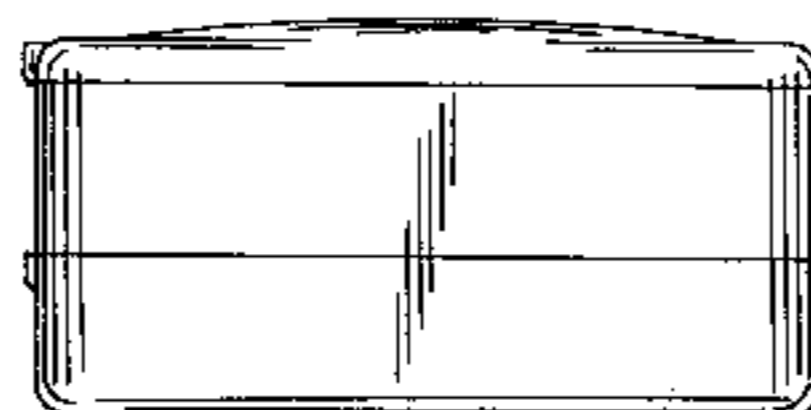
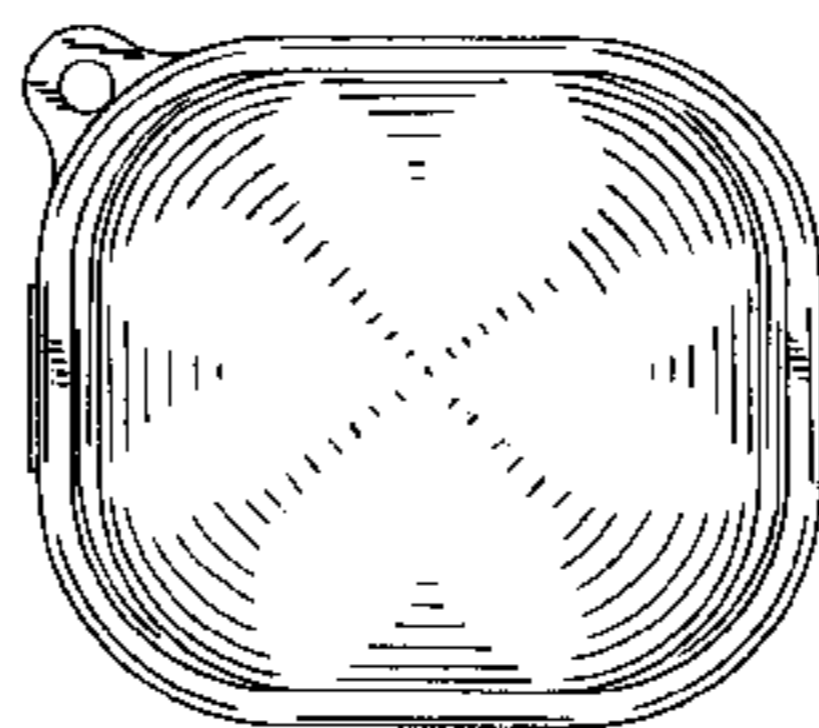

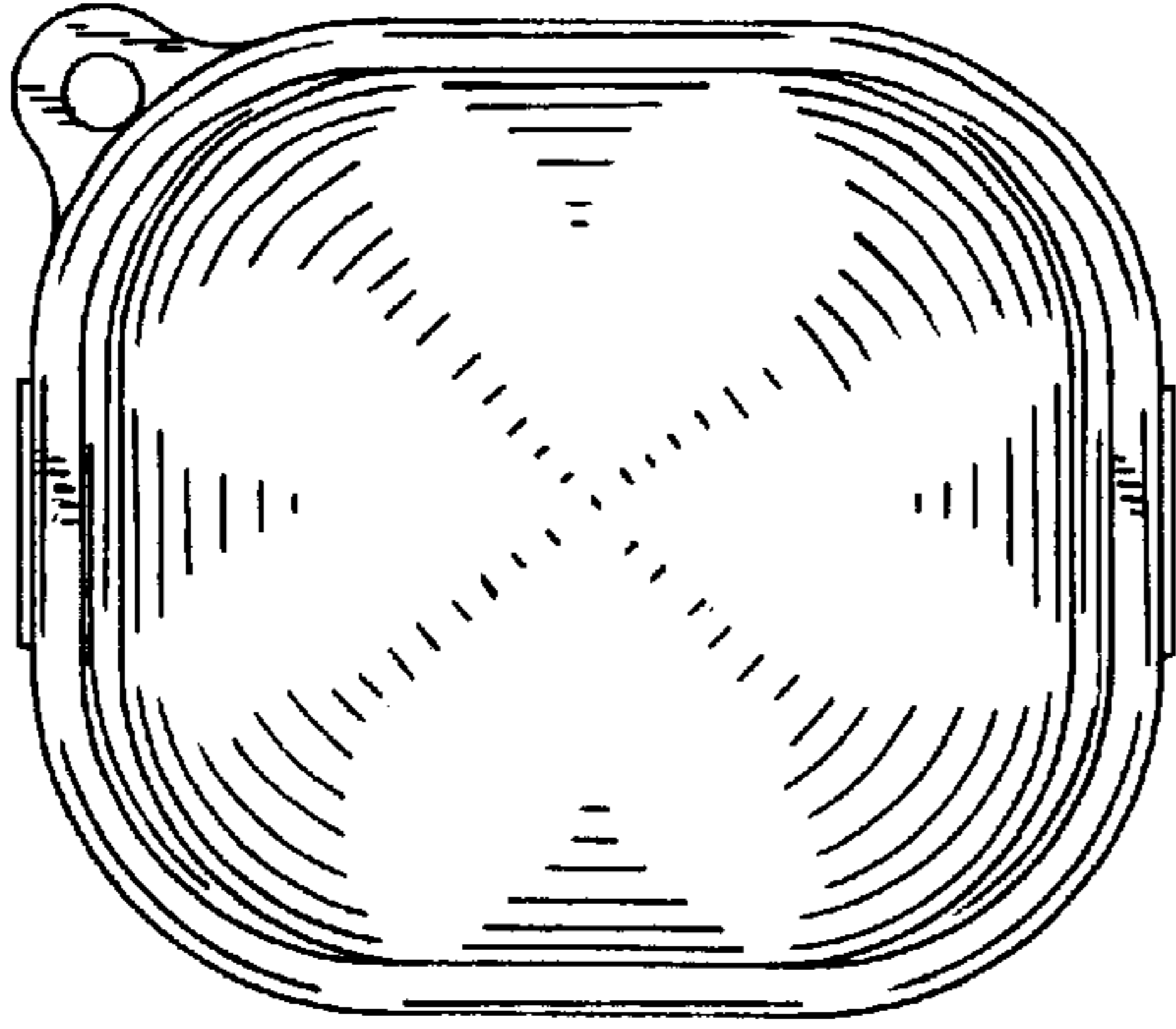

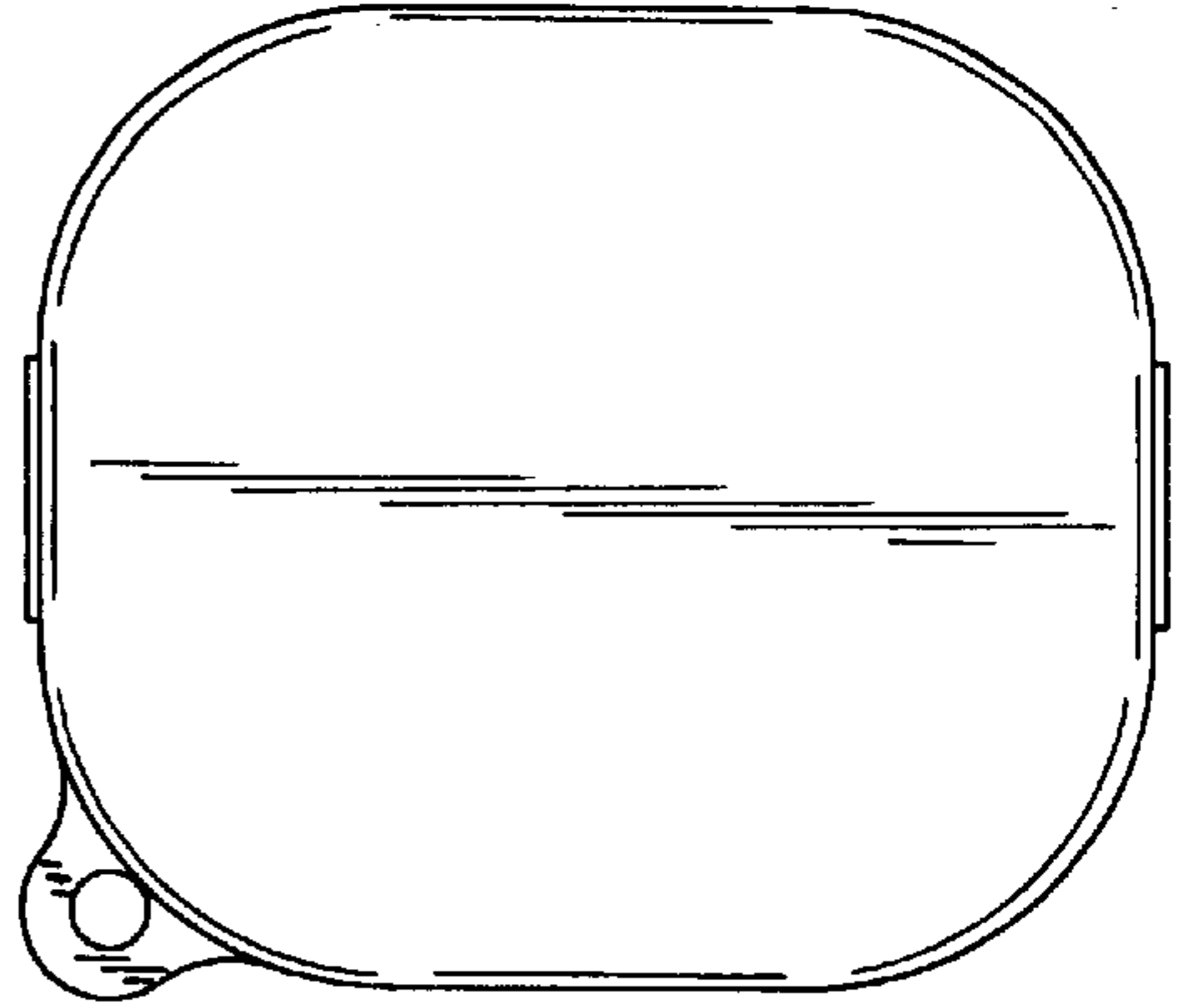

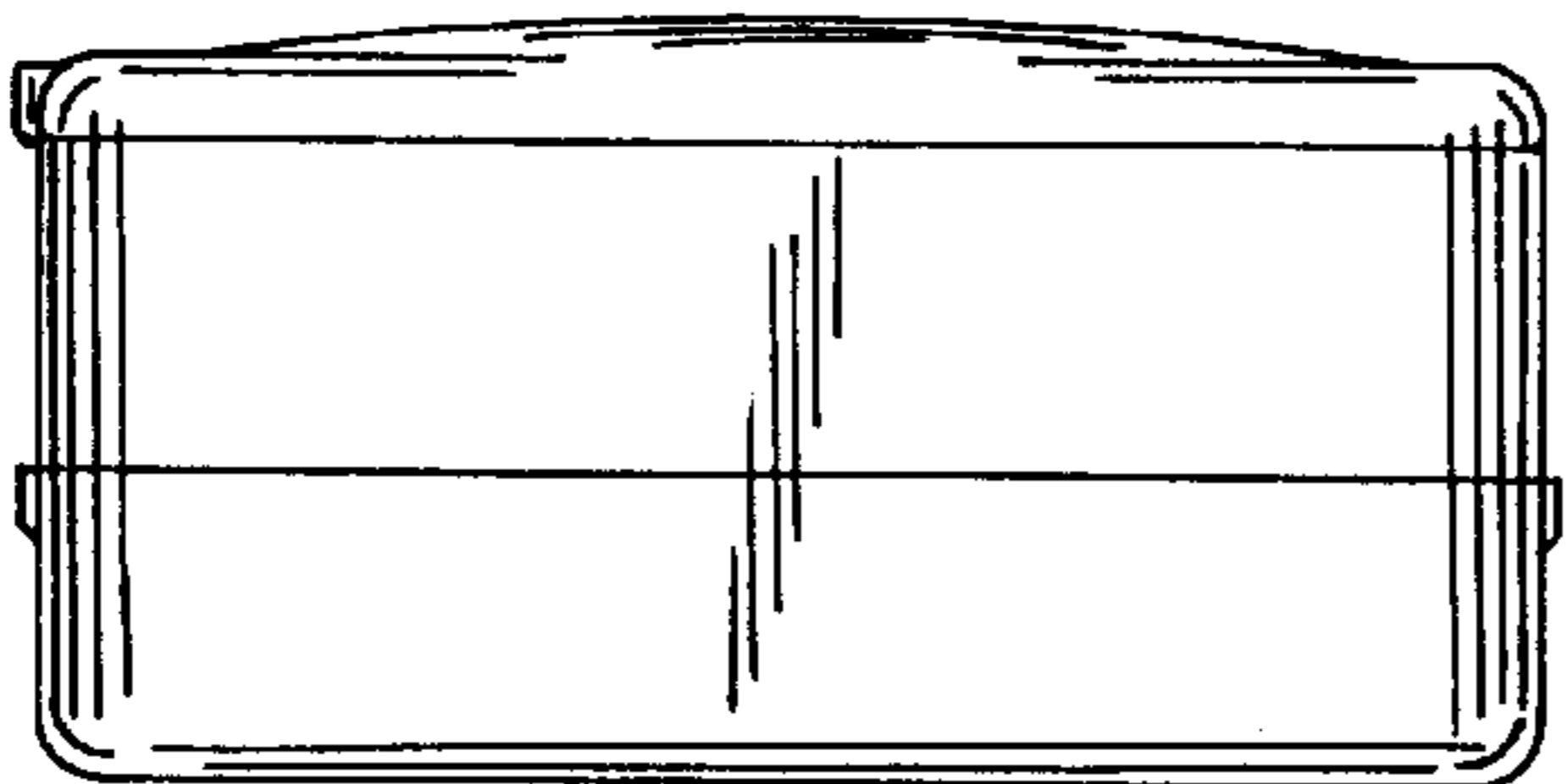

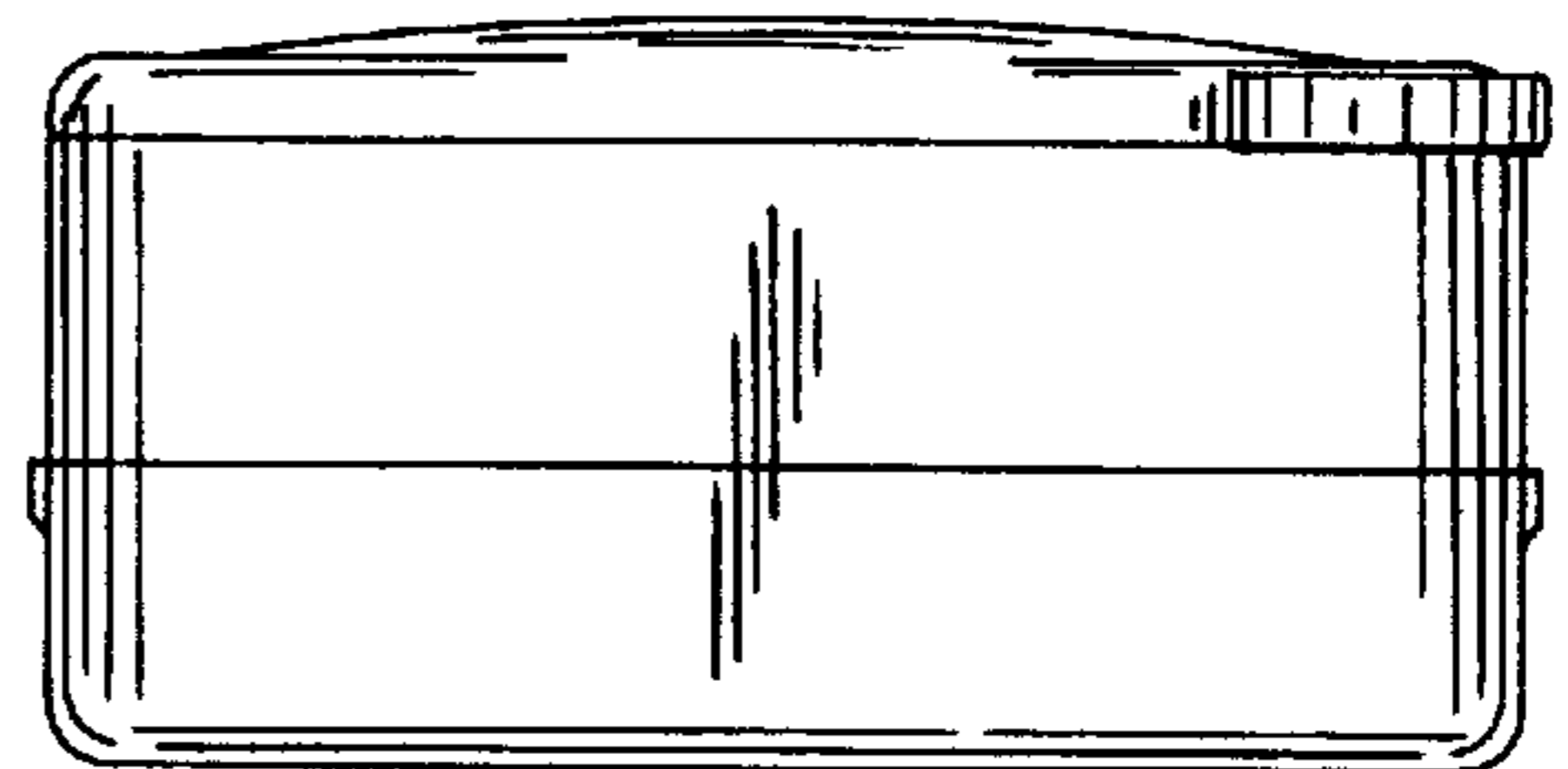

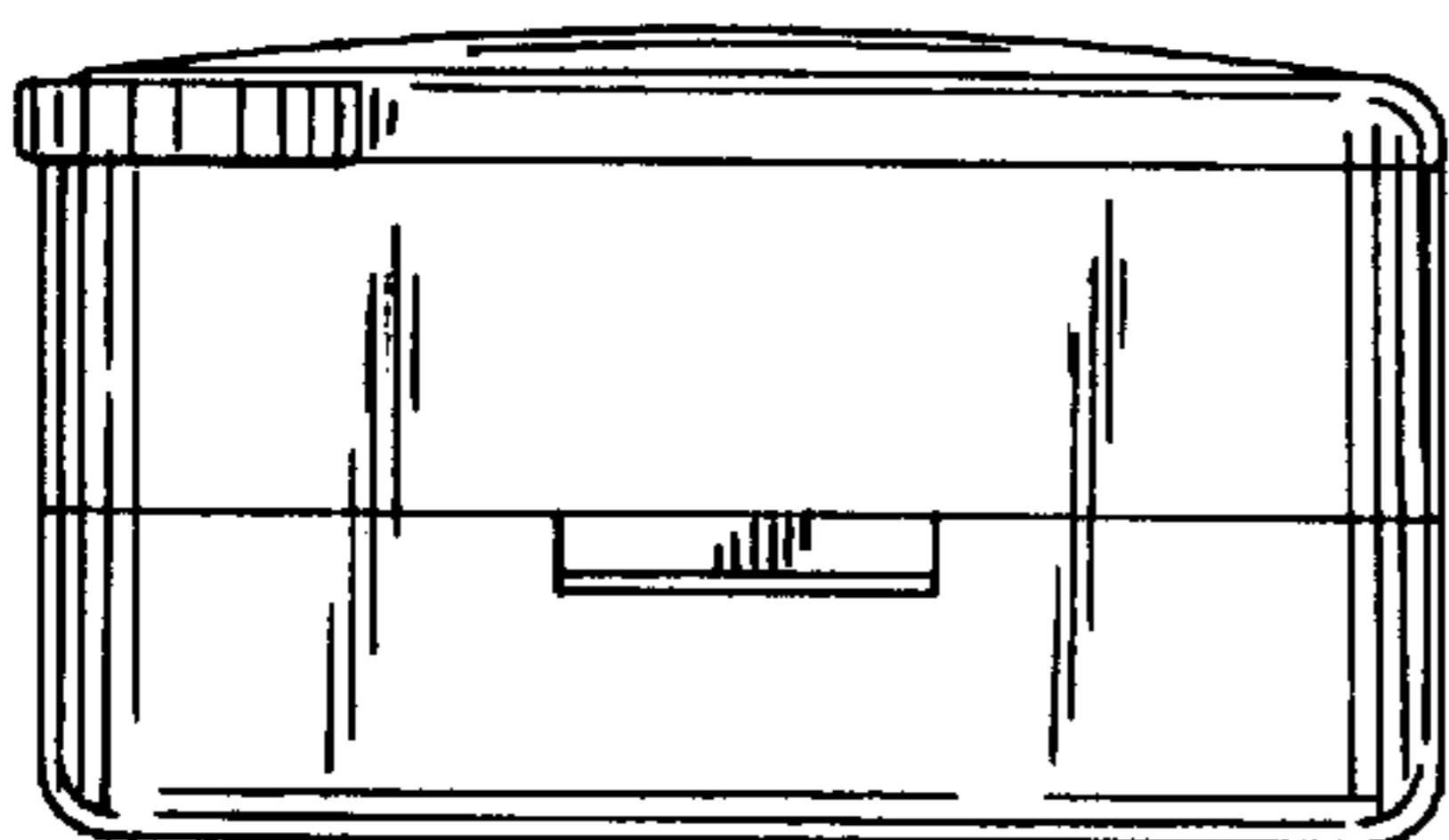

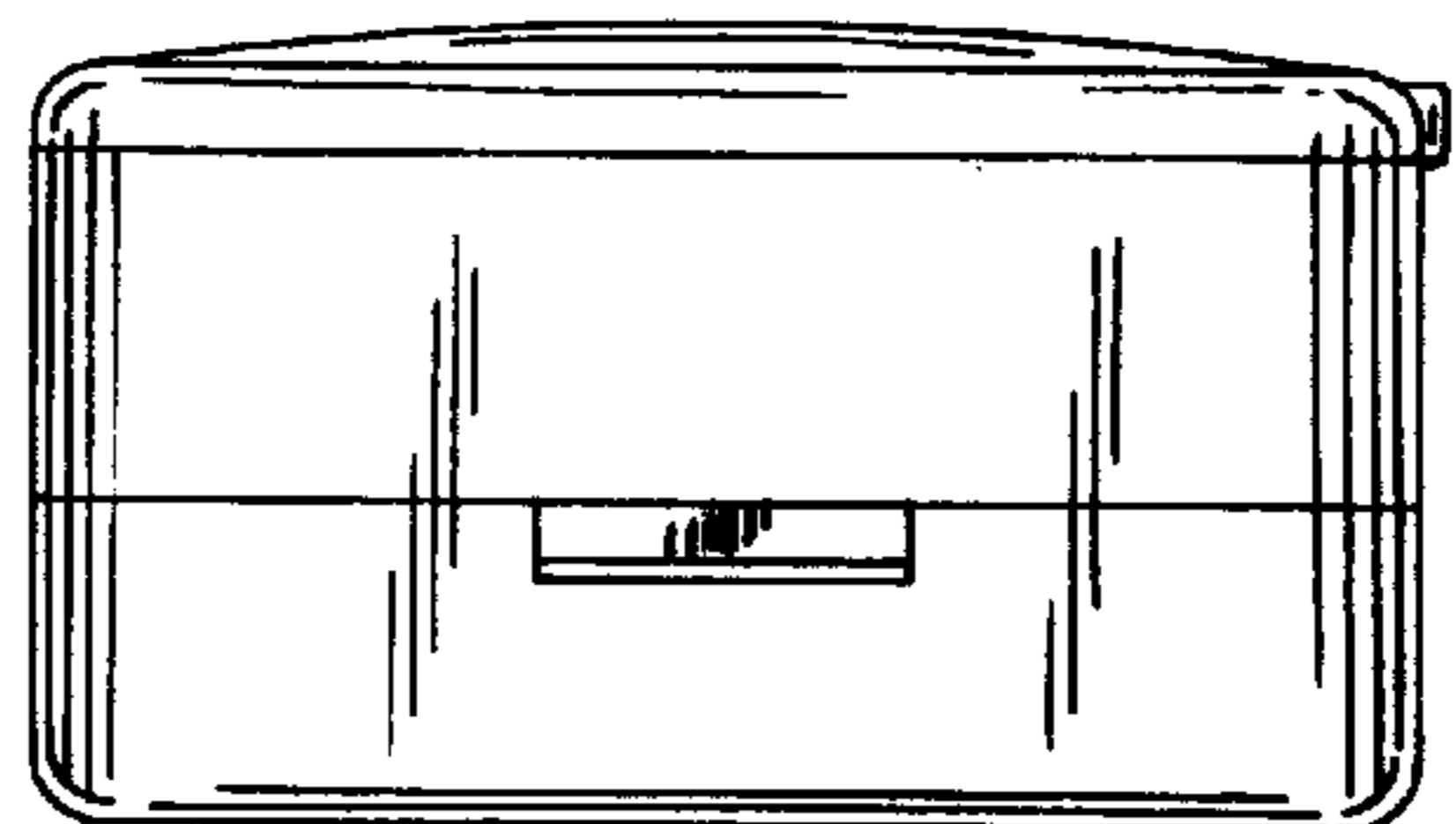

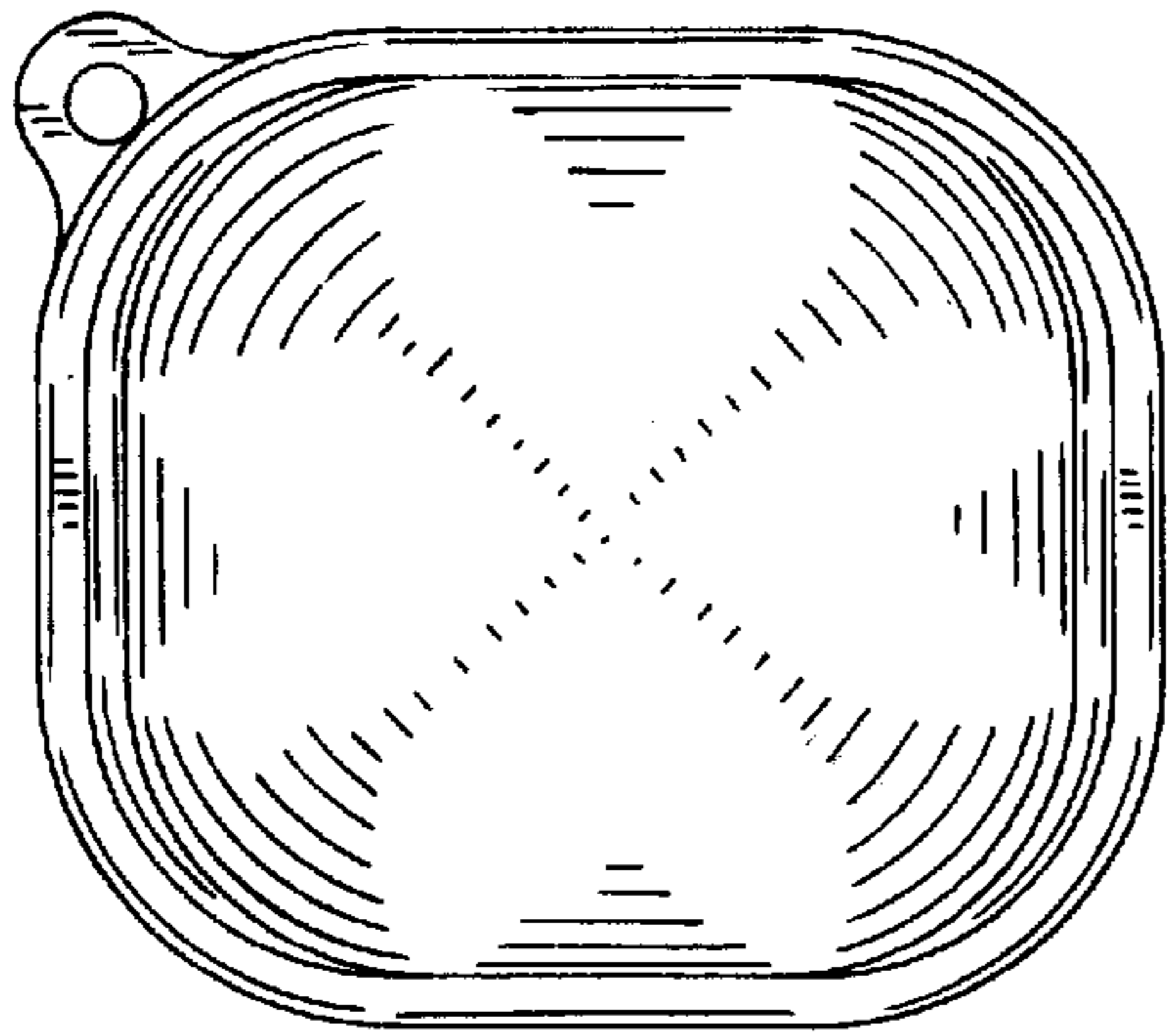

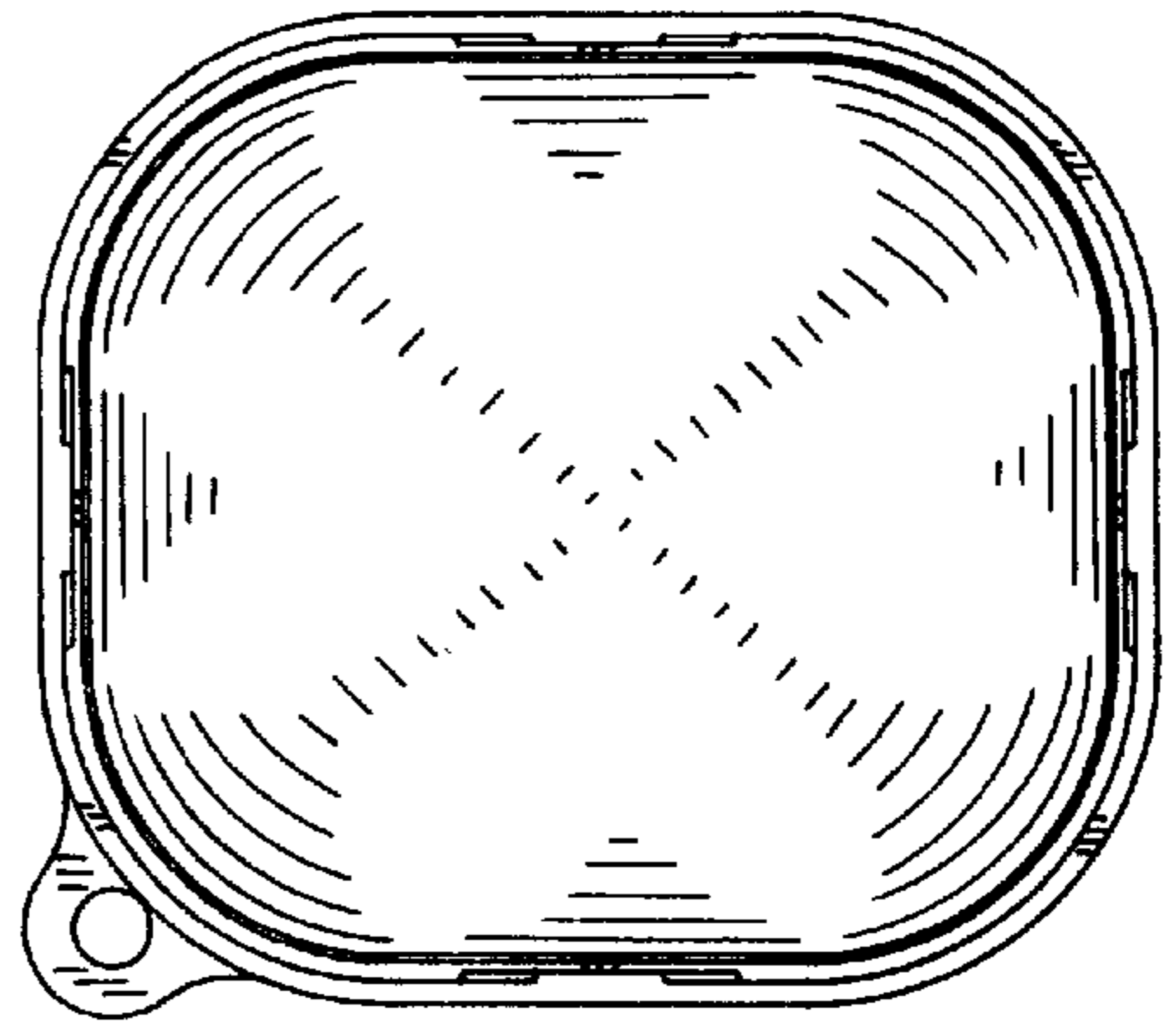

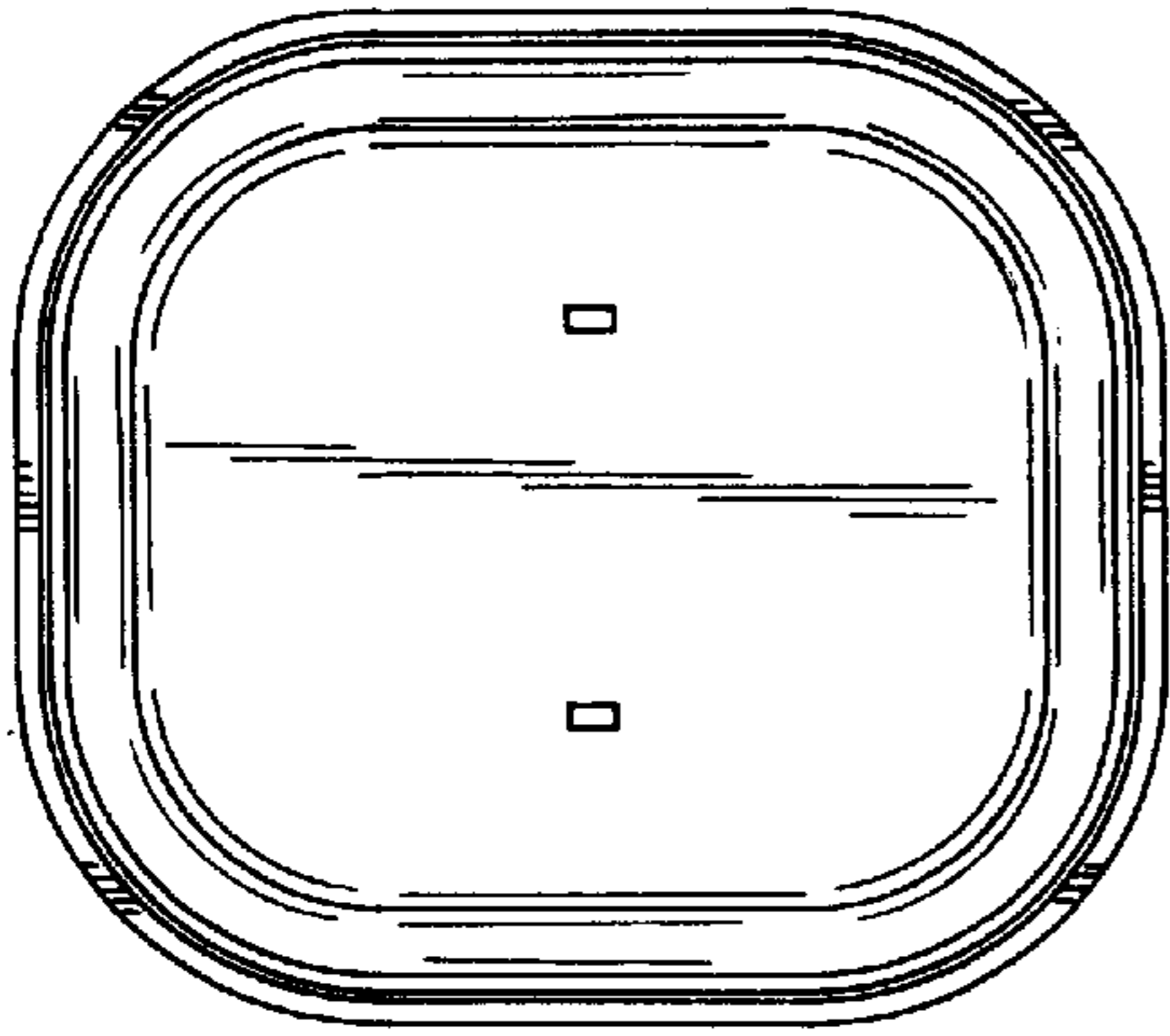

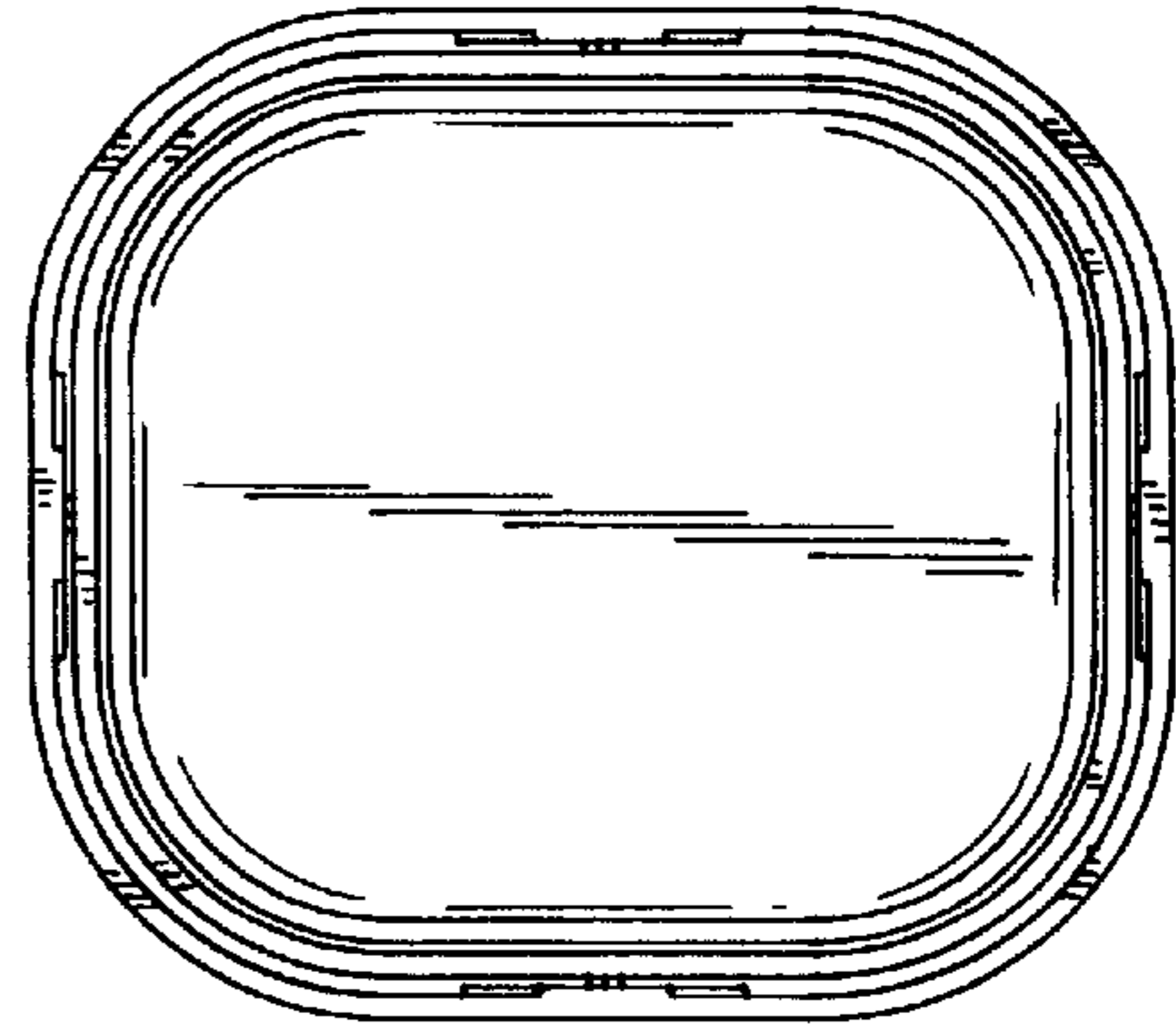

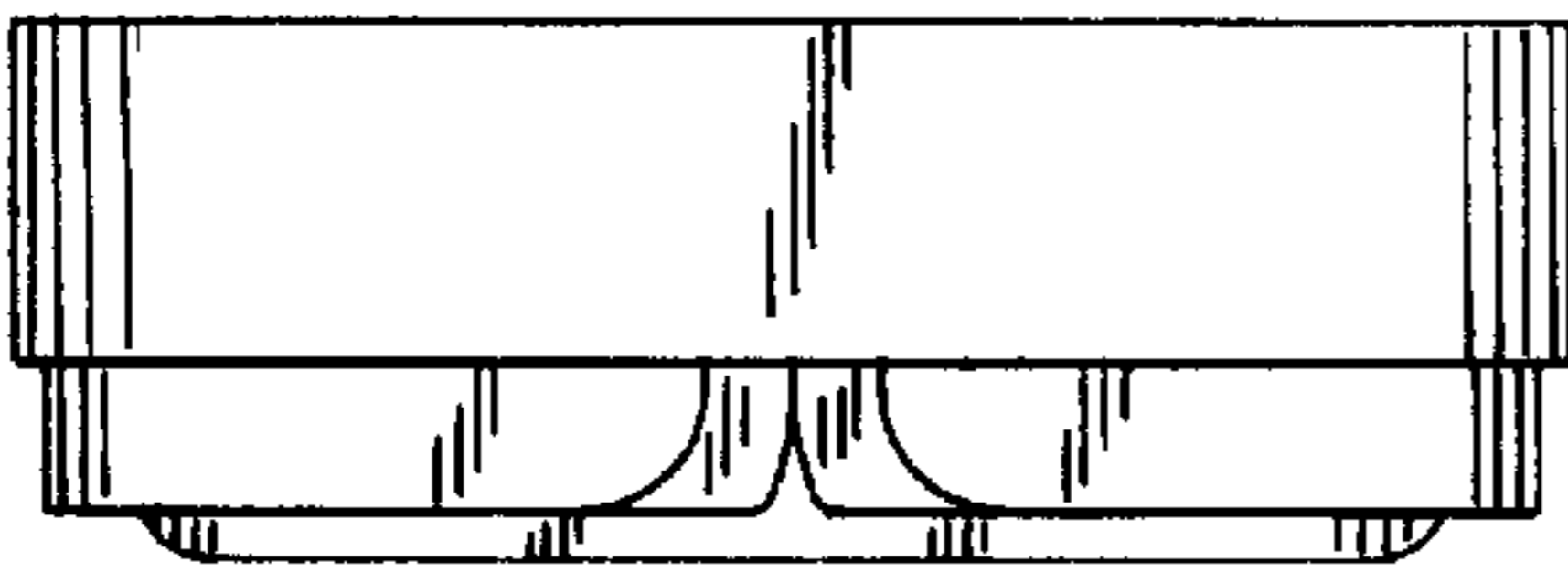

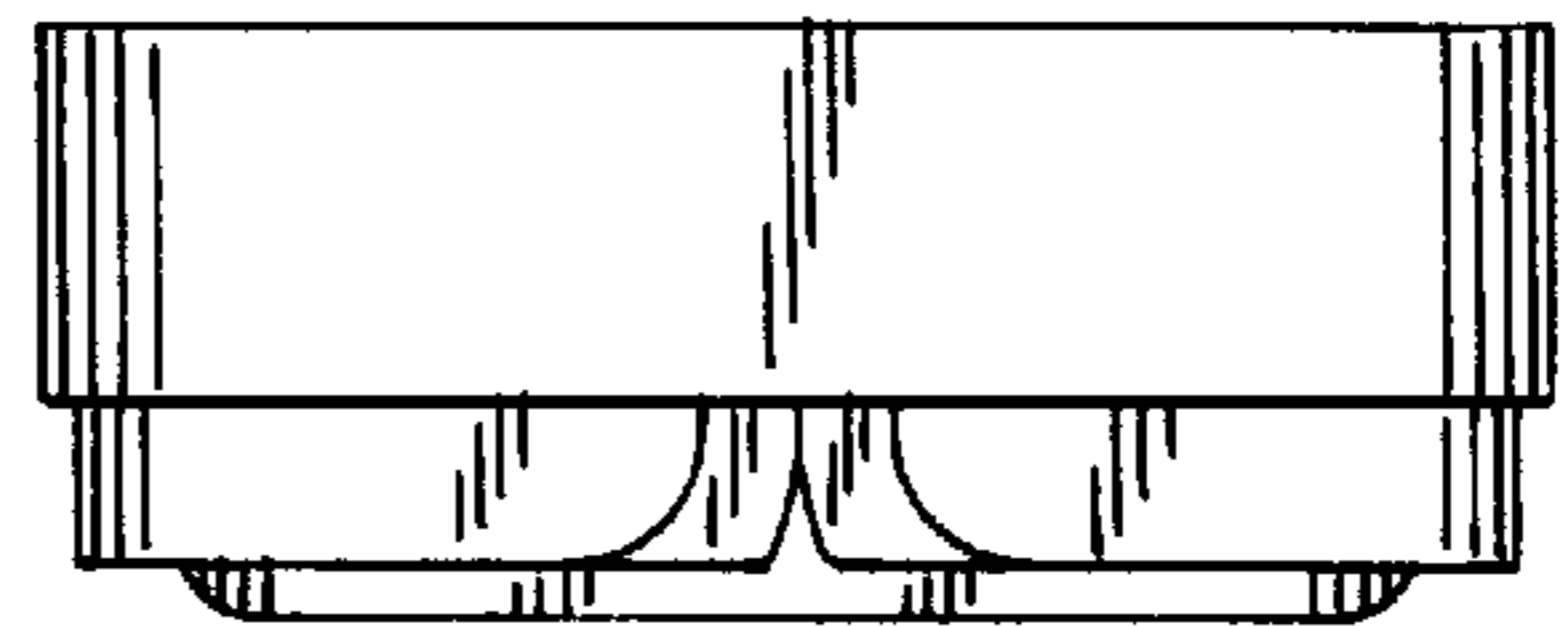

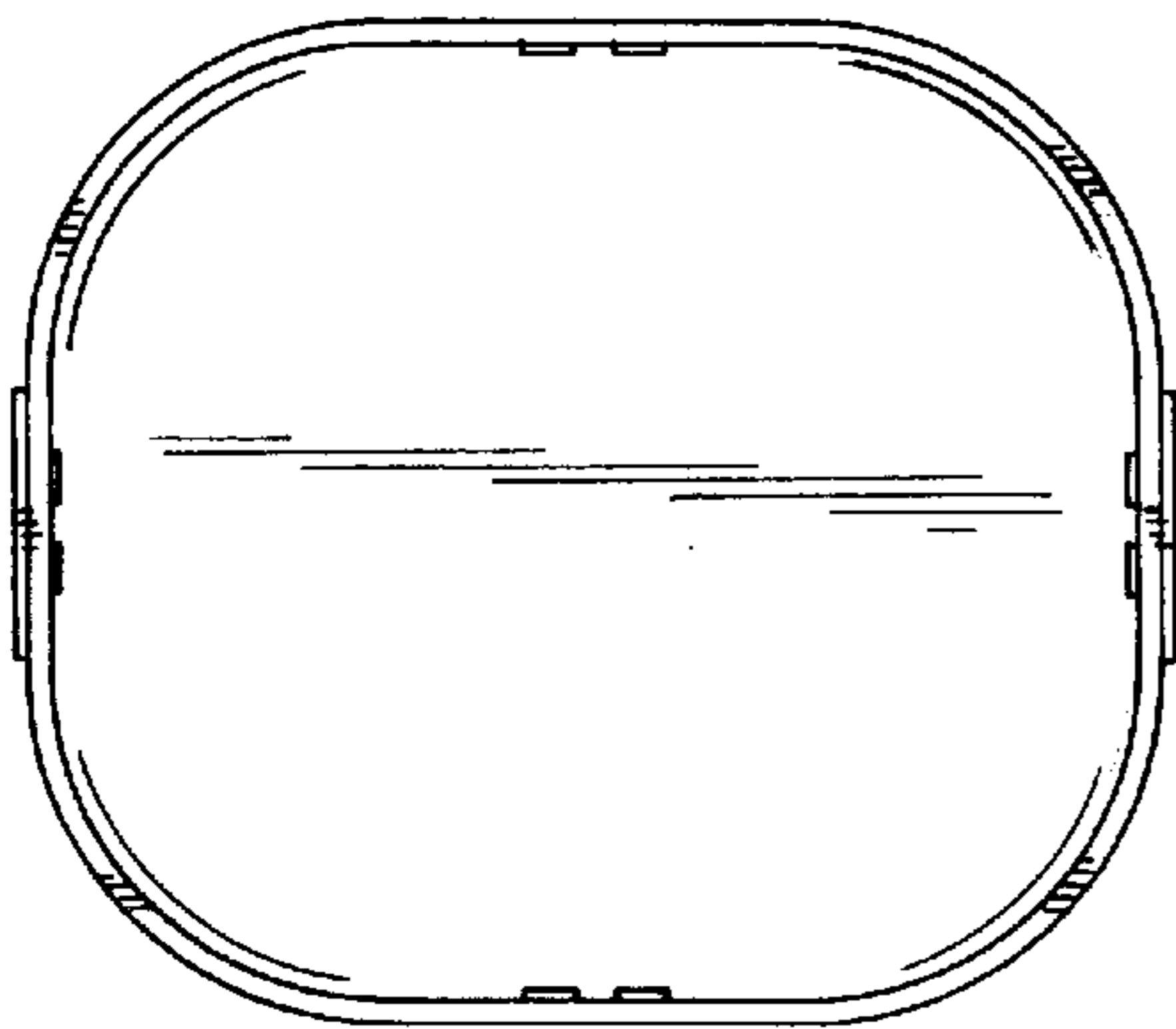

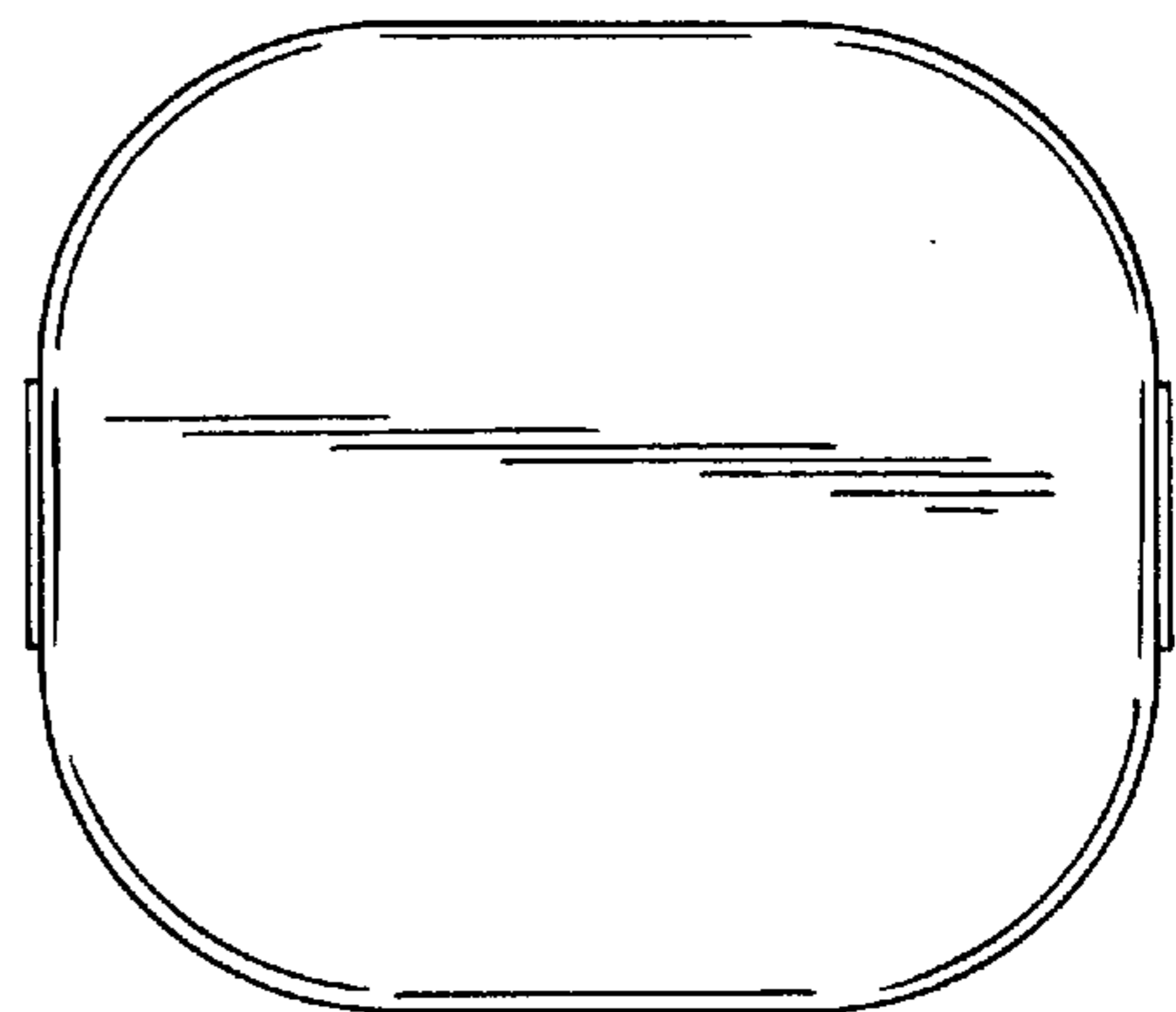

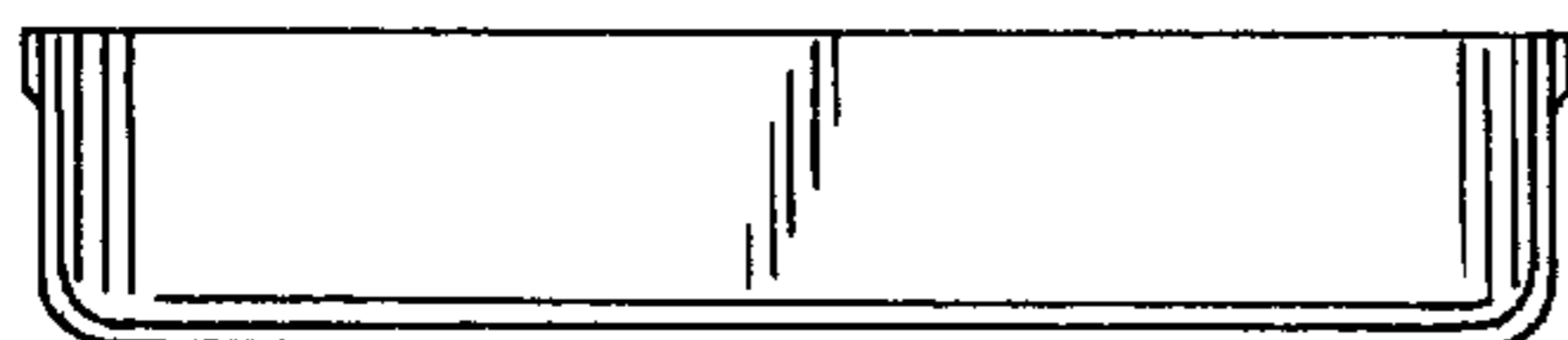

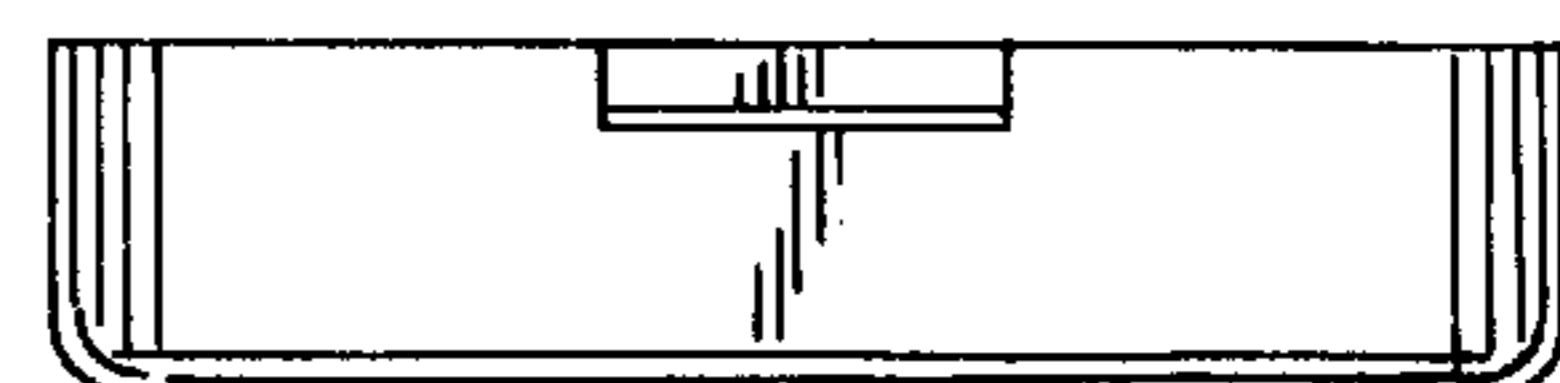
