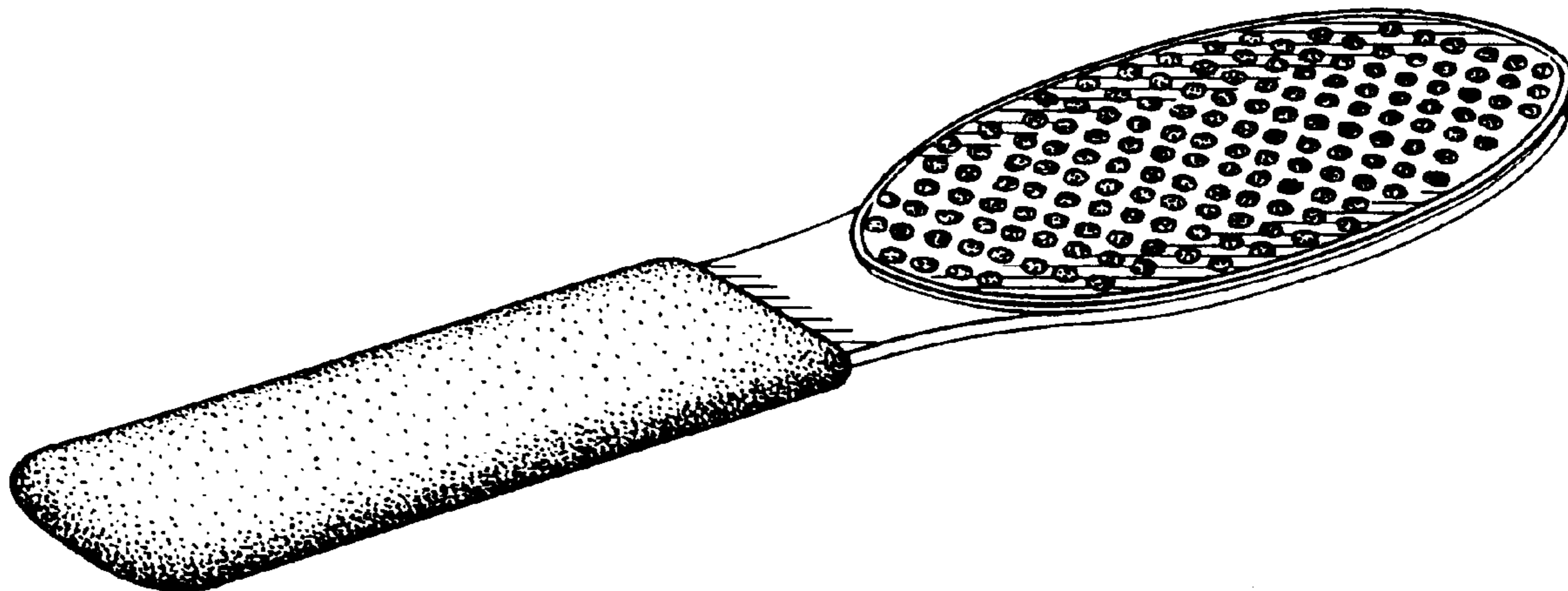
[57] **CLAIM**

The ornamental design for a pedicure implement, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the pedicure implement in accordance with the present invention;
FIG. 2 is a top view thereof;
FIG. 3 is a side elevation thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is an end view thereof taken from one end of the implement; and,
FIG. 6 is an end elevation thereof taken from the other end.

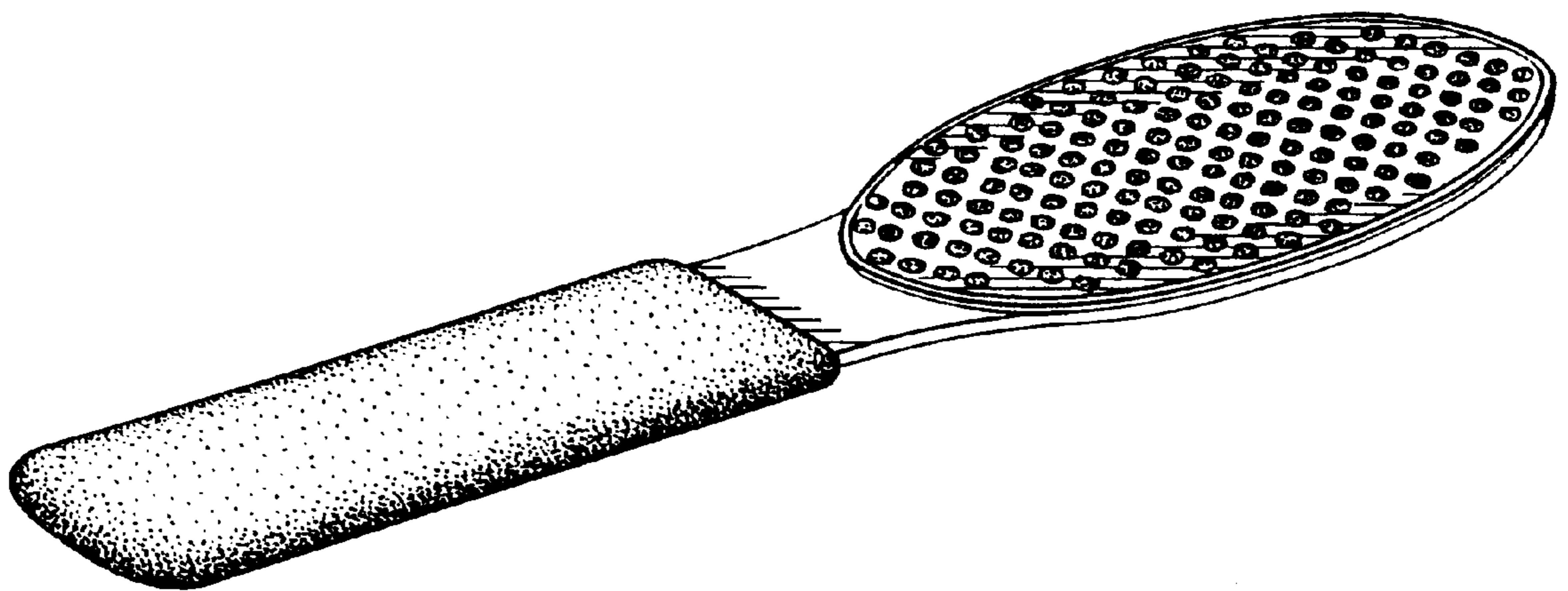

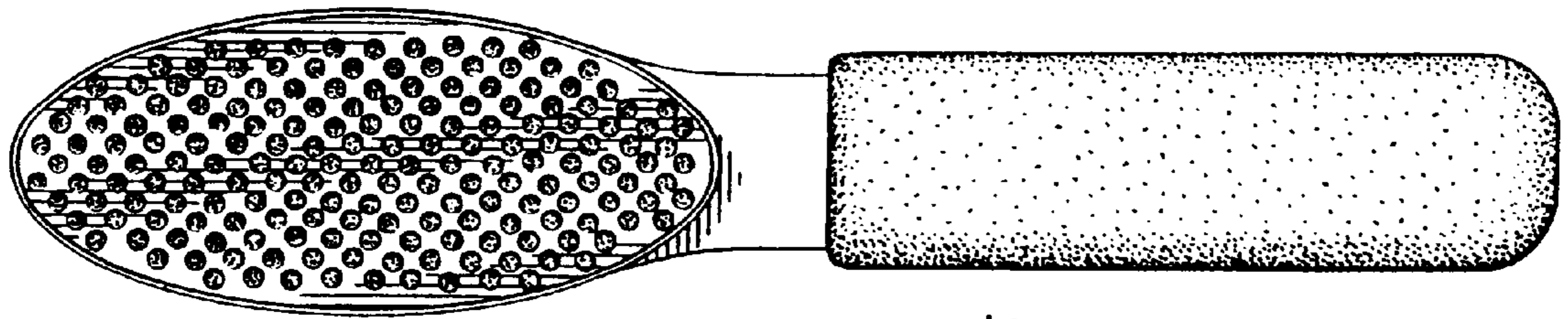

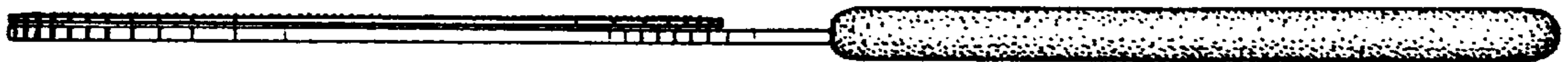

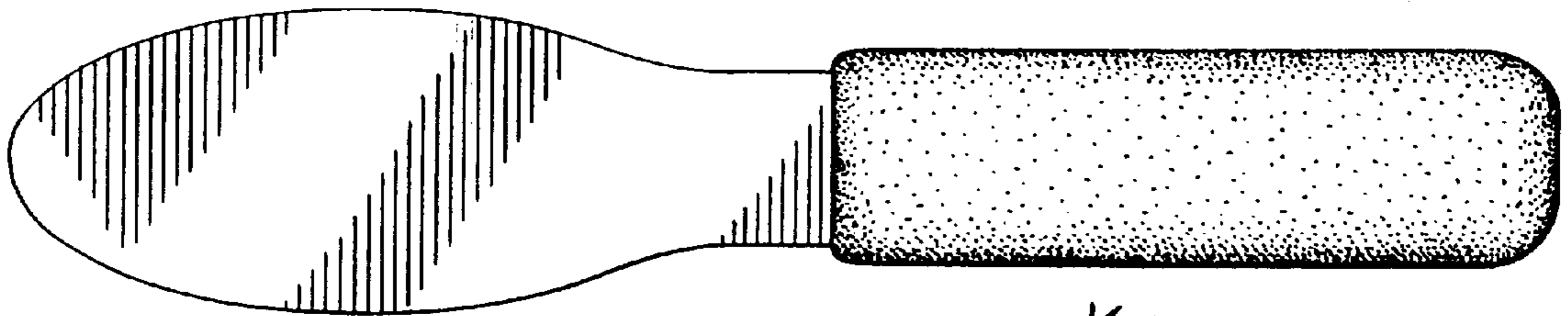
