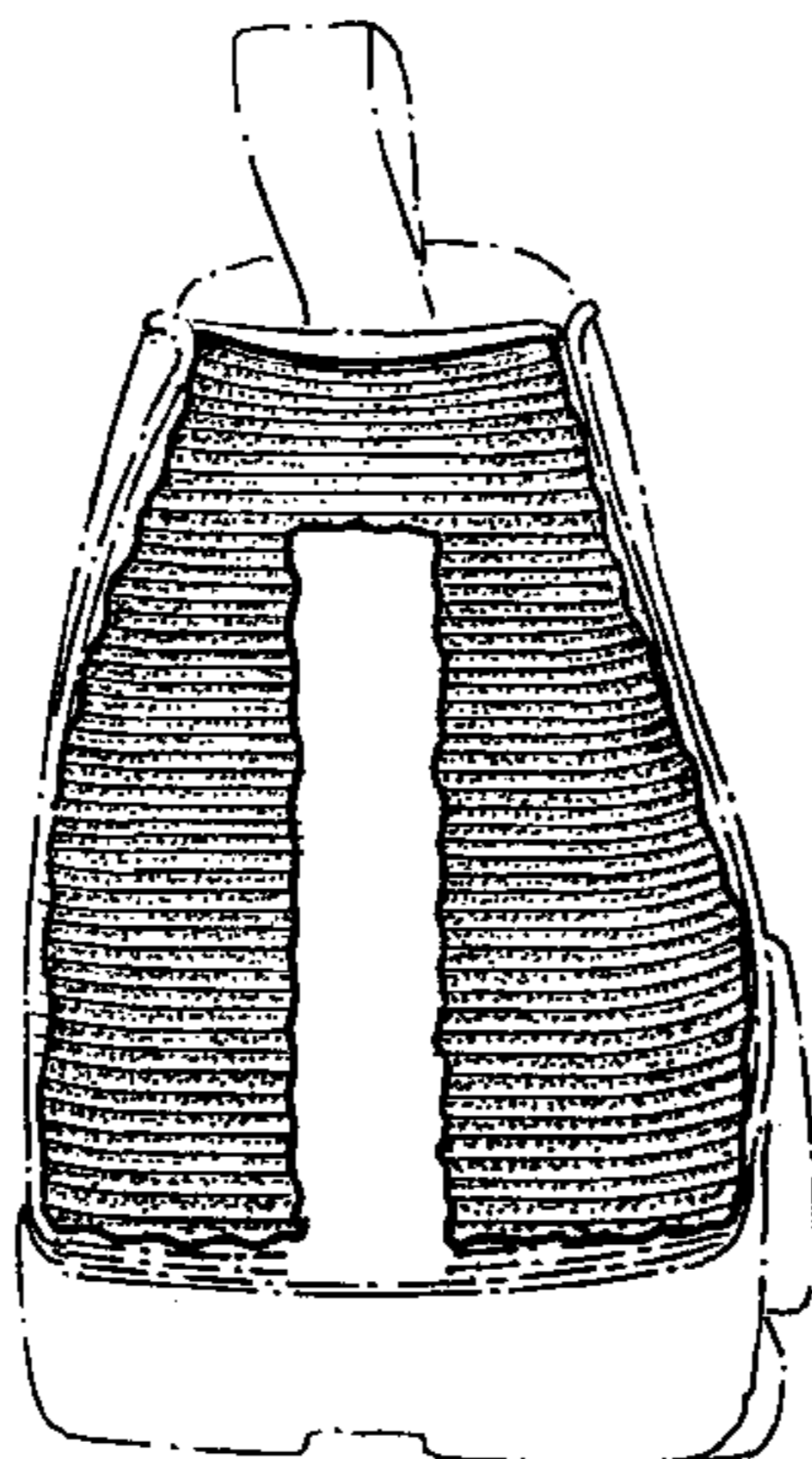
[57] **CLAIM**

The ornamental design for a portion of a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear view of a portion of a shoe upper showing our new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a side elevational view of one side thereof;  
FIG. 4 is a side elevational view of the other side thereof; and,  
FIG. 5 is a top plan view thereof.  
The uneven broken line showing of the remainder of the shoe is for illustration purposes only and forms no part of the claimed design.

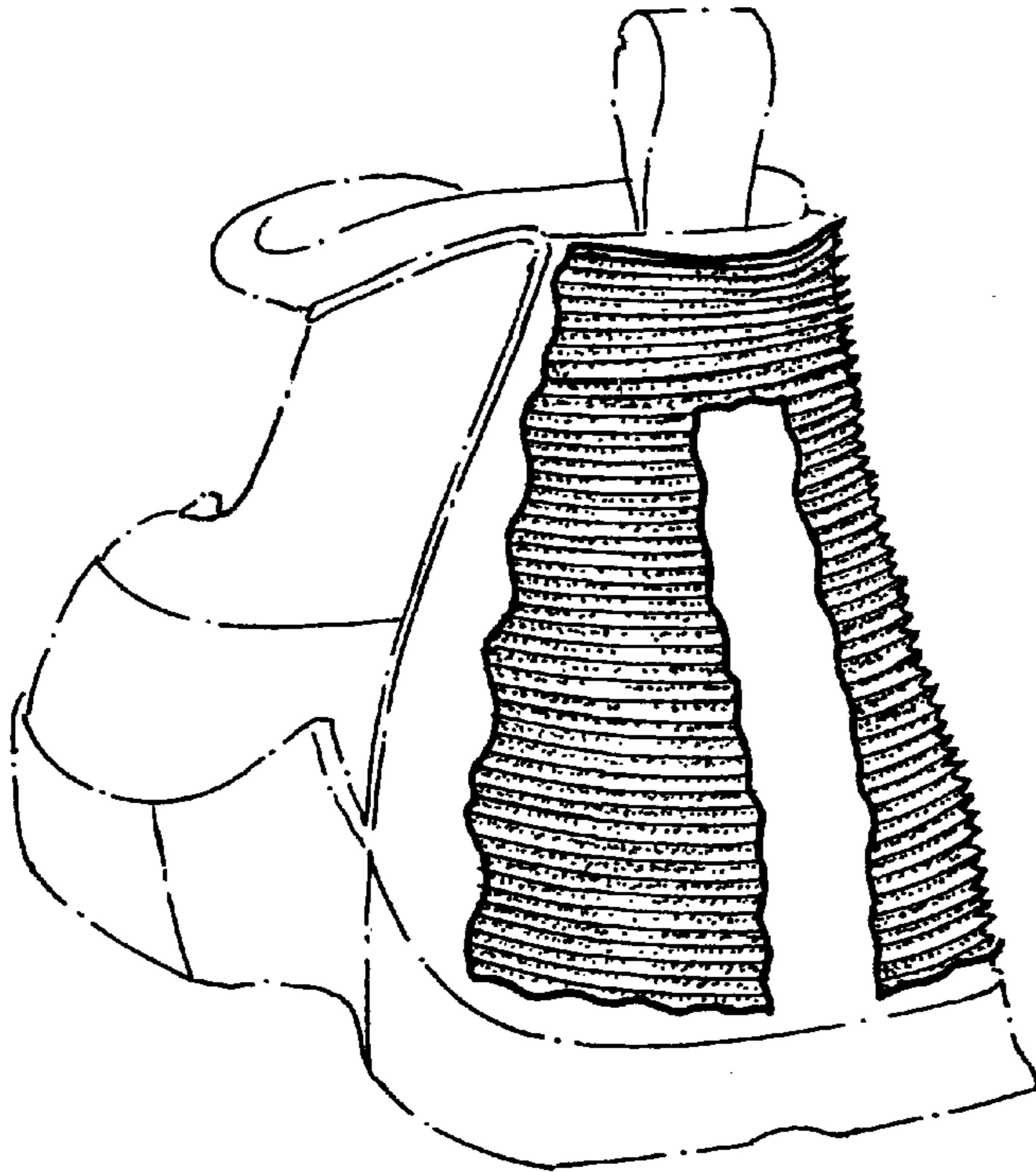

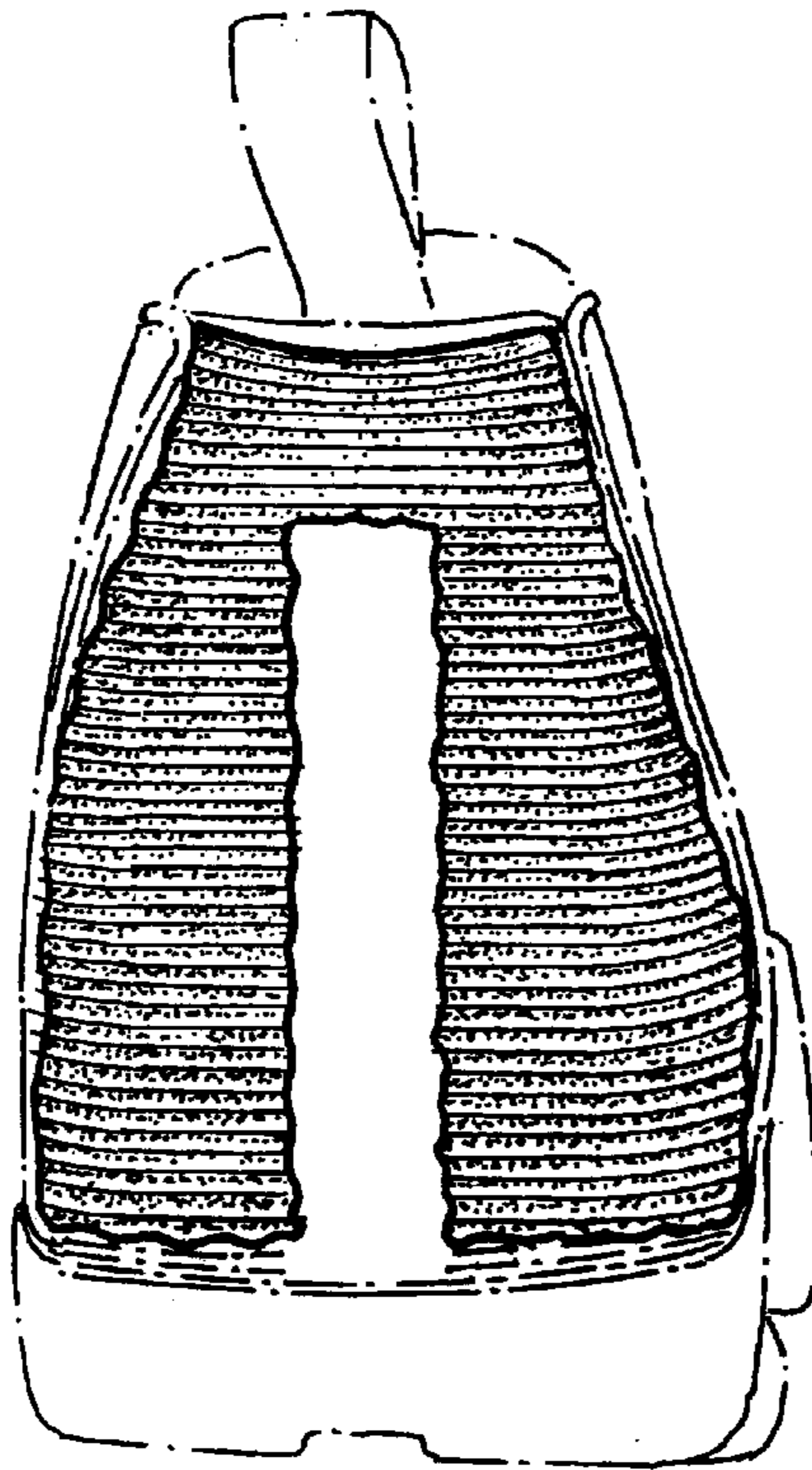

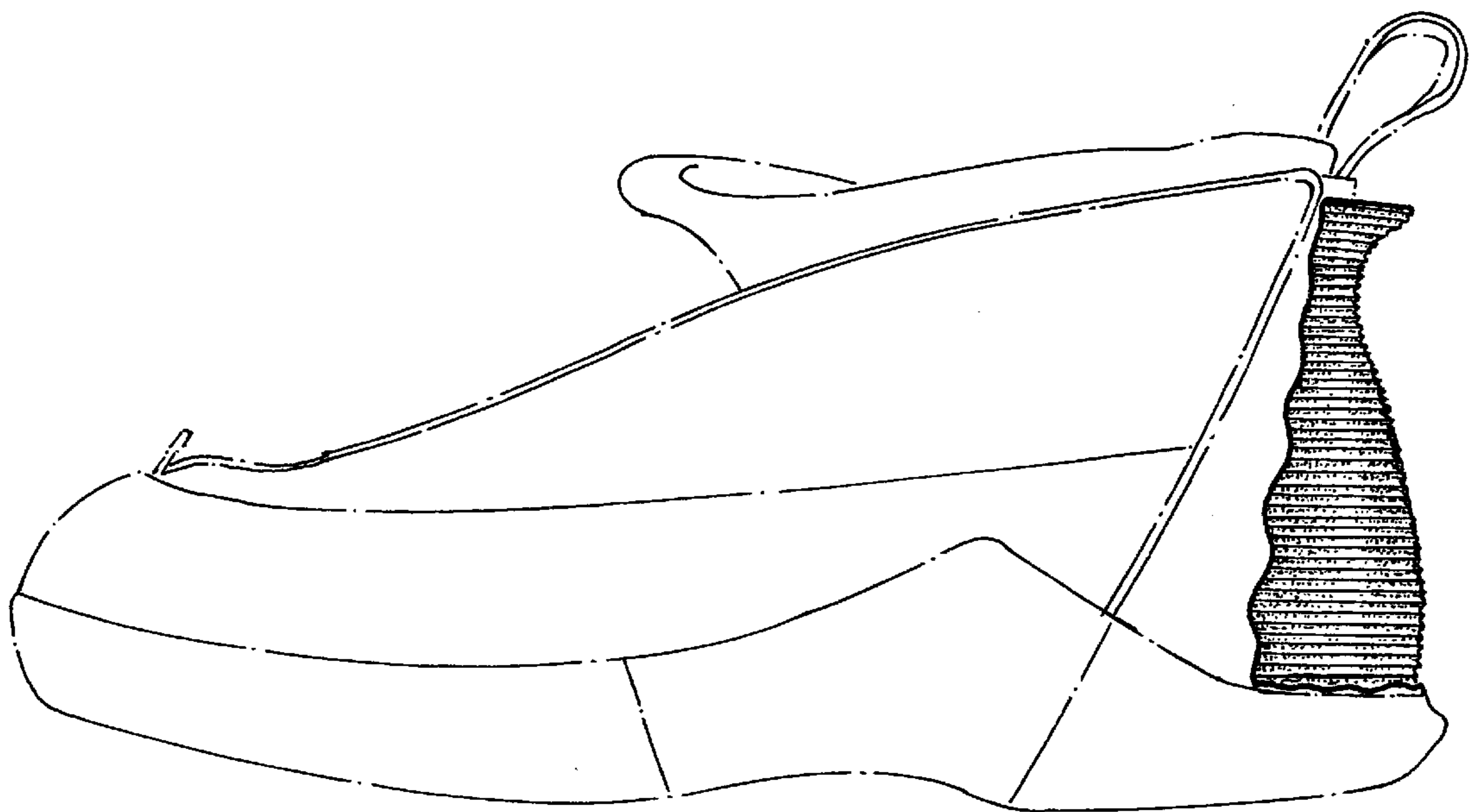

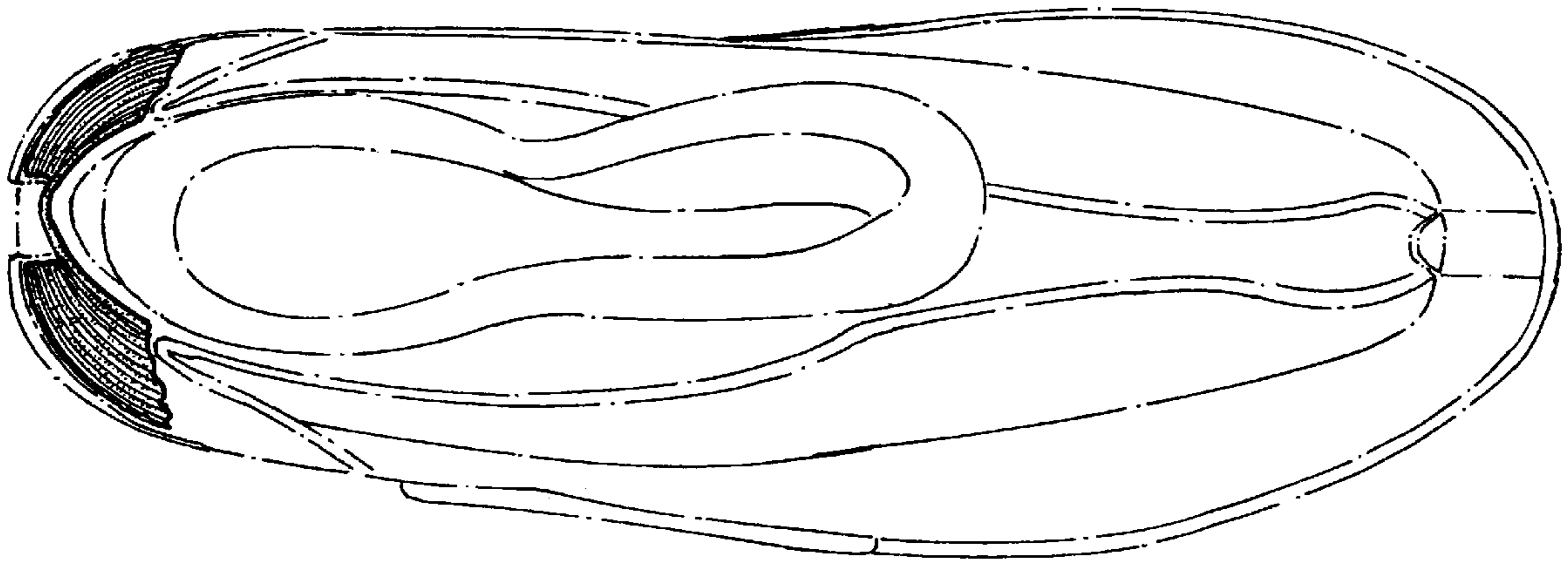
