[57] **CLAIM**

The ornamental design for a portion of a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a portion of a bottle showing our new design;

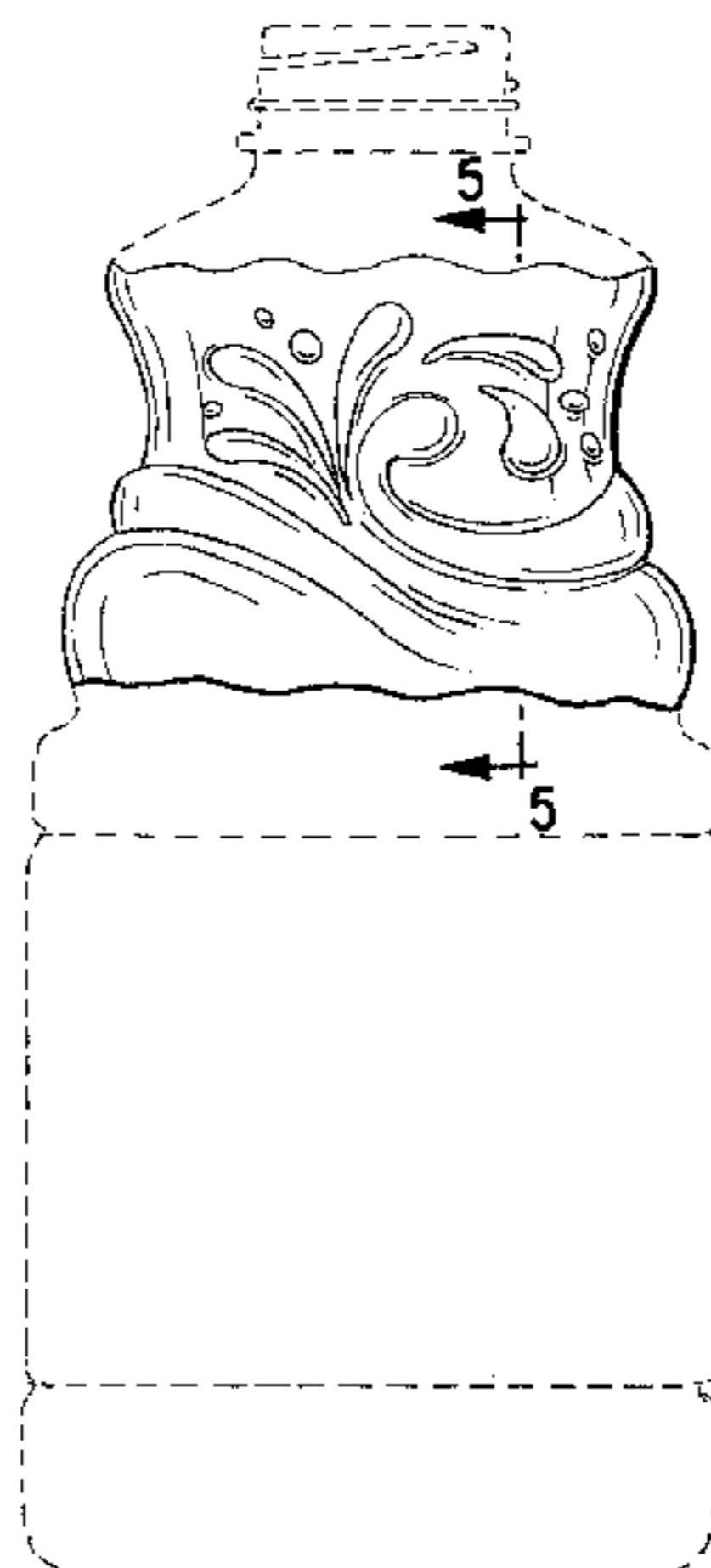


FIG. 2 is a side elevational view of a right side of the portion of a bottle of FIG. 1;
FIG. 3 is a side elevational view of a left side of the portion of a bottle of FIG. 1;
FIG. 4 is a top perspective view of the portion of a bottle of FIG. 1; and,
FIG. 5 is a cross-sectional view of the portion of a bottle of FIG. 1 taken along line 5—5 in FIG. 1.

The broken lines showing the remainder of the bottle in FIGS. 1–5 are for illustrative purposes only and form no part of the claimed design.

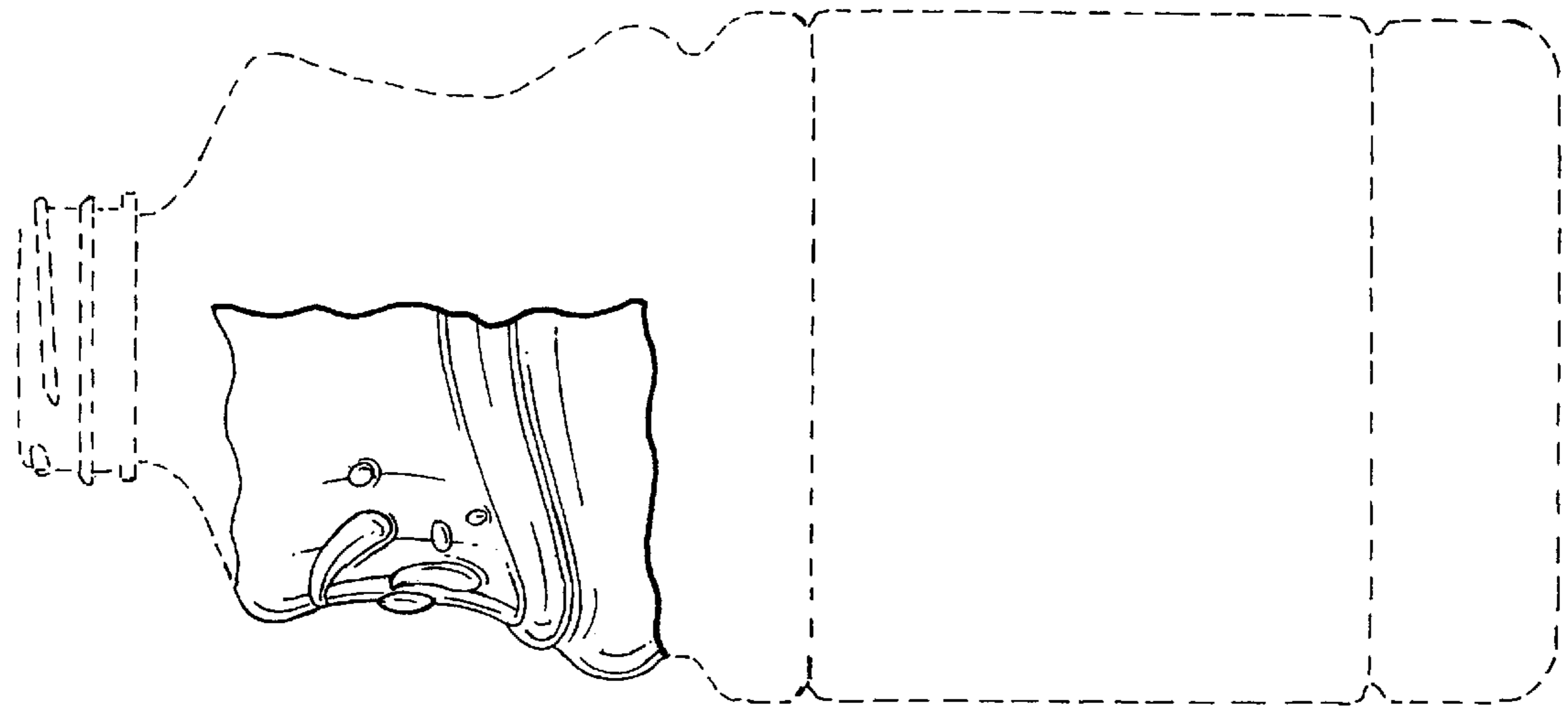

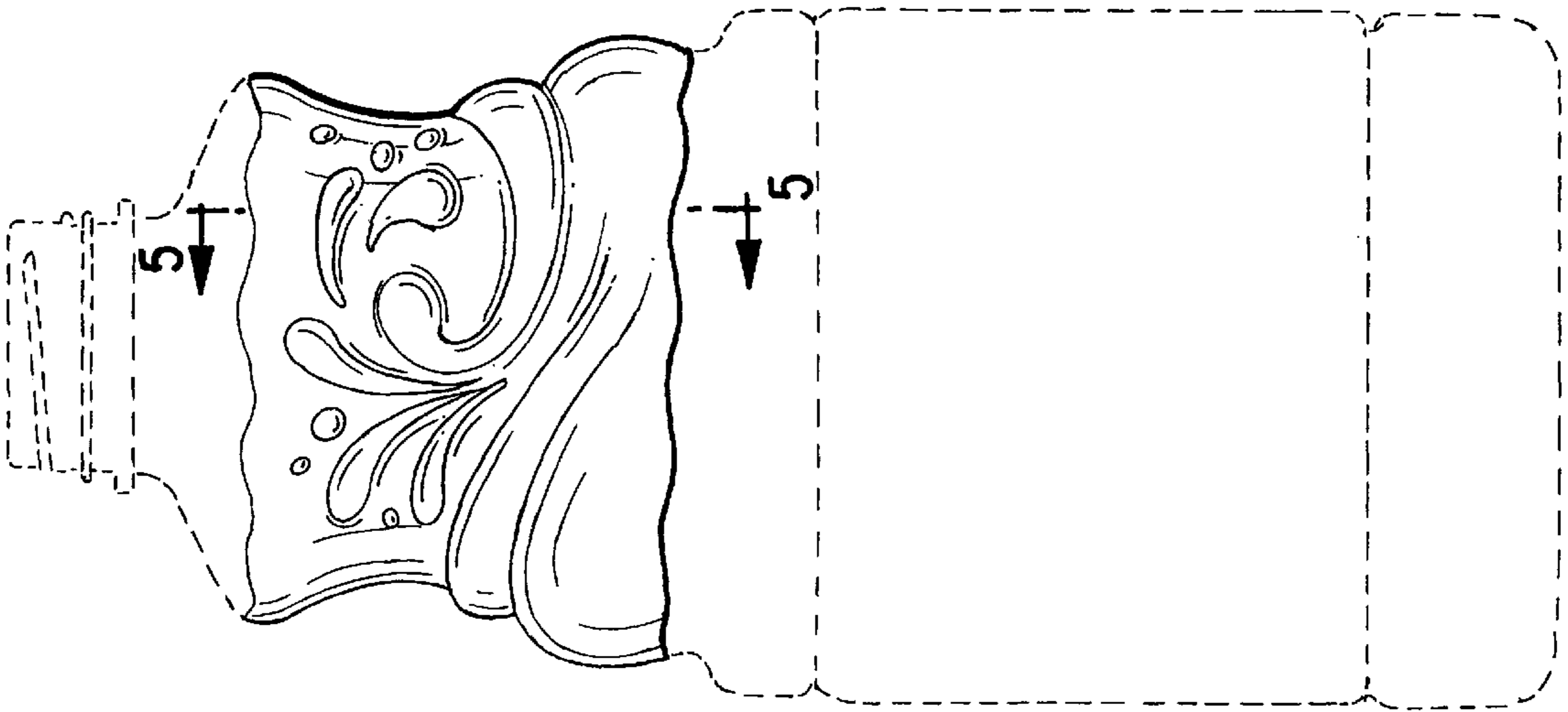

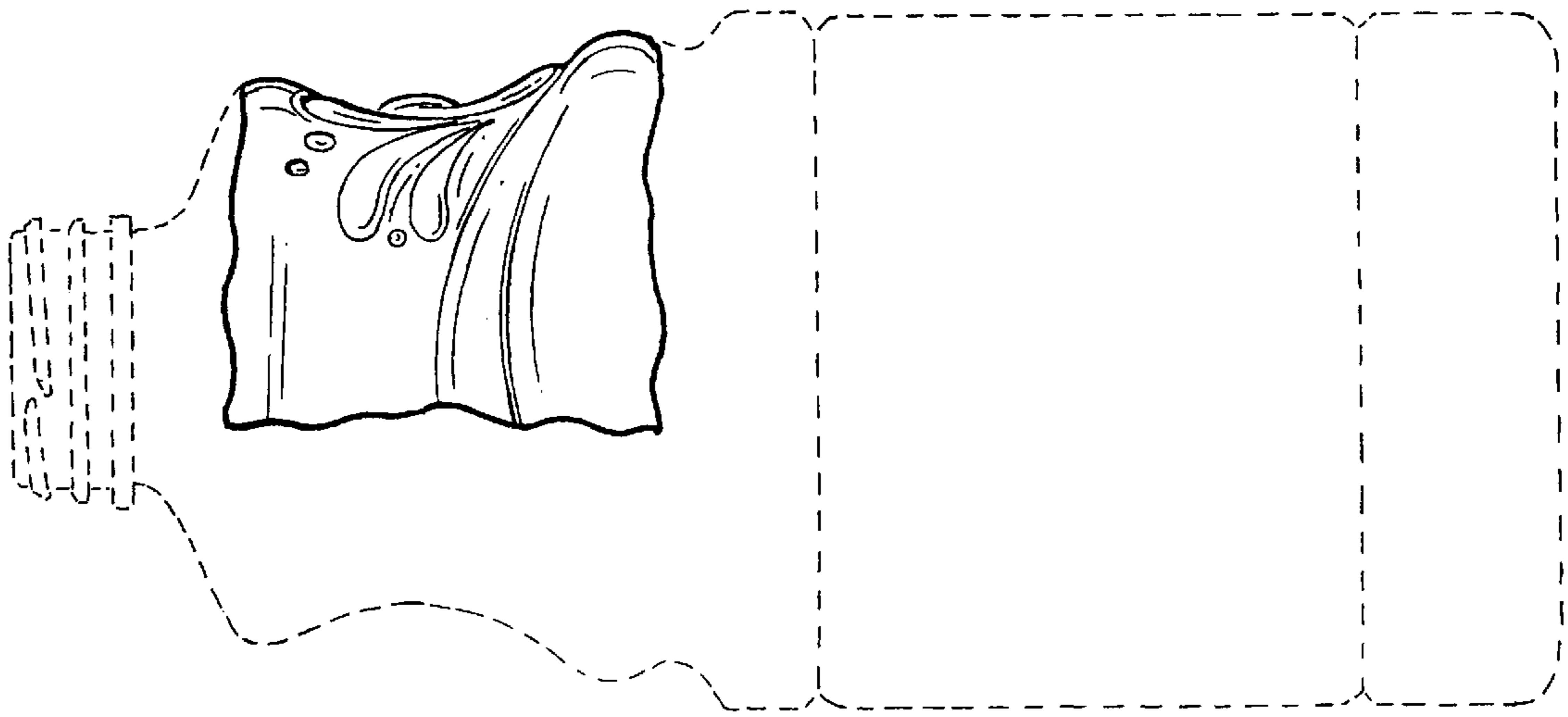

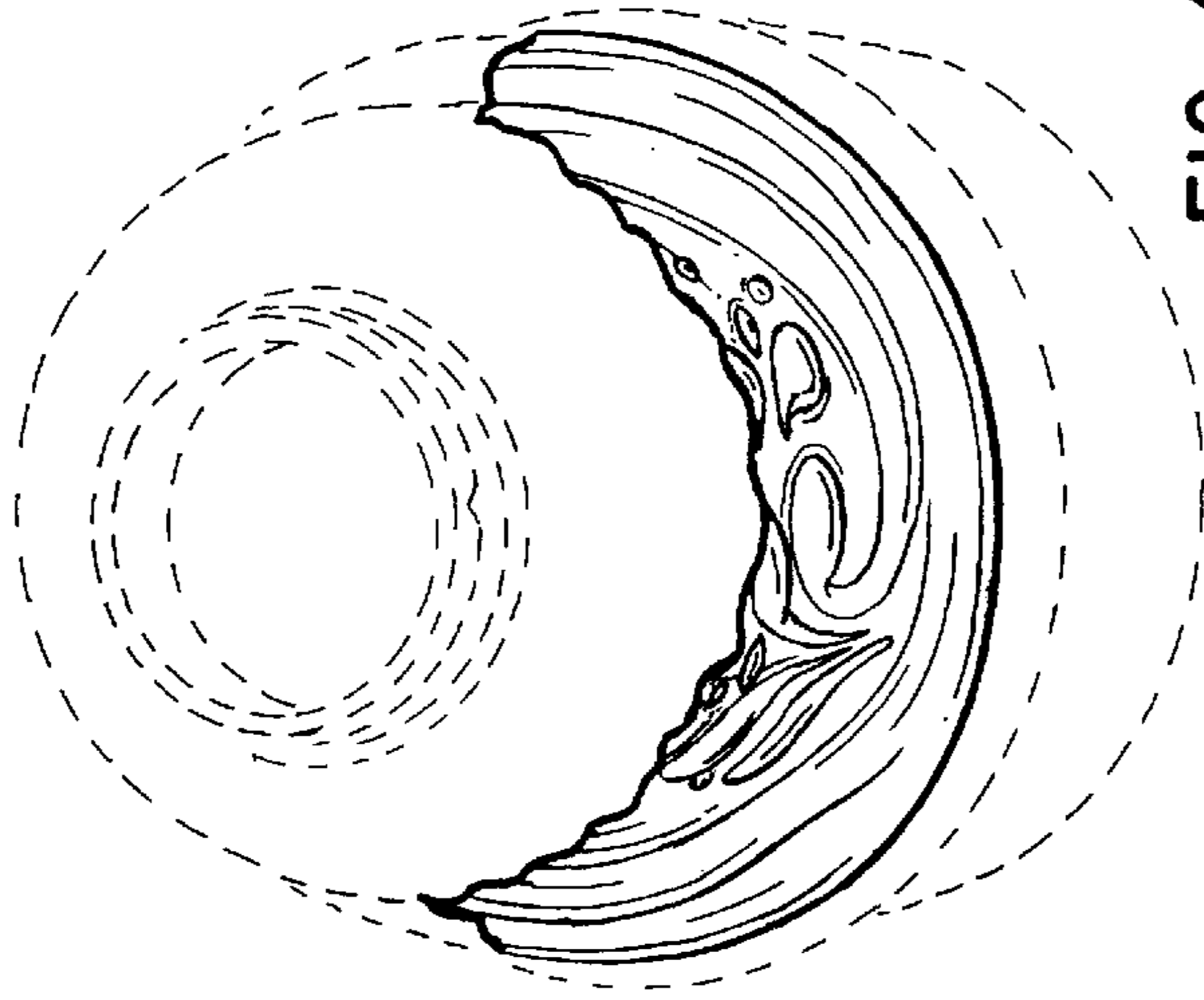
