The ornamental design for a wireless telephone, as shown and described.

**DESCRIPTION**

FIG. 10 is a rear elevational view thereof;

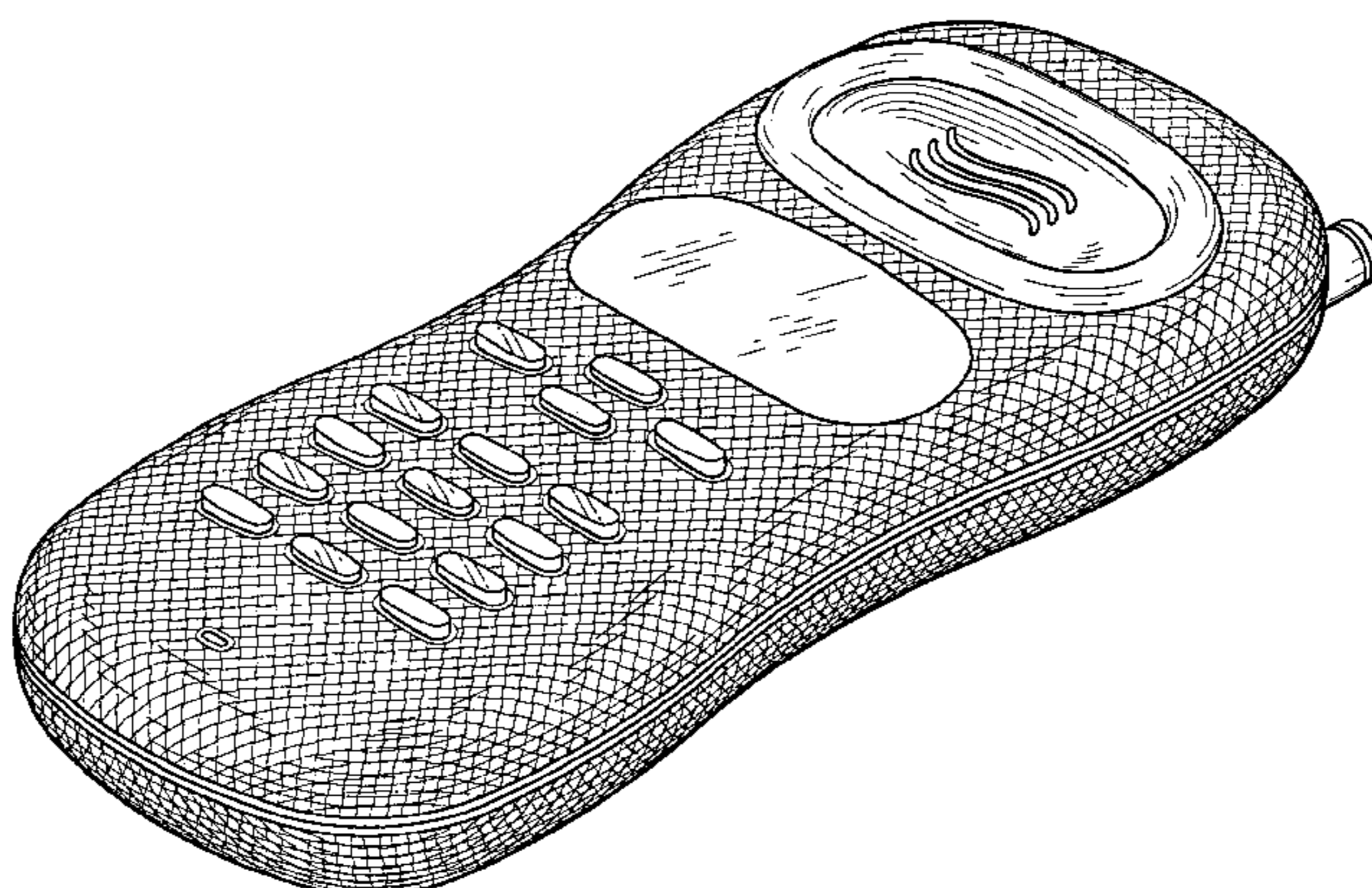
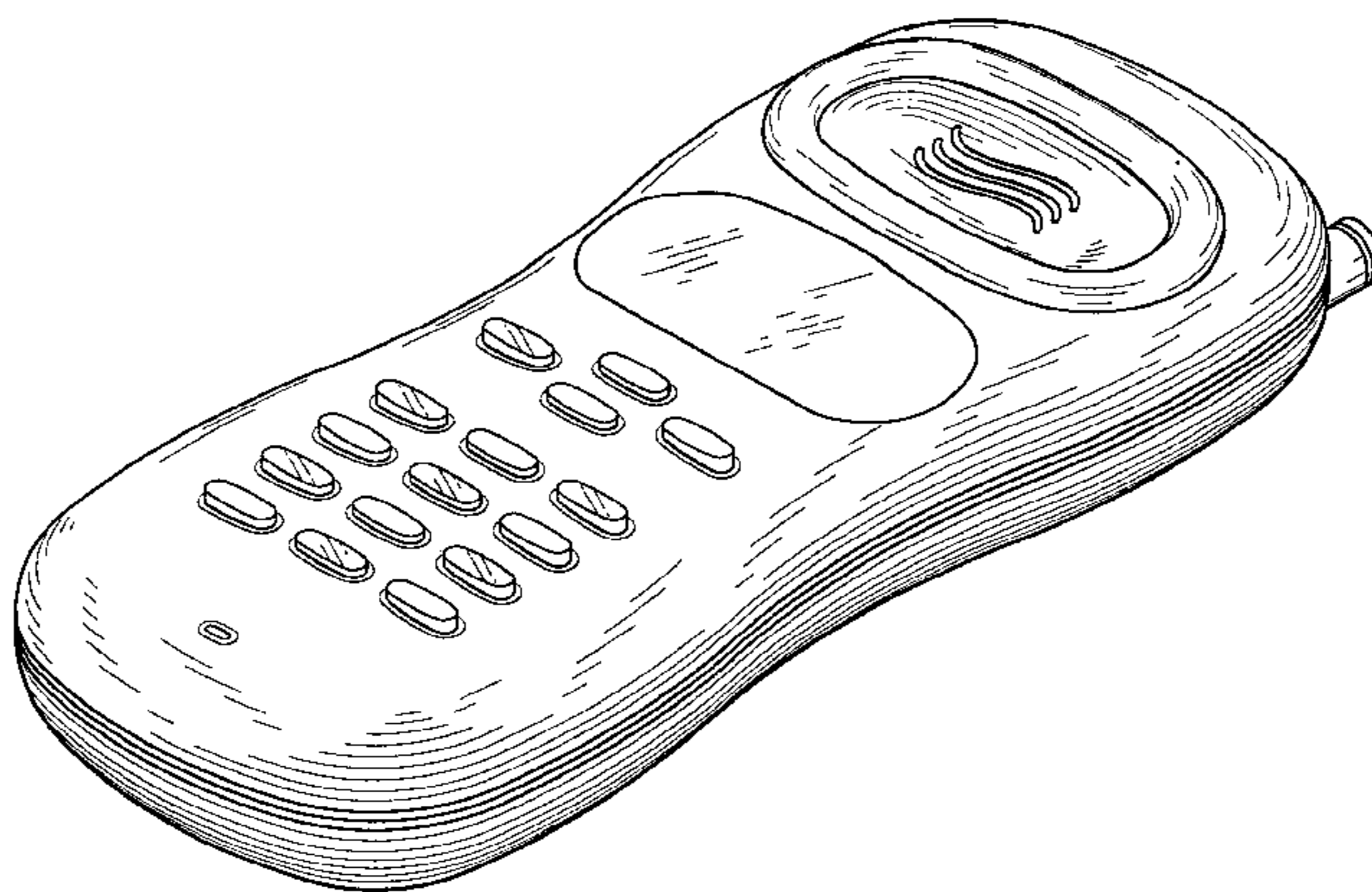
FIG. 11 is a side elevational view thereof;

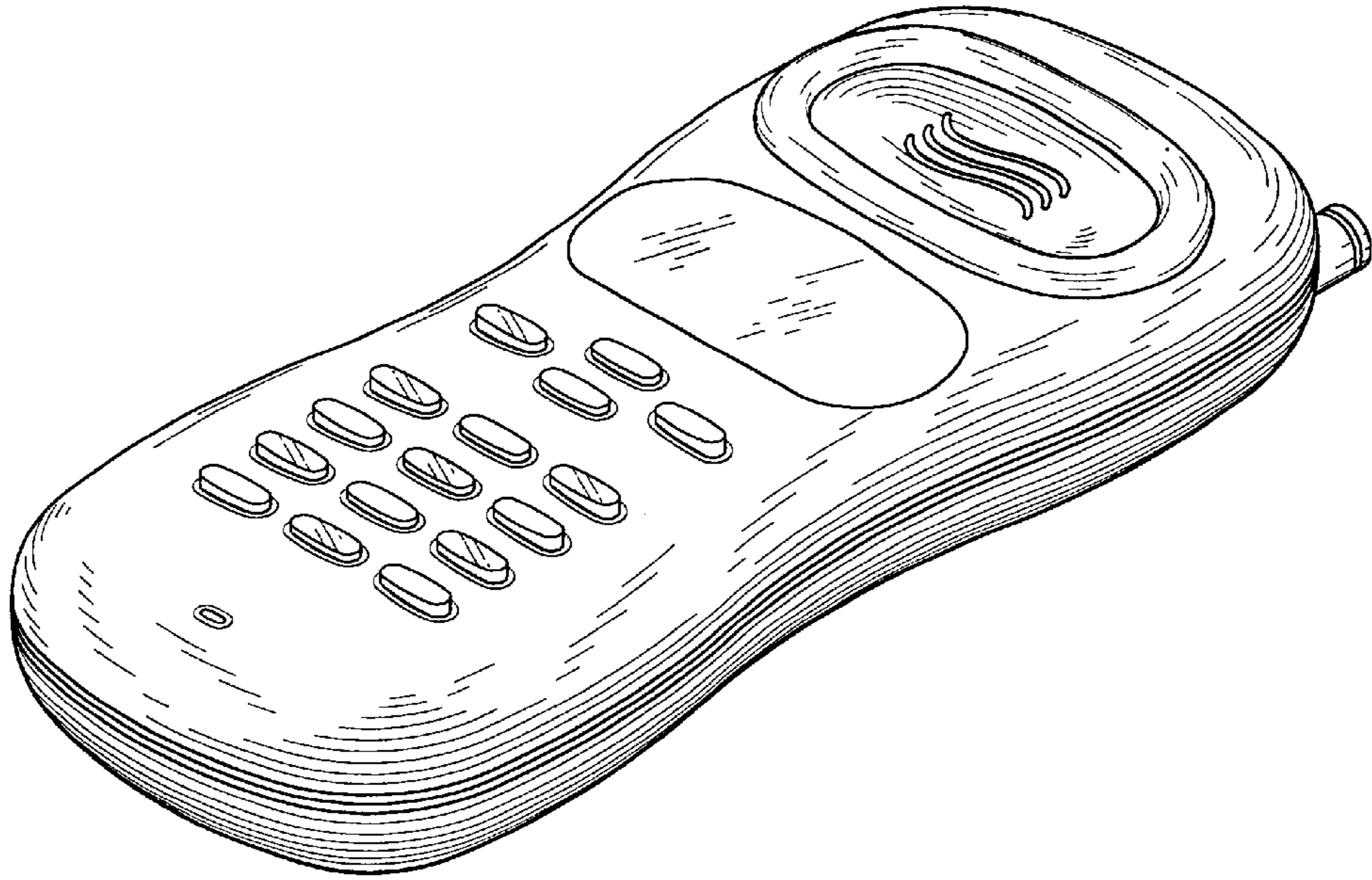

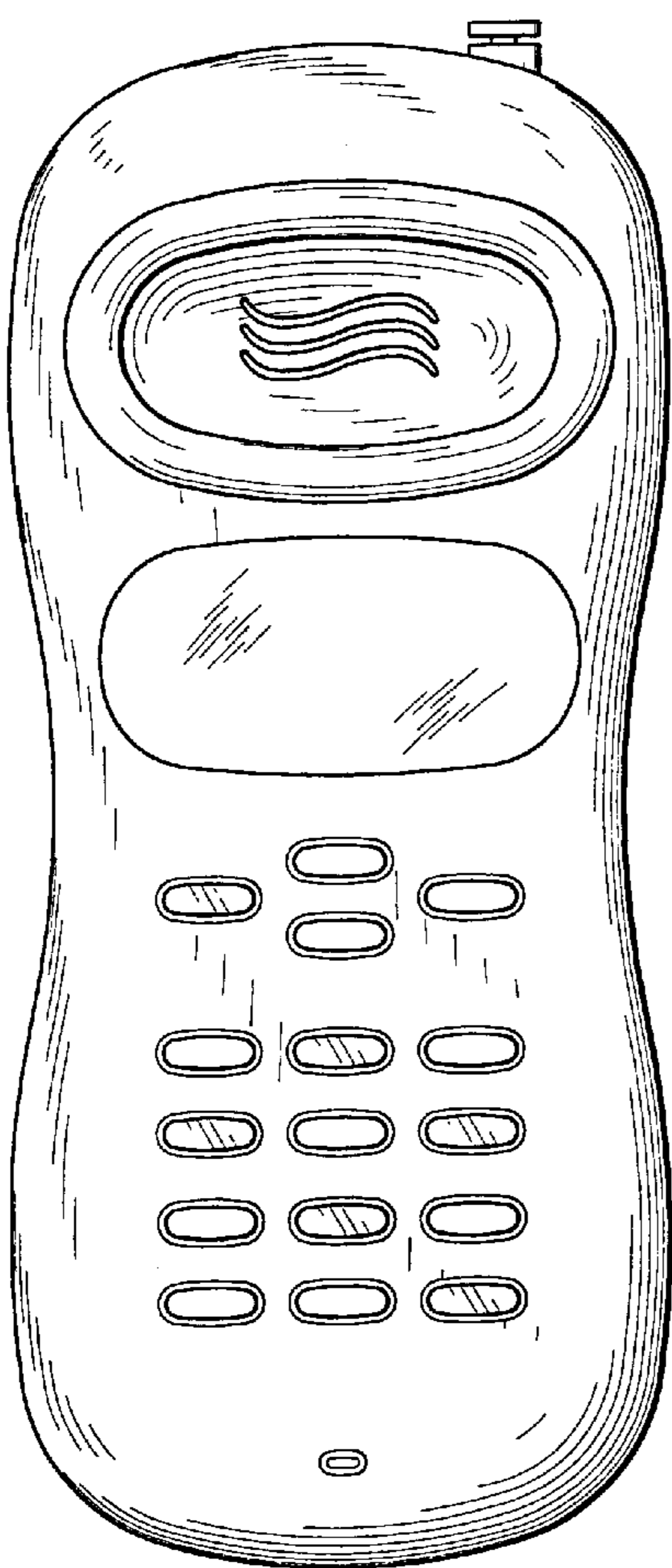

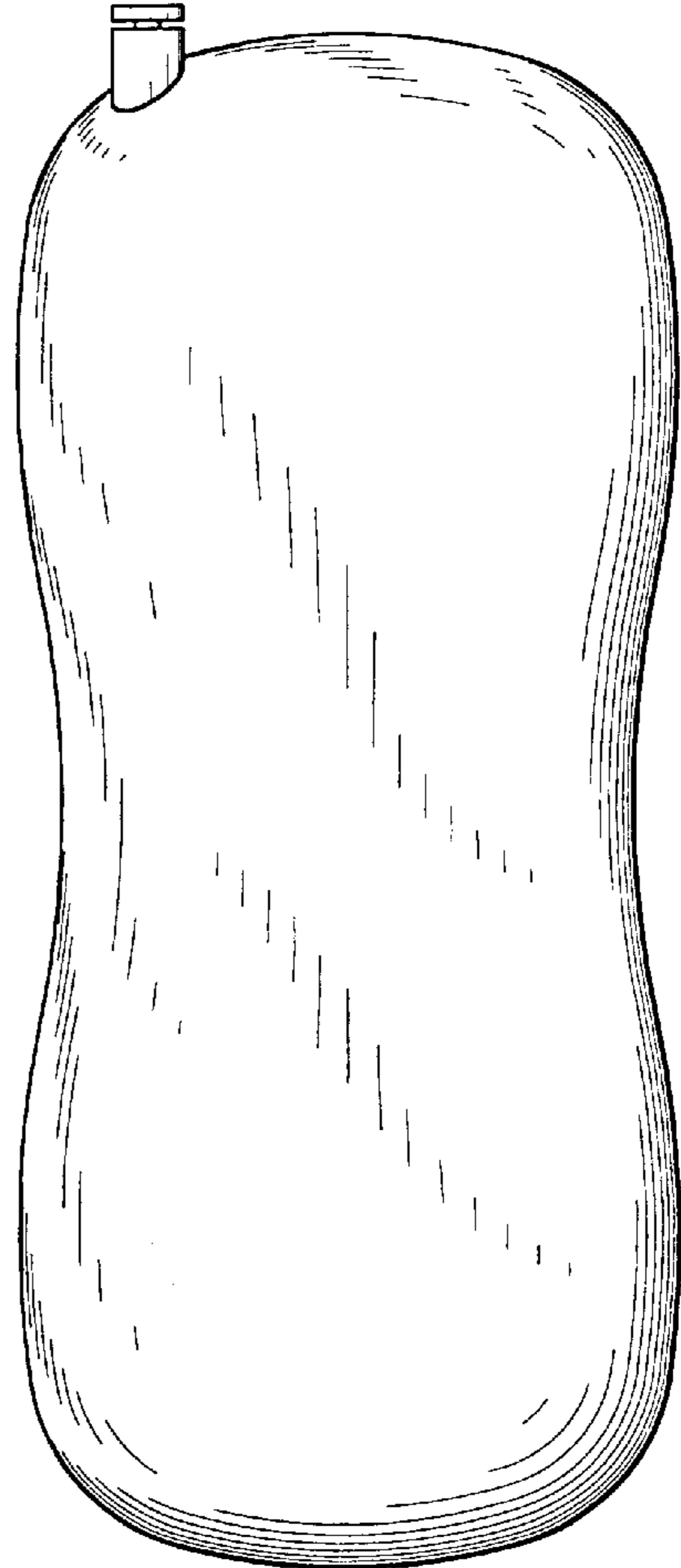

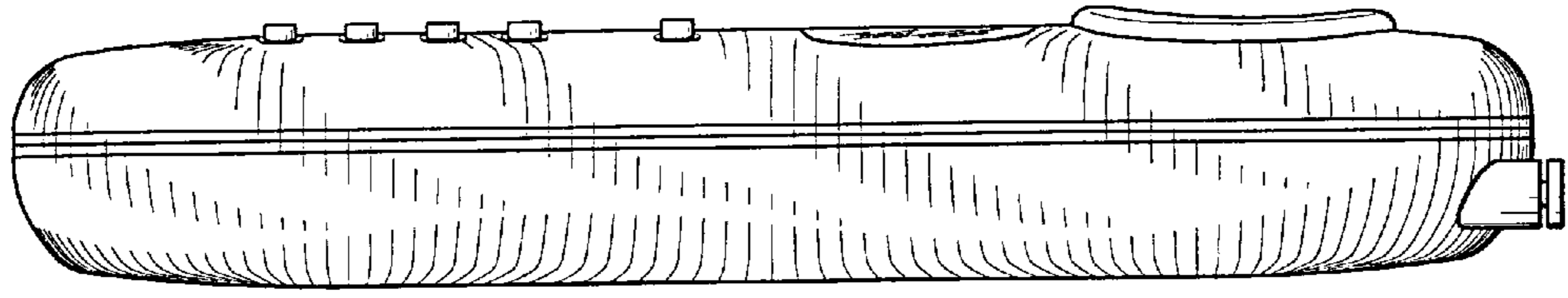

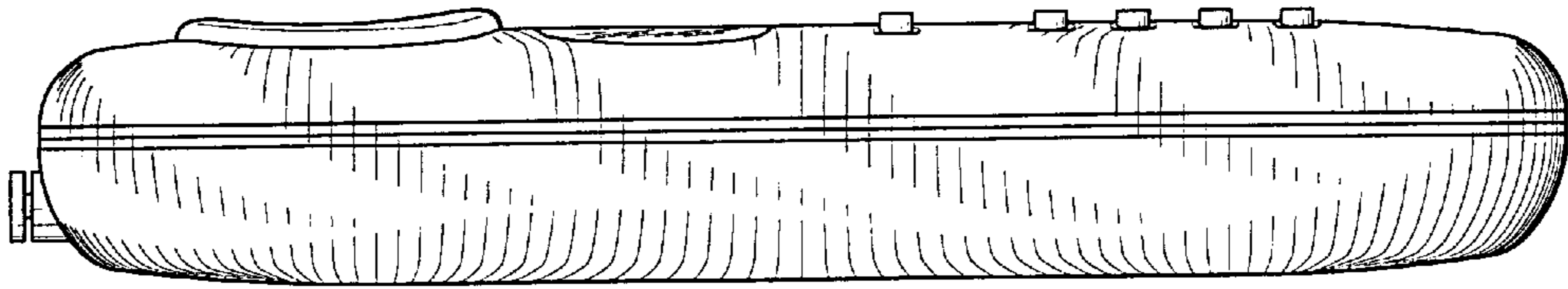

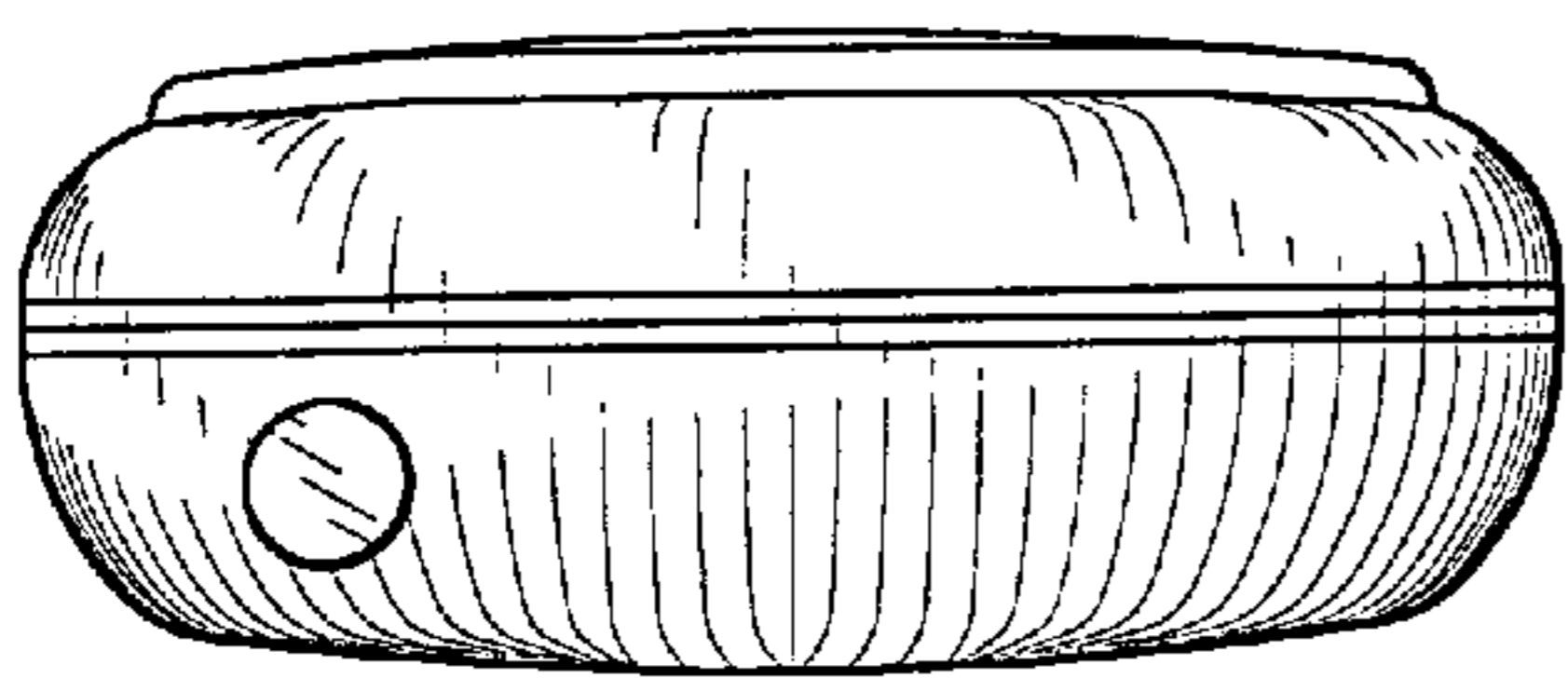

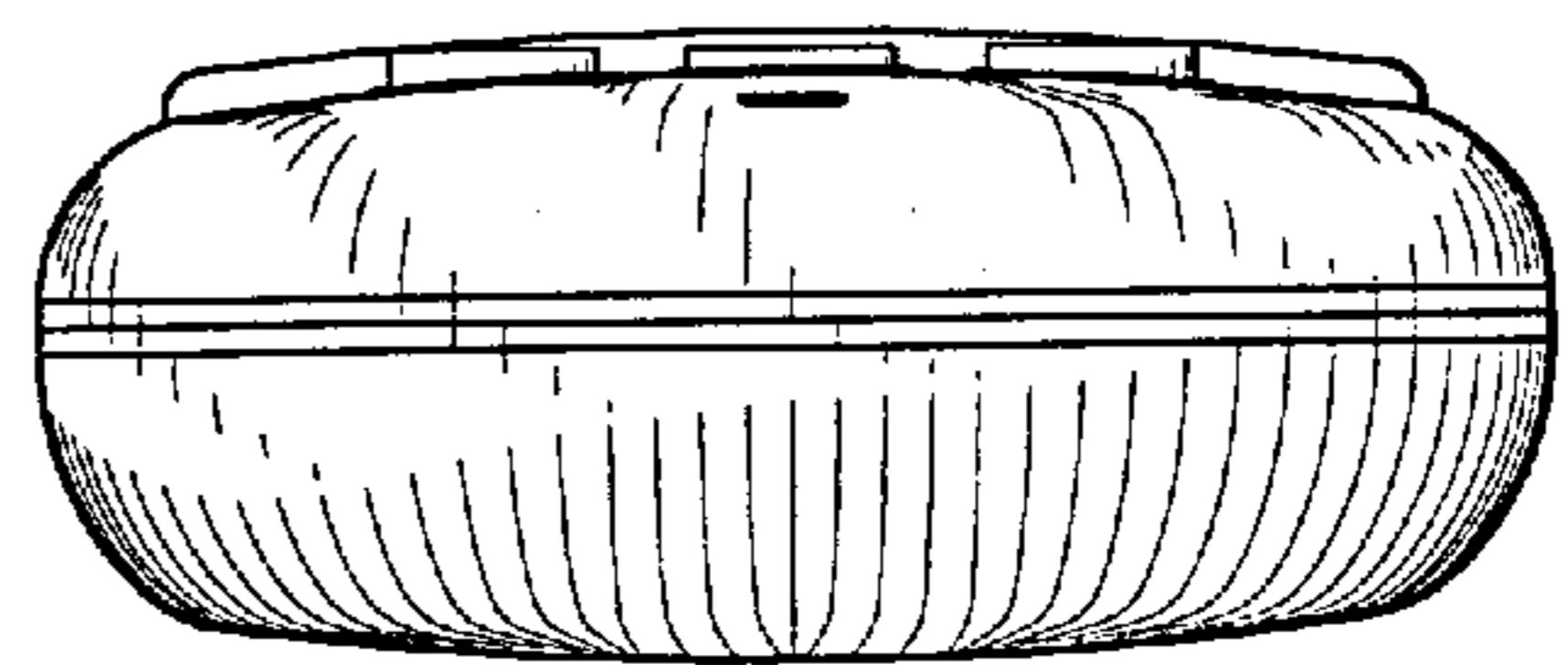
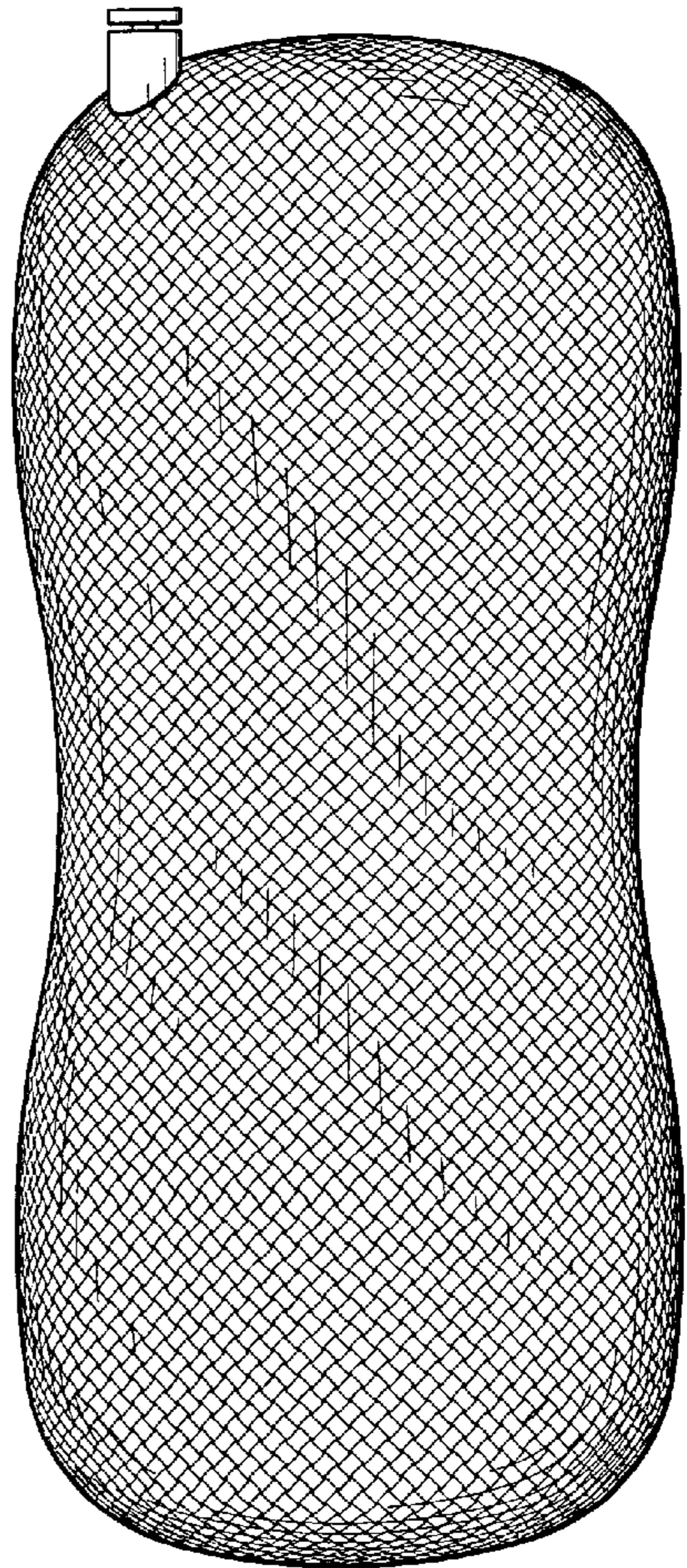
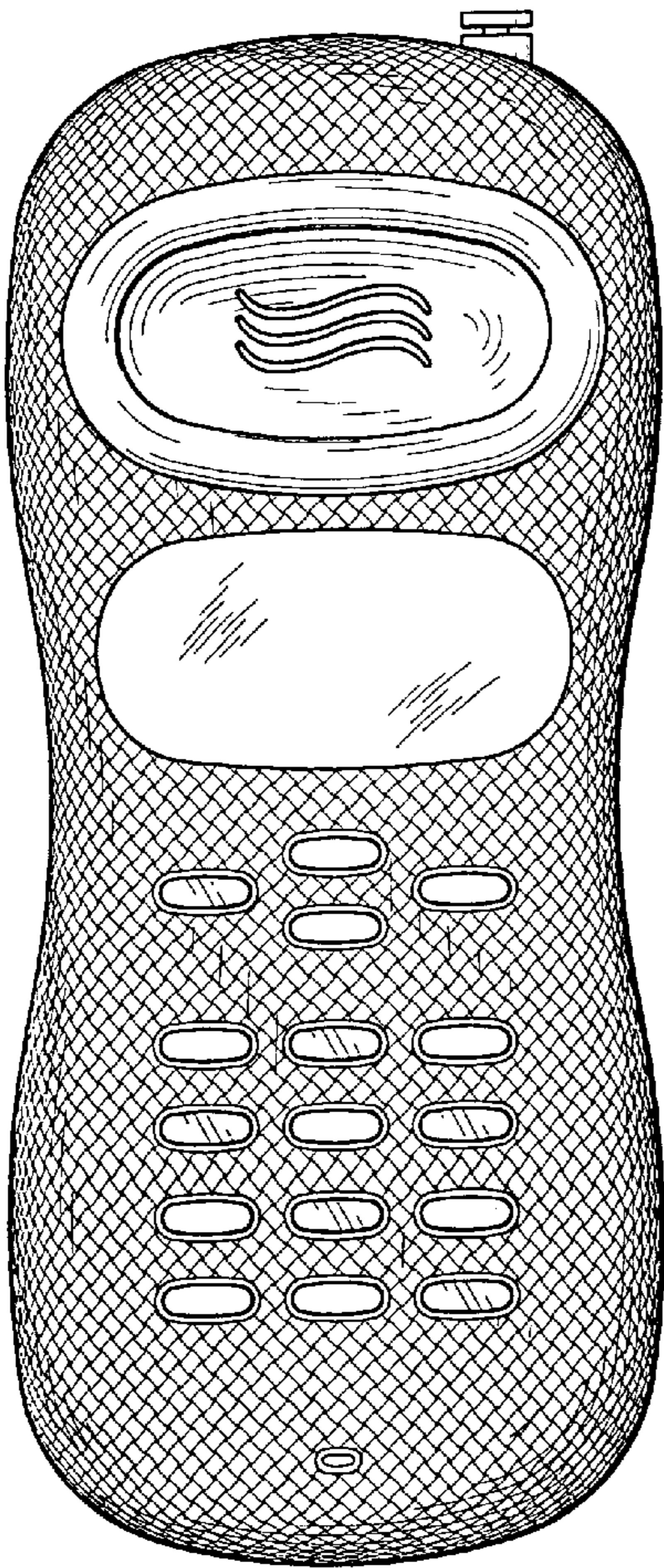
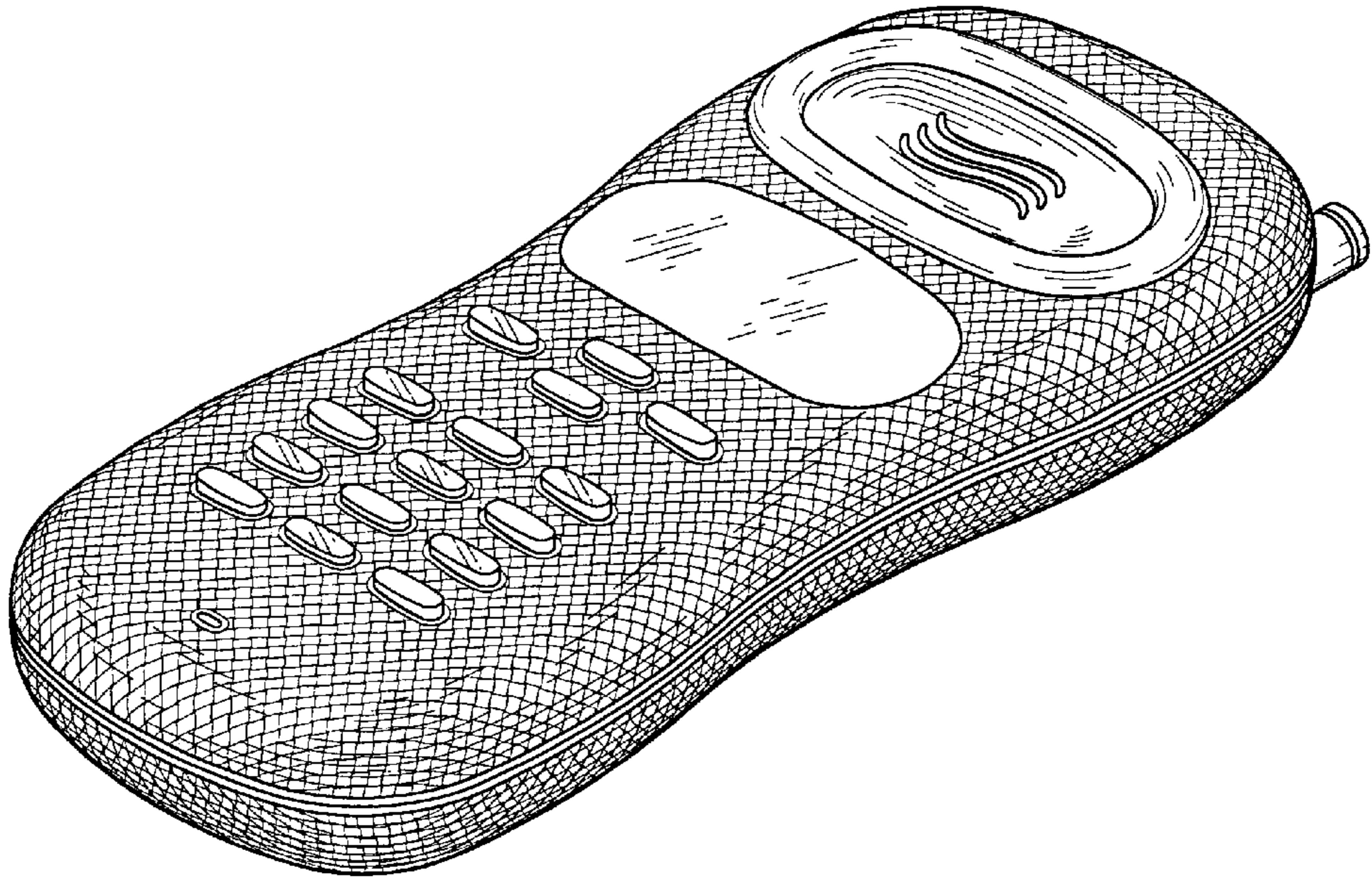

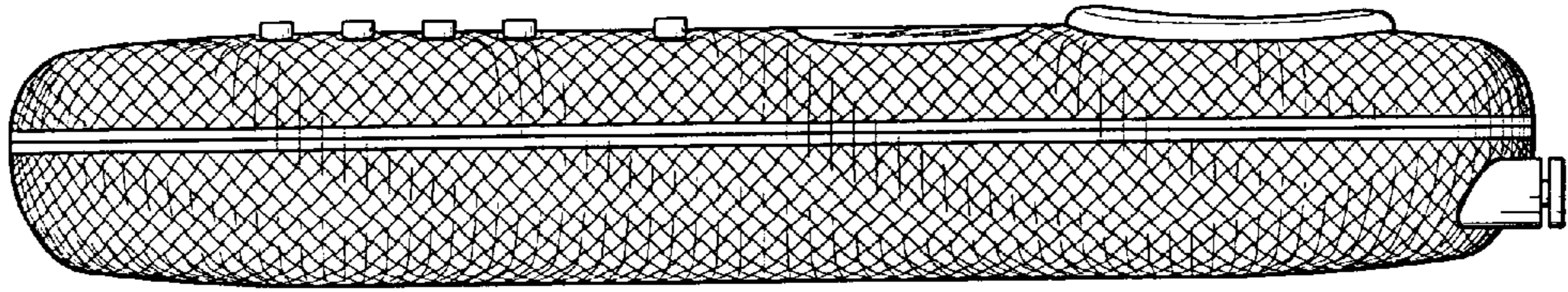

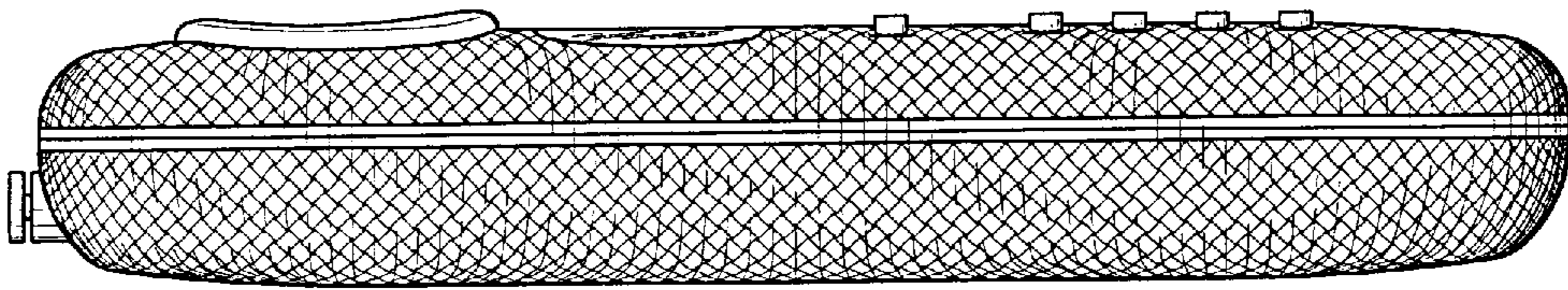

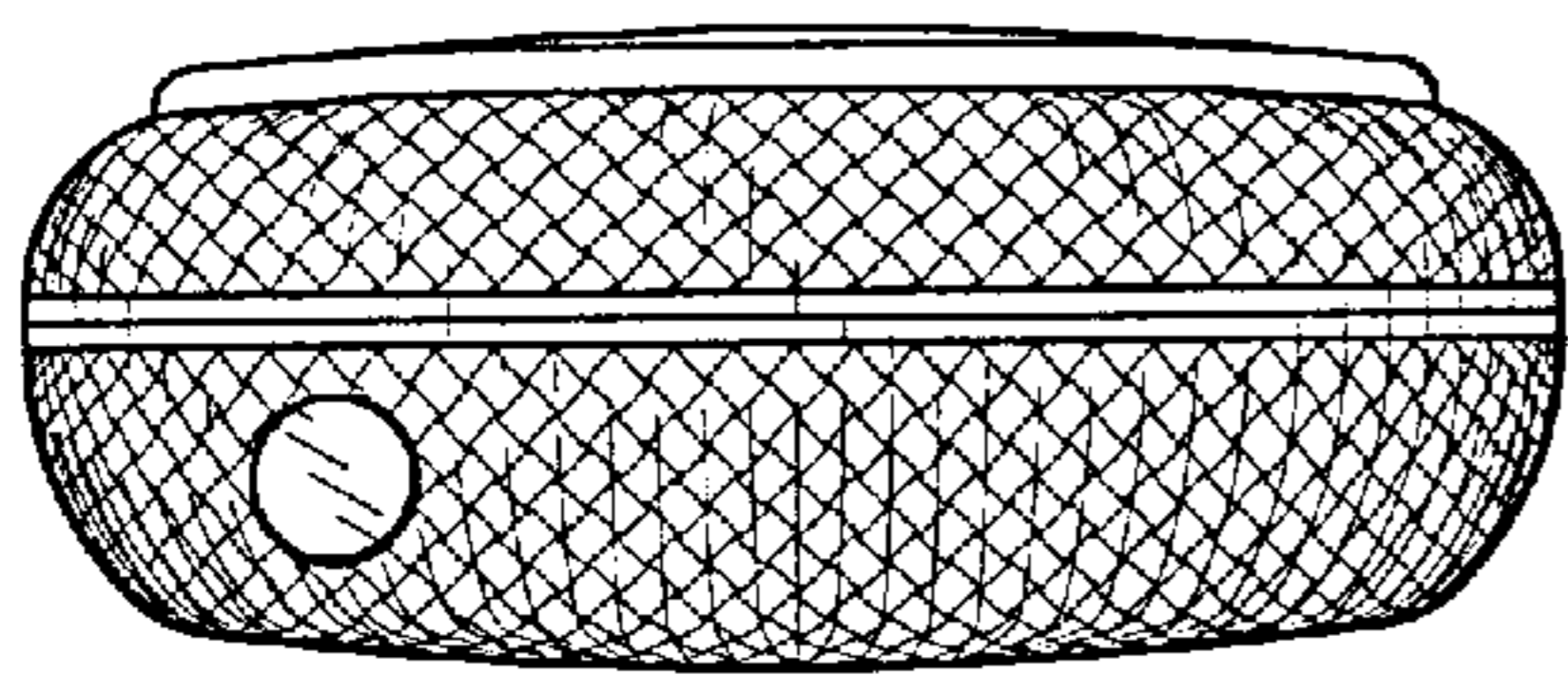

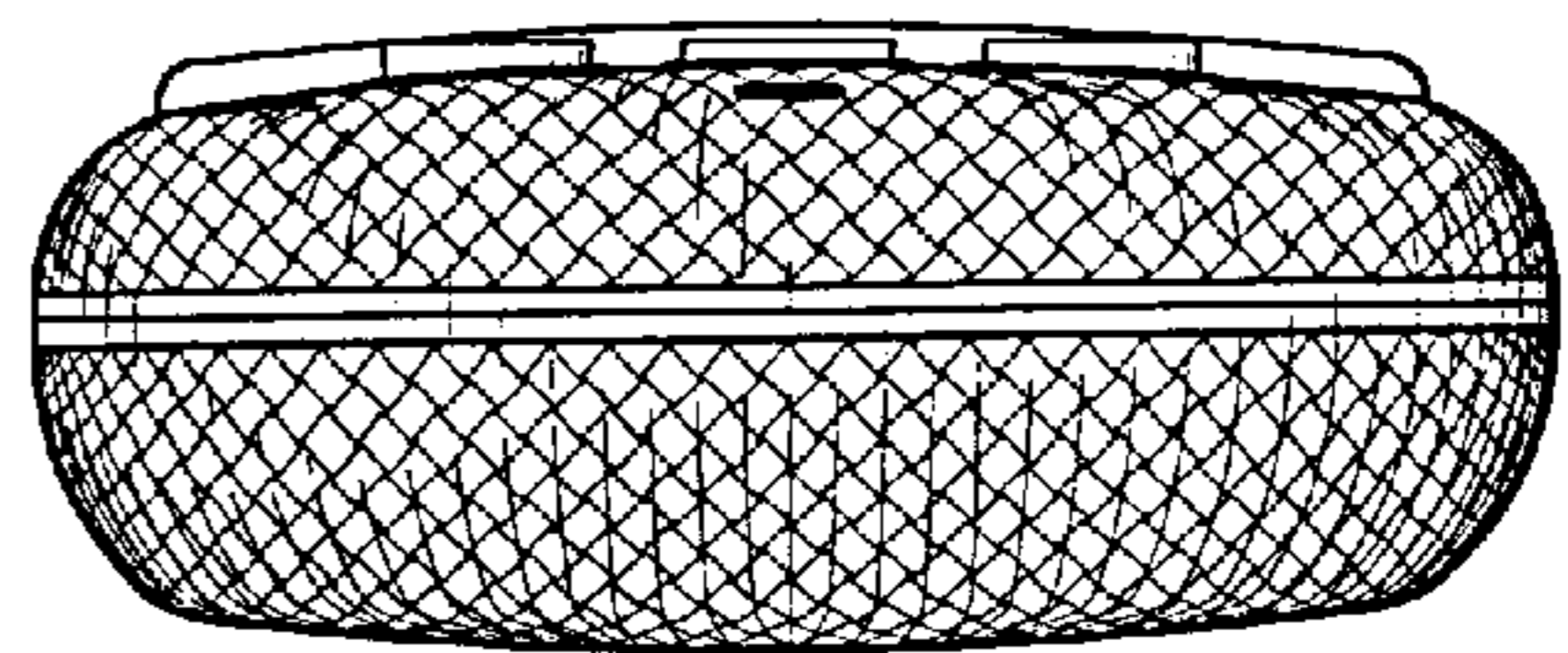
