The ornamental design for a sport shoe, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevation of a sport shoe of the present invention;
FIG. 2 is a right side elevation of the shoe;
FIG. 3 is a front elevation of the shoe;
FIG. 4 is a rear elevation of the shoe; and,
FIG. 5 is a top plan of the shoe.

The bottom of the sport shoe forms no part of the design.

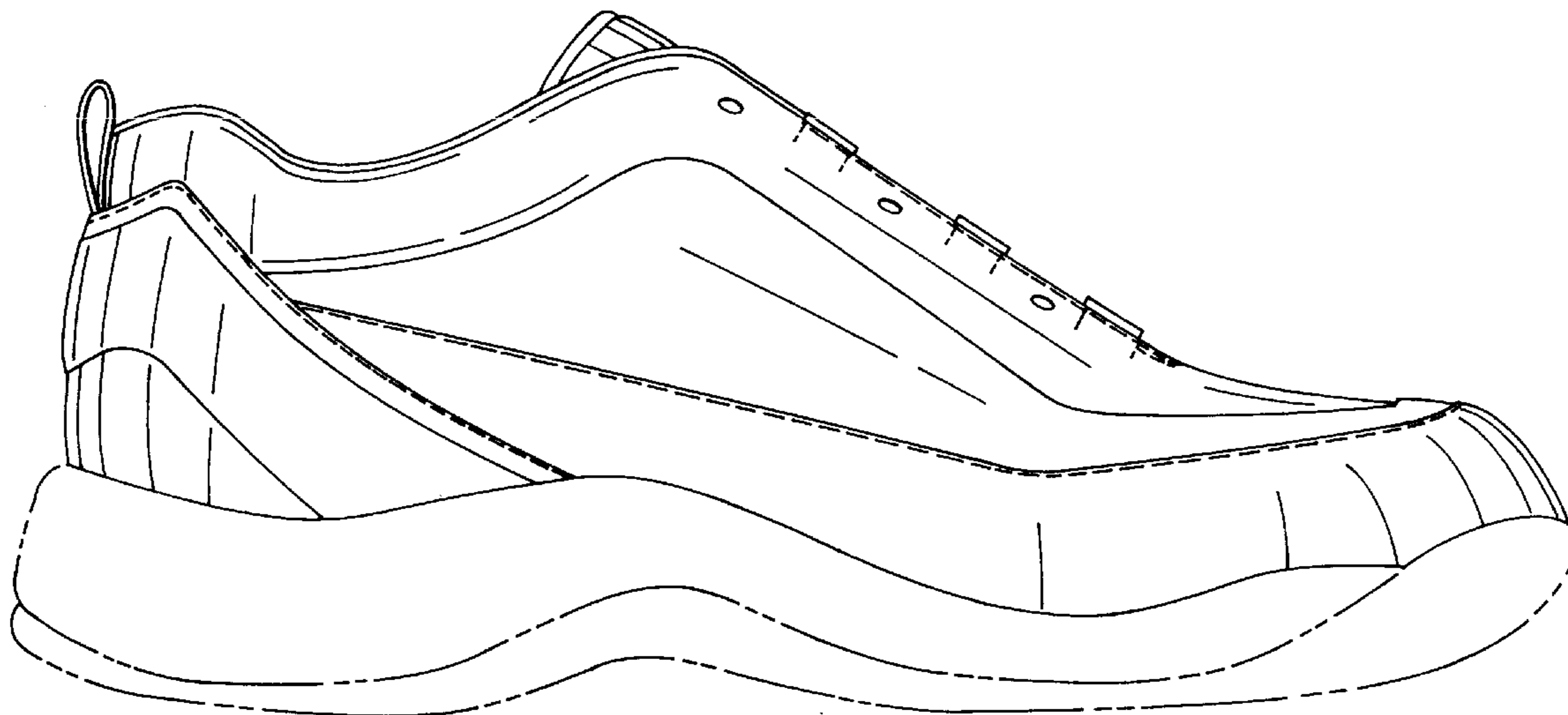
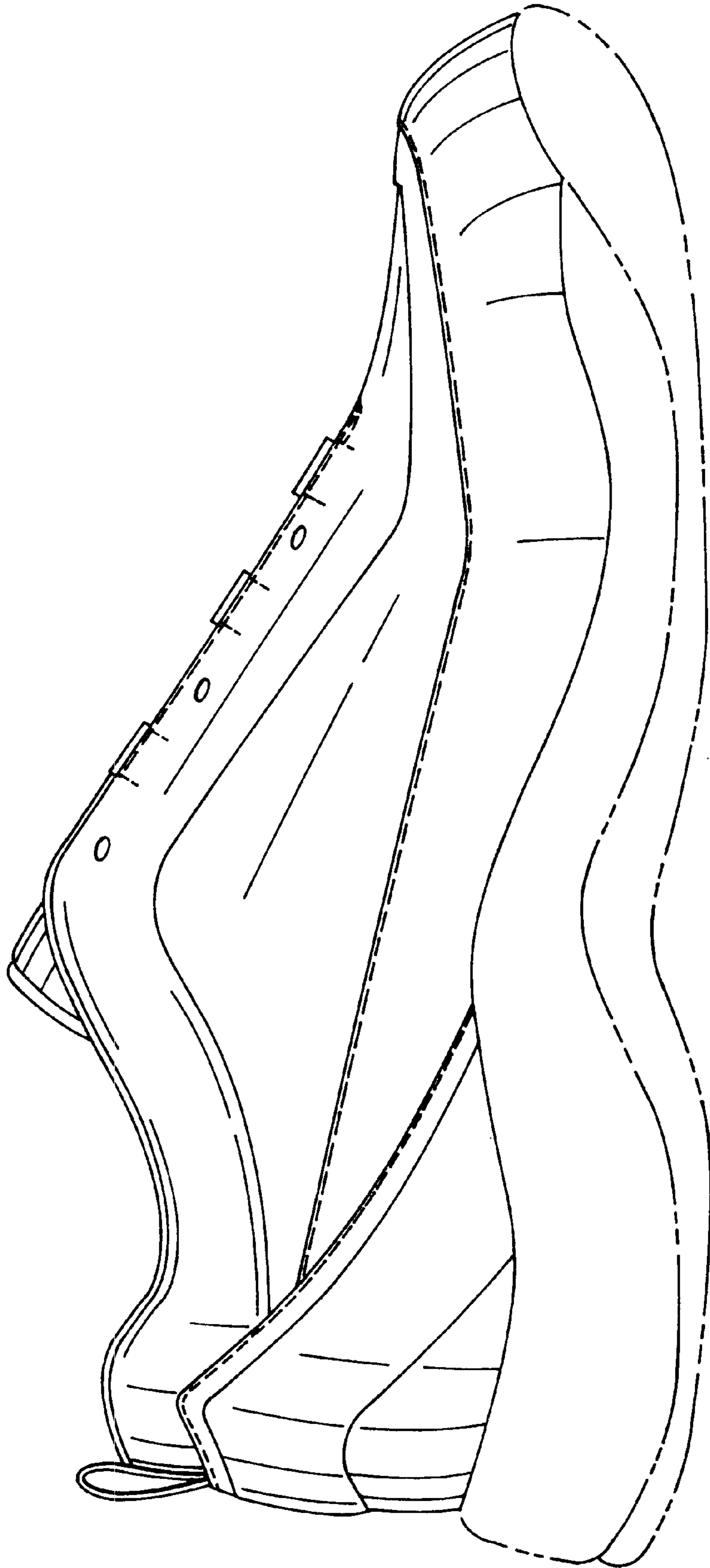

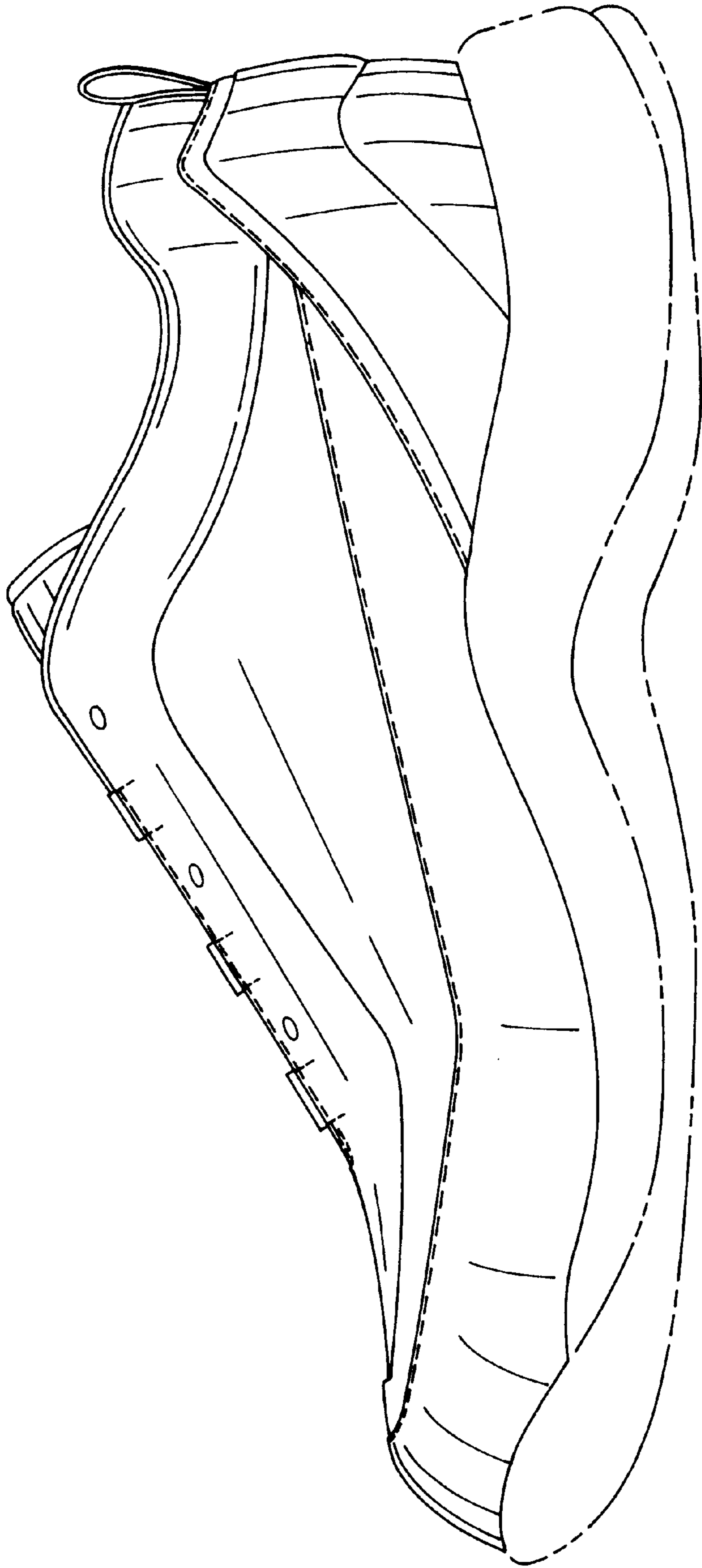

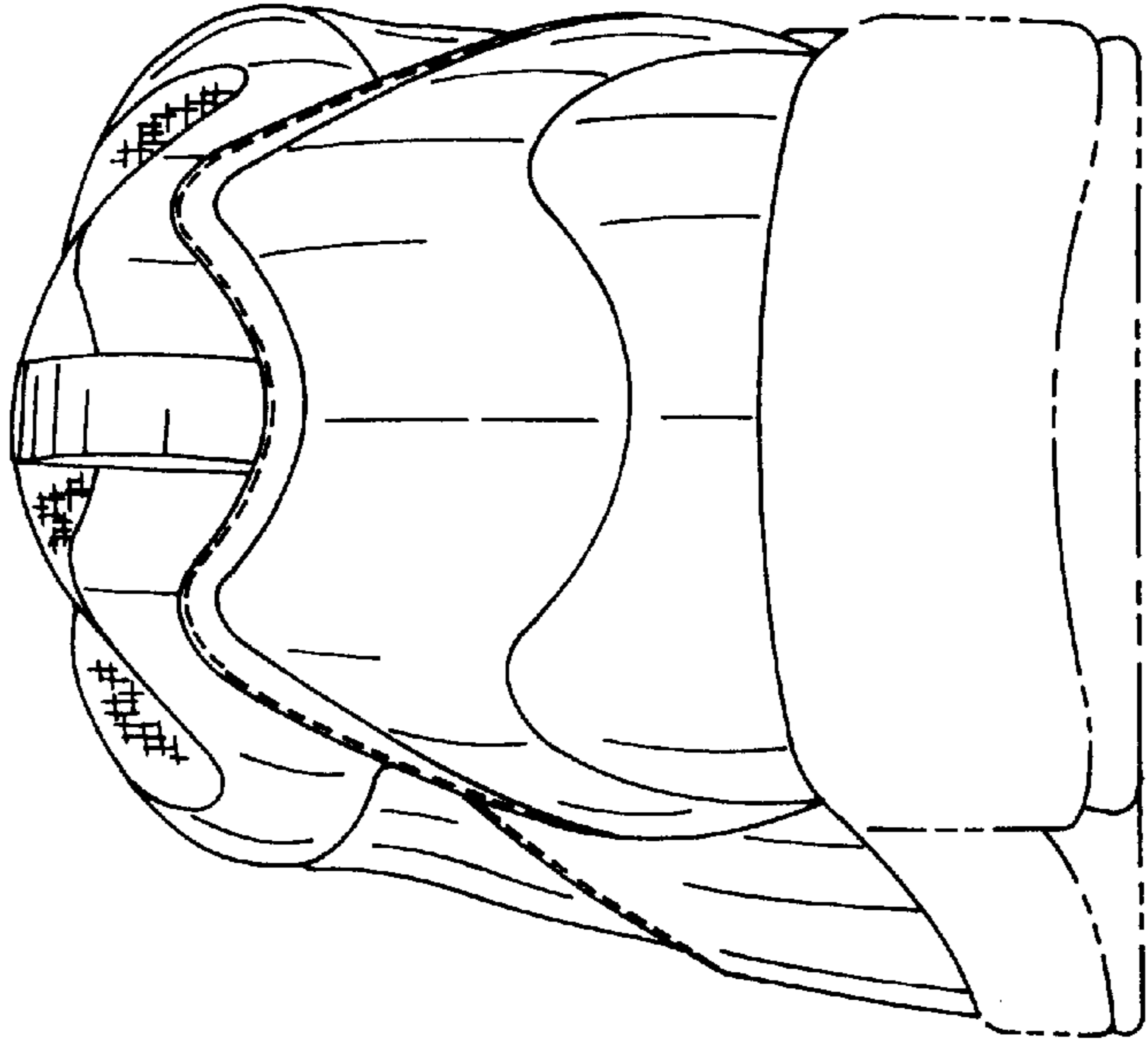

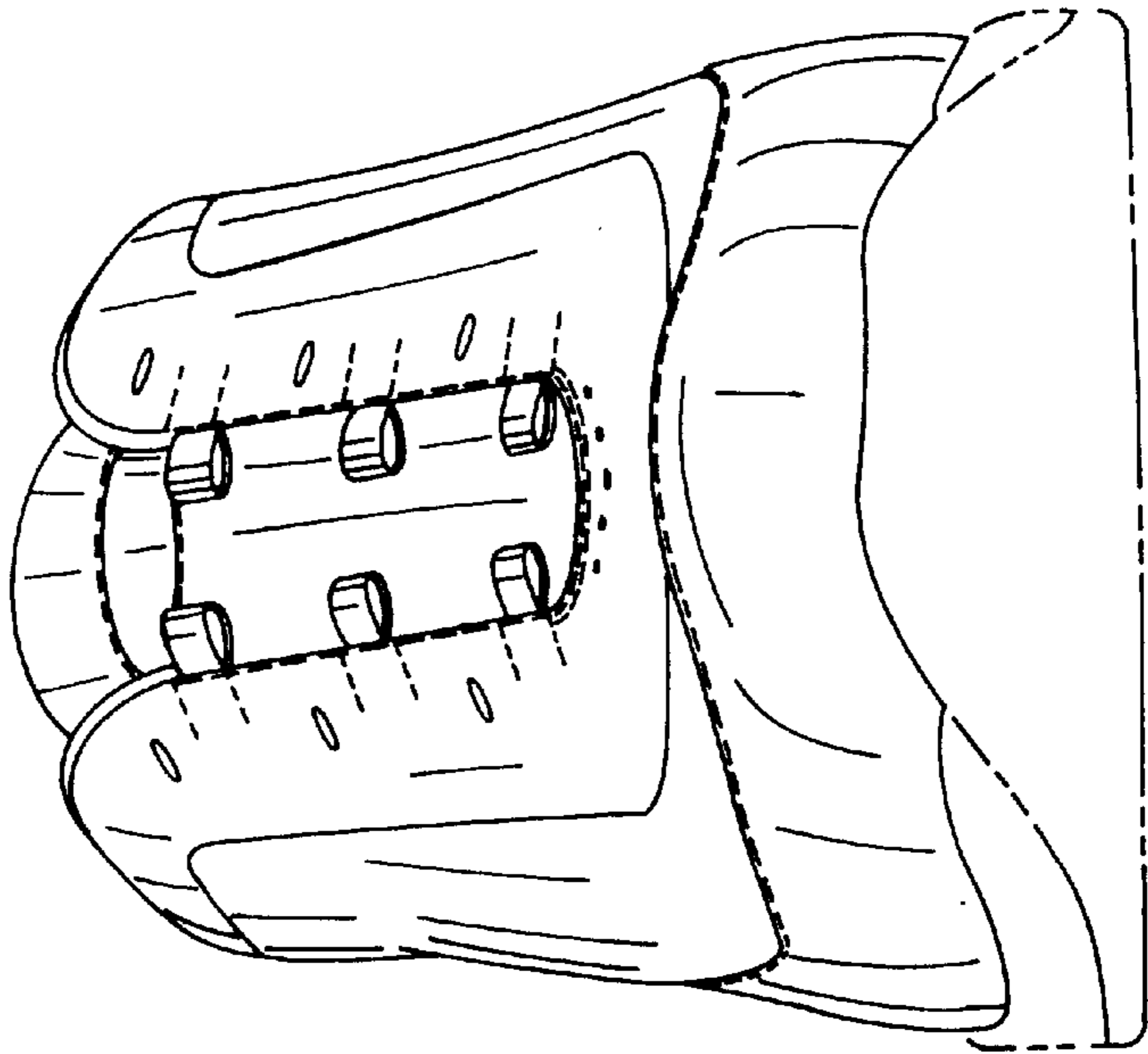
