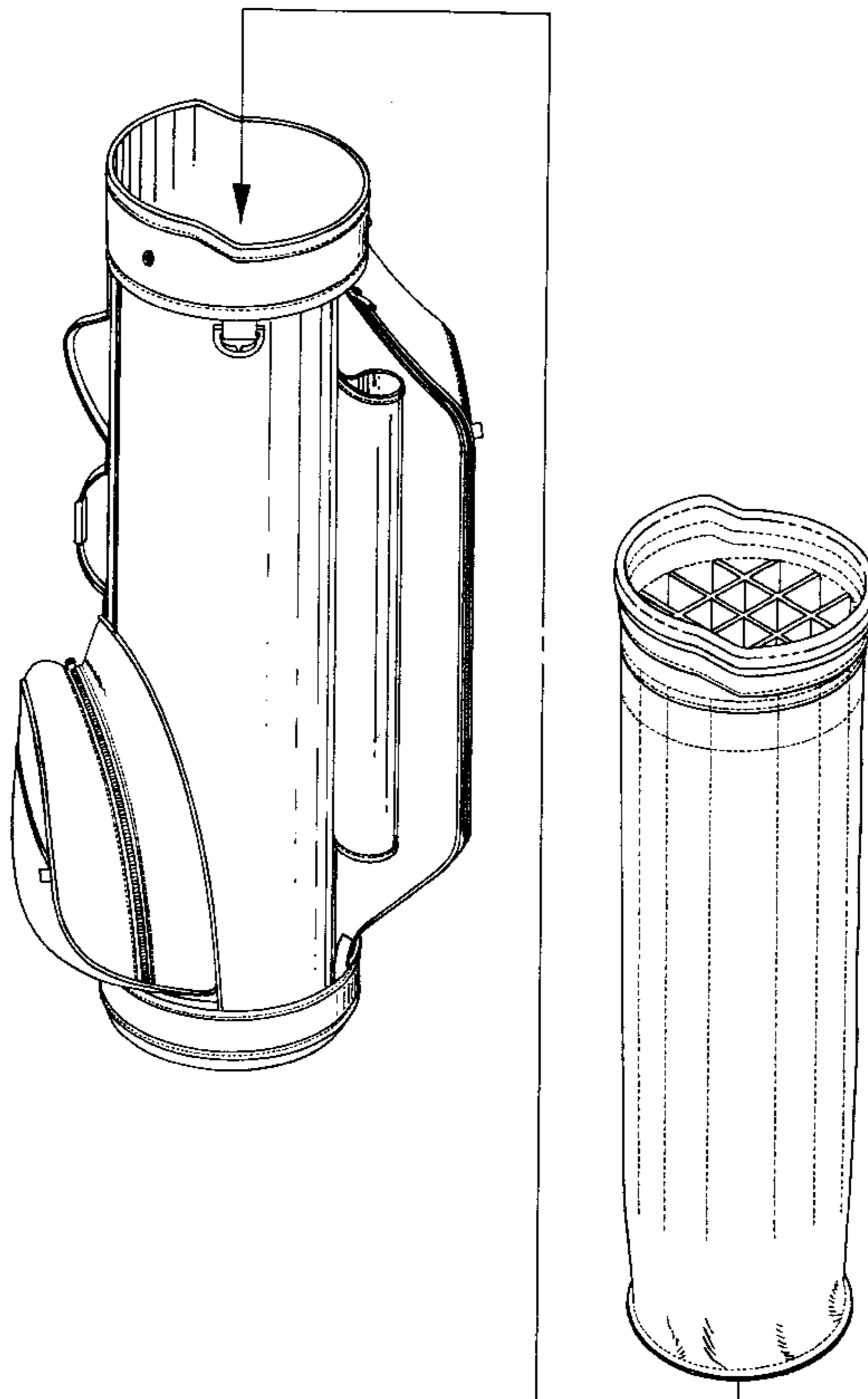
[57] **CLAIM**

The ornamental design for the golf bag with removable partitioned liner, as shown and described.

DESCRIPTION

FIG. 1 is an exploded, perspective view of the golf bag and the liner with the individual pockets.
 FIG. 2 is a front view of the liner.
 FIG. 3 is a top view of the liner.
 FIG. 4 is a side view of the liner.
 FIG. 5 is a bottom view of the liner.

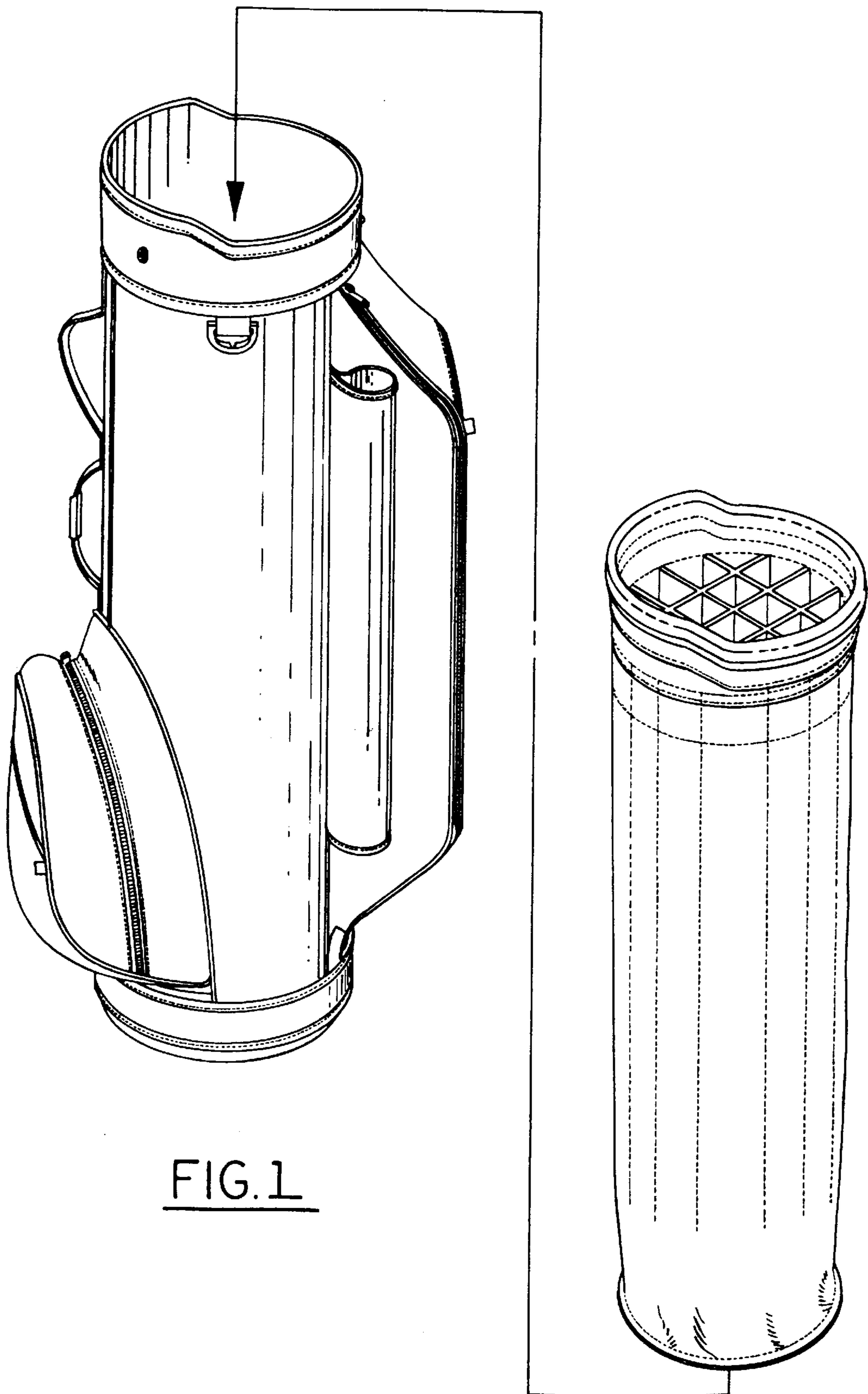

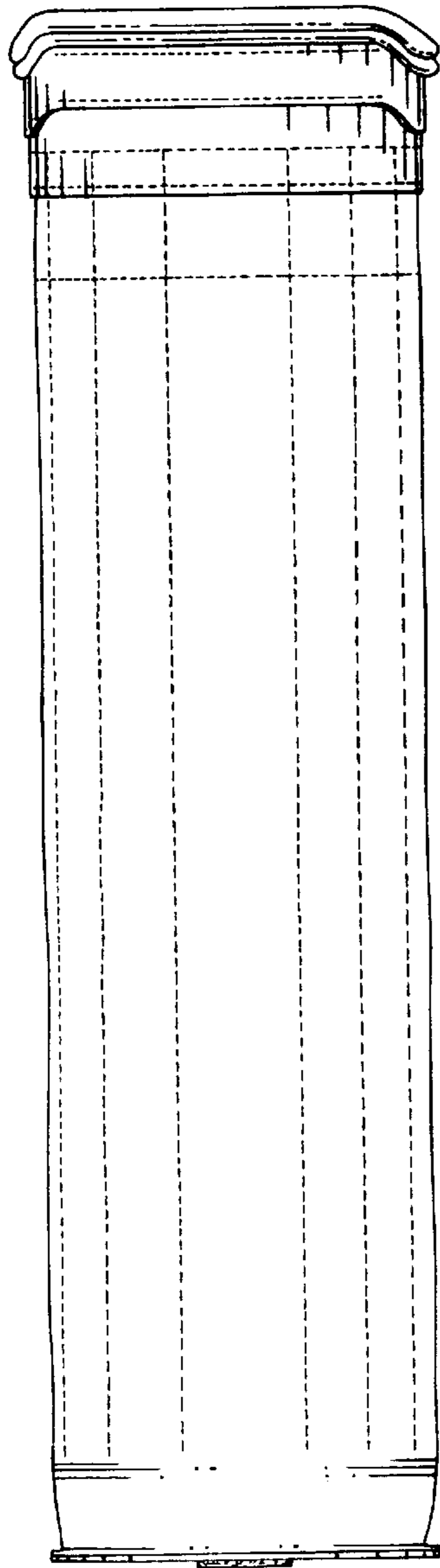

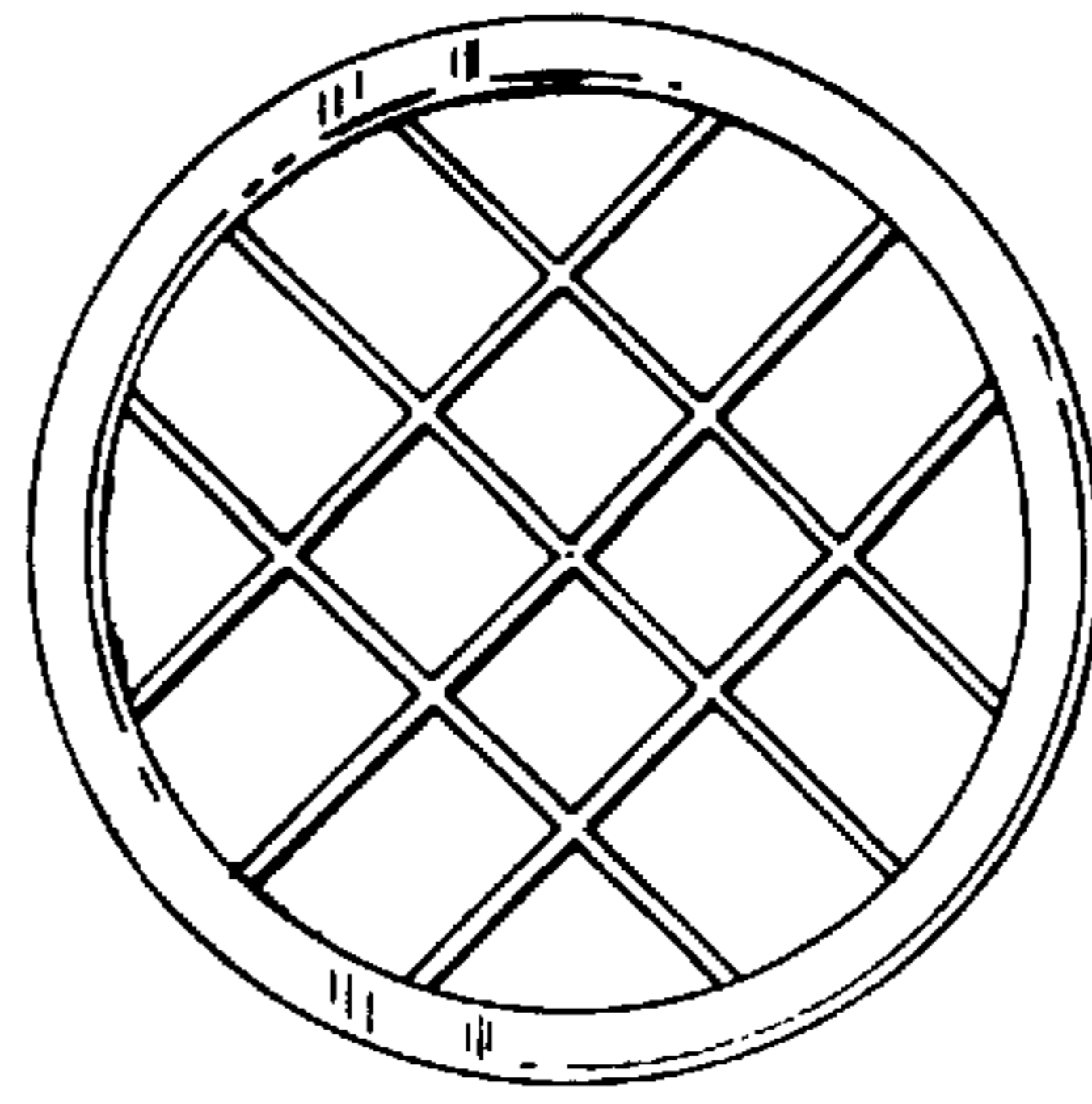

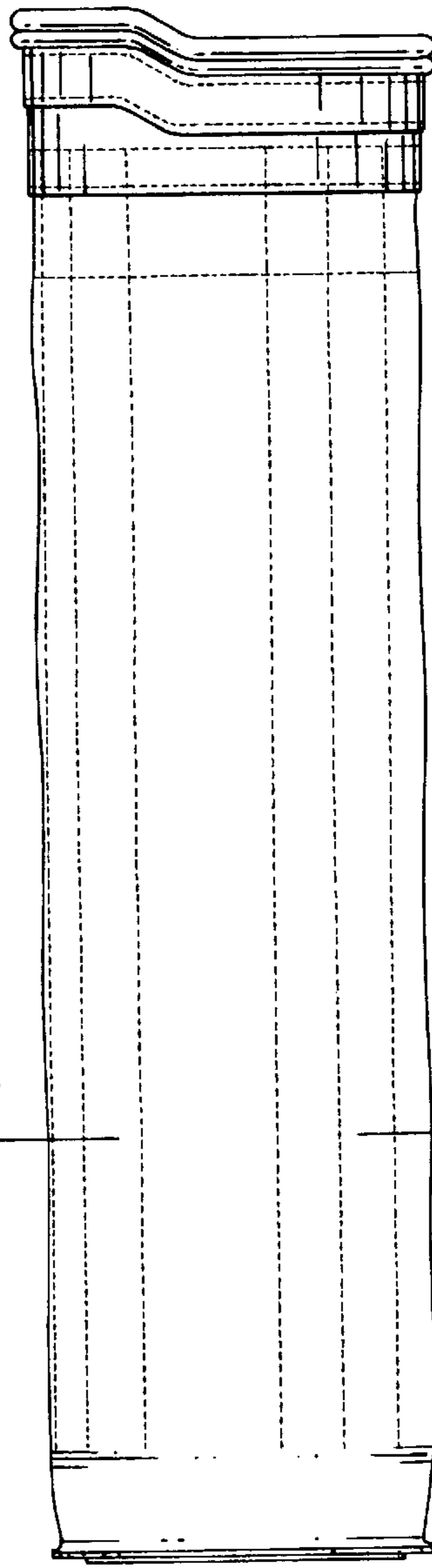

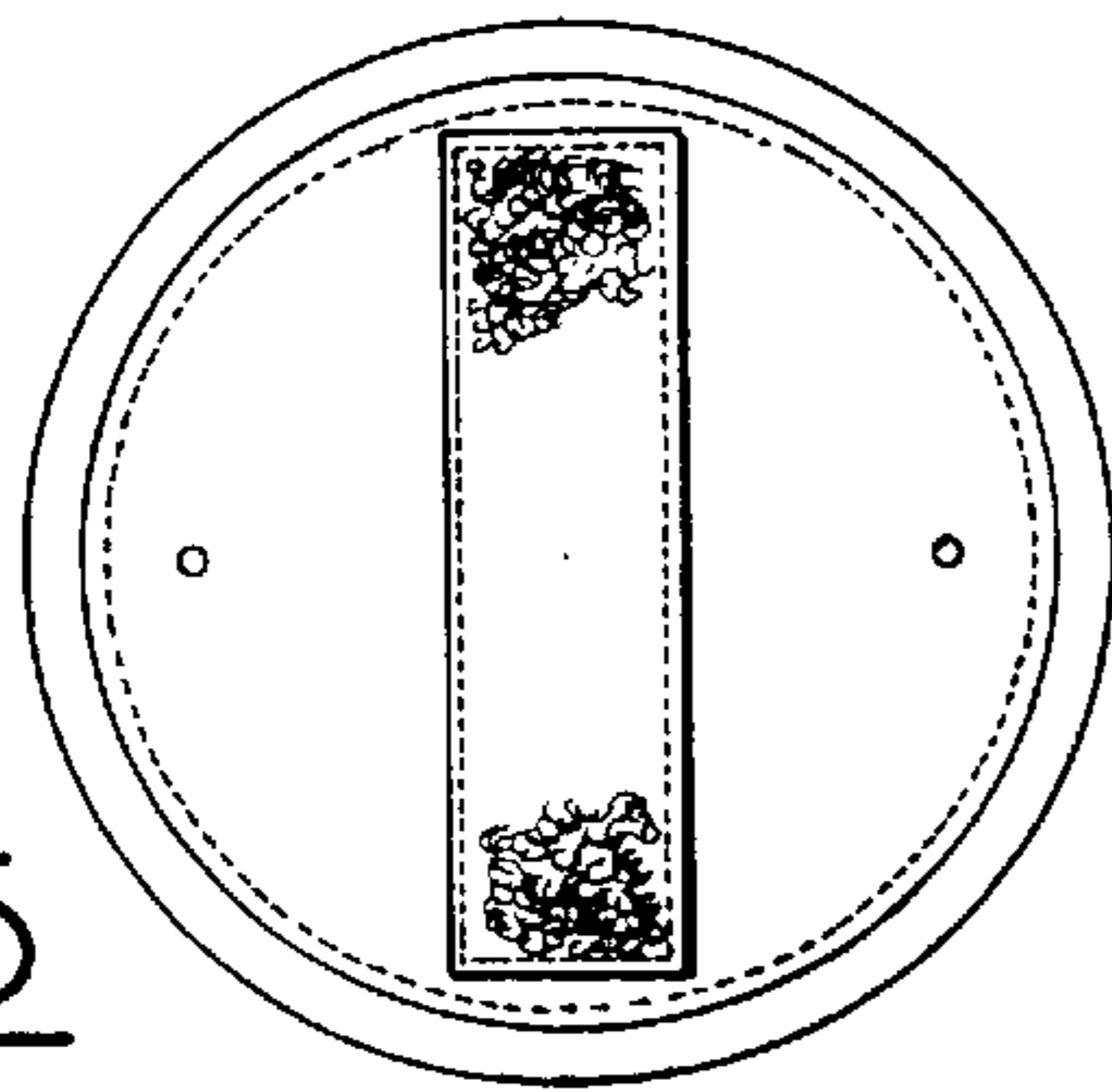

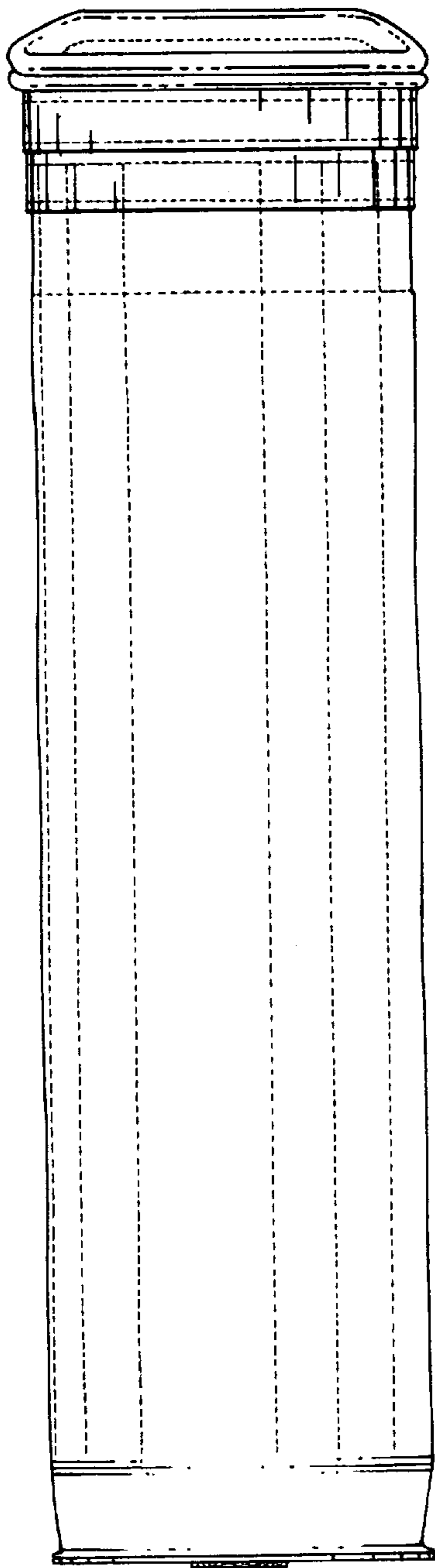

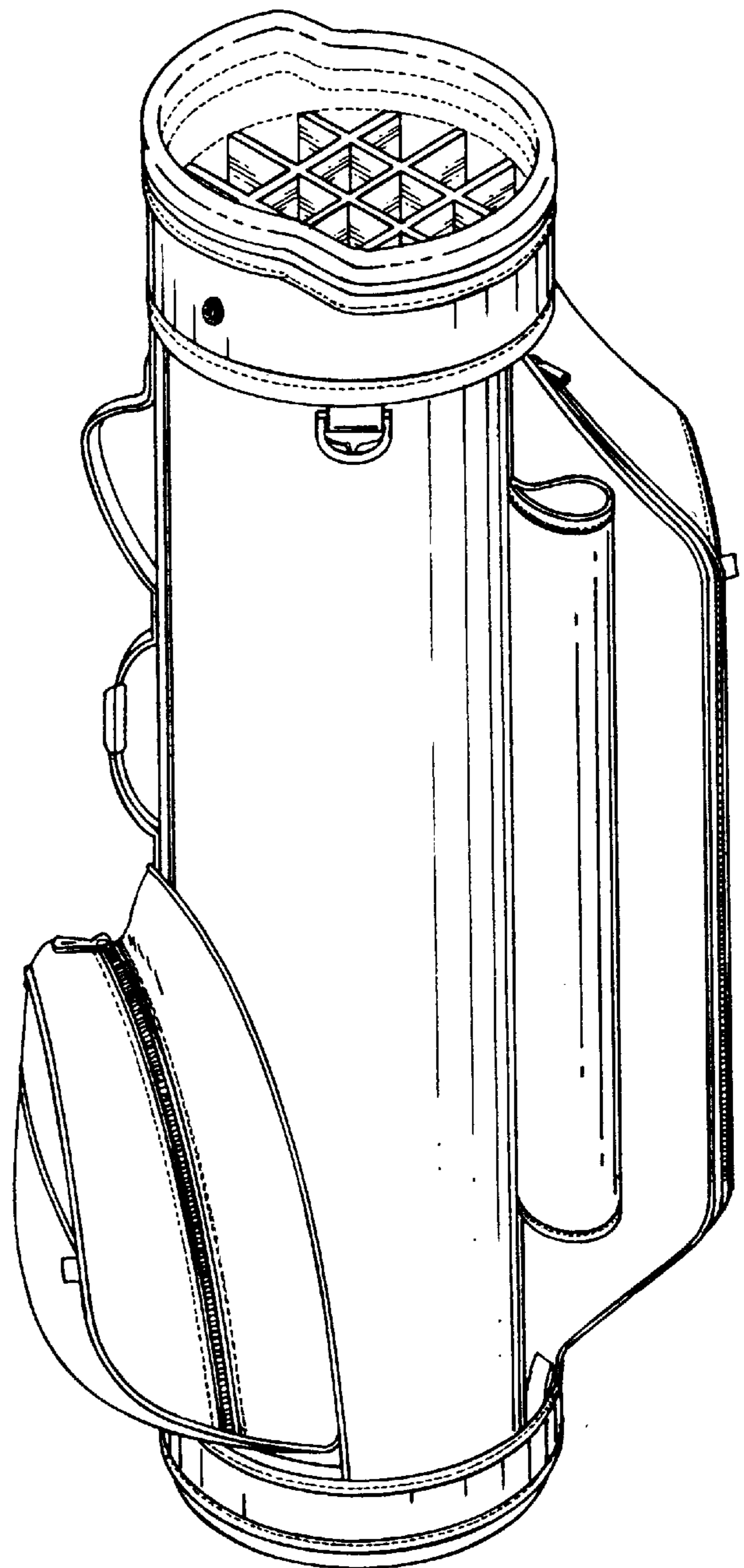

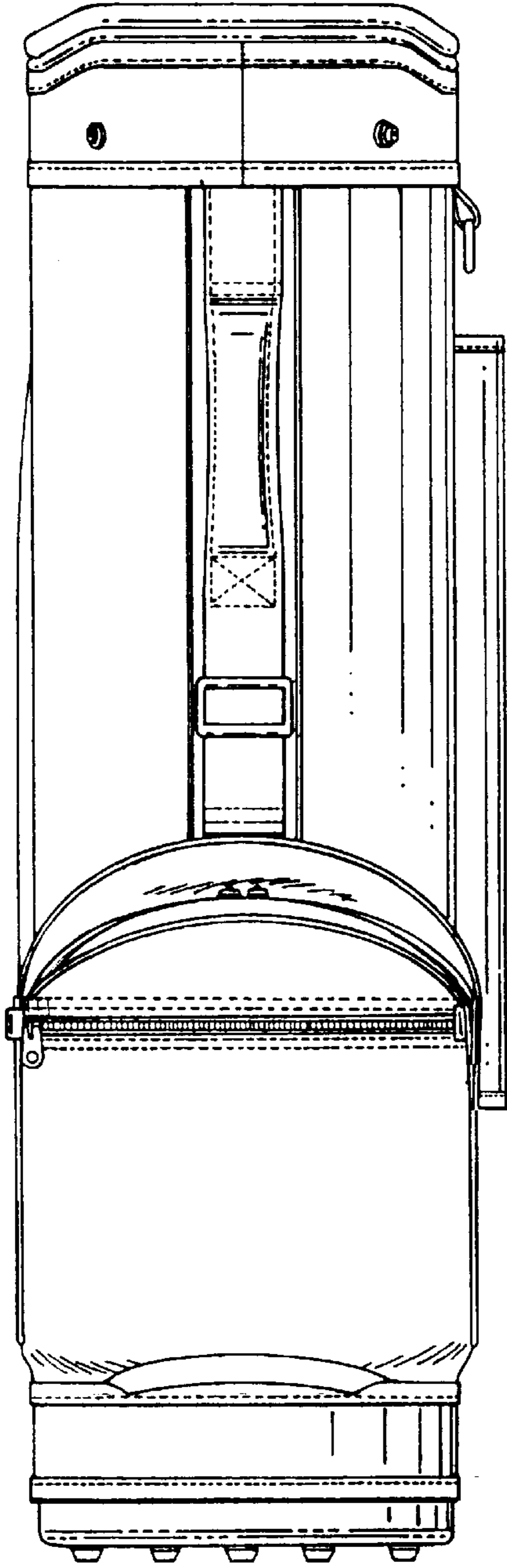

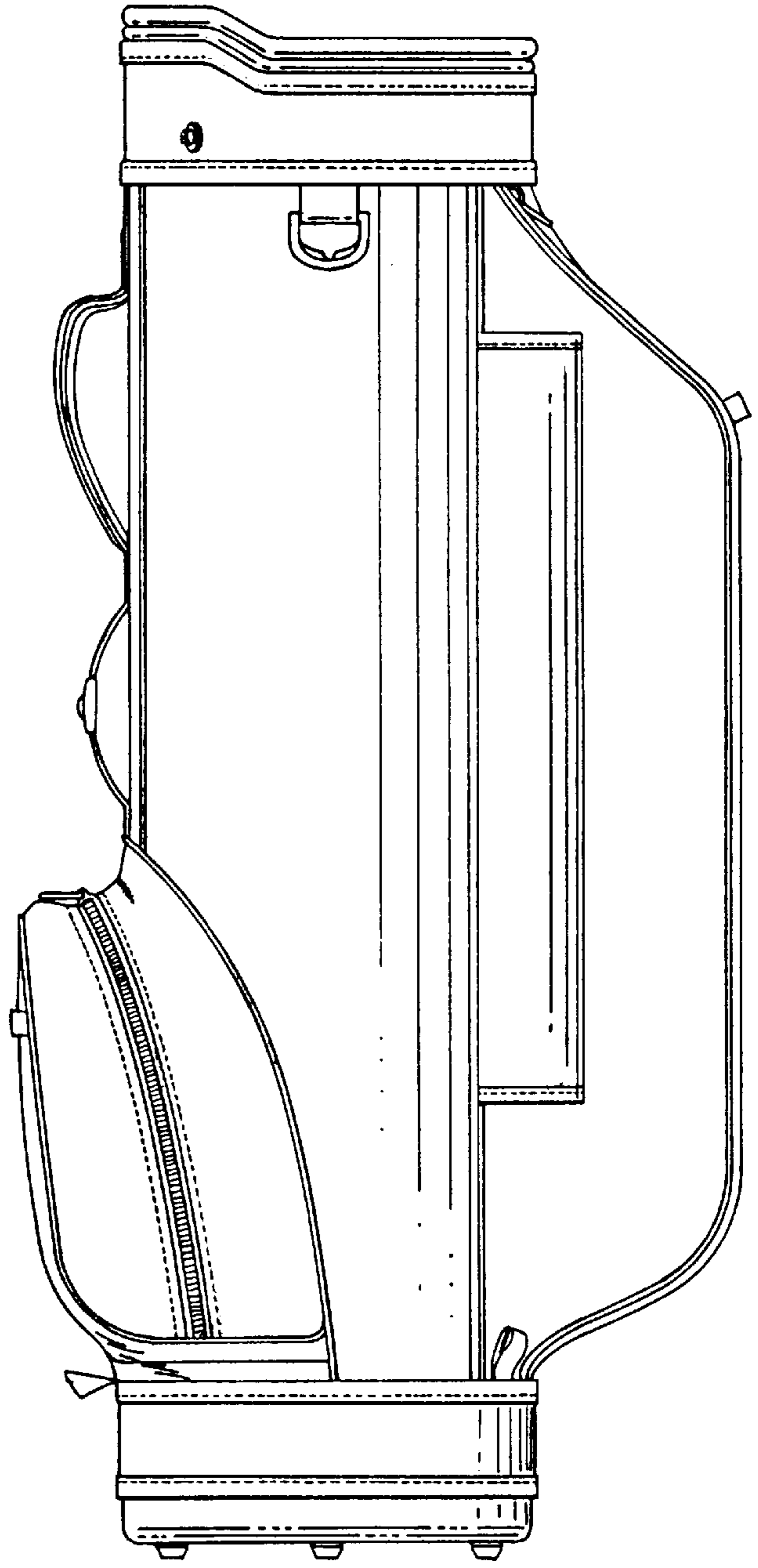

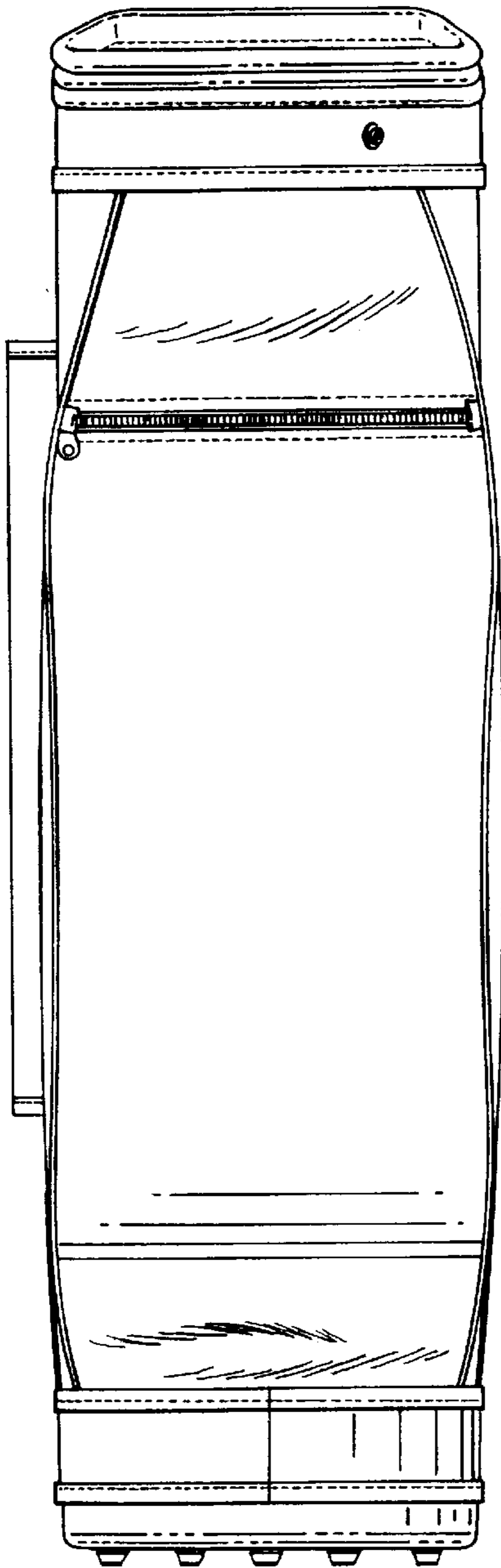

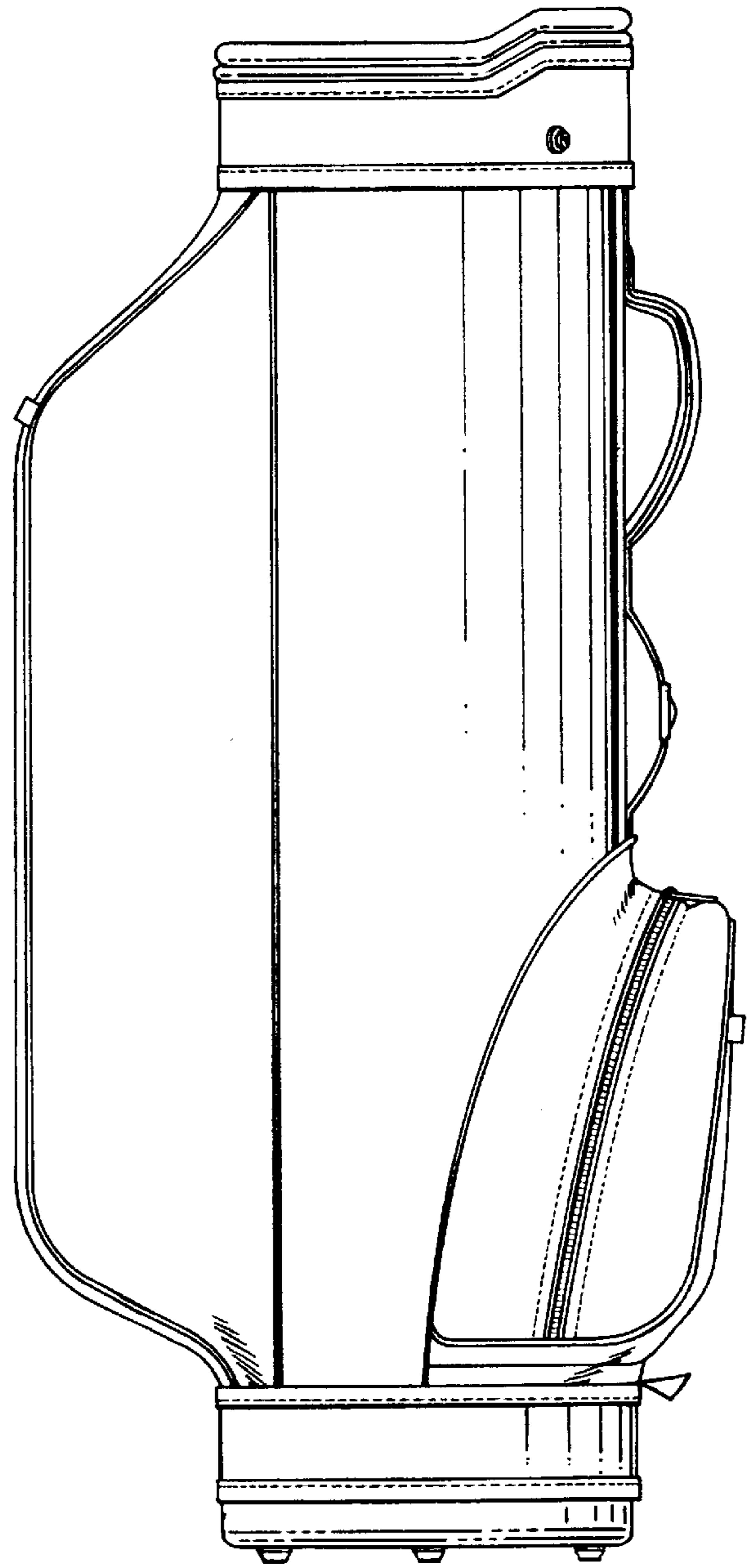

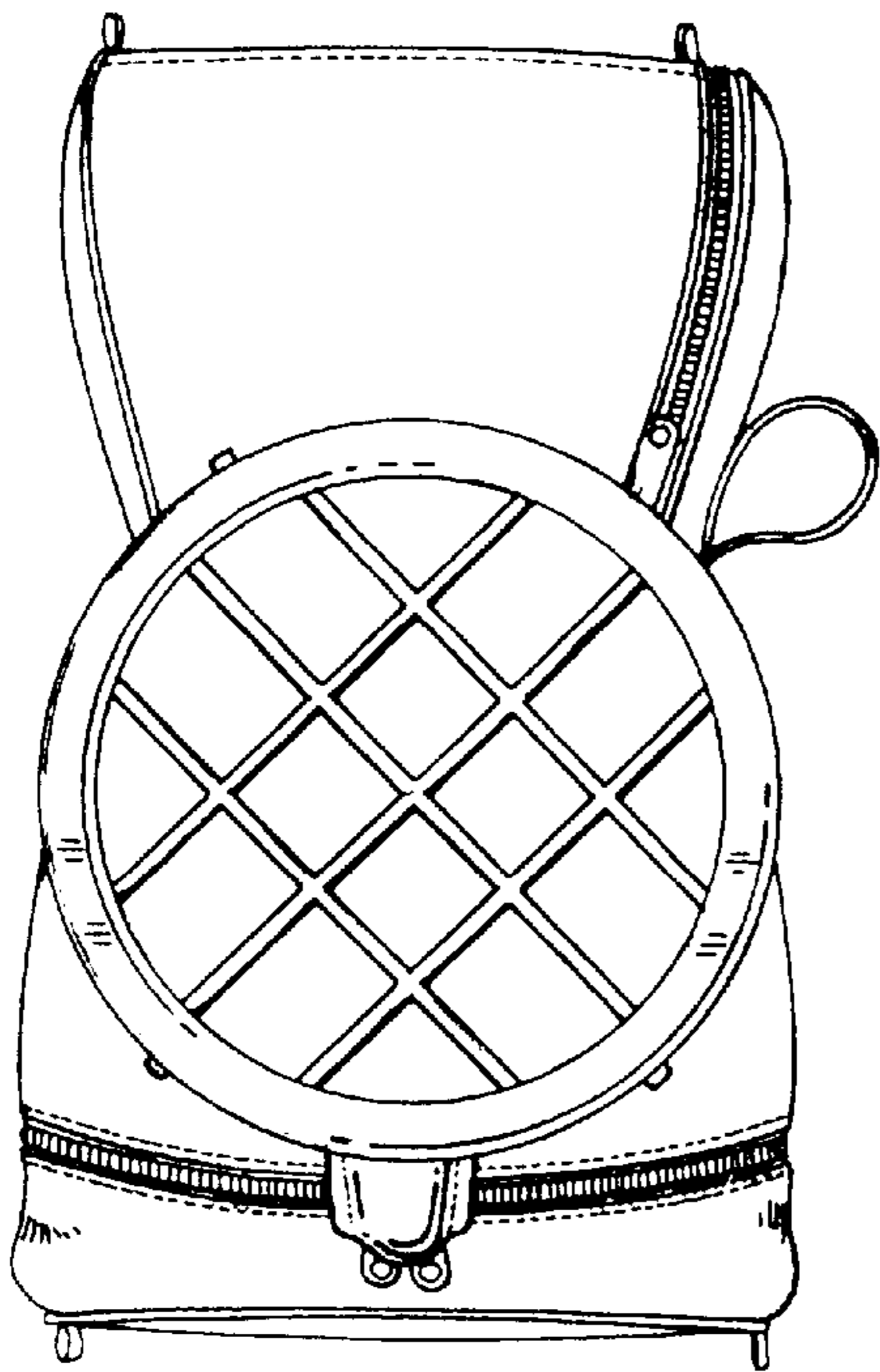

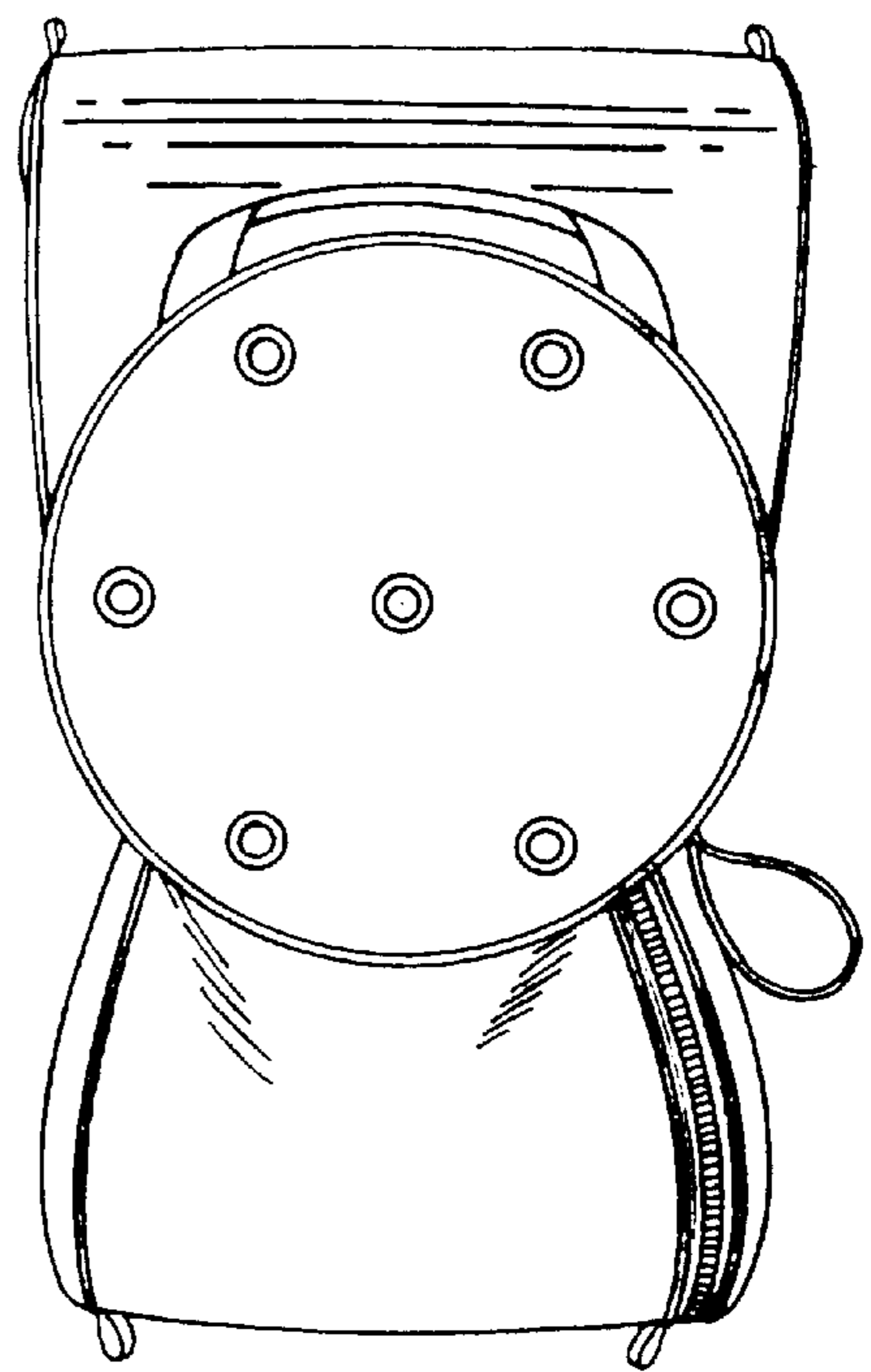
