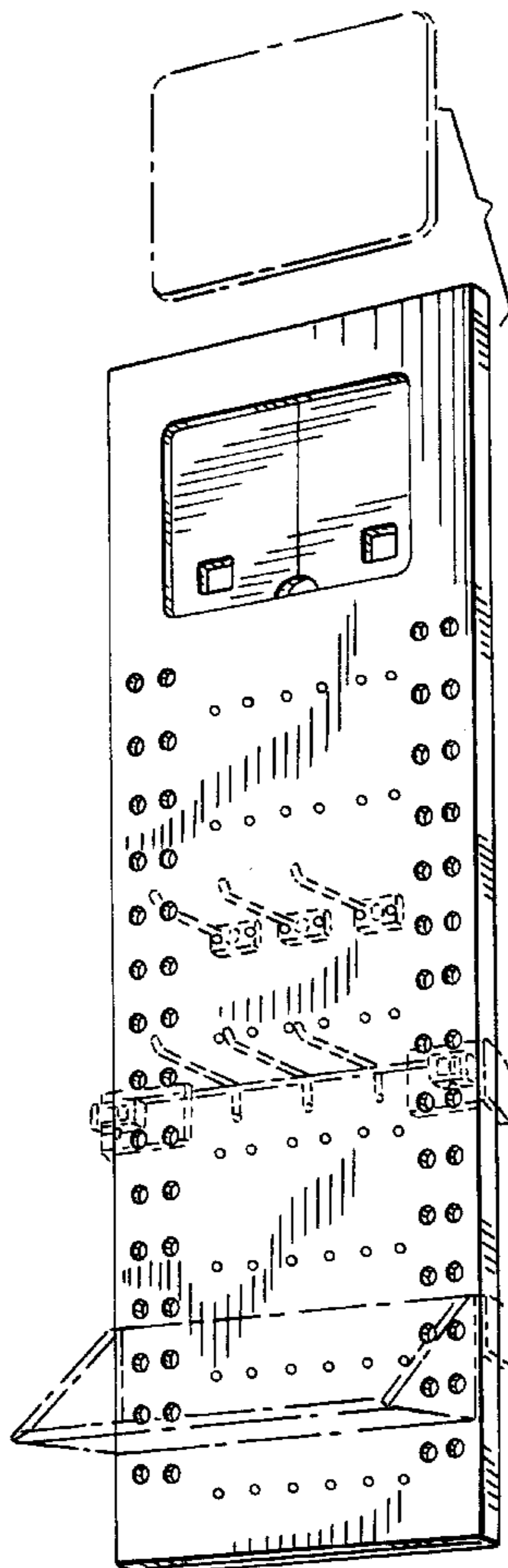
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of may new design, with representative product display elements, and a product description sign shown in phantom;

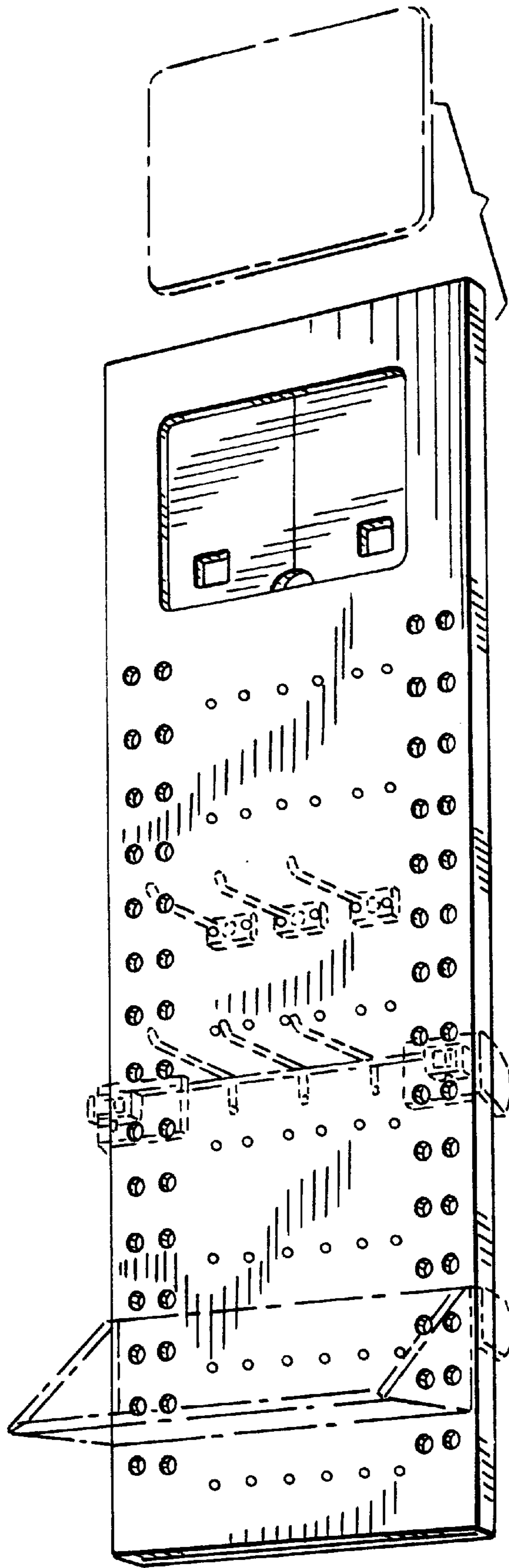
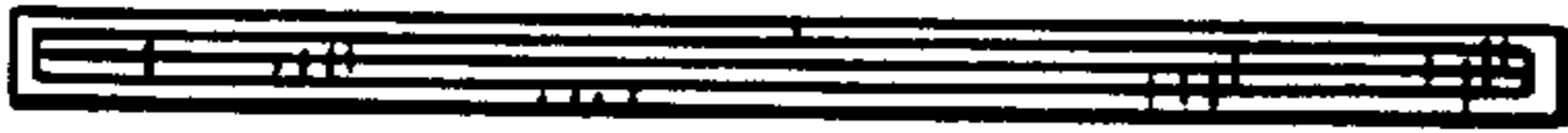
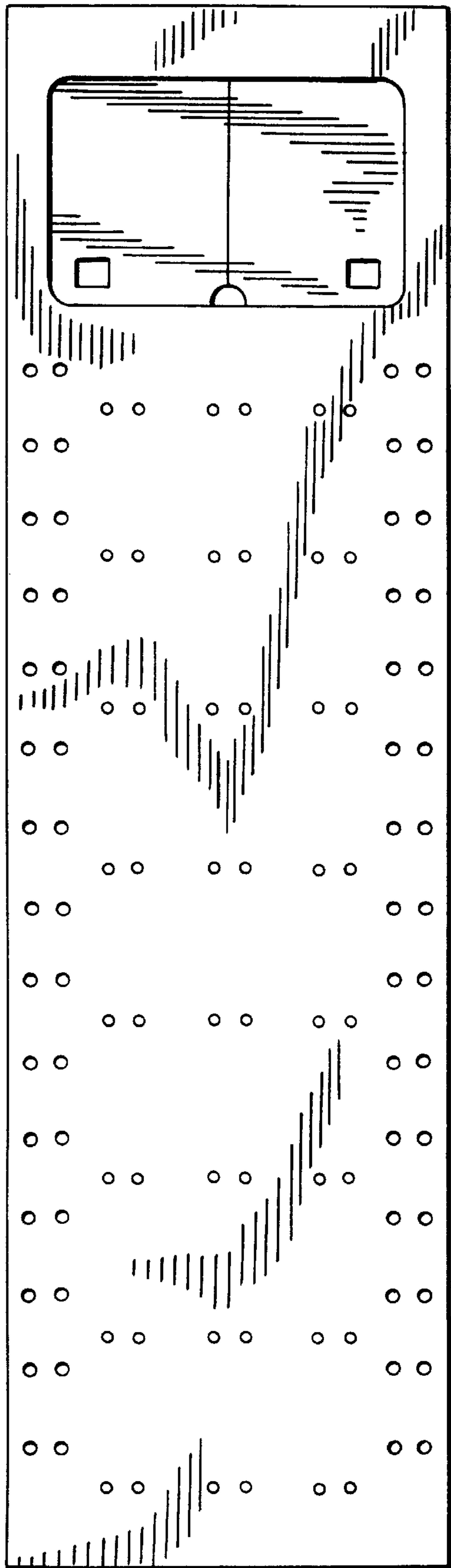

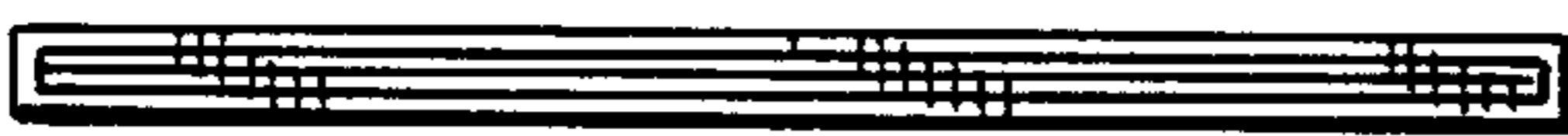

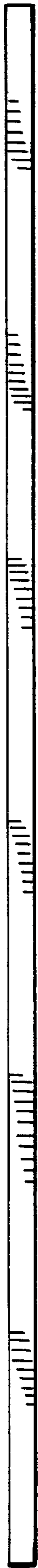

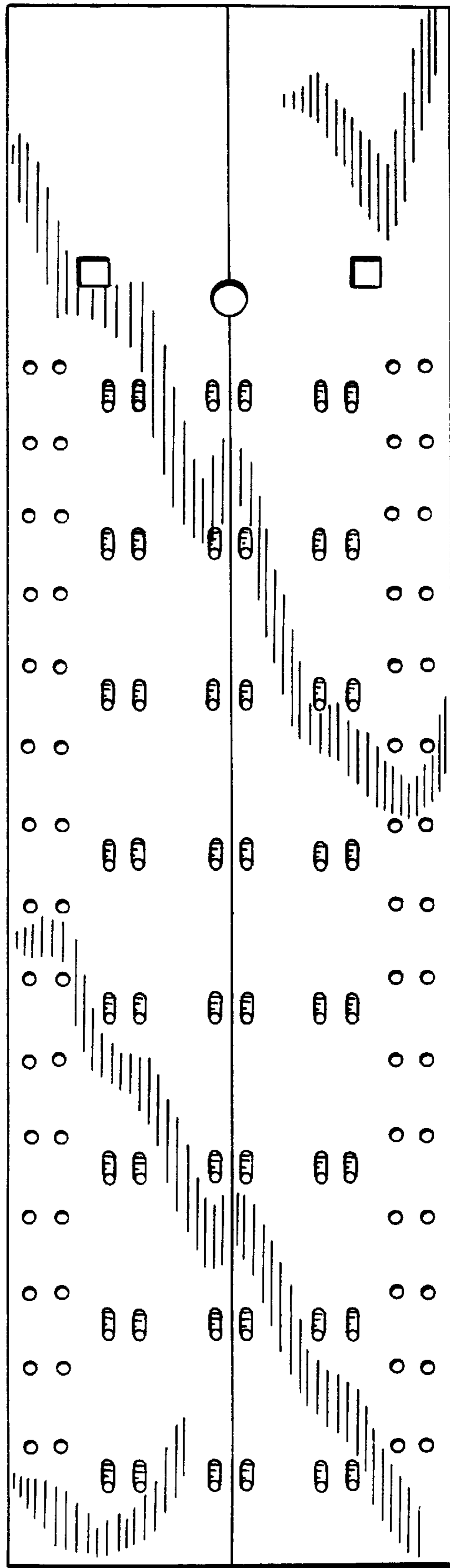
