DESCRIPTION

FIG. 1 is a front elevational view of eyewear showing my new design;

FIG. 6 is a front elevational view of eyewear showing a modified embodiment of my new design;

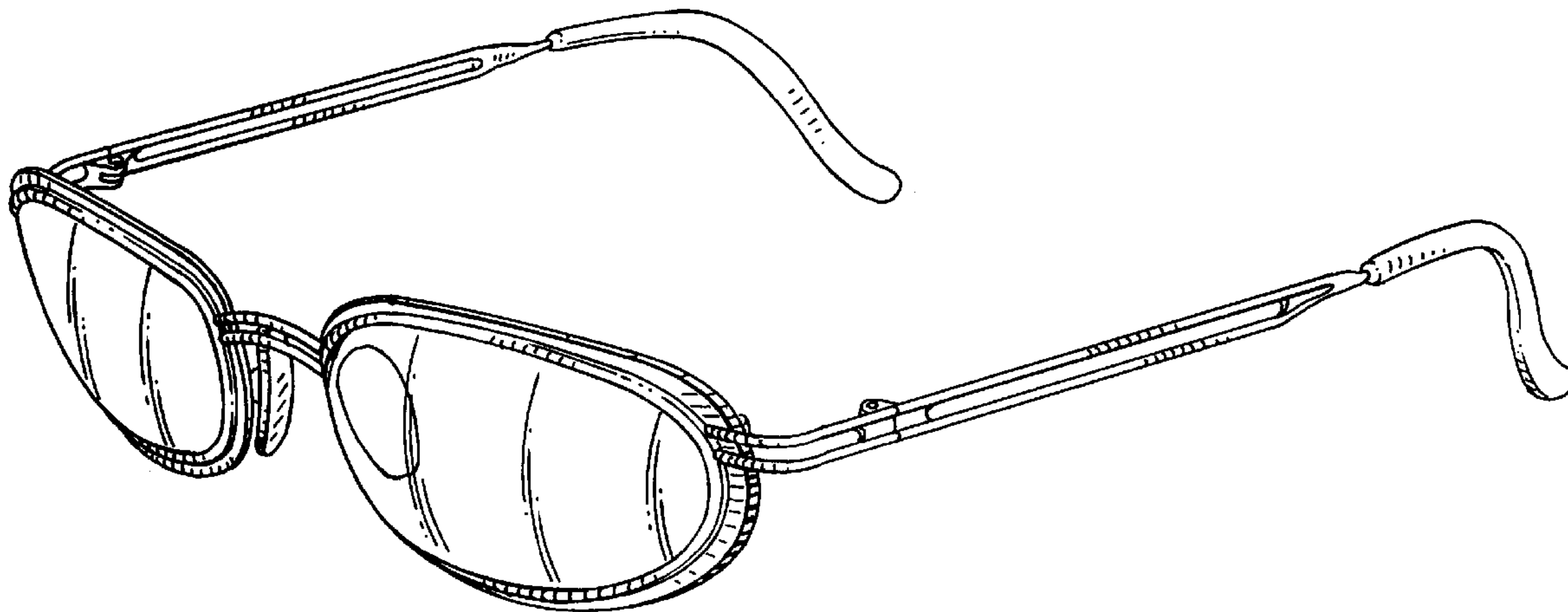
FIG. 7 is a side elevational view thereof;

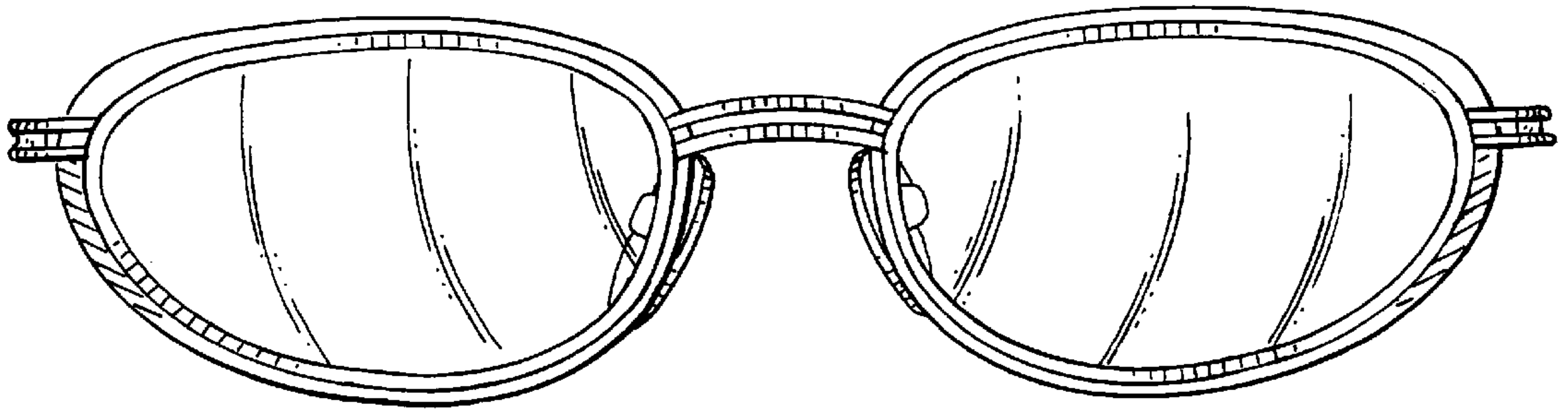

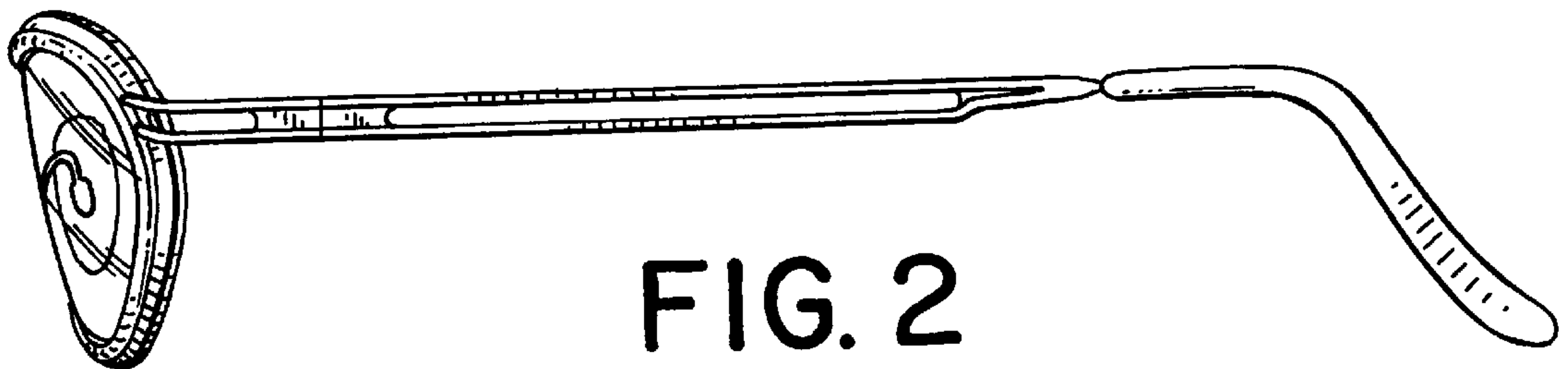

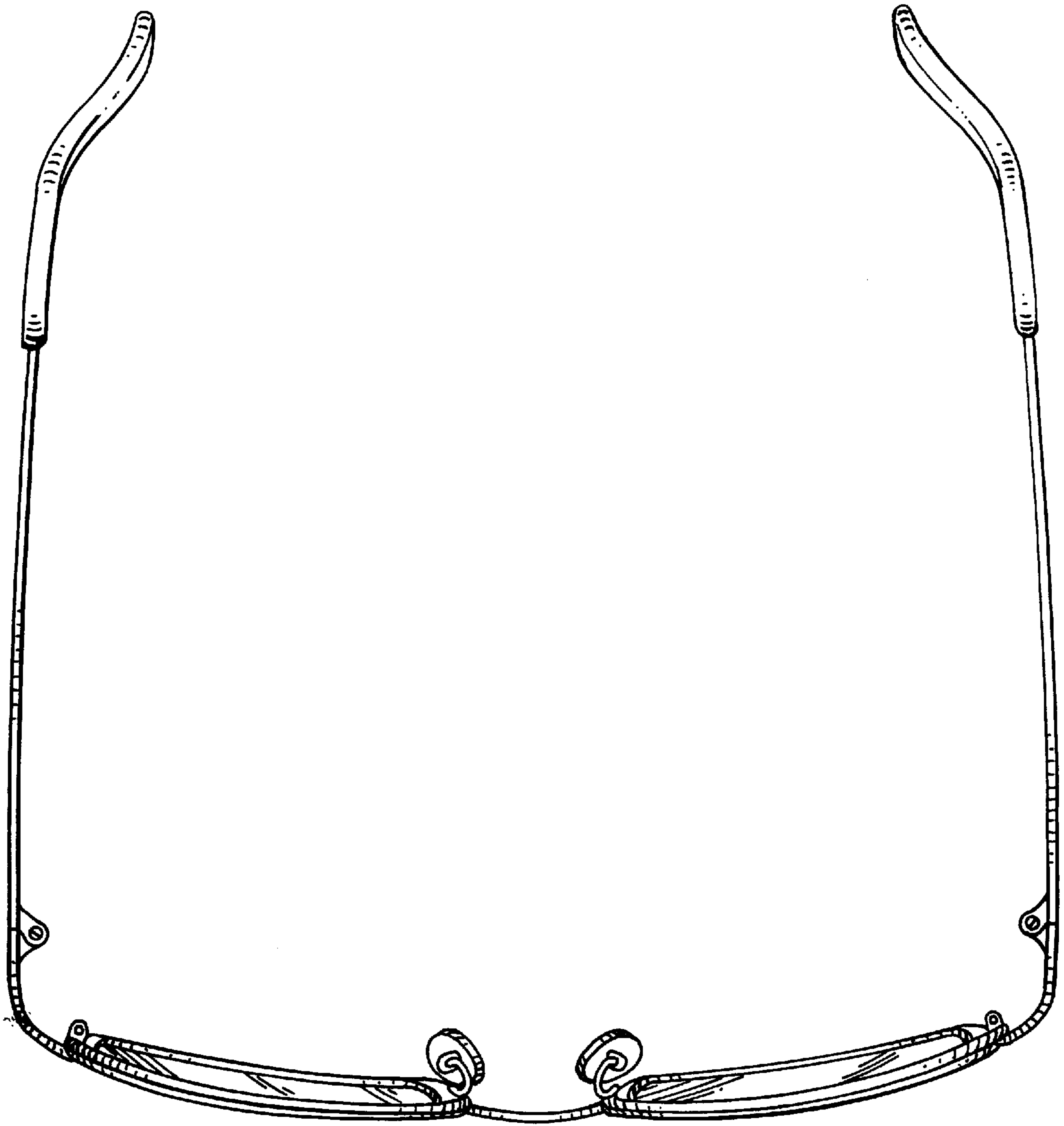

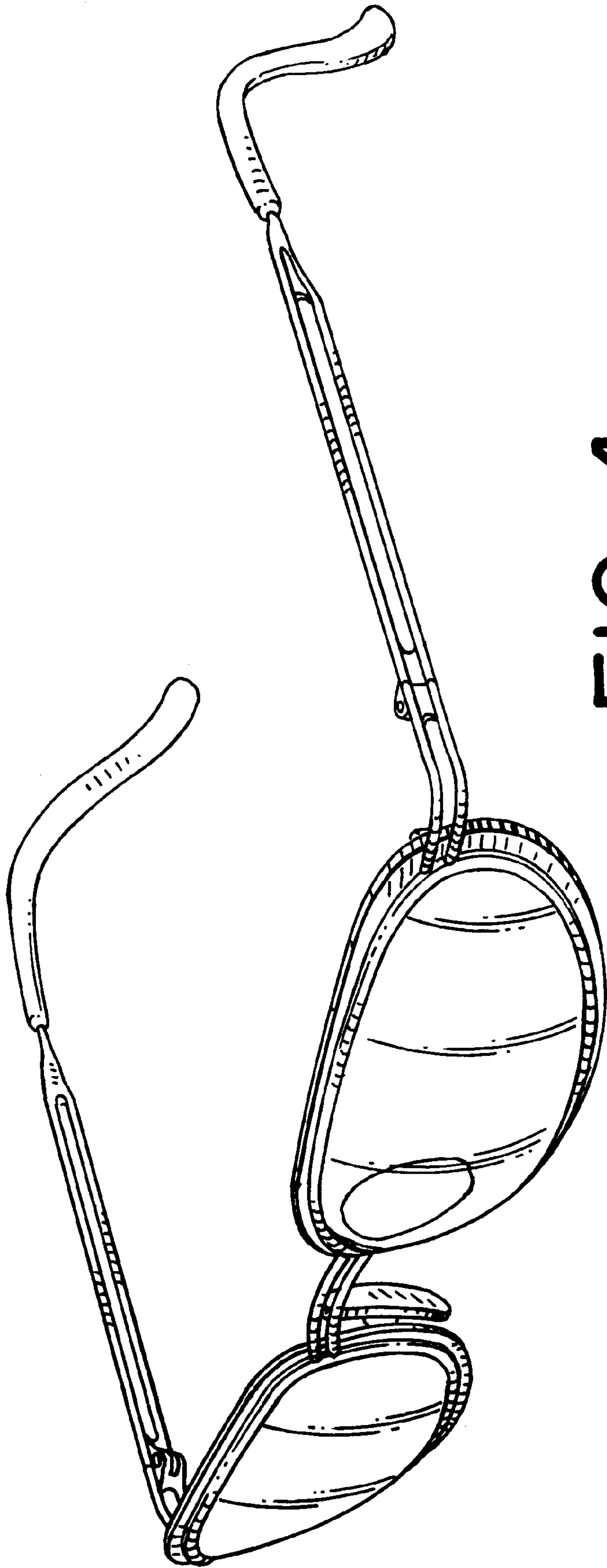
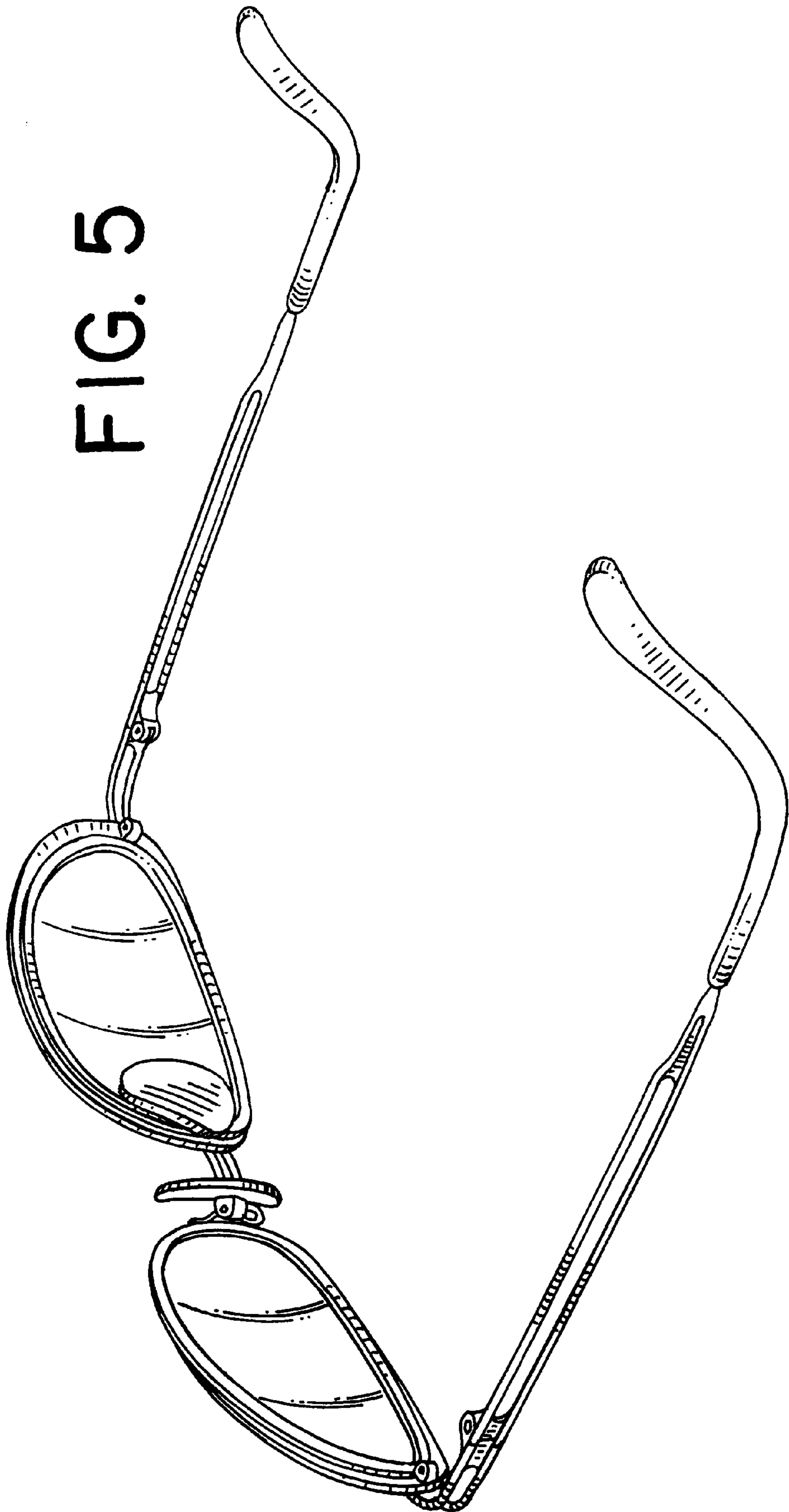

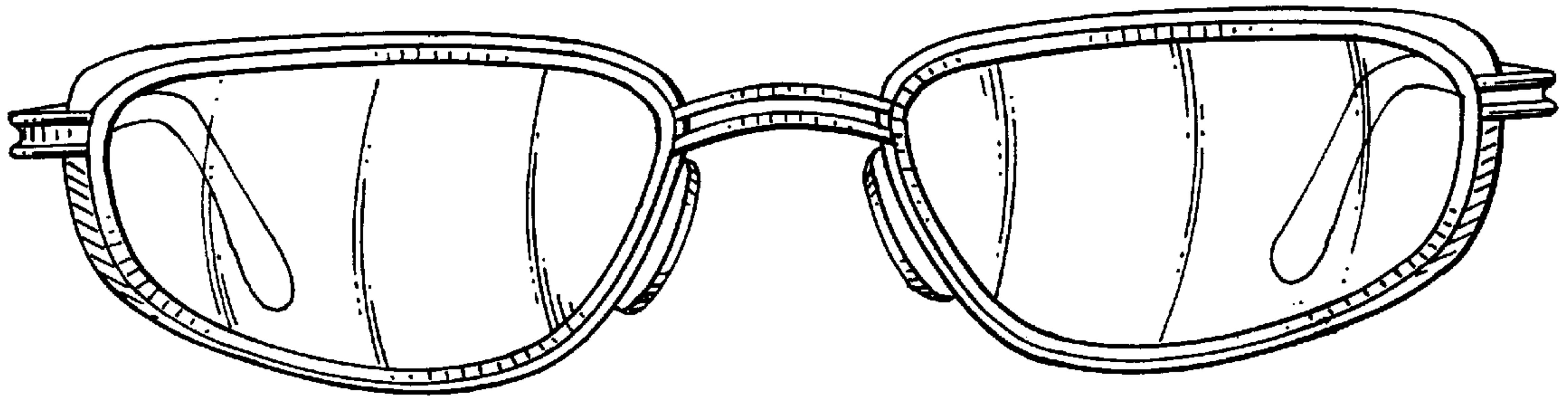

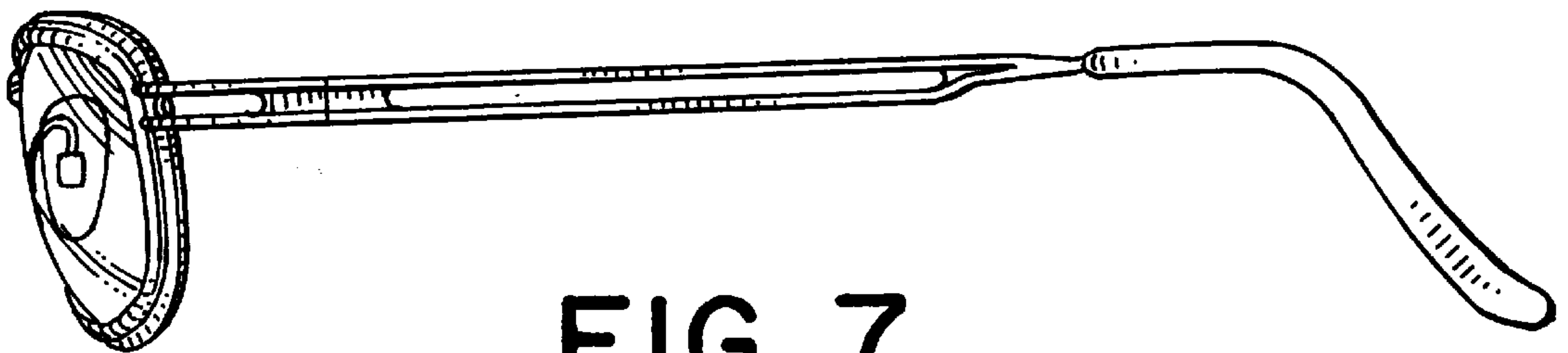

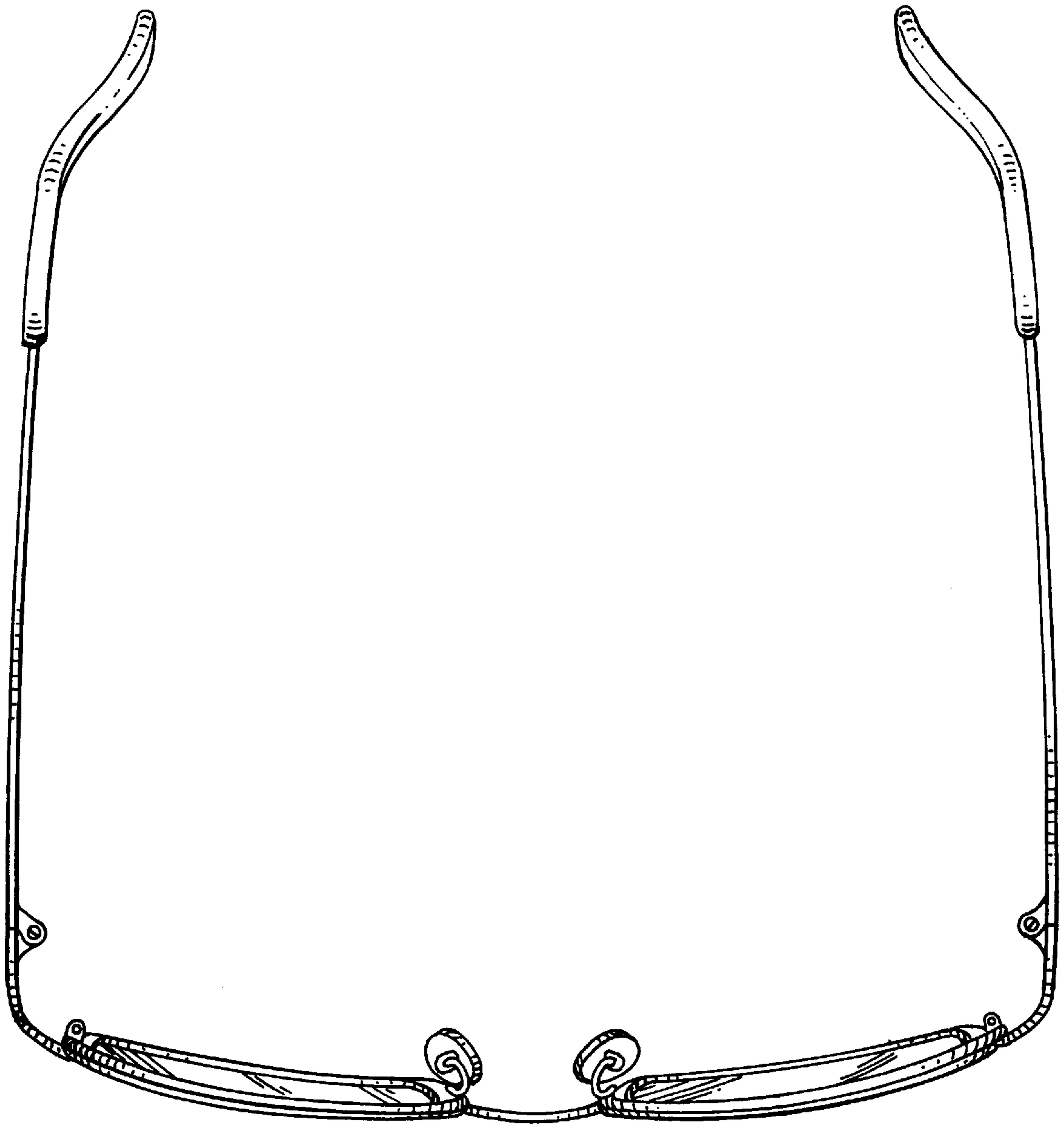

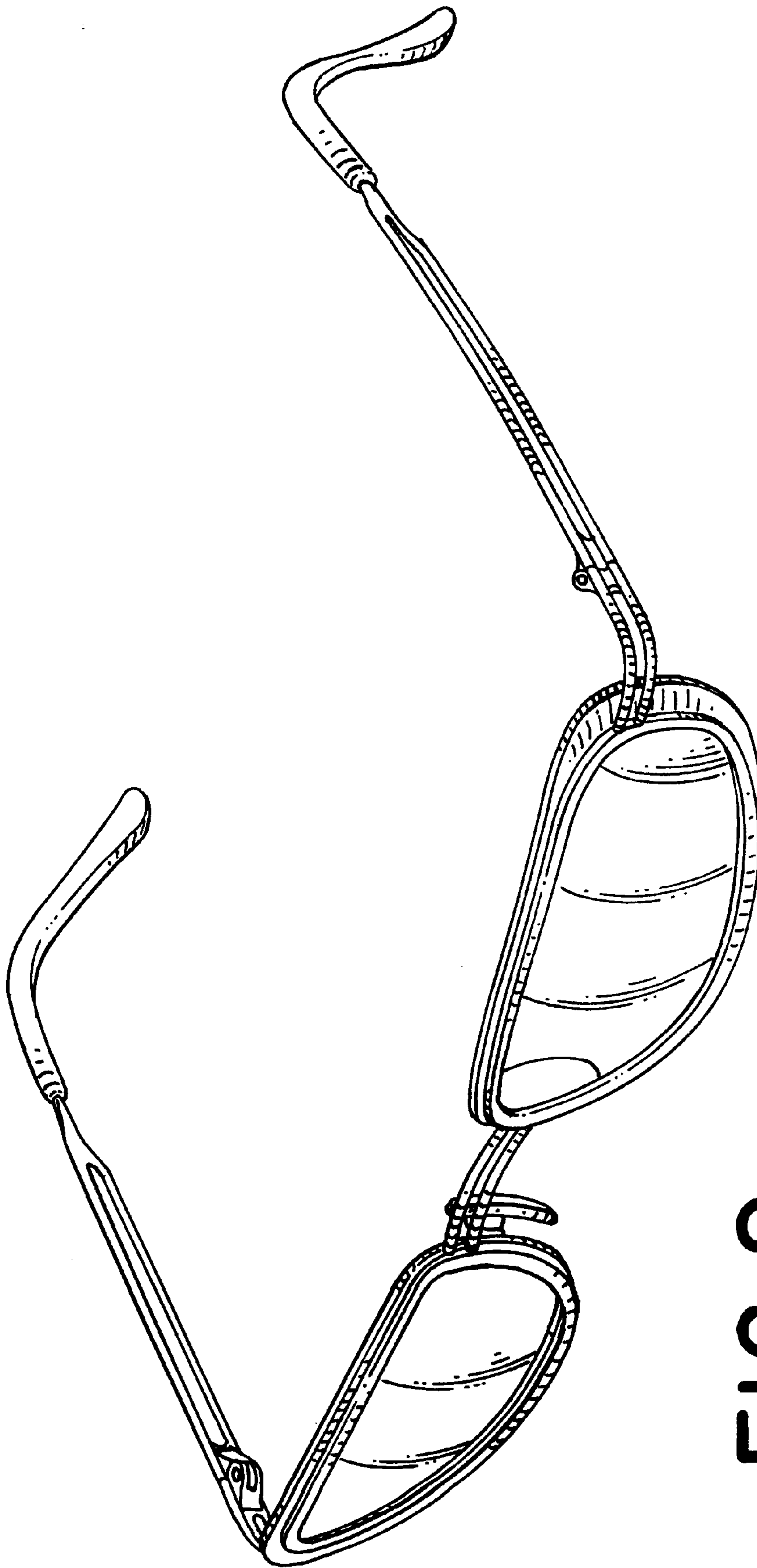

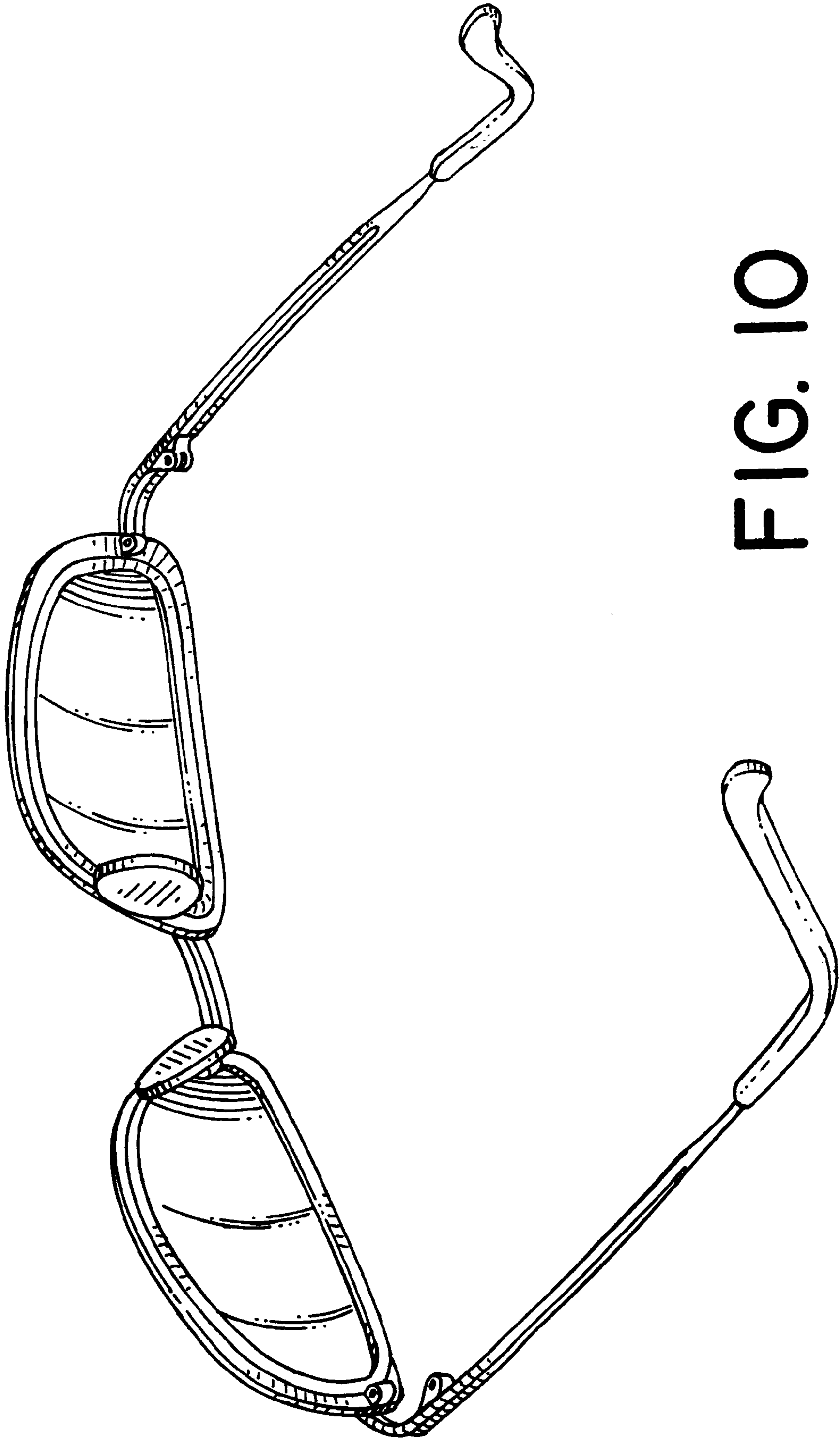
