### [57] CLAIM

The ornamental design for a combined safety razor handle, shaving cream container and cap therefore, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of a combined safety razor handle, shaving cream container and cap therefore showing my new design with the cap portion removed for a complete disclosure of the underlying parts;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 10 is a rear elevational view showing the cap element in place;

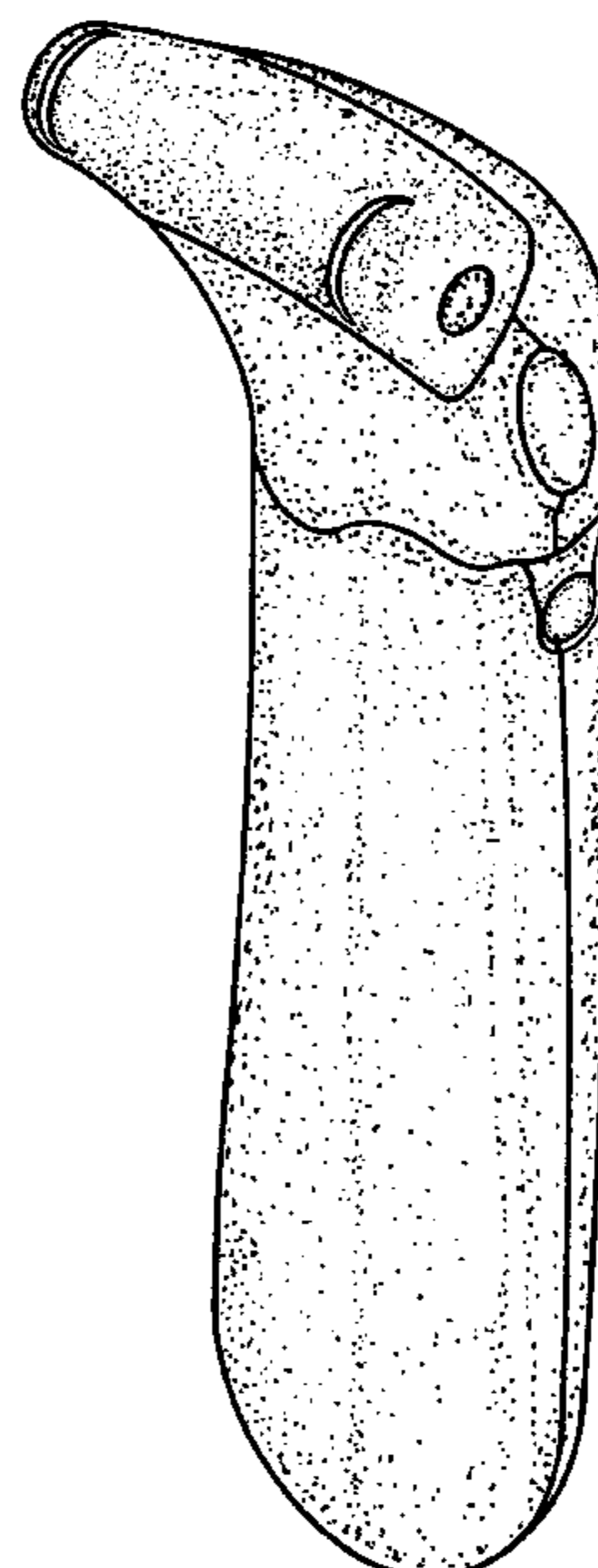
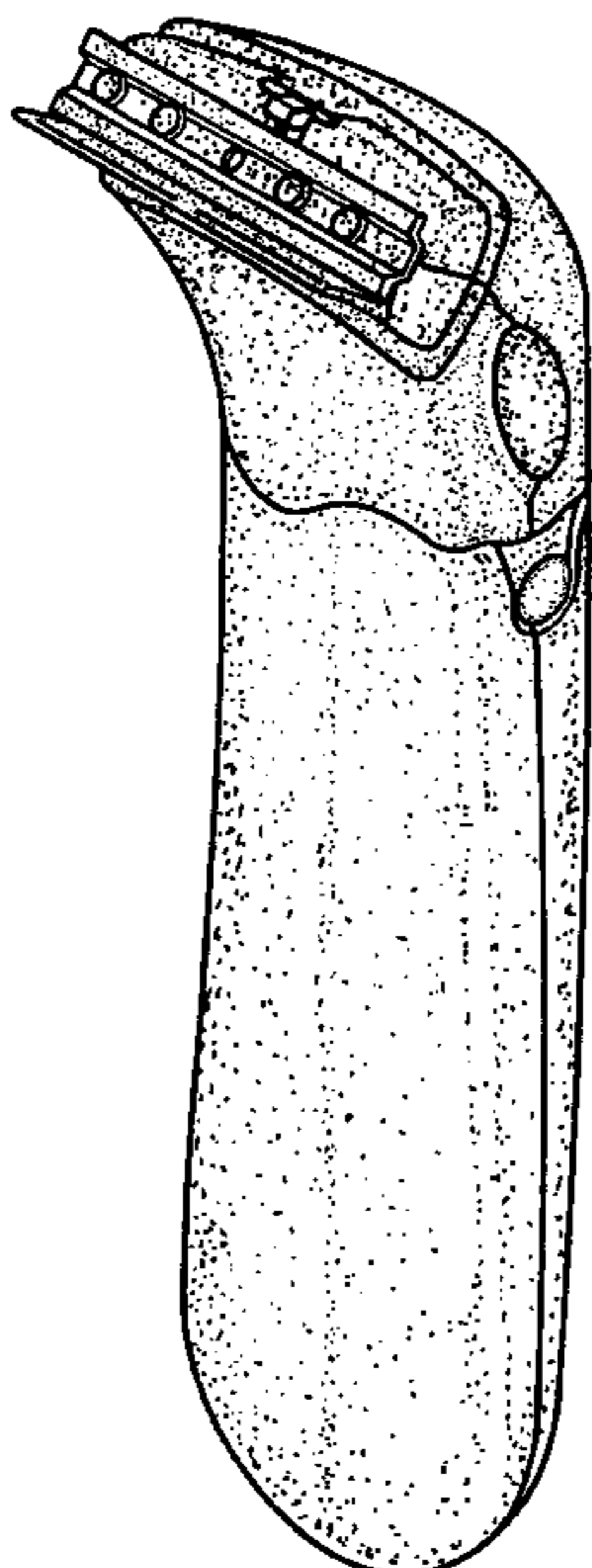
FIG. 11 is a top plan view showing the cap element in place;

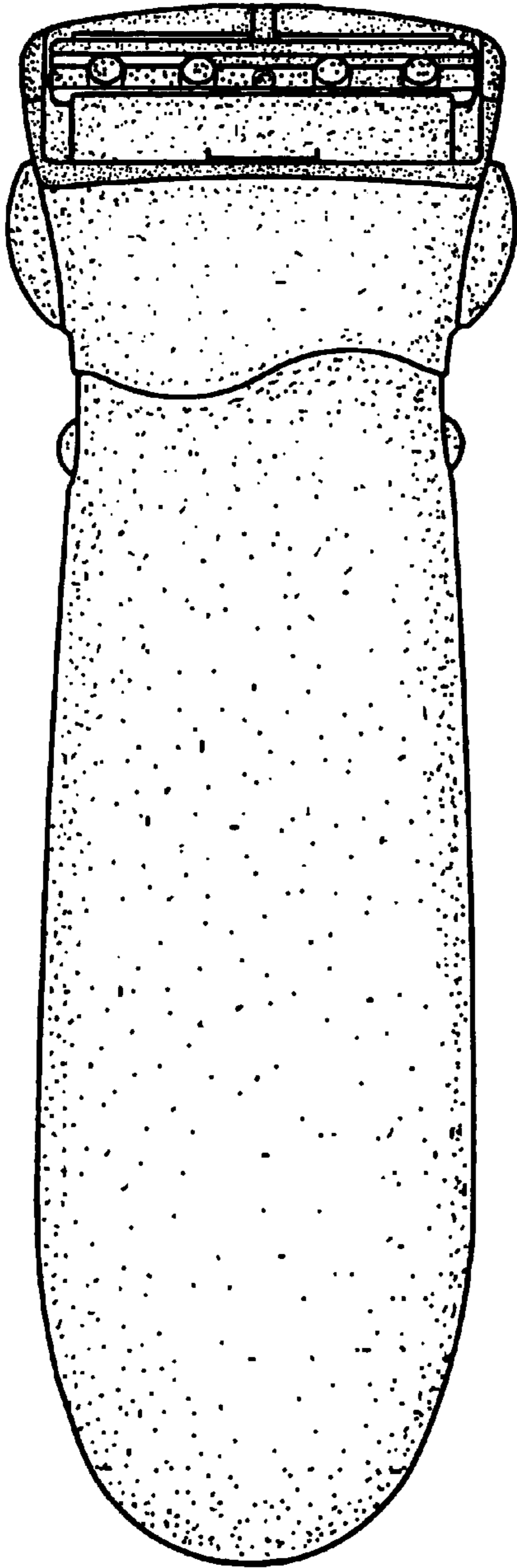
FIG. 12 is a bottom plan view showing the cap element in place;

FIG. 13 is a left side elevational view showing the cap element in place; and,

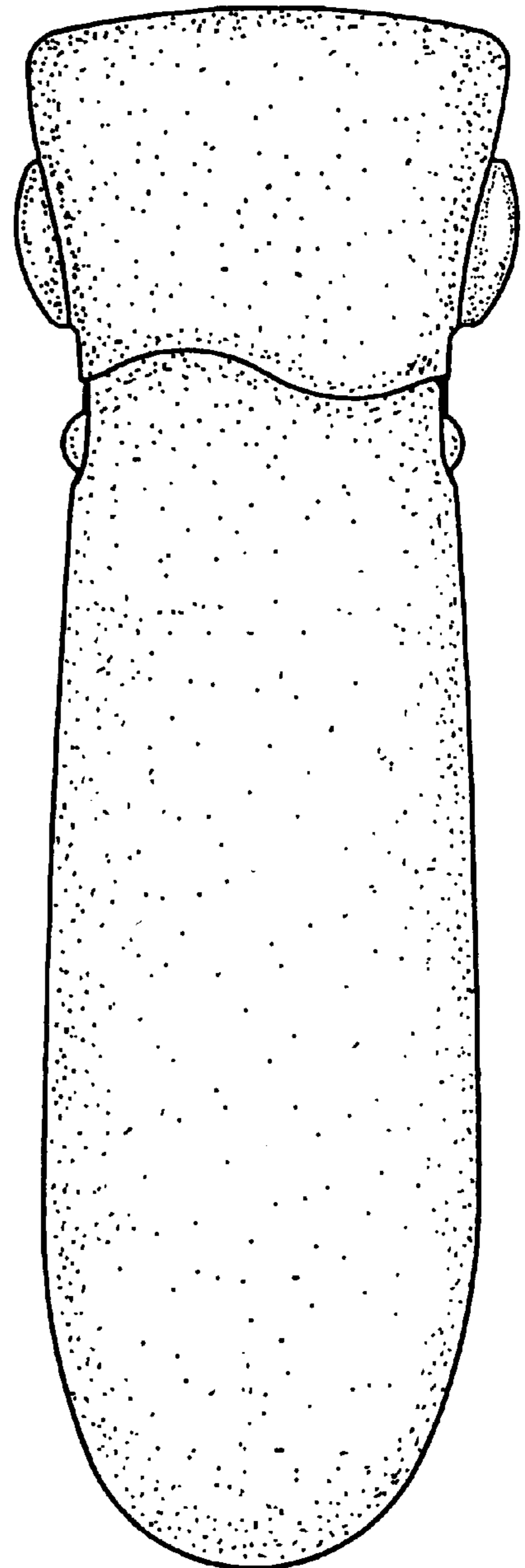
FIG. 14 is a right side elevational view showing the cap element in place.

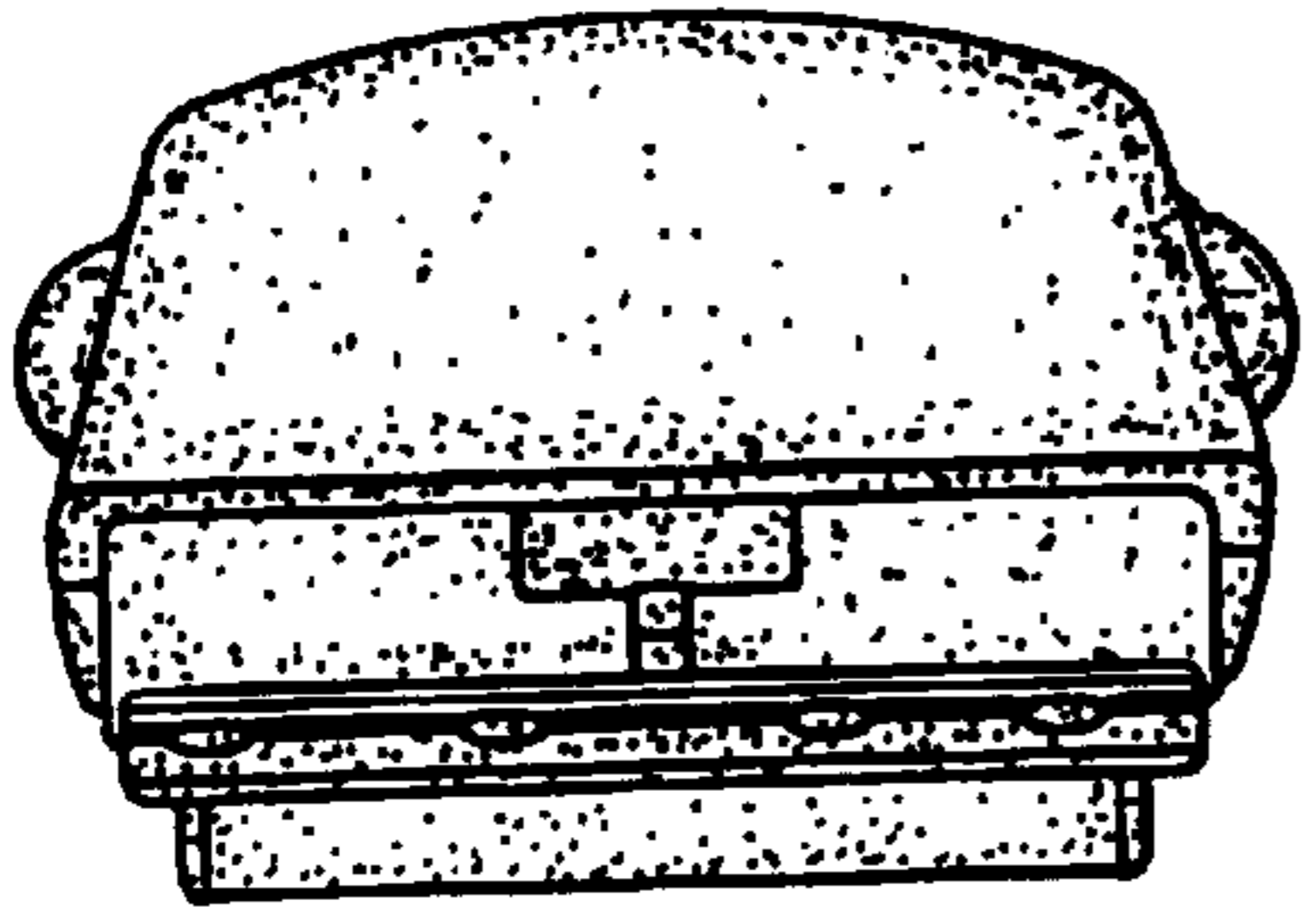




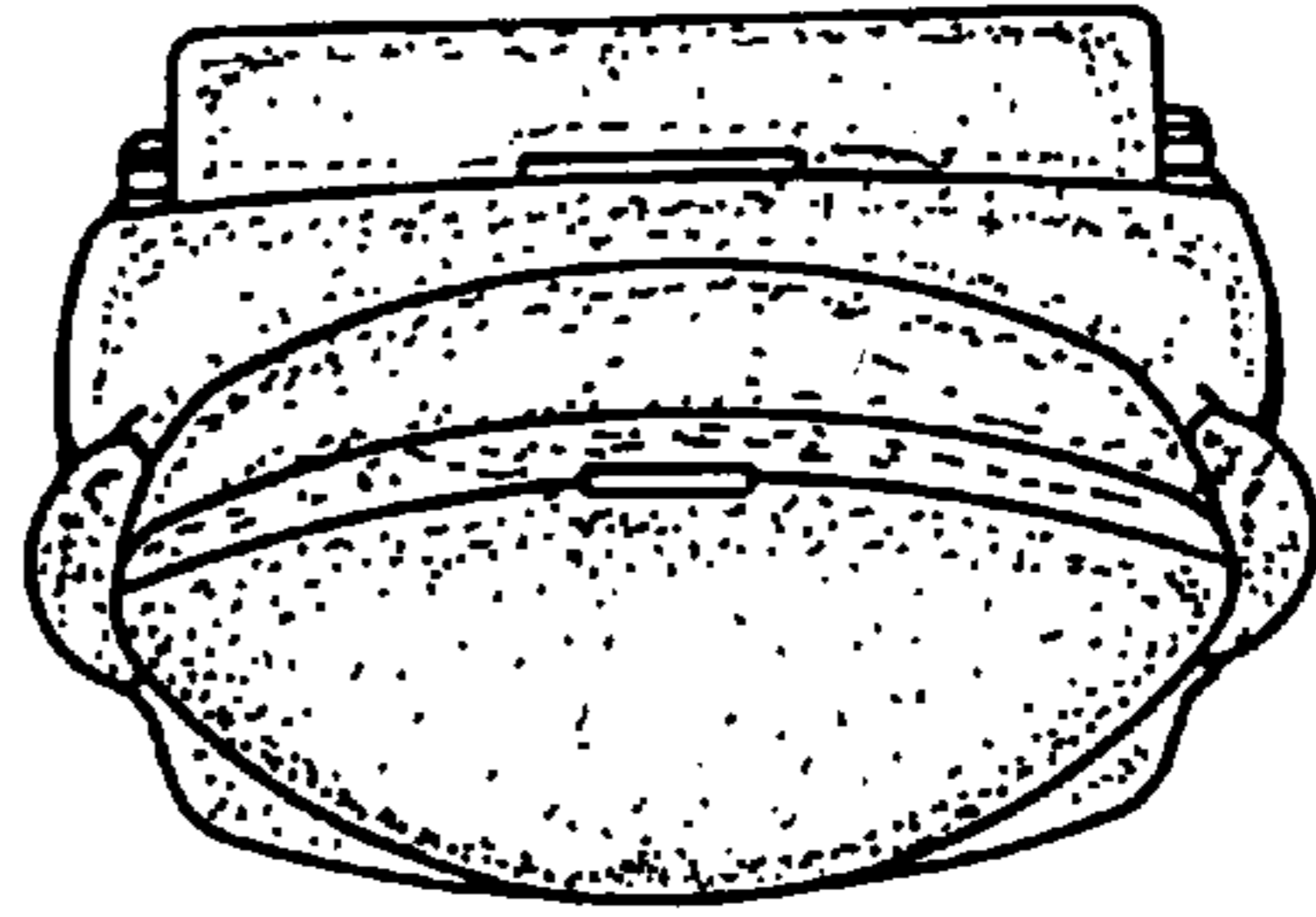

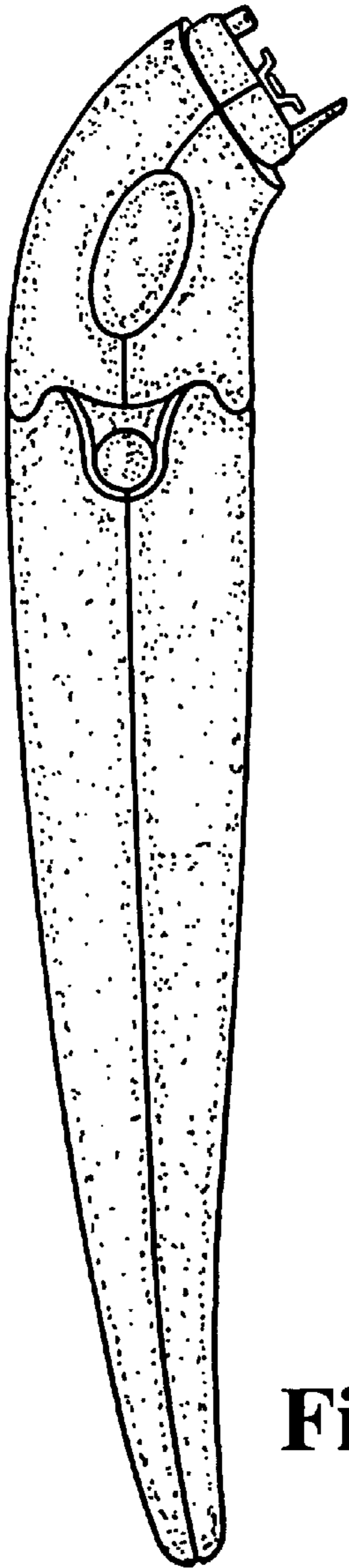

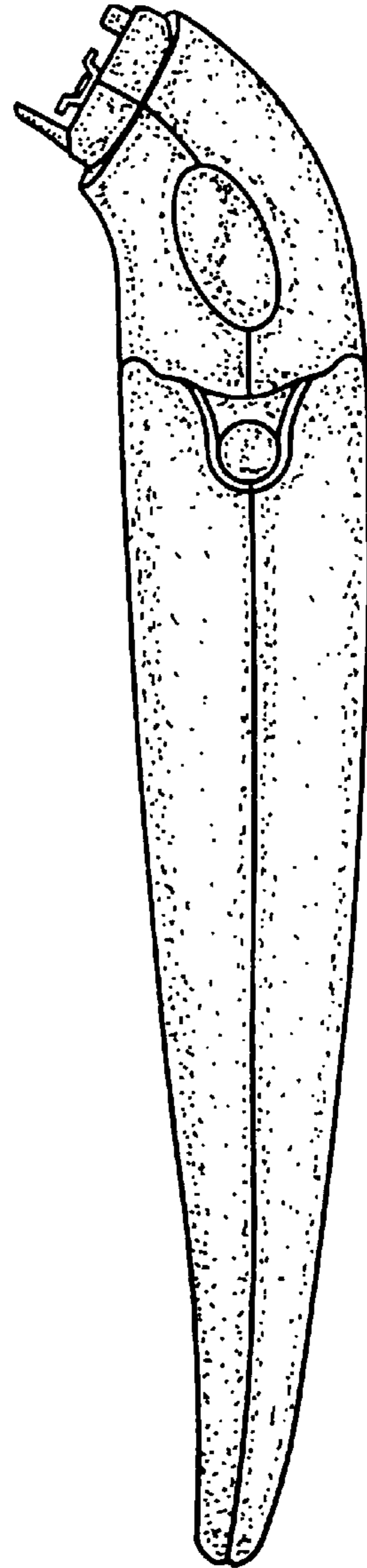

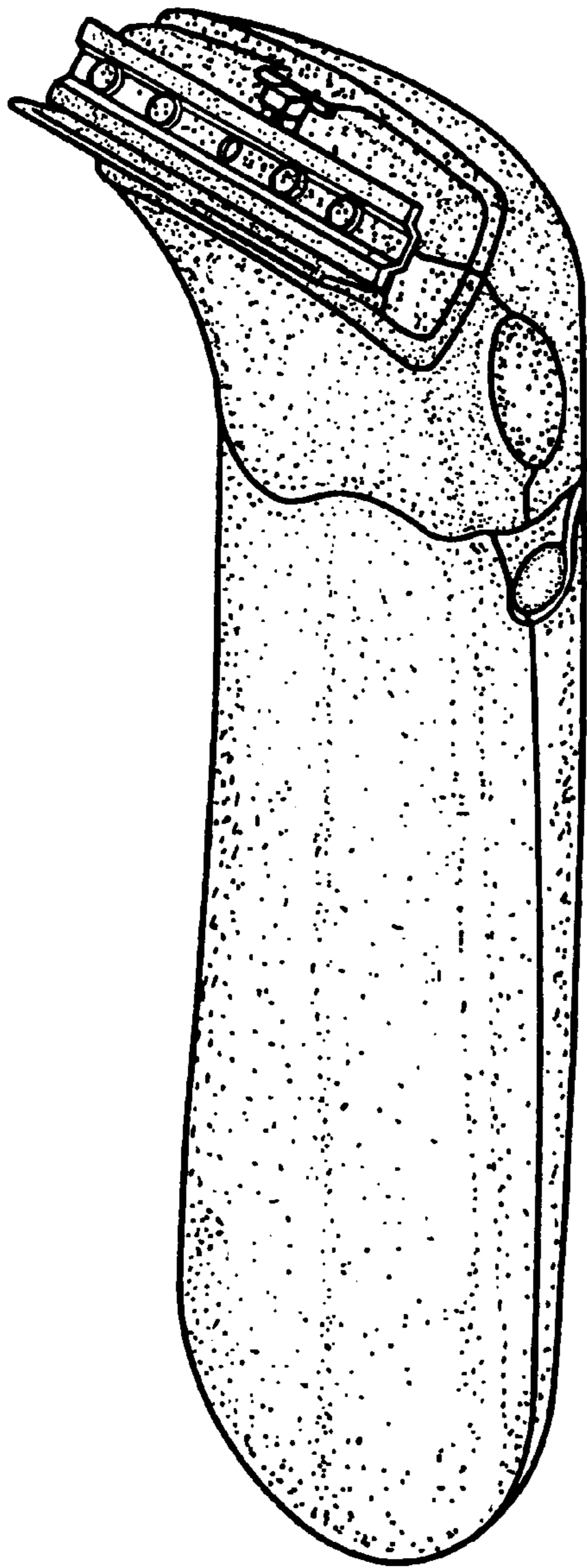

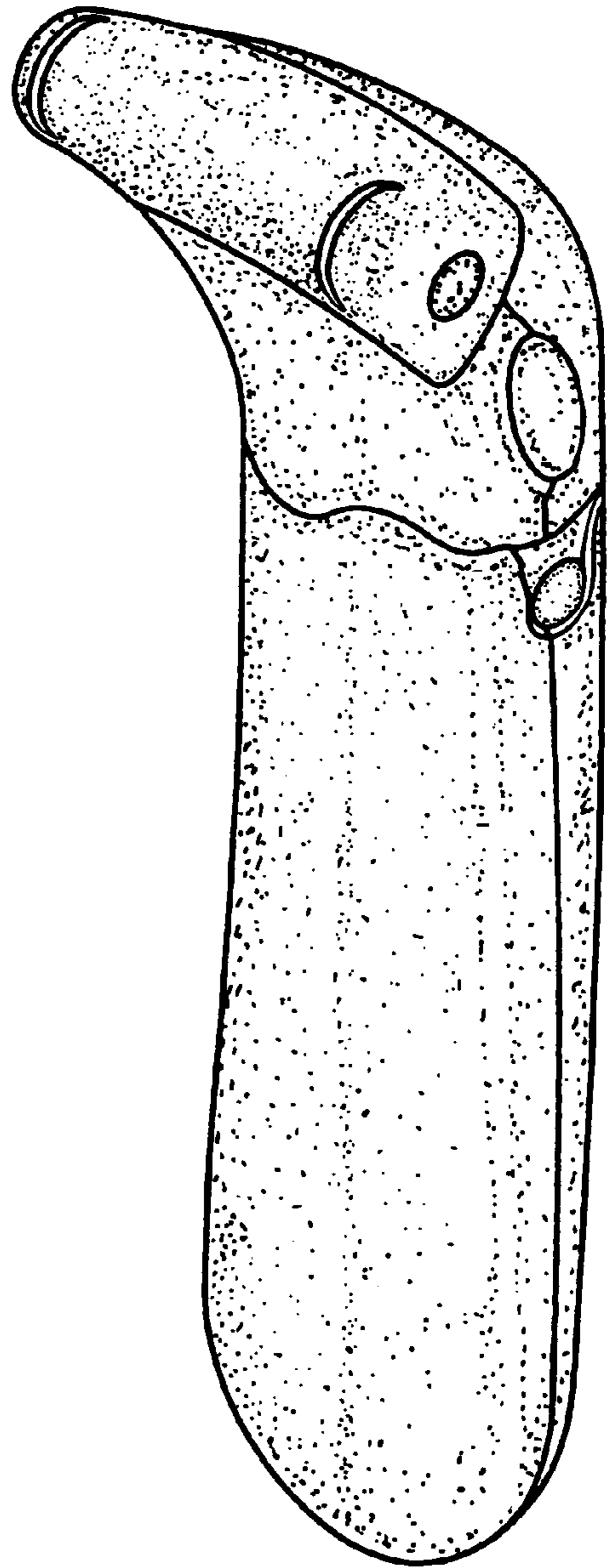

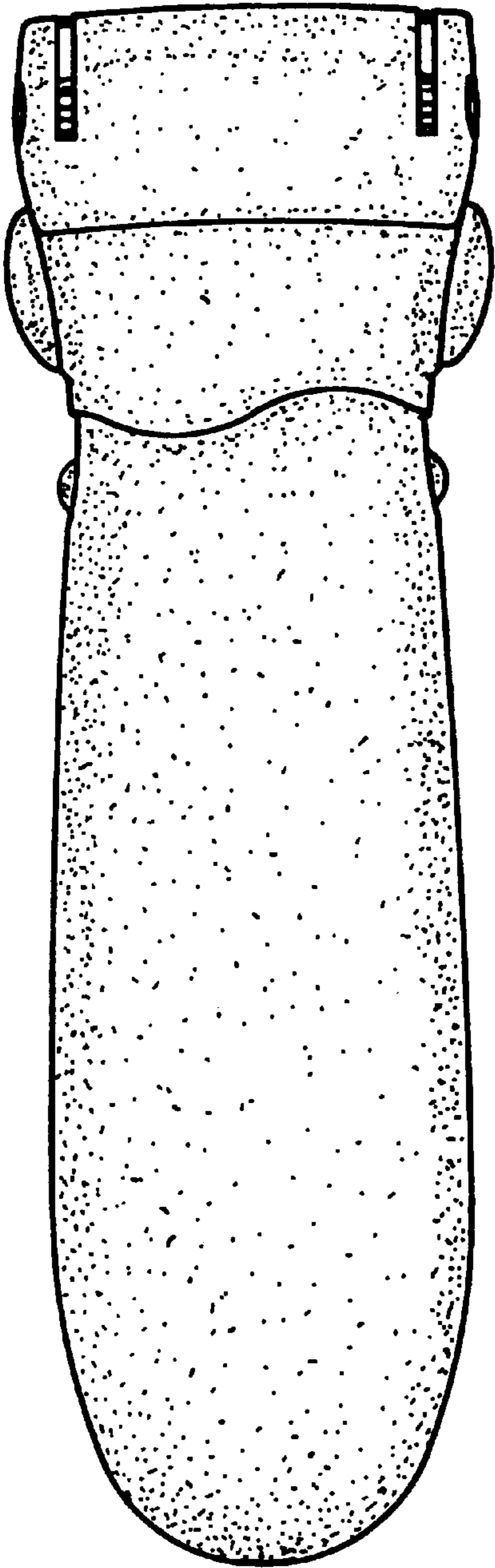

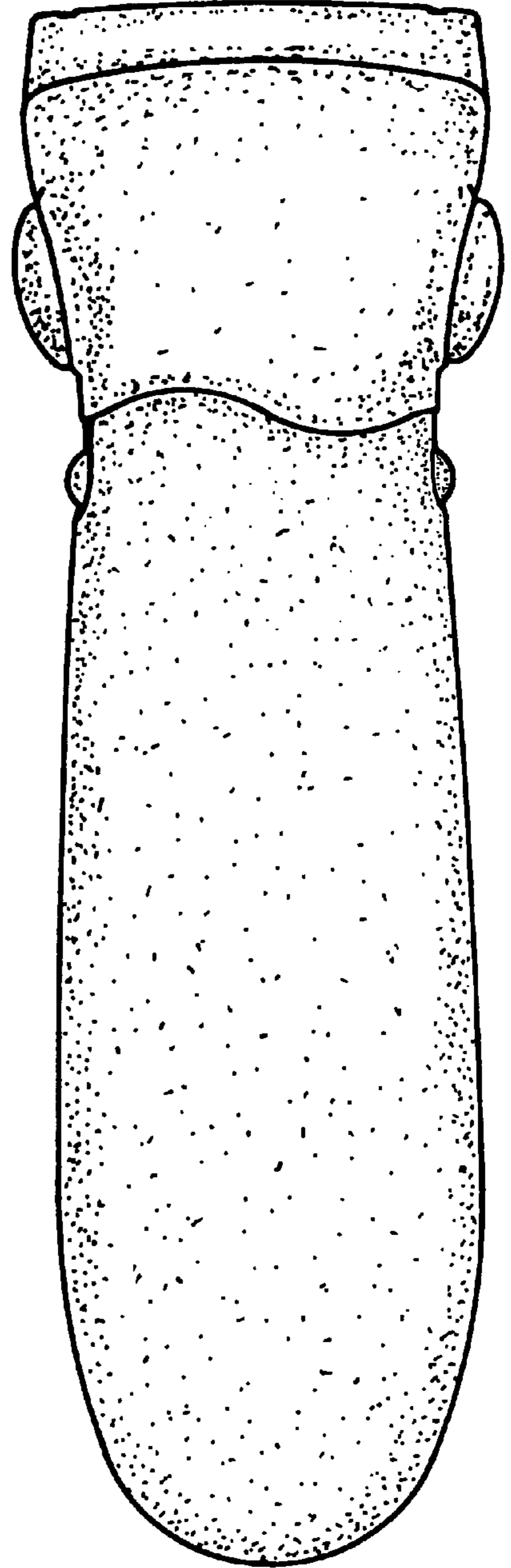

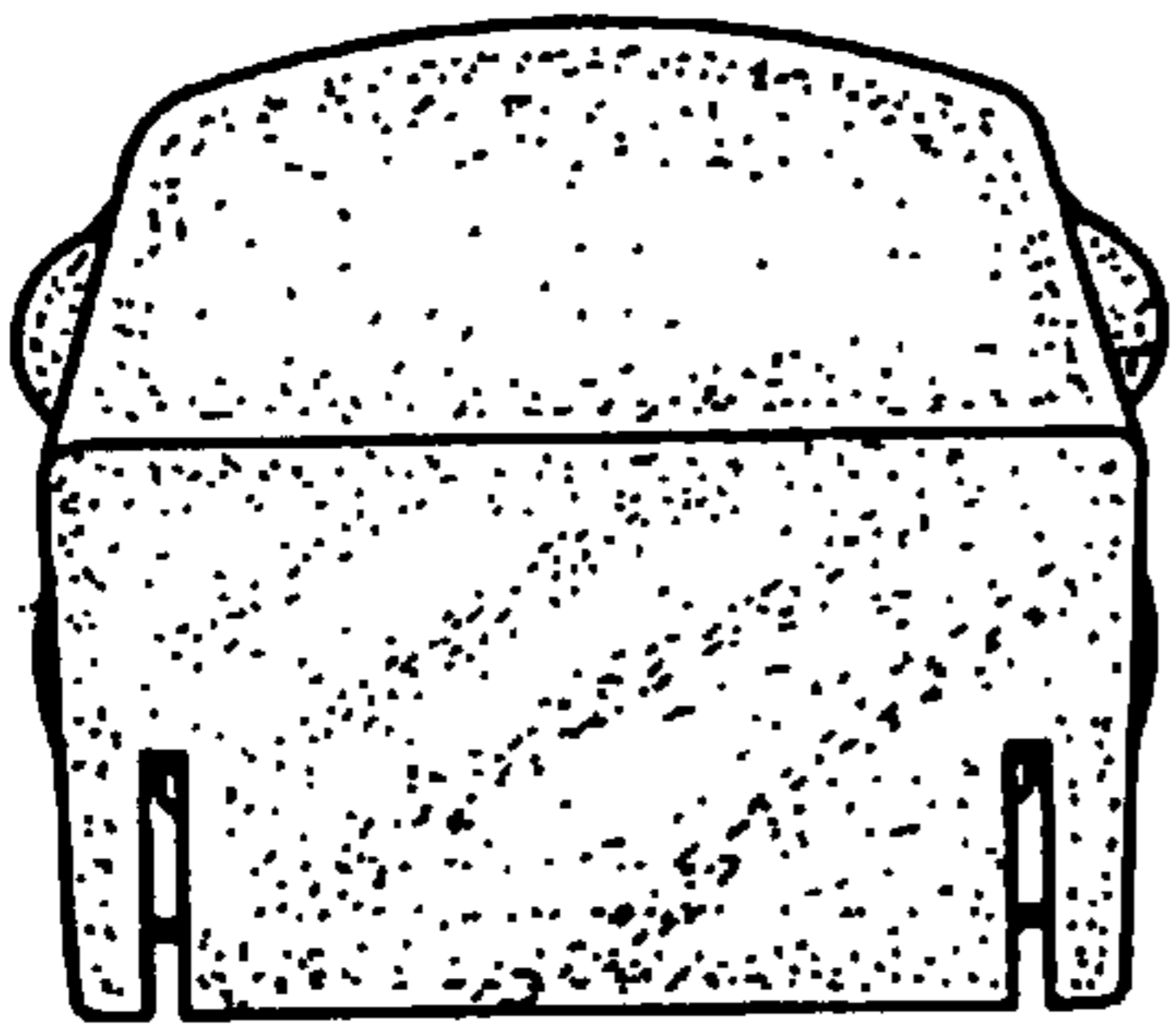

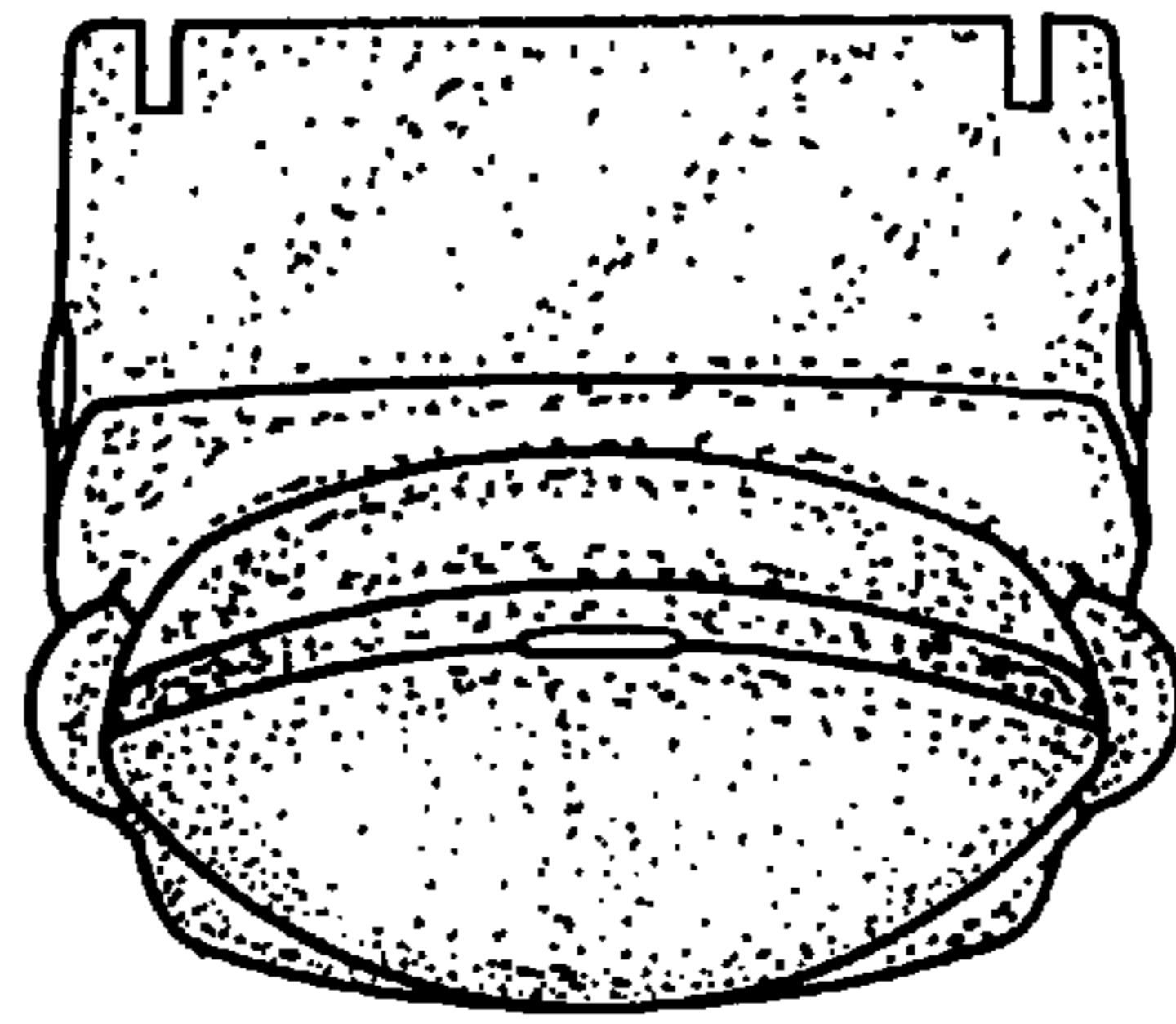

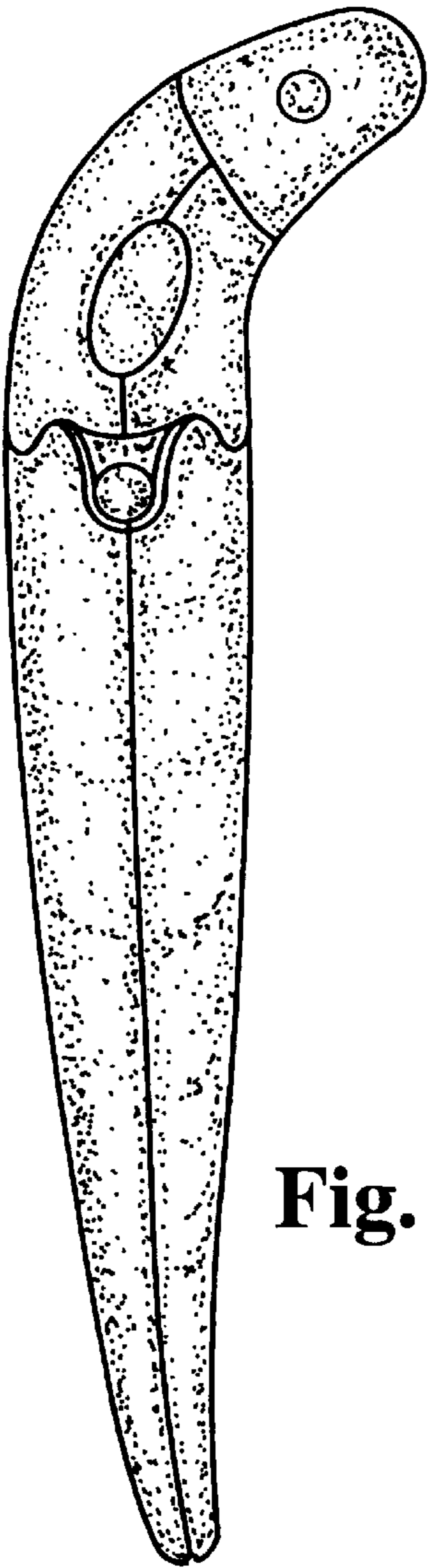

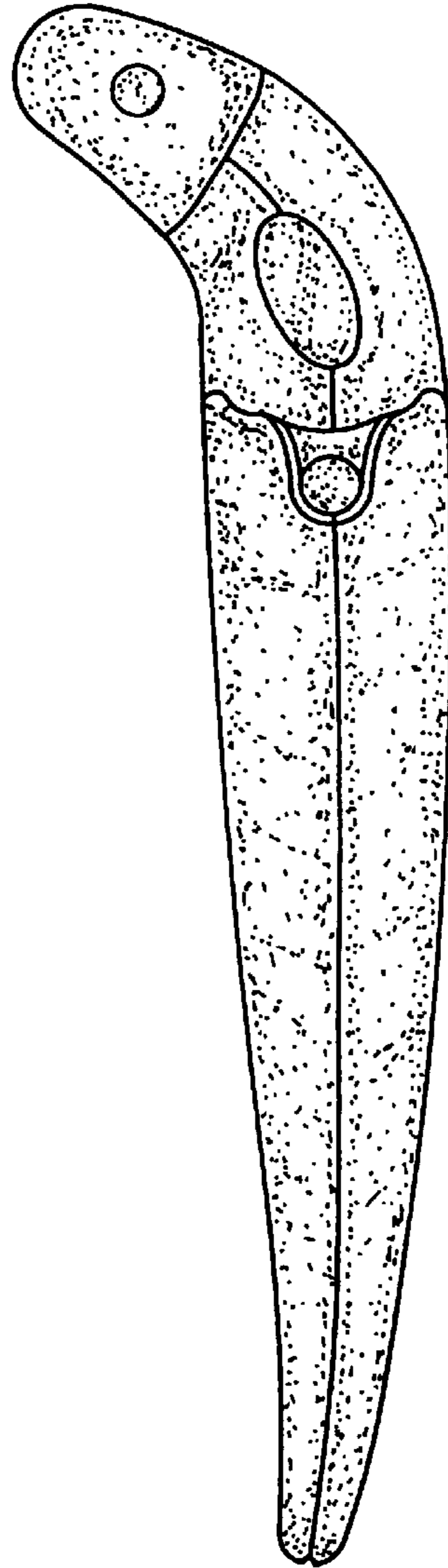
