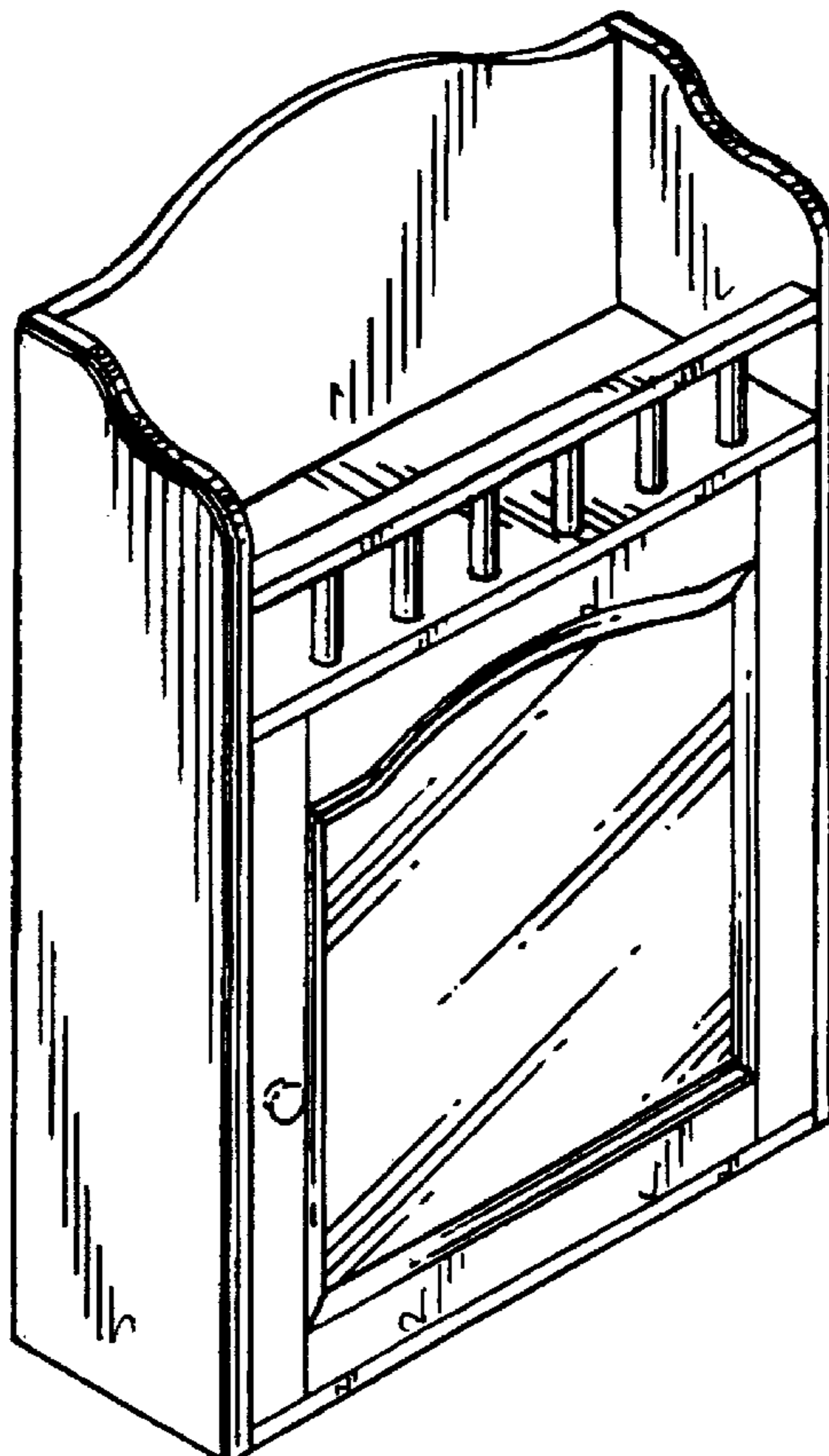
[57] CLAIM

The ornamental design for a bathroom cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the bathroom cabinet.
 FIG. 2 is a left side elevational view of the bathroom cabinet, the right side elevational view being a mirror image of the left side elevational view.
 FIG. 3 is a top plan view of the bathroom cabinet.

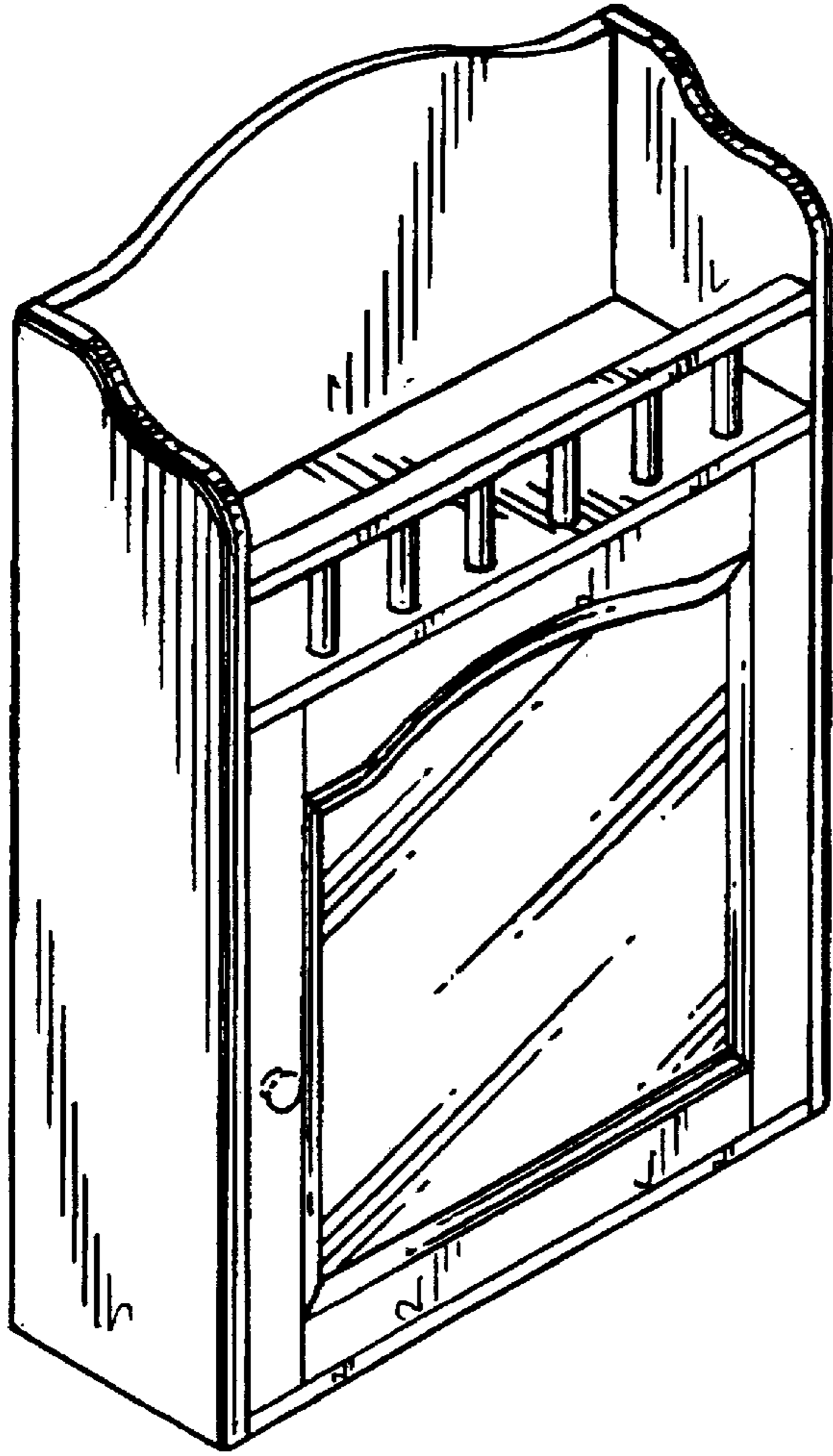

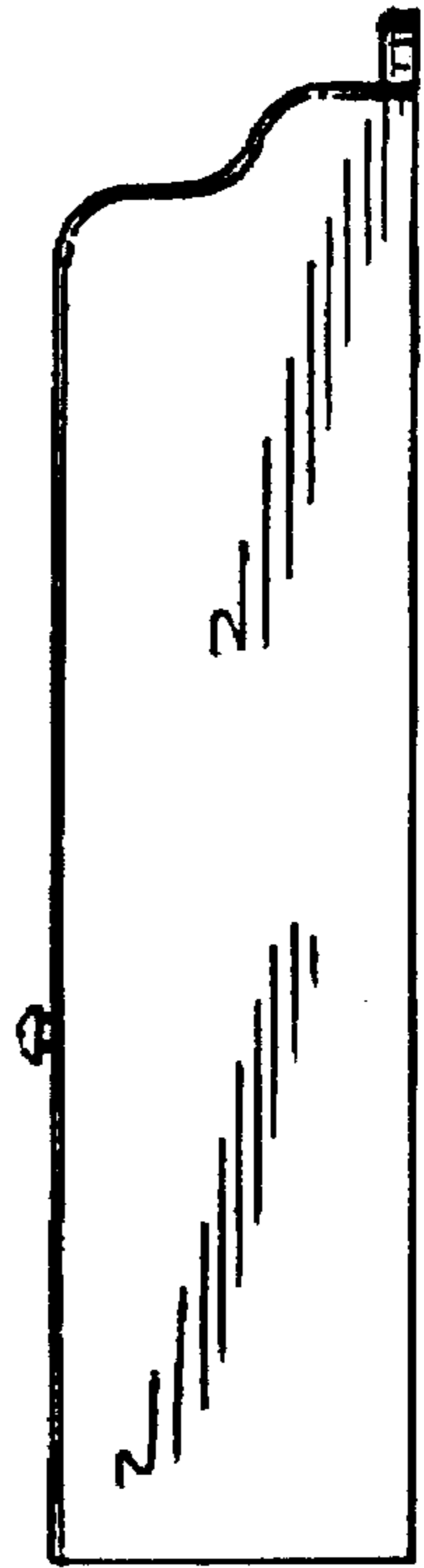
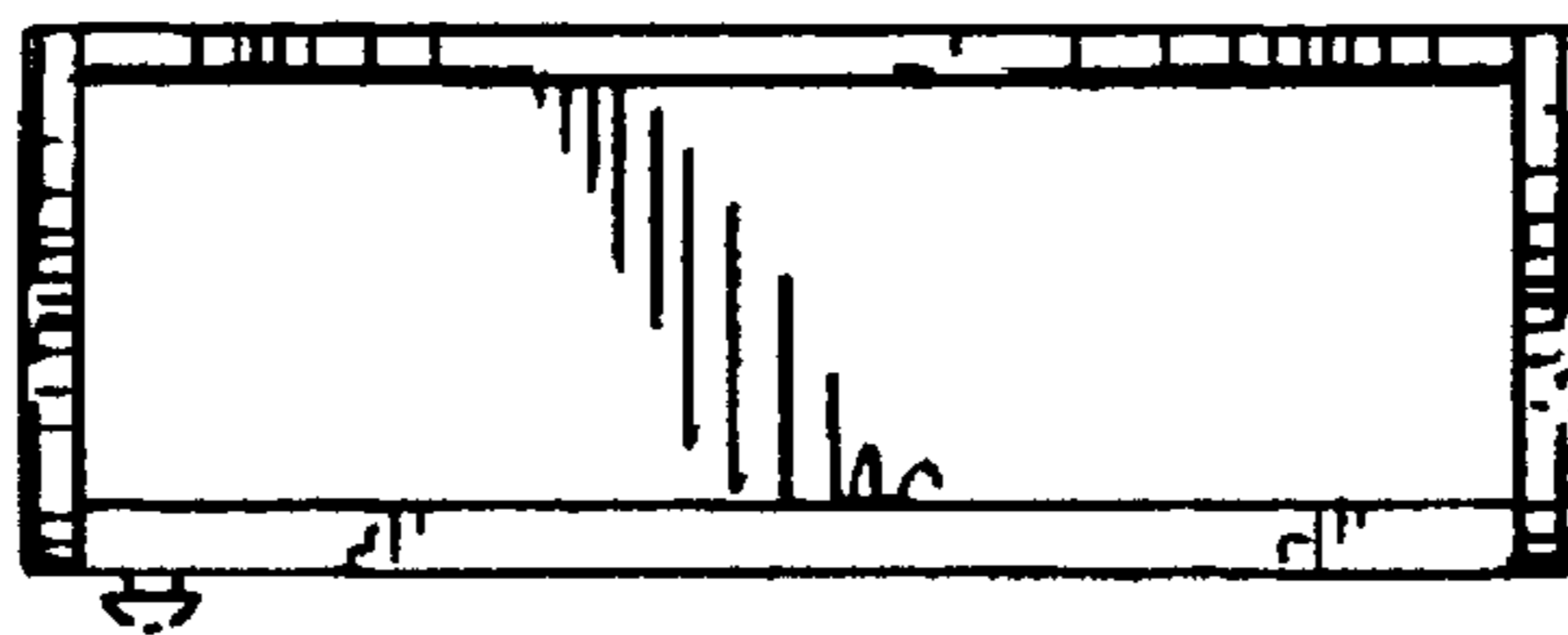

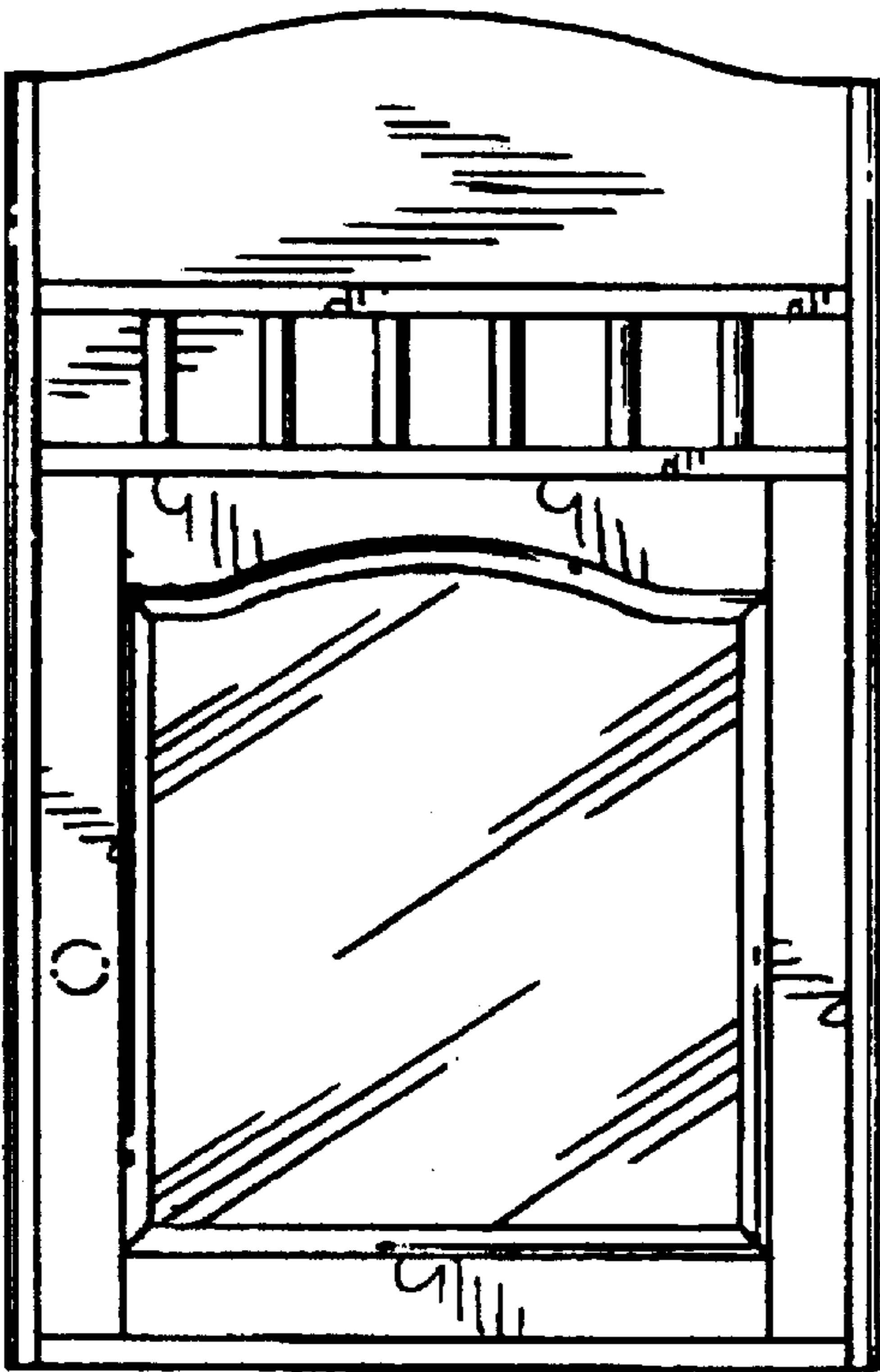

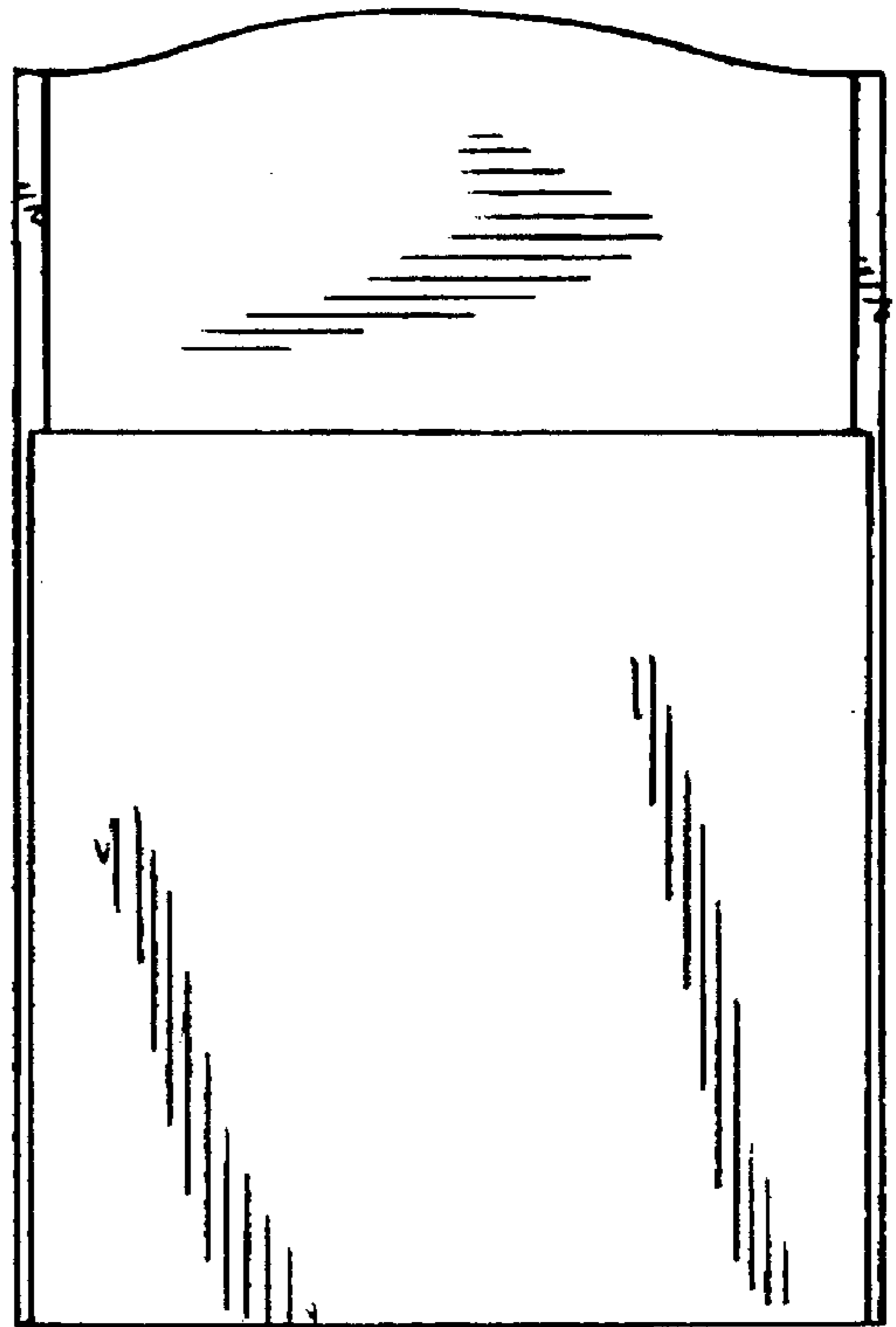
