## [57] **CLAIM**

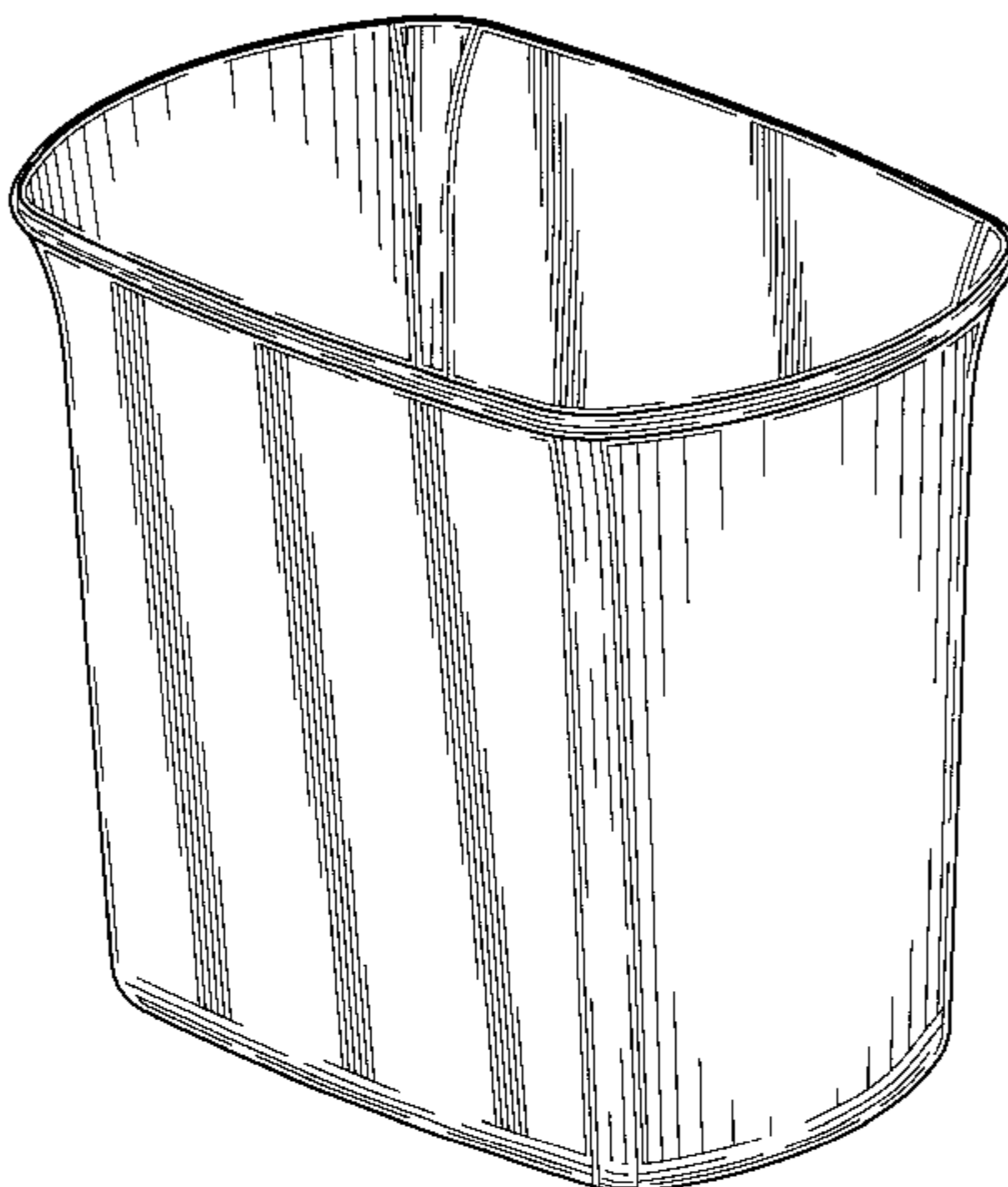
The ornamental design for a canister, as shown and described.

## **DESCRIPTION**

FIG. 1 is a top right front perspective view of a canister showing our new design;  
FIG. 2 is a left side elevational view thereof; the right side elevational view being a mirror image;  
FIG. 3 is a front elevational view thereof; the rear elevational view being a mirror image;  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a bottom plan view thereof.

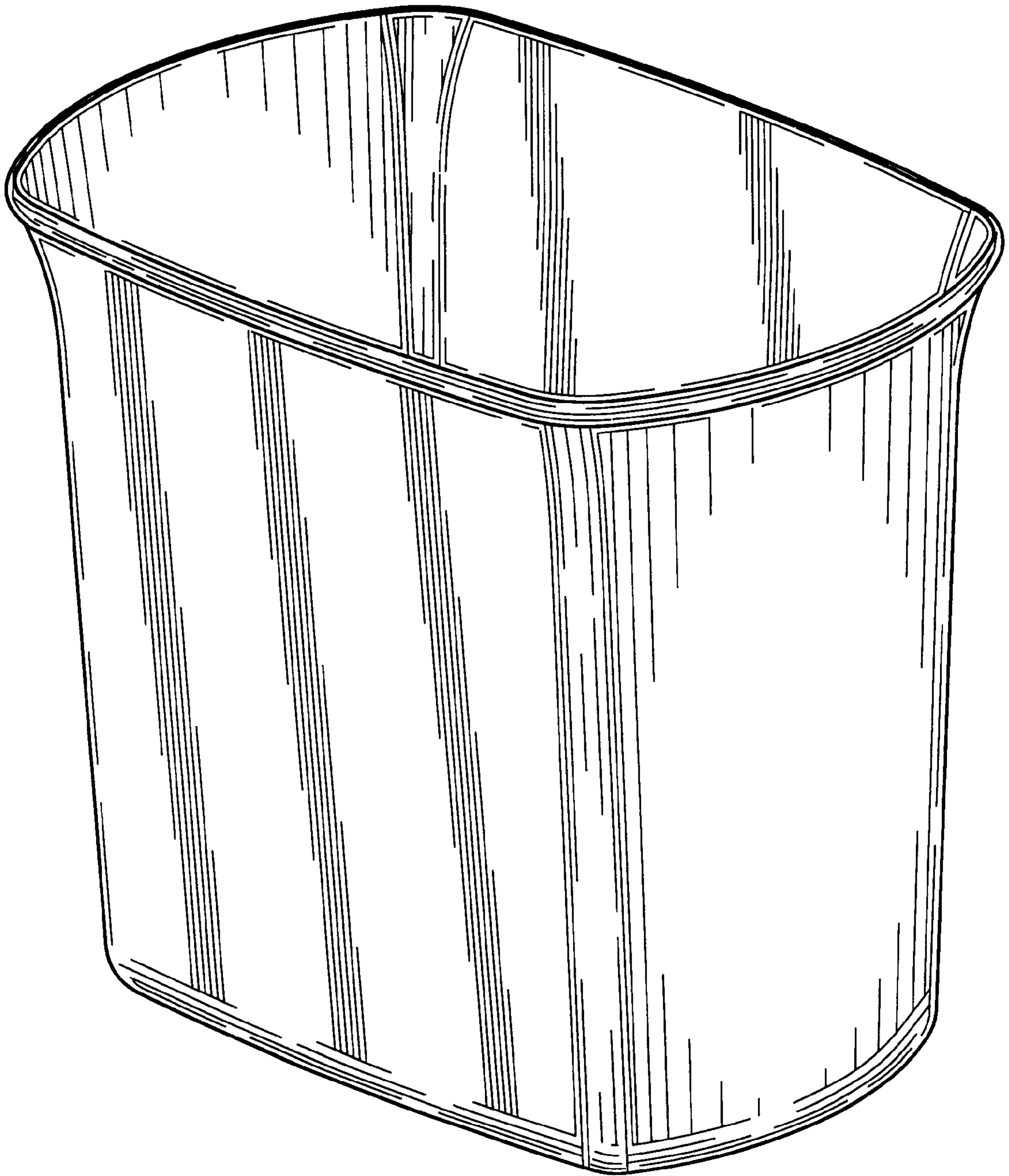

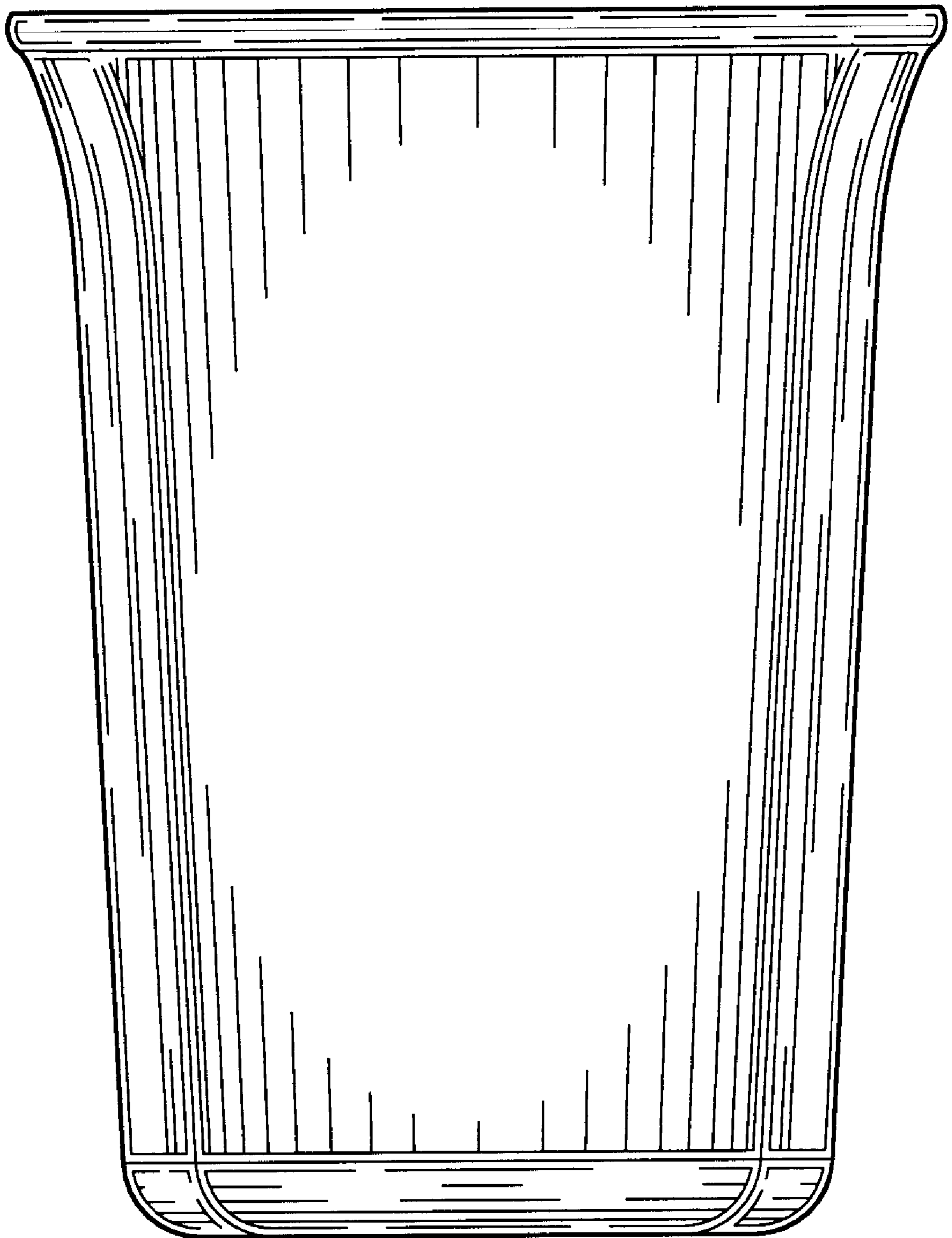

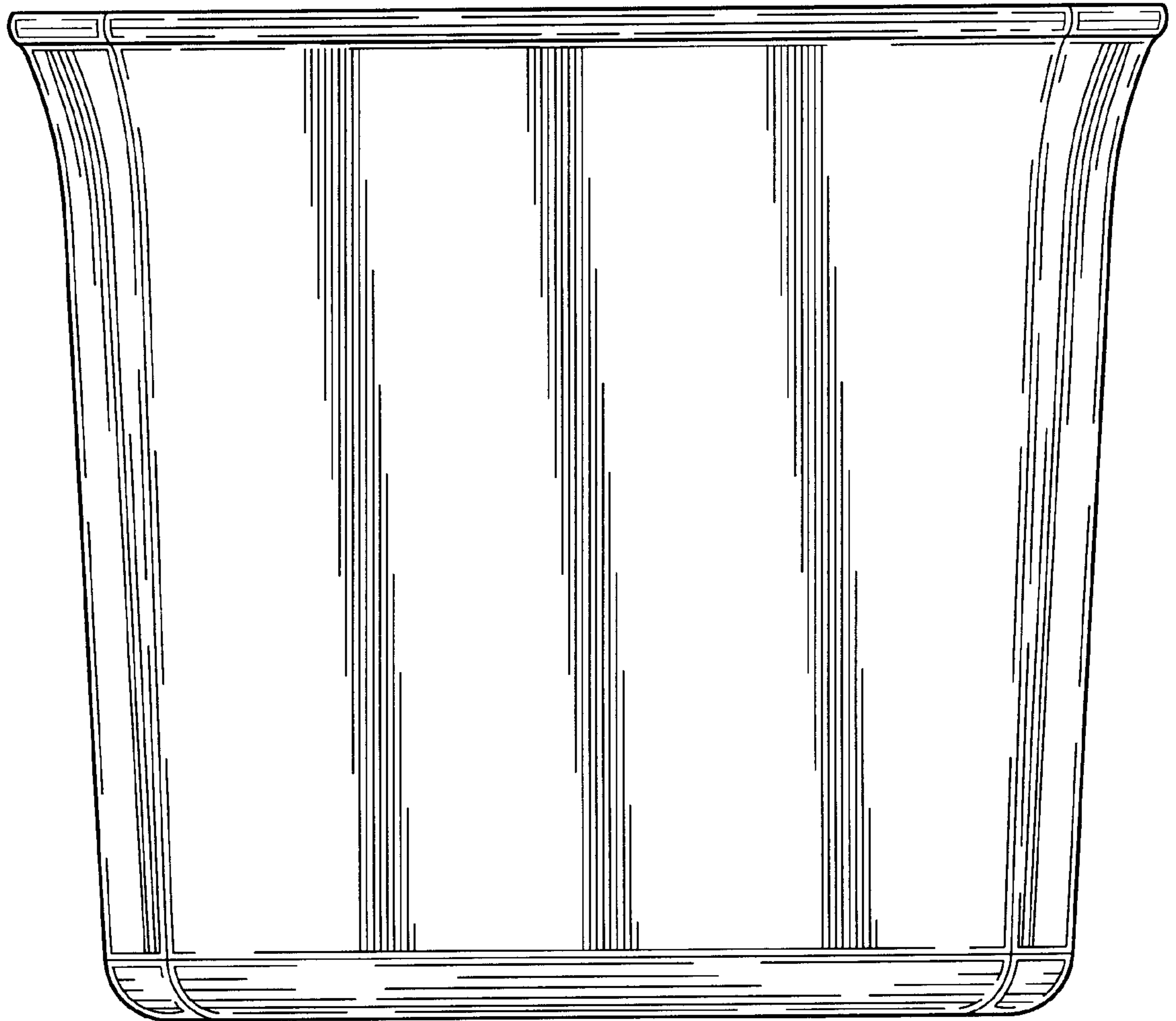

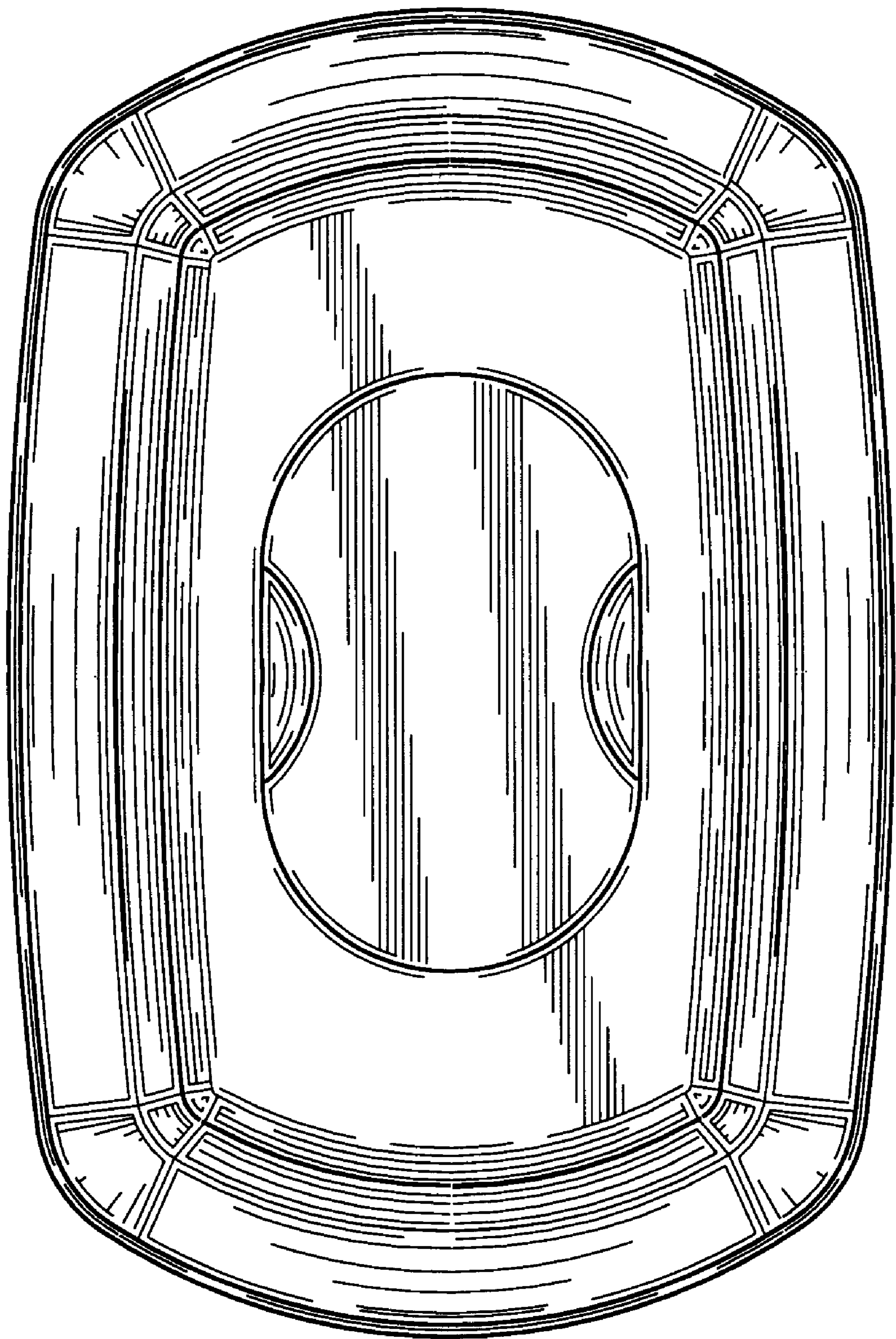

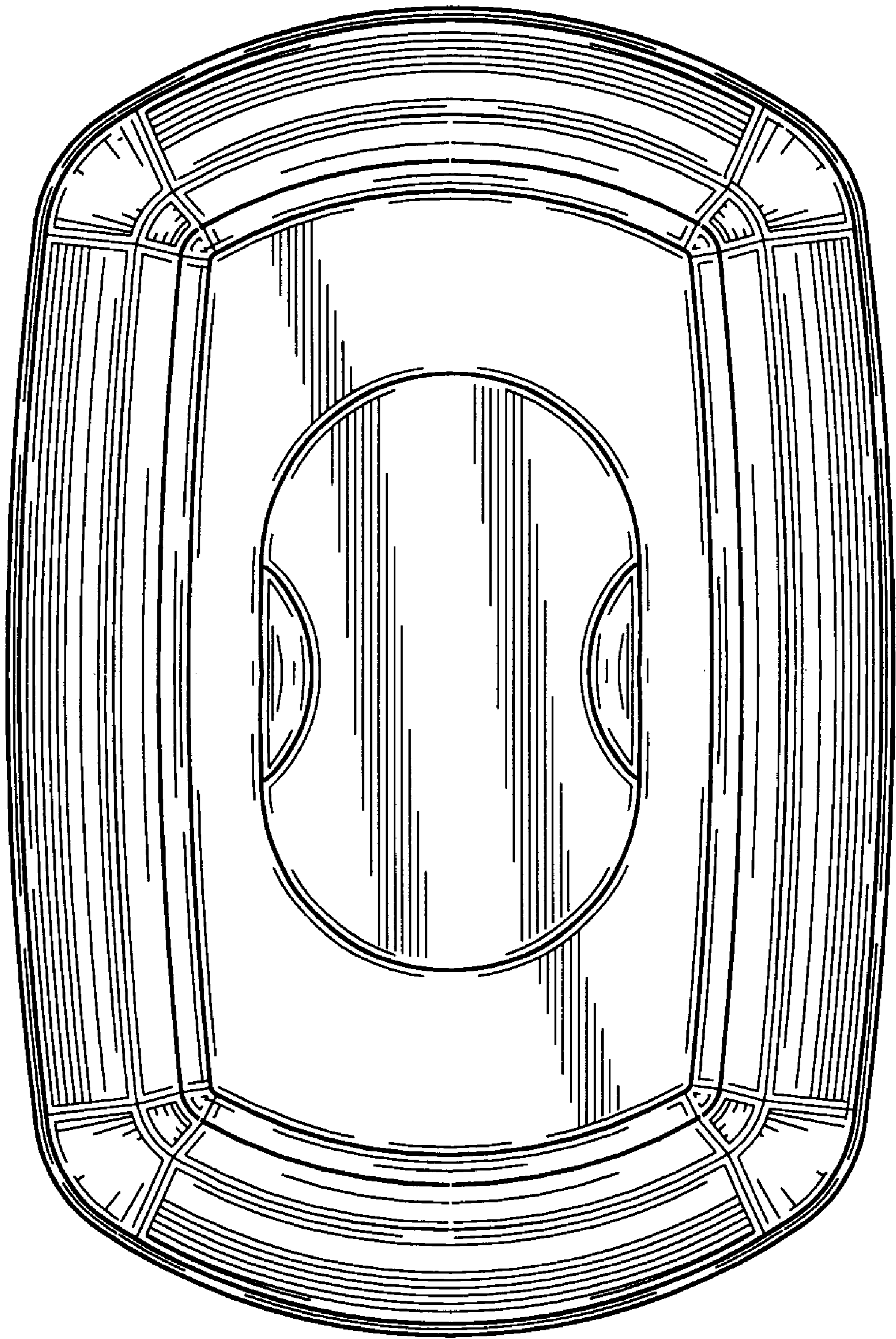
