[57] CLAIM

We claim the ornamental design for a set of icons for a display screen, as shown and described.

DESCRIPTION

FIG. 1 is a face of a set of icons for a display screen, on a reduced scale;

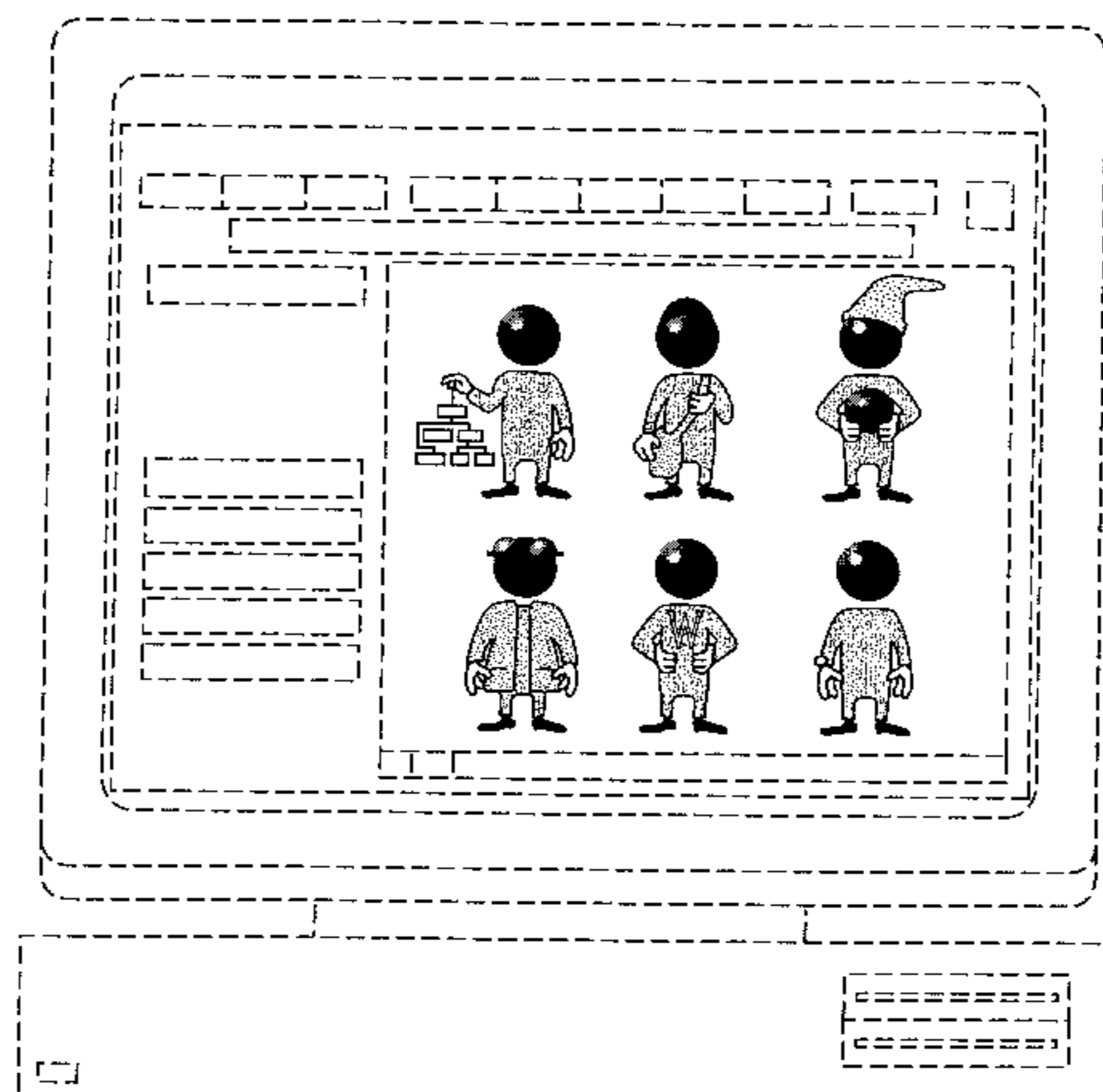


FIG. 22 is a face view of a twenty-second embodiment thereof, the second figure in the set of icons is shown separately for ease of illustration;

FIG. 38 is a face view of thirty-eighth embodiment thereof, the fifth figure in the set of icons is shown separately for ease of illustration;

FIG. 39 is a face view of a thirty-ninth embodiment thereof, the fifth figure in the set of icons is shown separately for ease of illustration; and,

FIG. 40 is a face view of a fortieth embodiment thereof, the fifth figure in the set of icons is shown separately for ease of illustration.

The broken line drawing of a display screen in FIGS. 1-8 is for illustrative purposes only and forms no part of the claimed design. The variations of the first figure shown in FIGS. 9-11 are understood to substitute for the first figure in FIGS. 1-8. The variations of the second figure shown in FIGS. 12-23 are understood to substitute for the second figure in FIGS. 1-8. The variations of the fourth figure shown in FIGS. 24-33 are understood to substitute for the fourth figure in FIGS. 1-8. The variations of the fifth figure shown in FIGS. 34-37 are understood to substitute for the fifth figure in FIGS. 1-8.

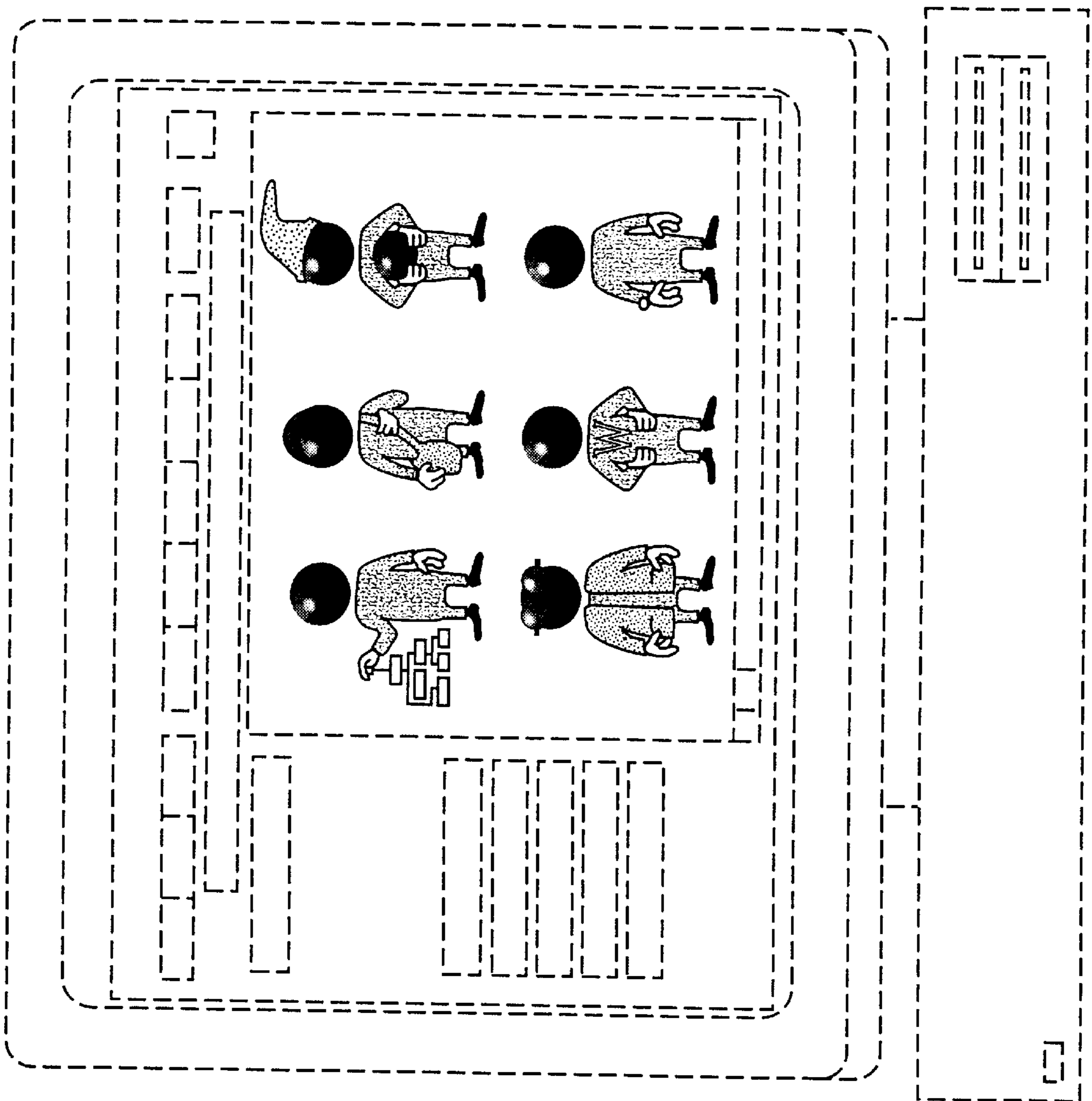

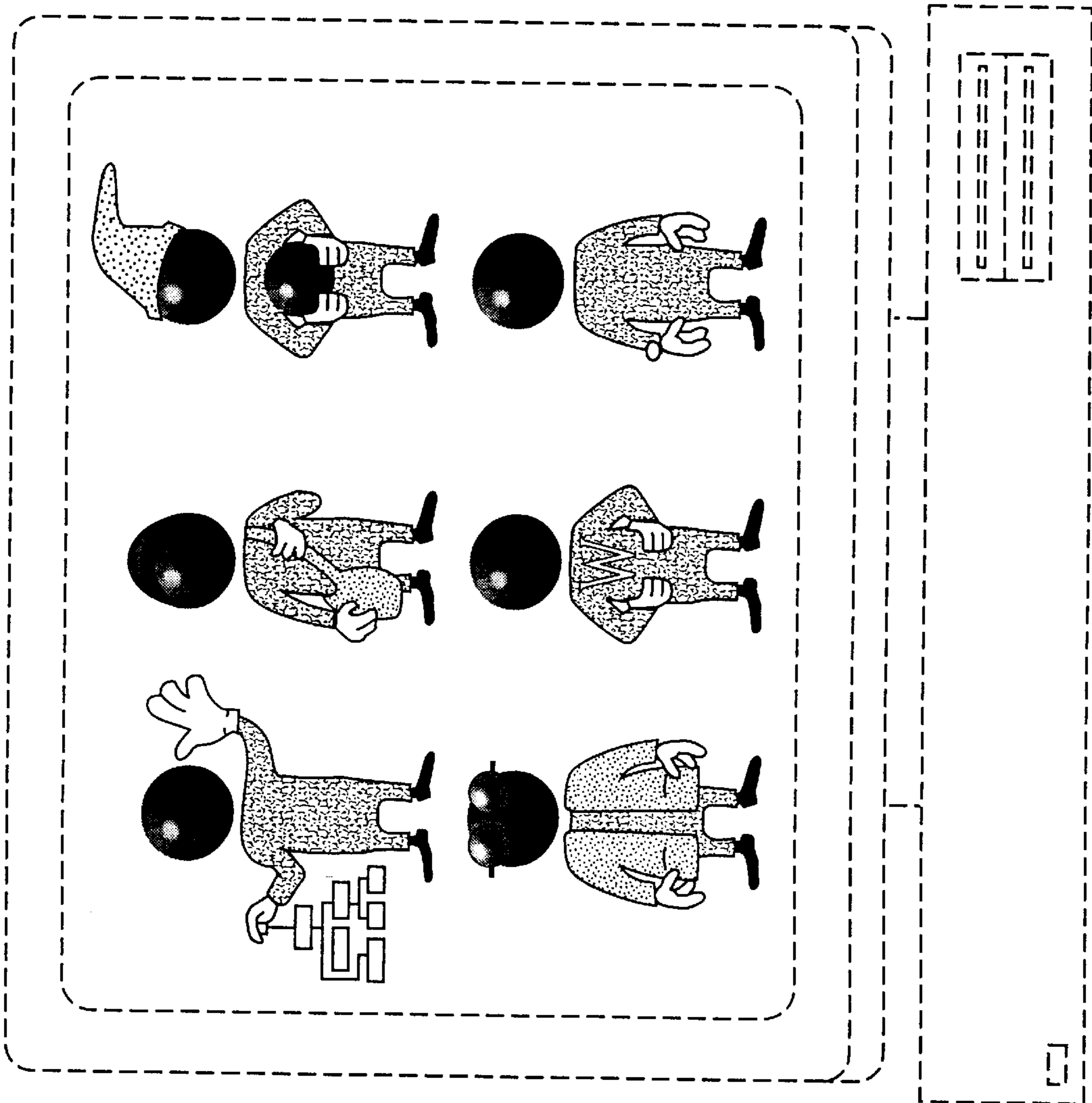

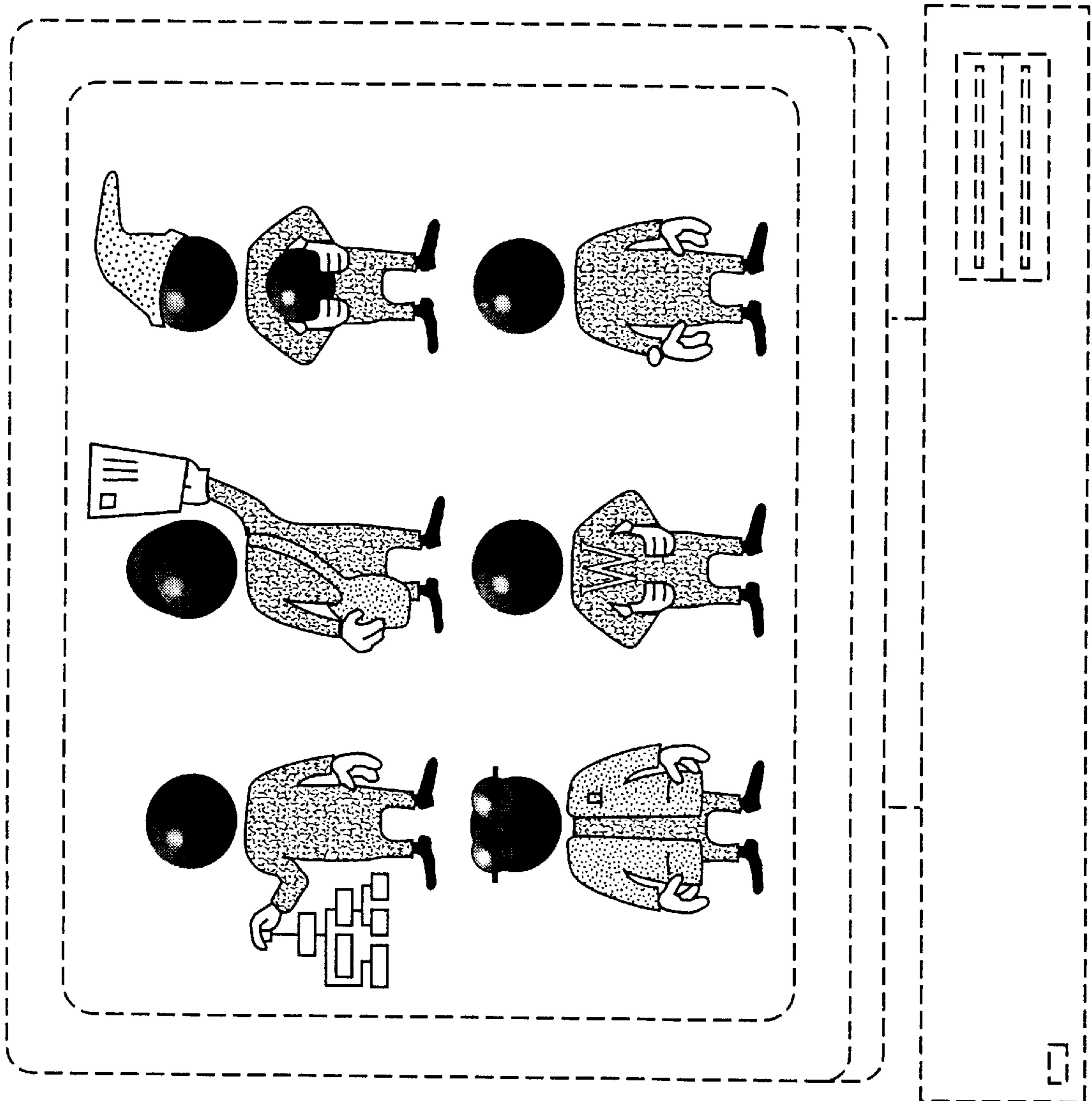

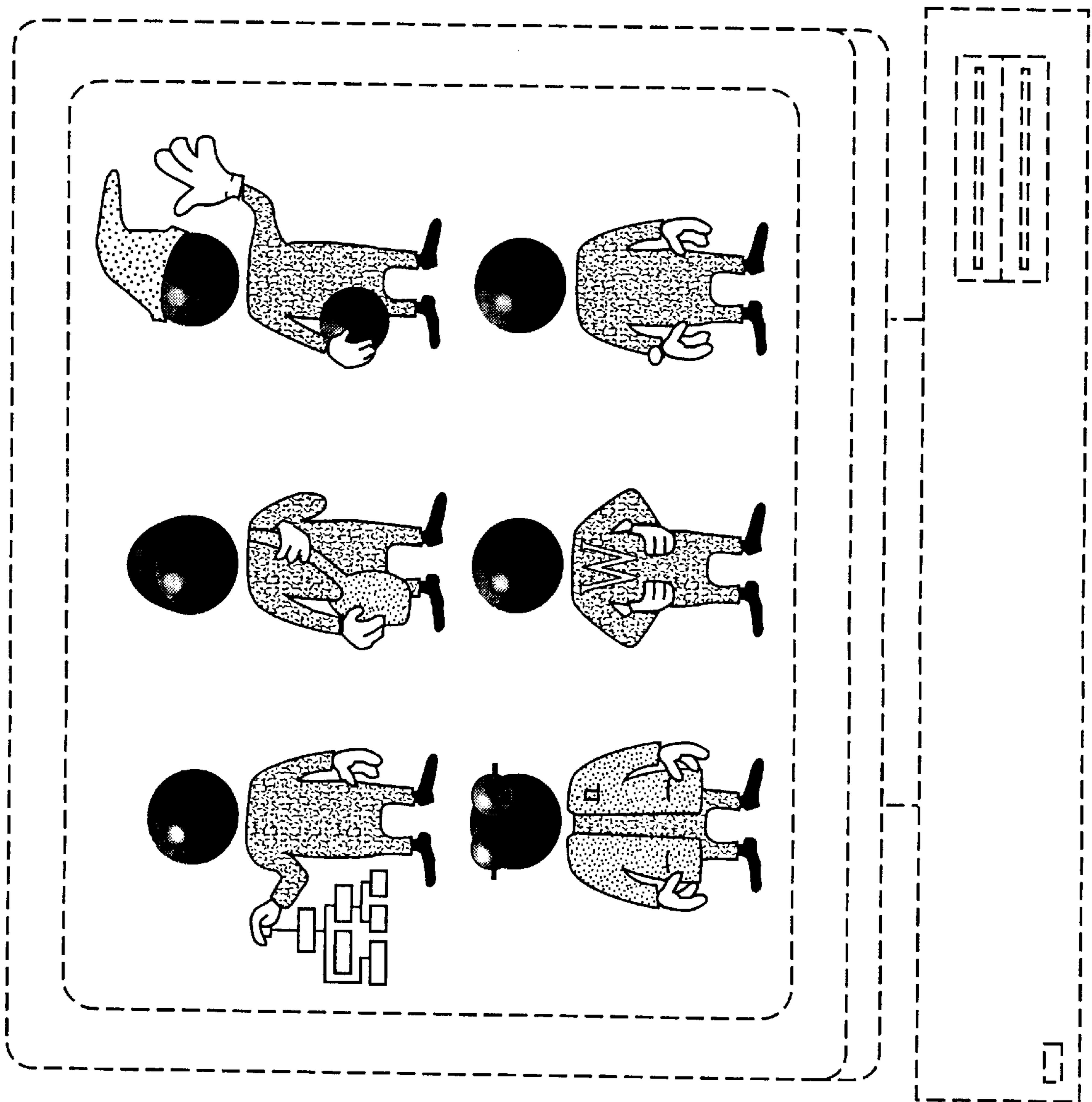

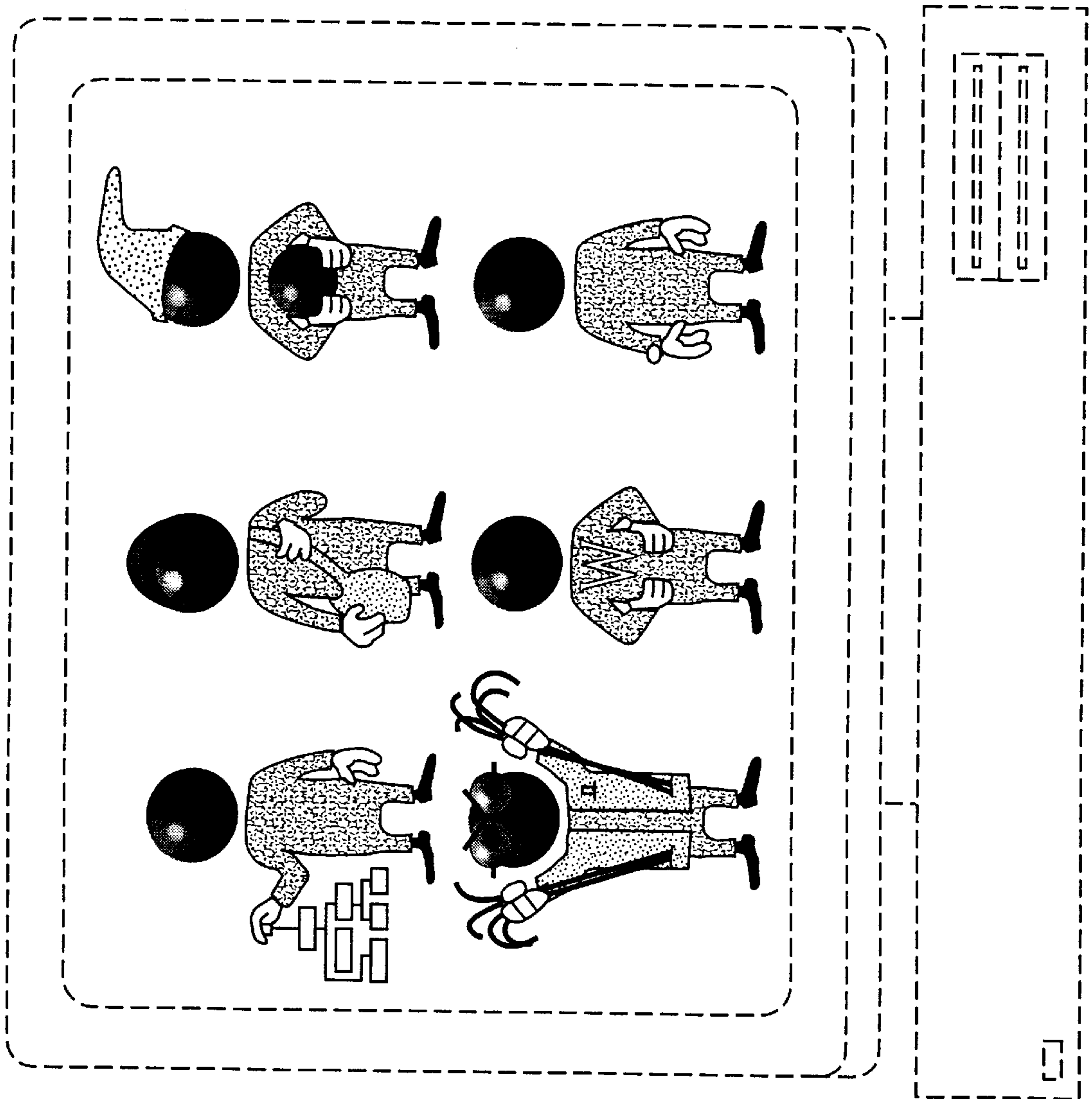

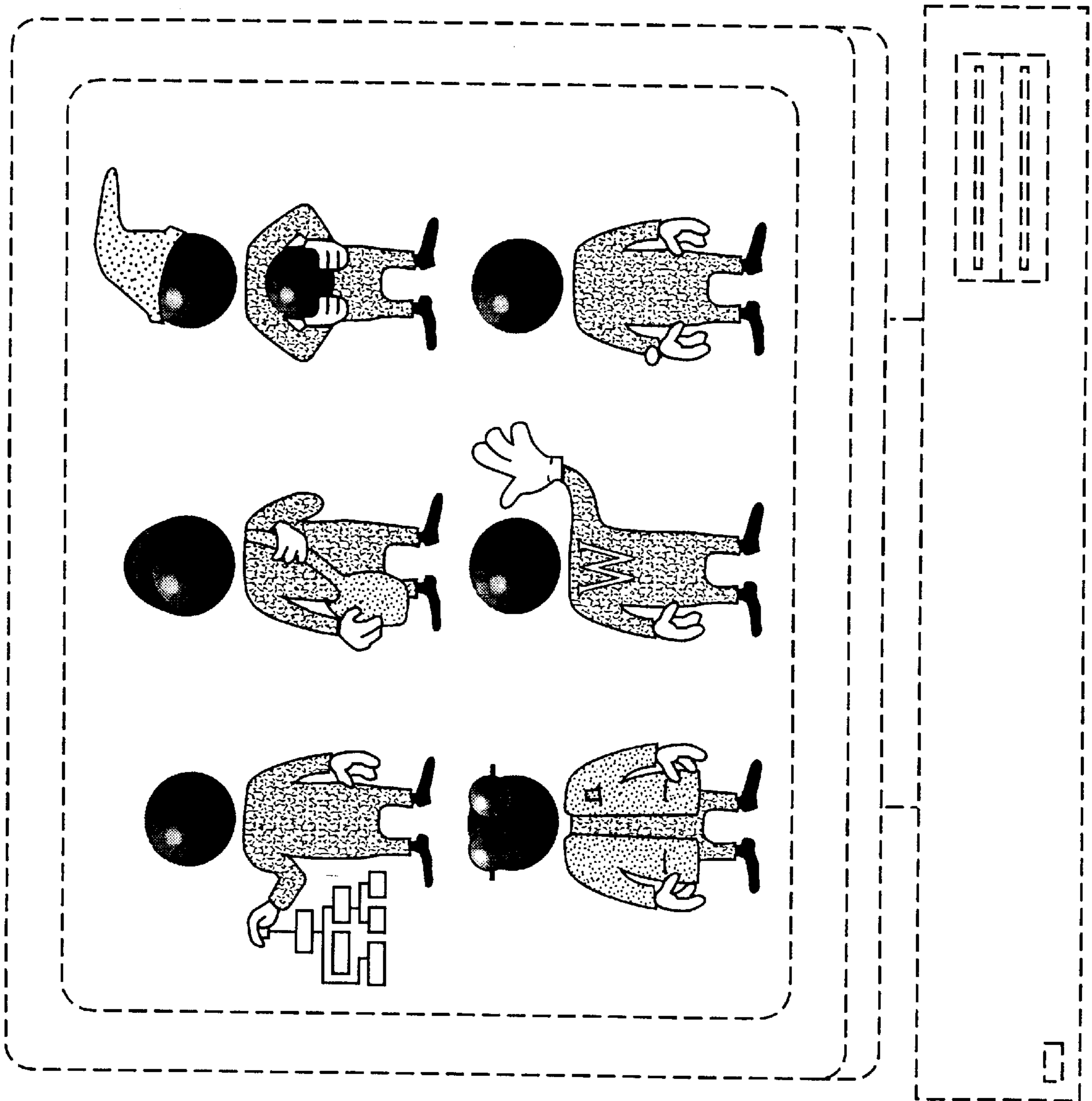

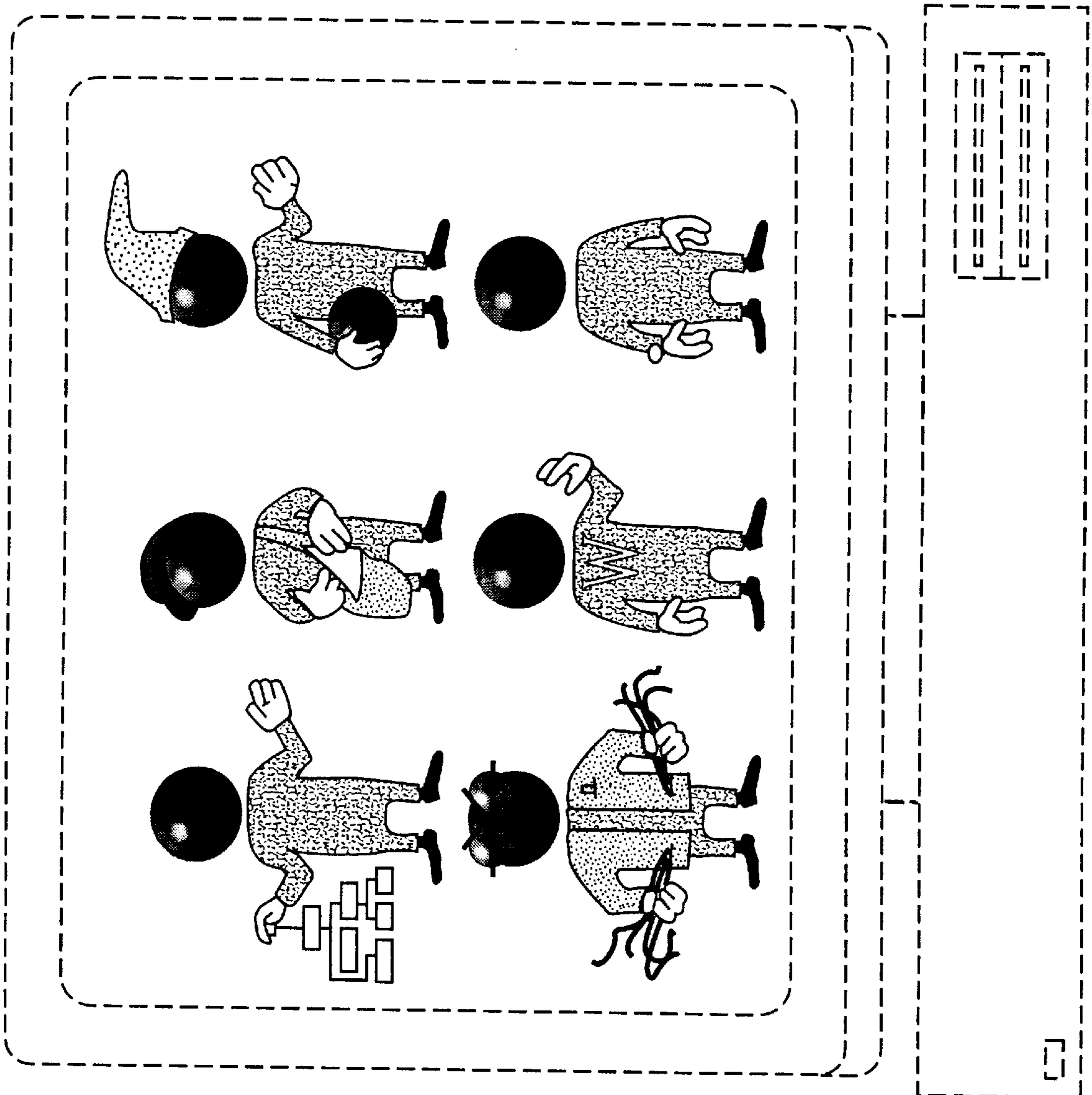
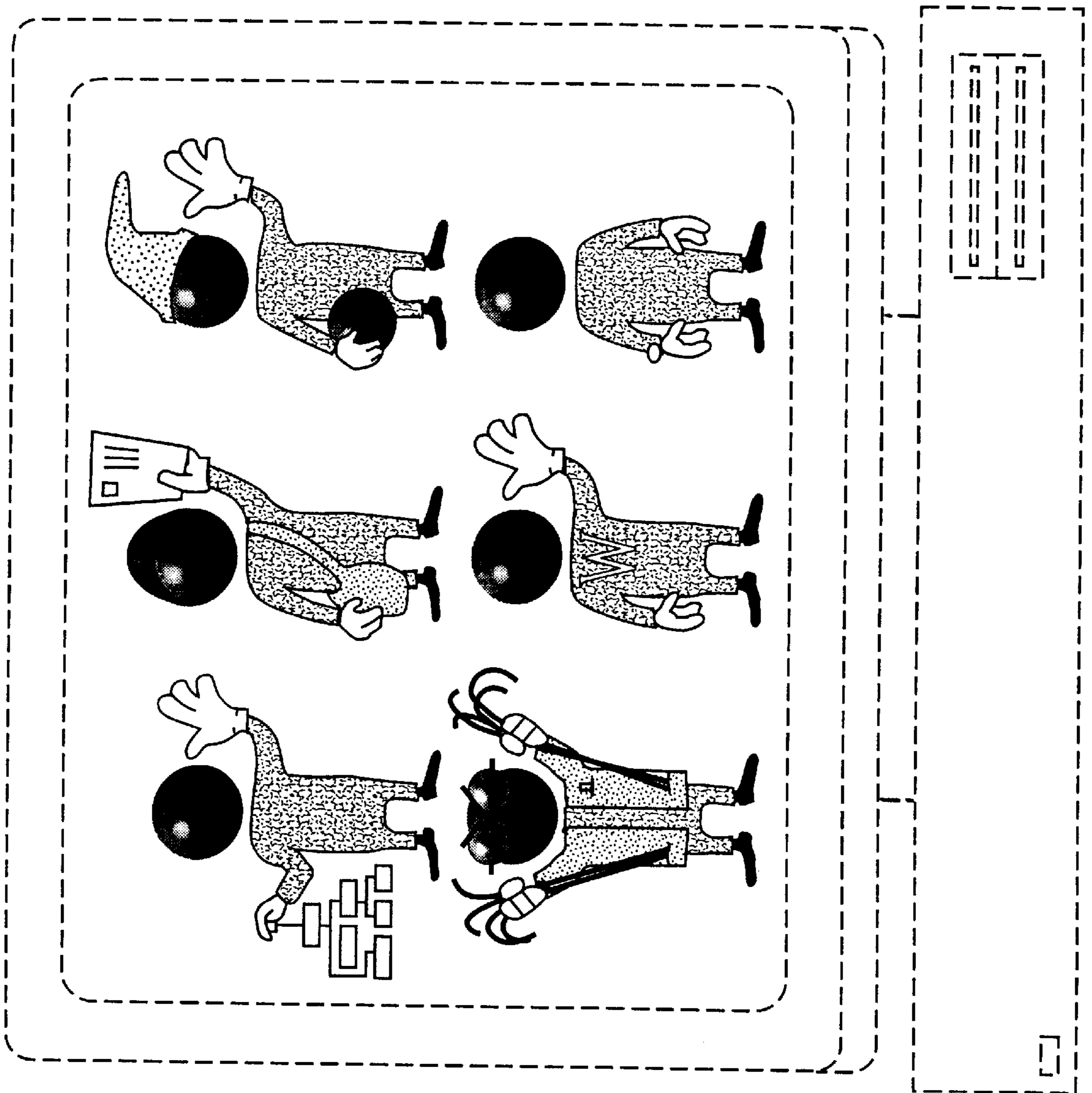

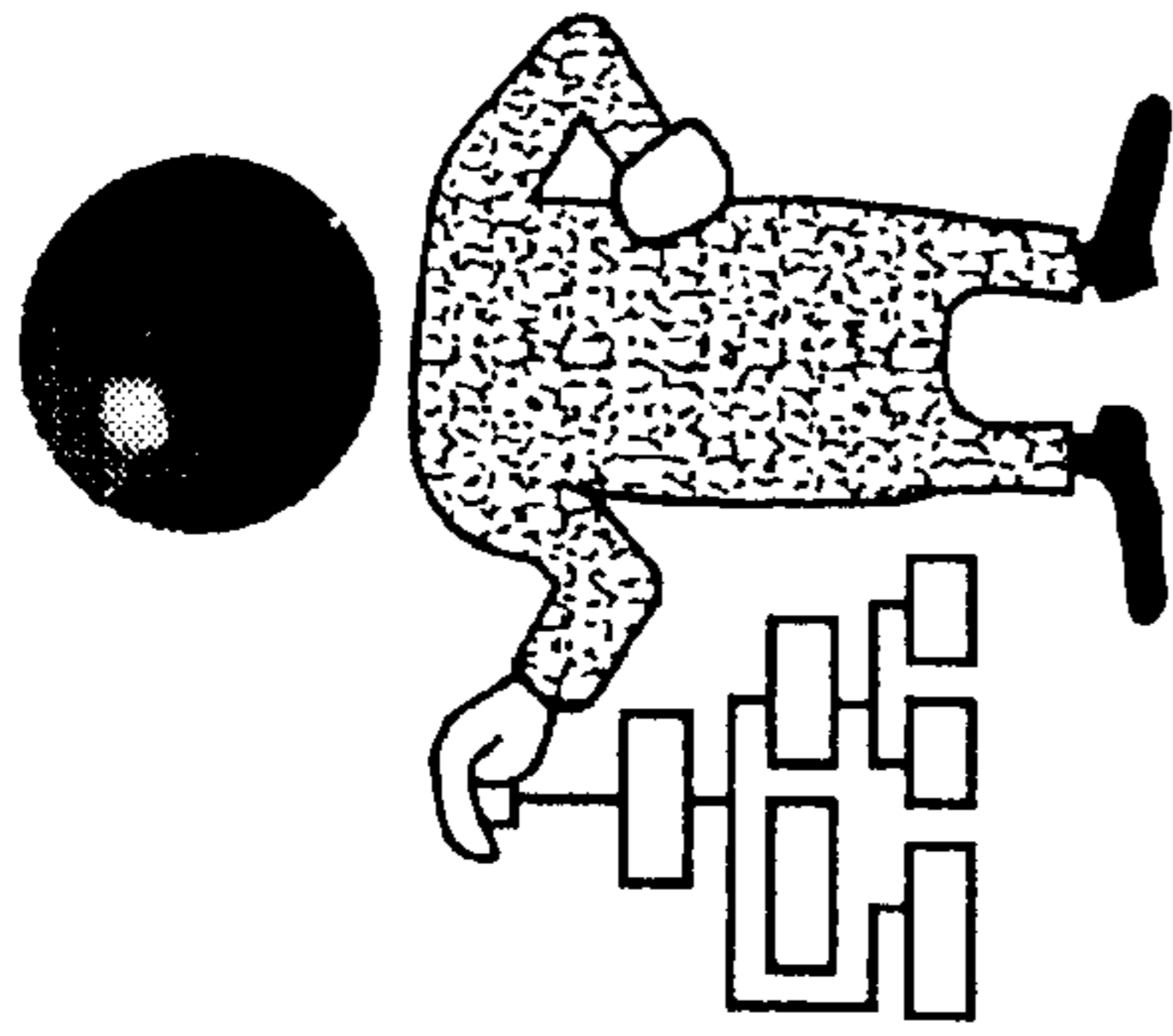

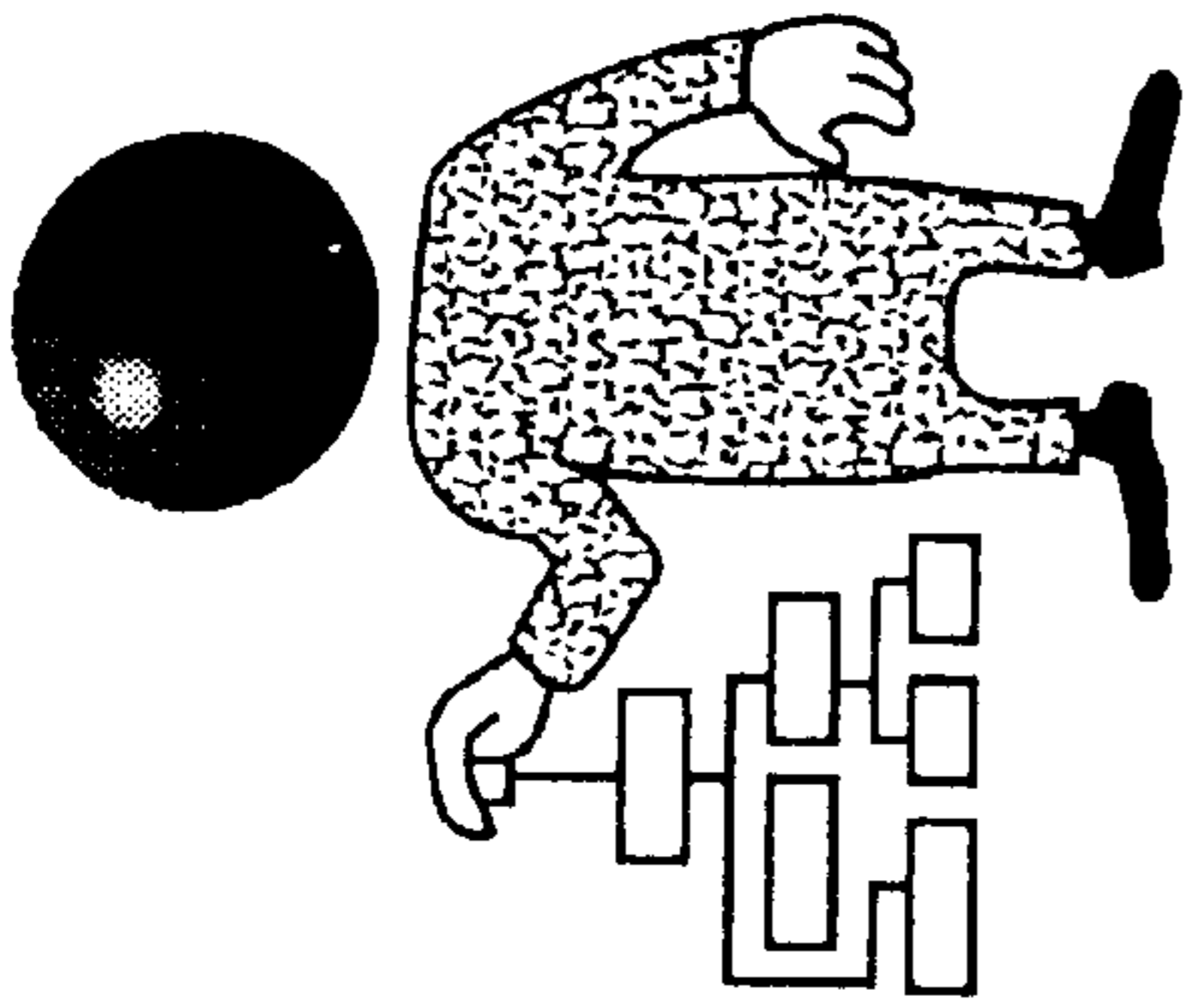

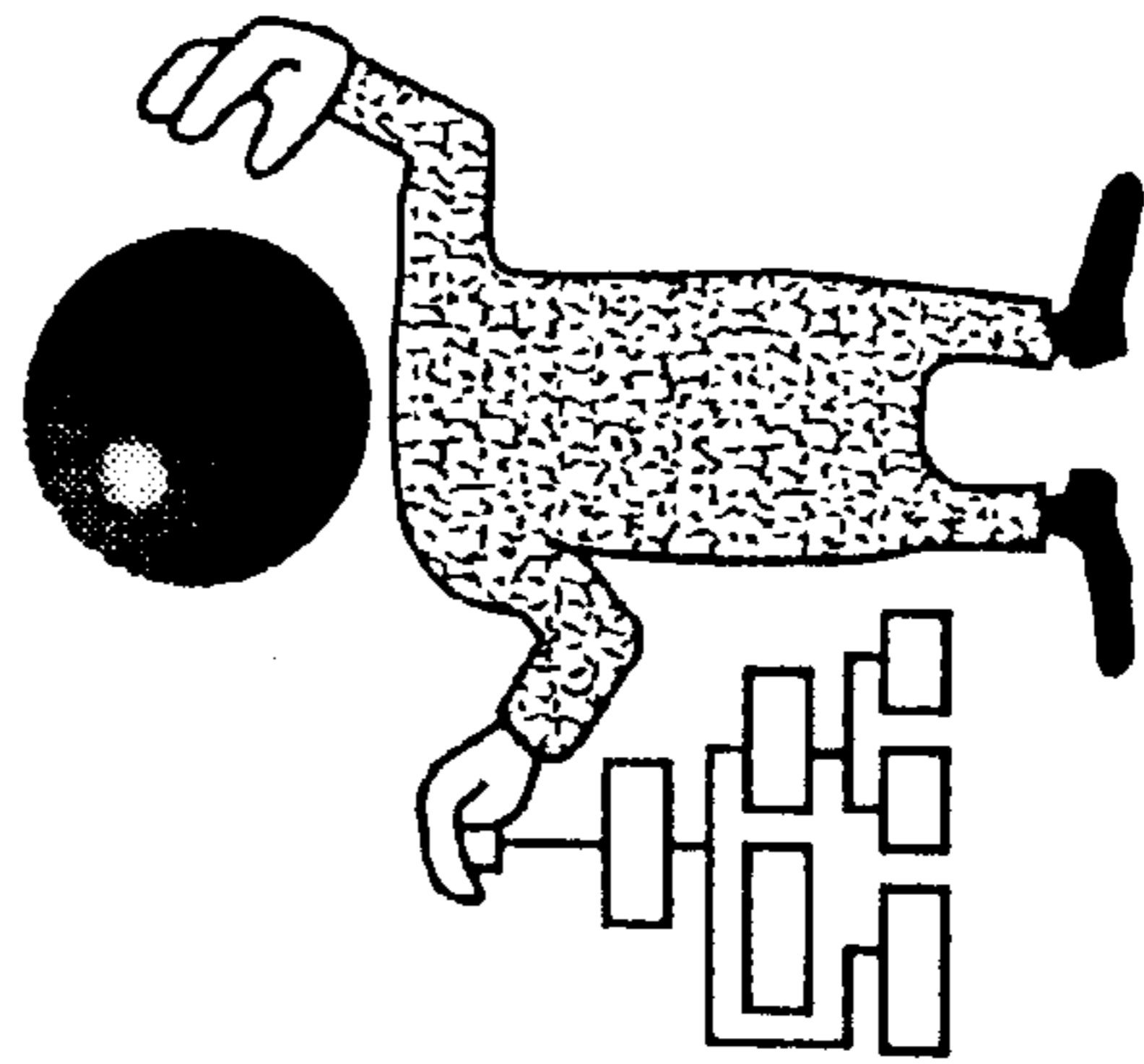

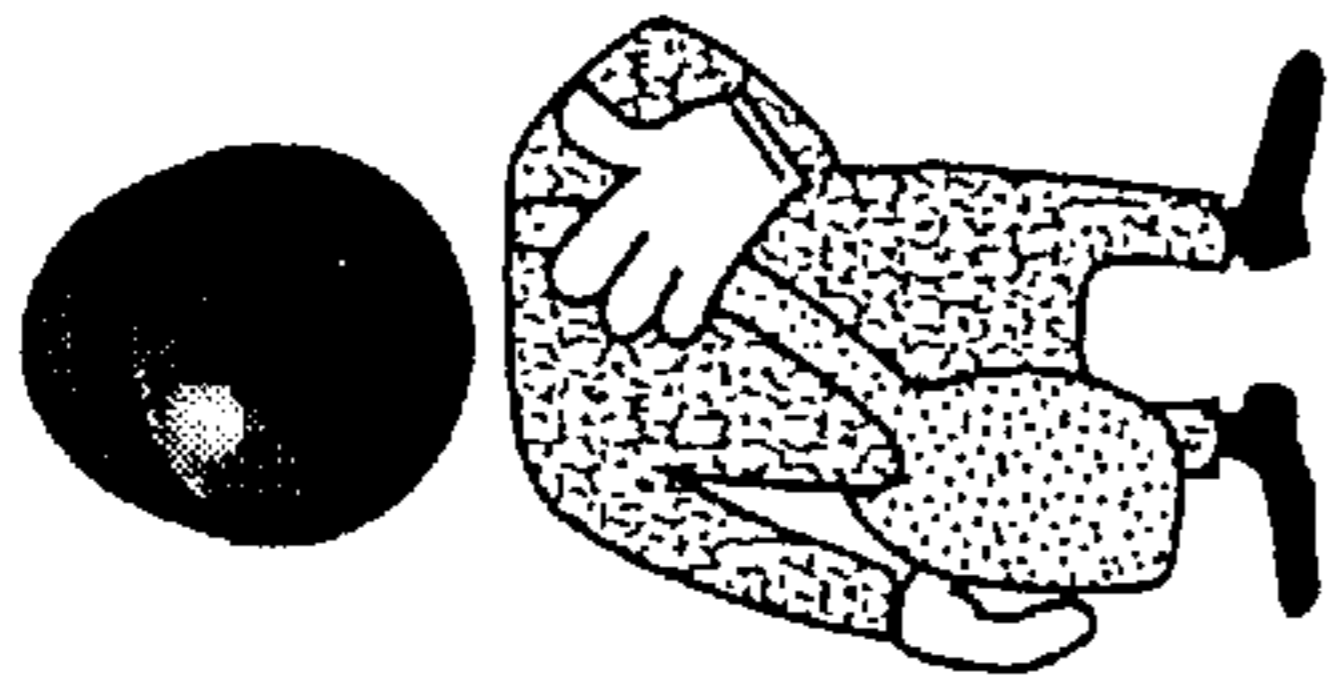

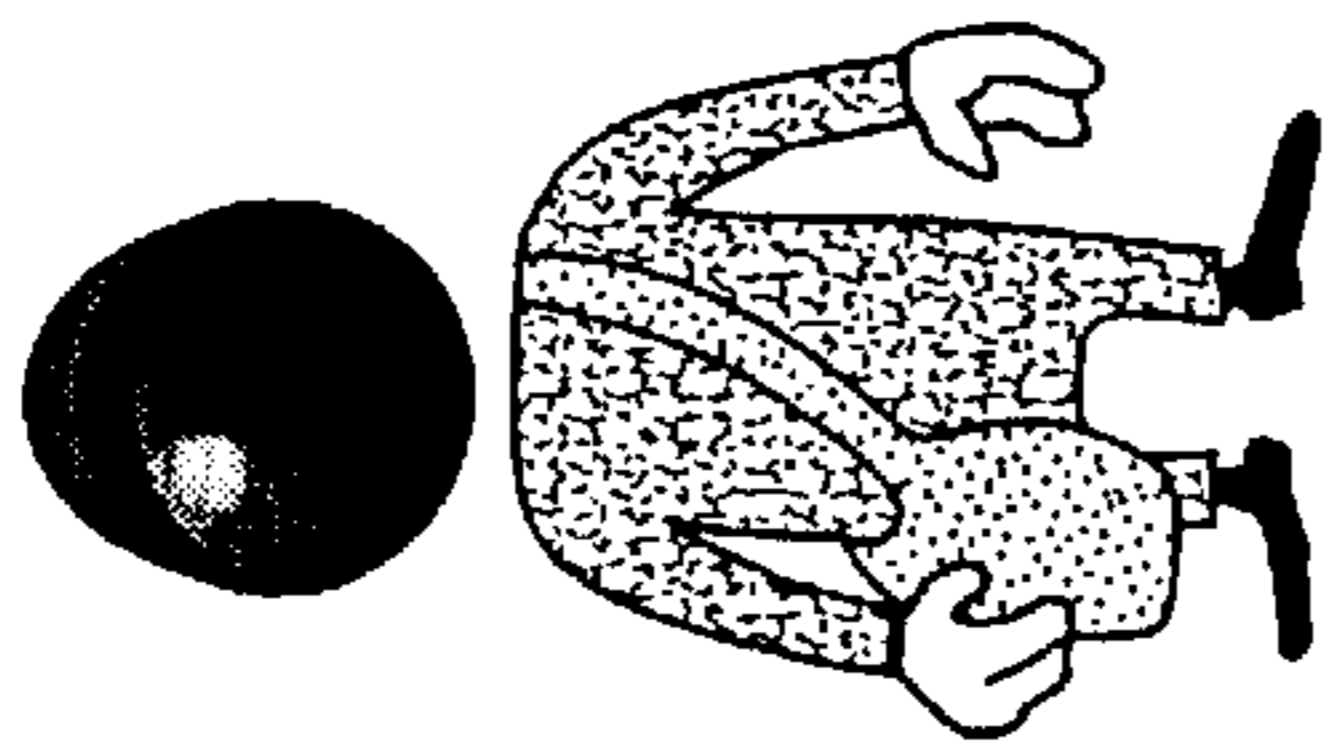

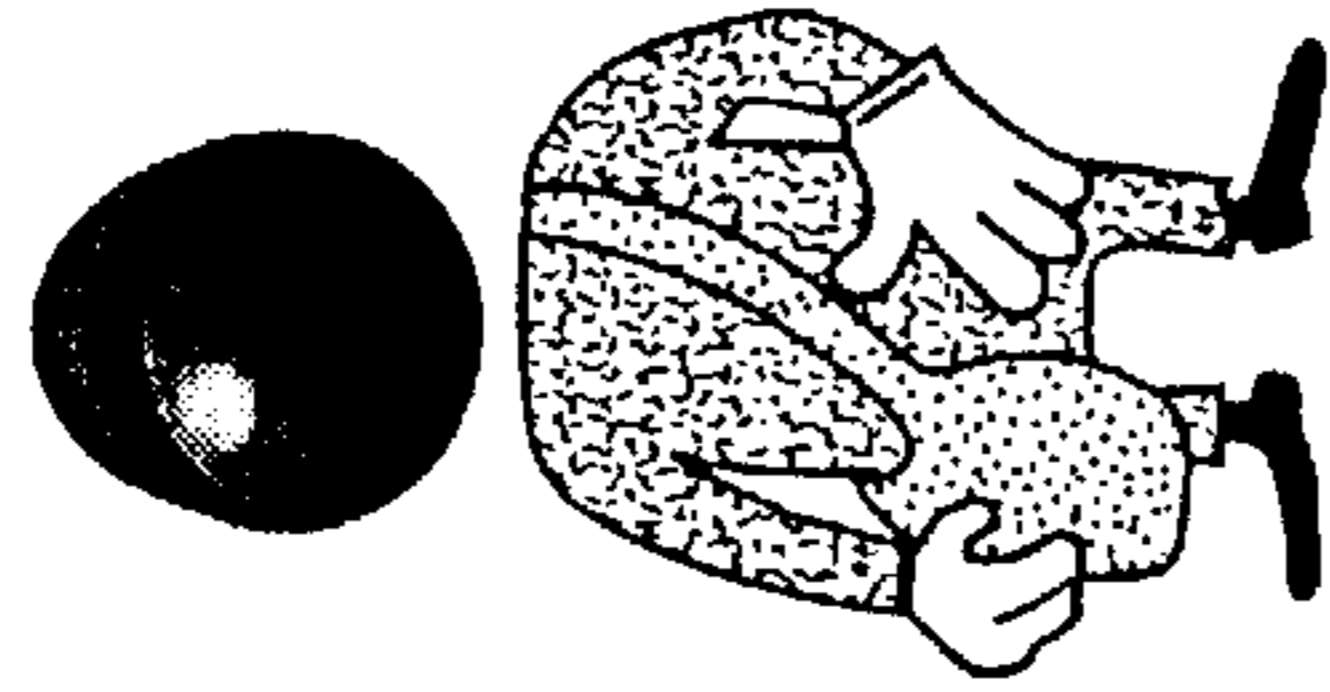

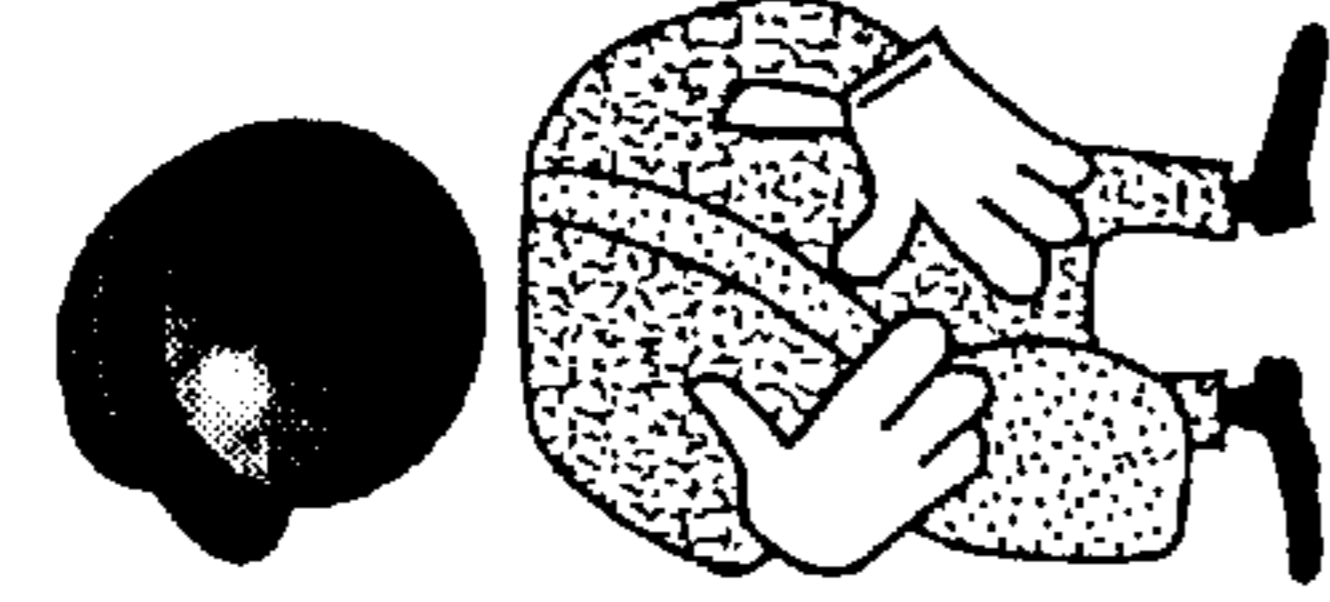

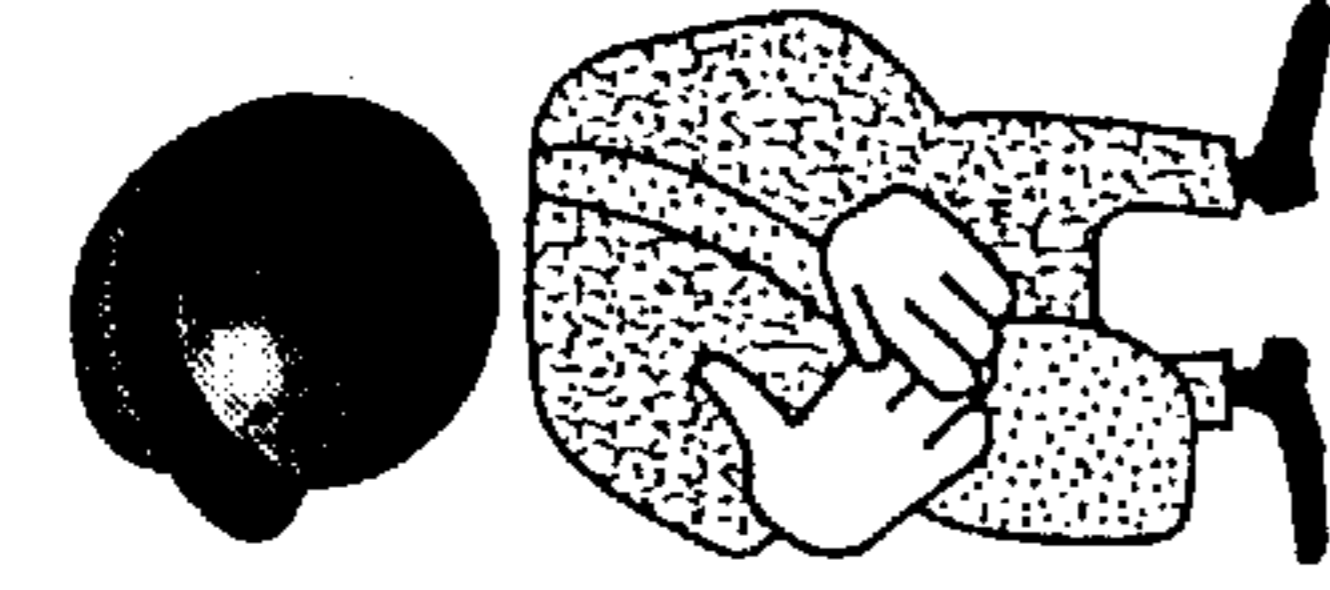

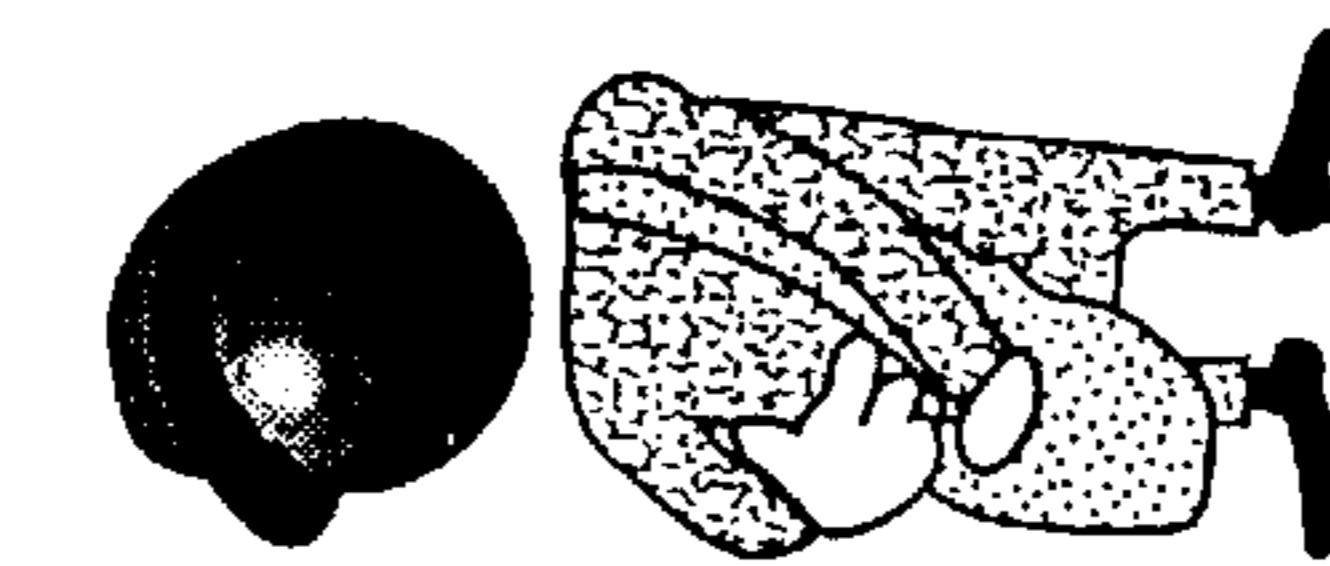

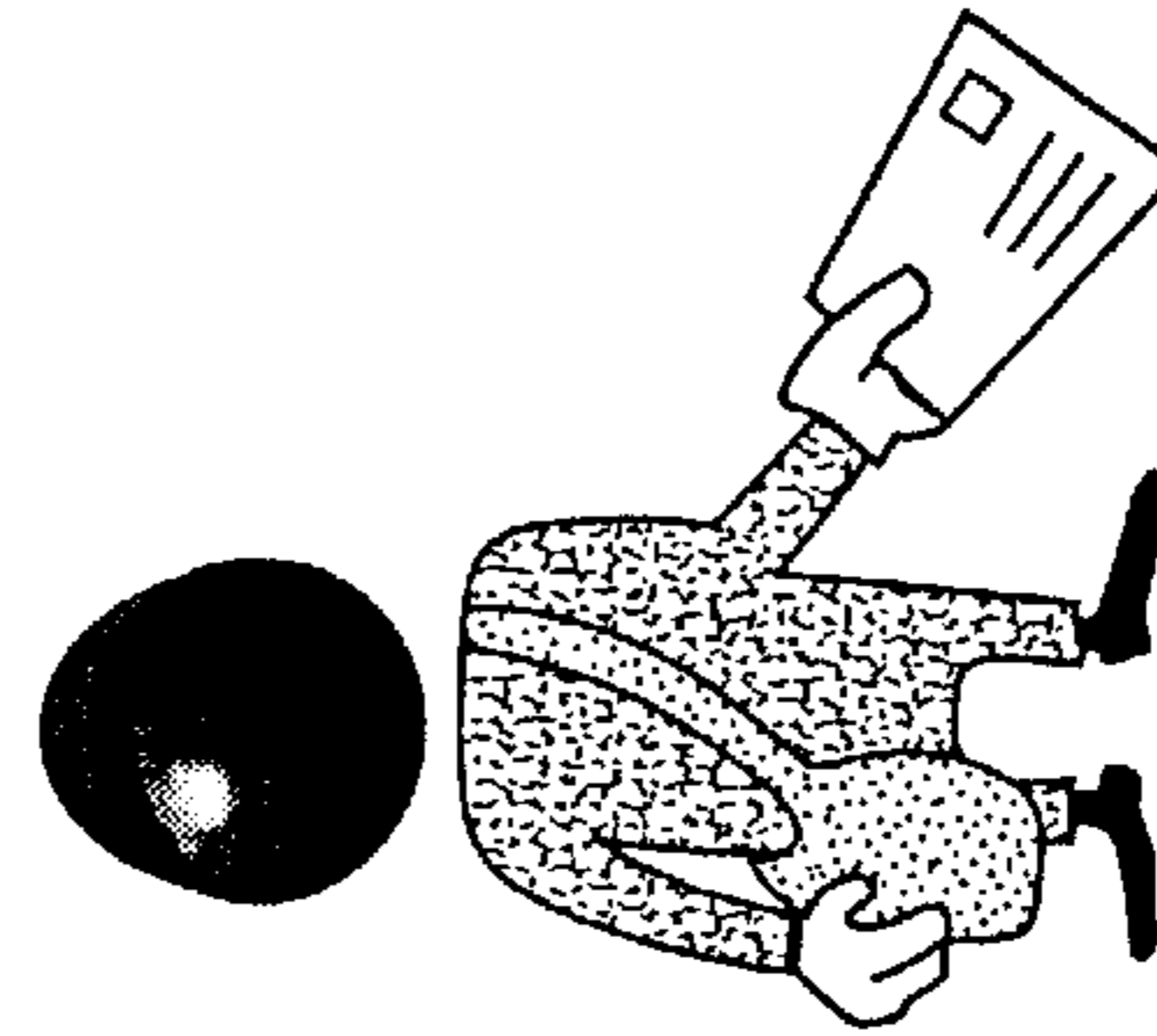

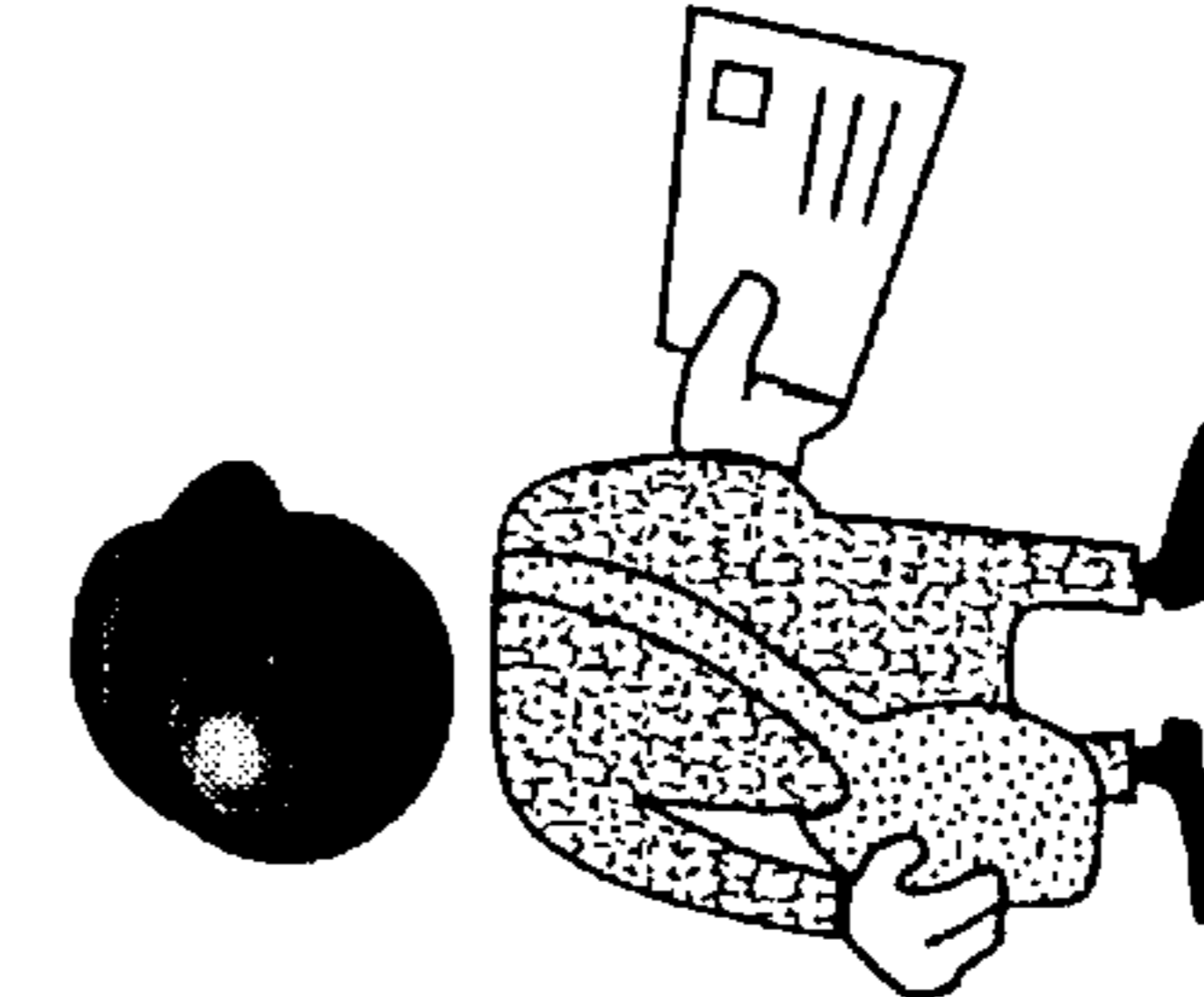

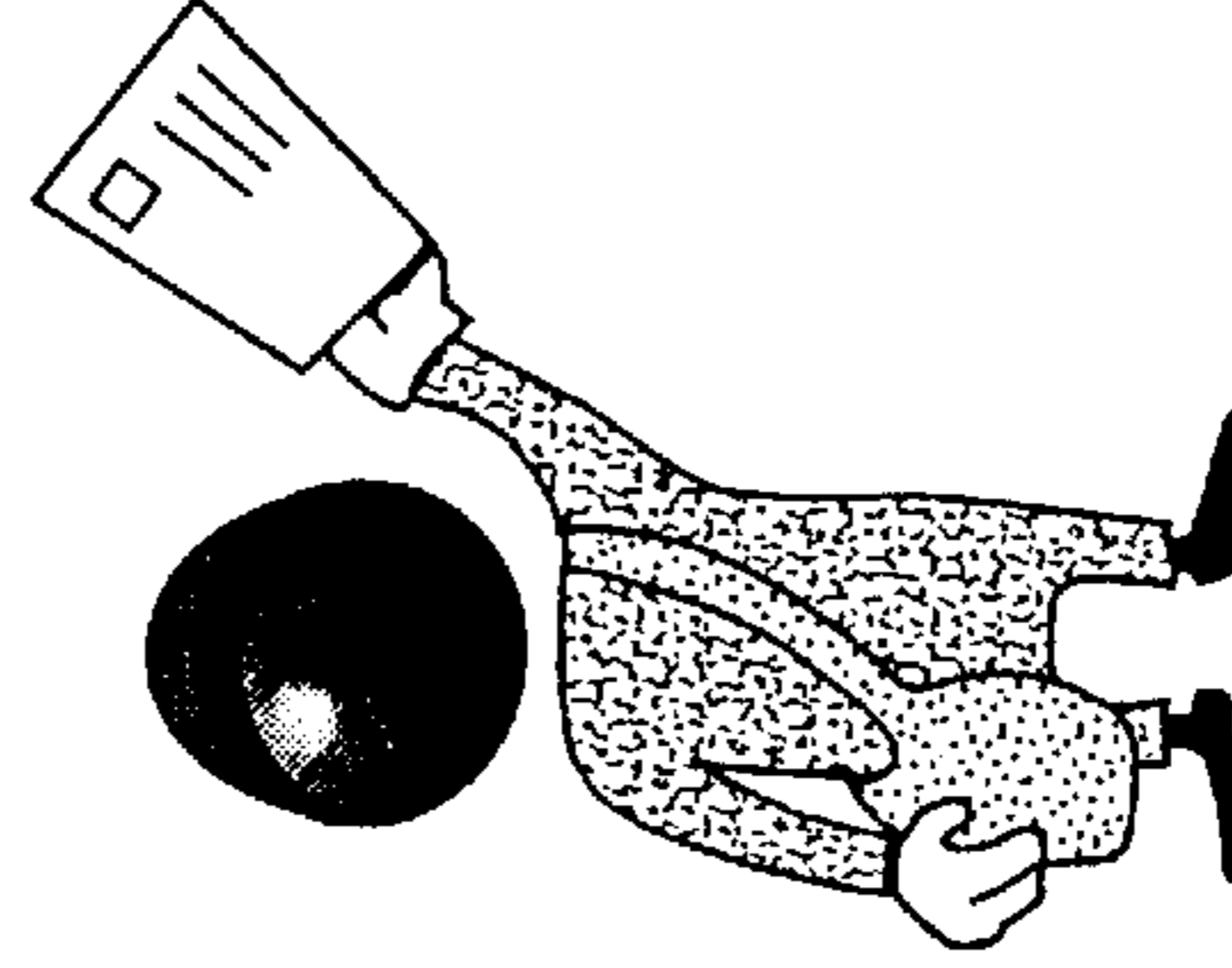

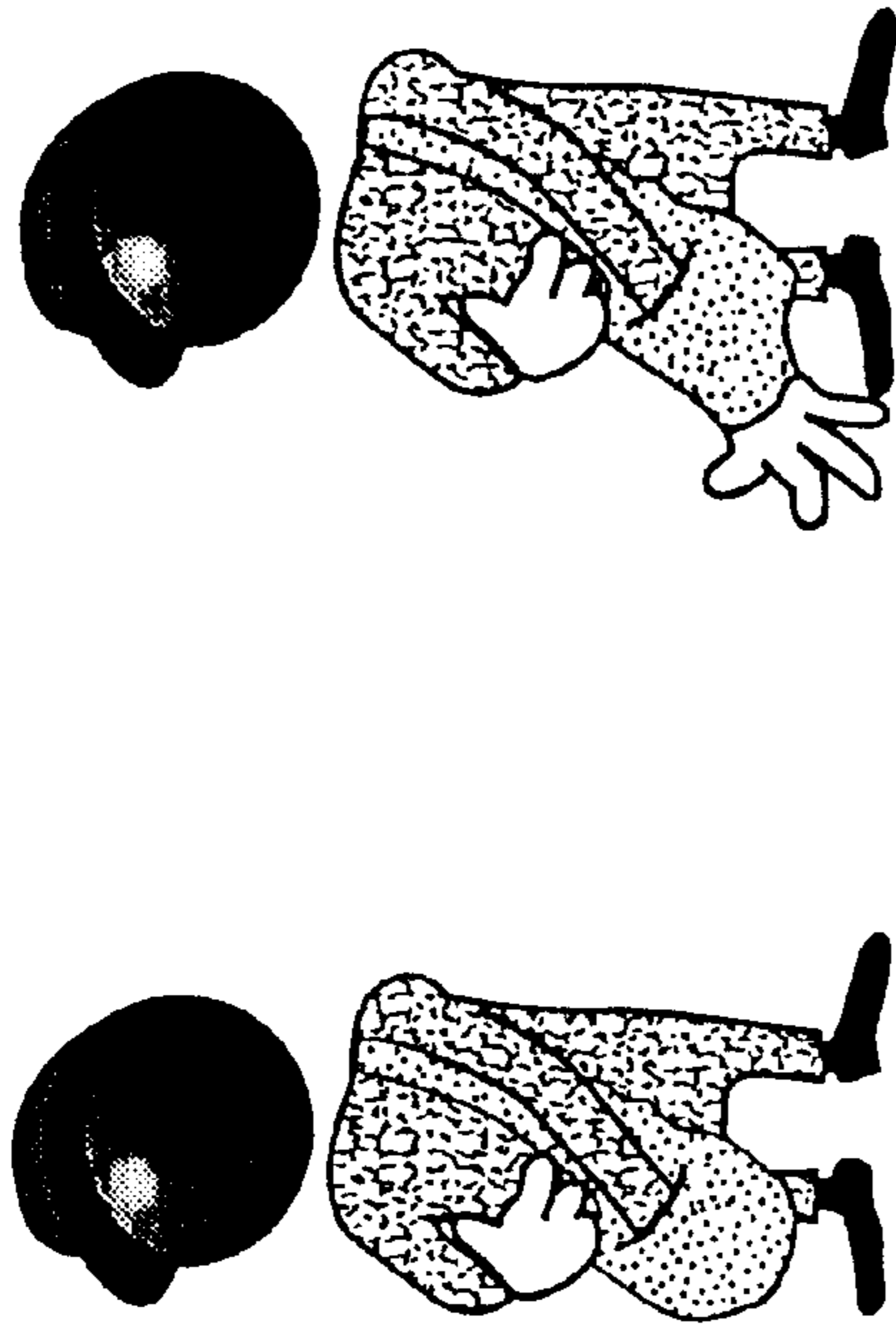

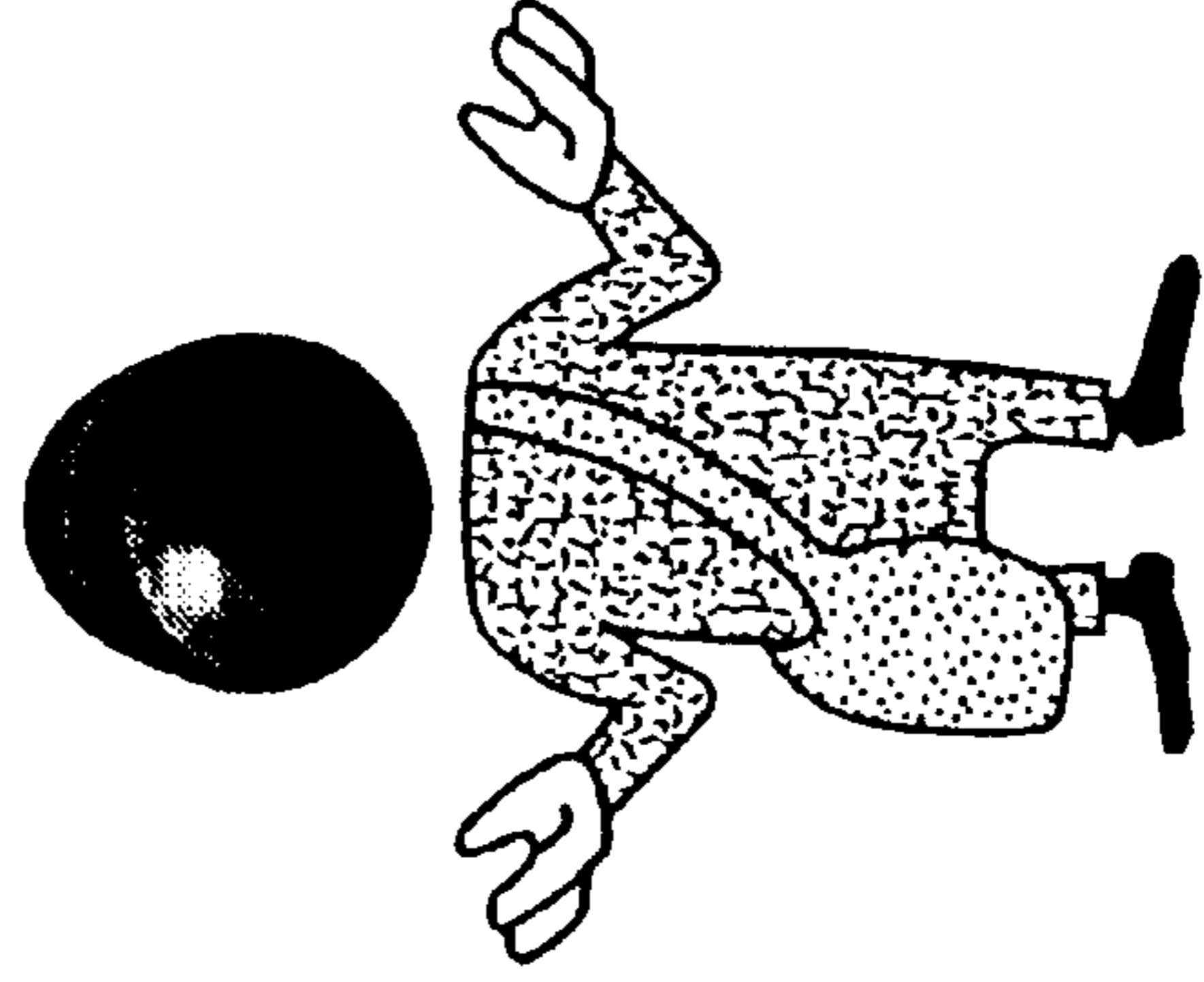

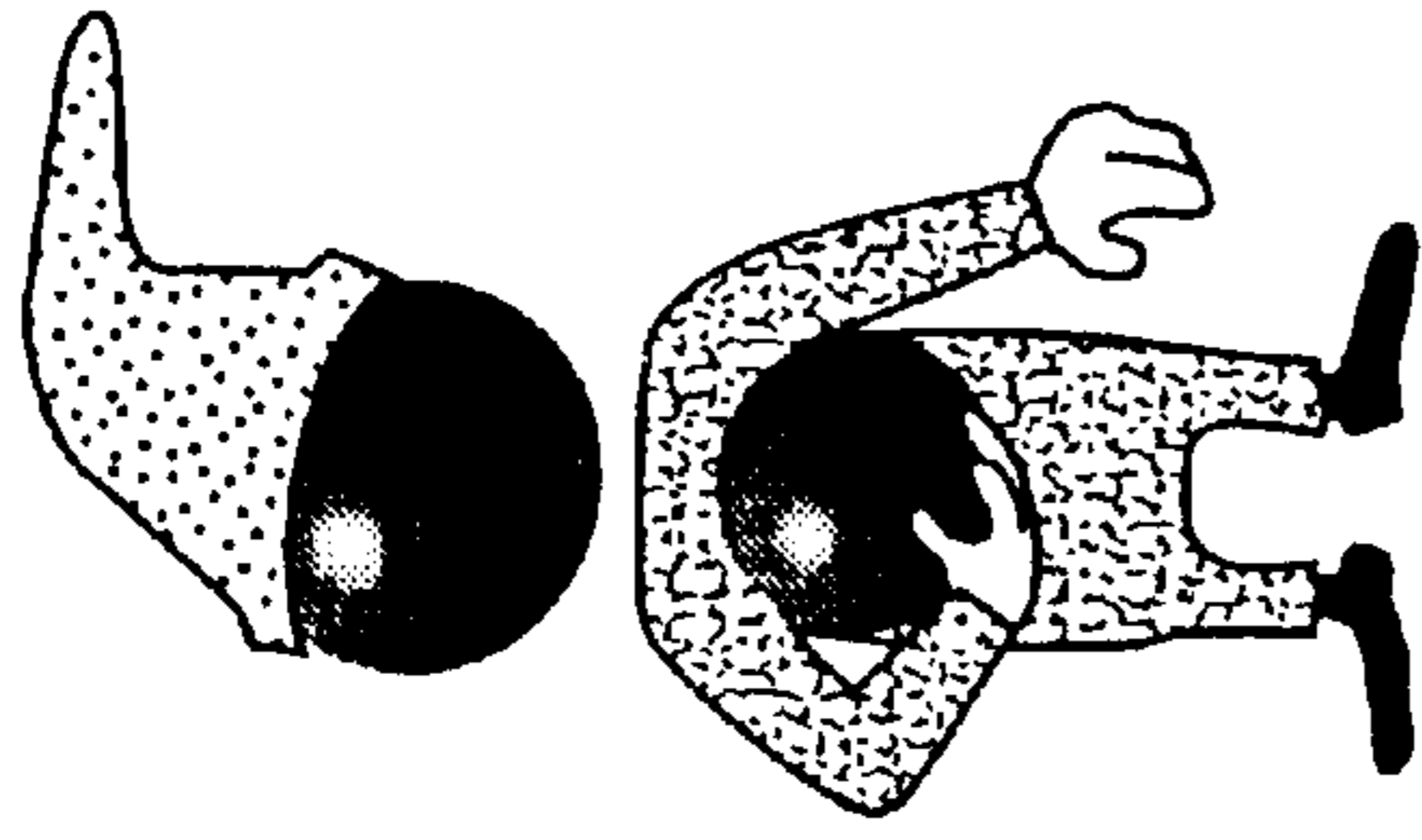

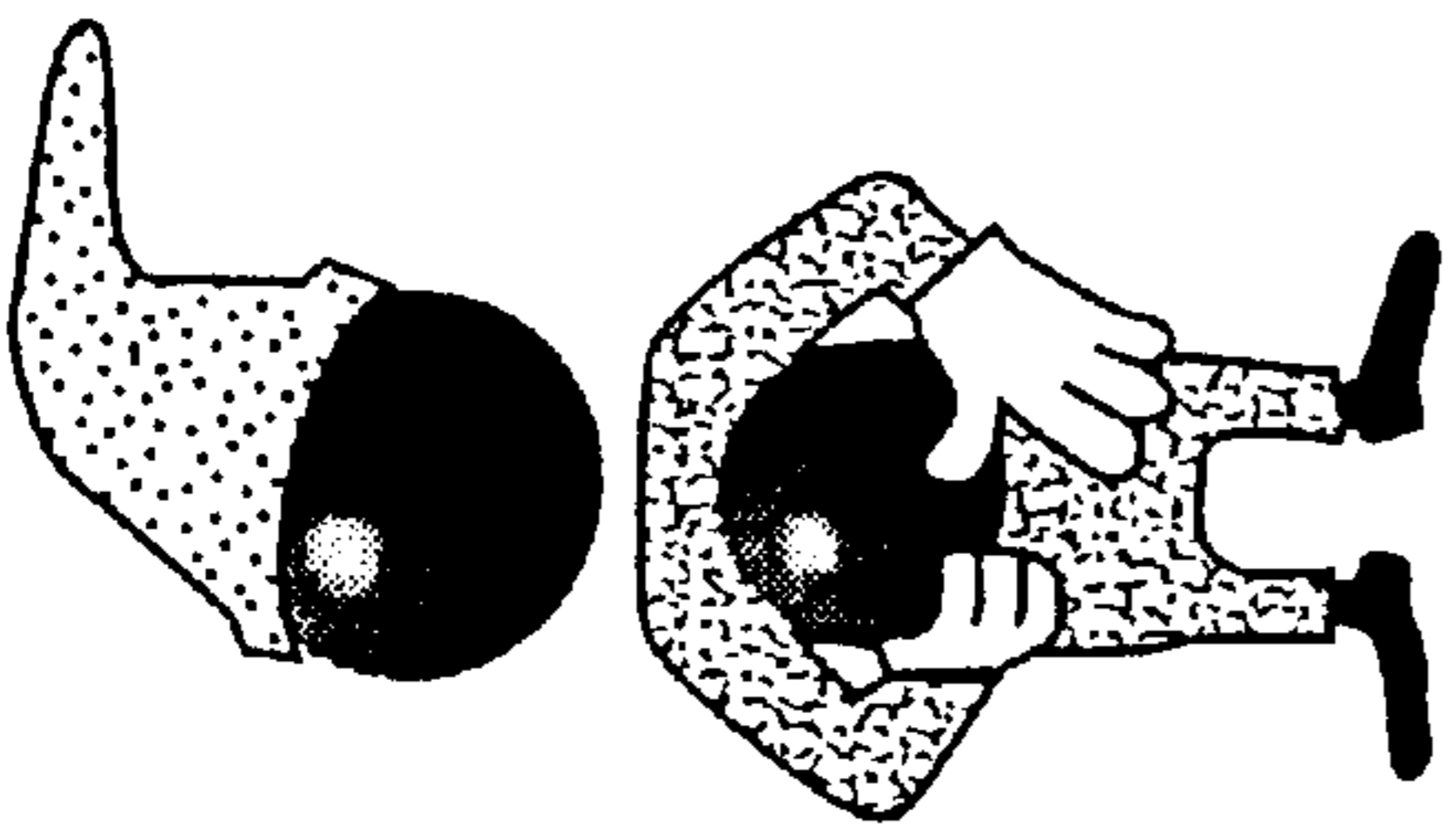

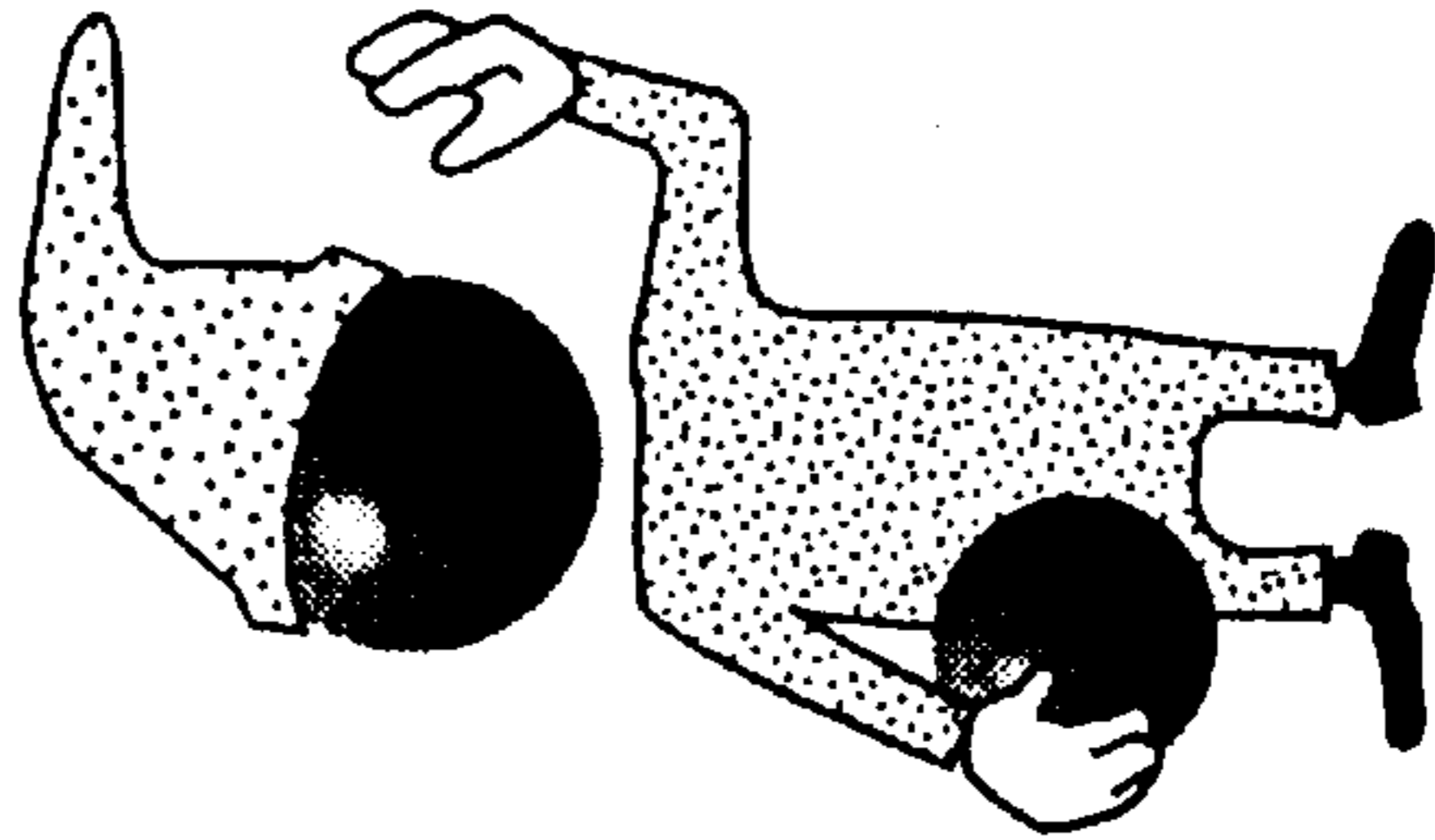

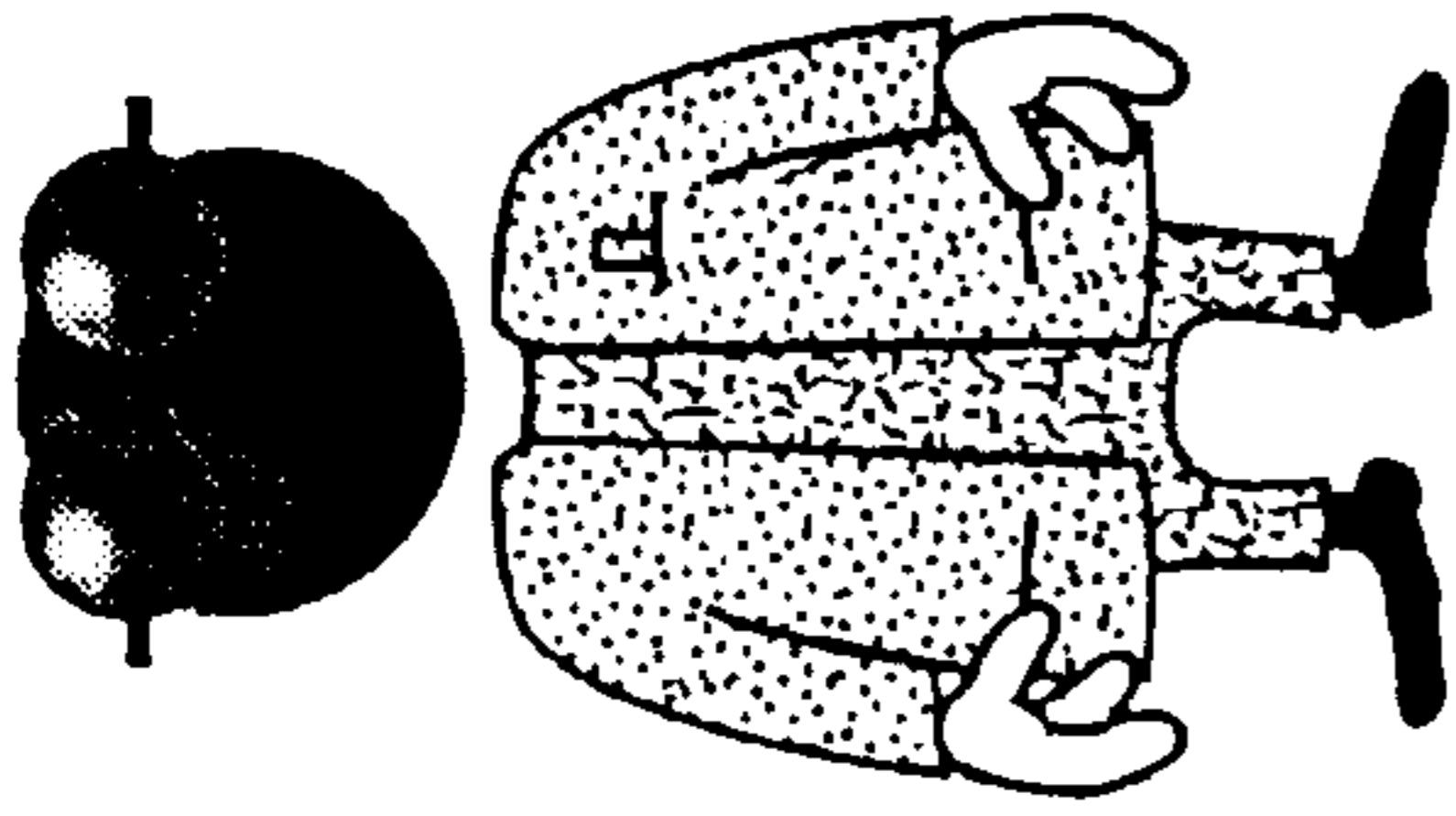

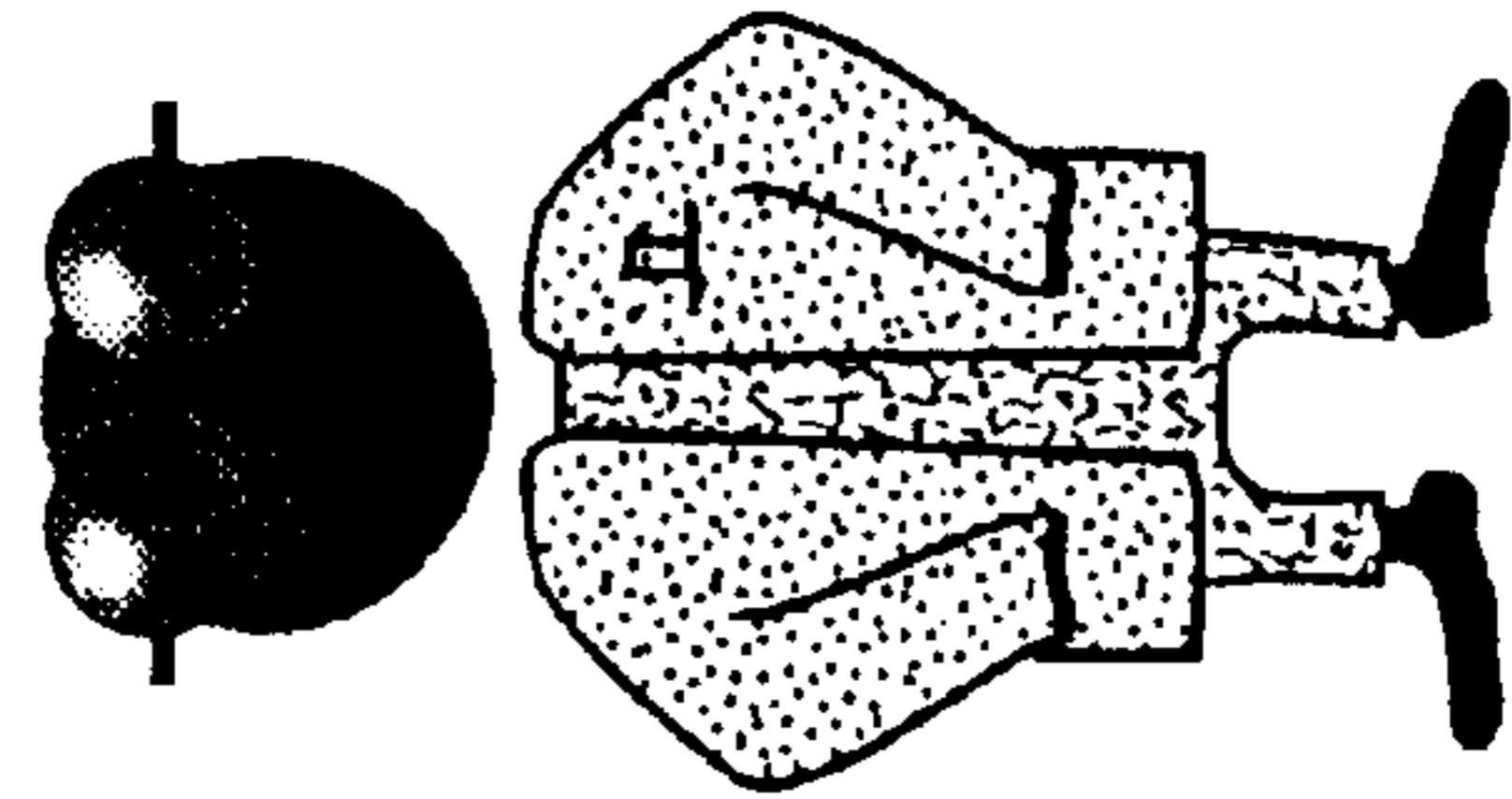

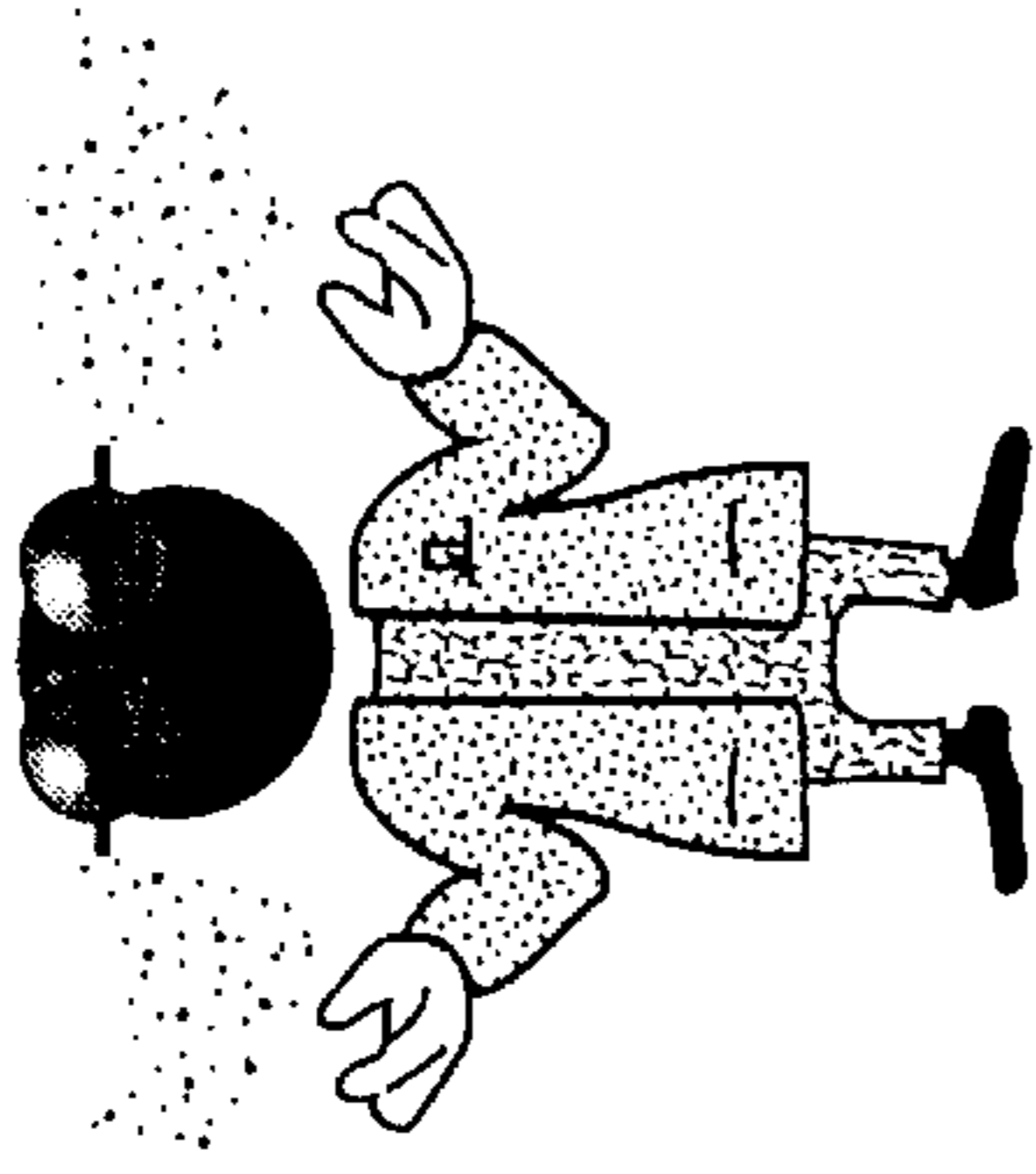

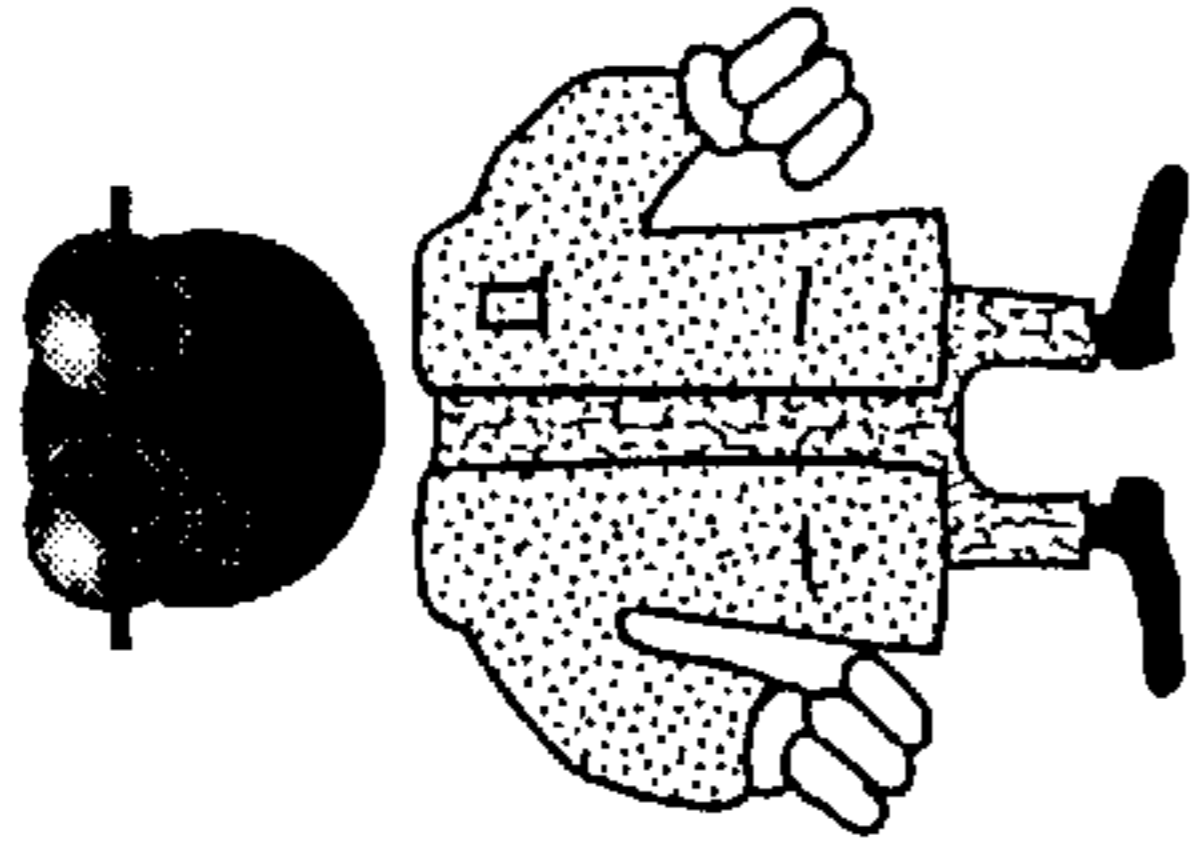

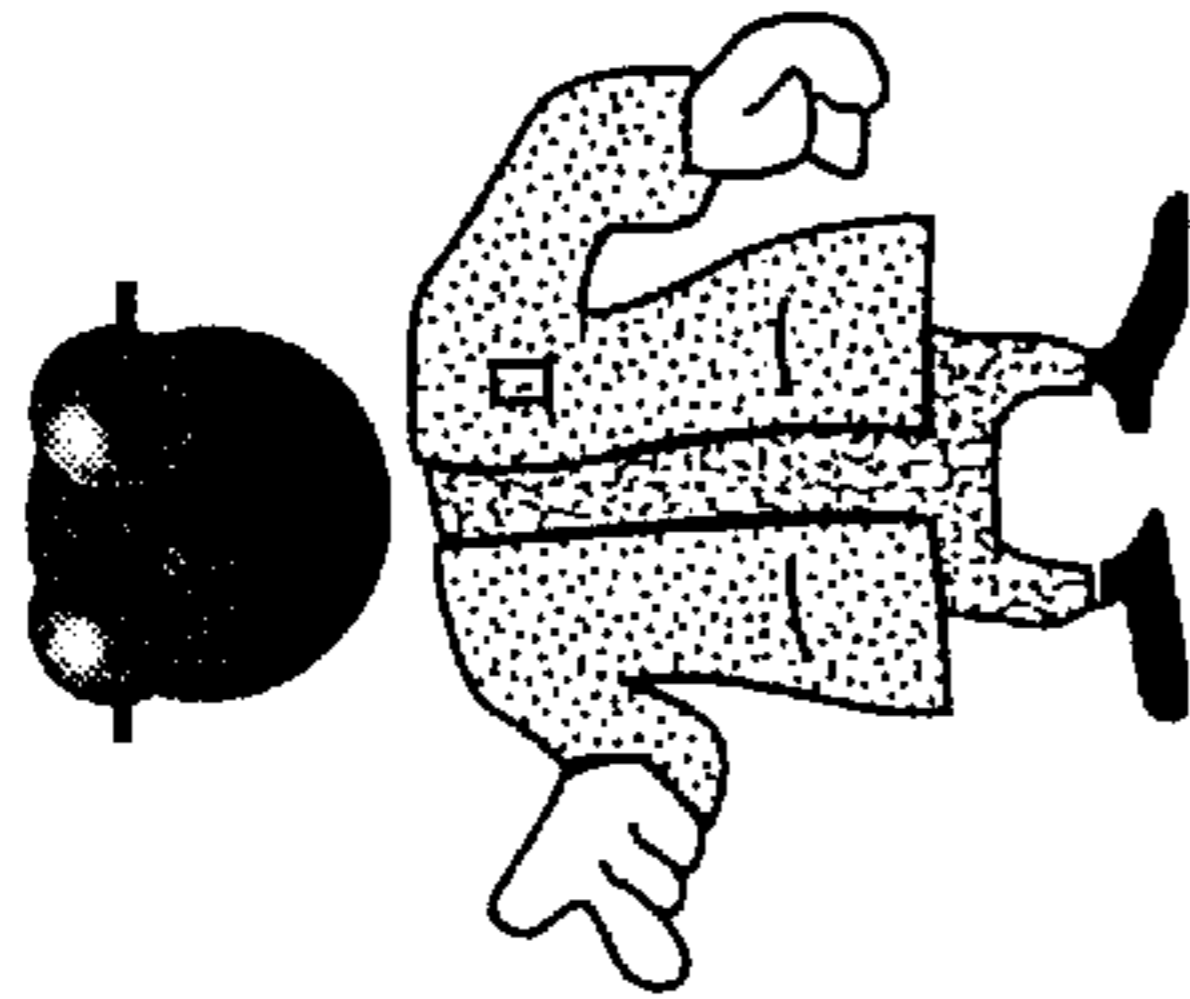

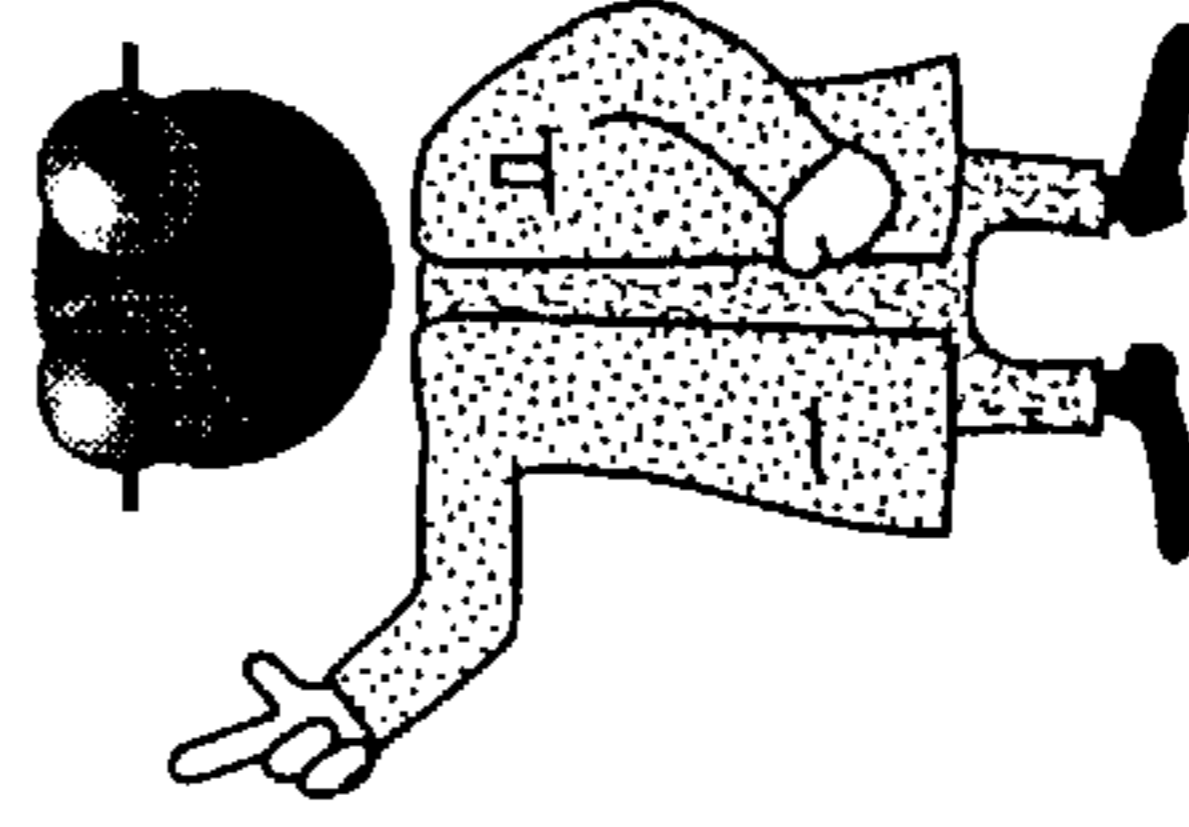

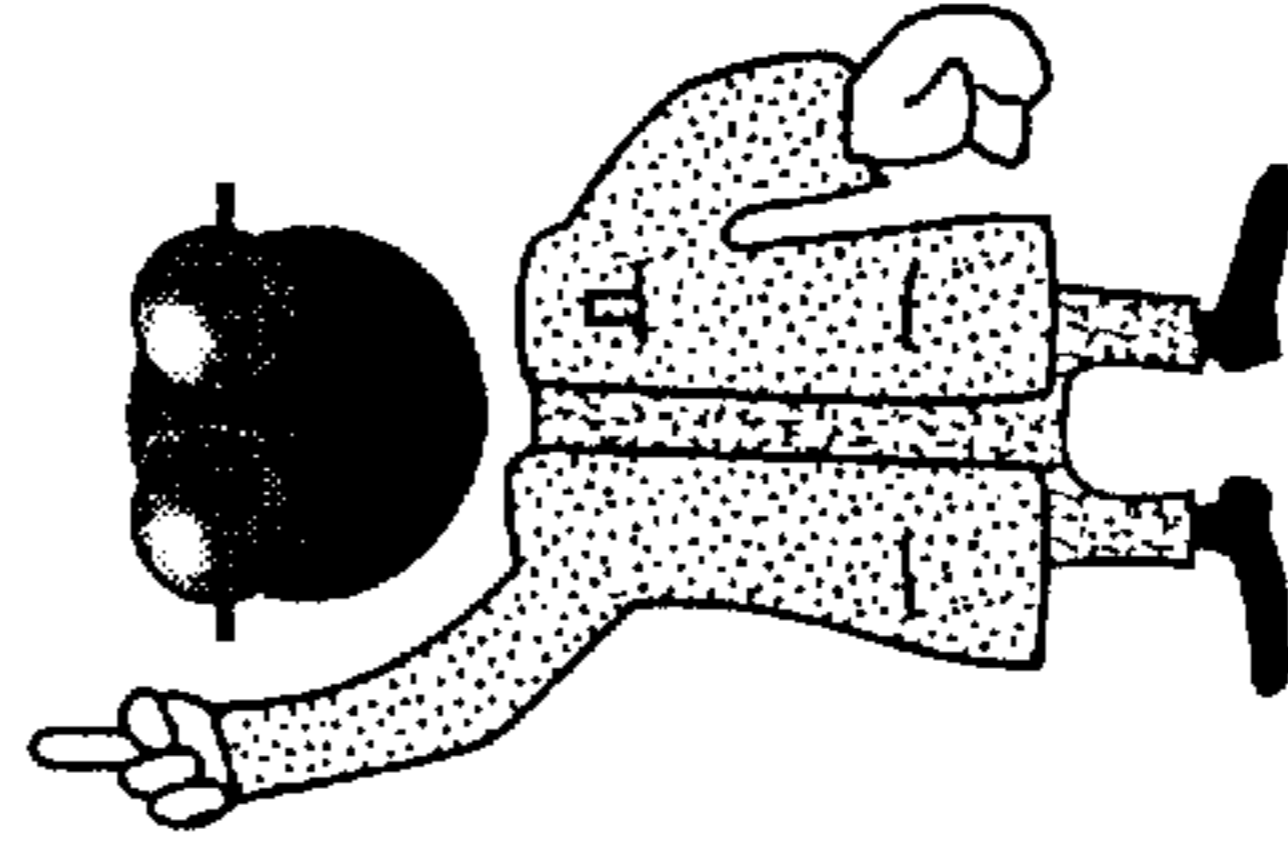

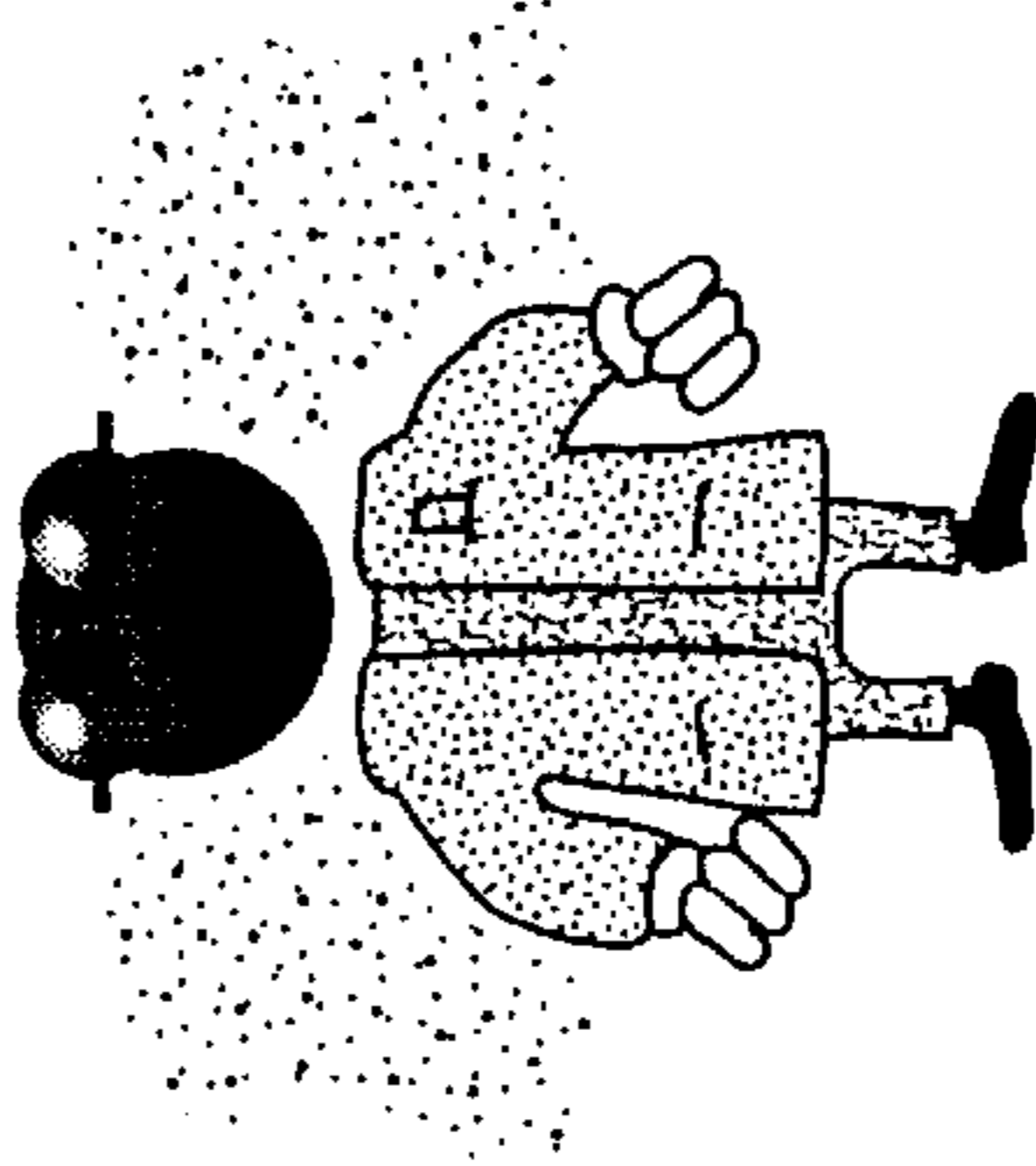

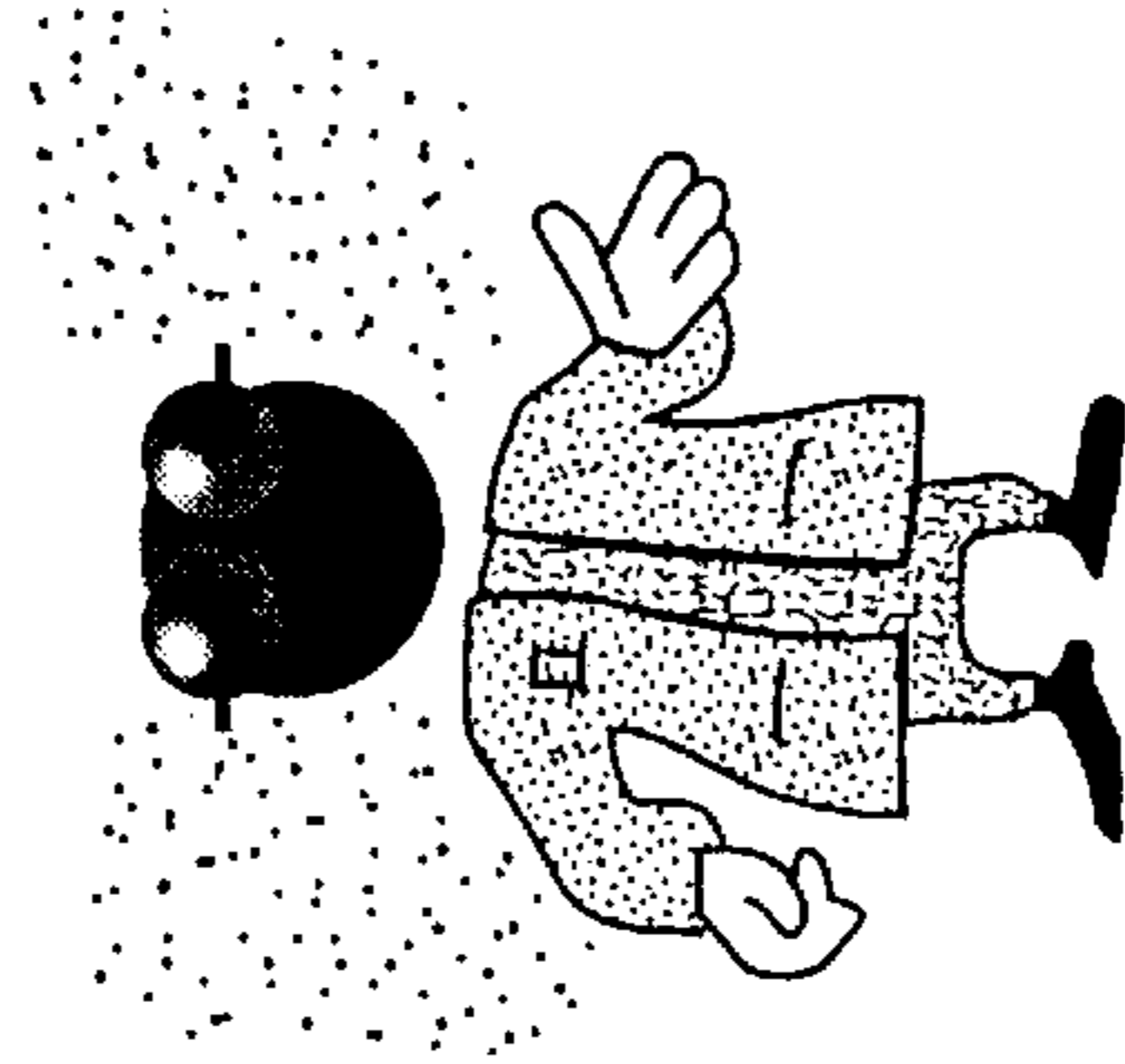

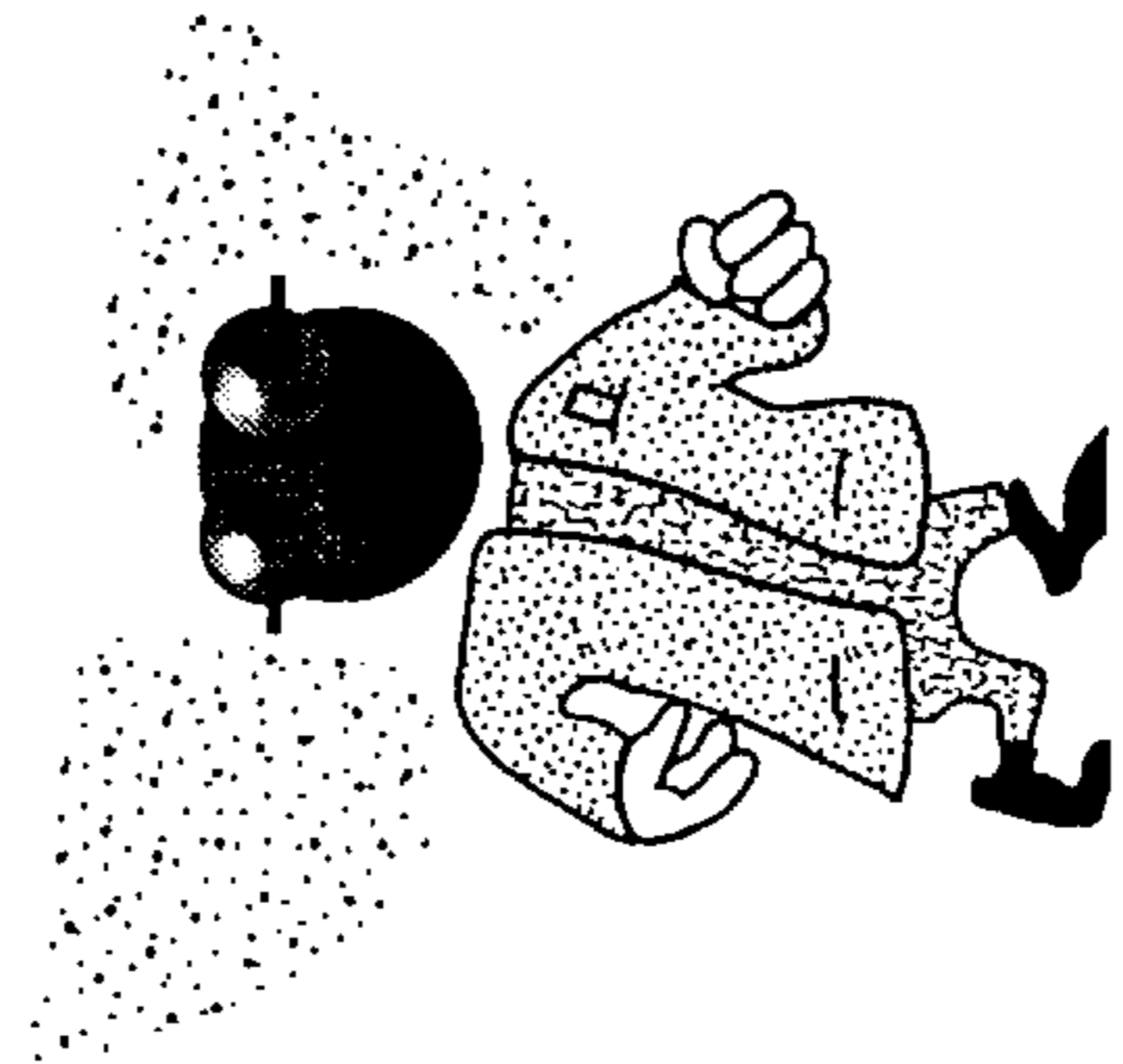

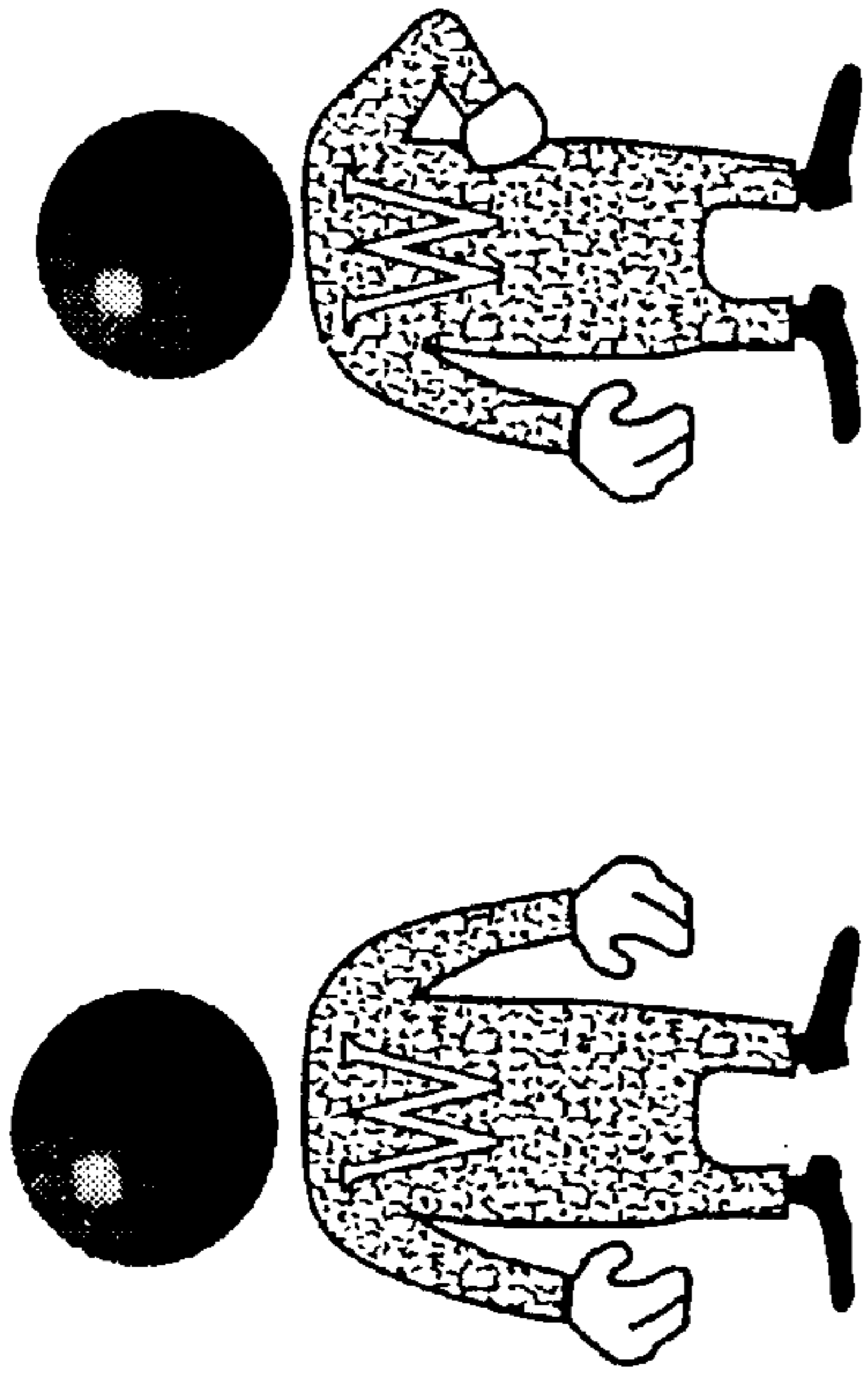

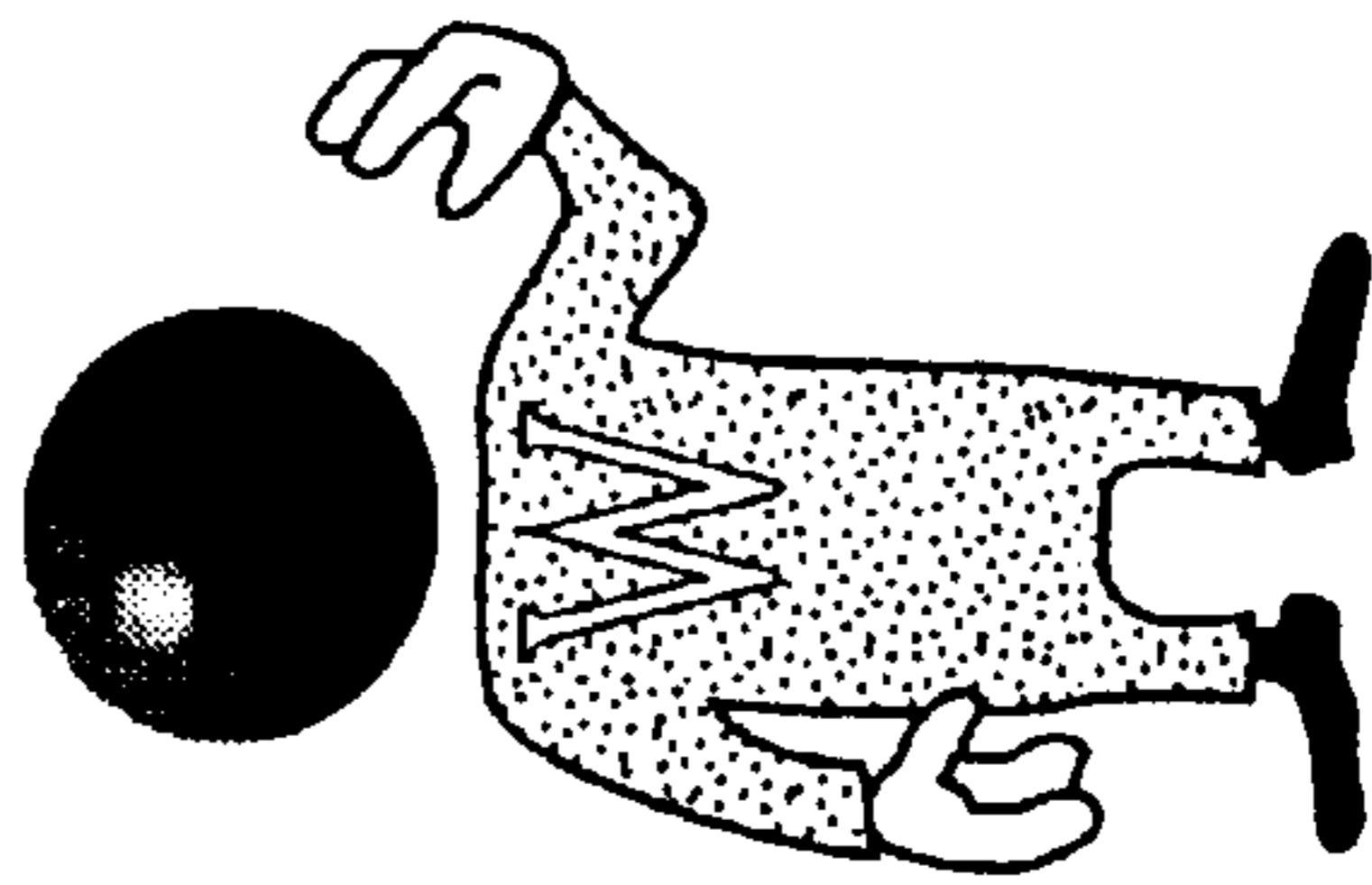

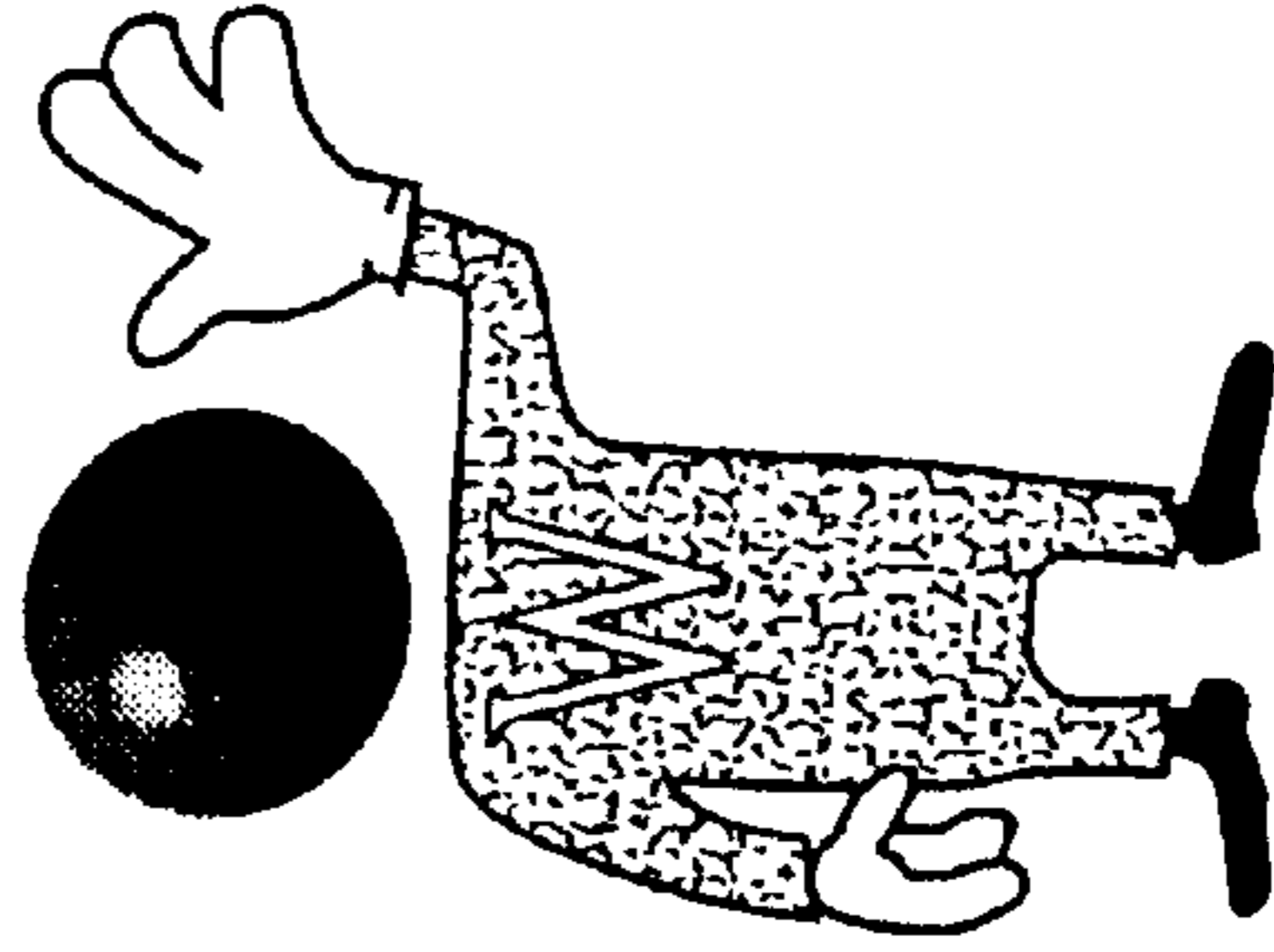
