### DESCRIPTION

FIG. 1 is a front, left side perspective view of a printer showing our new design;

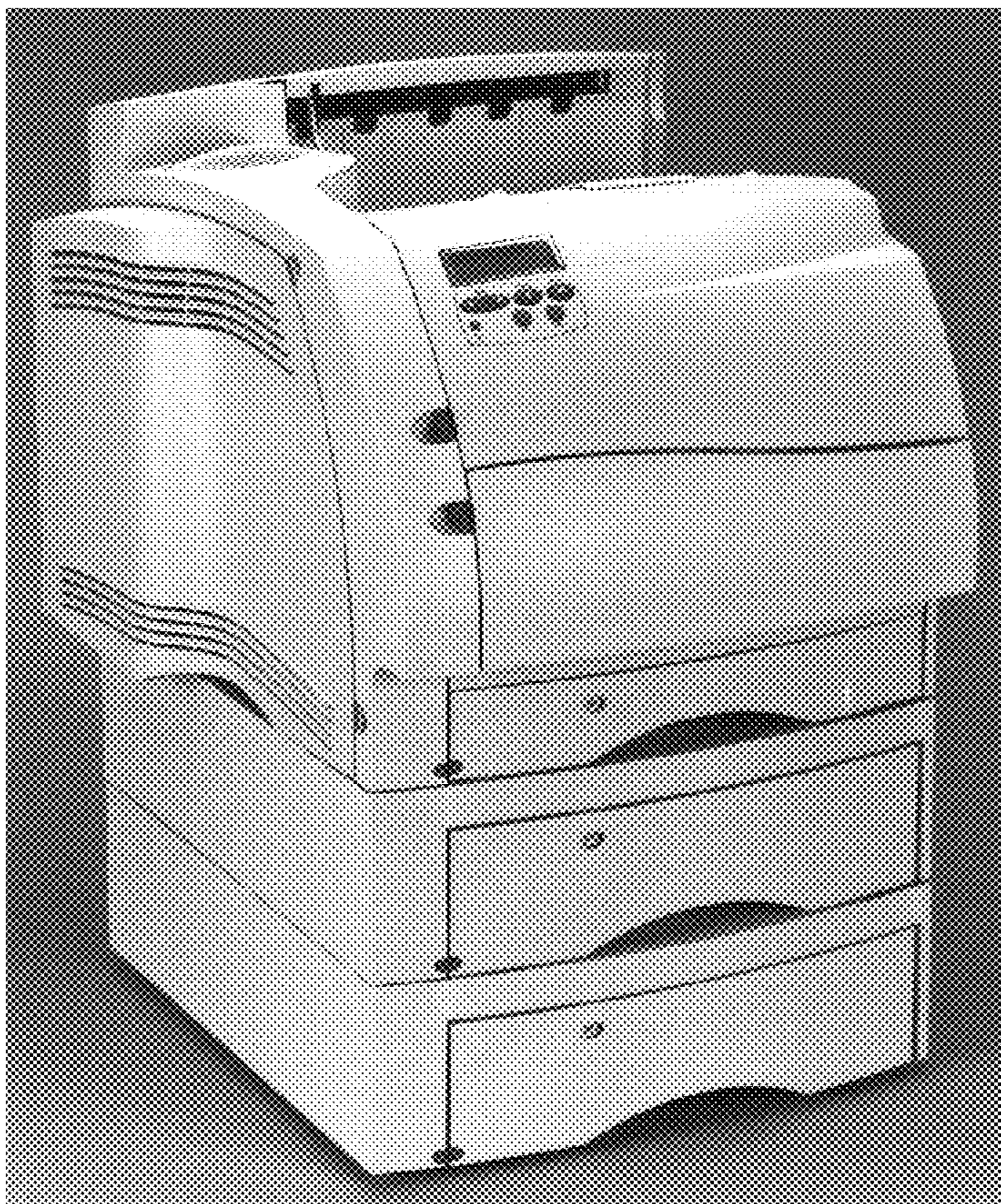

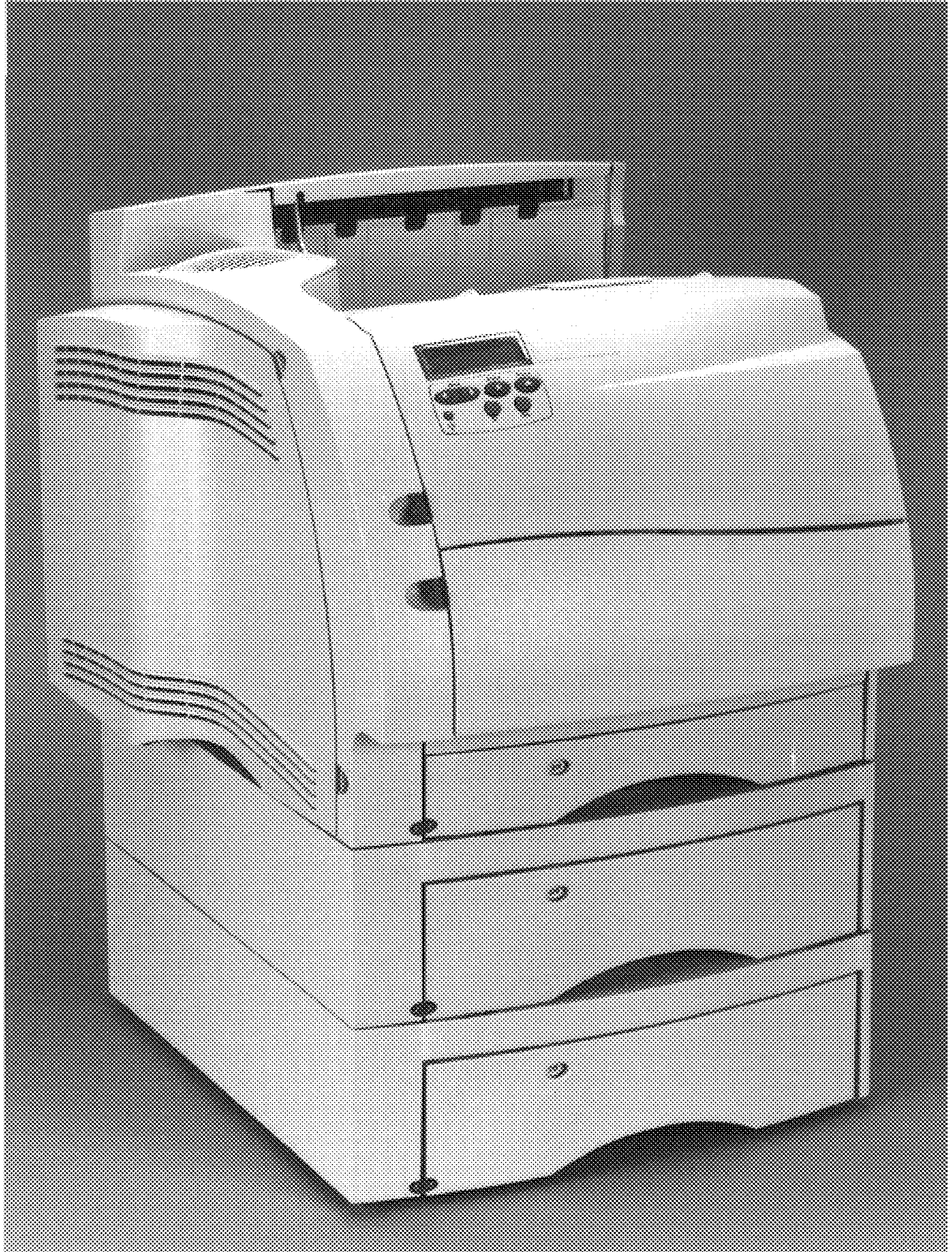

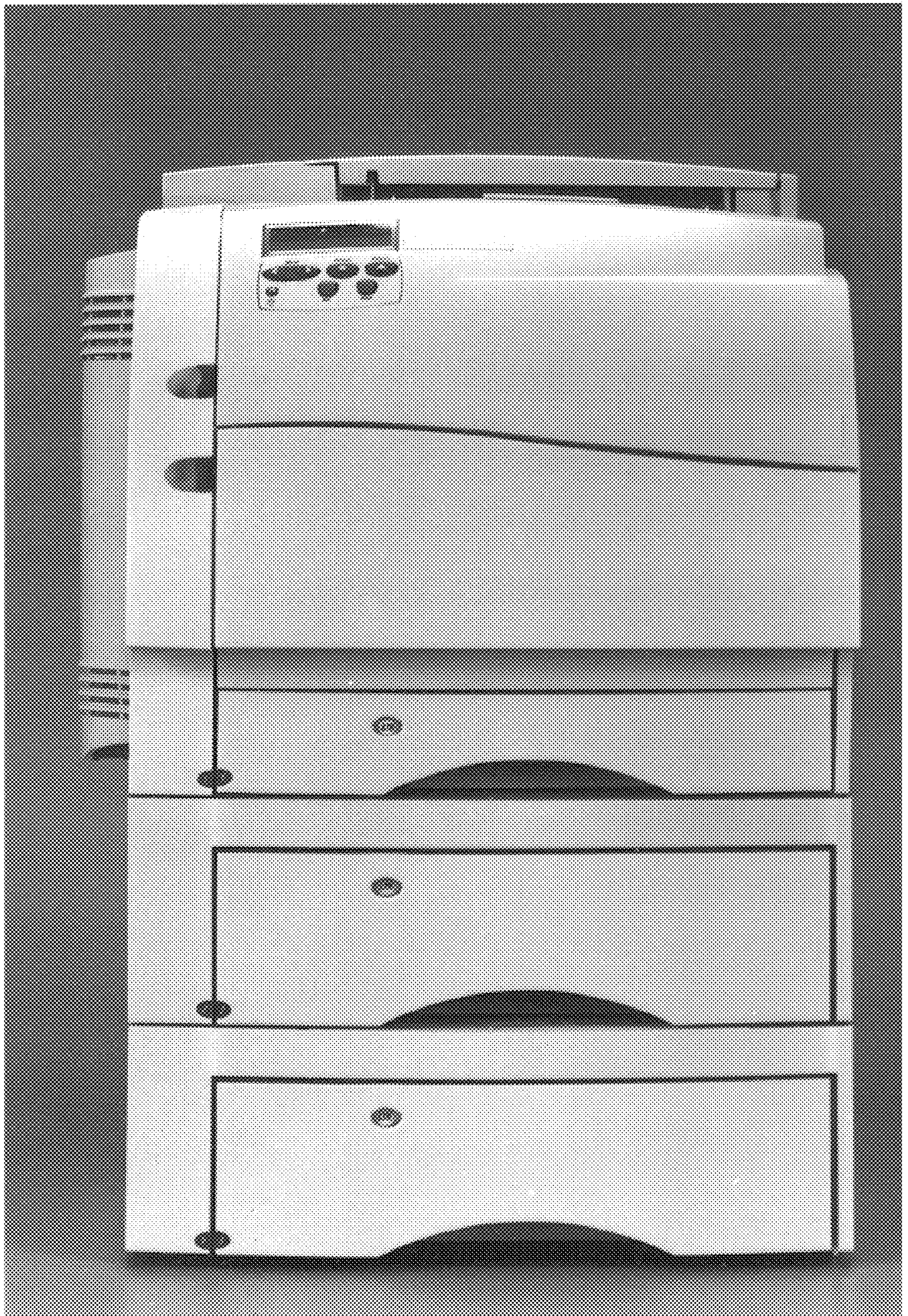

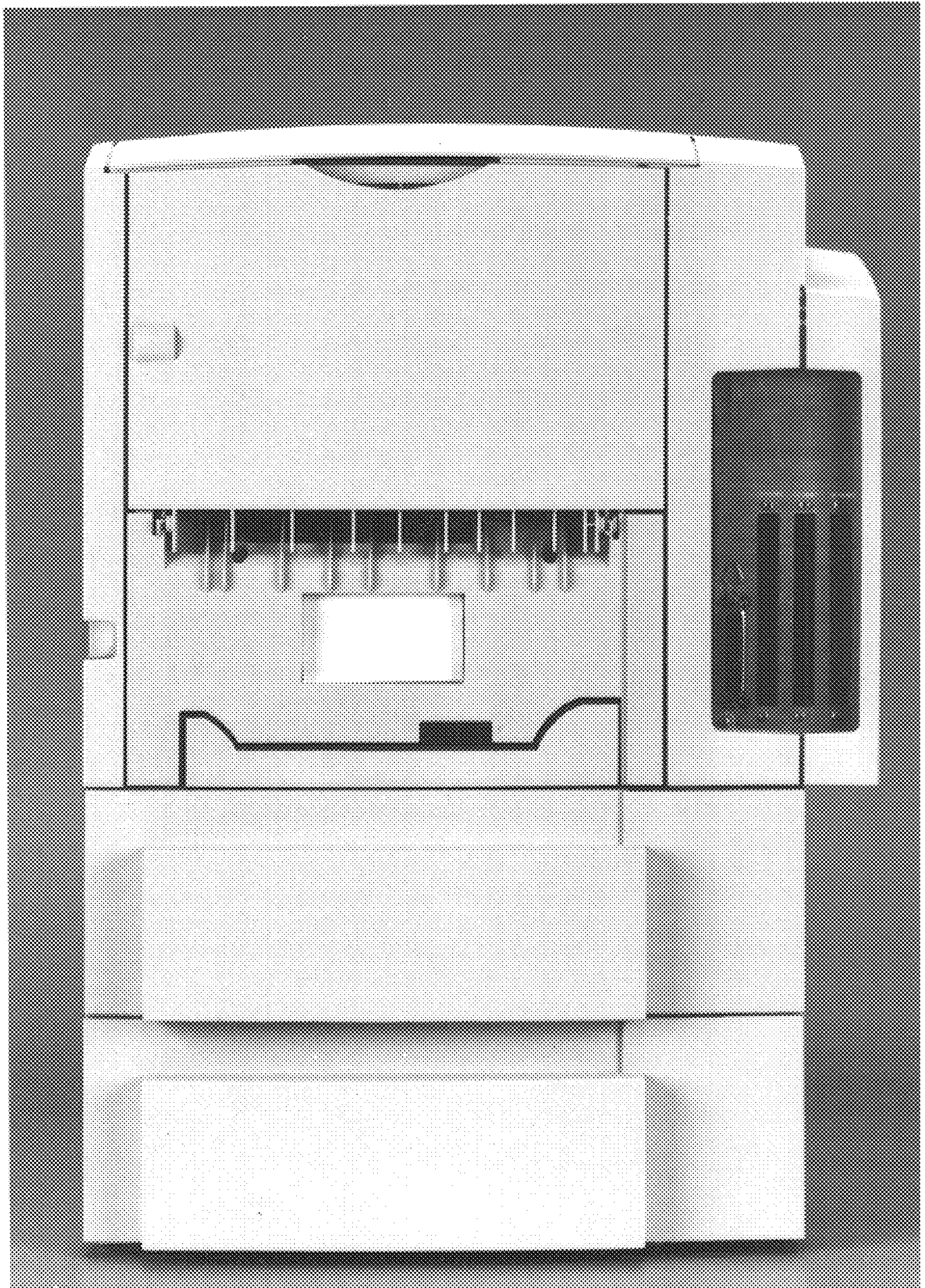

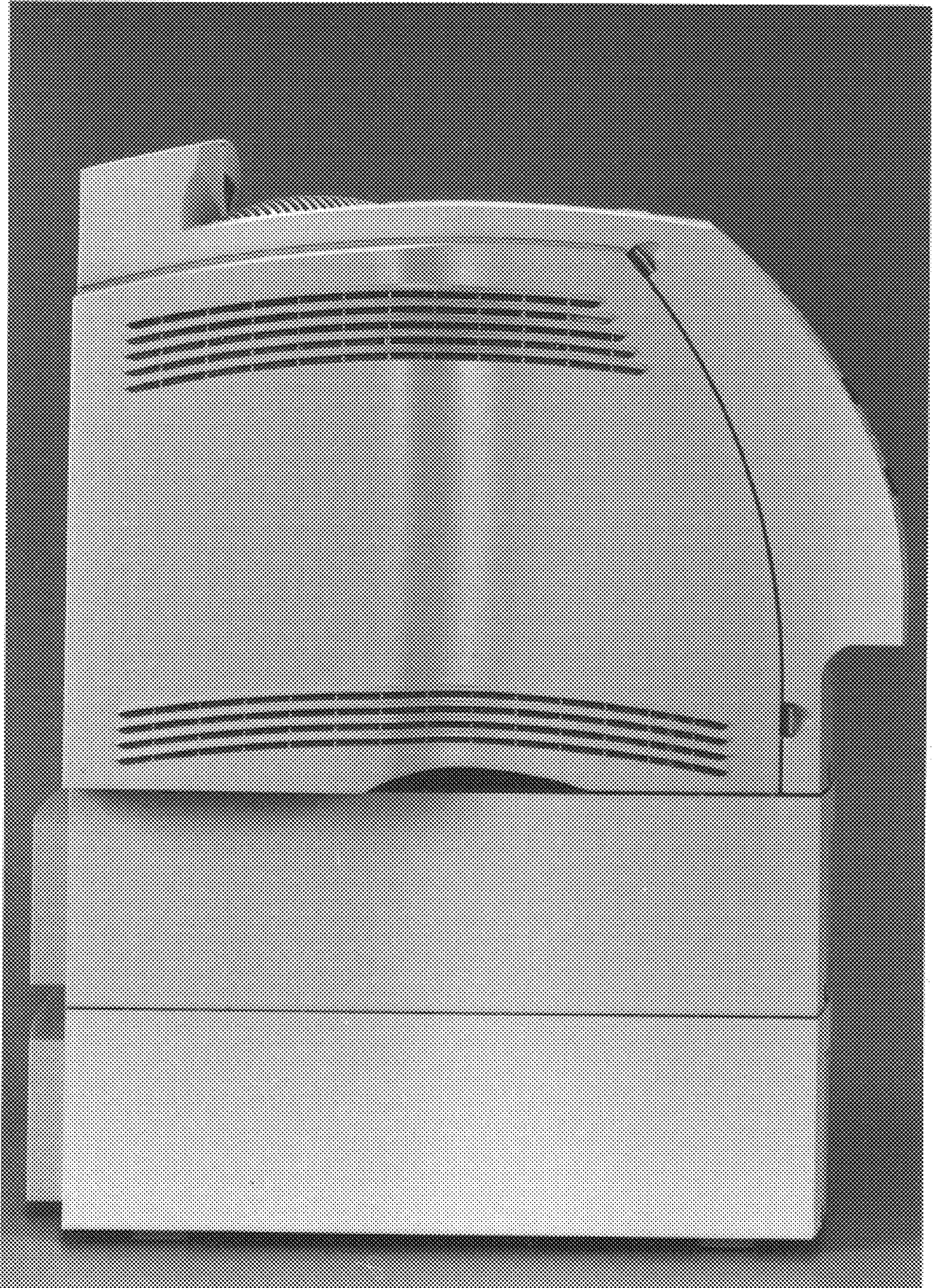

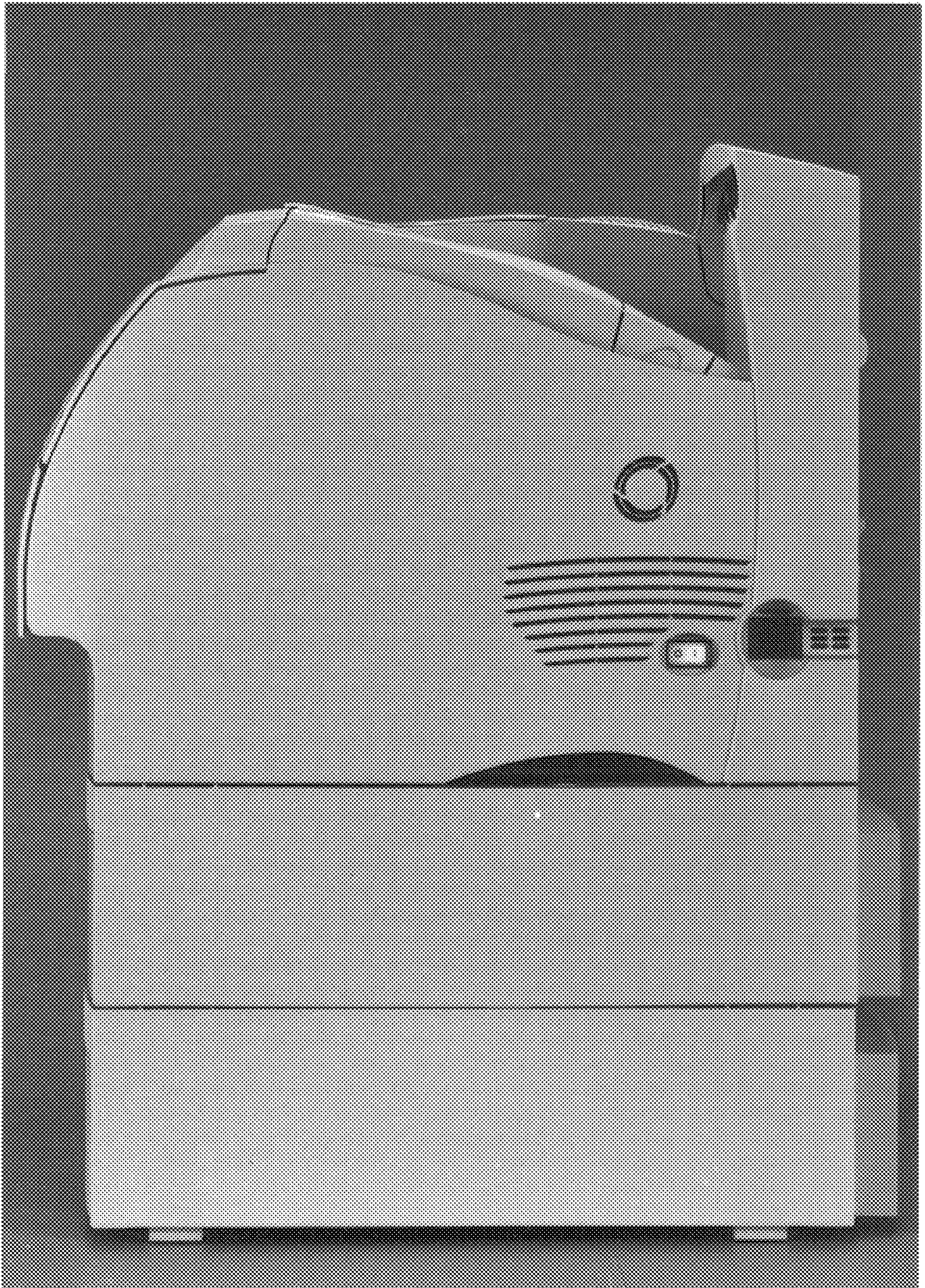
