[57] **CLAIM**

The ornamental design for a therapeutic support bandage for hot or cold therapy, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a second embodiment of my new design for a therapeutic support bandage for hot or cold therapy showing a printed pattern thereon and a hook fastener stitched adjacent the right end.

FIG. 2 is a rear elevational view of the therapeutic support bandage of FIG. 6;

FIG. 3 is a bottom plan view of the therapeutic support bandage of FIG. 6, of which the top plan view is a mirror image and is therefor not shown;

FIG. 4 is a left-end elevational view of the therapeutic support bandage of FIG. 6;

FIG. 5 is a right-end elevational view of the therapeutic support bandage of FIG. 6;

FIG. 6 is a front elevational view of a fifth embodiment of my new design for a therapeutic support bandage for hot or cold therapy showing a printed pattern thereon and hook fastener stitched adjacent the right end;

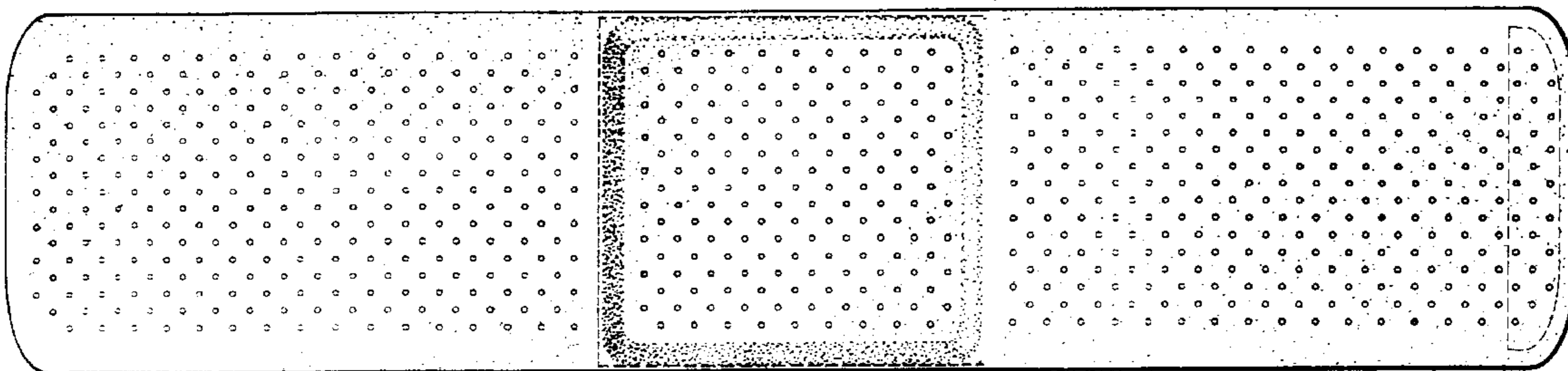
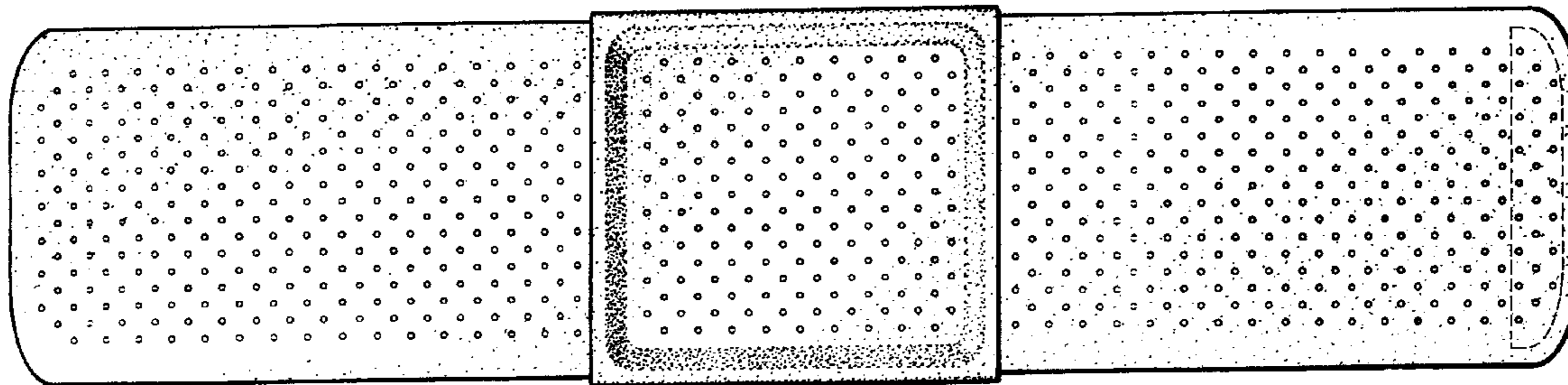
FIG. 7 is a rear elevational view of the therapeutic support bandage of FIG. 6;

FIG. 8 is a bottom plan view of the therapeutic support bandage of FIG. 6 of which the top plan view is a mirror image and is therefor not shown;

FIG. 9 is a left-end elevational view of the therapeutic support bandage of FIG. 6; and,

FIG. 10 is a right-end elevational view of the therapeutic support bandage of FIG. 6.

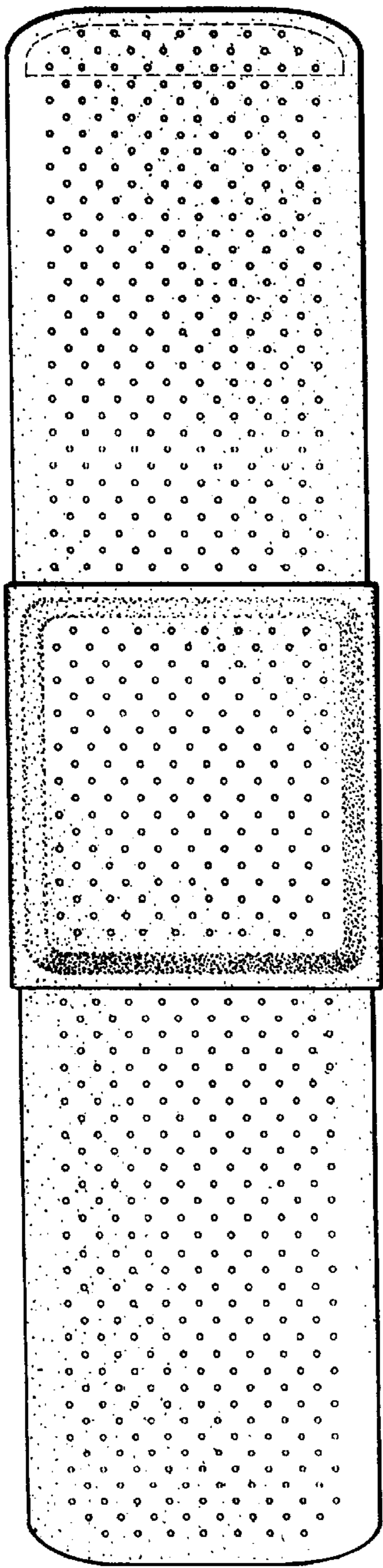

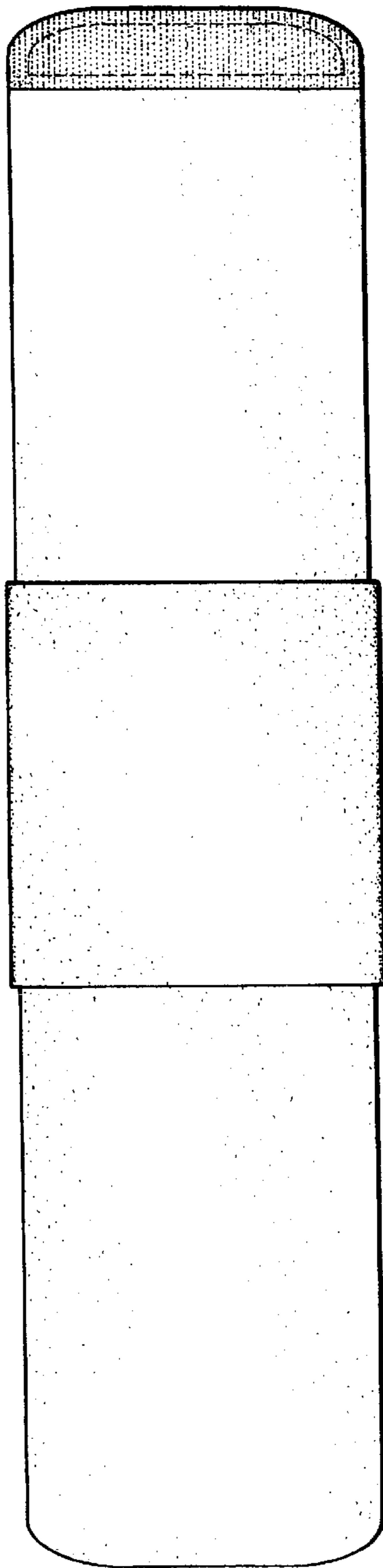

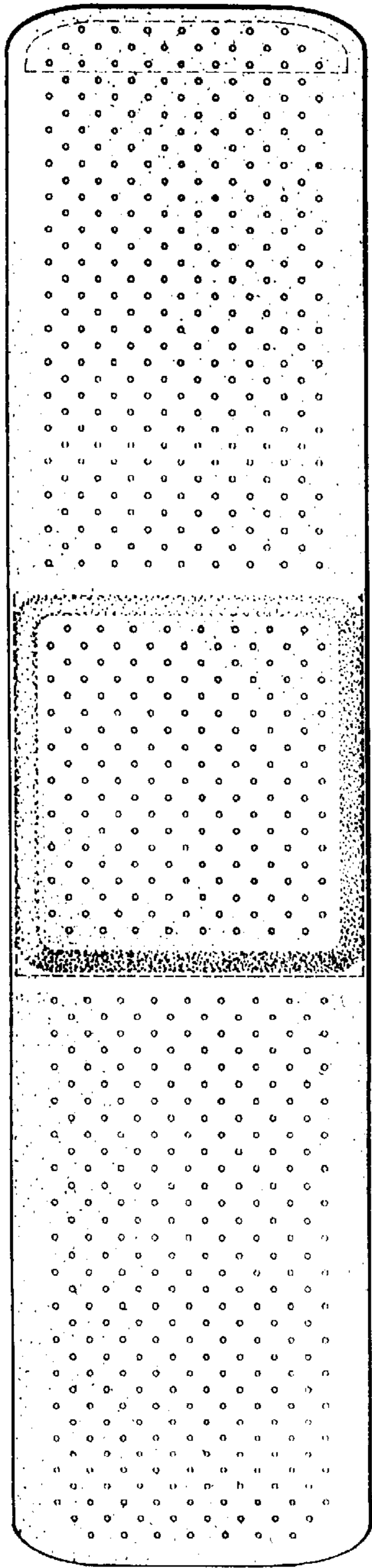

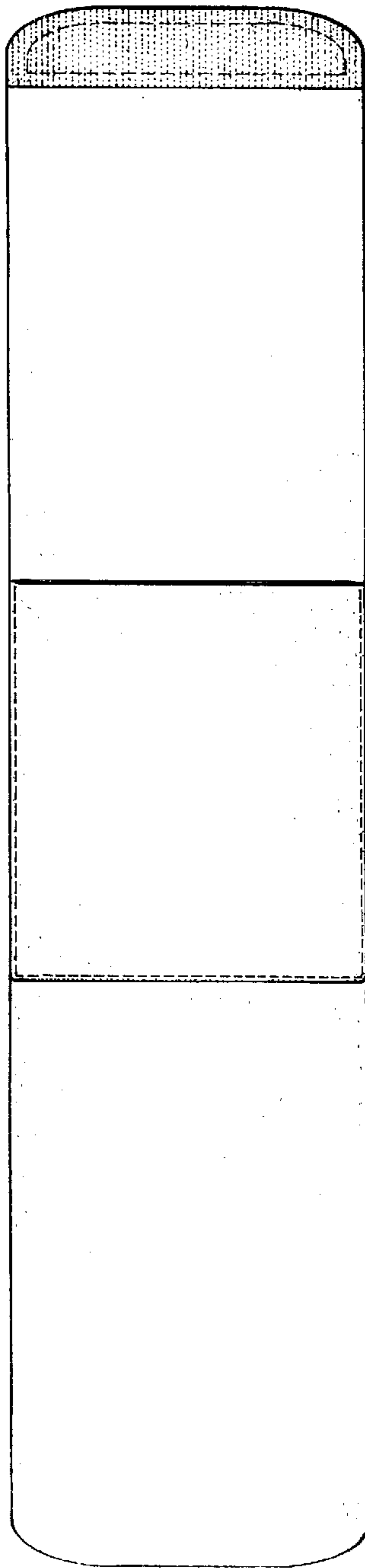
