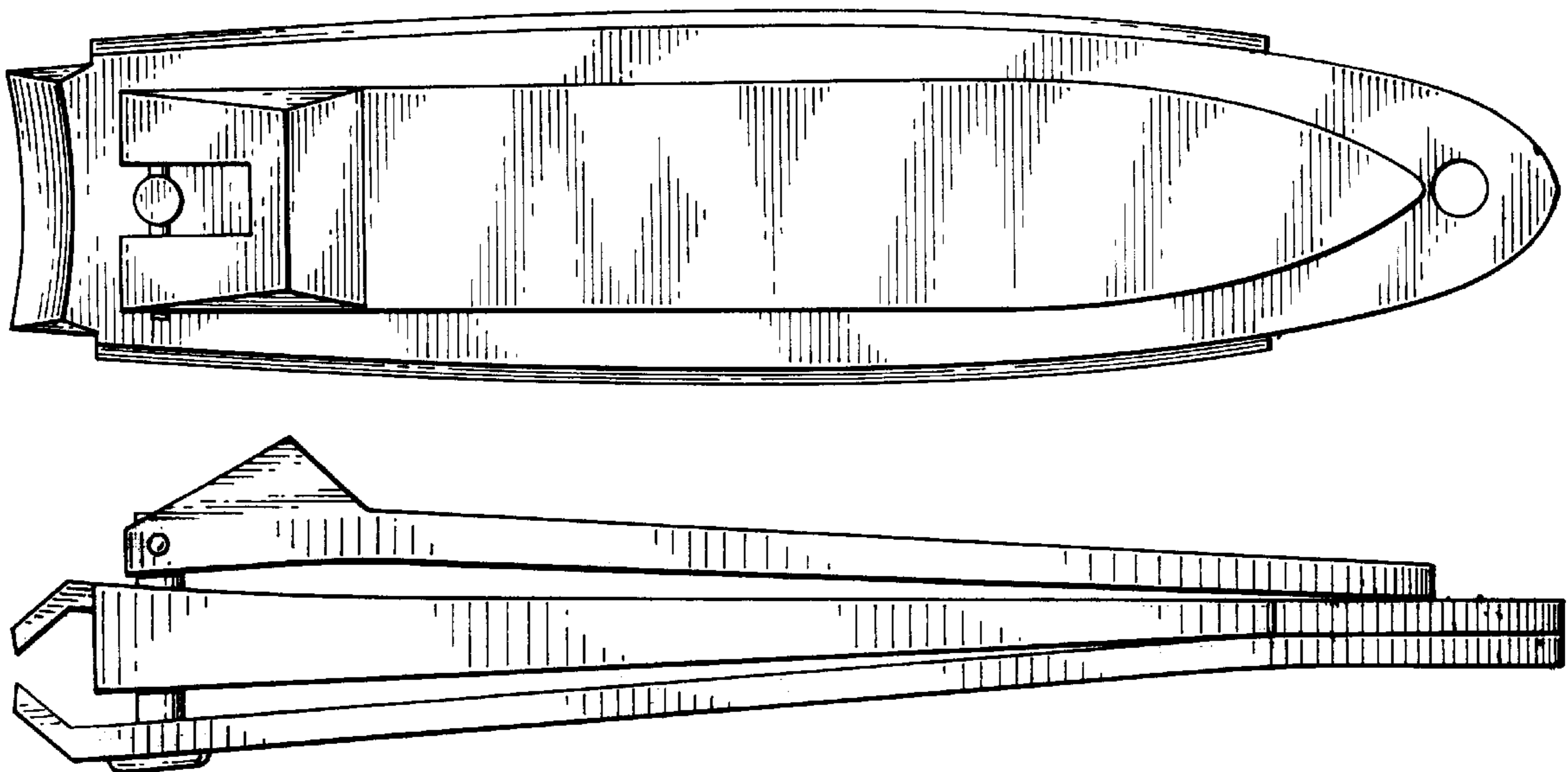
### [57] CLAIM

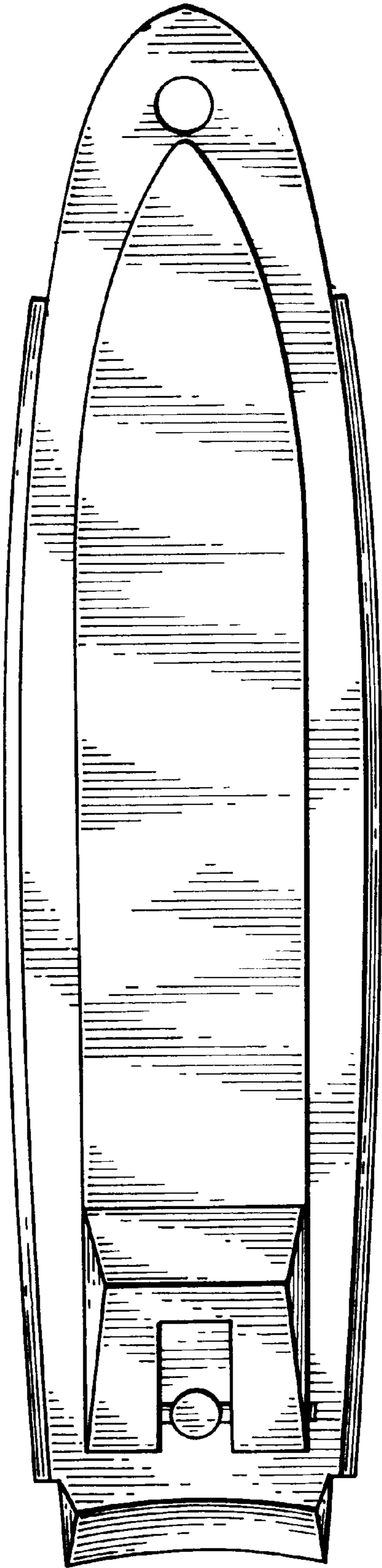
The ornamental design for a nail clipper, as shown and described.

### DESCRIPTION

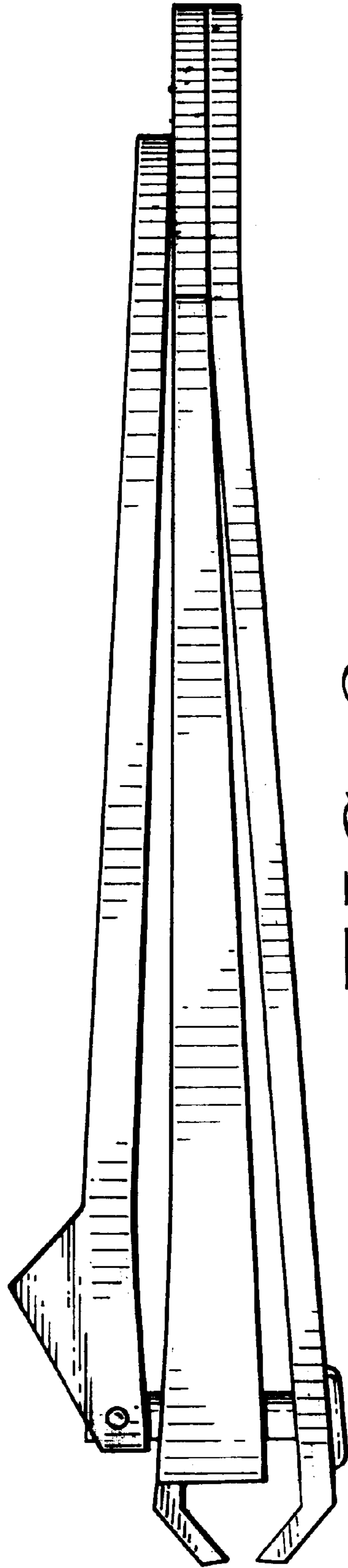
FIG. 1 is a top plan view of a nail clipper showing my new design;

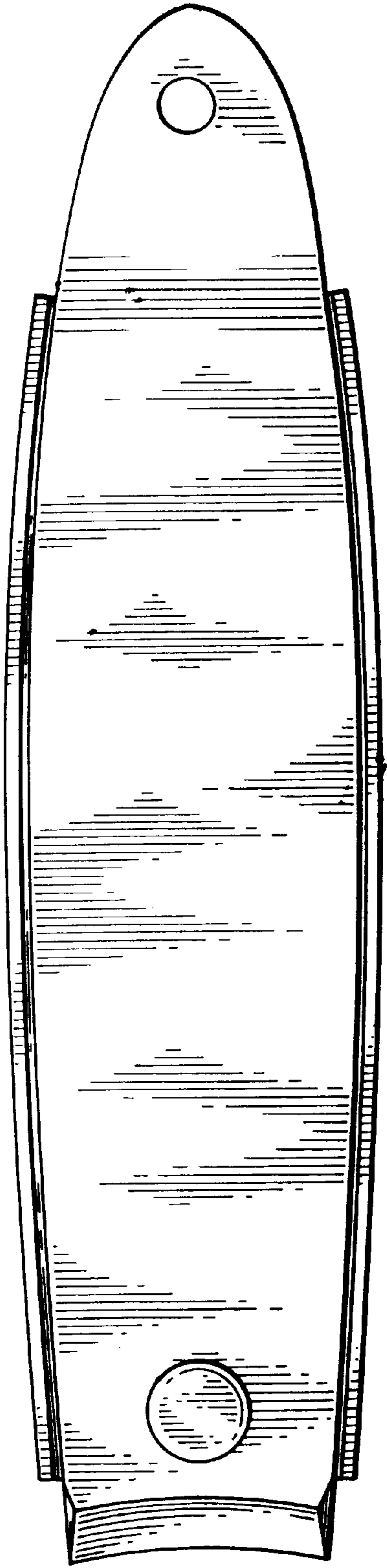




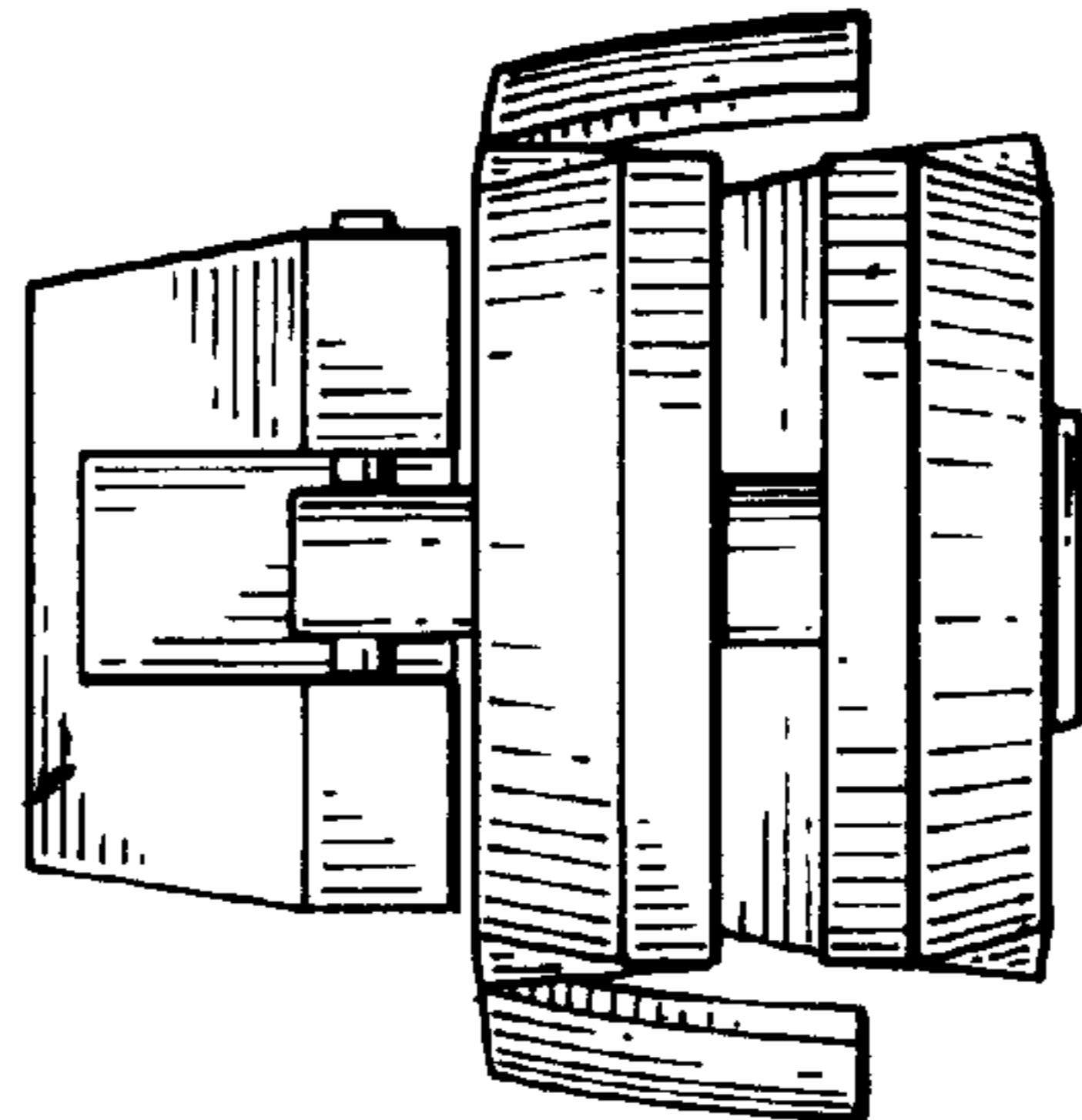
