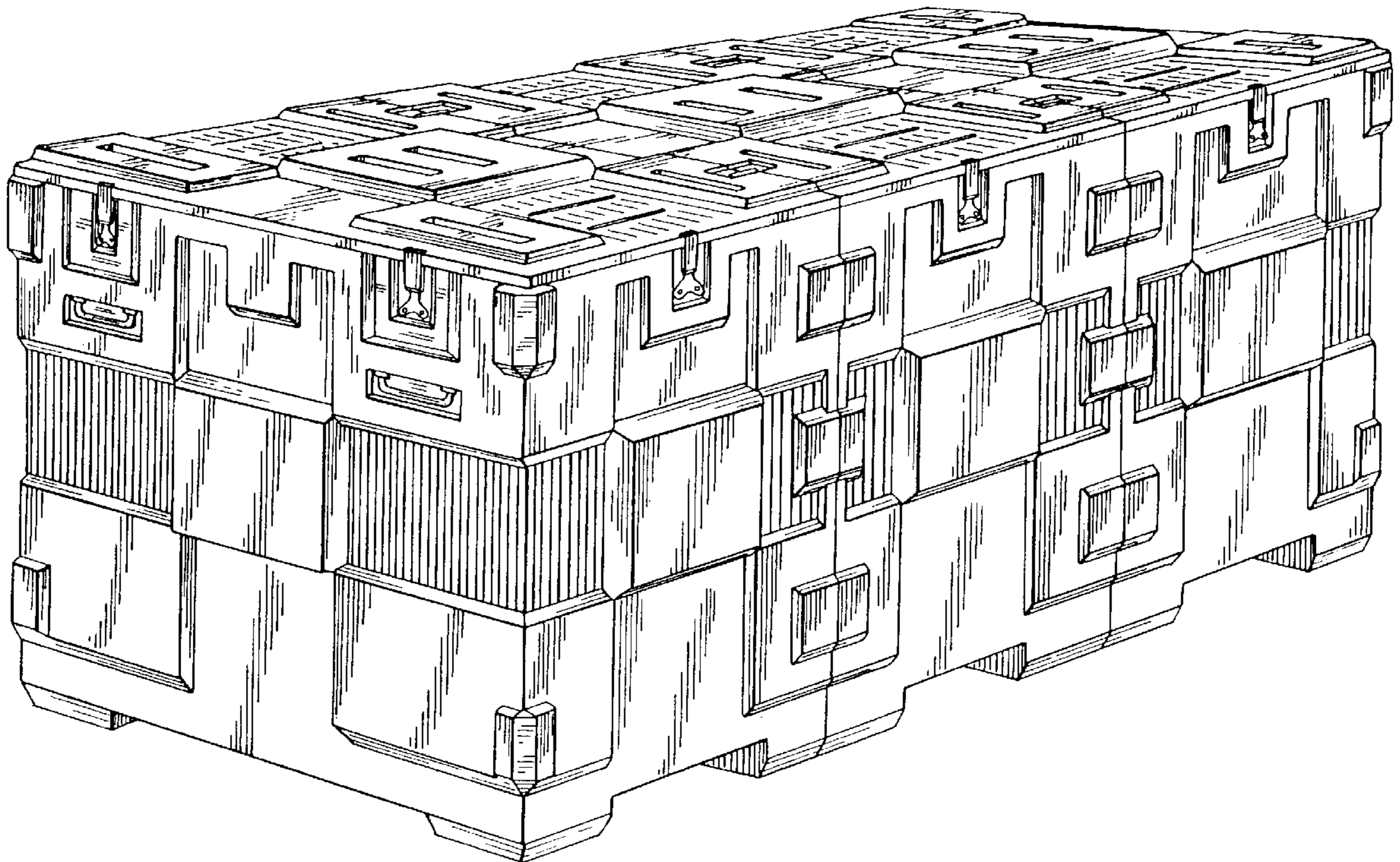
[57] CLAIM

The ornamental design for a shipping case, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a shipping case showing my new design;
FIG. 2 is a top left side elevational of the shipping case of FIG. 1, the right side being a mirror image thereof;
FIG. 3 is a rear elevational view thereof, the opposite end elevational view being identical; end
FIG. 4 is a top plan view, the bottom plan view being plain and unadorned.

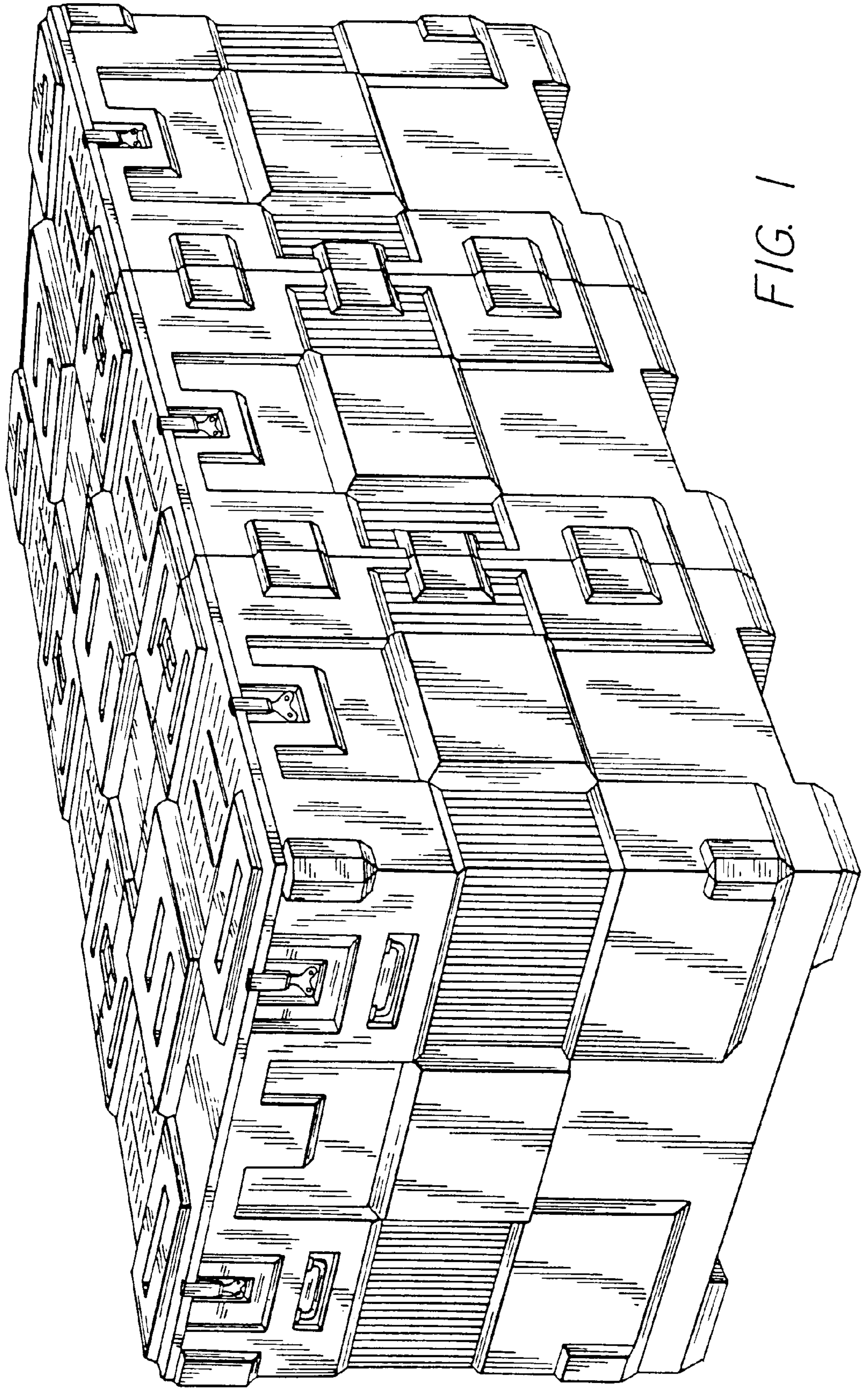

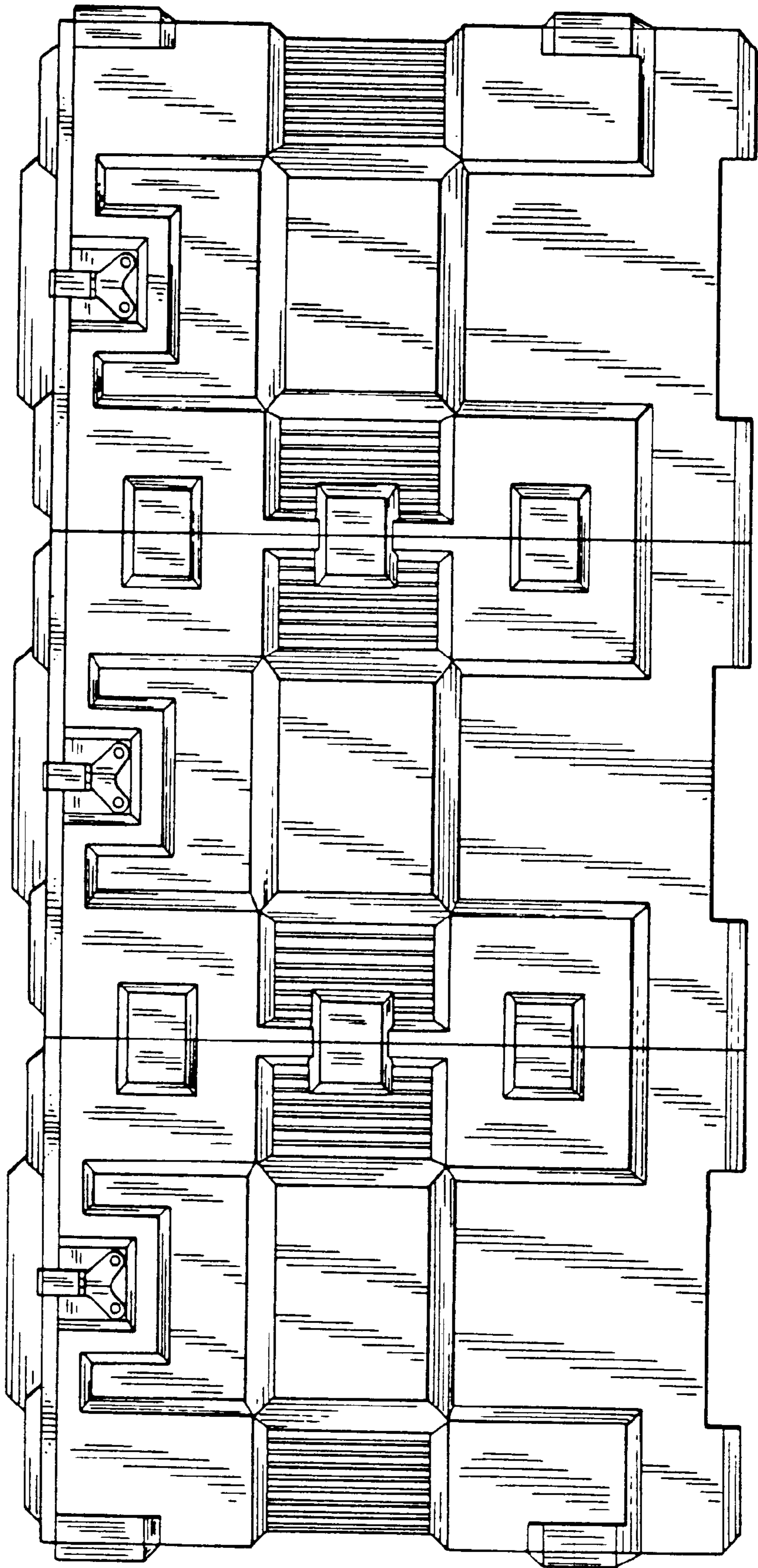

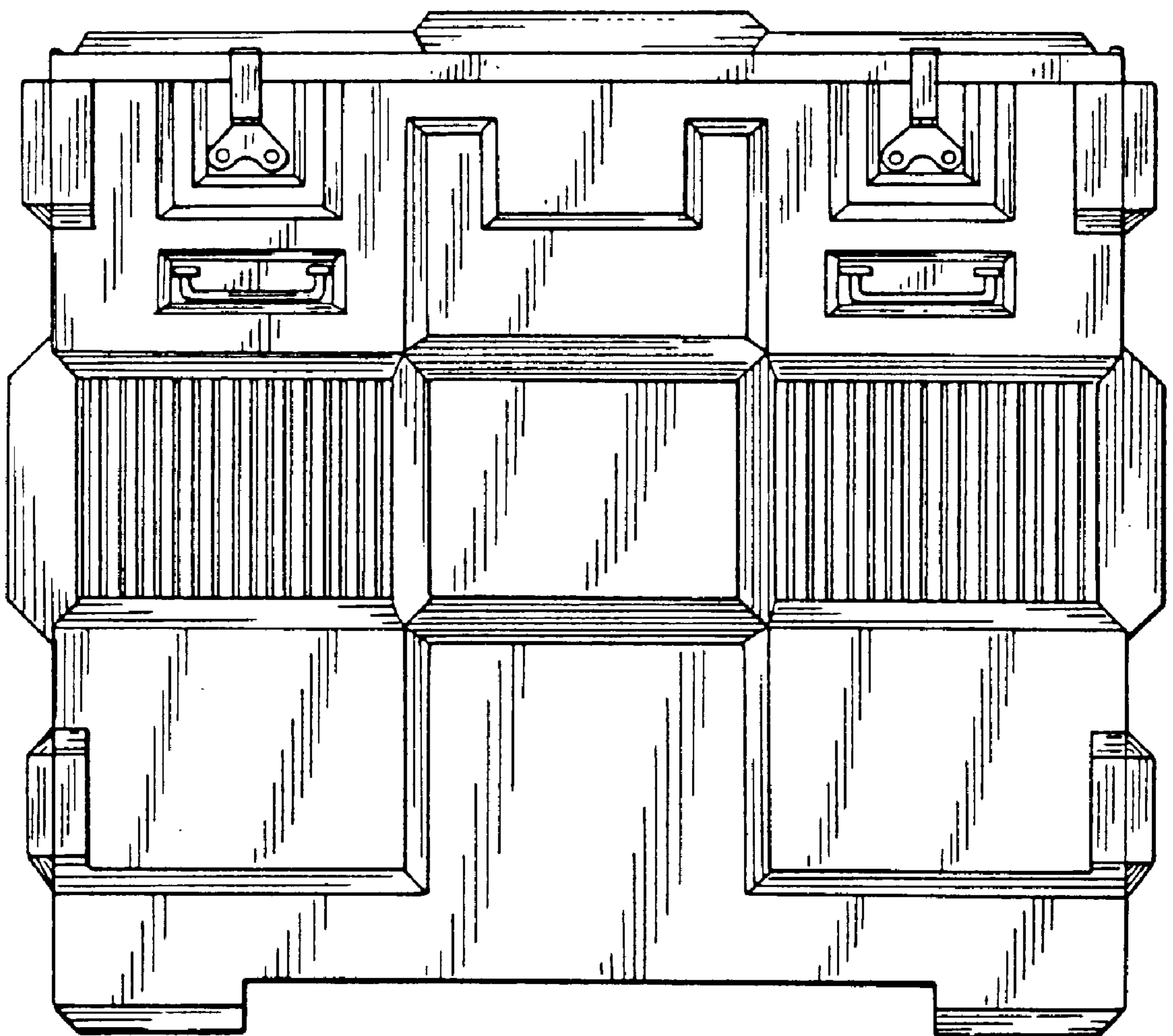
