FIG. 3 is a back view of the potted-plant jacket.

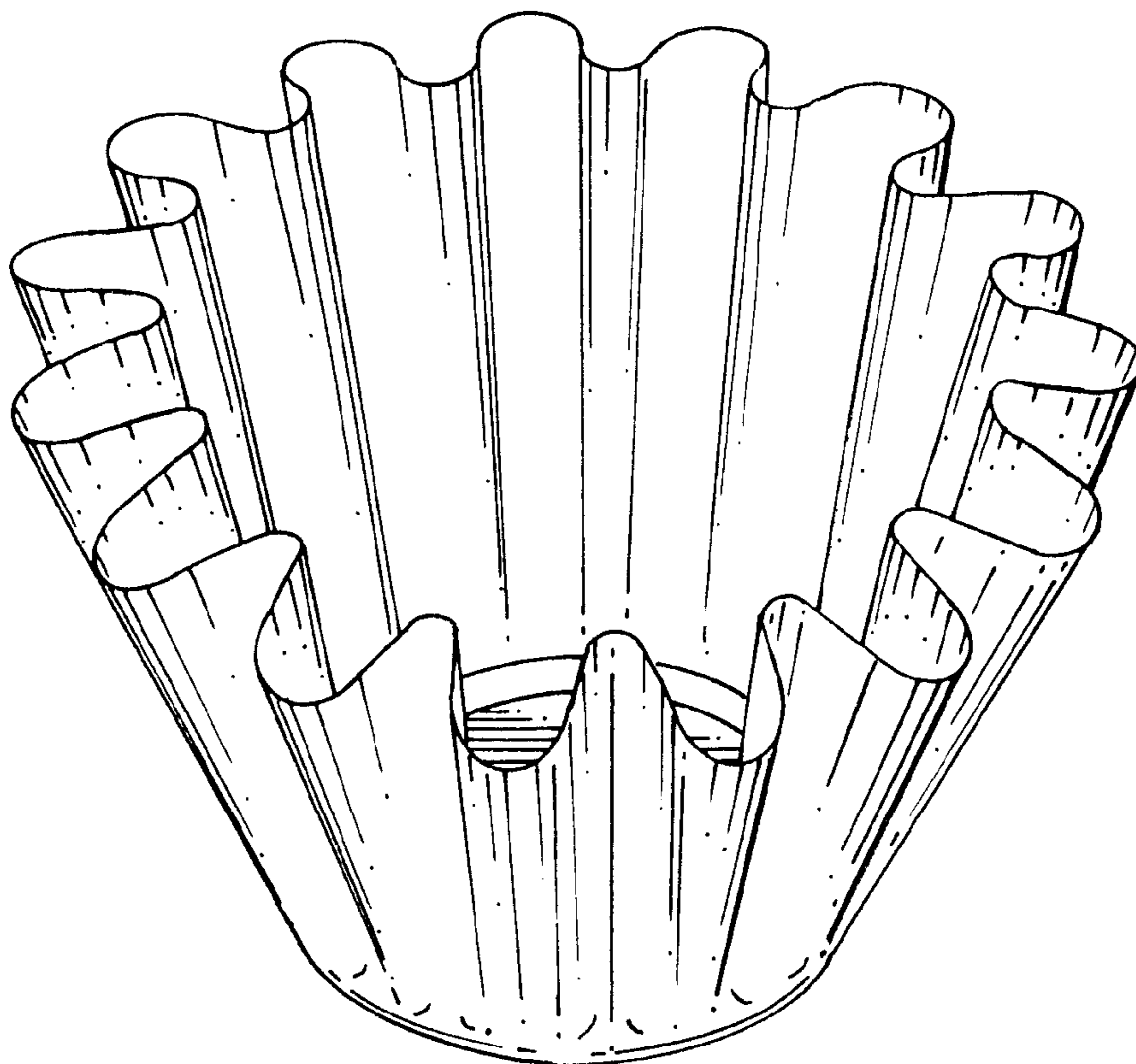
FIG. 4 is a left view of the potted-plant jacket.

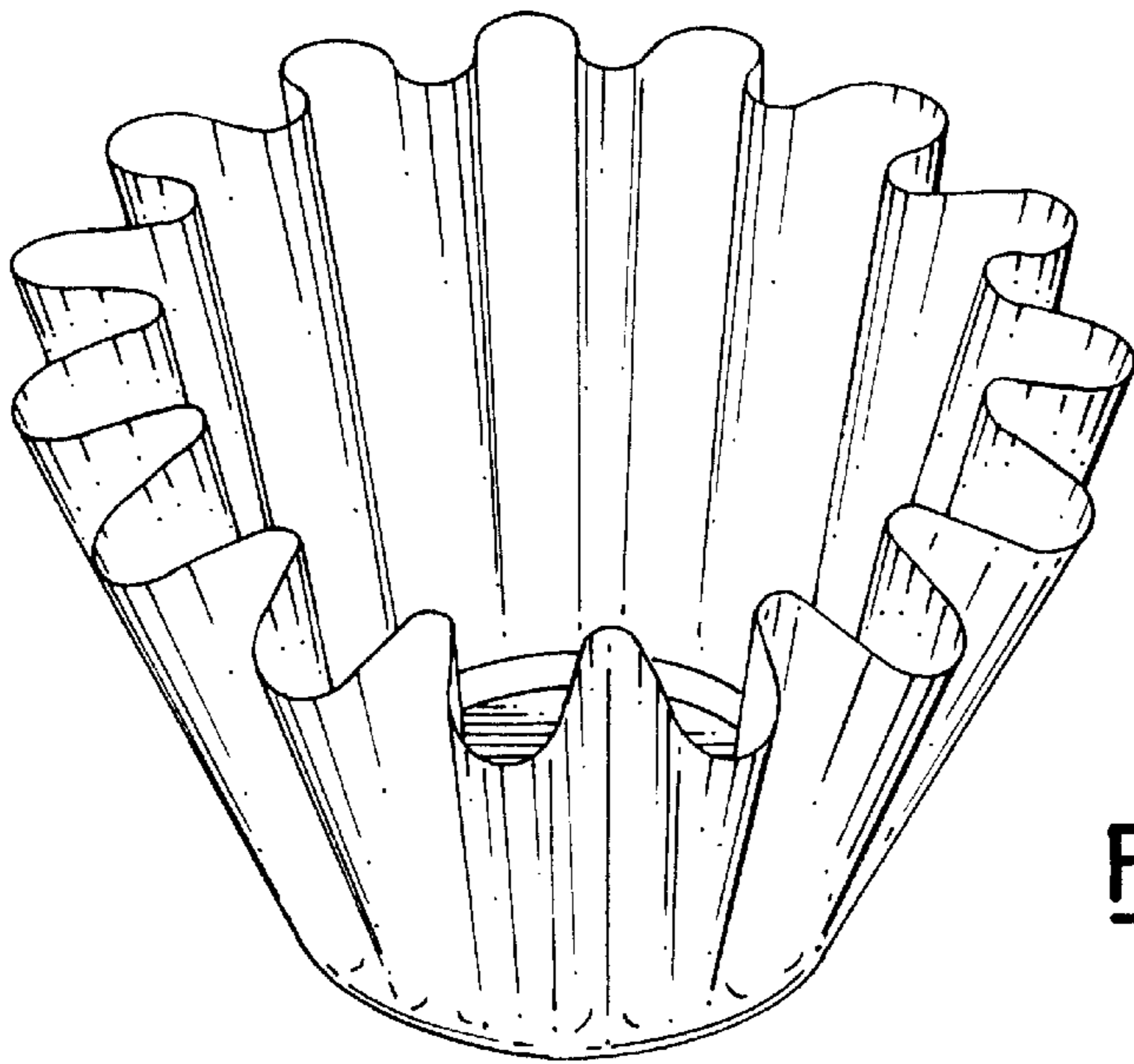

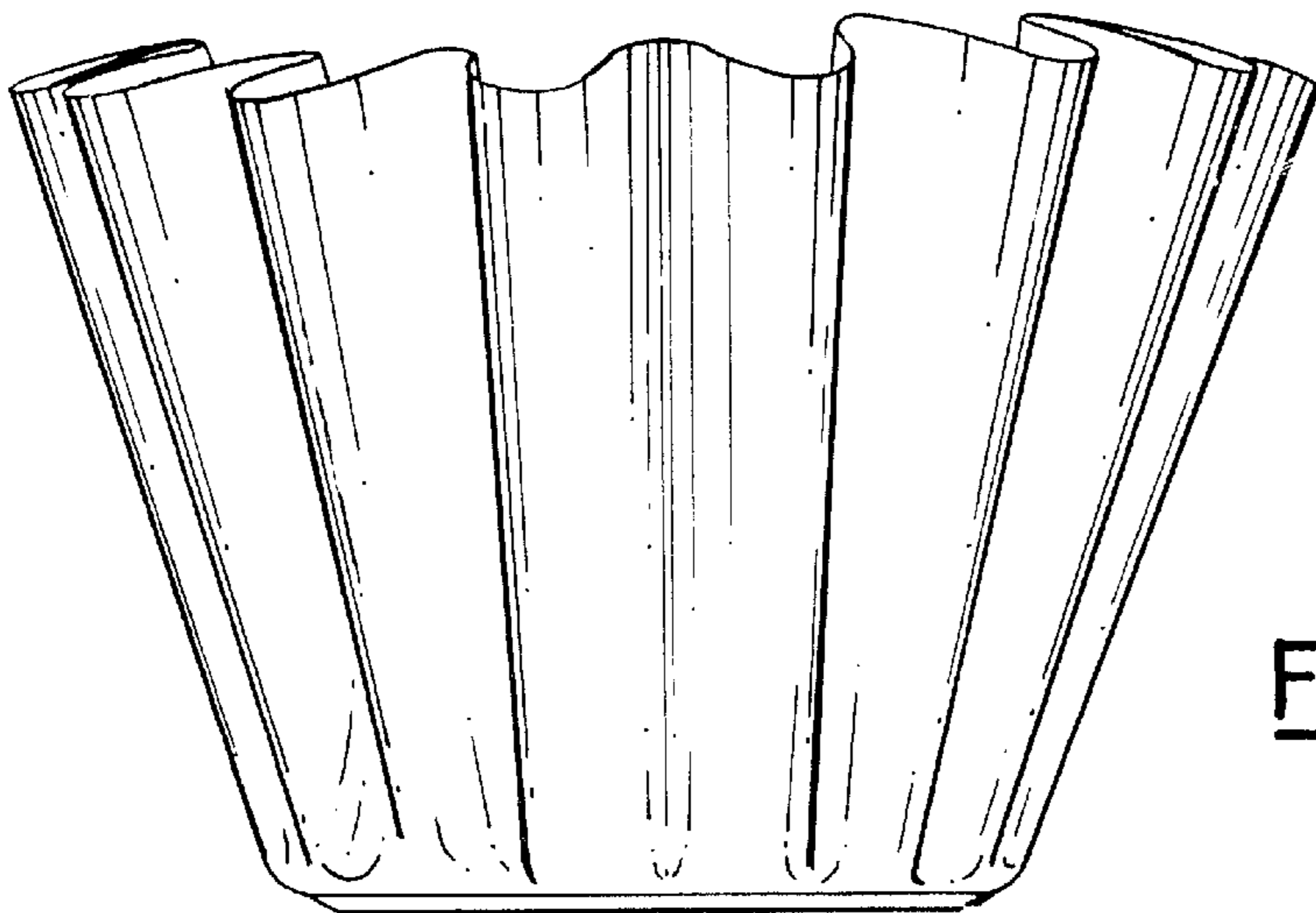
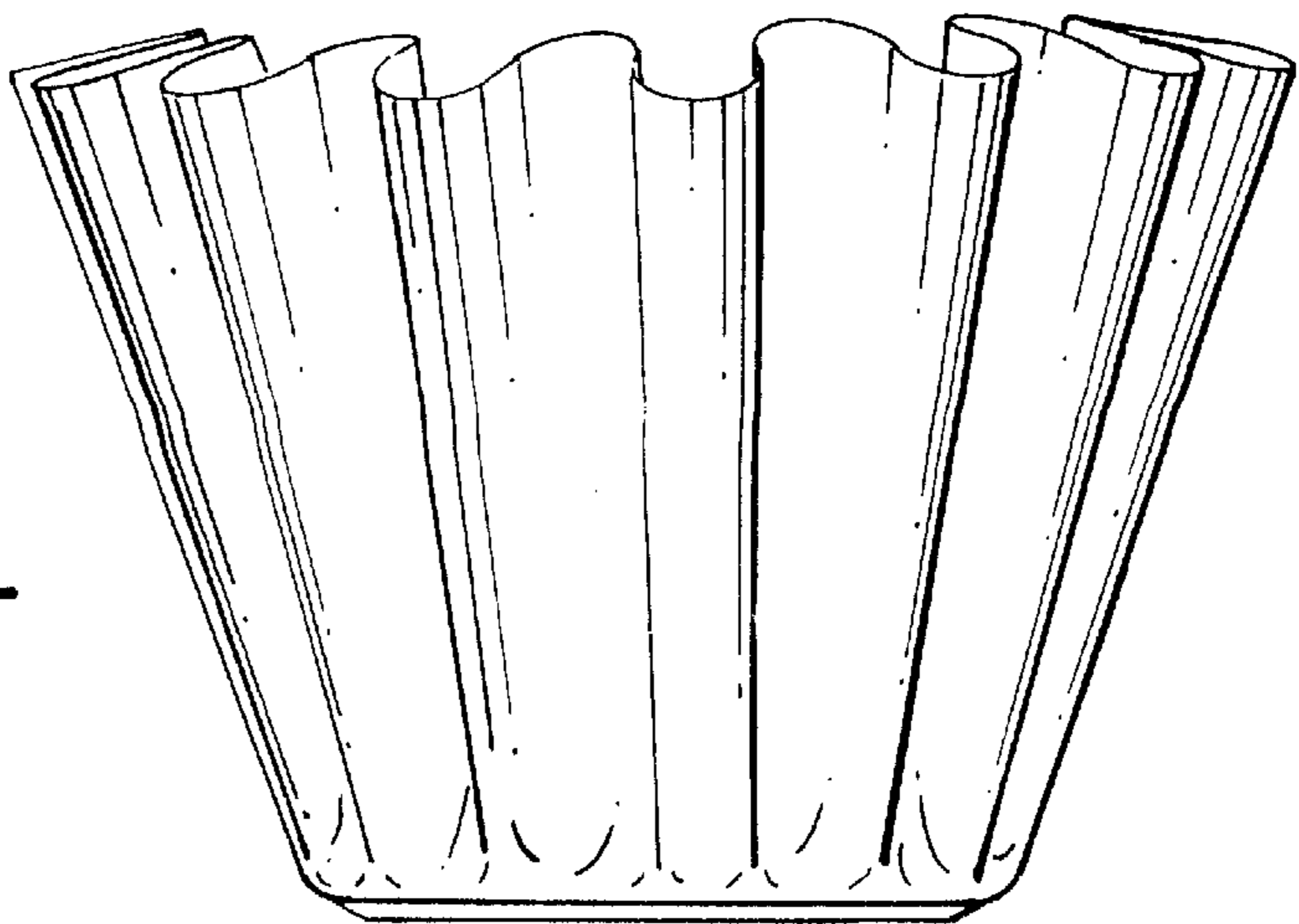

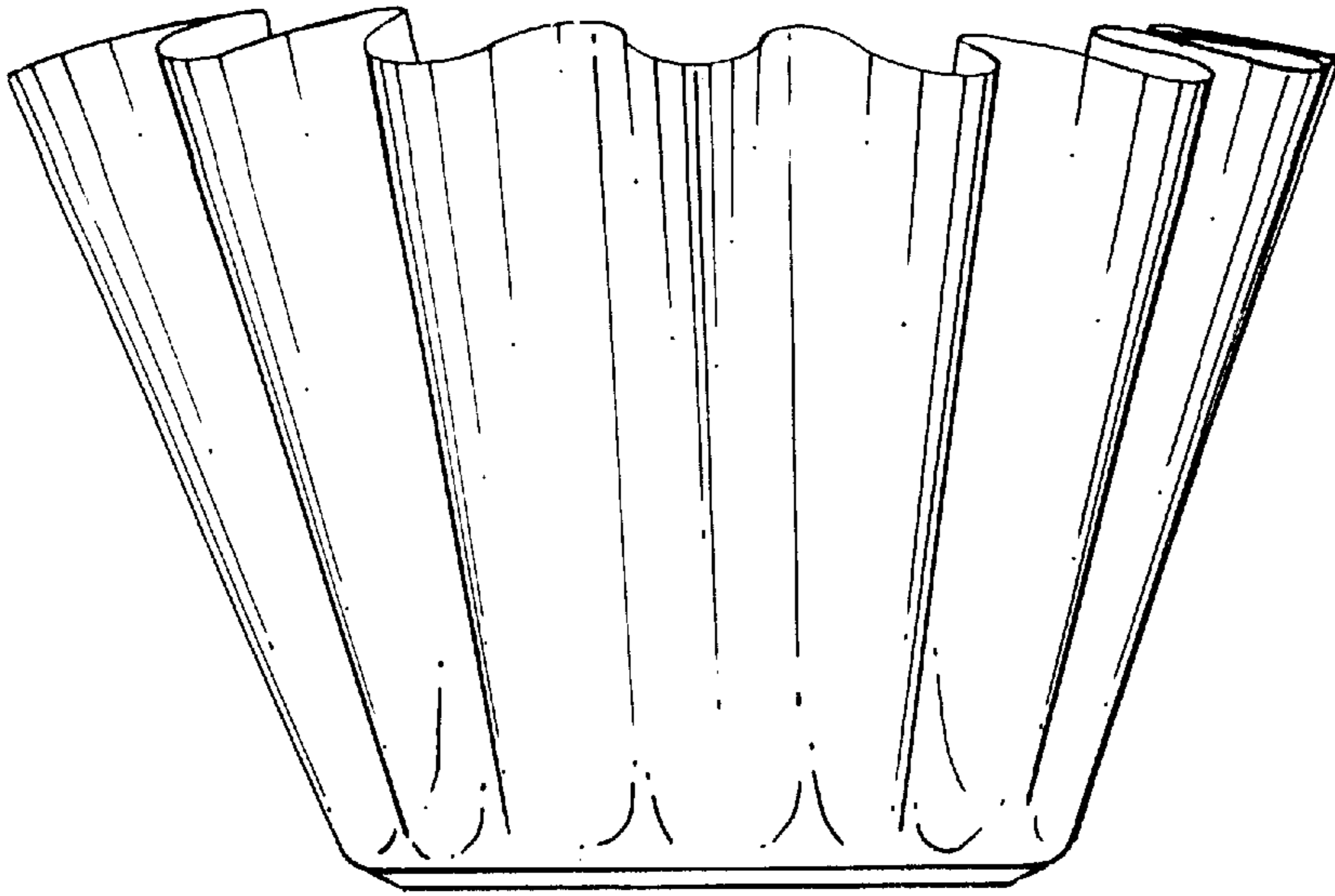

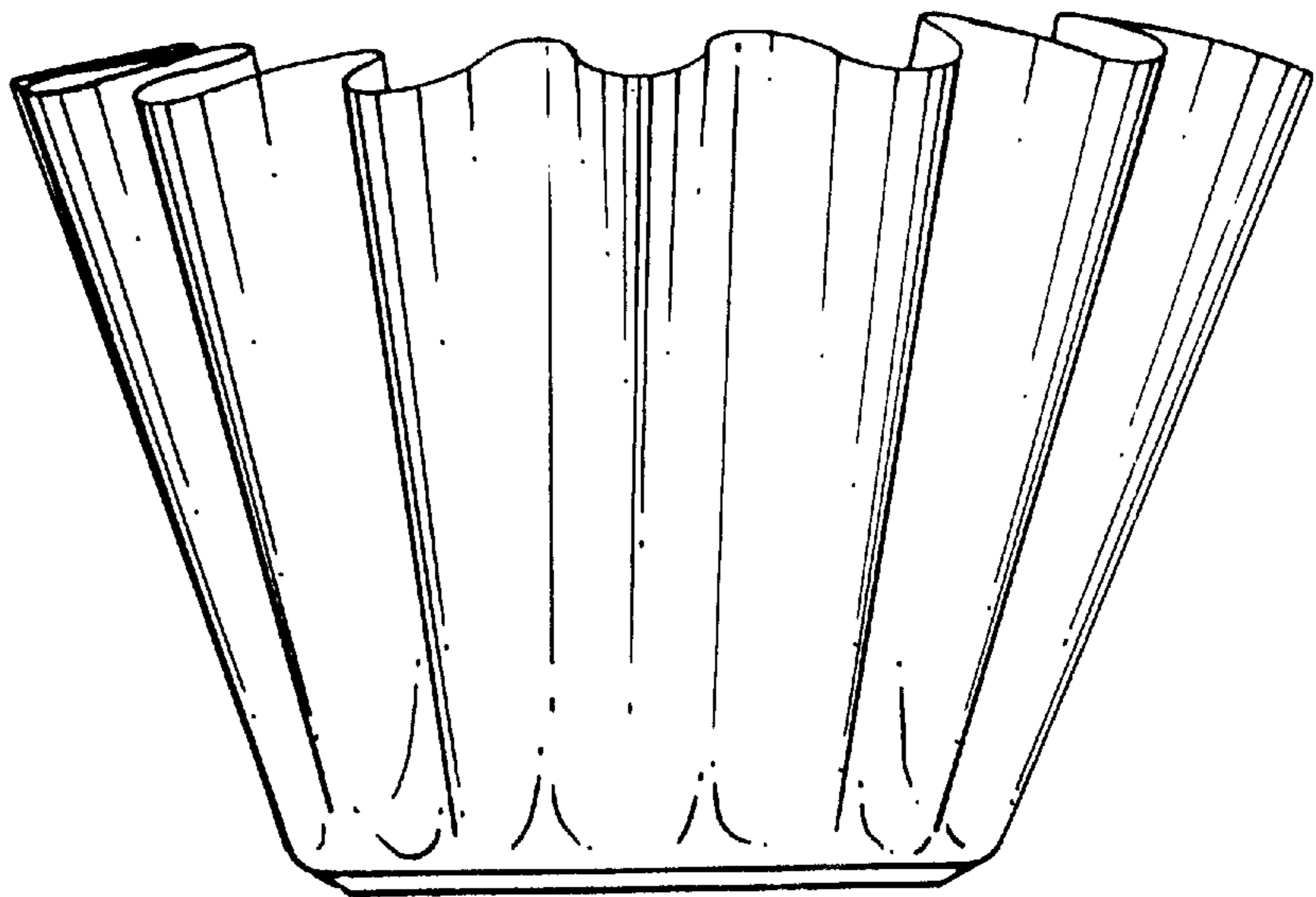

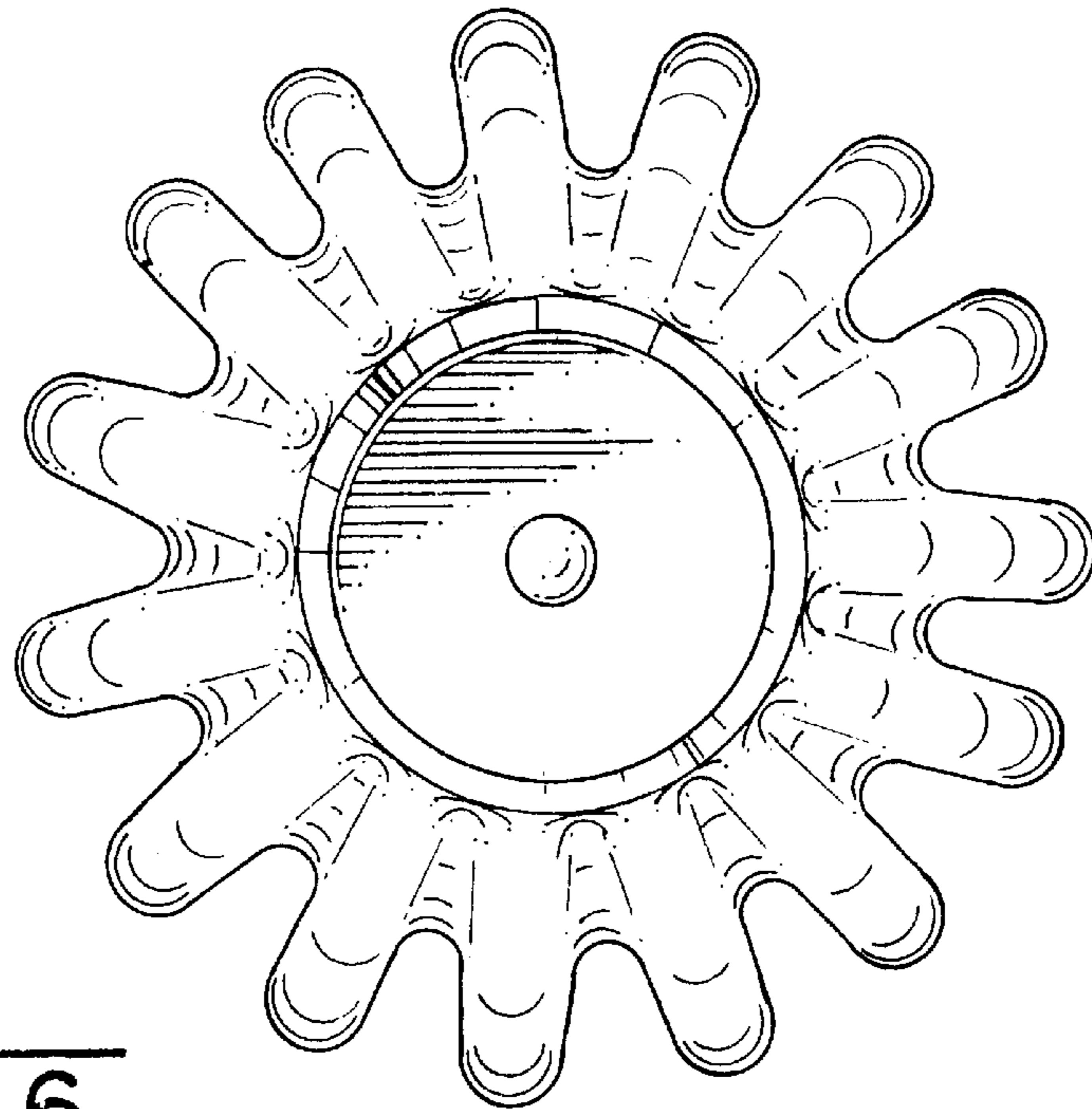

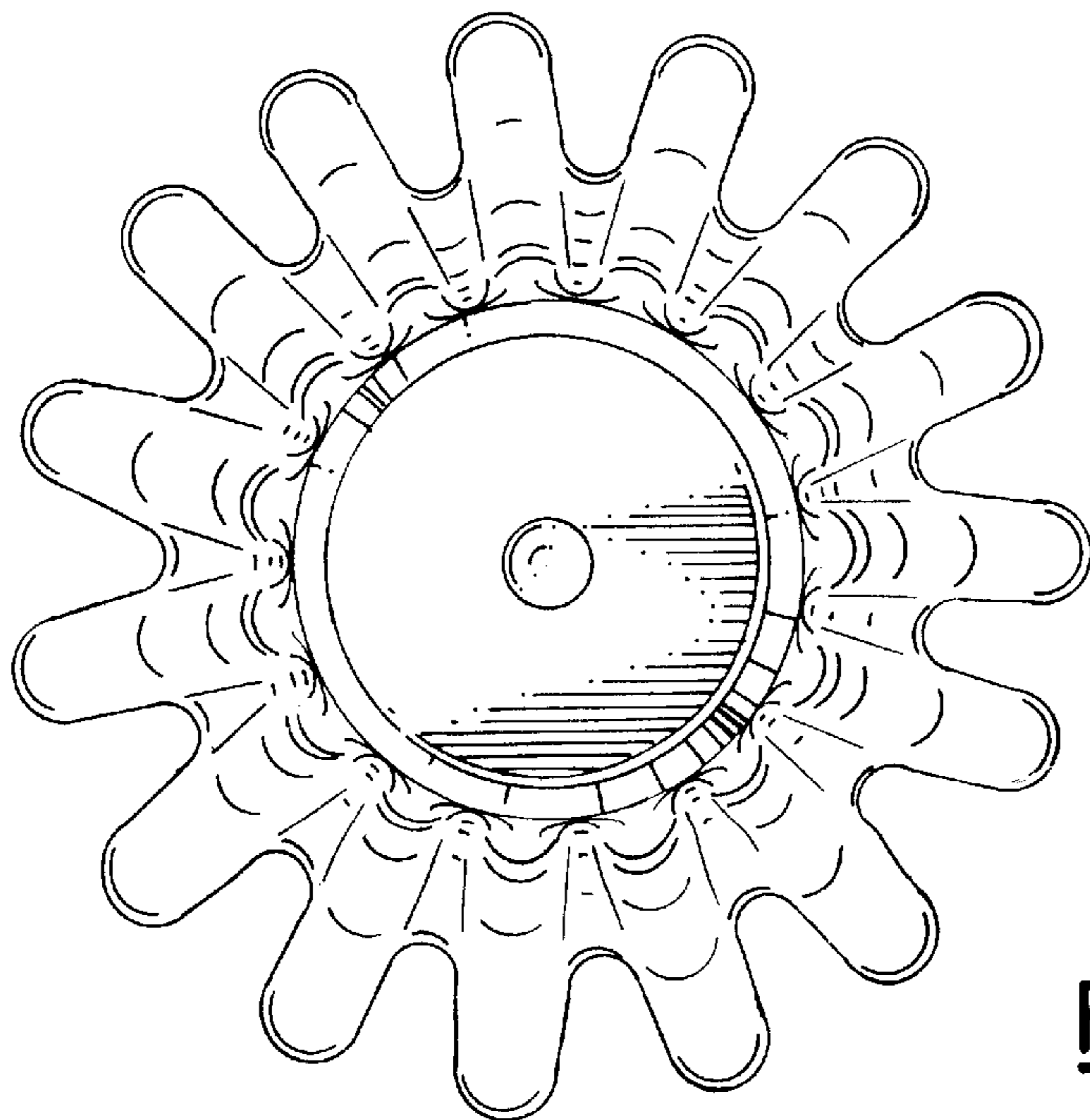
