DESCRIPTION

FIG. 1 is a front elevational view of the remote caller identification device of the present invention;

FIG. 2 is a back elevational view of the remote caller identification device of FIG. 1;

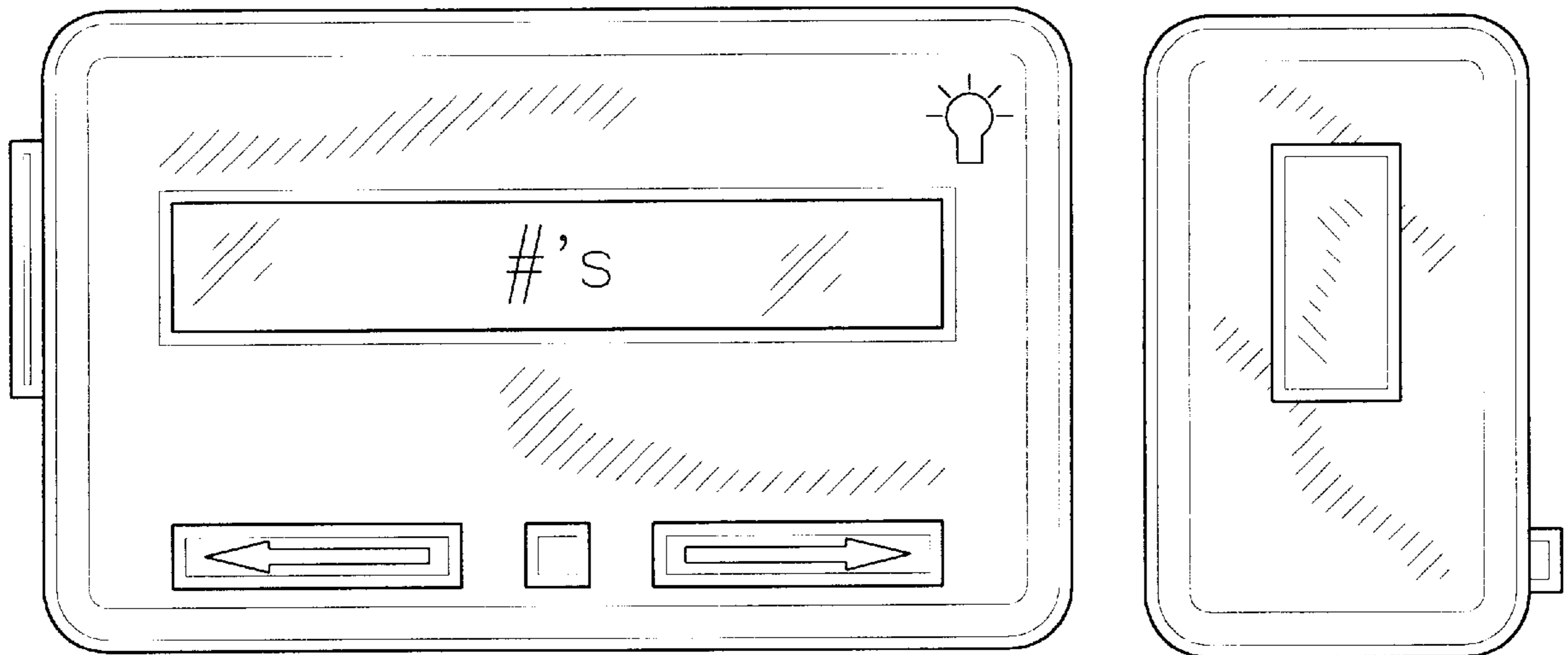
FIG. 3 is a left side elevational view of the remote caller identification device of FIG. 1;

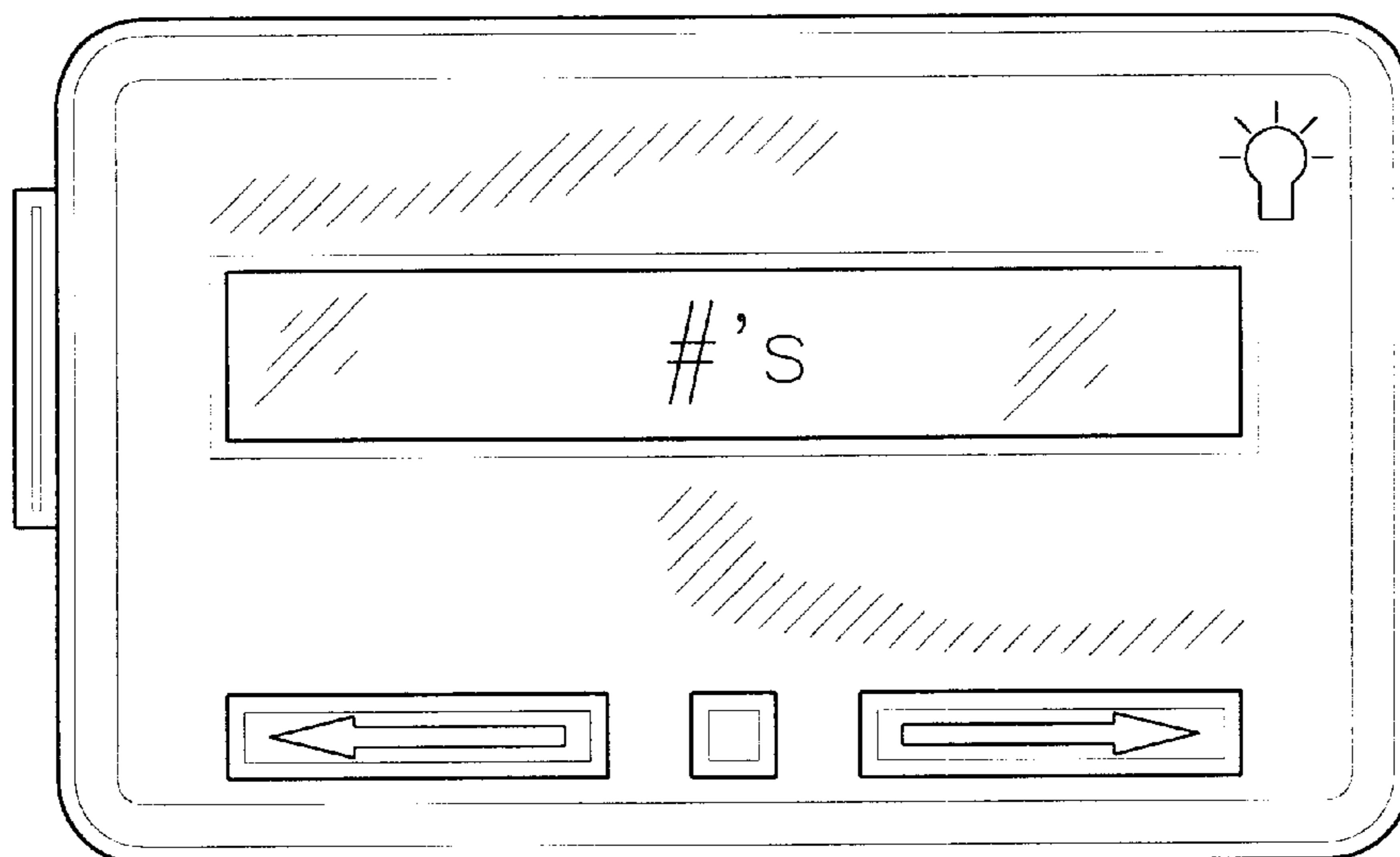

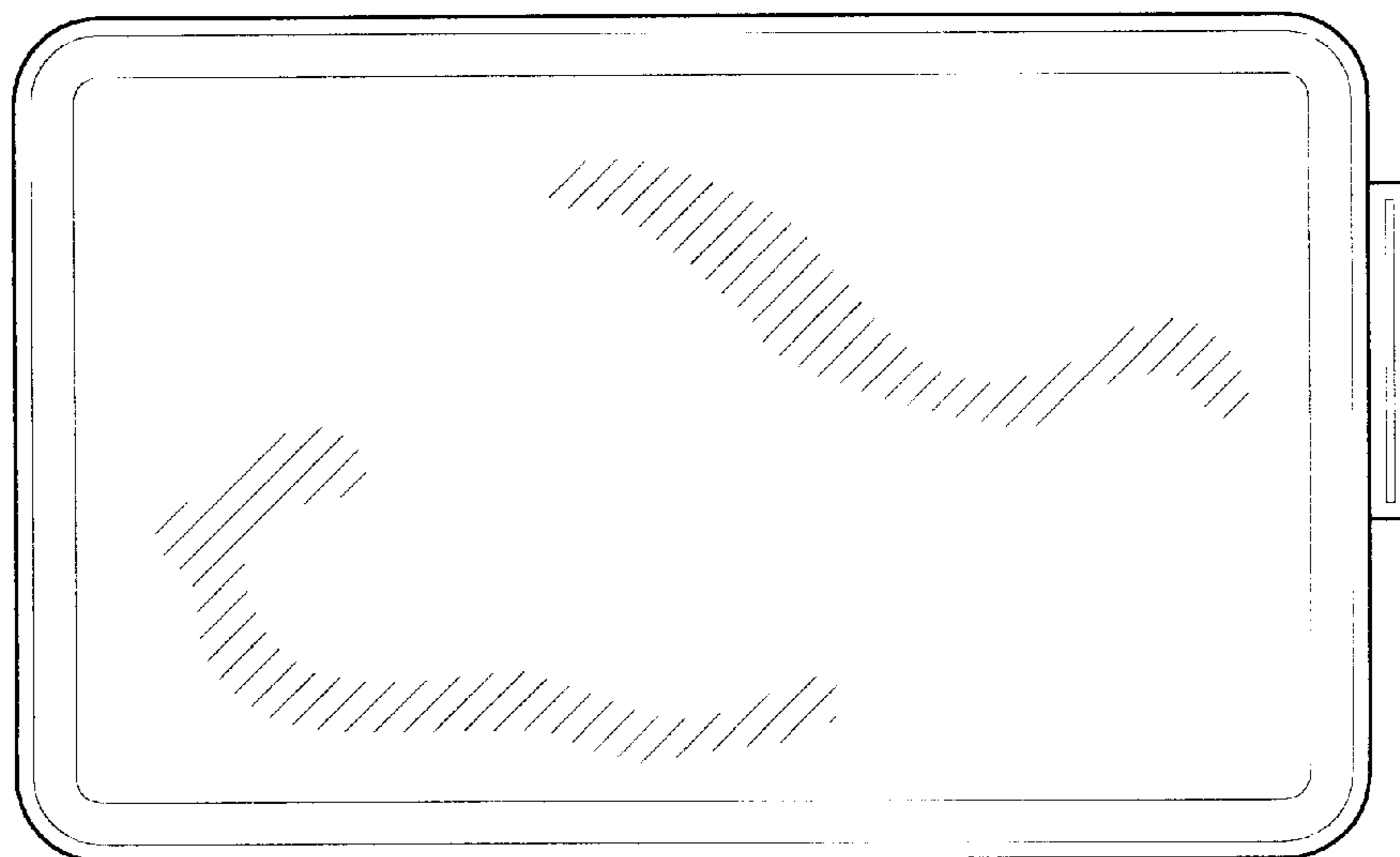

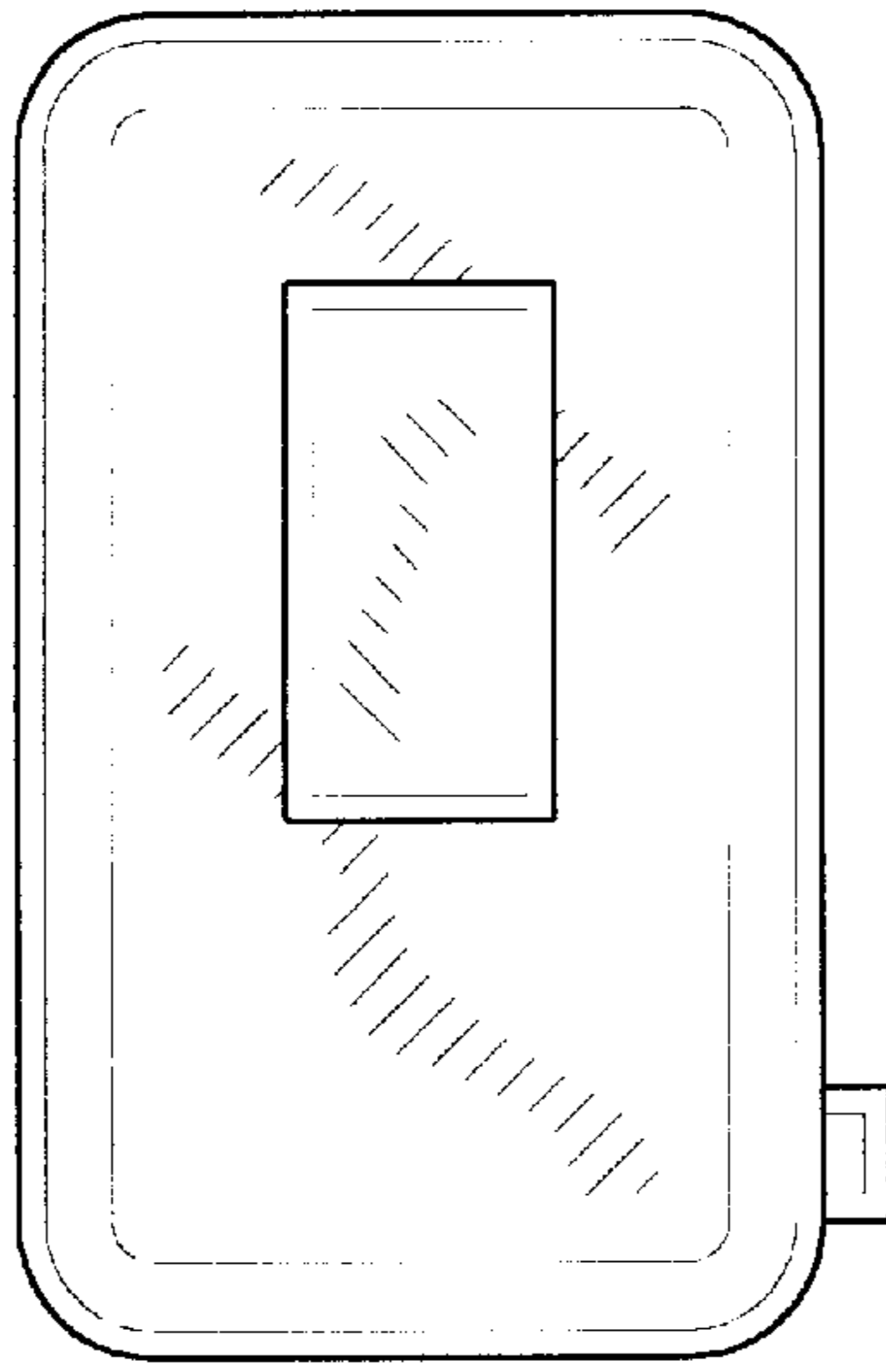

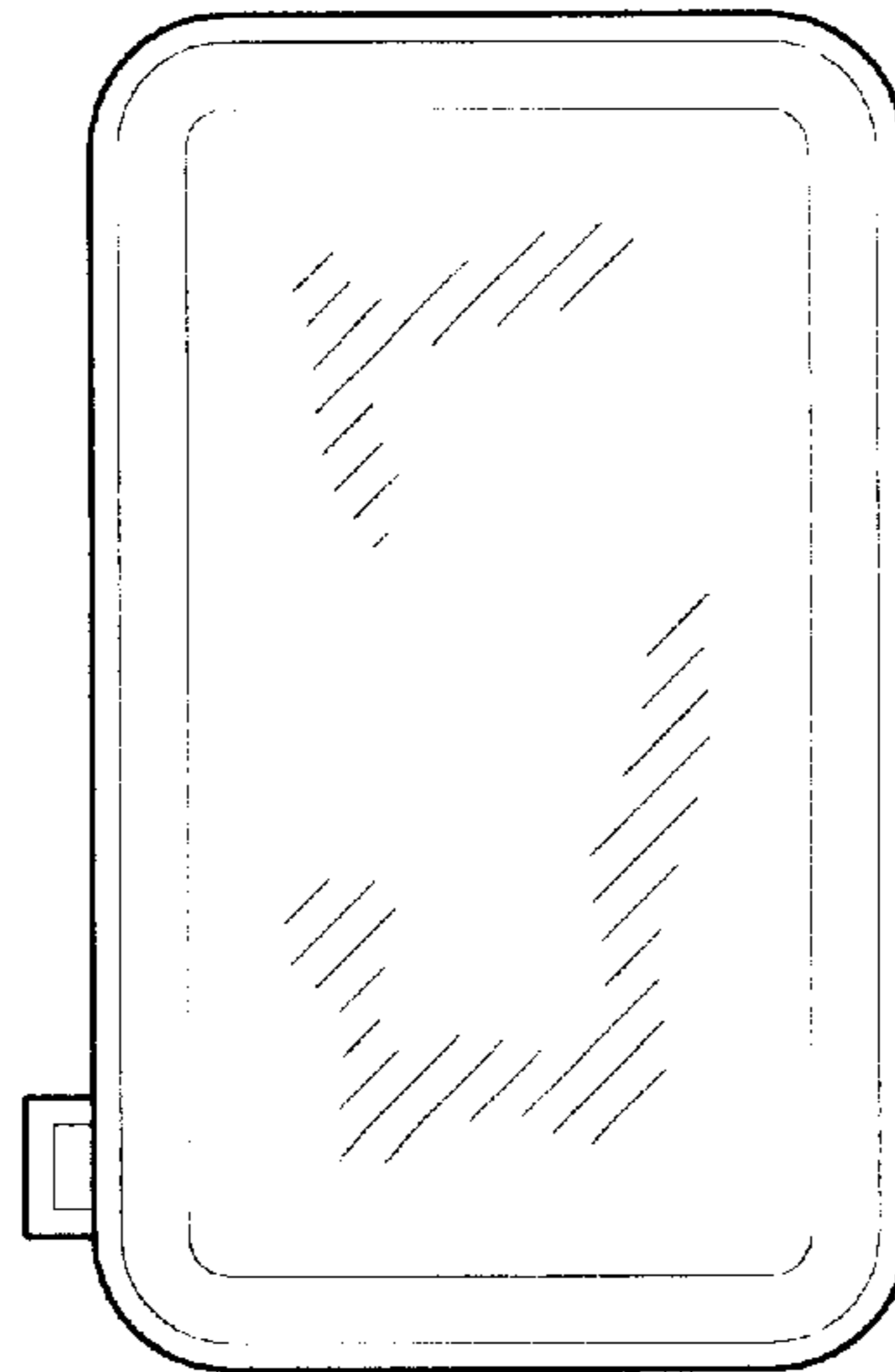

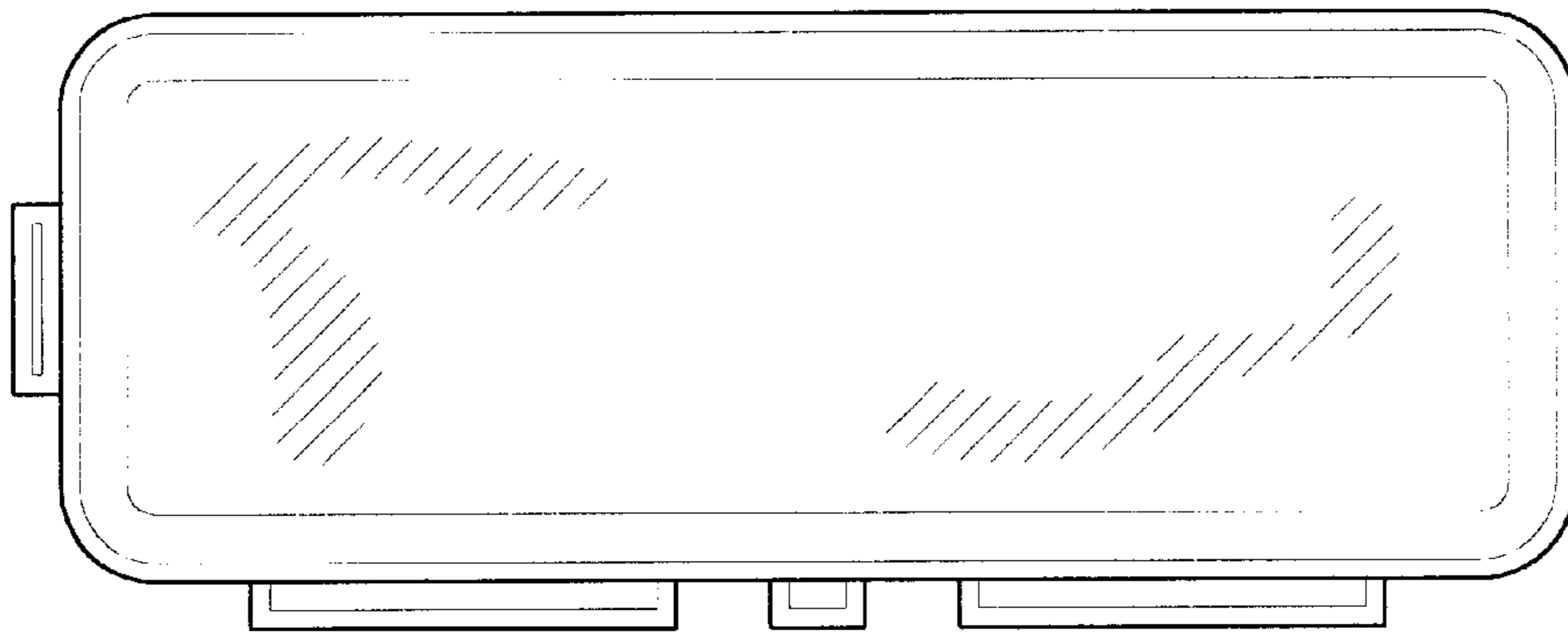

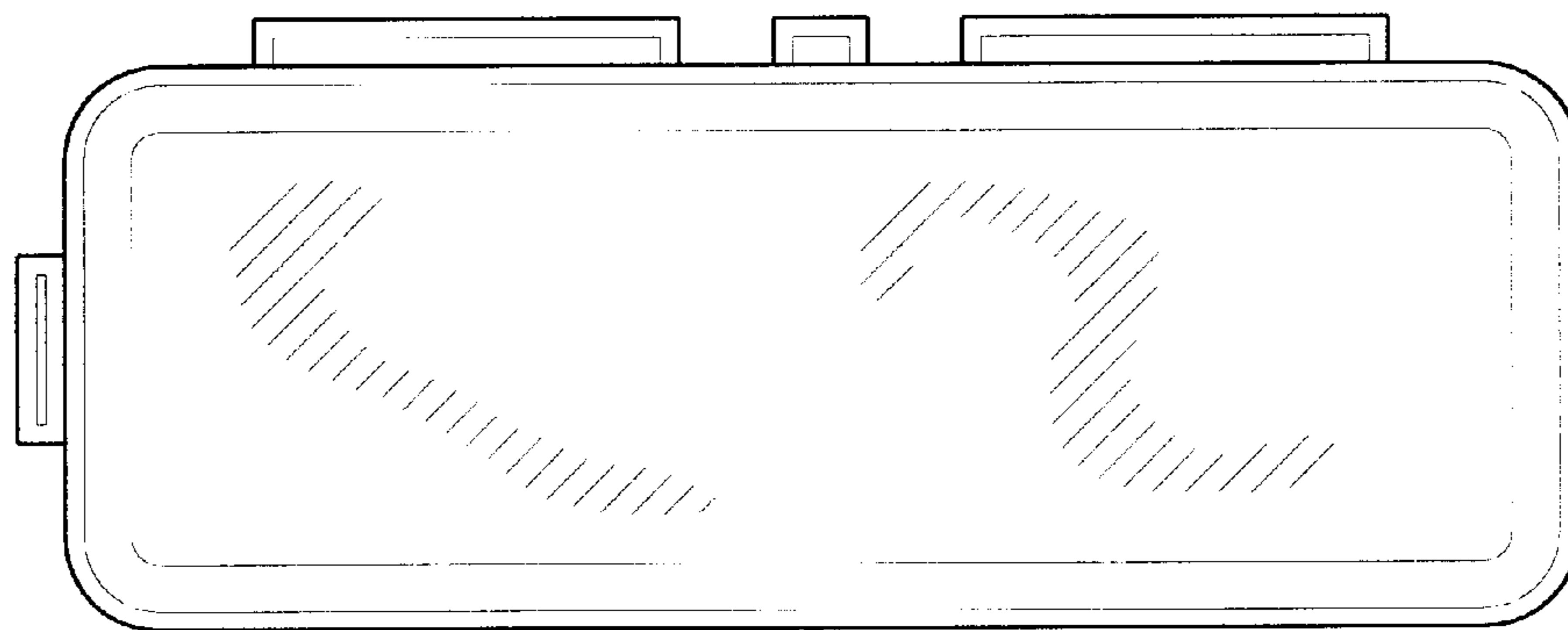
