**DESCRIPTION**

illustrated in FIG. 1;

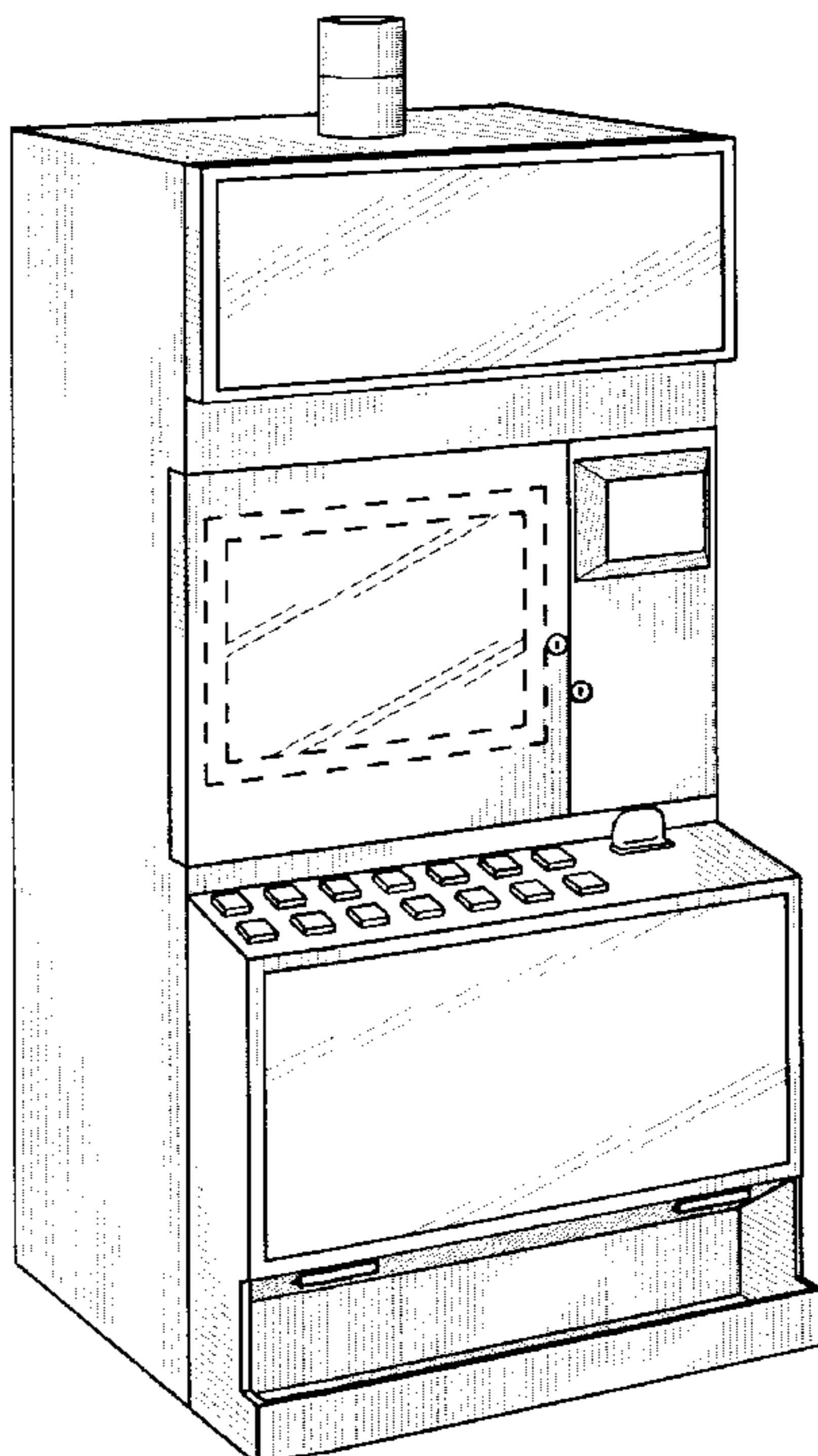
FIG. 5 is a top plan view of the gaming cabinet illustrated

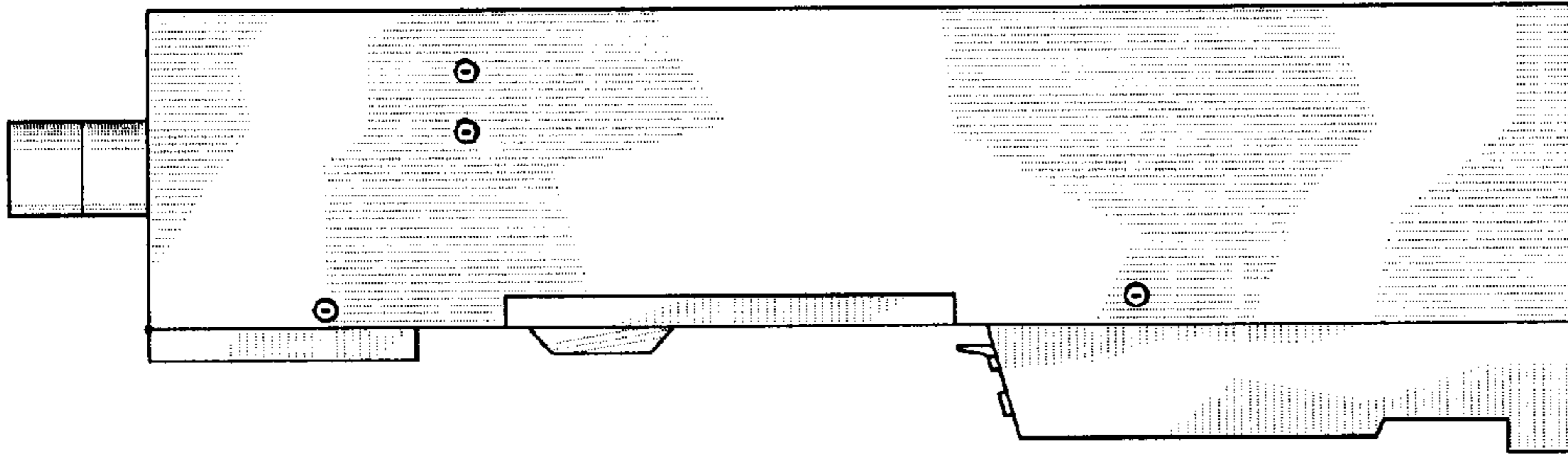

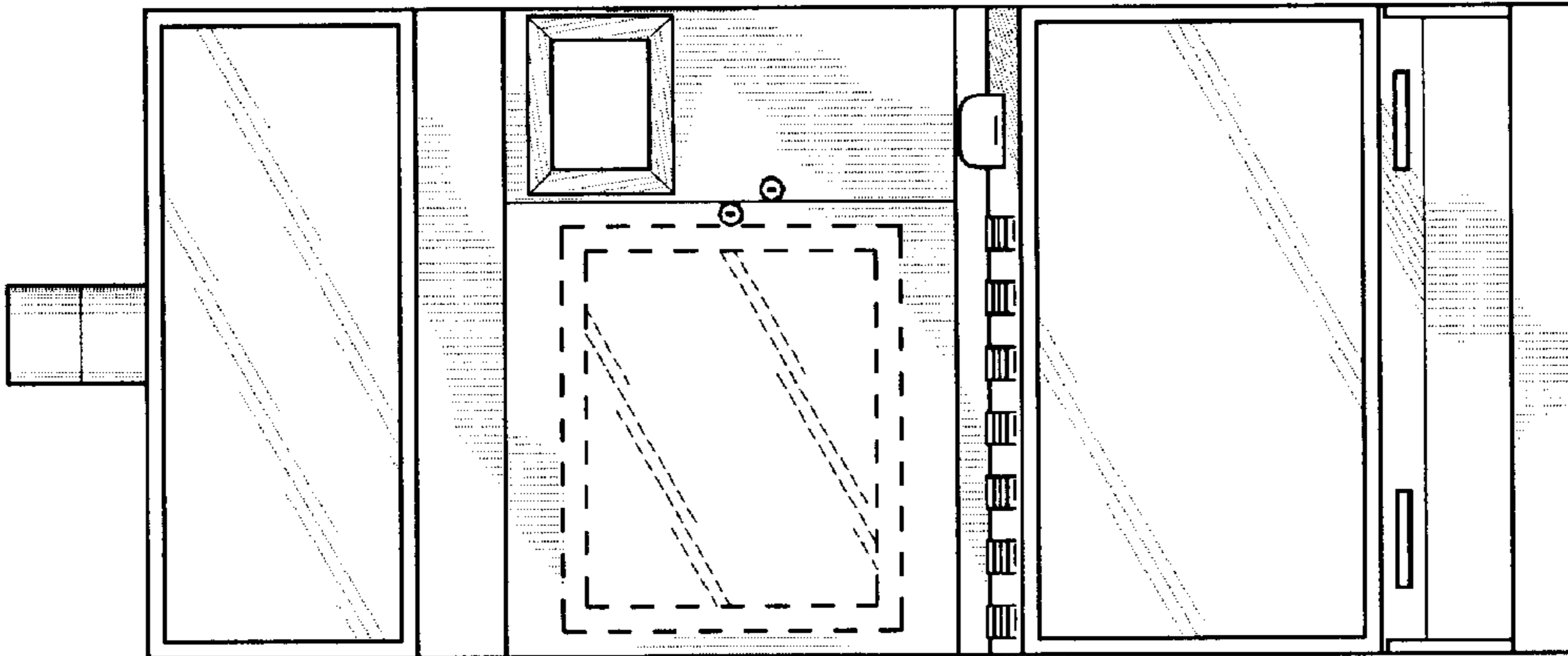

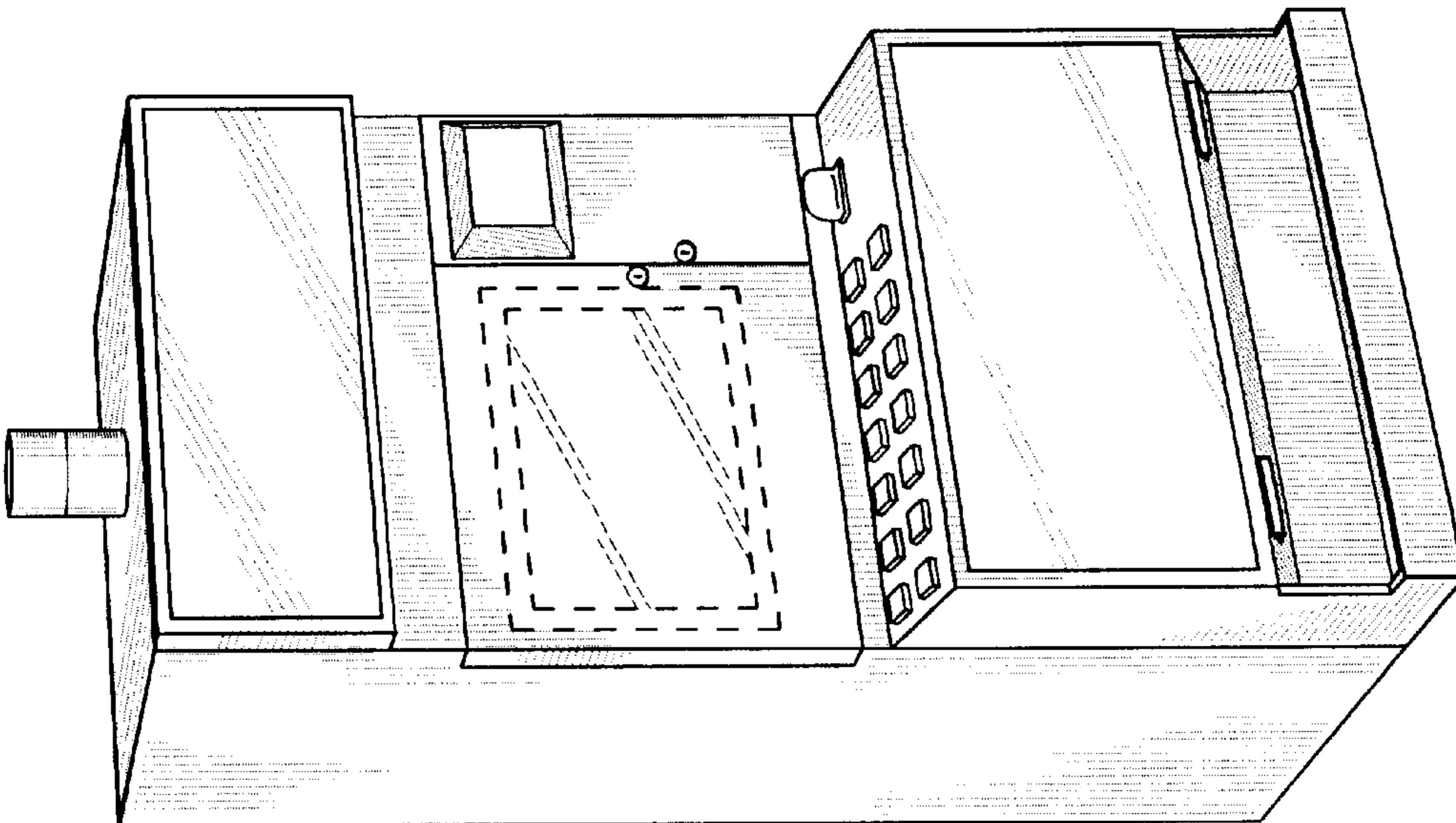

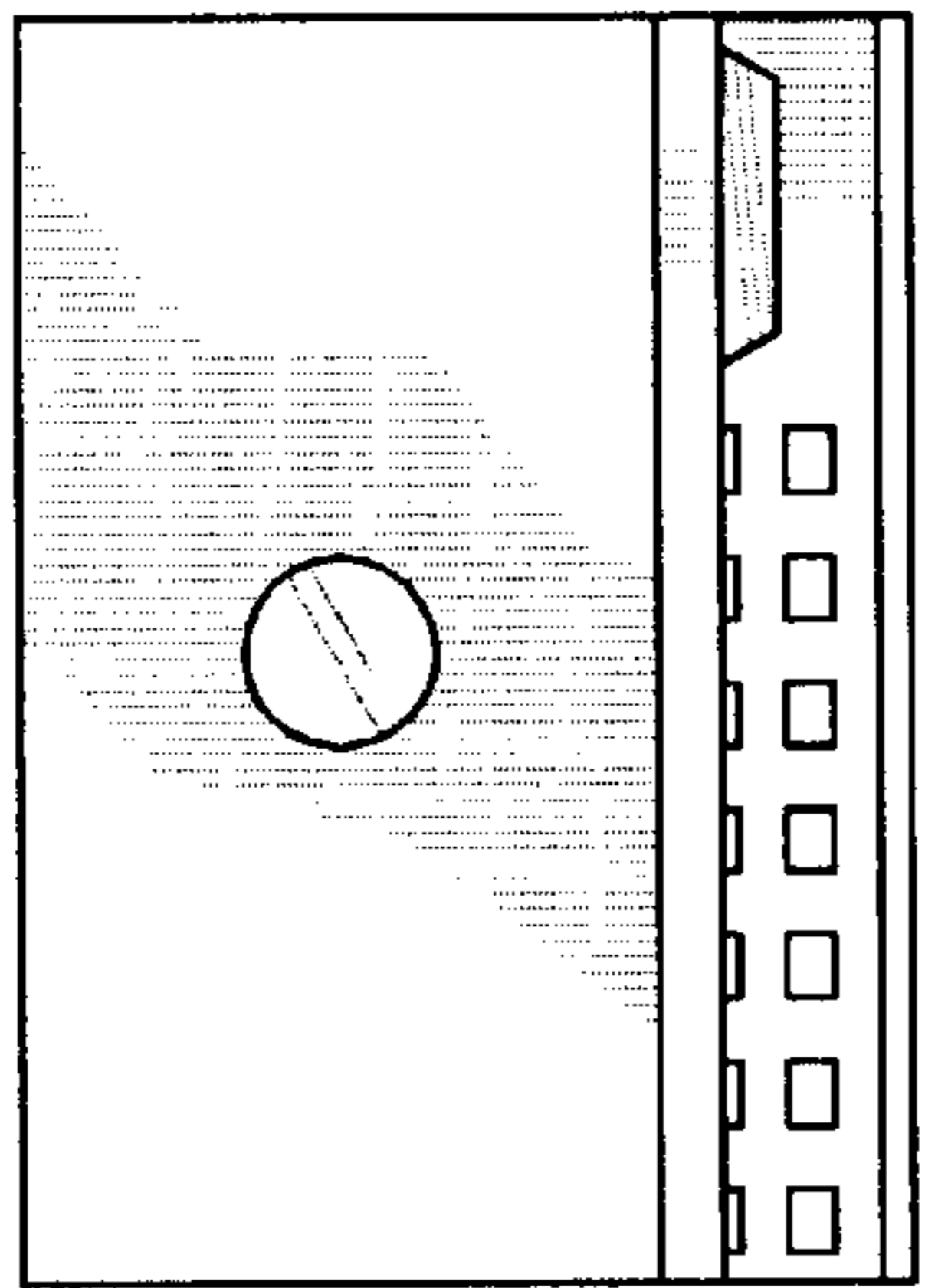

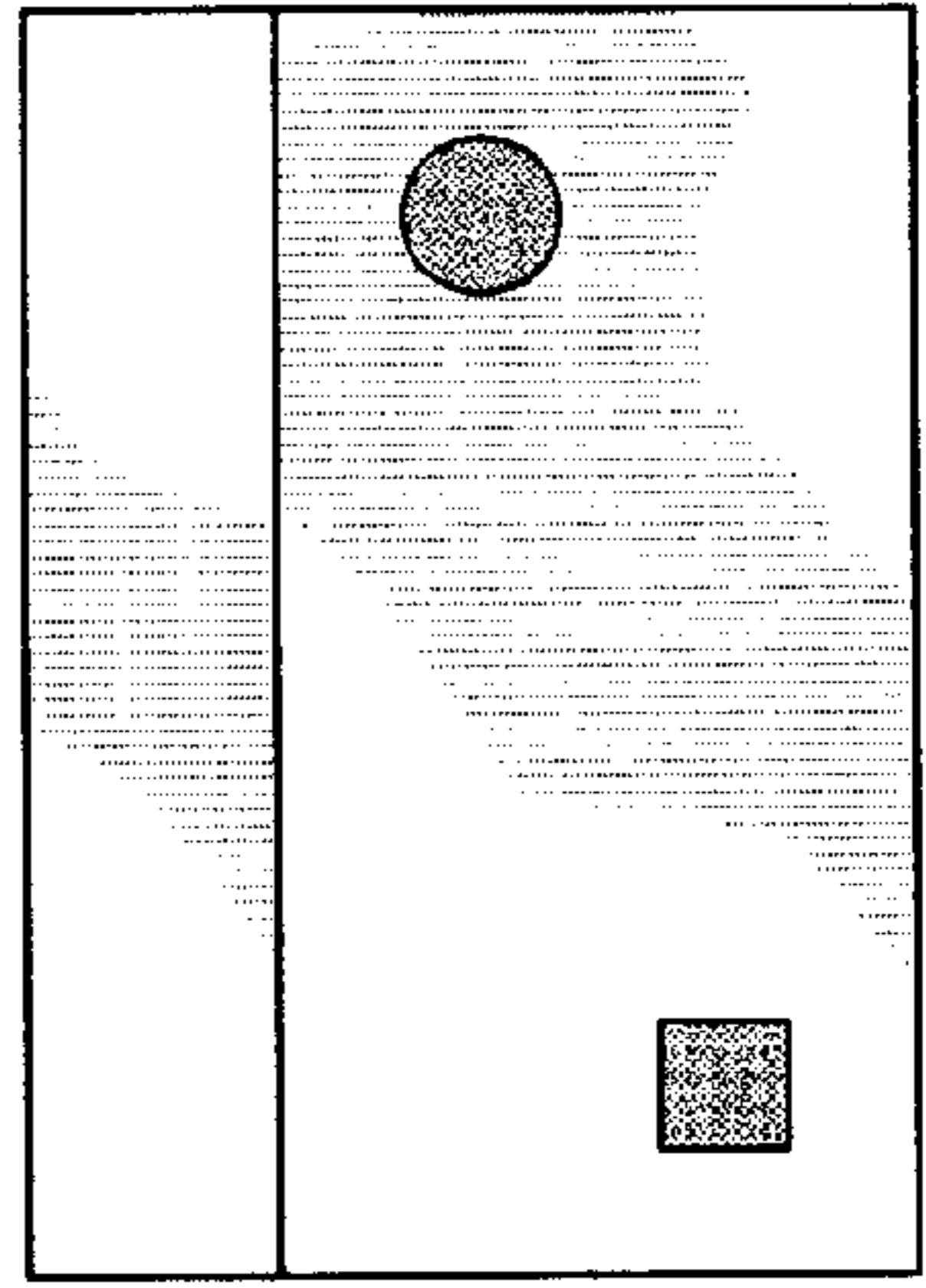

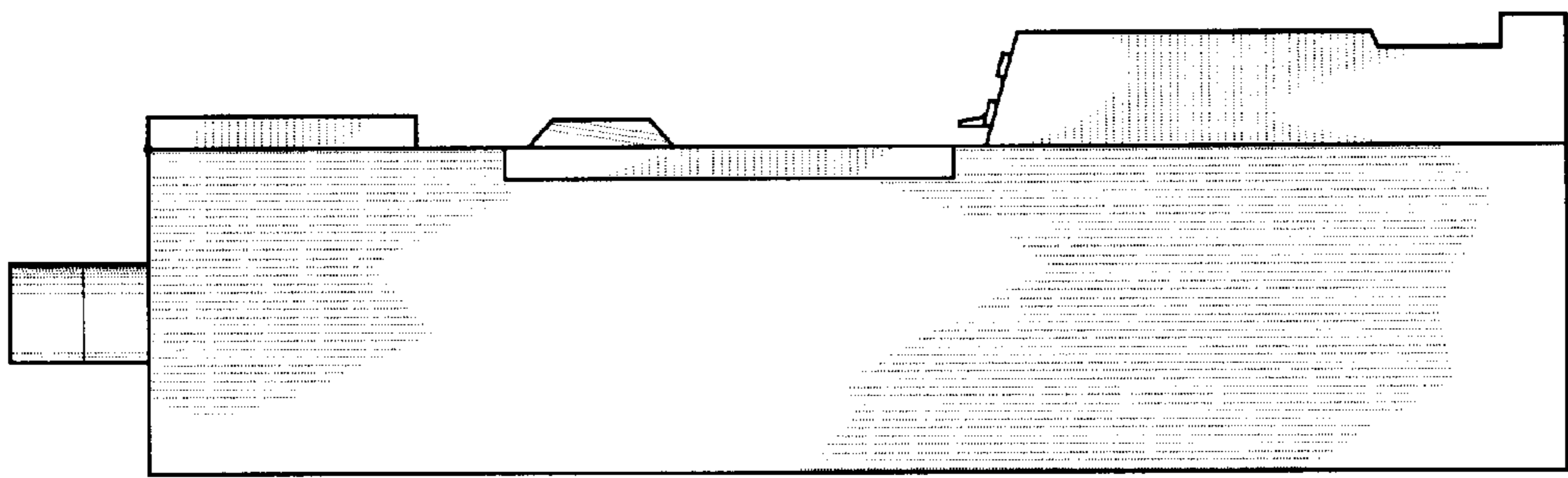
