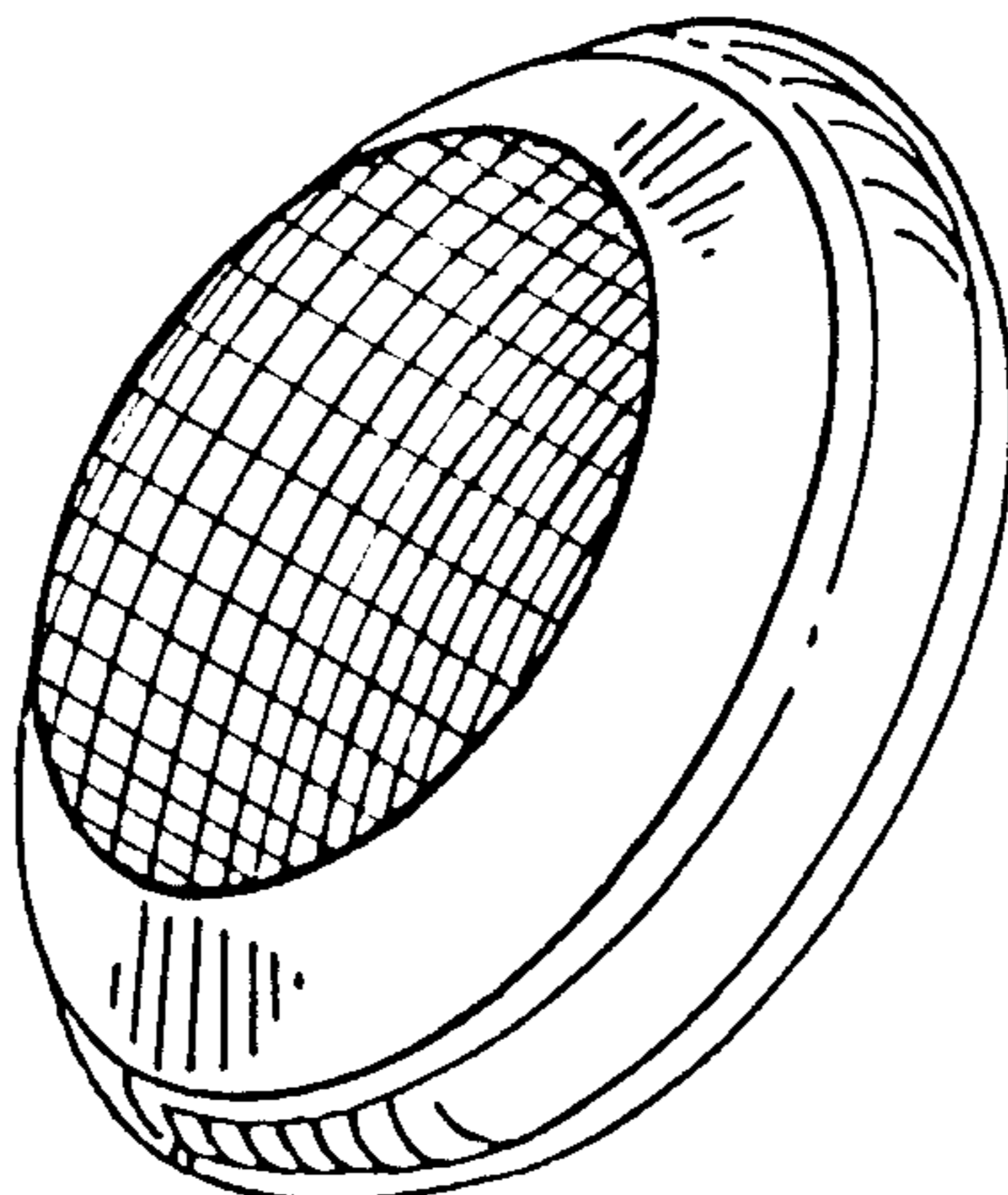
[57] **CLAIM**

The ornamental design for an implantable injection port, as shown and described.

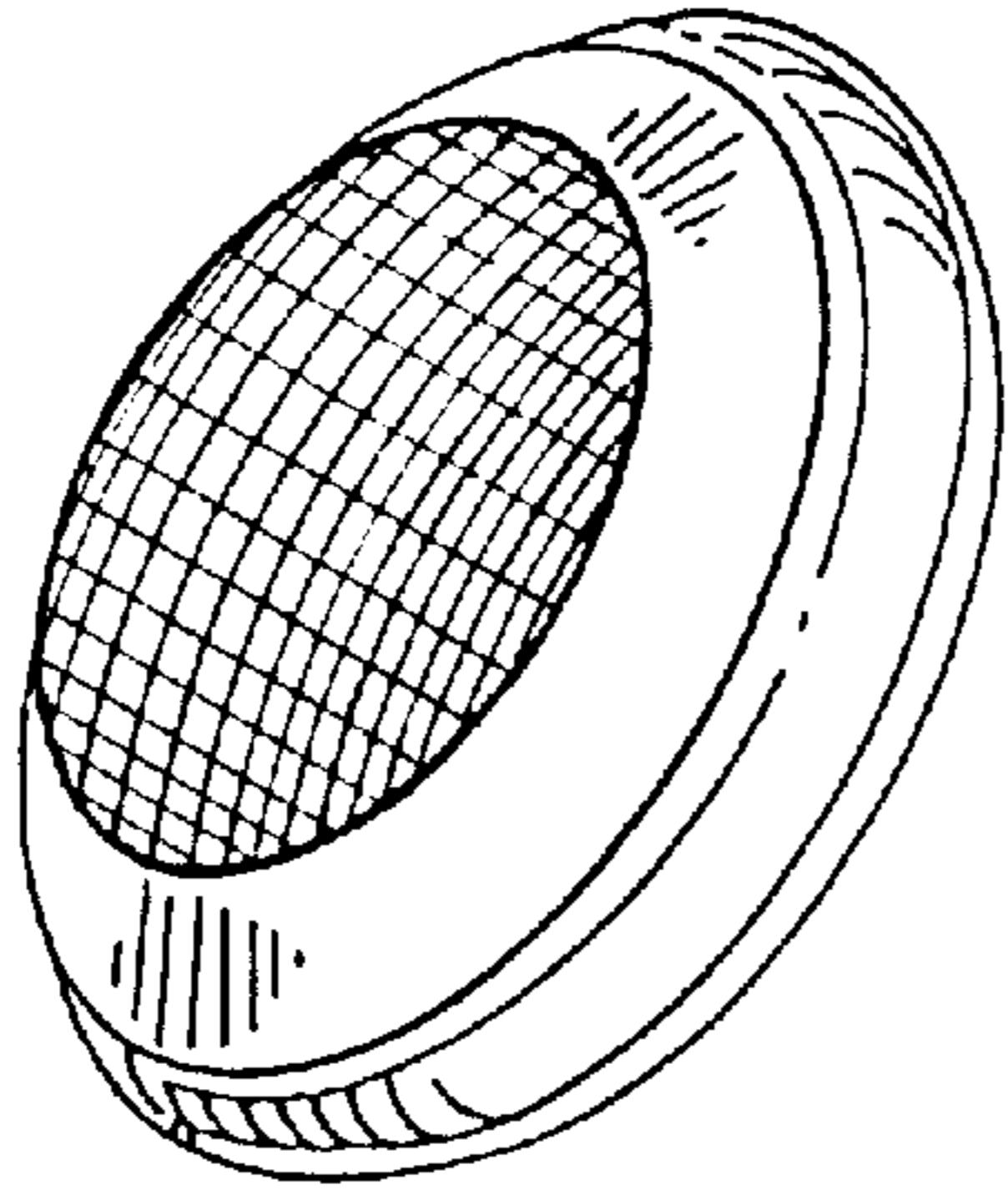
**DESCRIPTION**

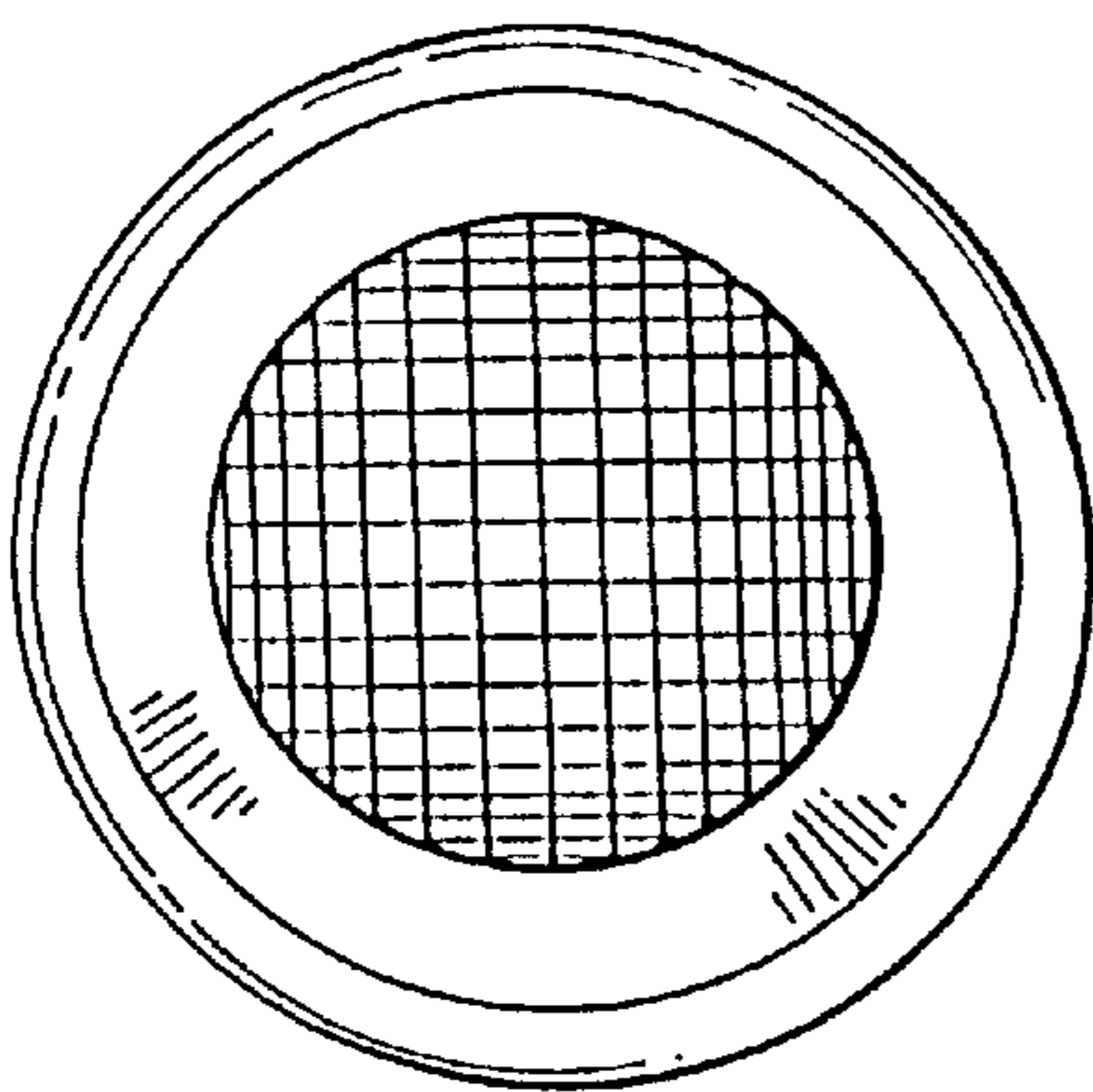
