[57] **CLAIM**

The ornamental design for a toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a toothbrush from the top of the brush showing our new design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is an elevational view as seen from the head end thereof;
FIG. 7 is an elevational view as seen from the handle end thereof;
FIG. 8 is an enlarged perspective view of the toothbrush head from the top of the brush;
FIG. 9 is an enlarged perspective side view thereof; and,
FIG. 10 is an enlarged perspective view as seen from the head end thereof.
The broken line showing of the toothbrush head and handle unit is for illustrative purposes only and forms no part of the claimed design.

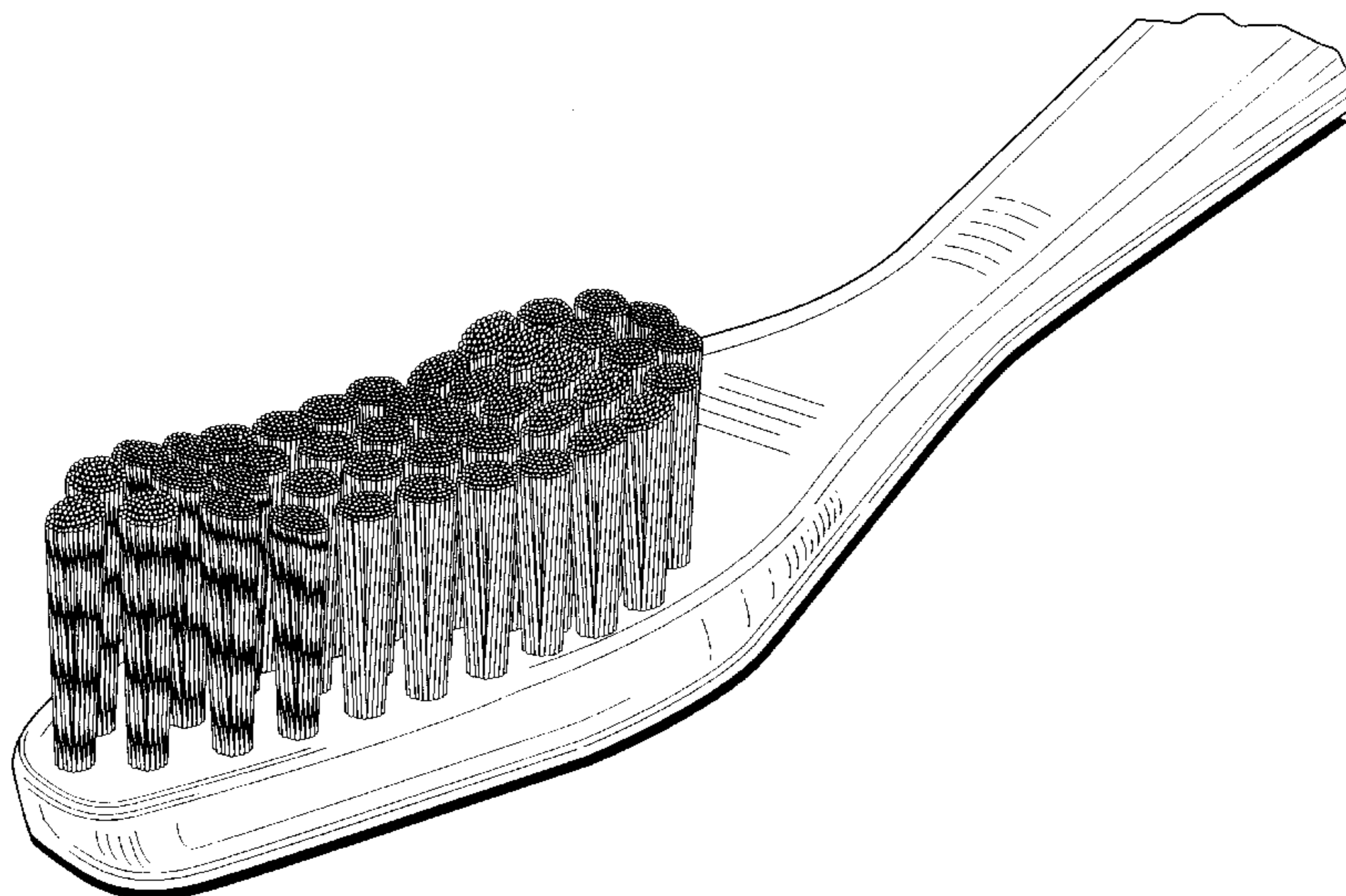

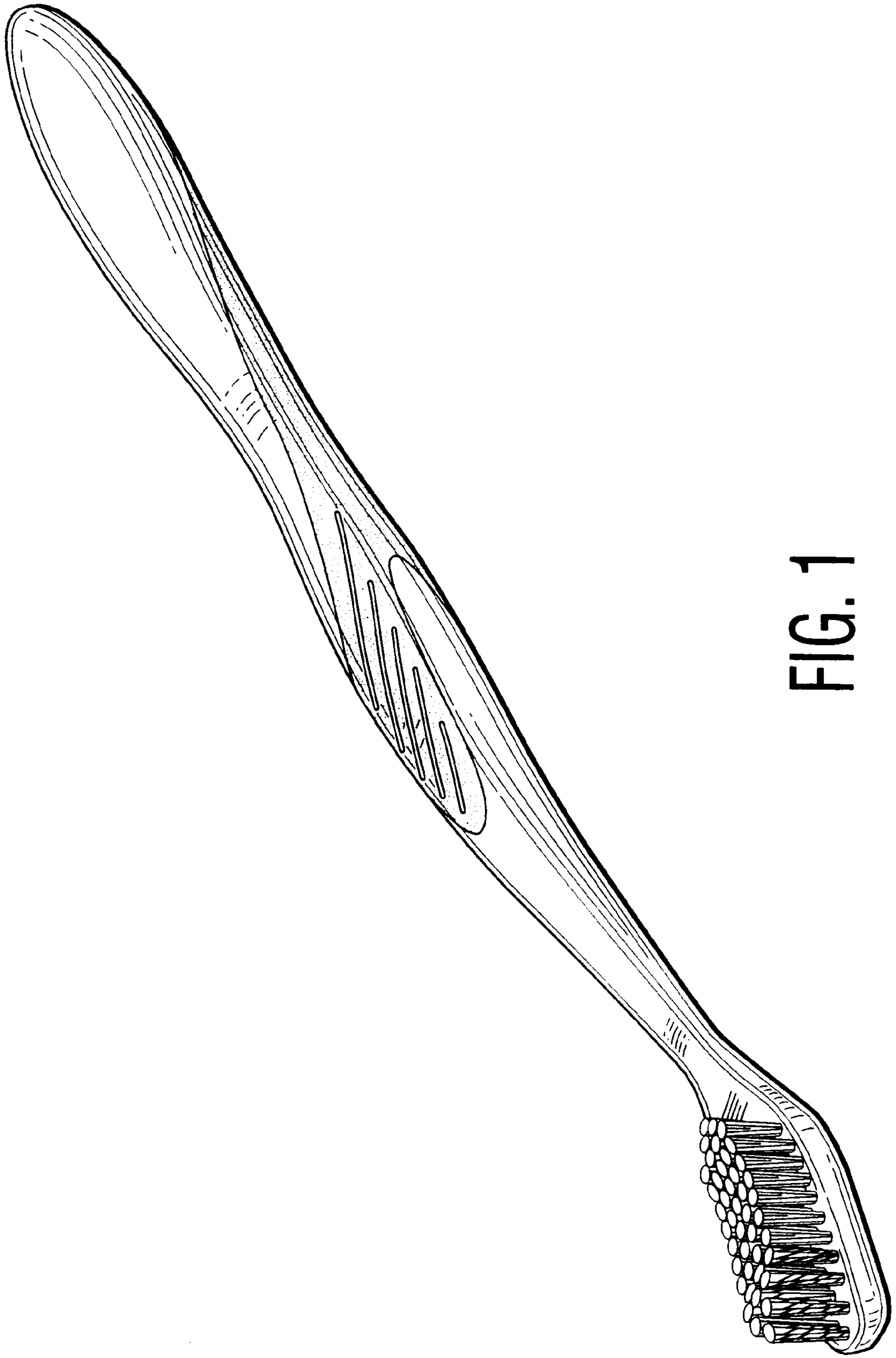

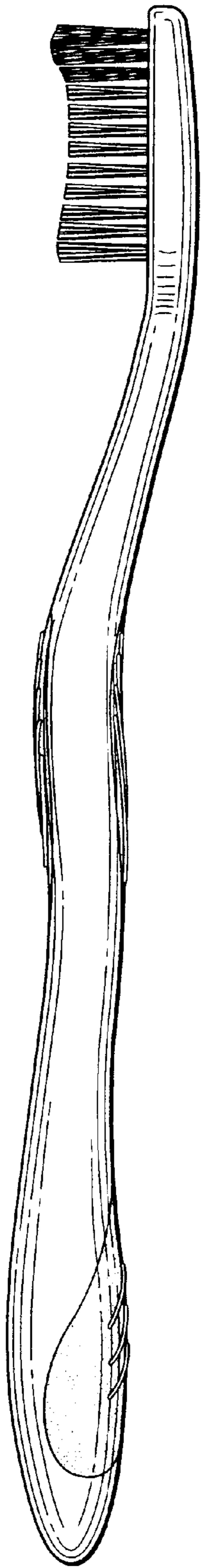

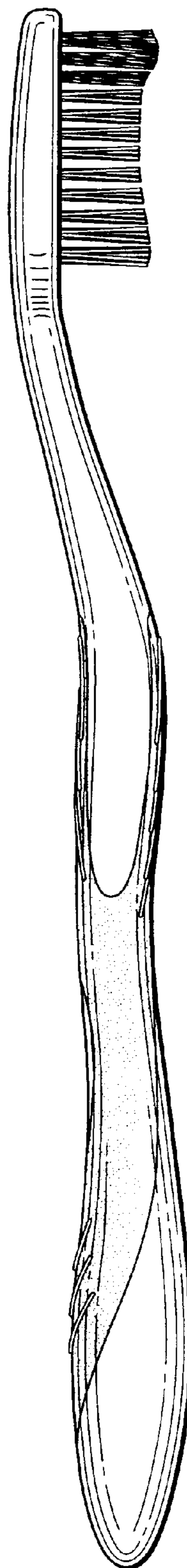

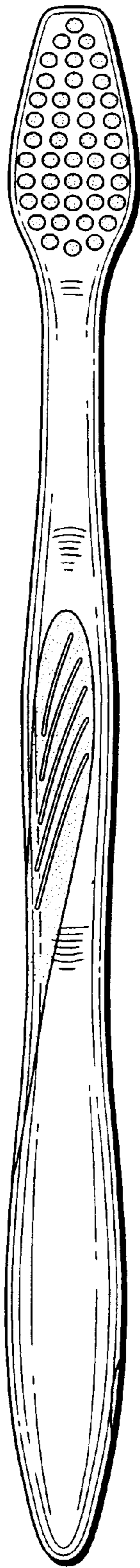

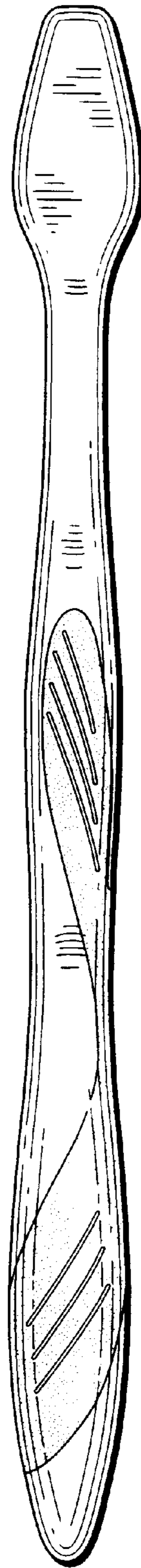

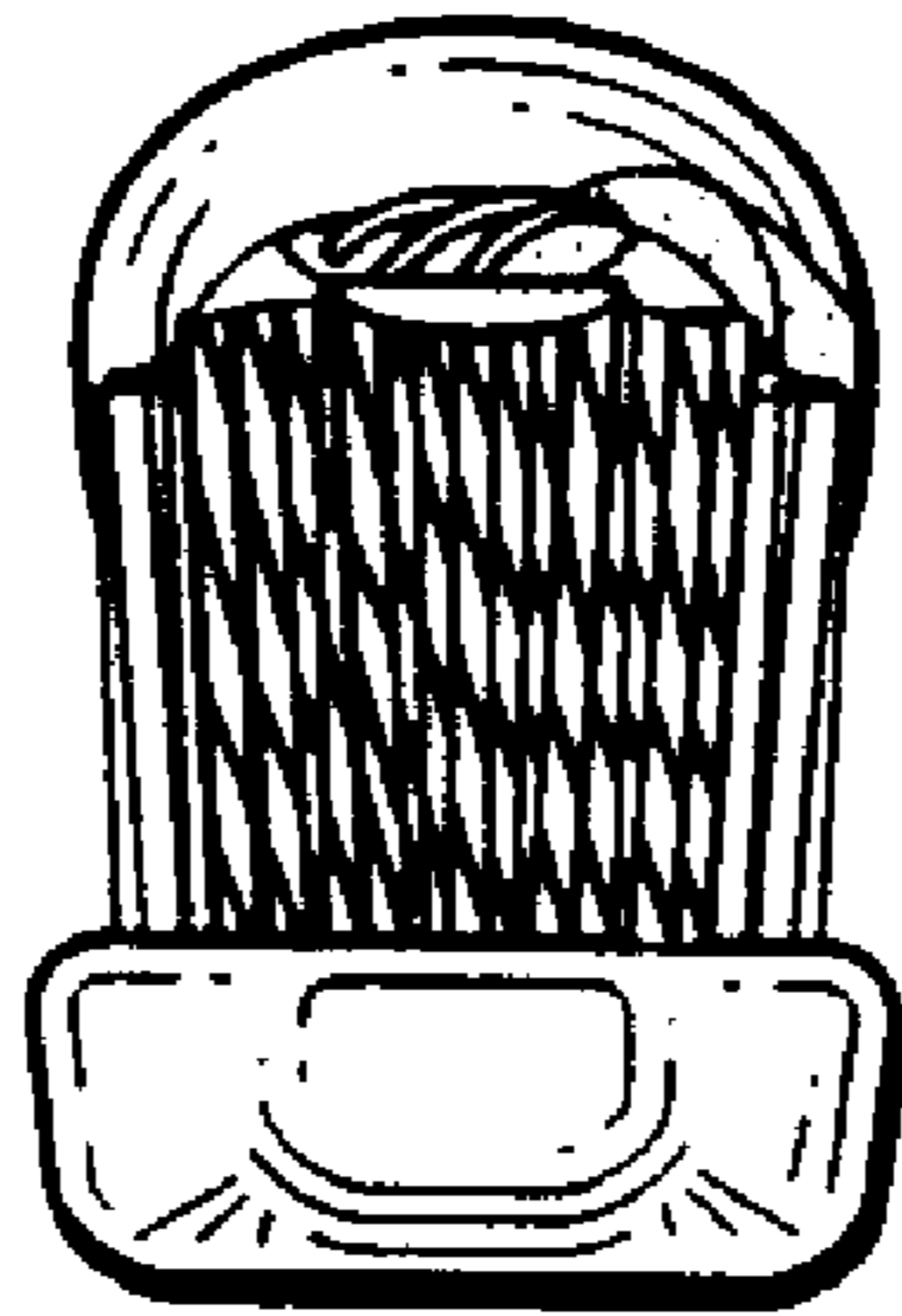

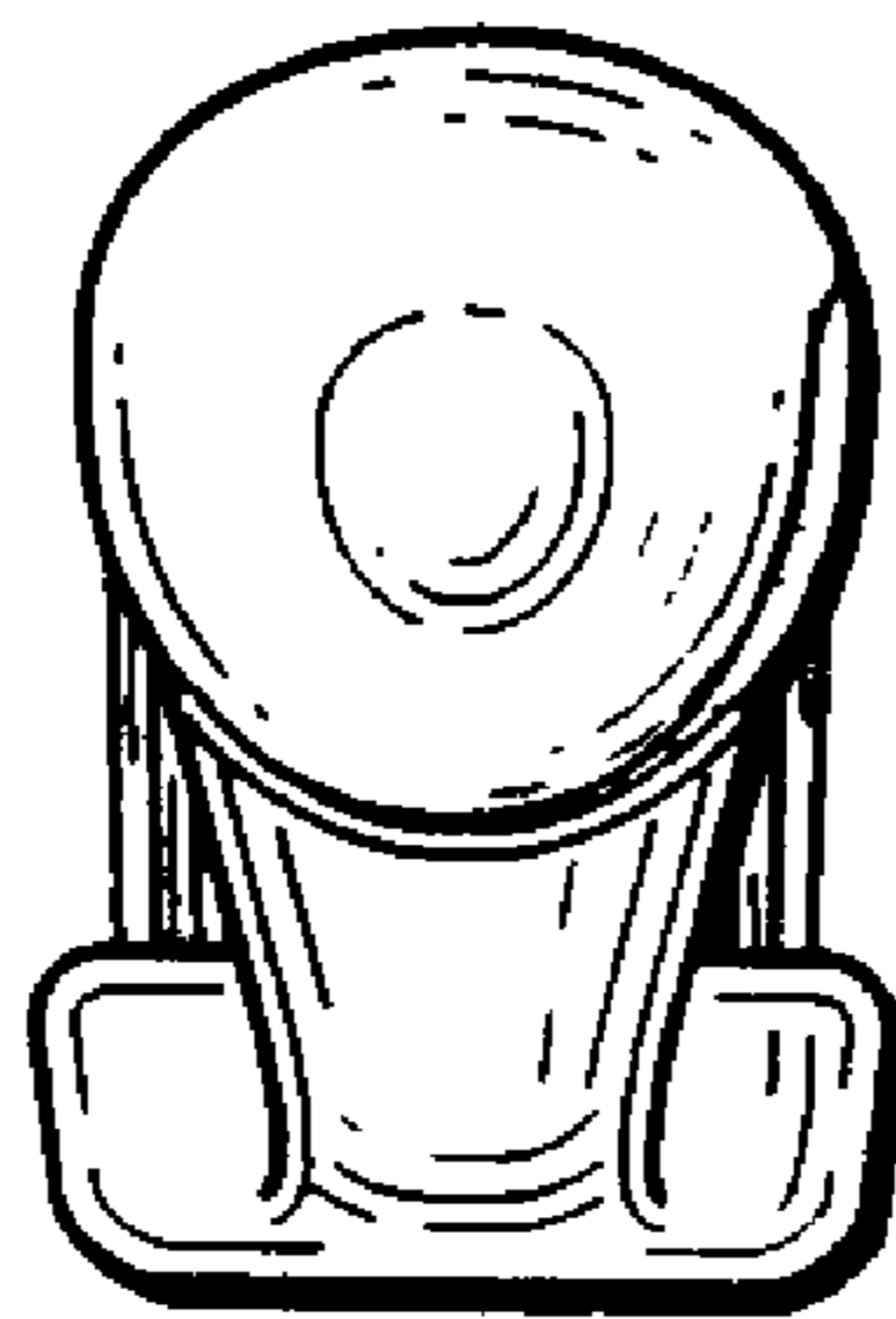

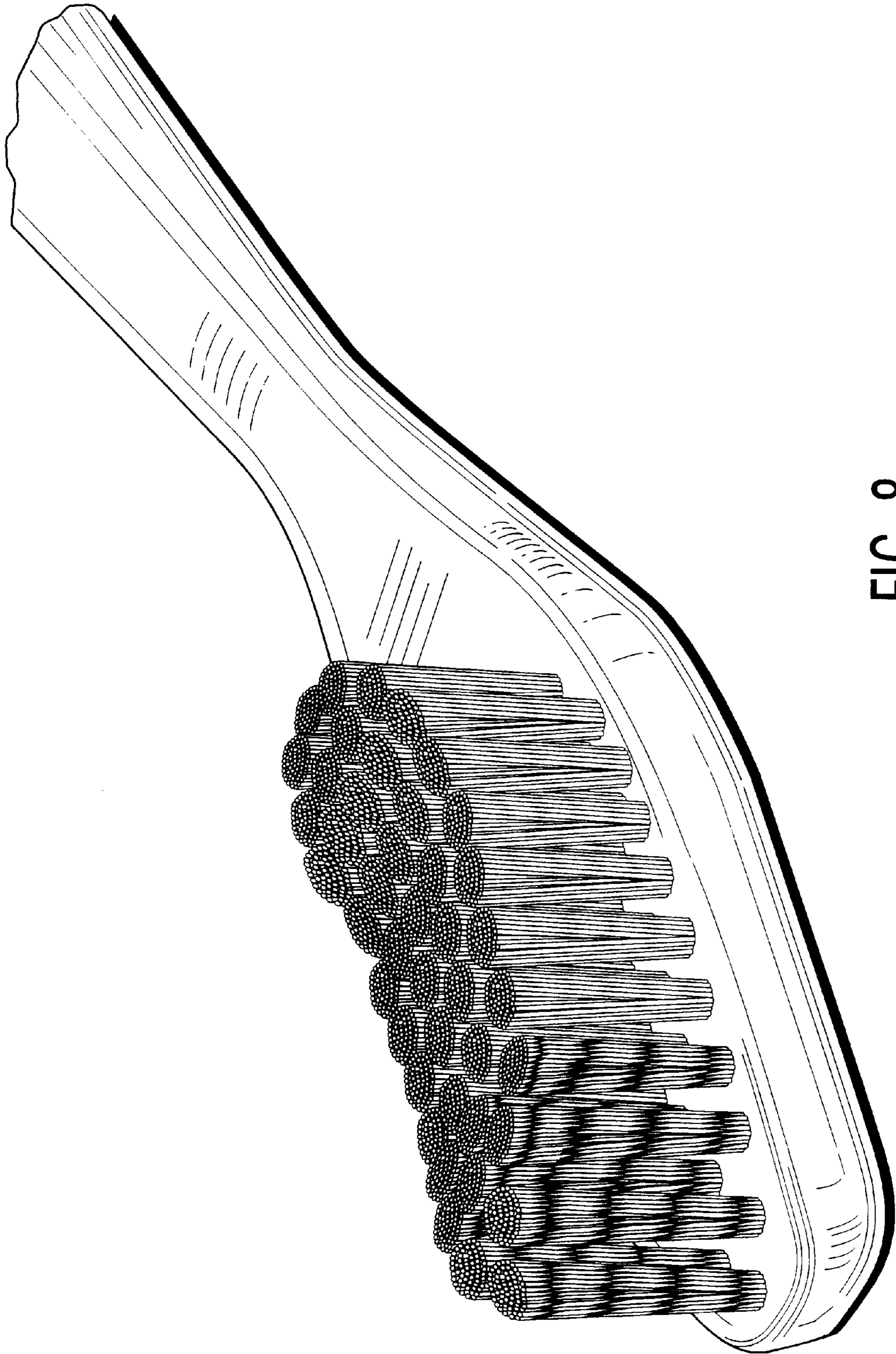

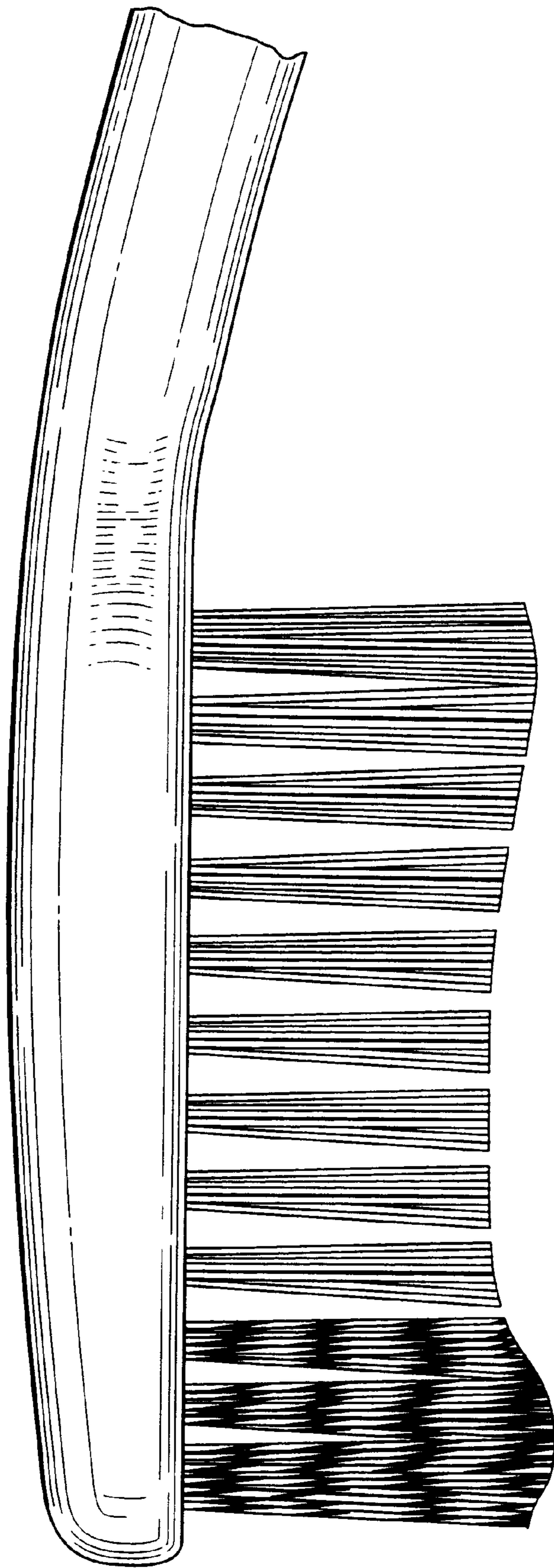

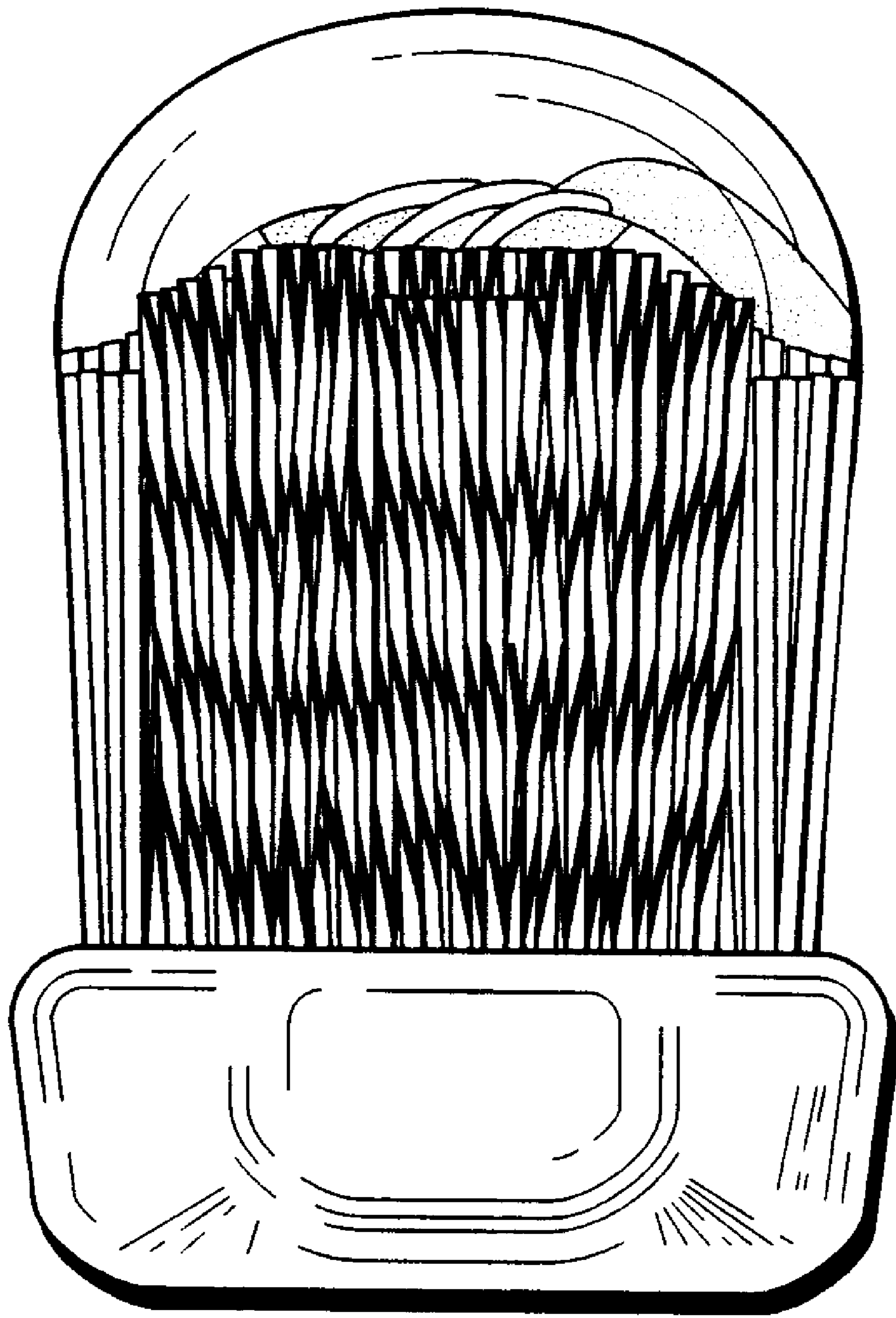
