[57] **CLAIM**

The ornamental design for a watch and bracelet combination, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a watch and bracelet combination, showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 5 is a partial section view thereof taken along the line 5—5 of FIG. 2 and looking in the direction of the arrows;

FIG. 6 is a partial section view thereof taken along the line 6—6 of FIG. 2 and looking in the direction of the arrows;

FIG. 7 is a rear elevation view thereof;

FIG. 8 is a top plan view of an alternate embodiment of my watch and bracelet combination;

FIG. 9 is a front elevation view of the alternate embodiment.

FIG. 10 is a bottom plan view of the alternate embodiment;

FIG. 11 is a right side elevation view of the alternate embodiment;

FIG. 12 is a partial section view of the alternate embodiment taken along the line 12—12 of FIG. 9 and looking in the direction of the arrows;

FIG. 13 is a partial section view of the alternate embodiment taken along the line 13—13 of FIG. 9 and looking in the direction of the arrows; and,

FIG. 14 is a rear elevation view of the alternate embodiment.

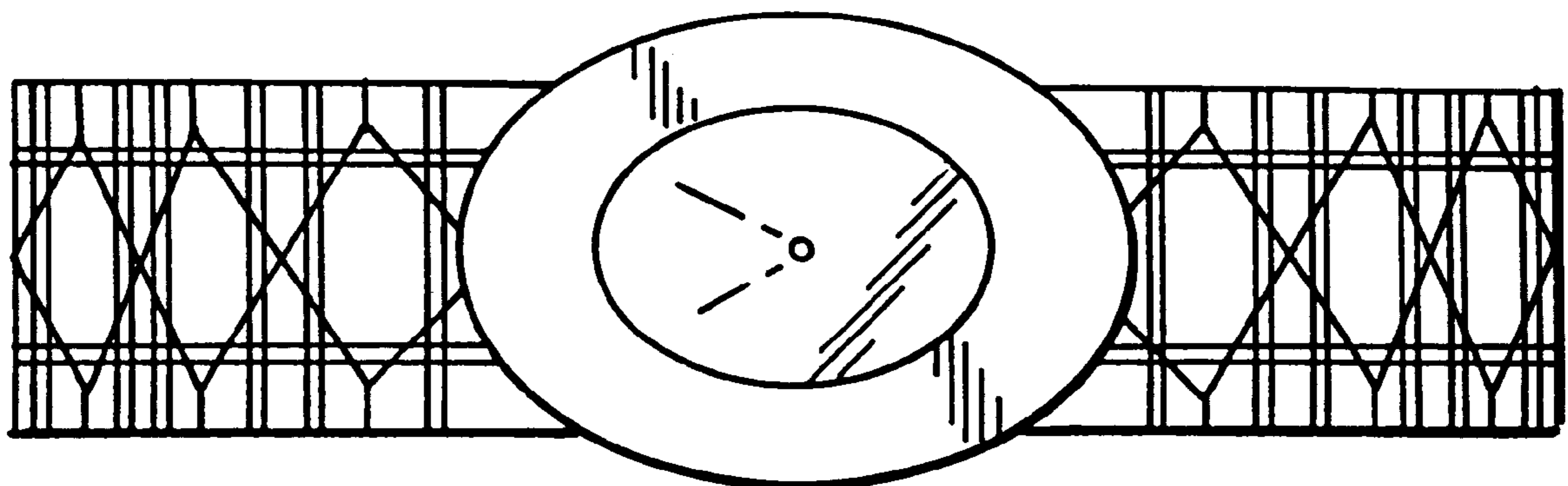

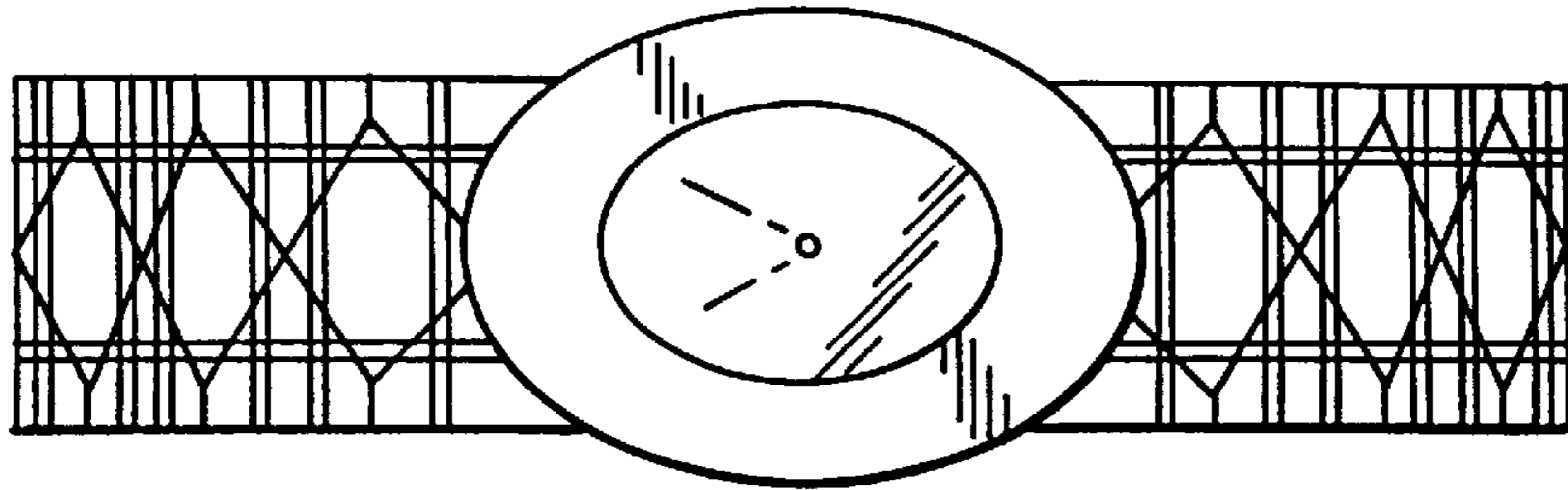

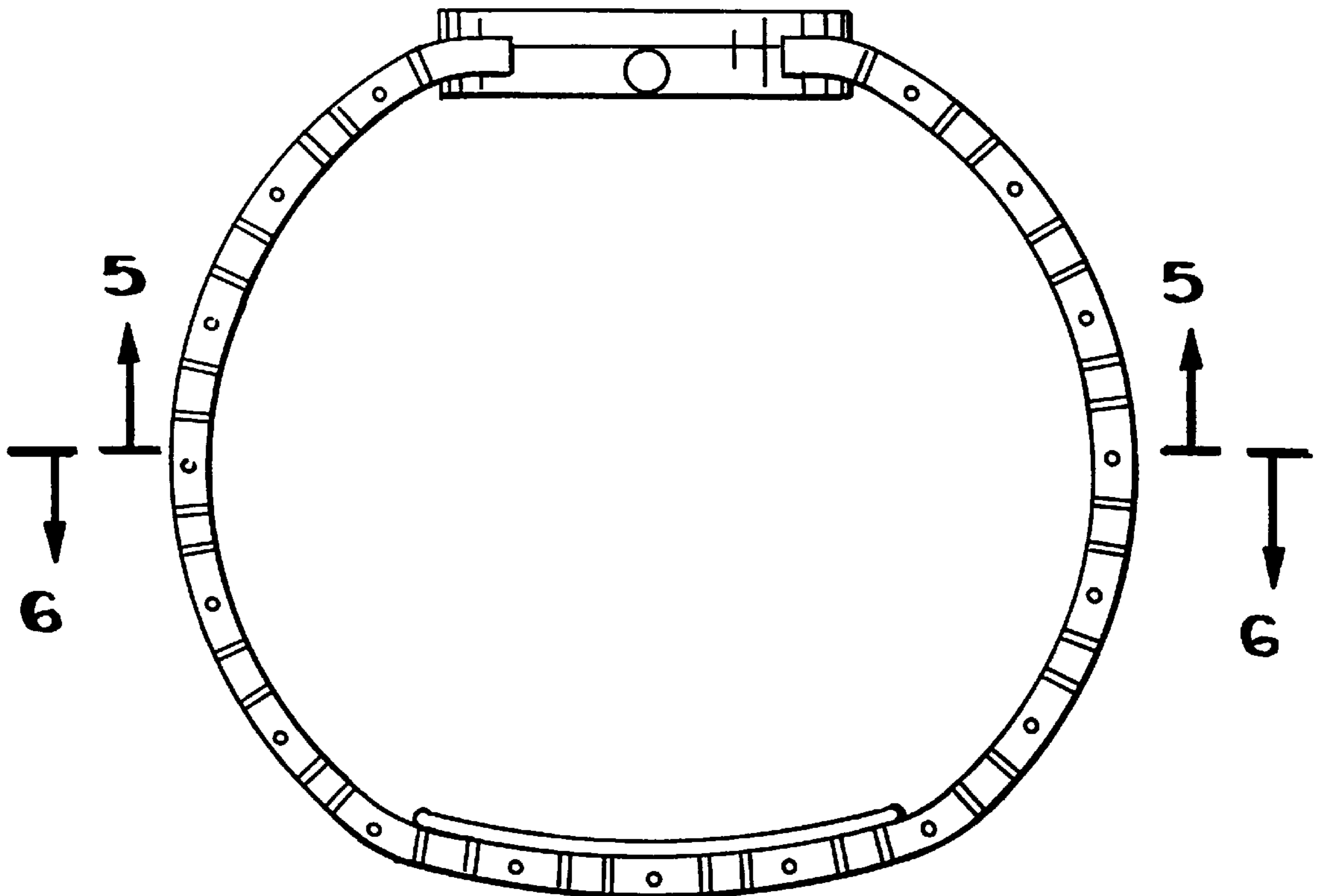

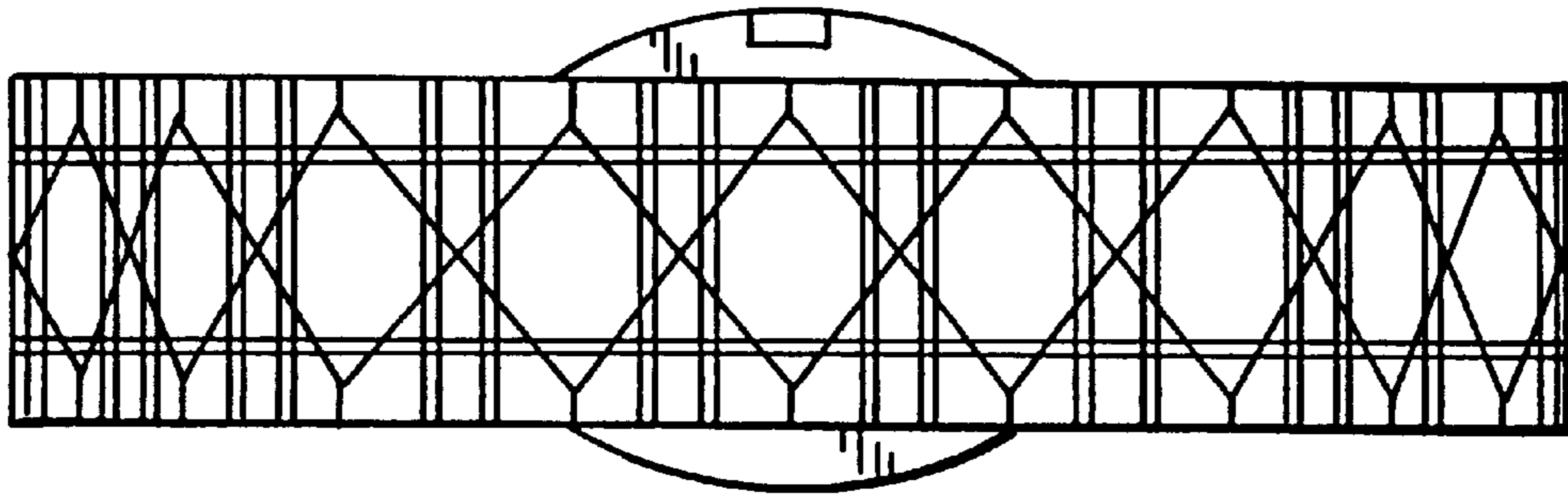

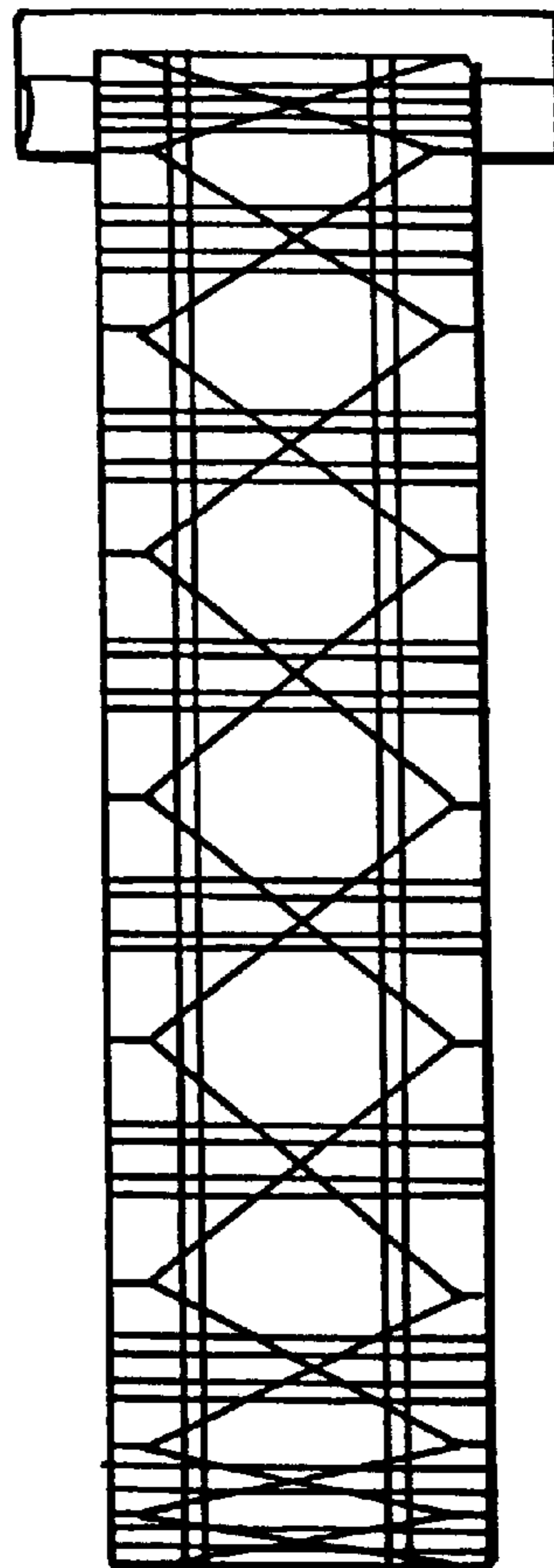

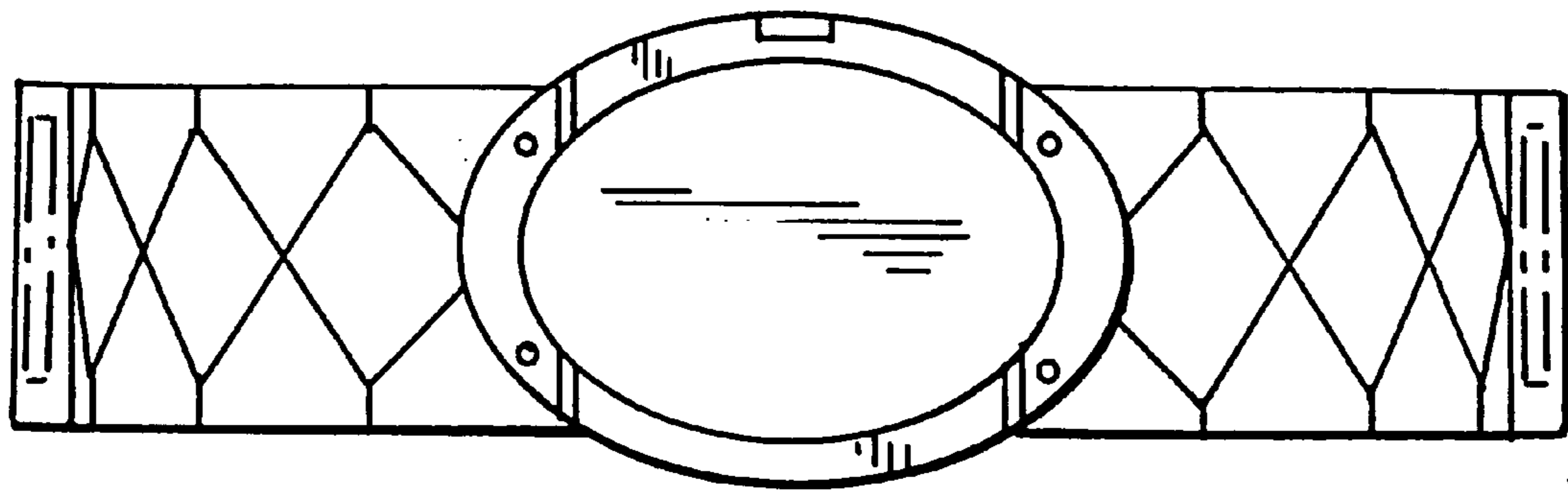

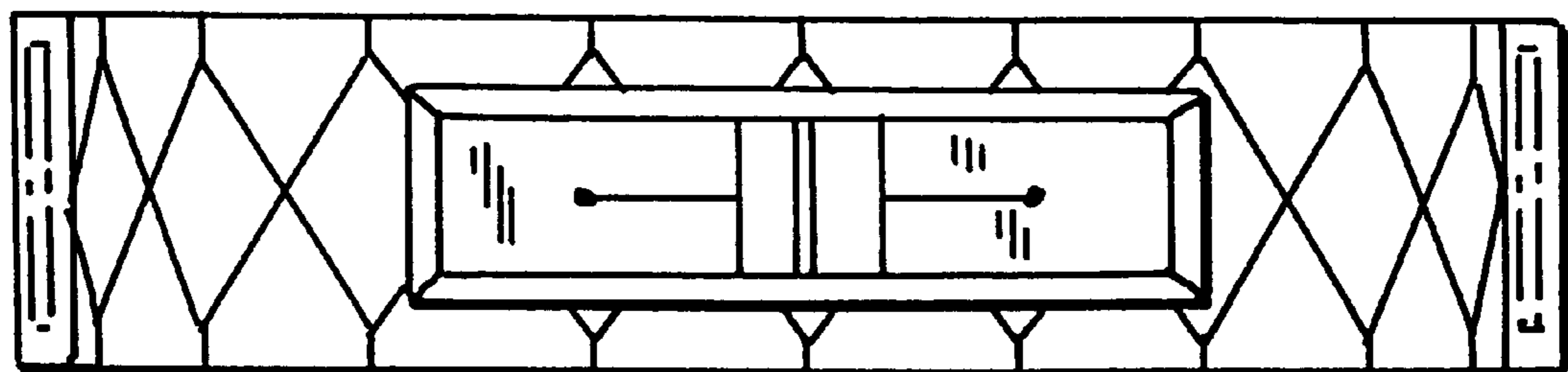

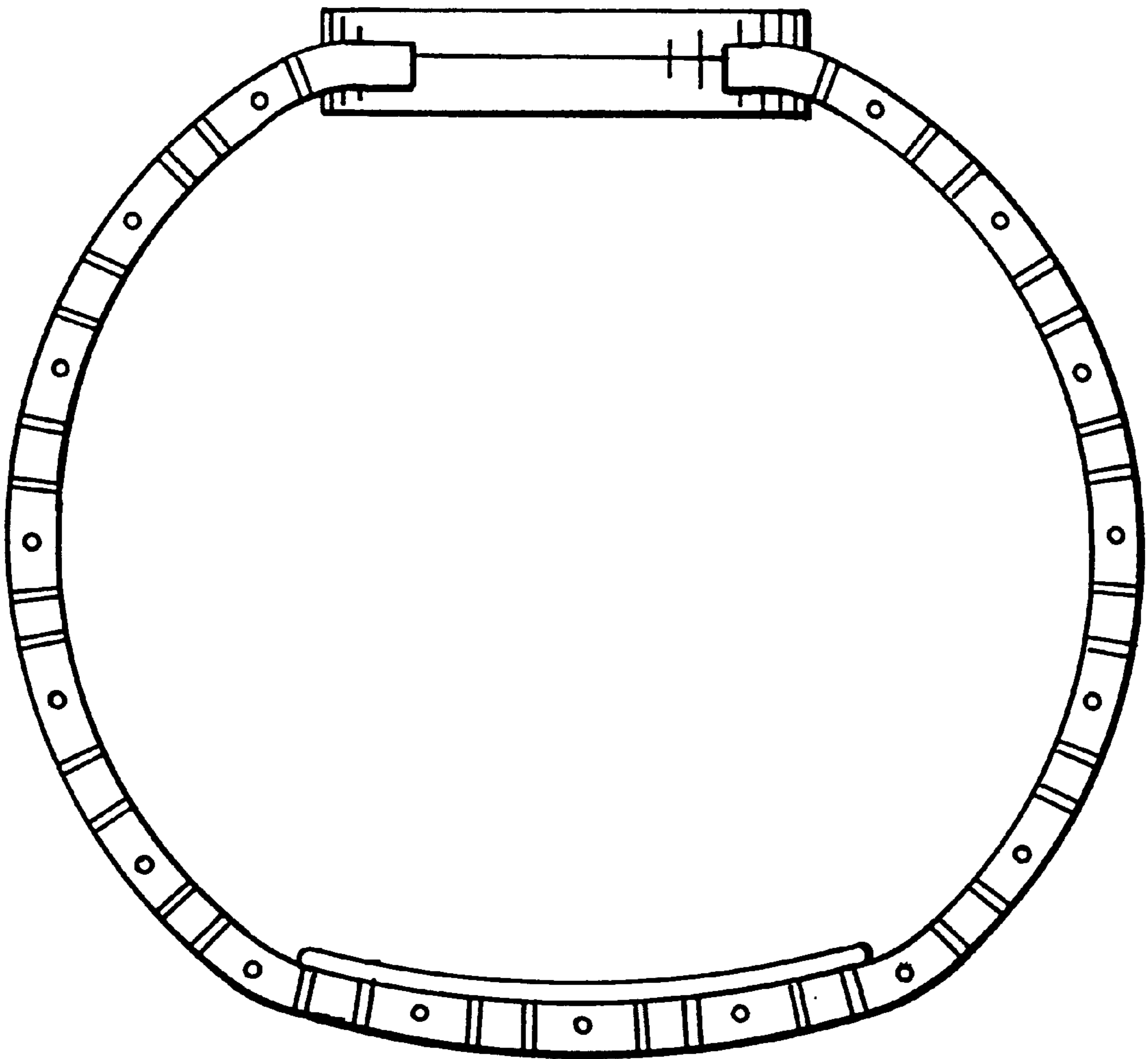

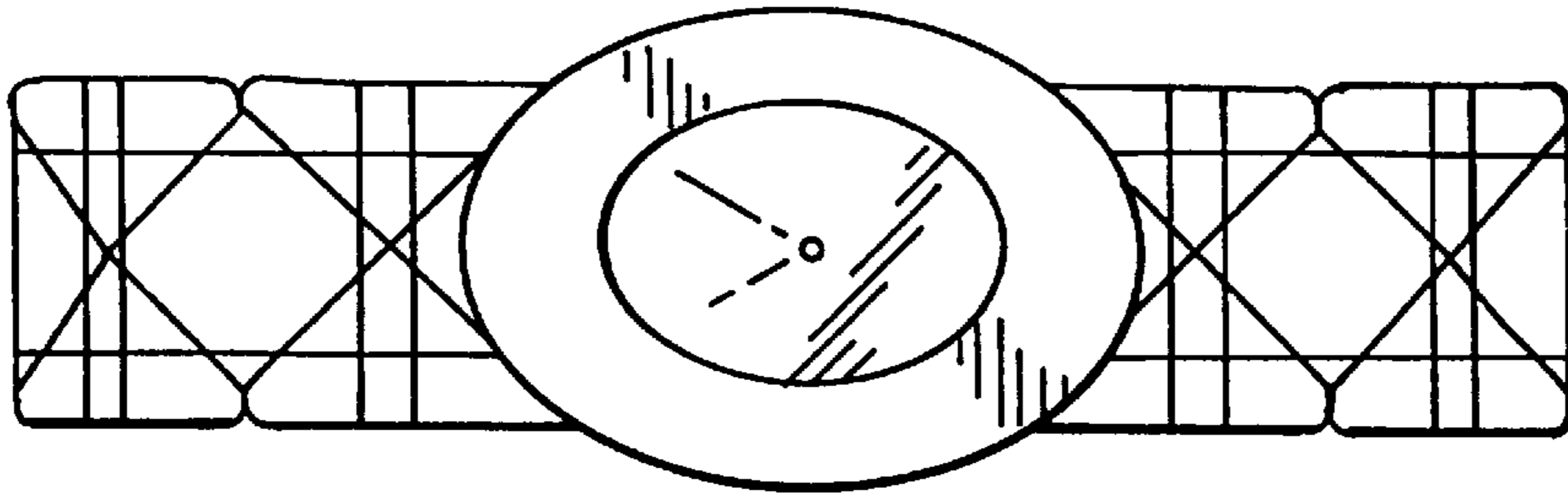

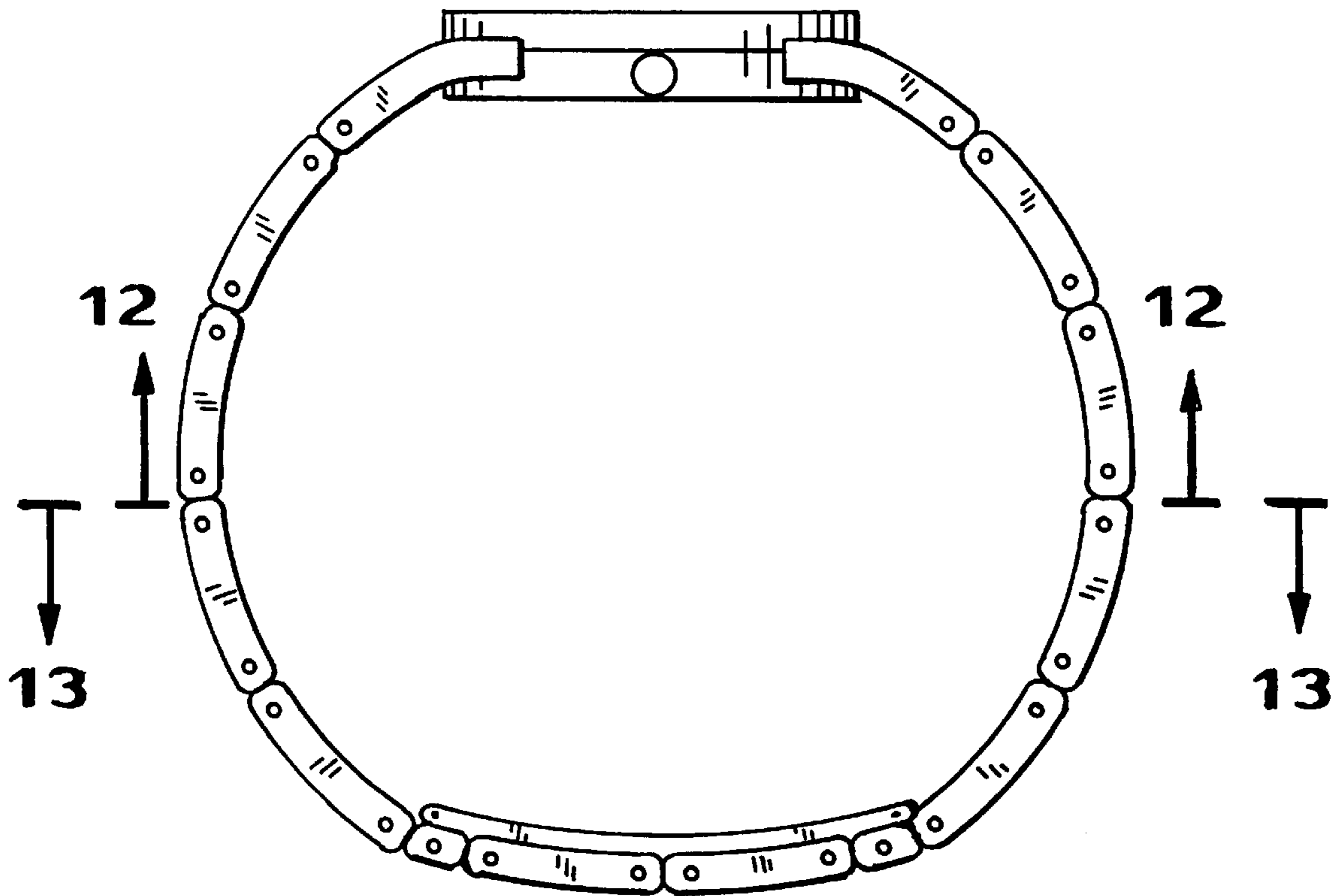

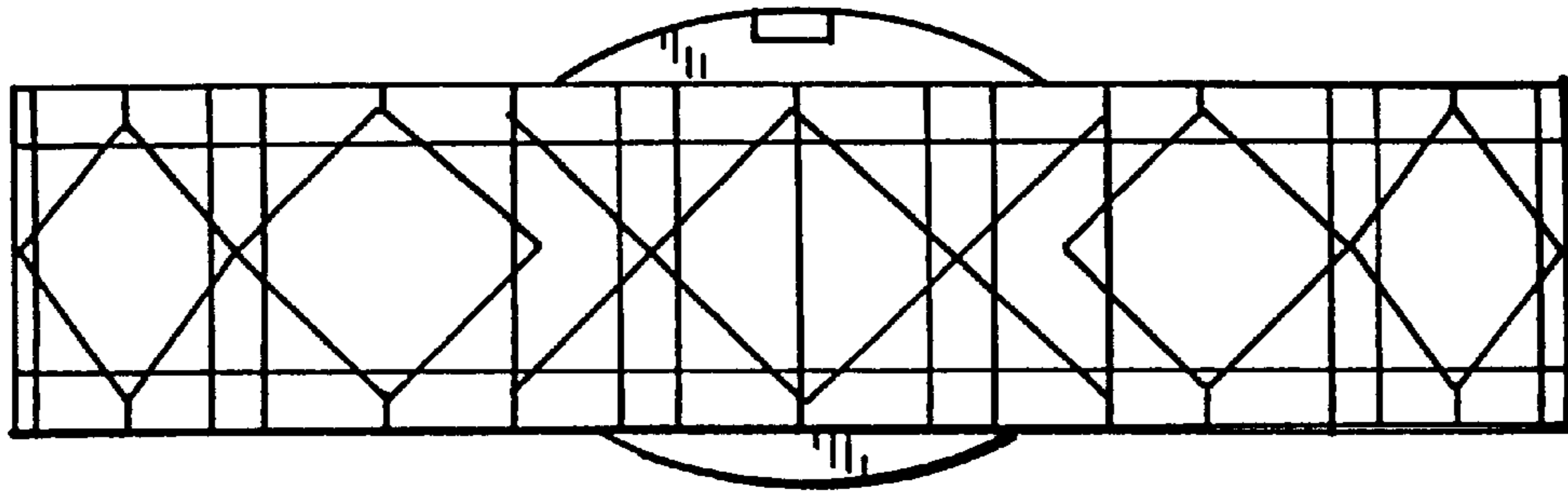

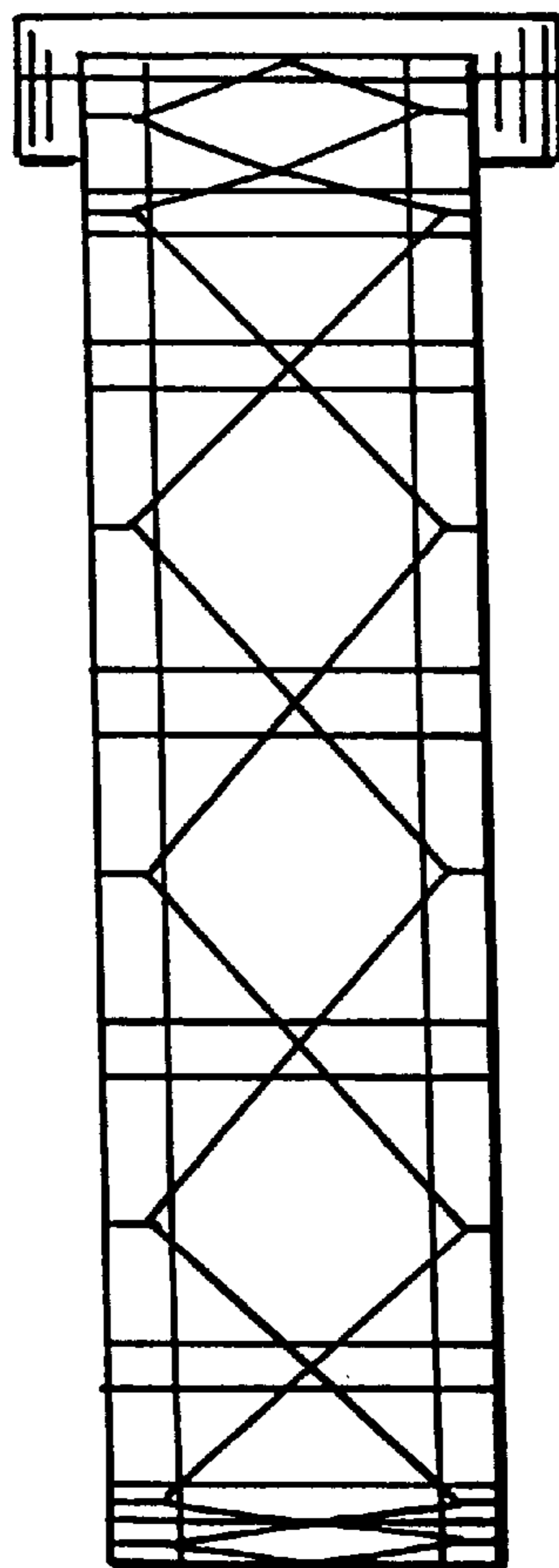

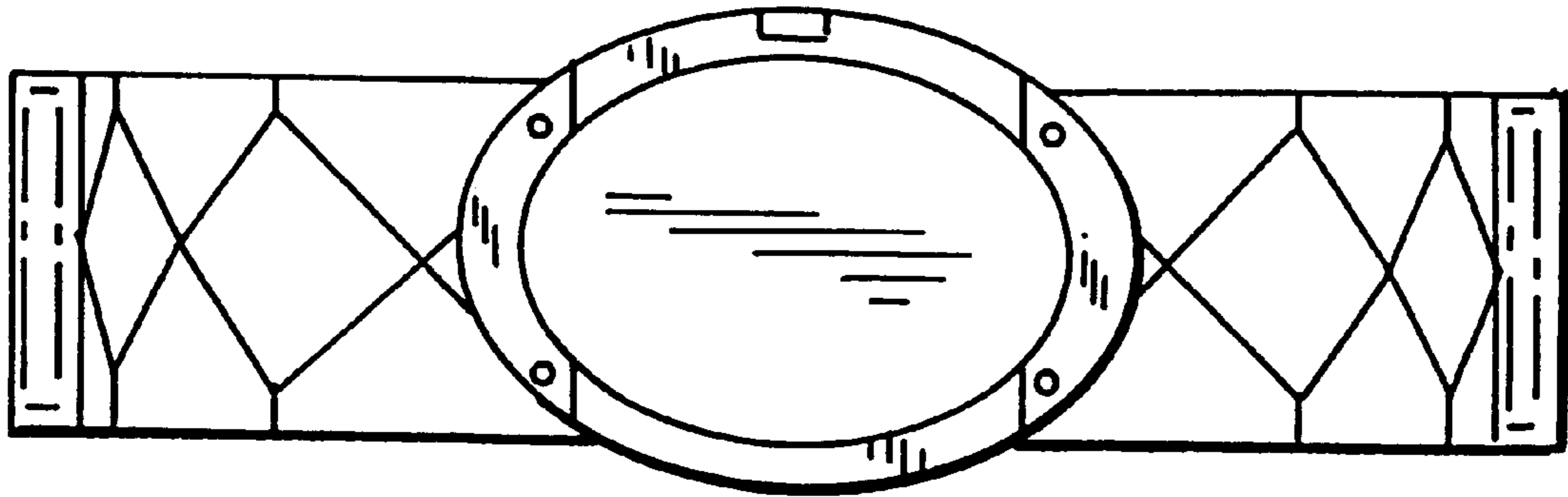

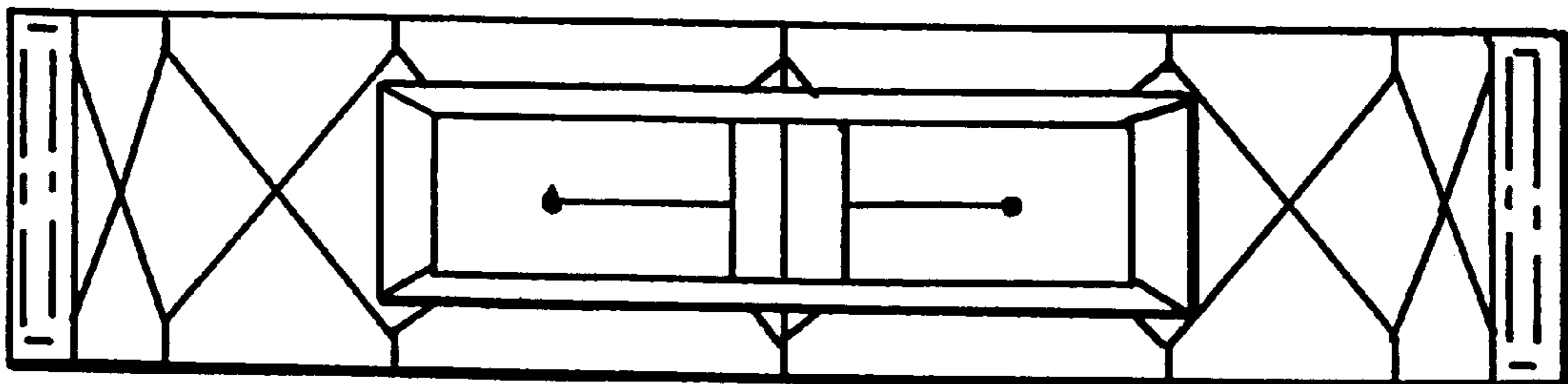
